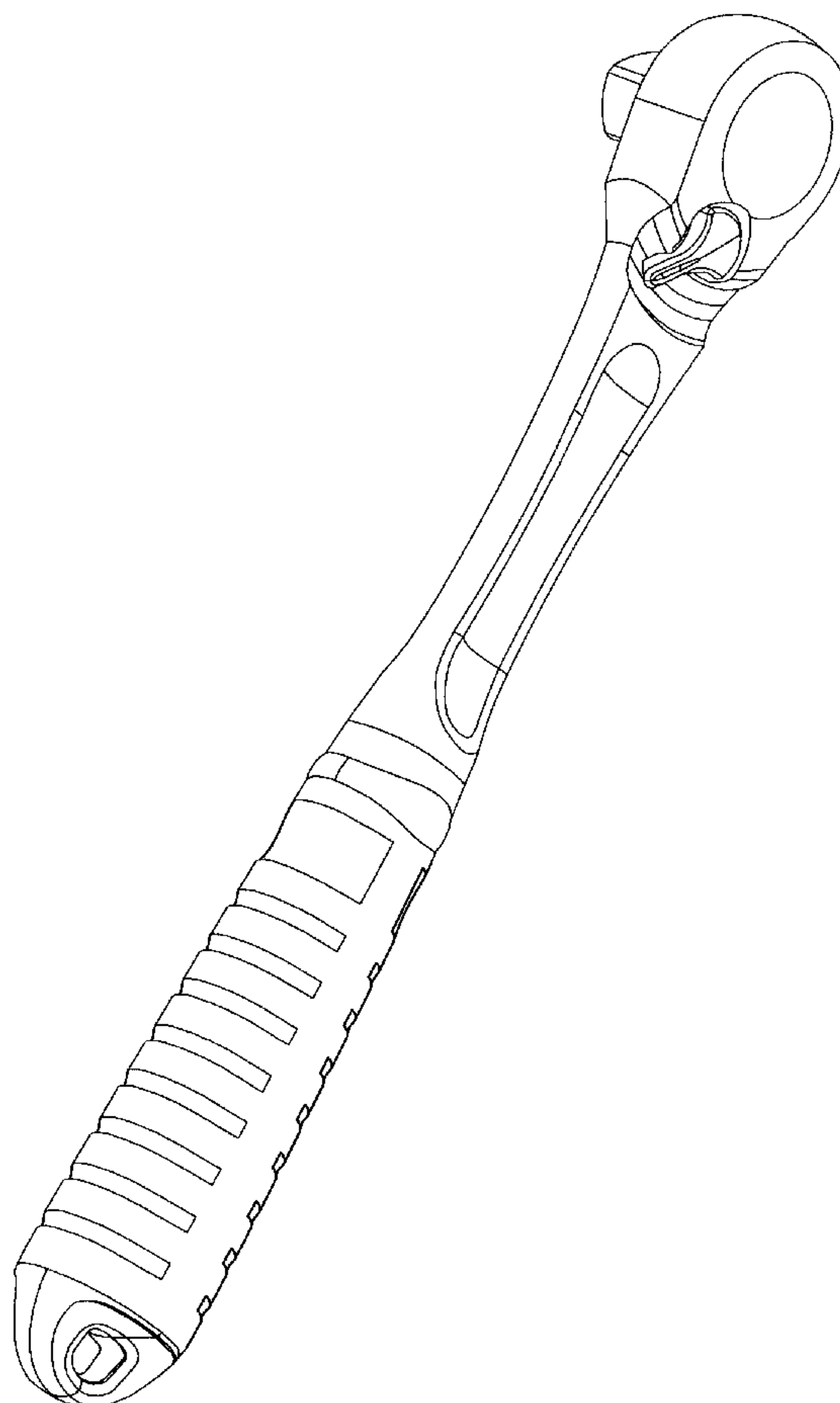
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a ratchet wrench according to the present invention;

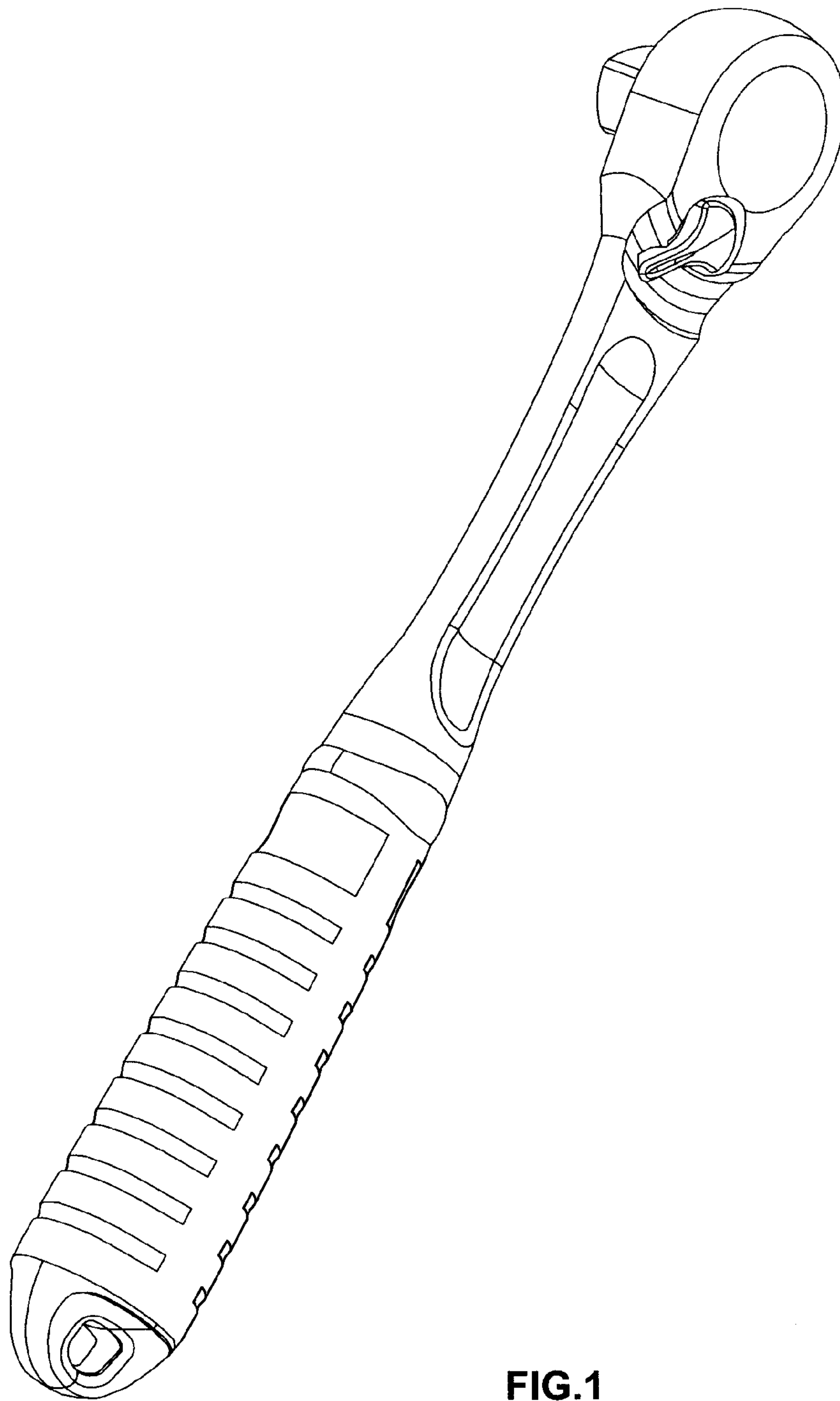

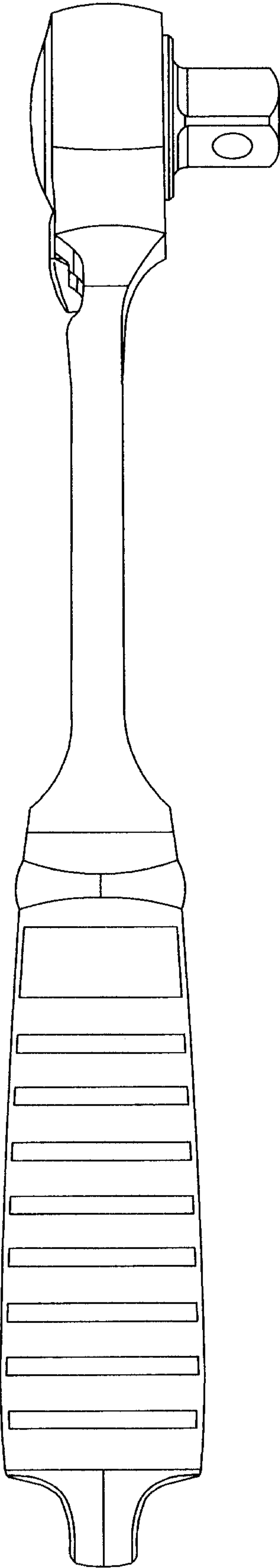

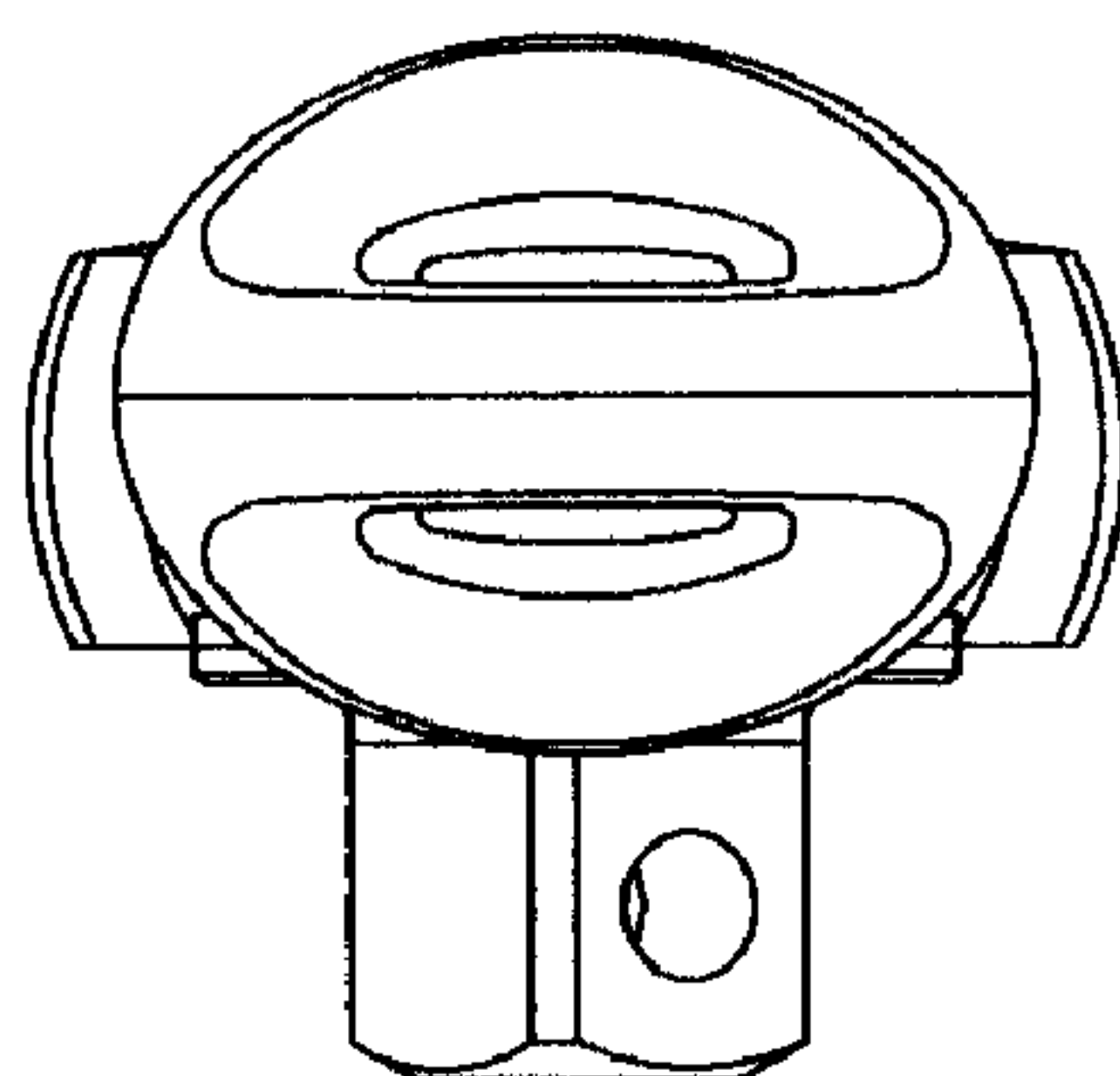

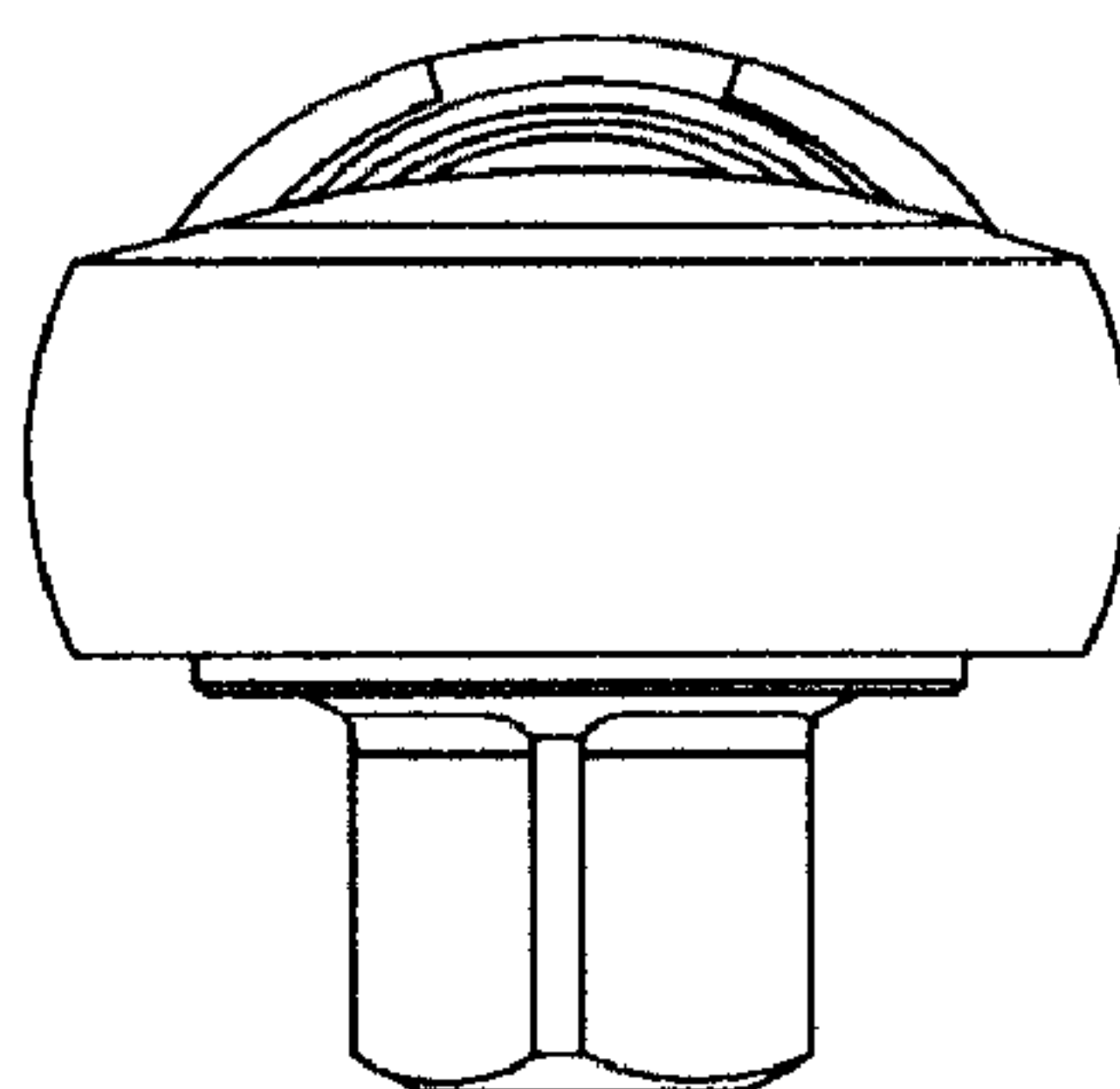

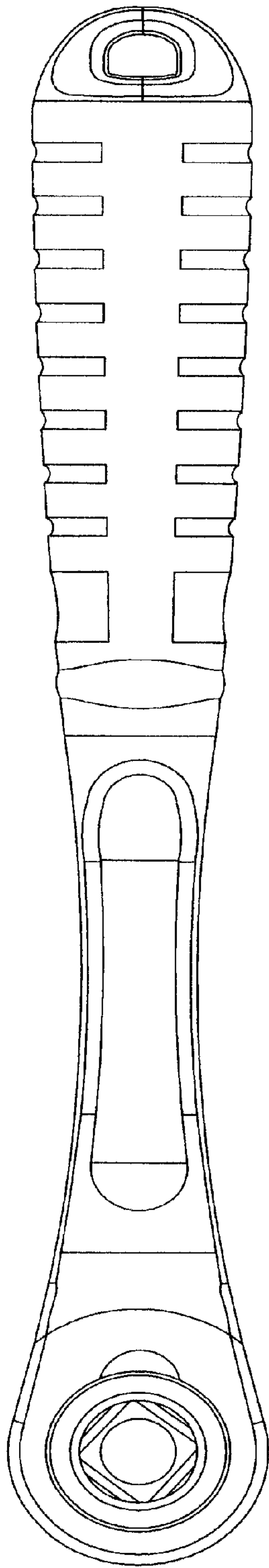

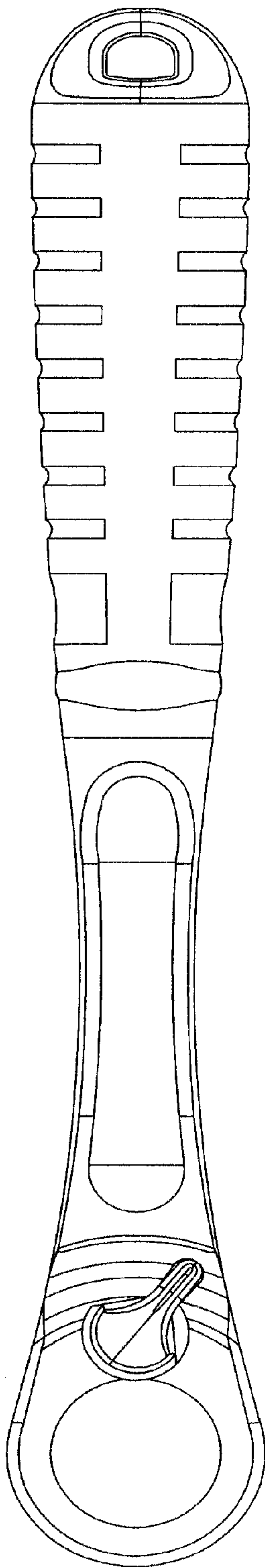
