The ornamental design for a feminine hygiene product package, as shown and described.

DESCRIPTION

FIG. 4 is a right side view of the feminine hygiene product package as shown in FIG. 1;

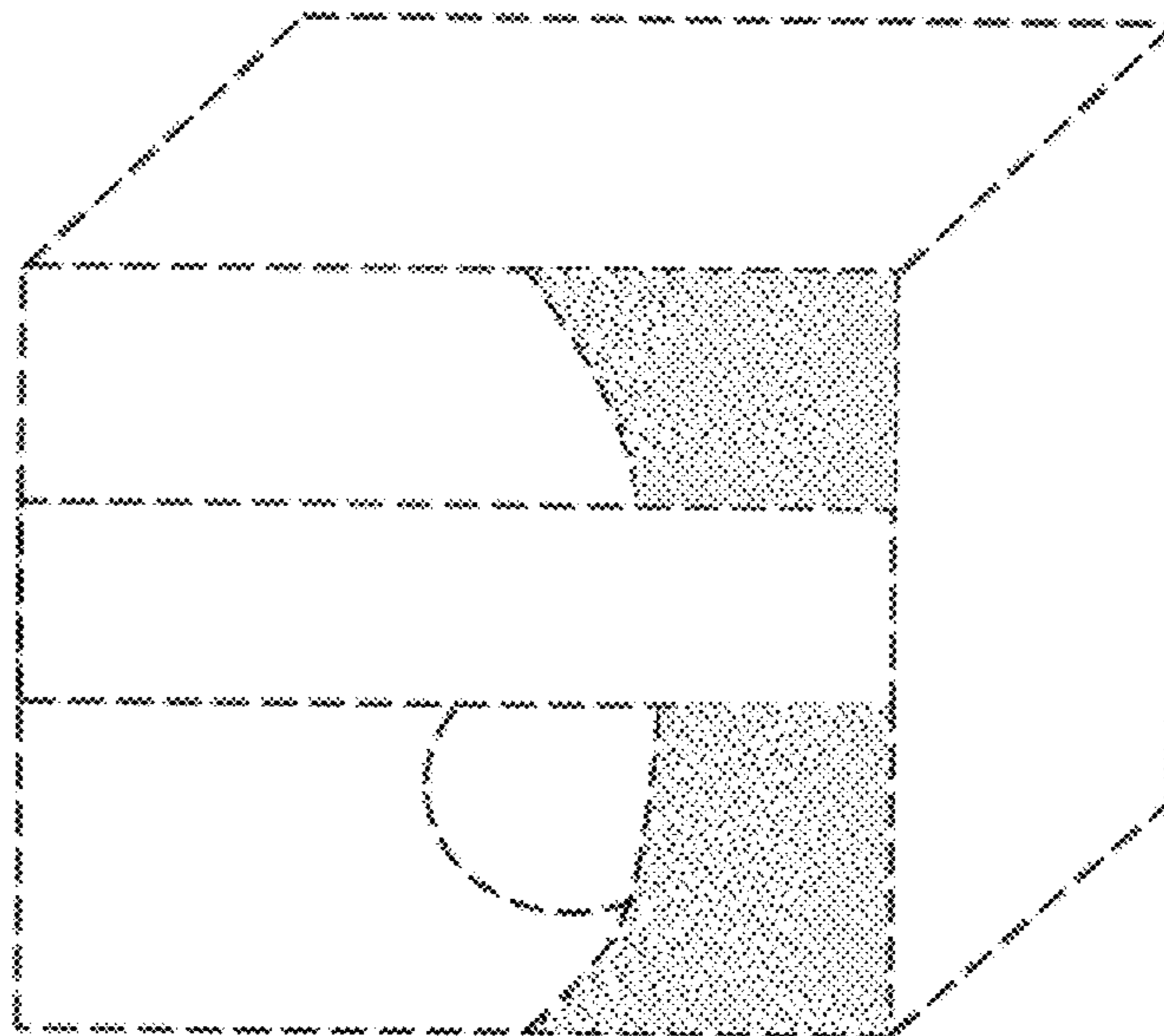
FIG. 5 is a top view of the feminine hygiene product package as shown in FIG. 1;

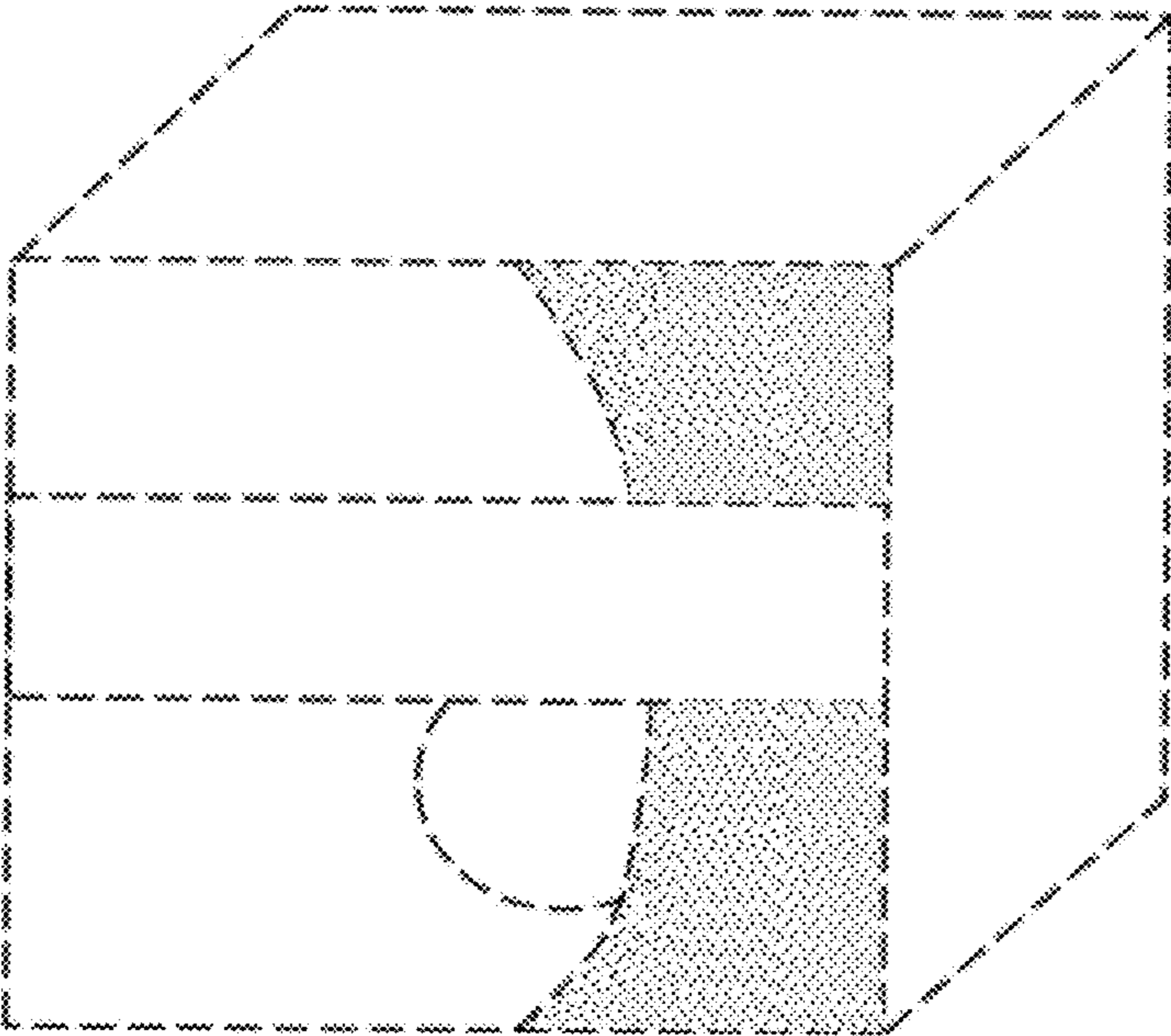

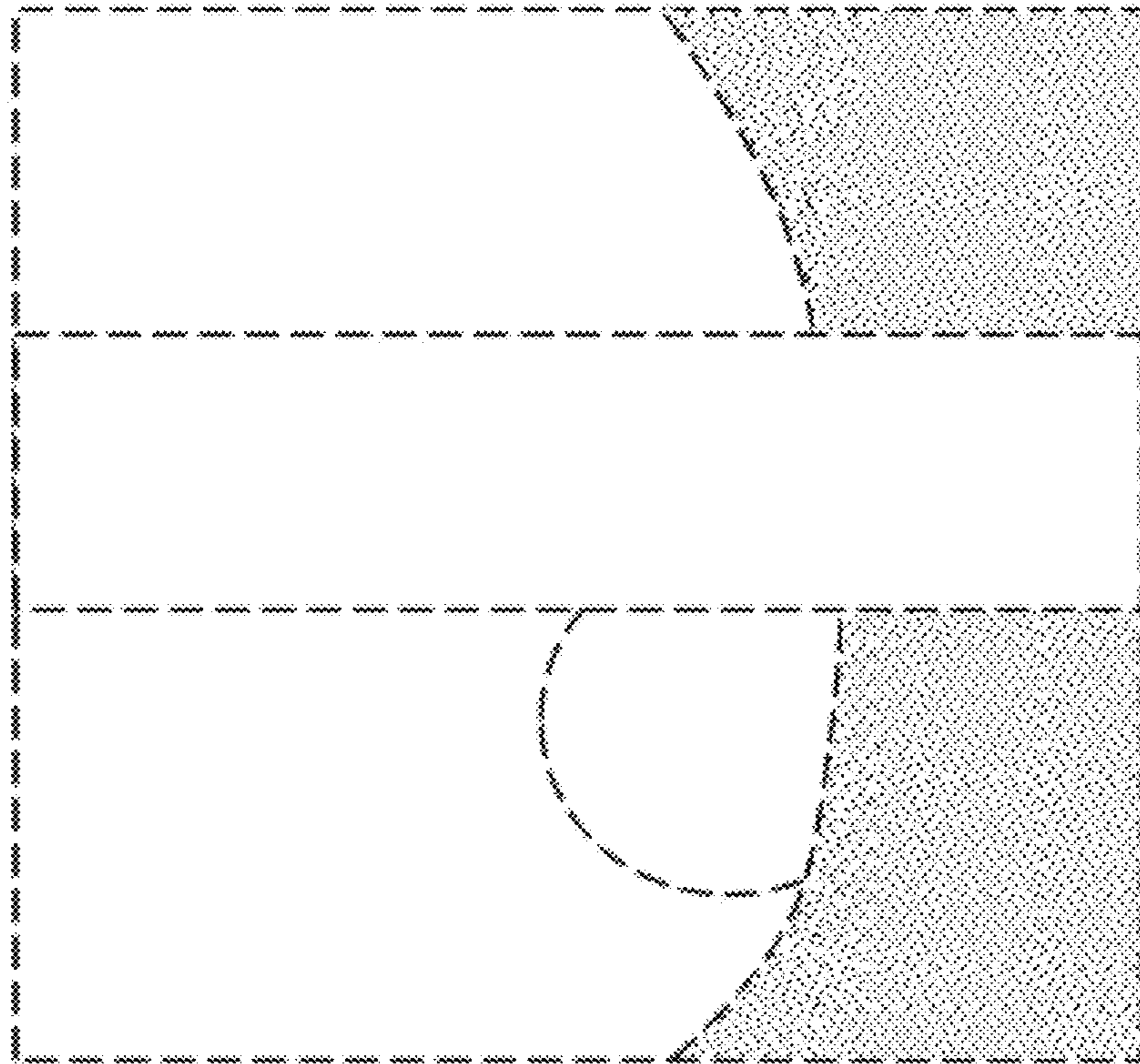

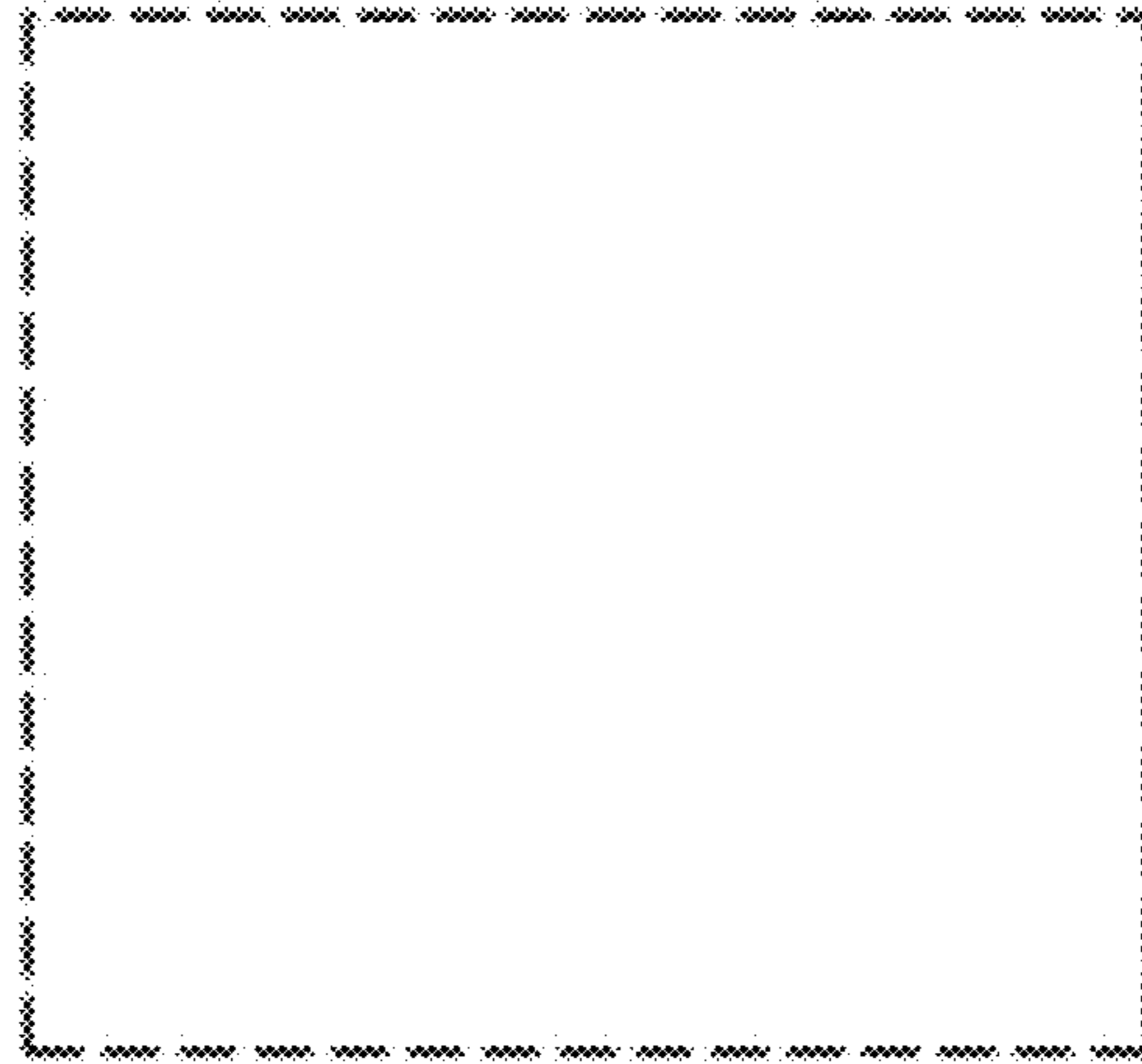

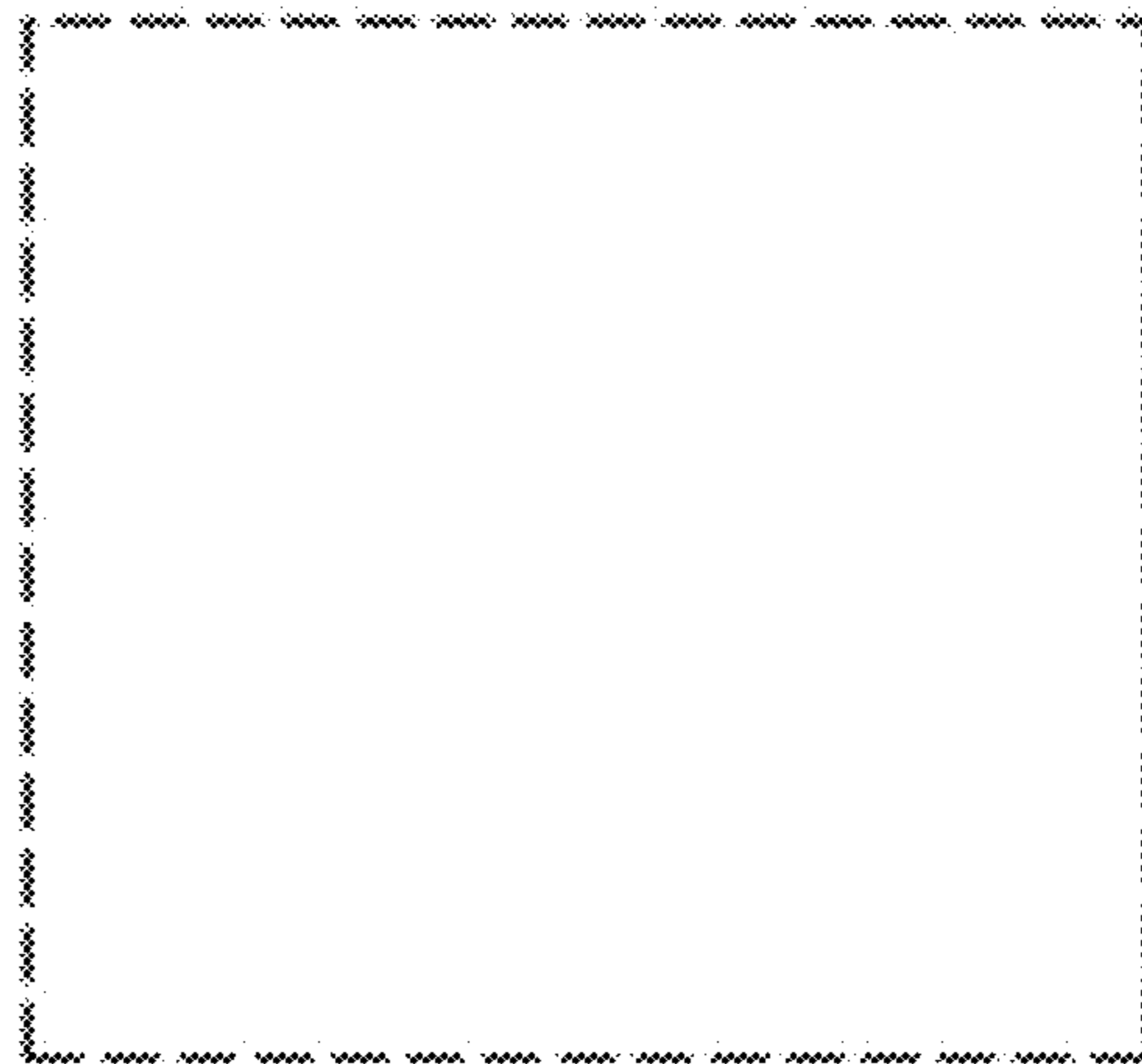

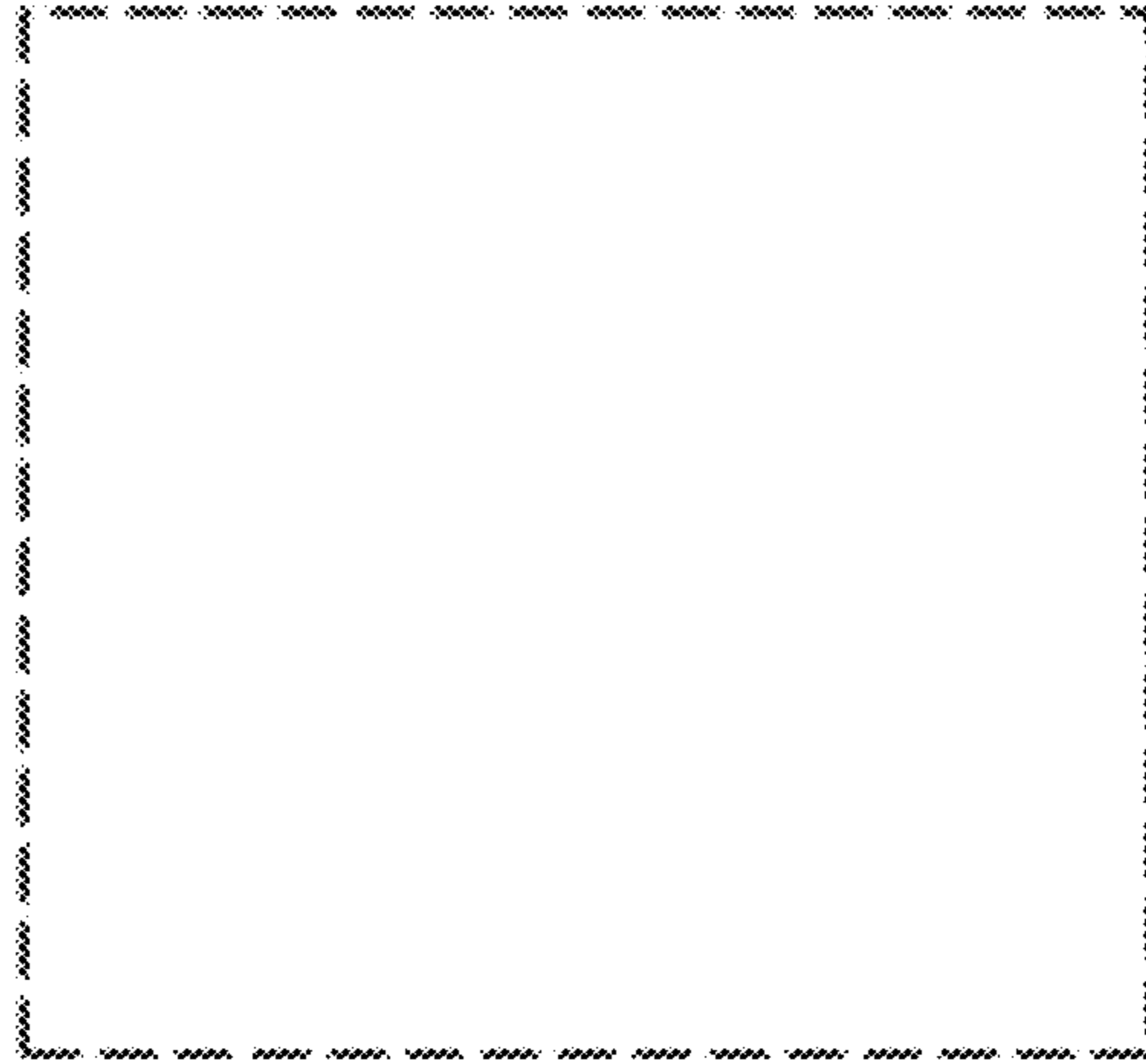

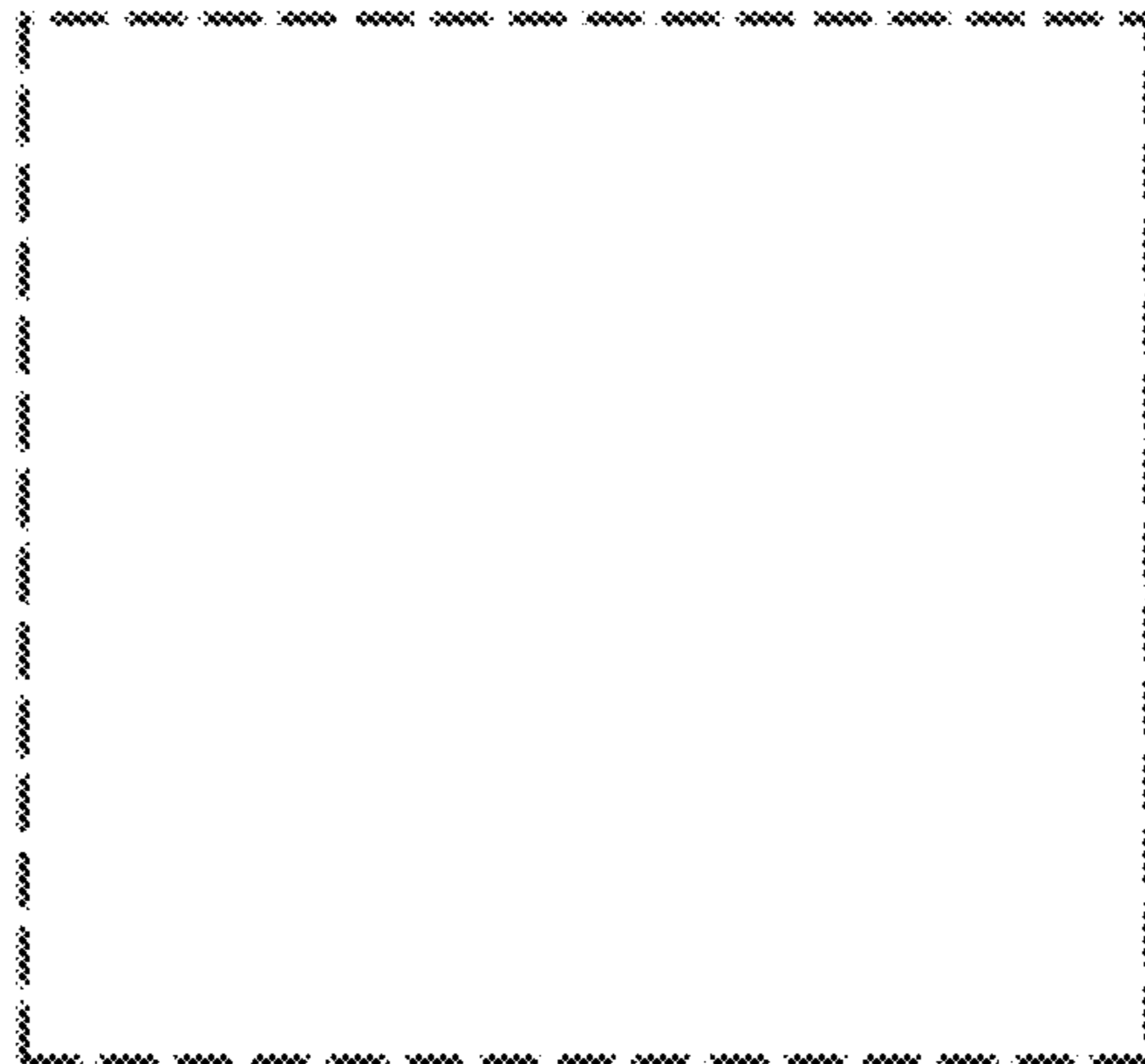
