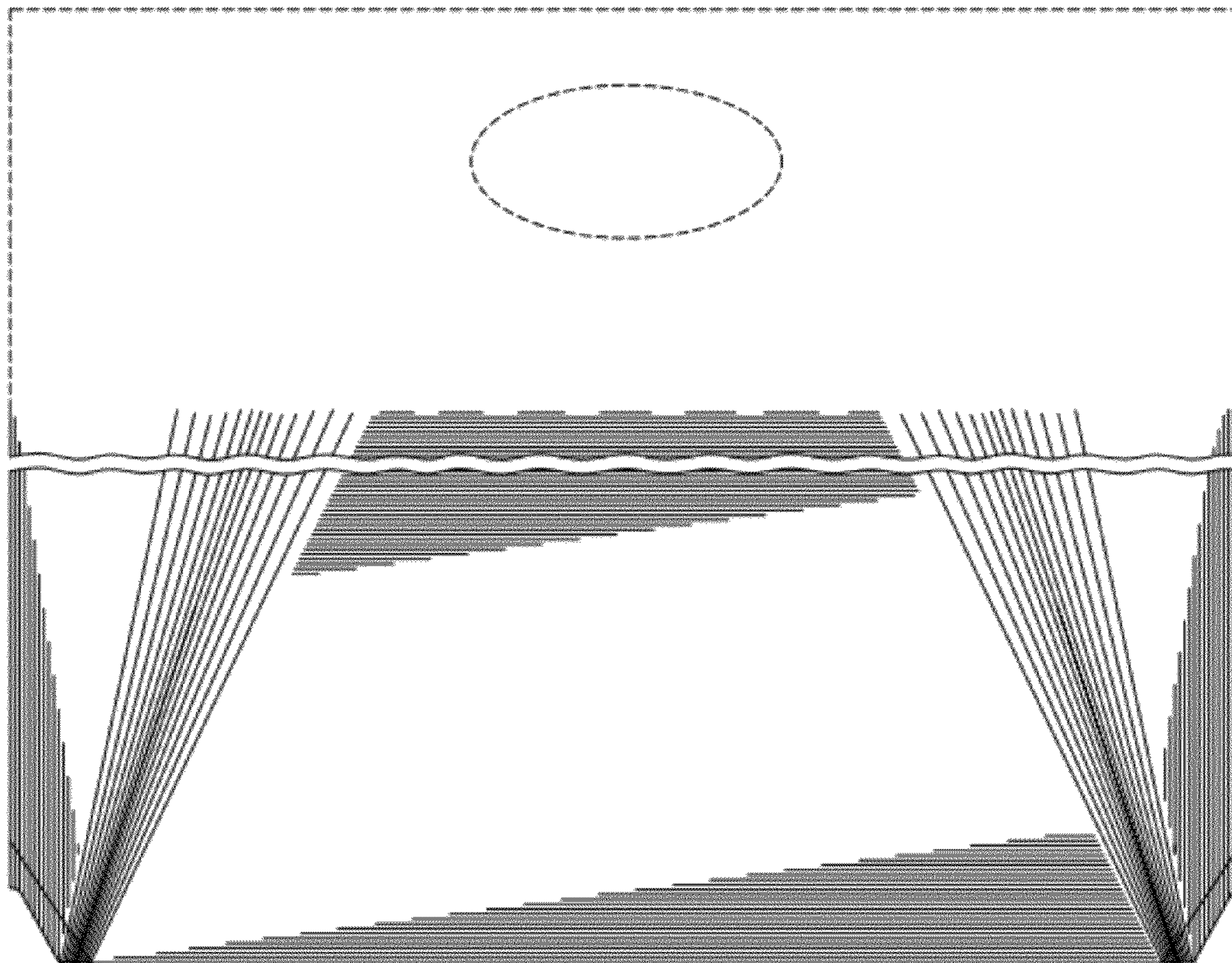
(57) **CLAIM**

The ornamental design for a merchandise bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a merchandise bag;  
FIG. 2 is a first side view of the merchandise bag of FIG. 1, the second opposed side view being identical to the first side view;  
FIG. 3 is a bottom view of the merchandise bag of FIG. 1; and,  
FIG. 4 is a top view of the merchandise bag of FIG. 1.

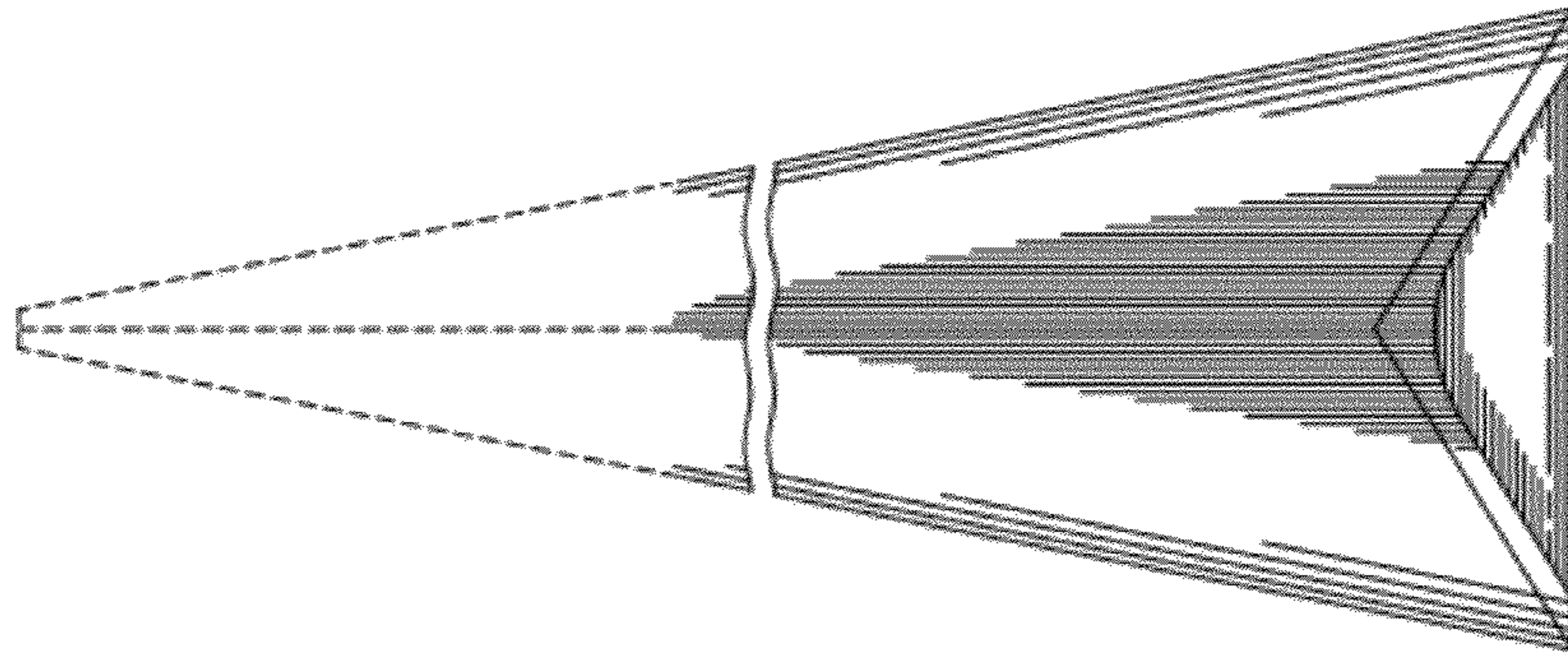

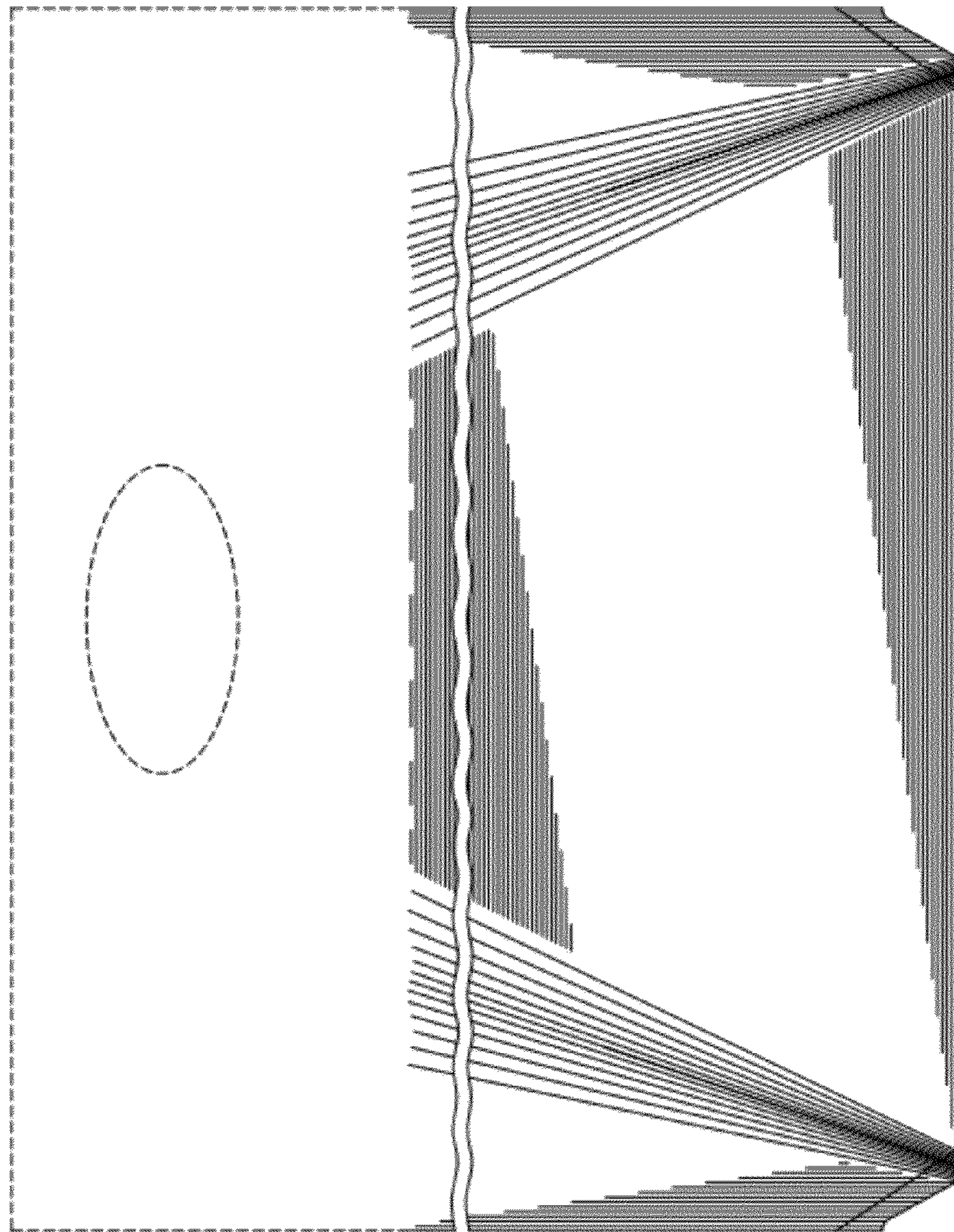

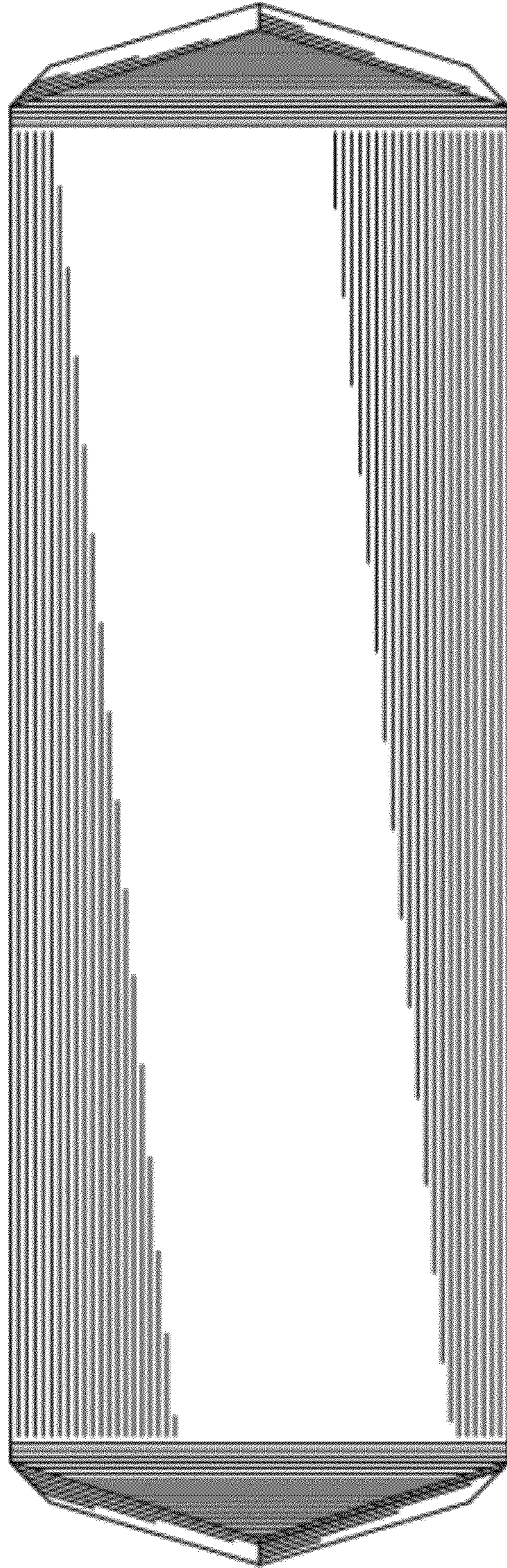

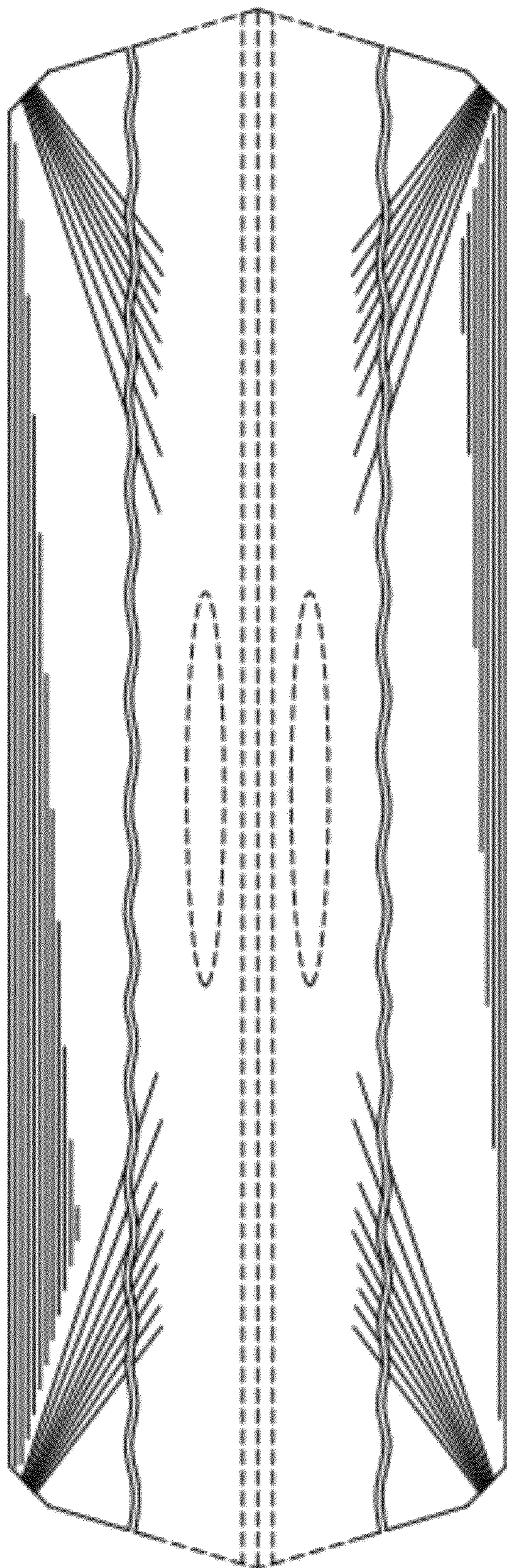
