(57) **CLAIM**

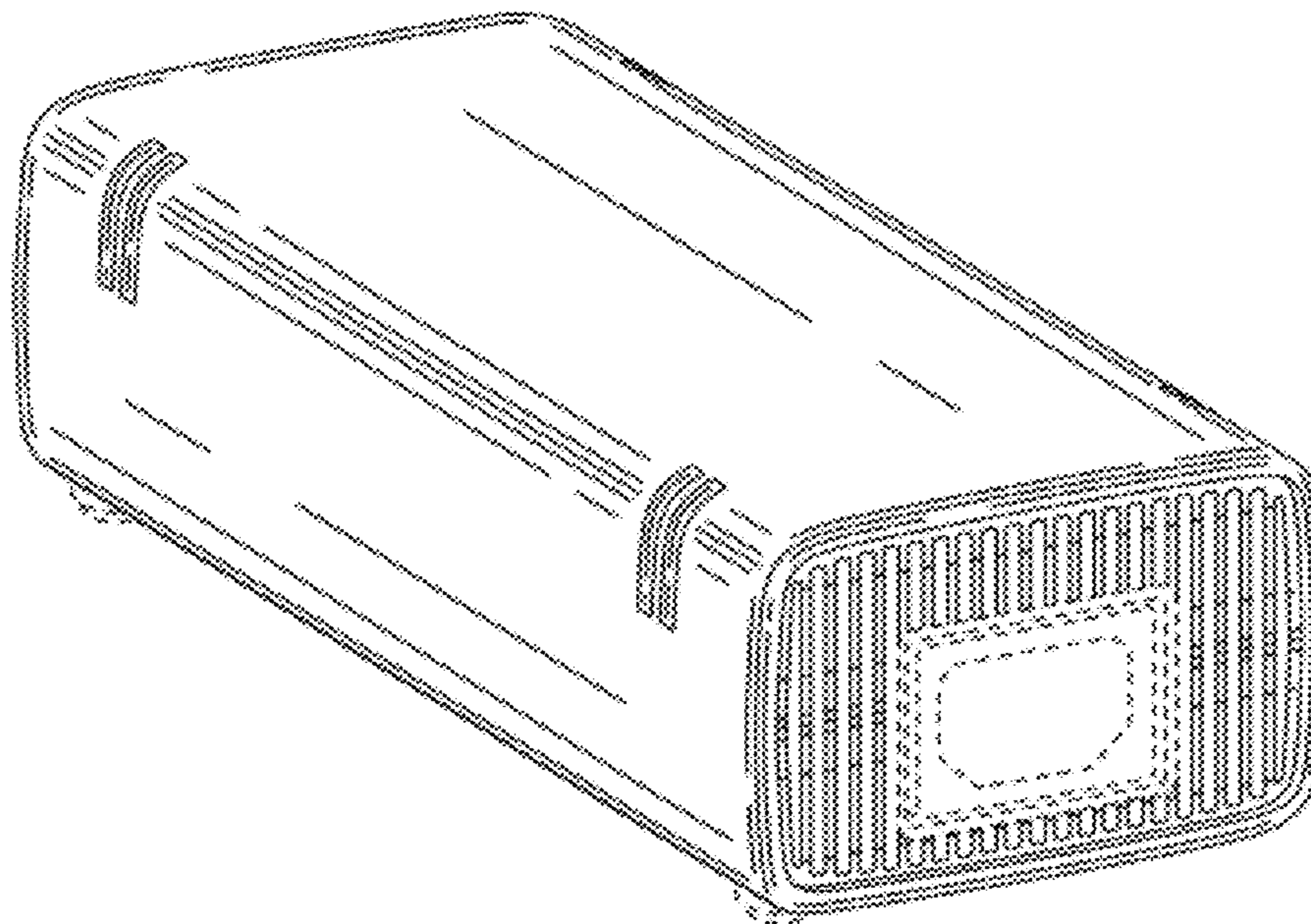
The ornamental design for an electronic housing, as shown and described.

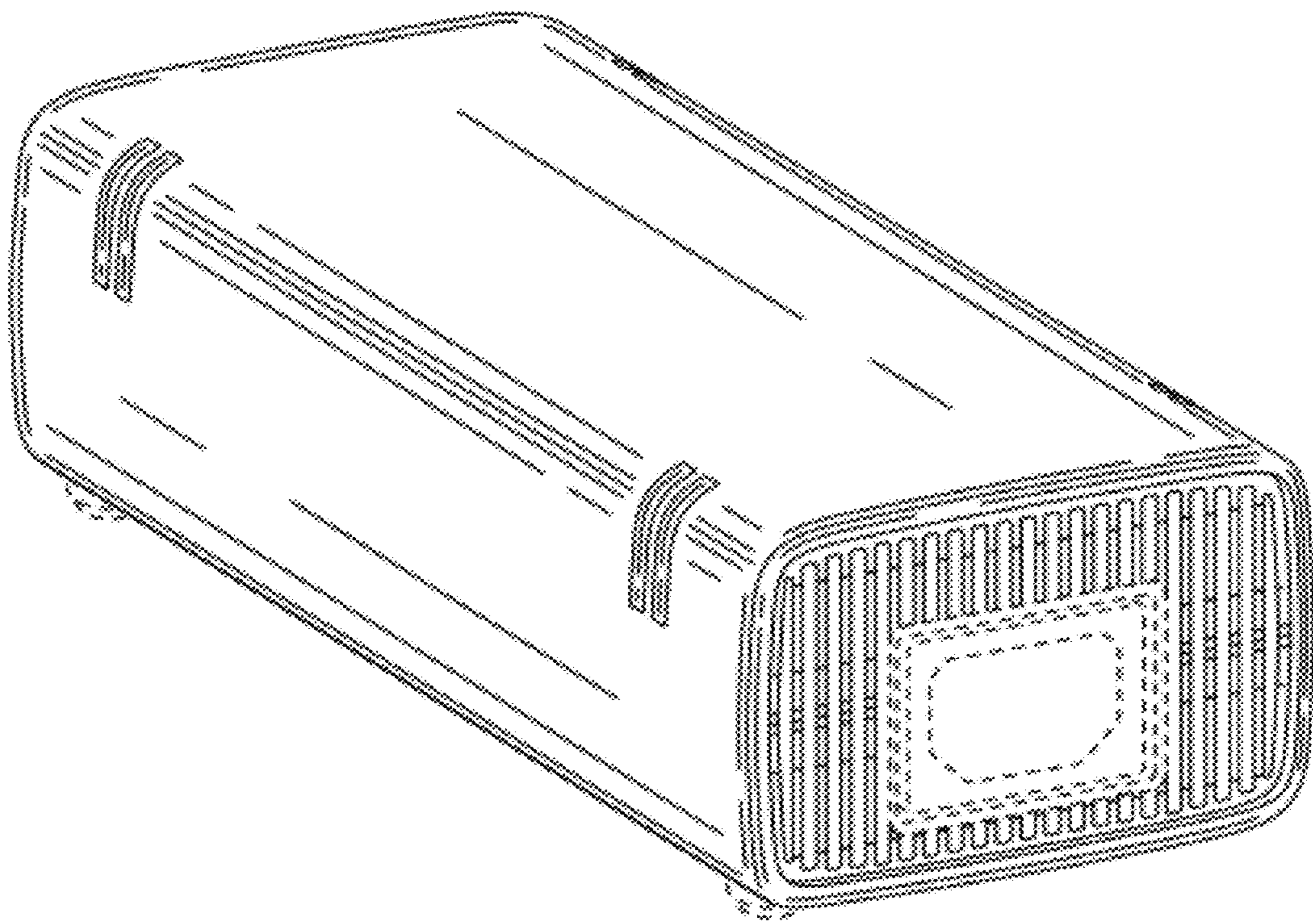

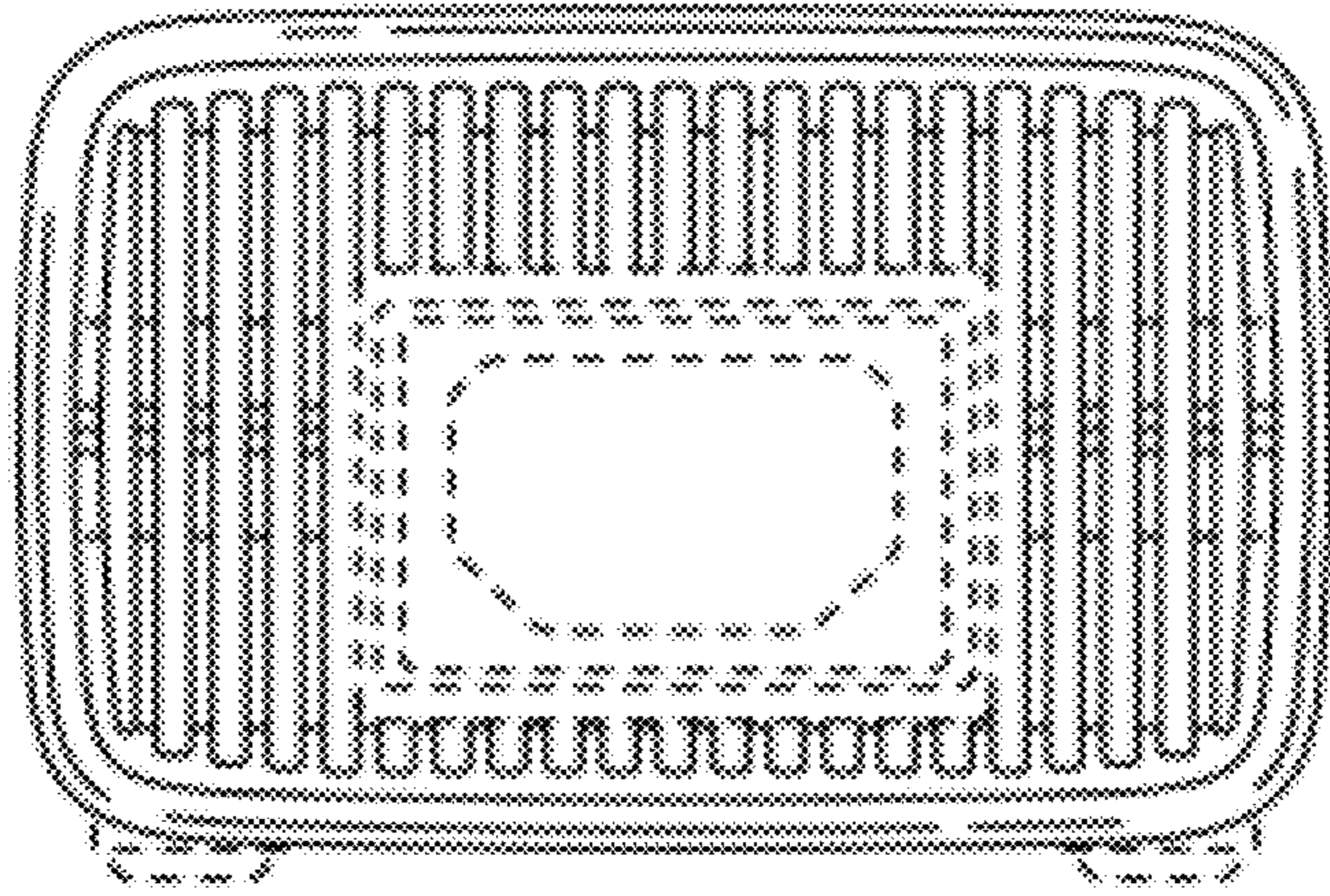

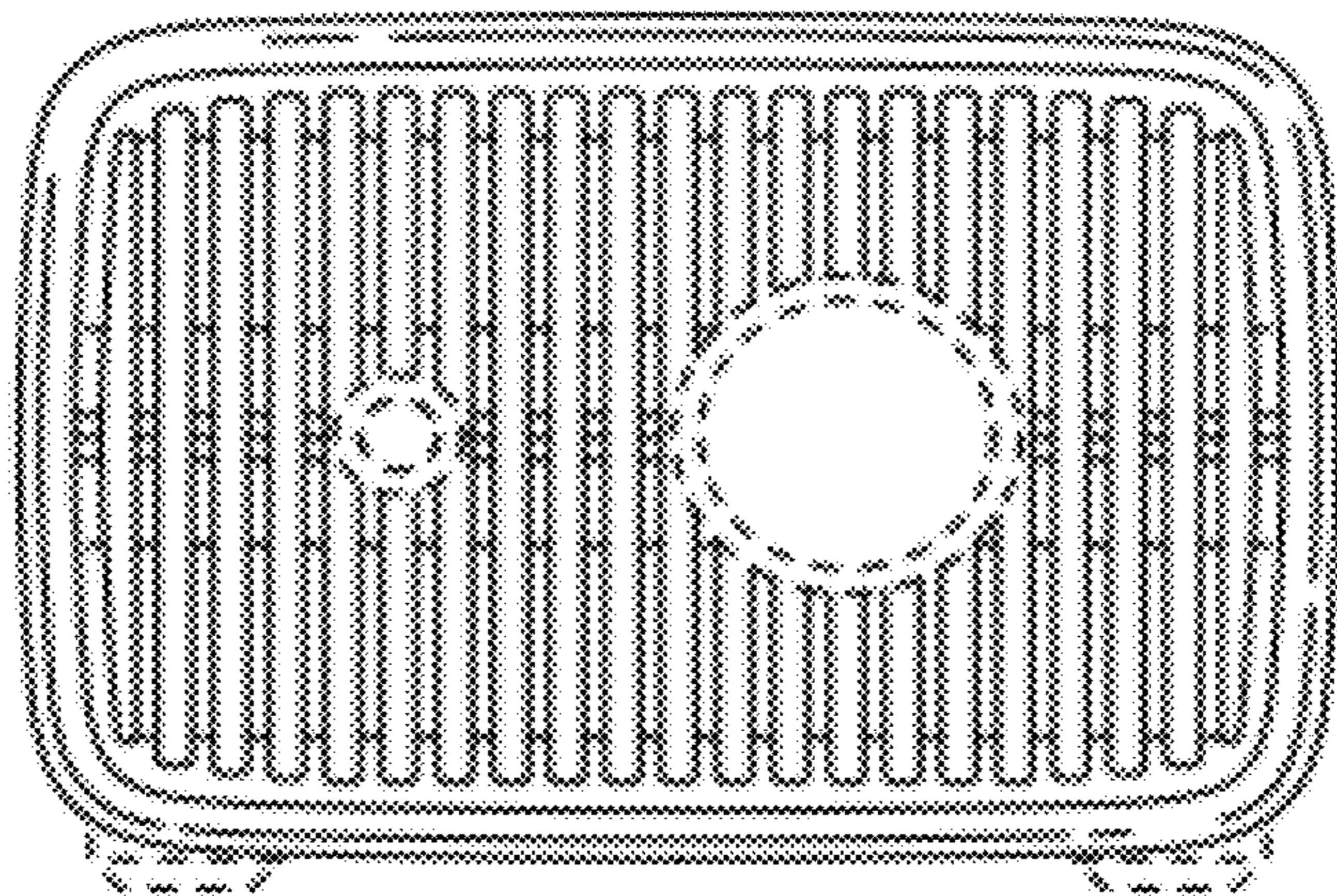

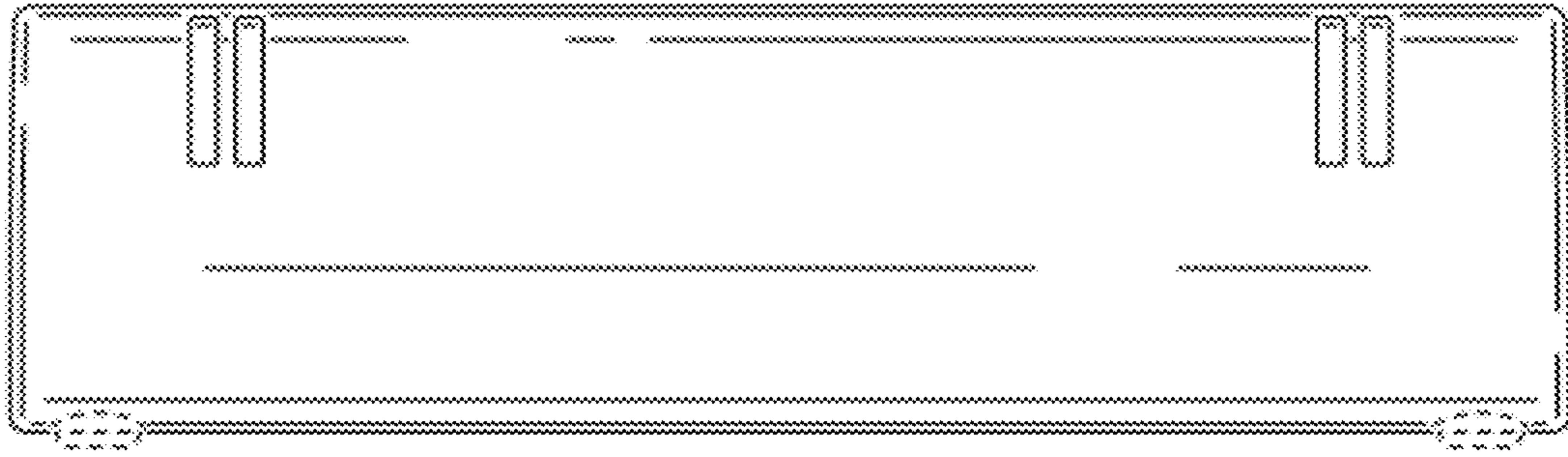

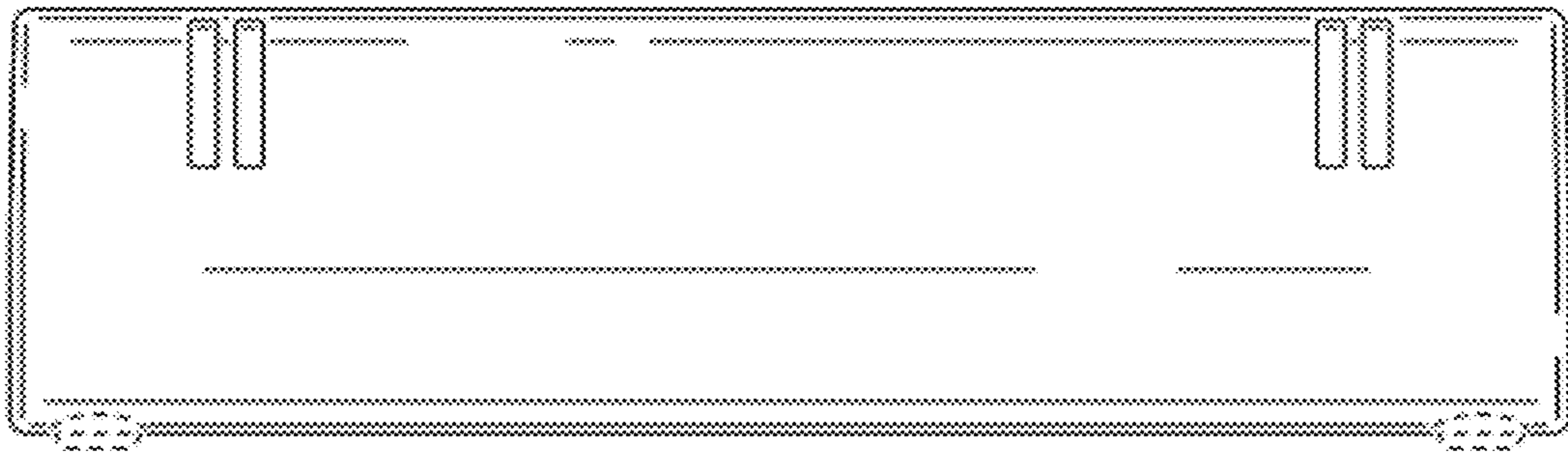

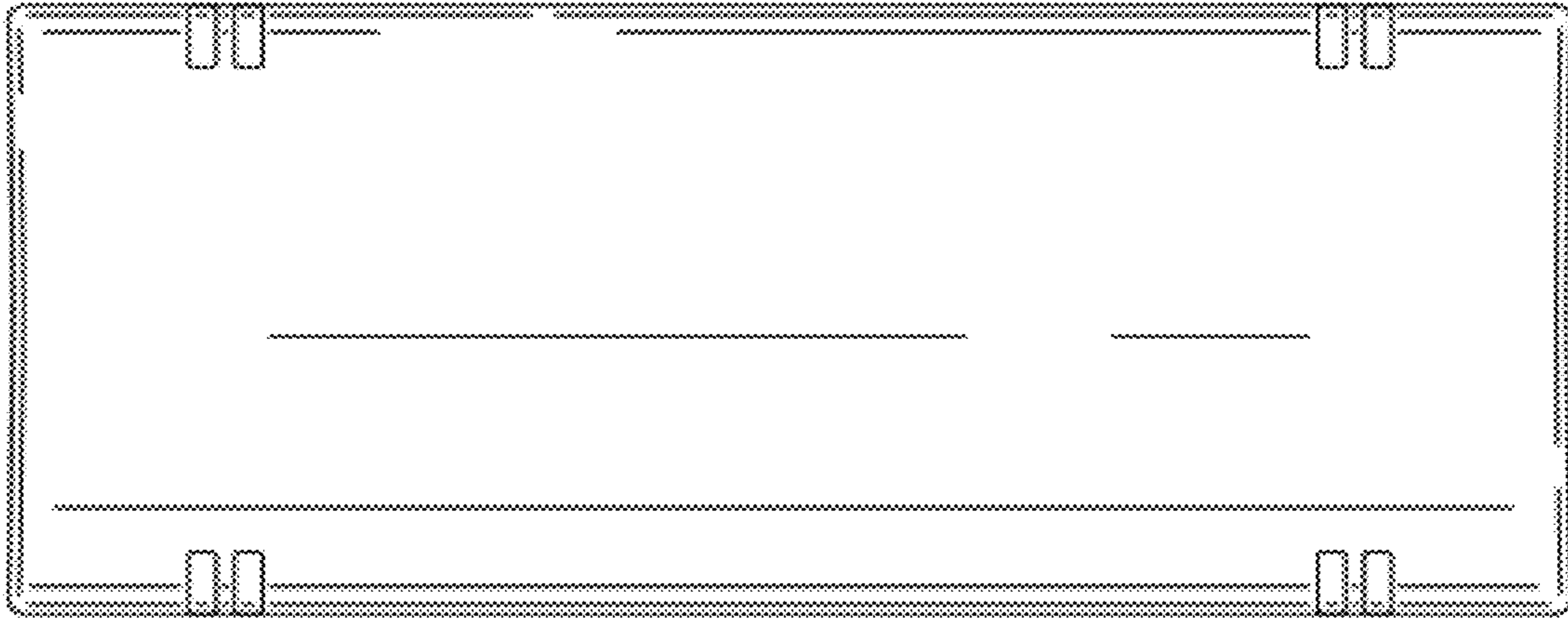

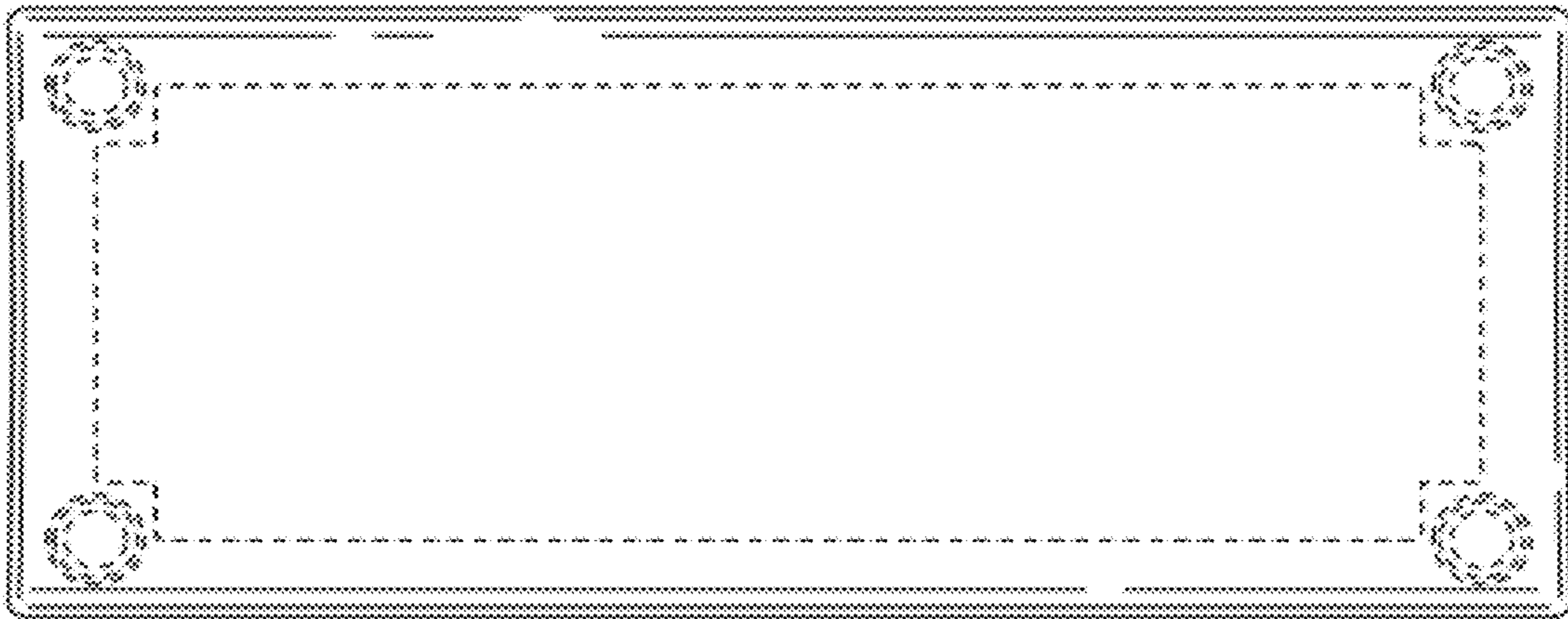

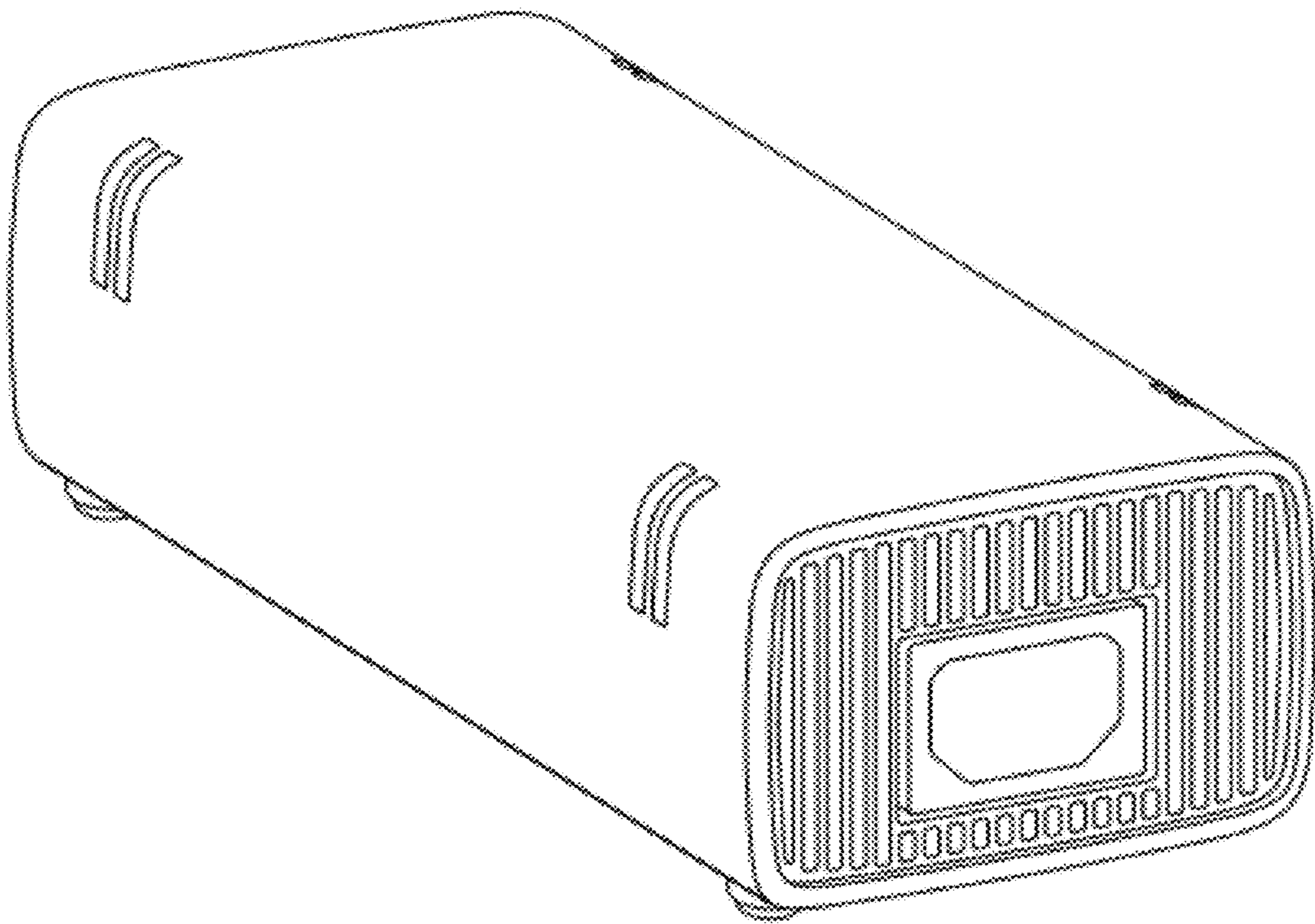

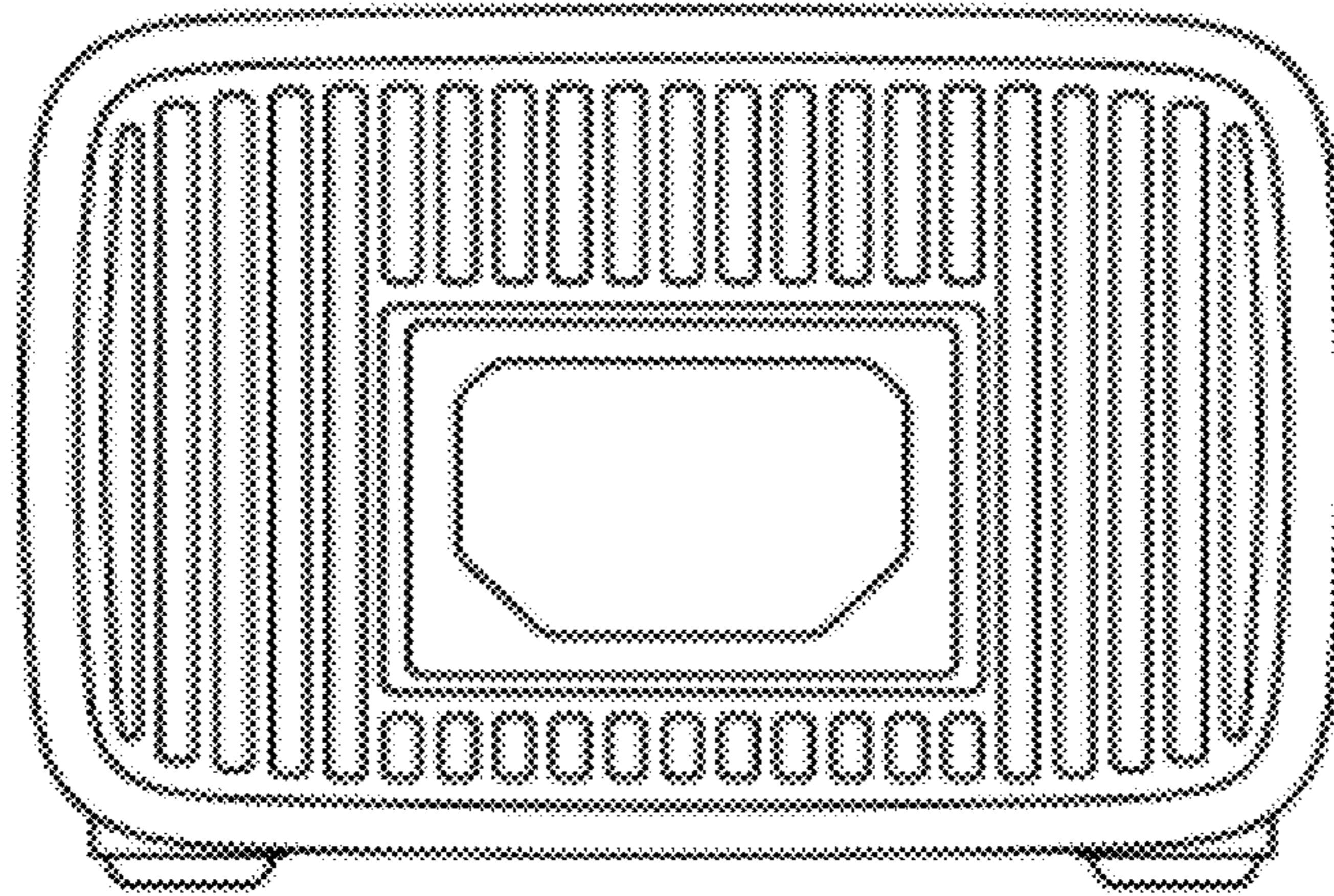

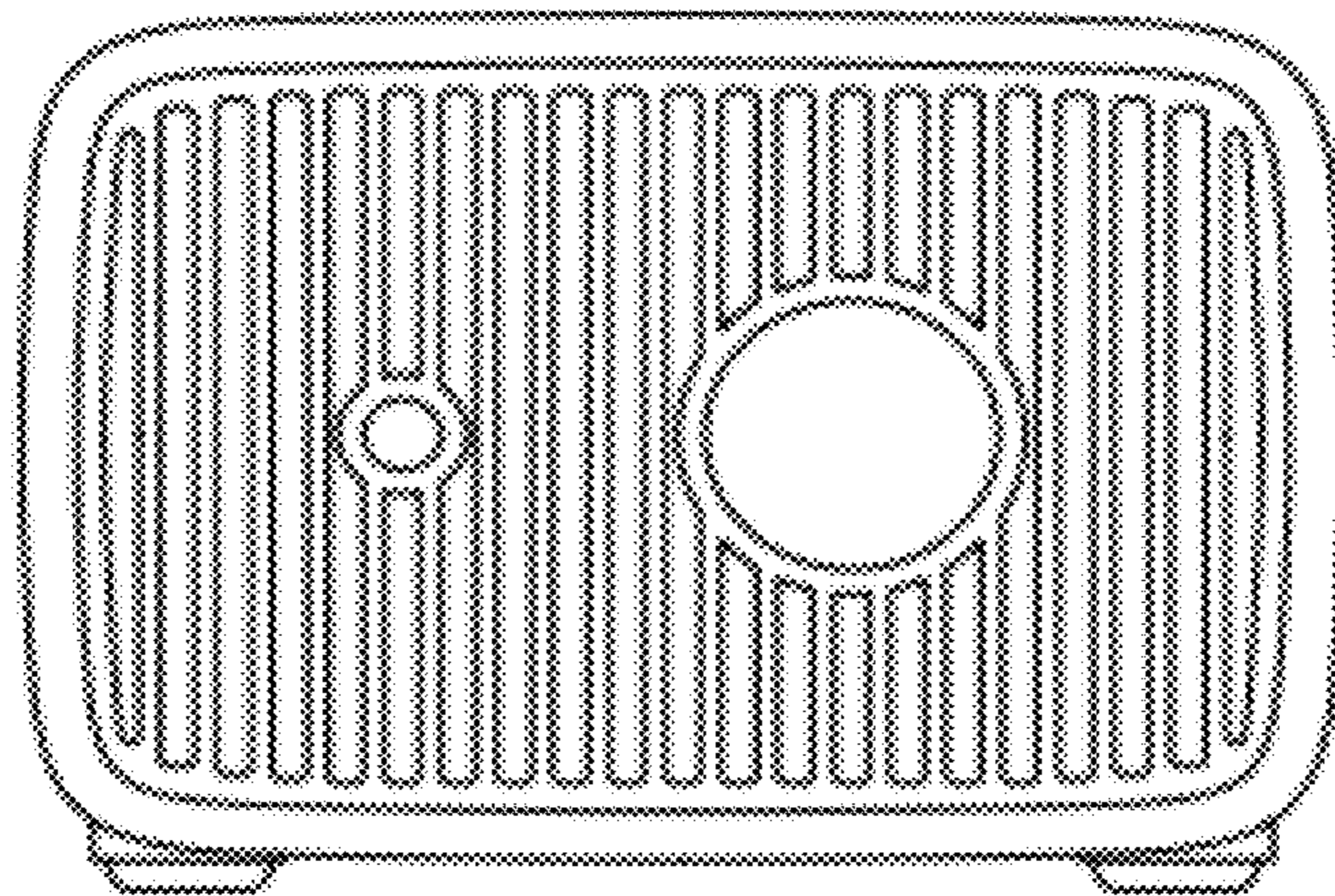

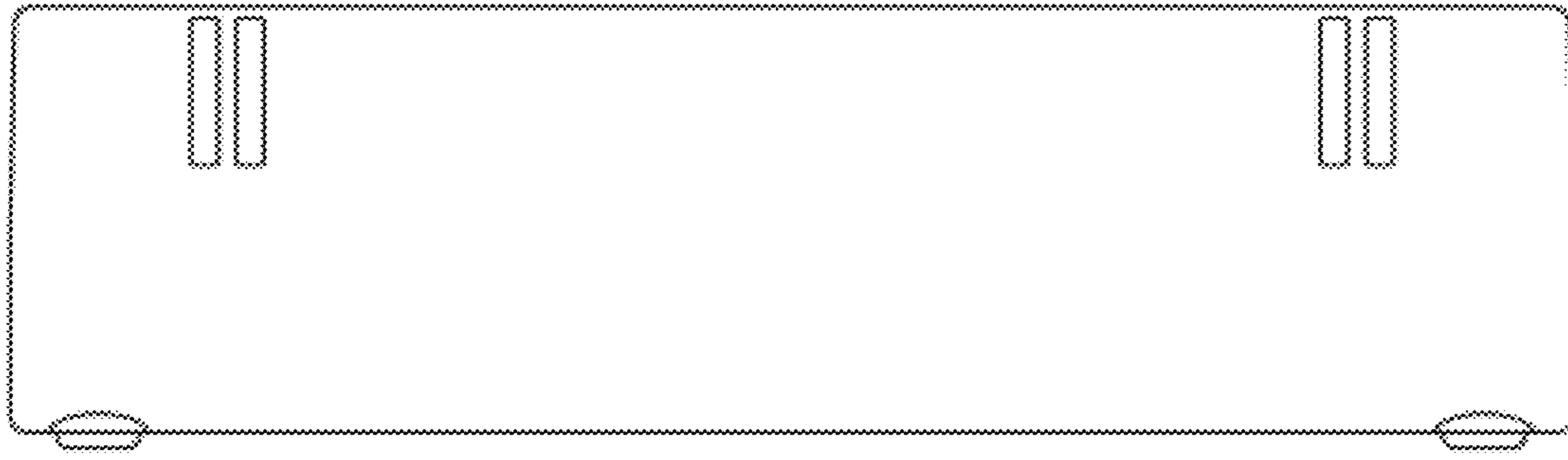

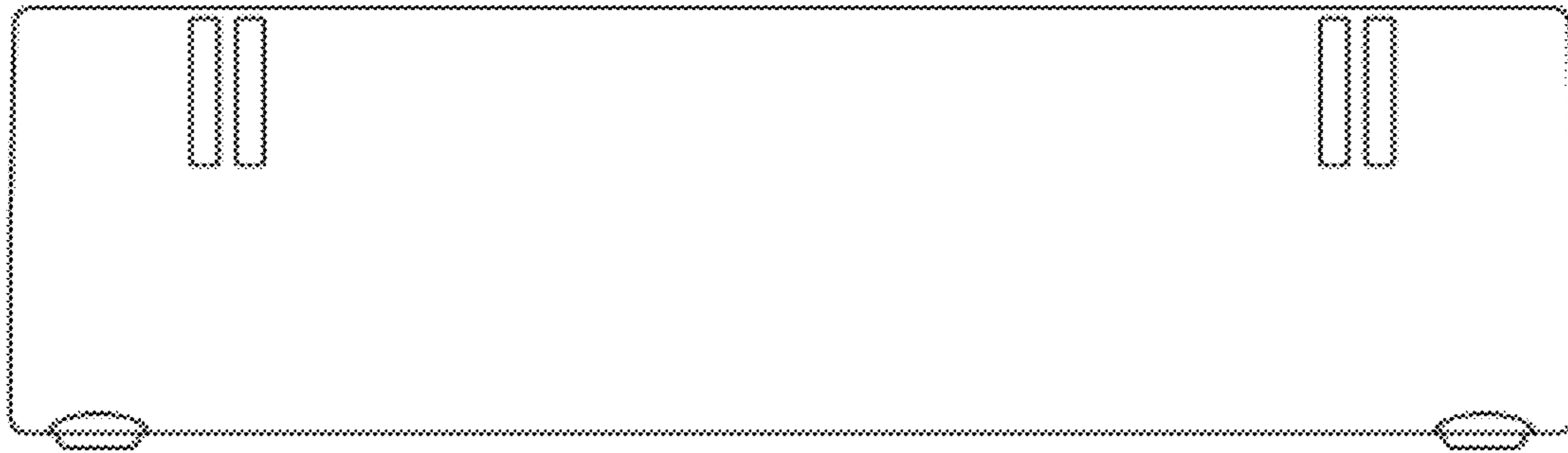
