I claim the ornamental design for a camera hole insert for phone case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a case showing our new design;

FIG. 2 is a bottom view of the case;

FIG. 3 is a side view of the case; and,

FIG. 4 is a top perspective view of the case.

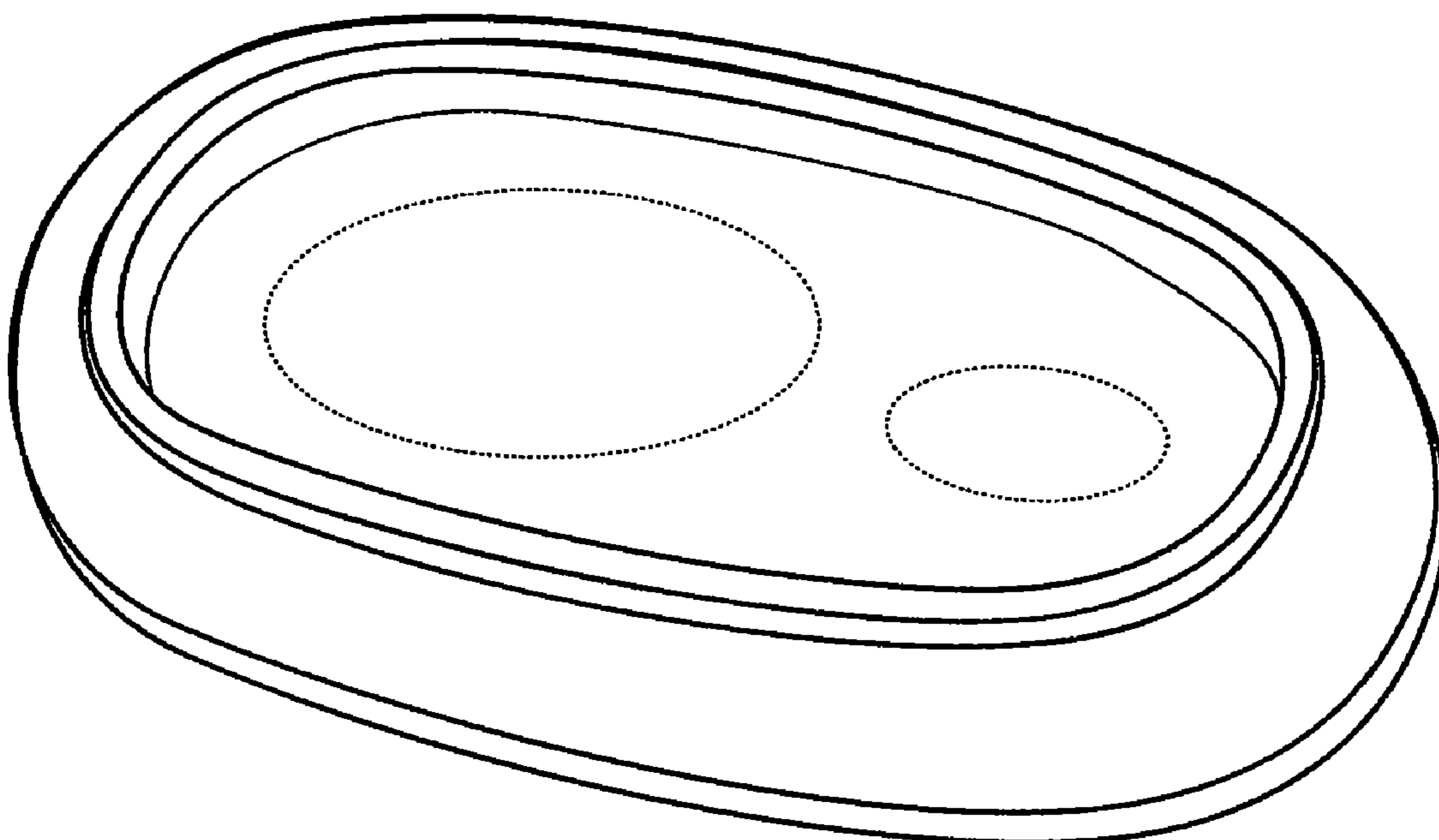

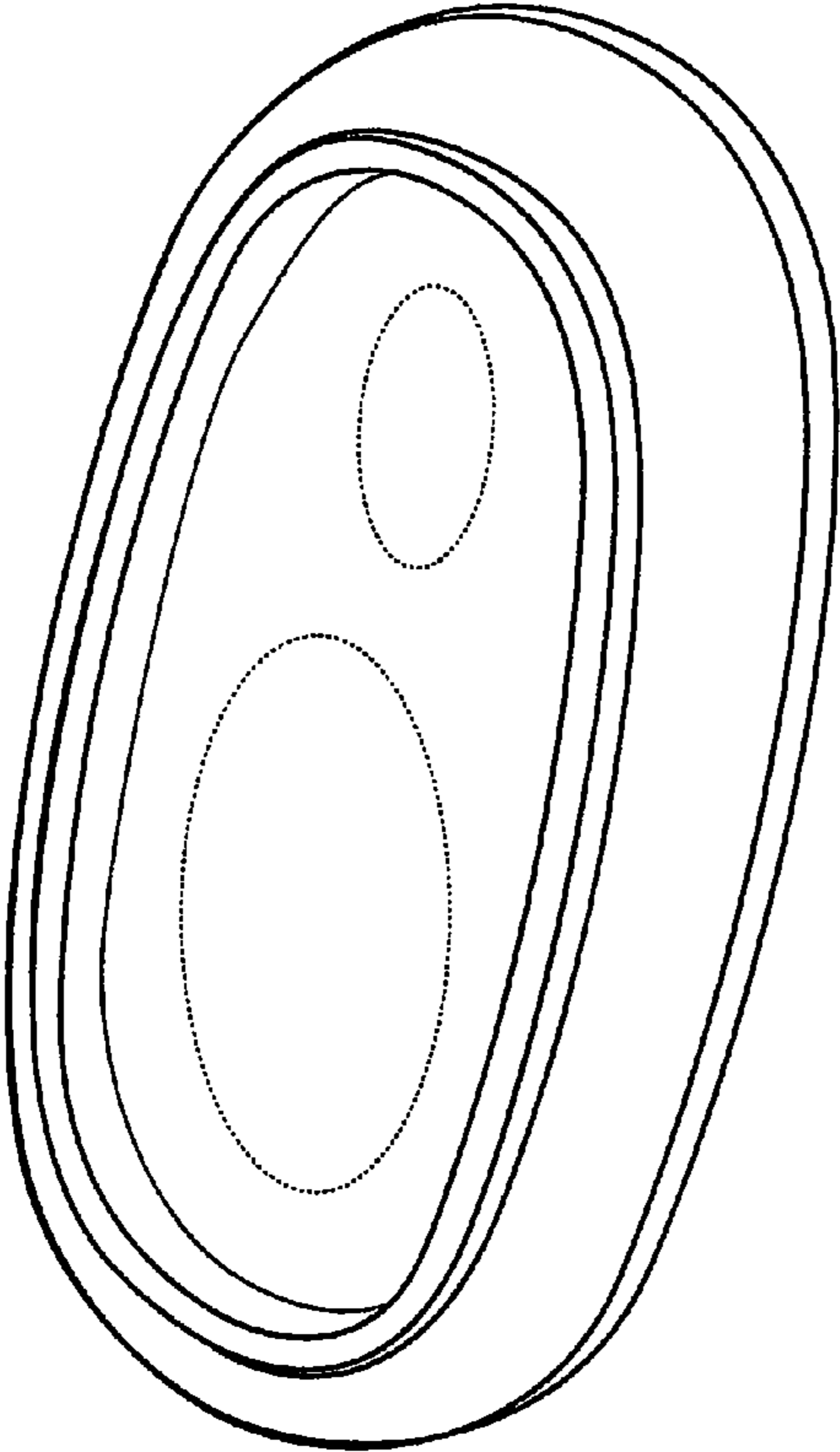

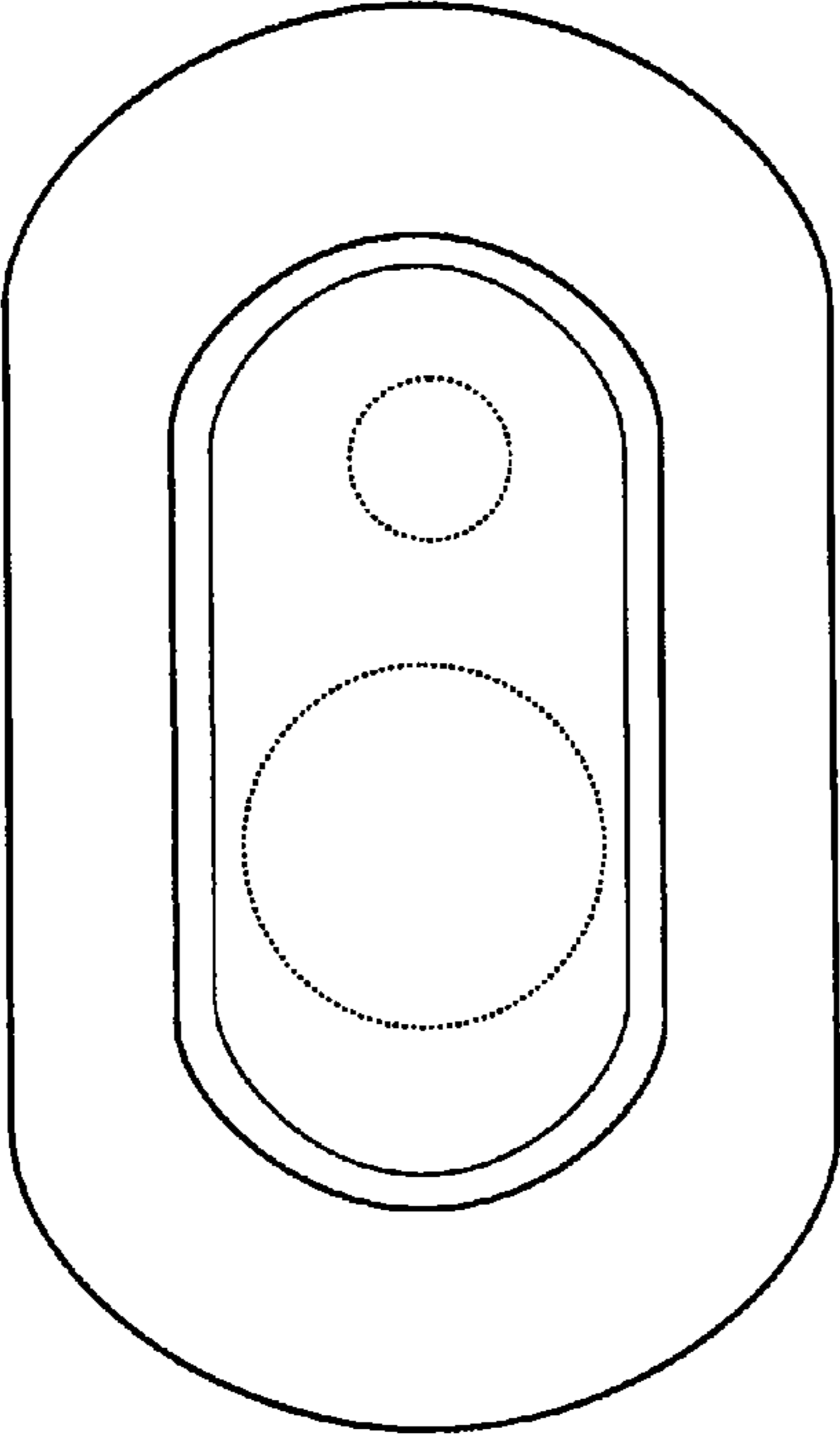

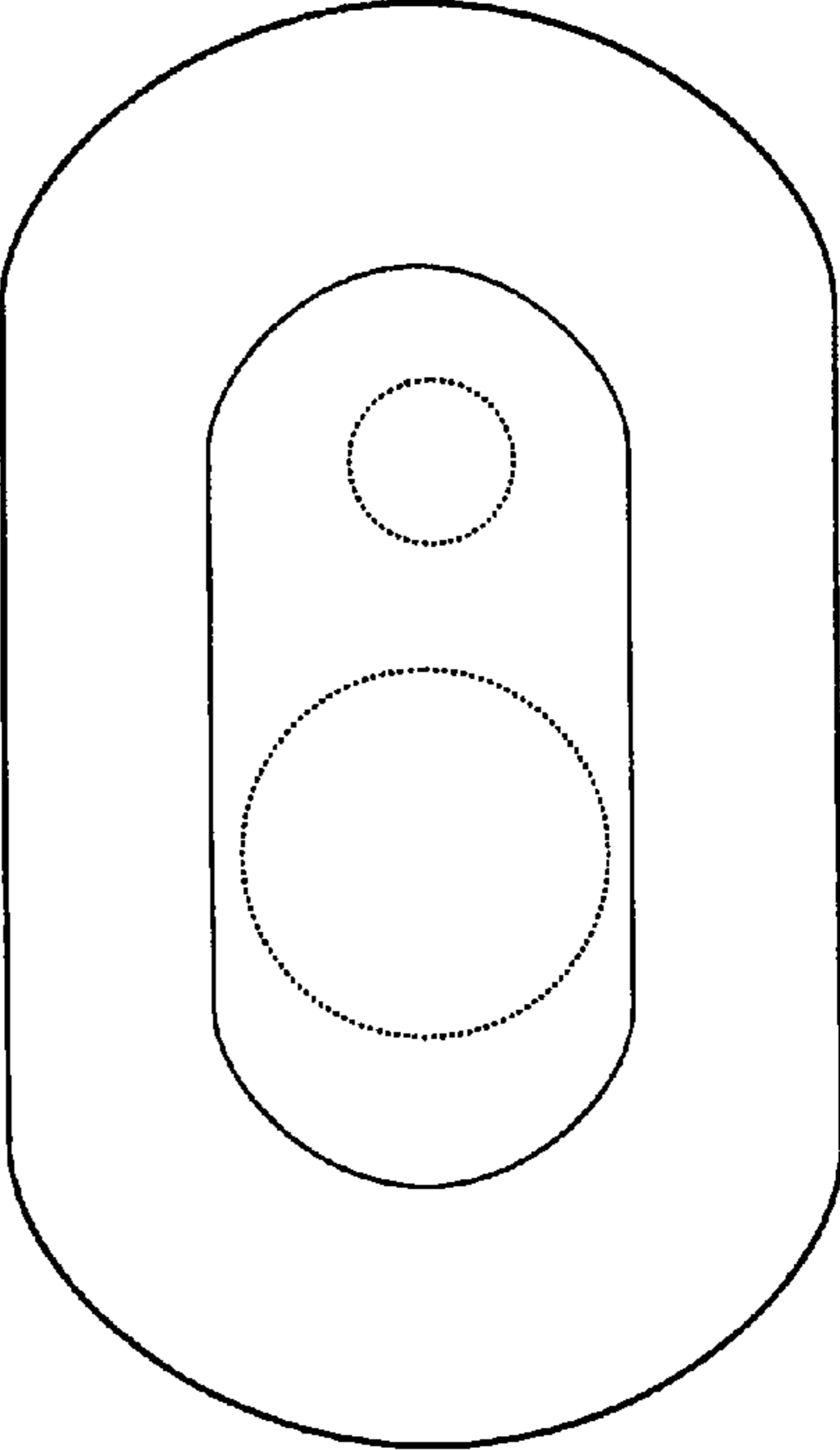
