FIG. 2 is the second image thereof;

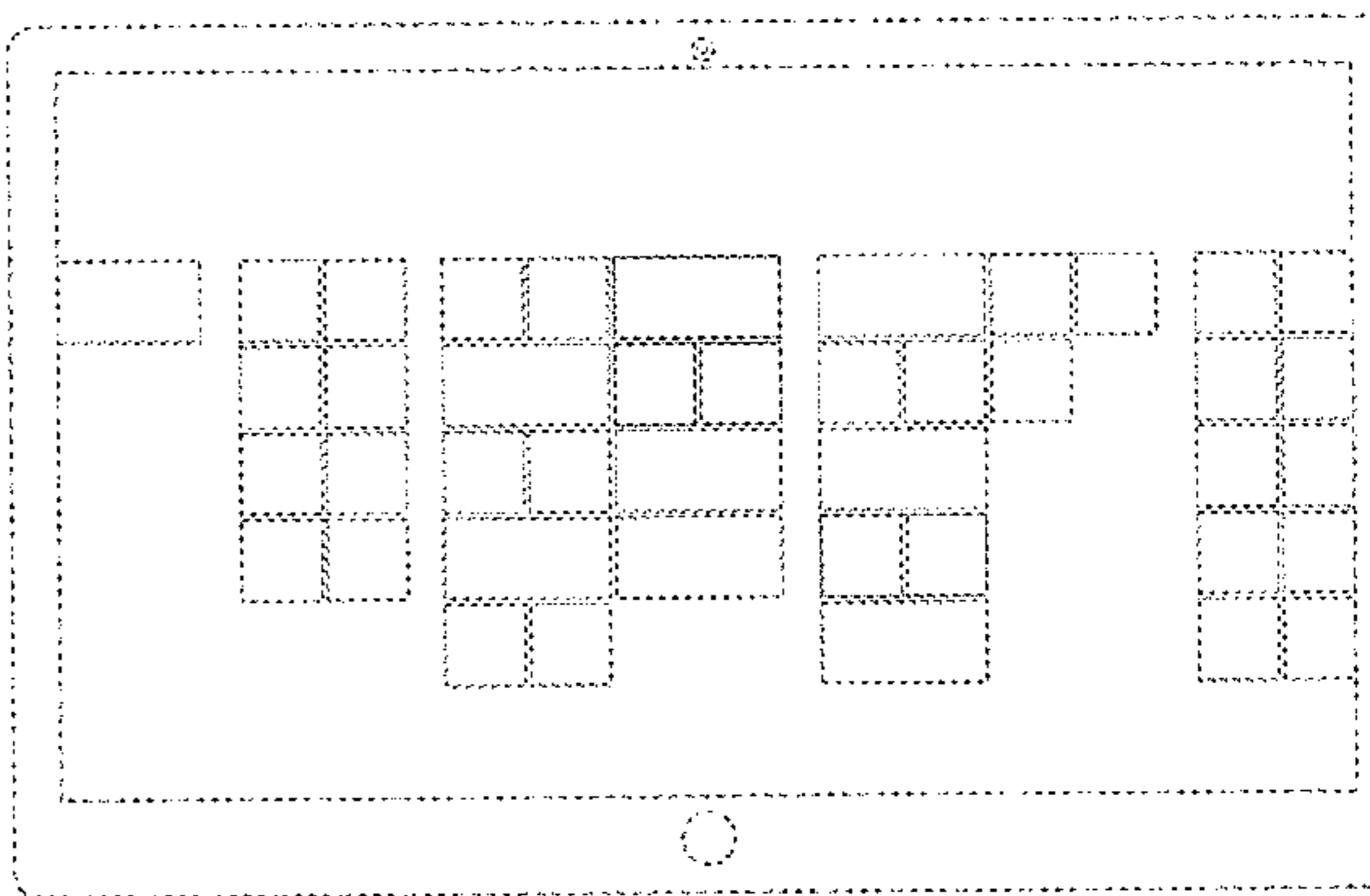
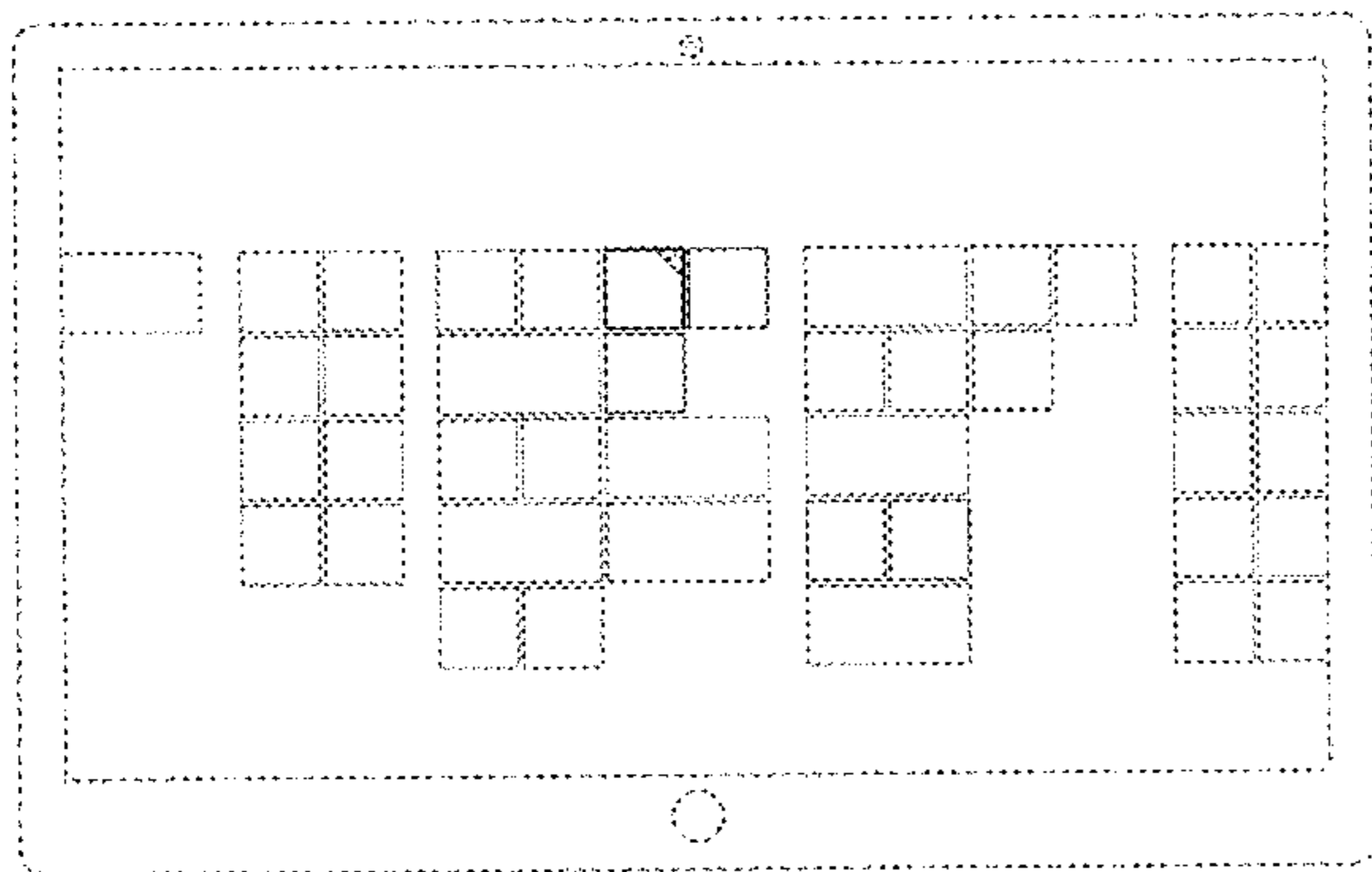
FIG. 3 is the third image thereof; and,

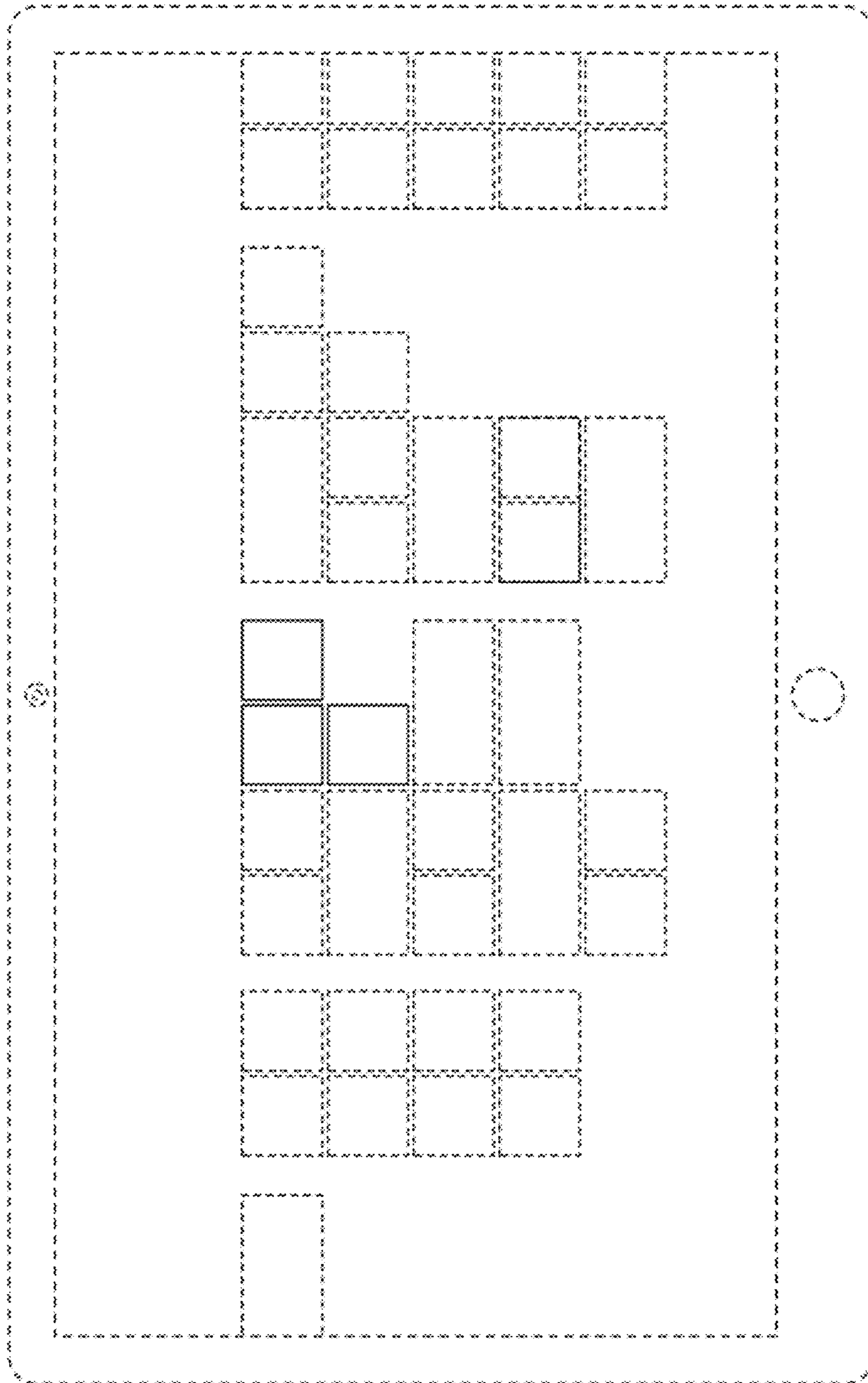

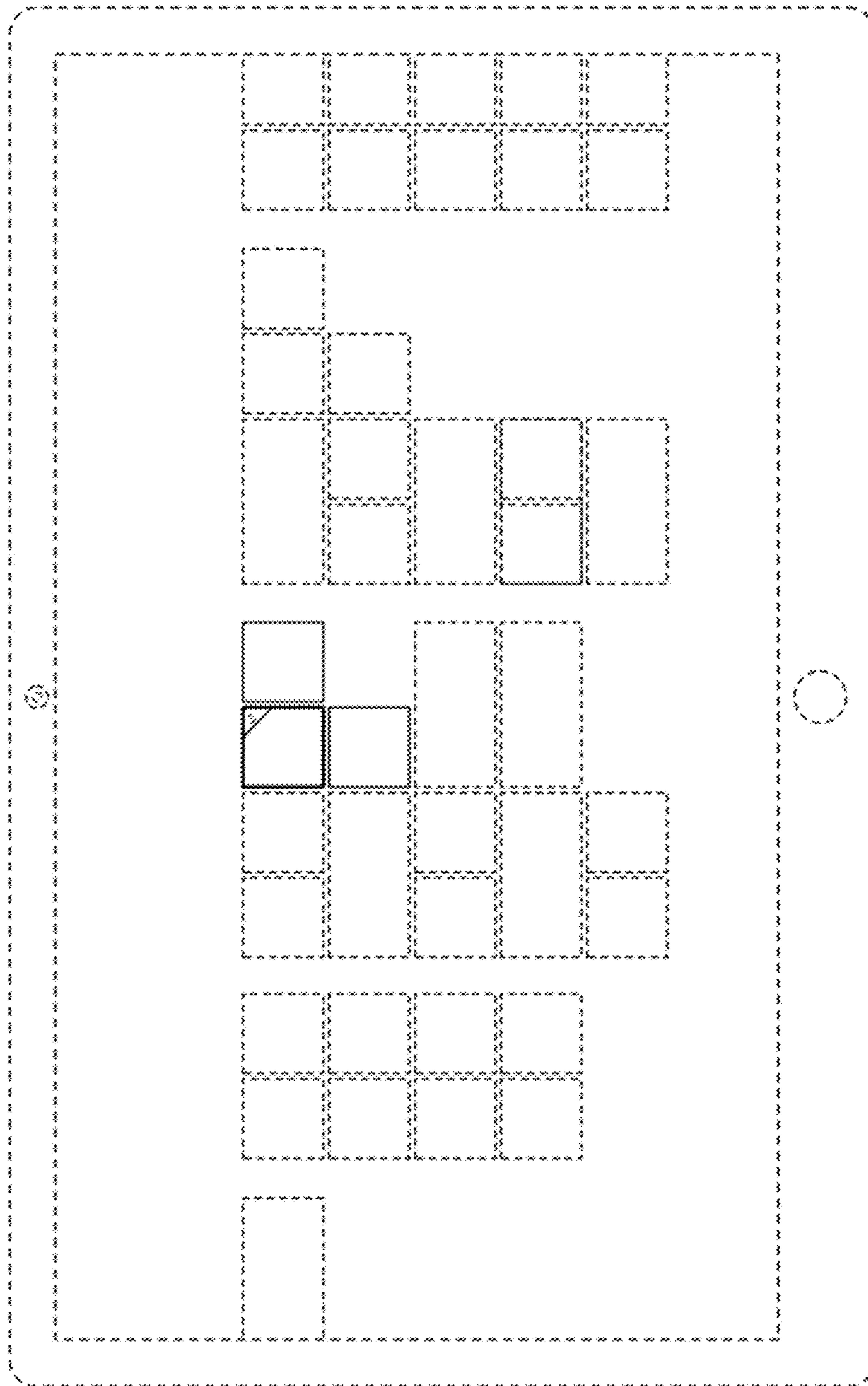
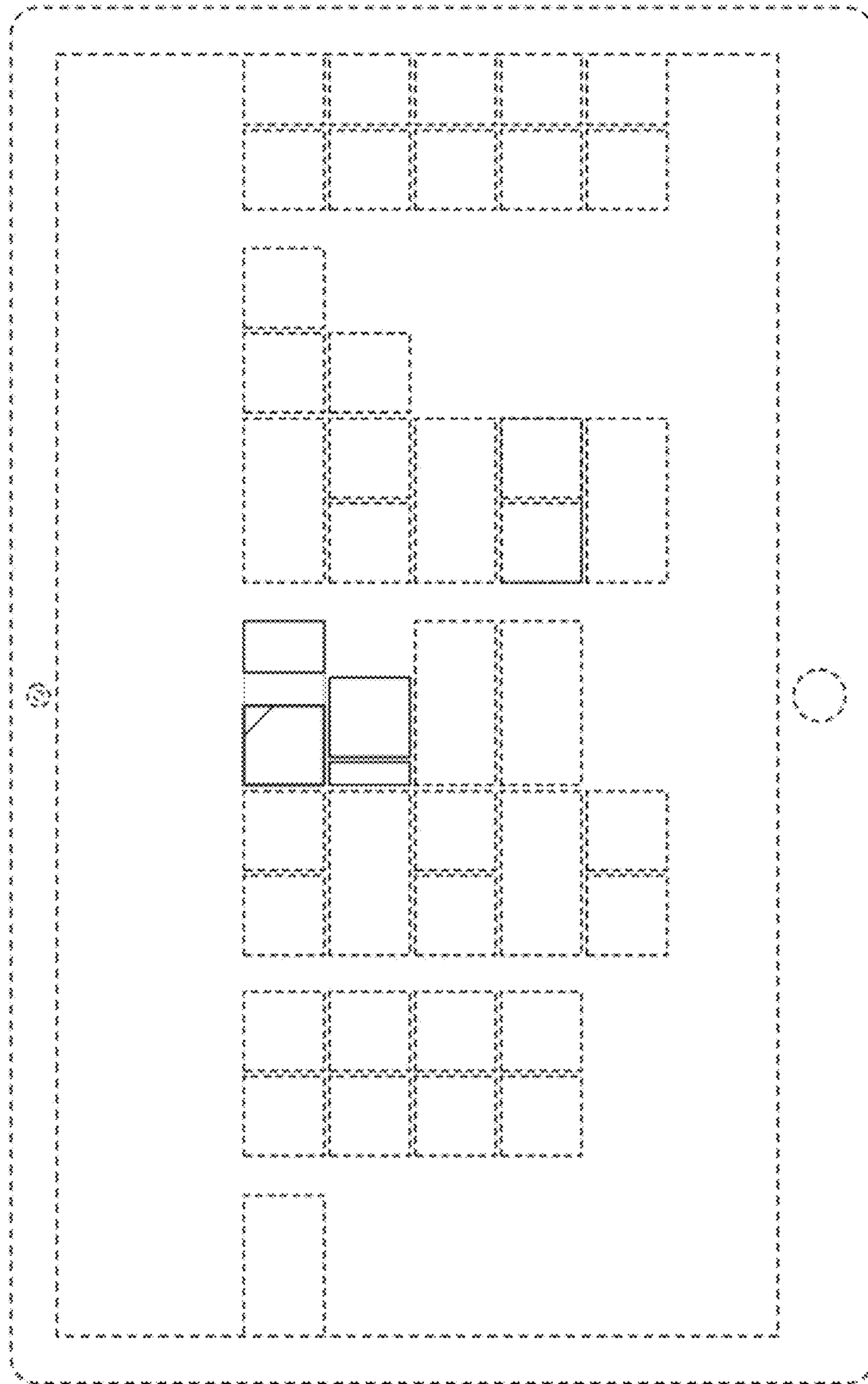

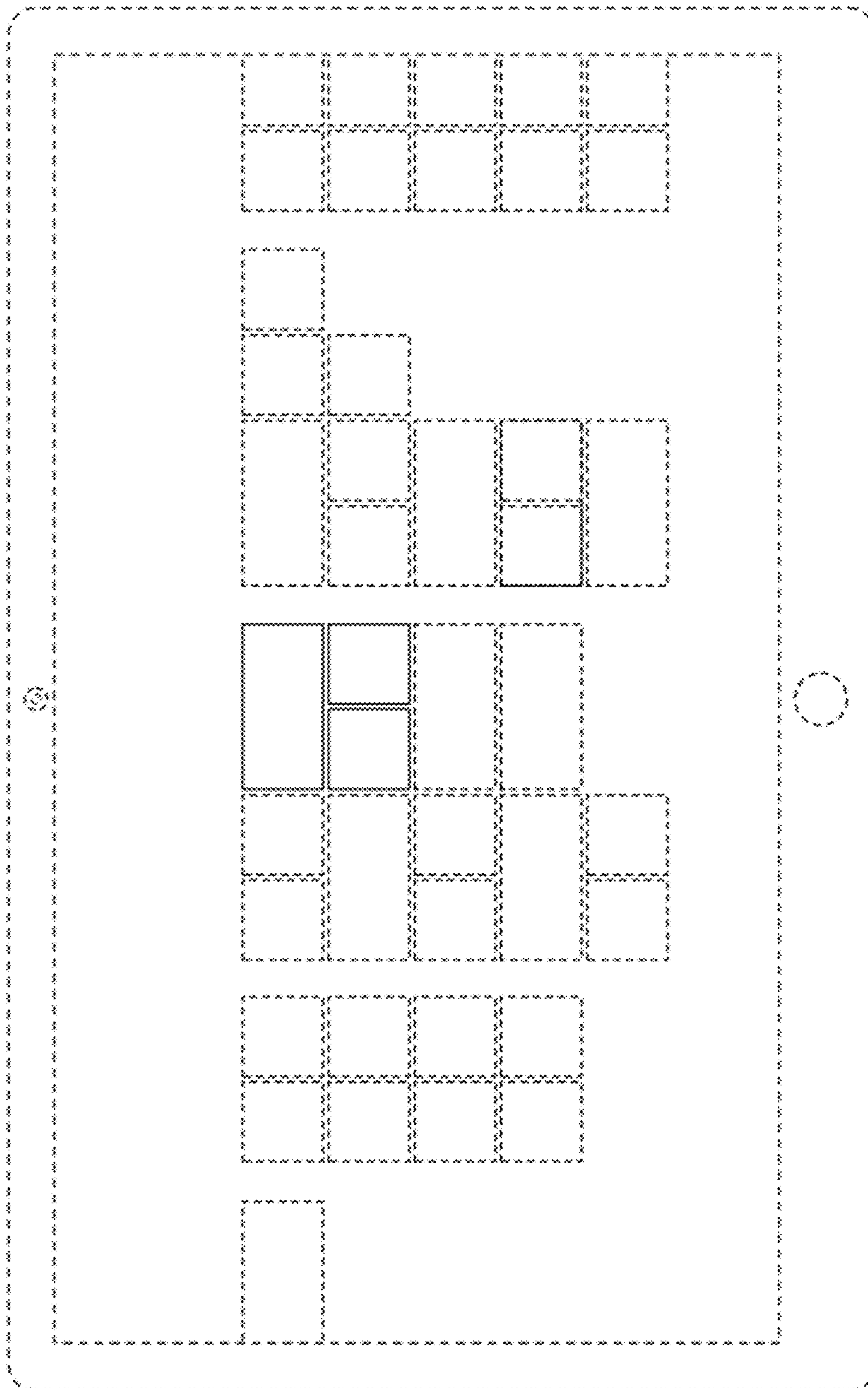
