The ornamental design for an display panel or screen portion with icon, as shown and described.

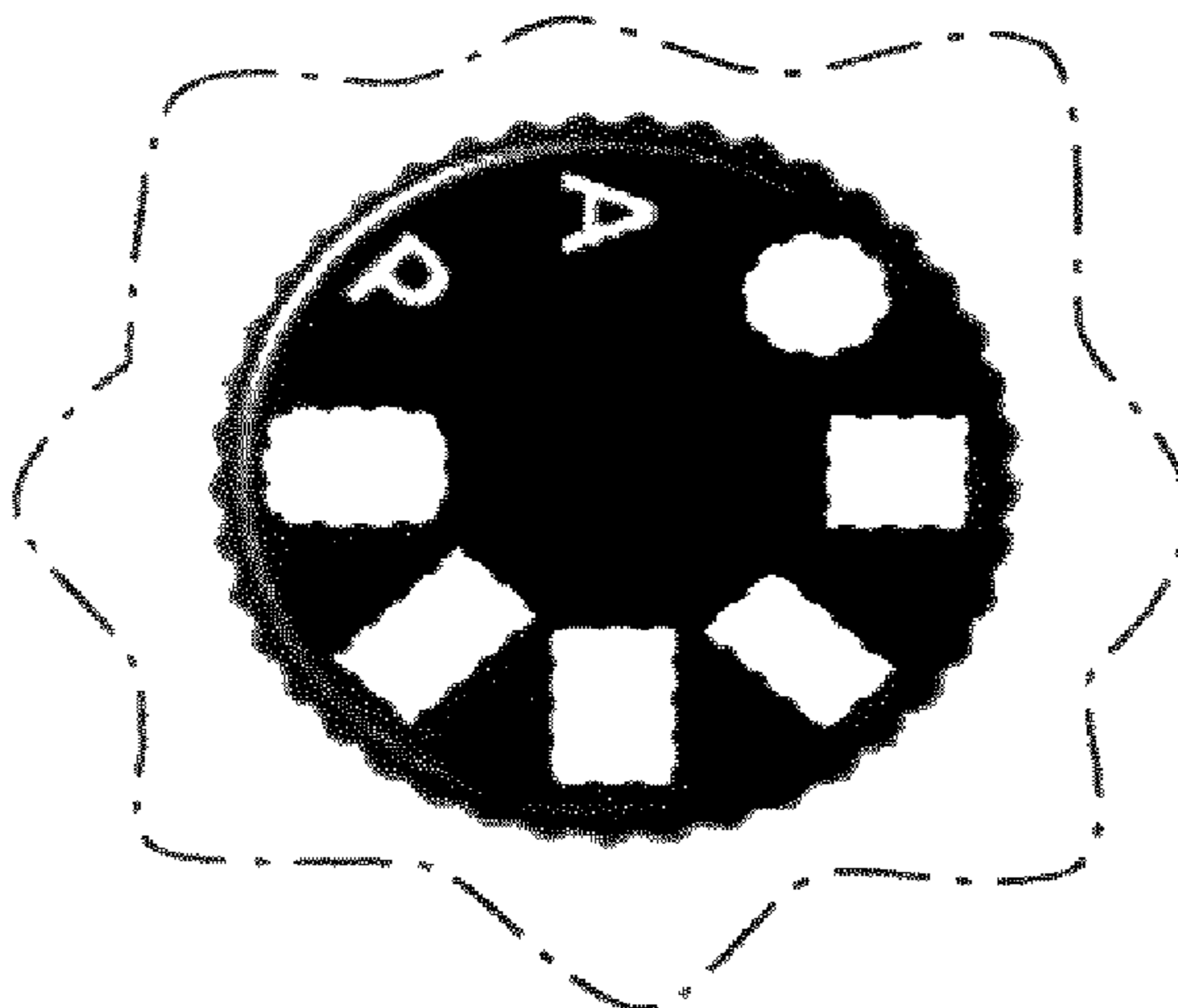
DESCRIPTION
