(57) **CLAIM**

The ornamental design for lawn care vehicle hood assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a lawn care vehicle having a hood assembly in accordance with an embodiment of the present invention;

FIG. 2 is an isolated top perspective view of the hood assembly of FIG. 1;

FIG. 3 is a left side view of the hood assembly of FIG. 1;

FIG. 4 is a right side view of the hood assembly of FIG. 1;

FIG. 5 is a front view of the hood assembly of FIG. 1;

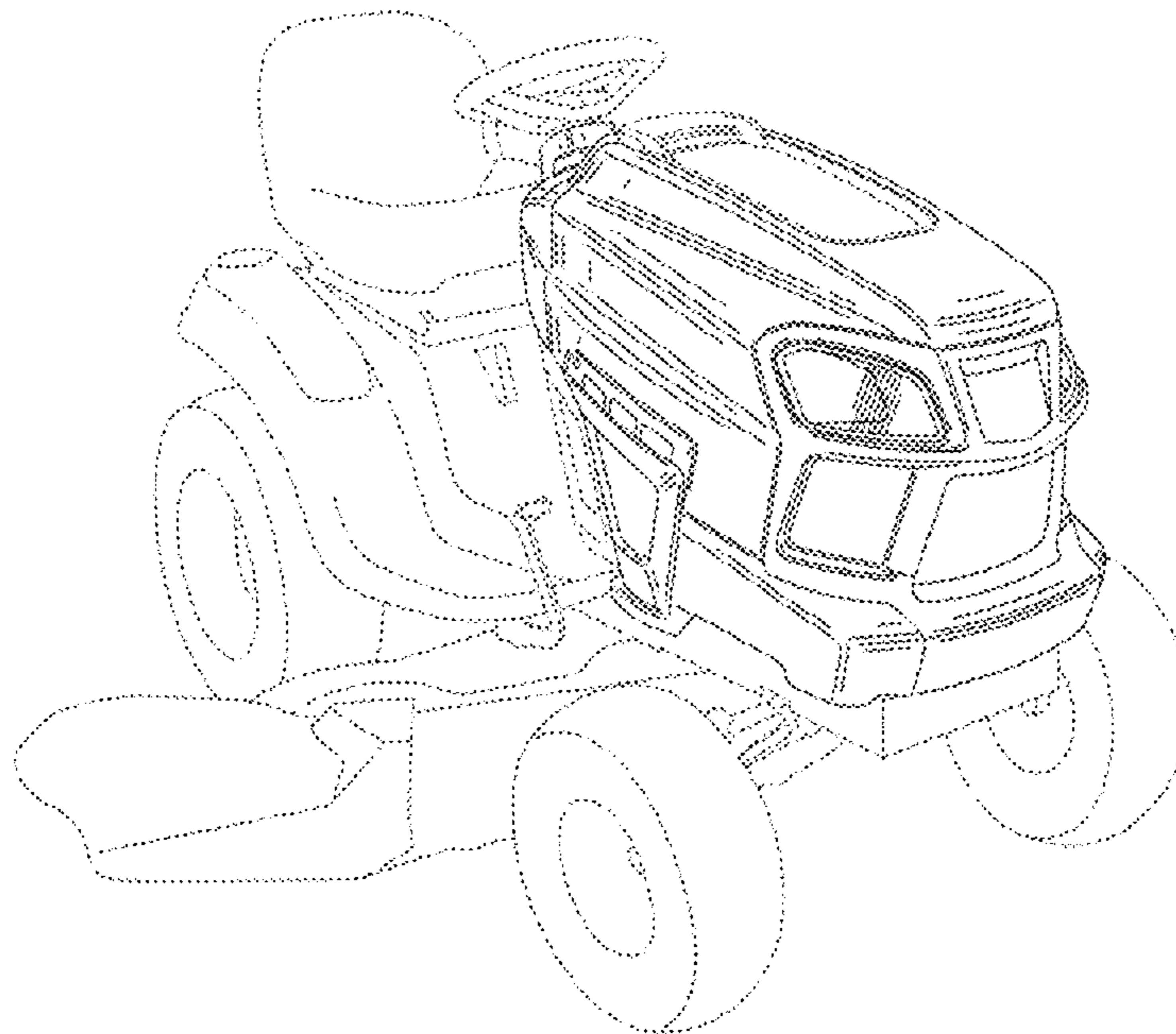
FIG. 6 is a rear view of the hood assembly of FIG. 1;

FIG. 7 is a top view of the hood assembly of FIG. 1; and,

FIG. 8 is a bottom view of the hood assembly of FIG. 1.

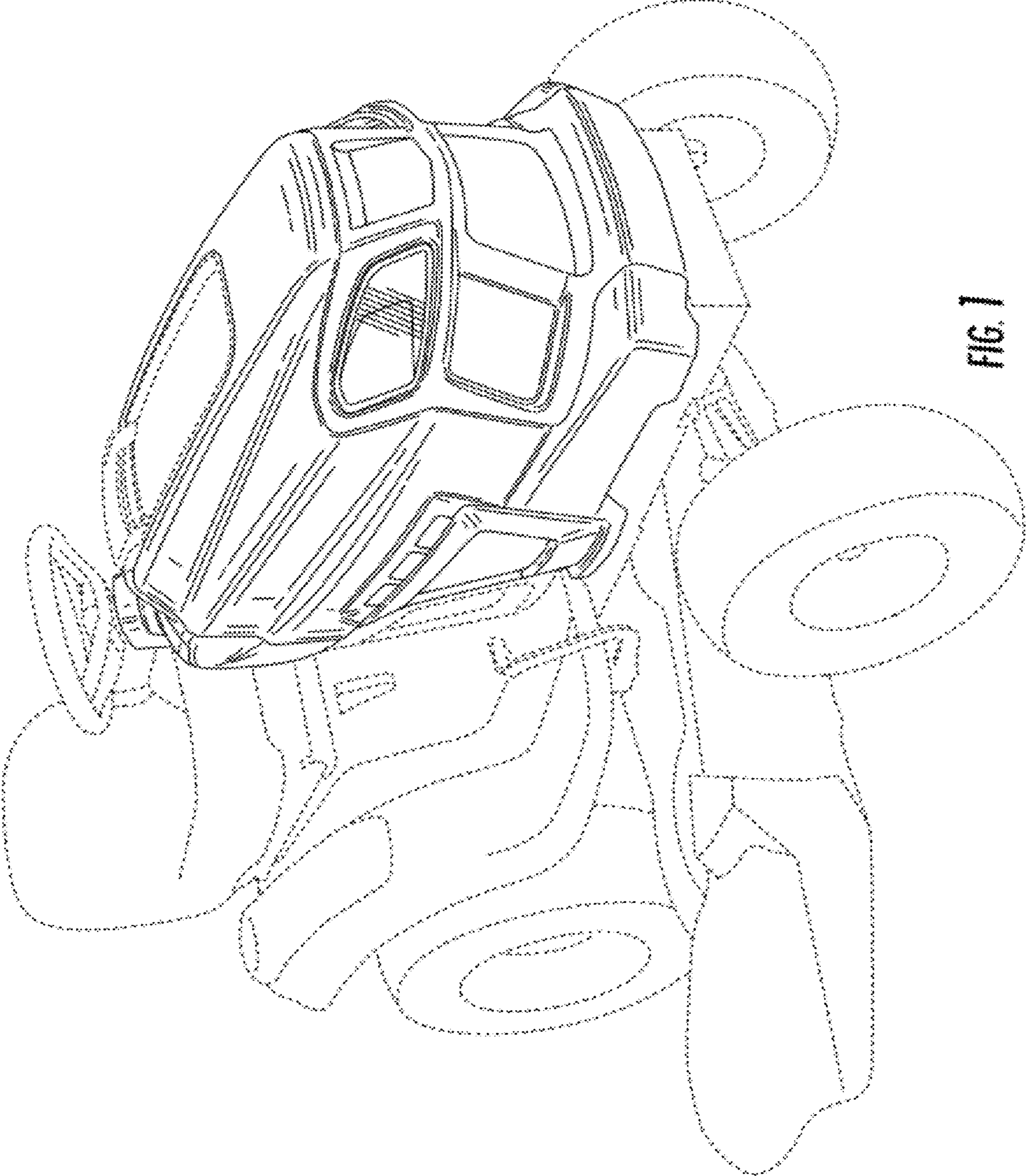

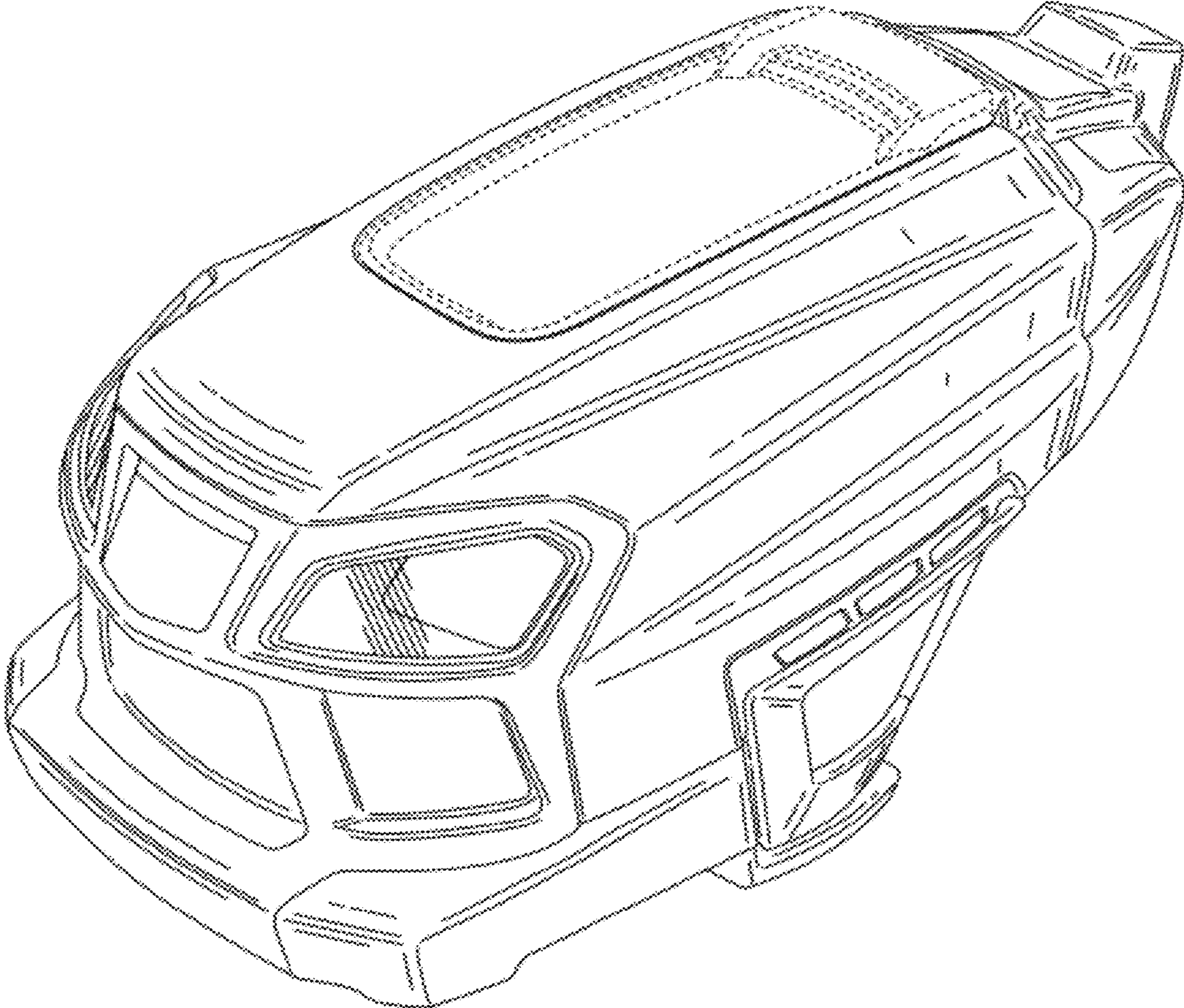

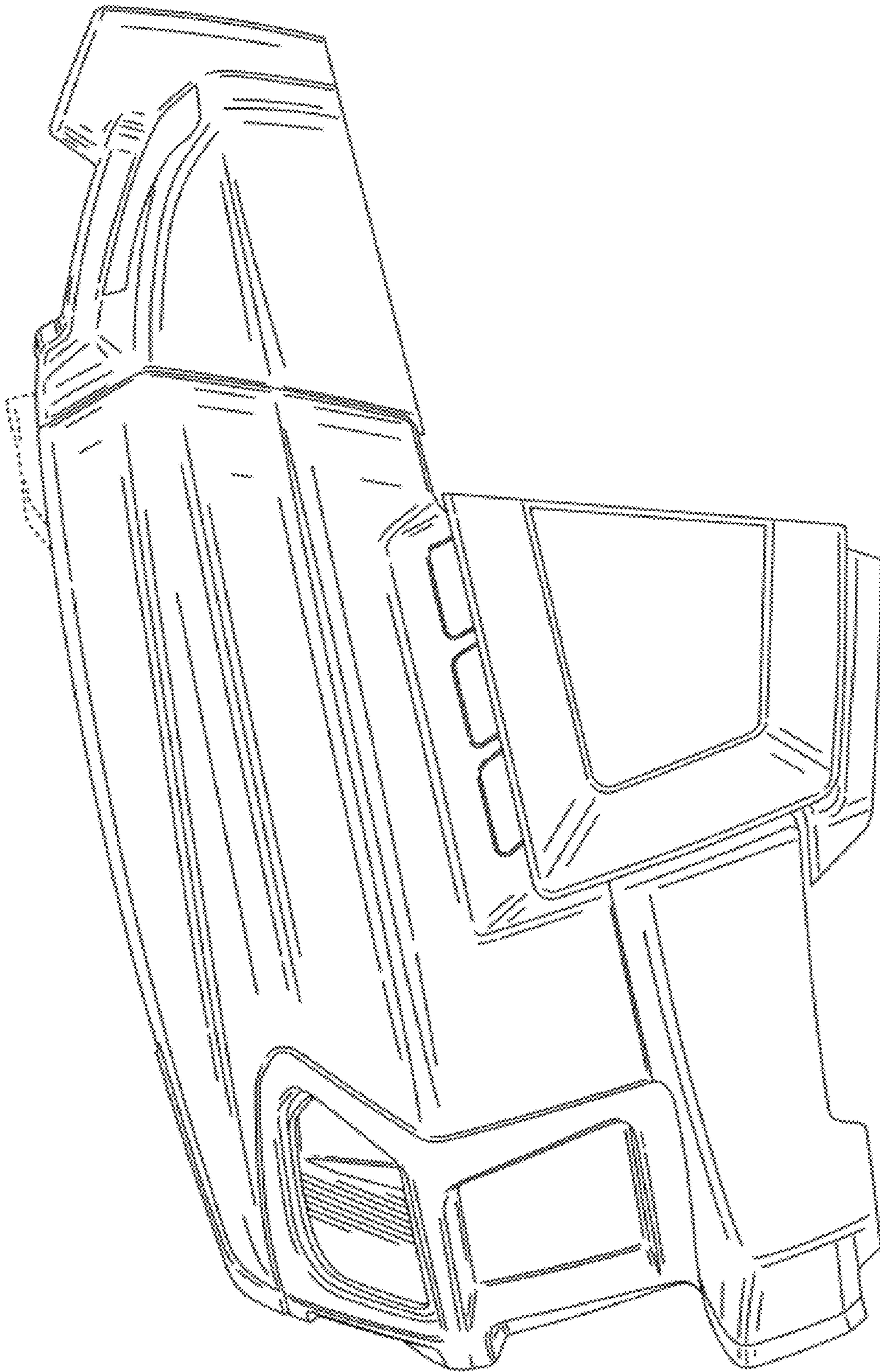

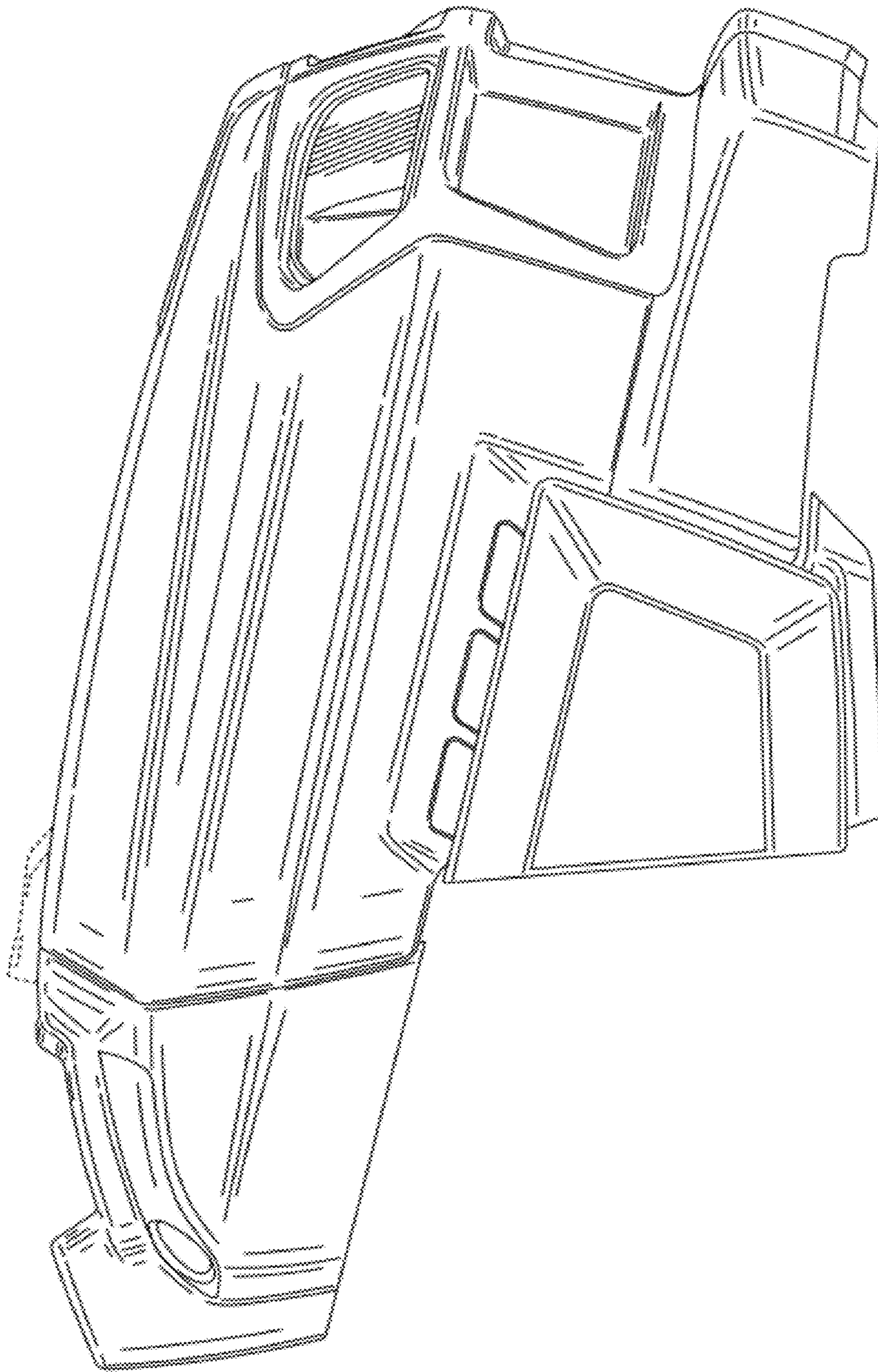

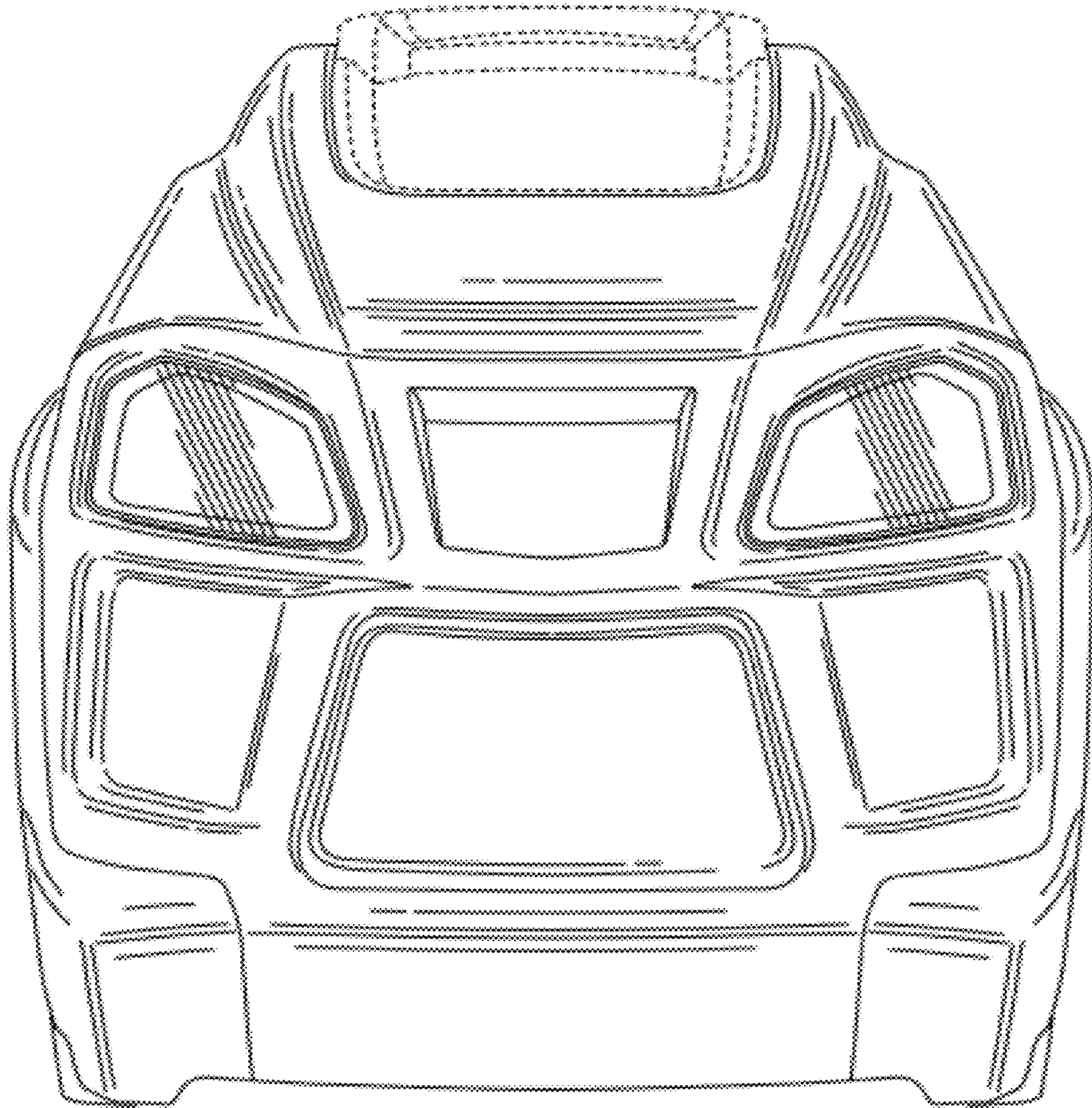

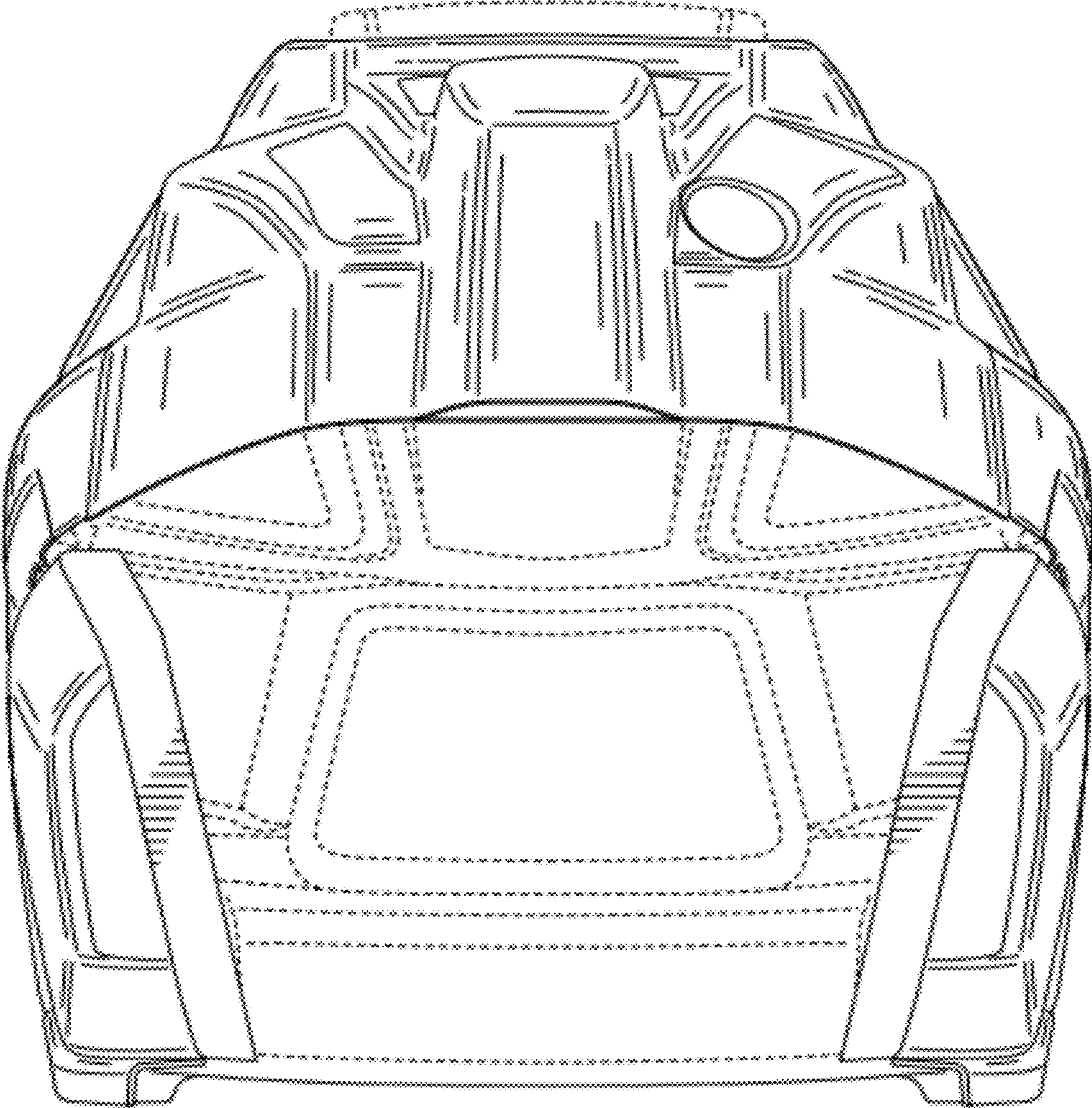

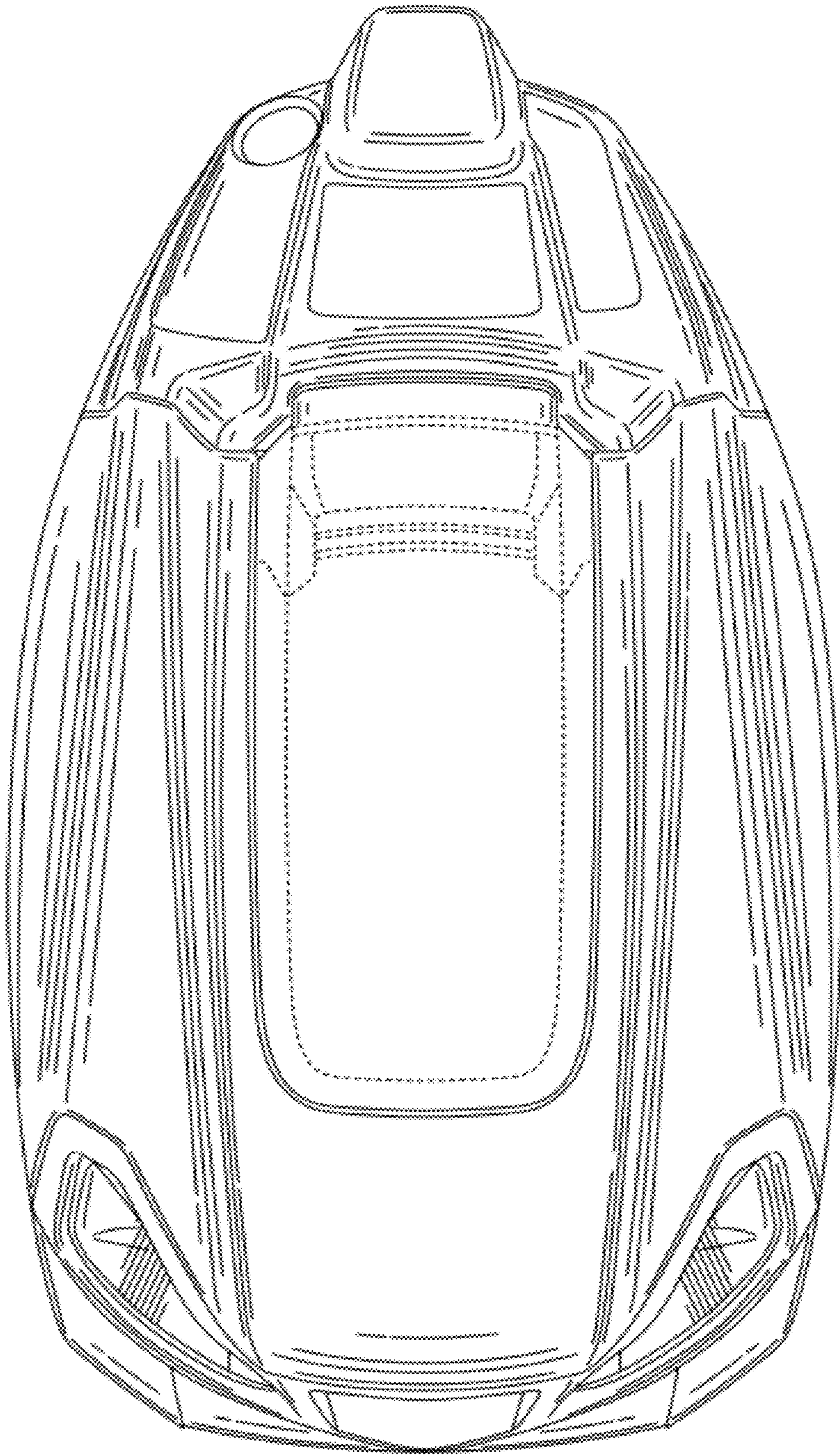

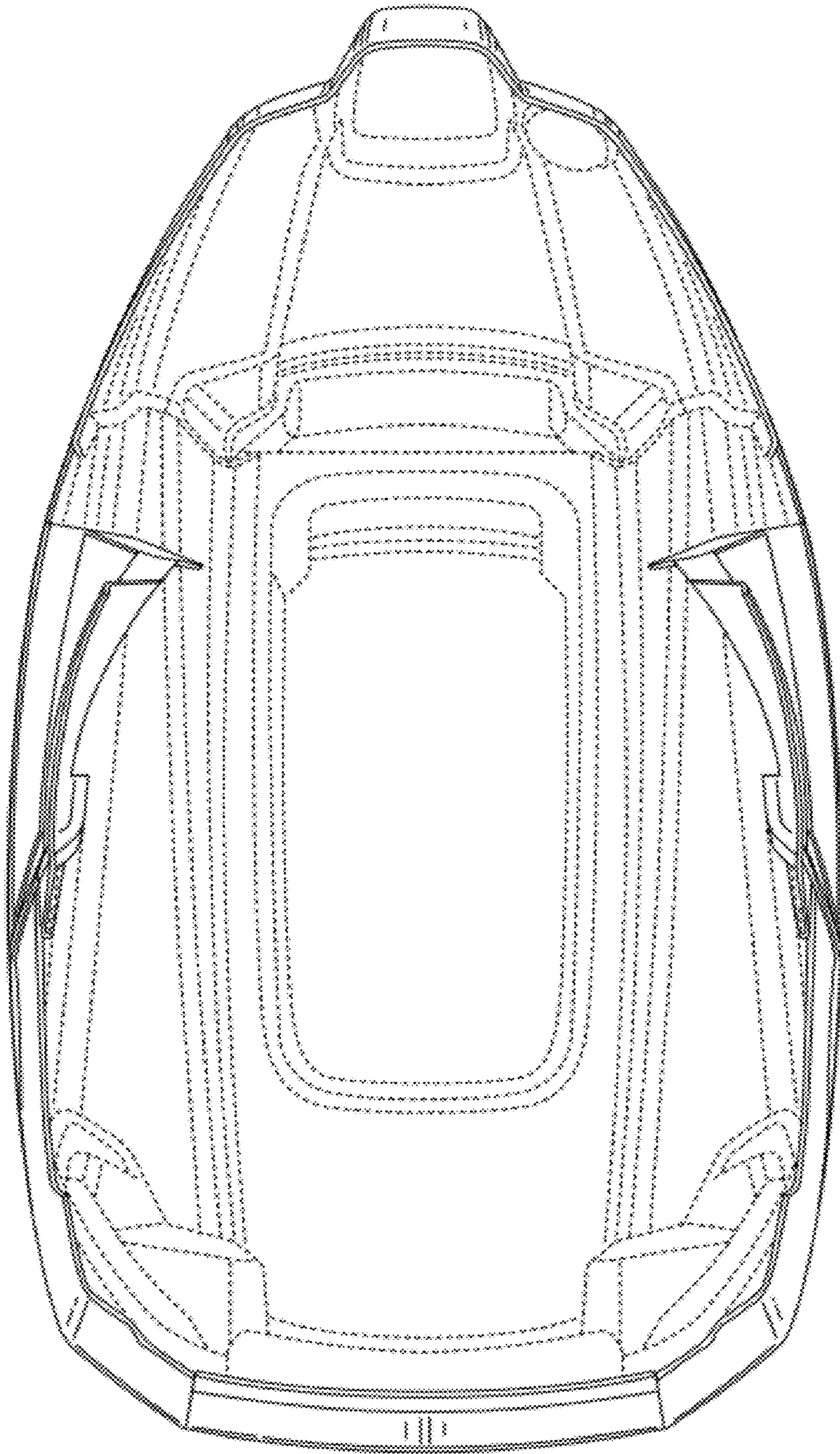
