The ornamental design for hand stamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of our design for the hand stamp;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side view thereof (the right side being a mirror image of the left side view); and,  
FIG. 5 is a top plan view thereof.

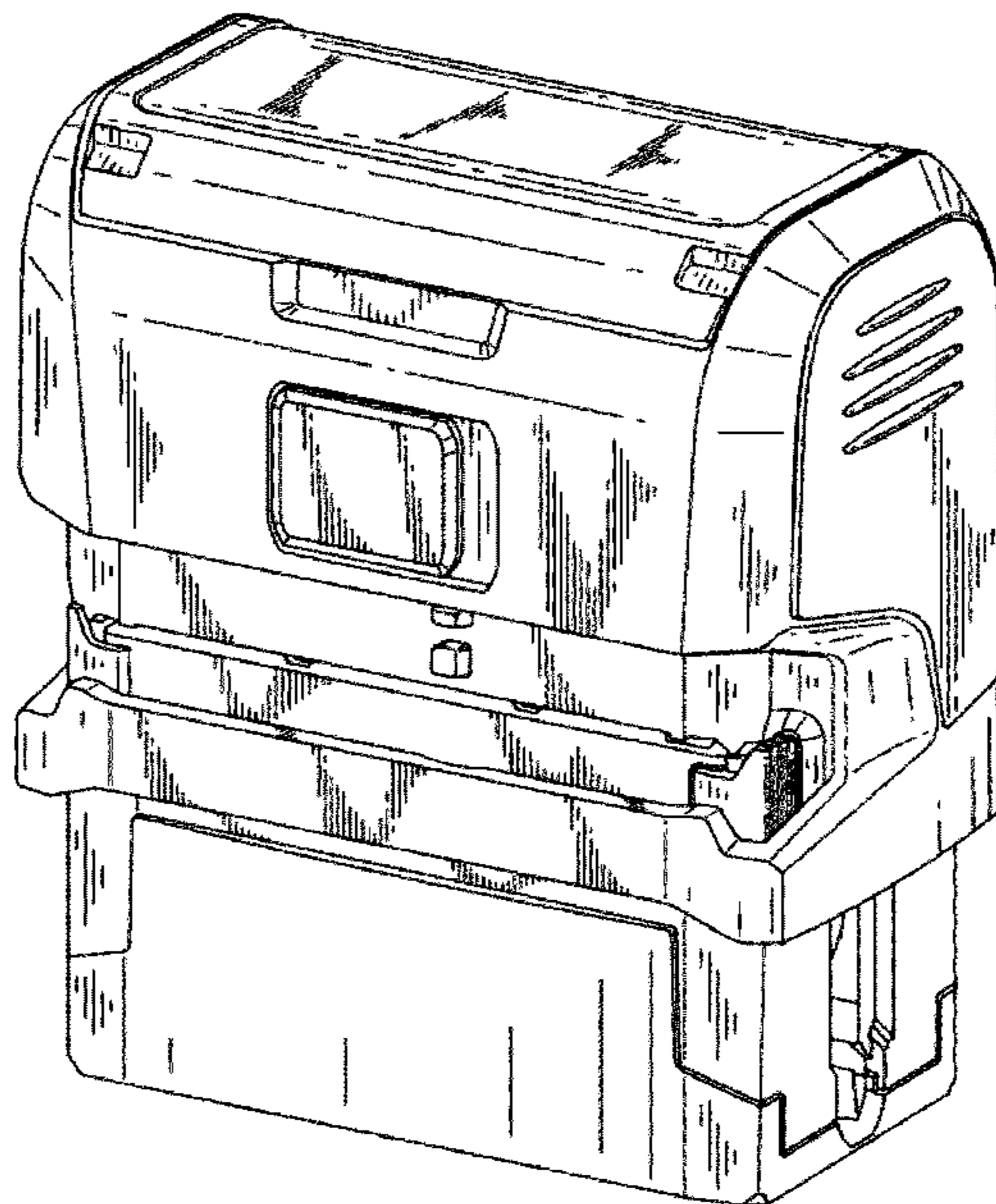

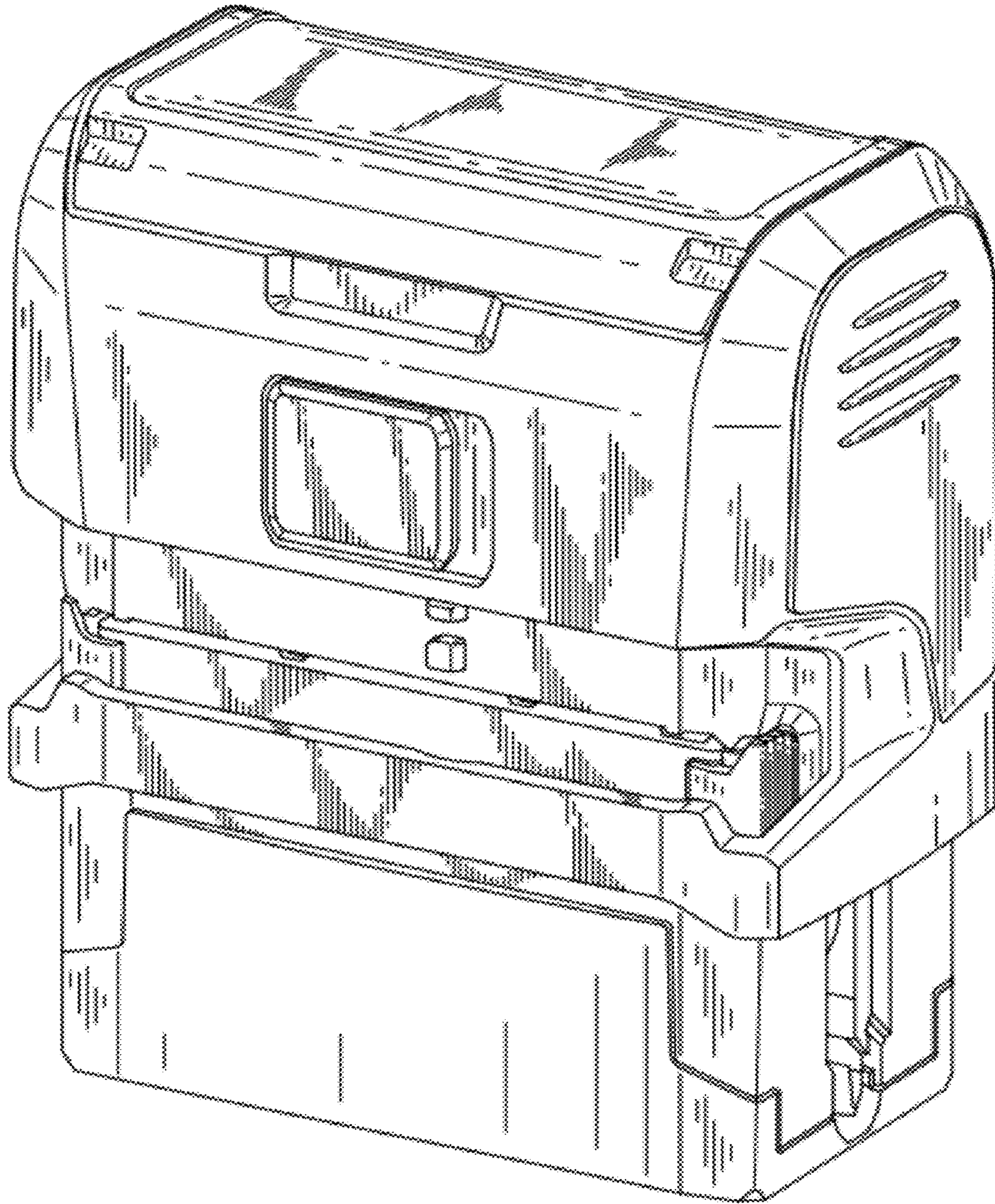

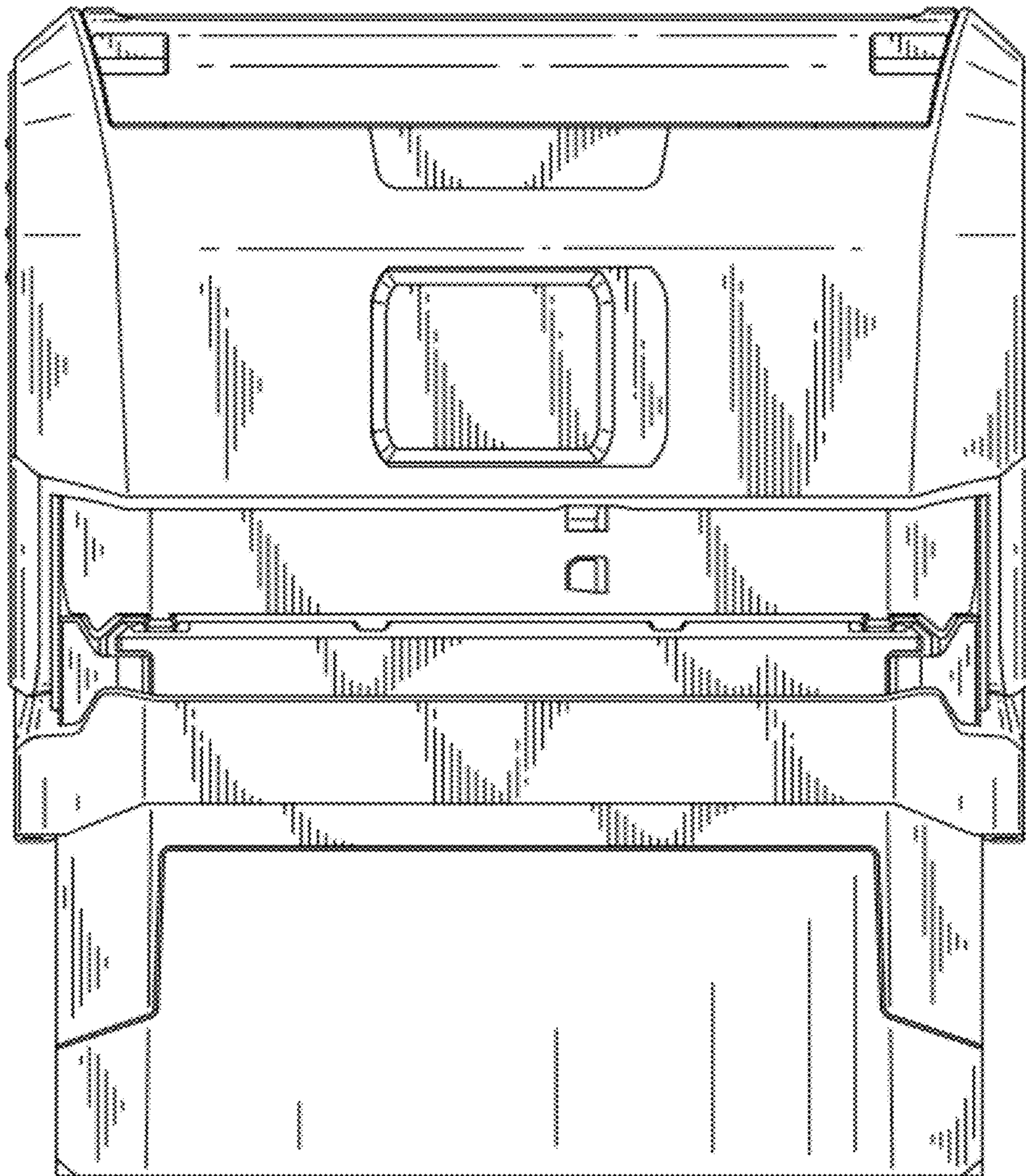

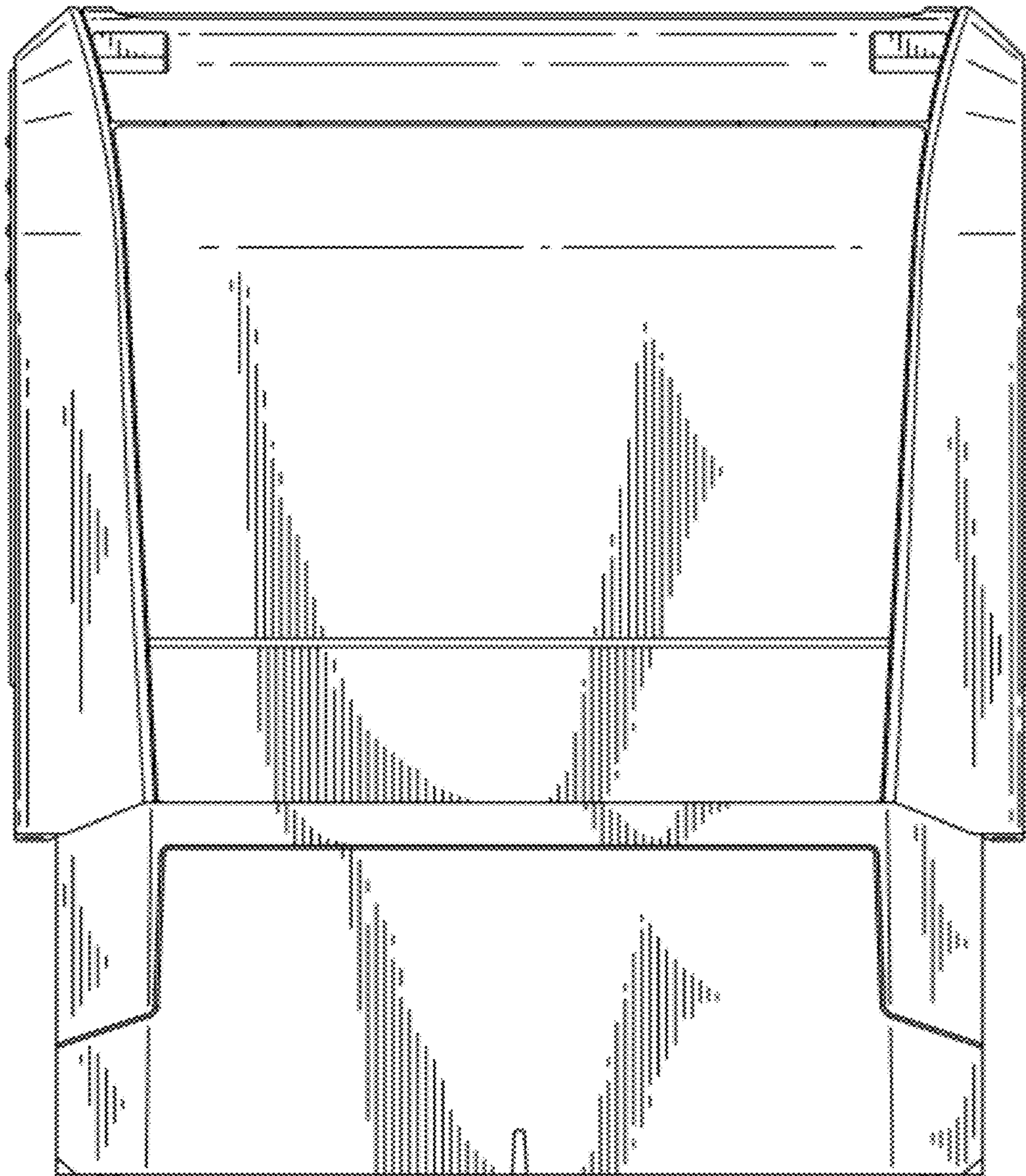

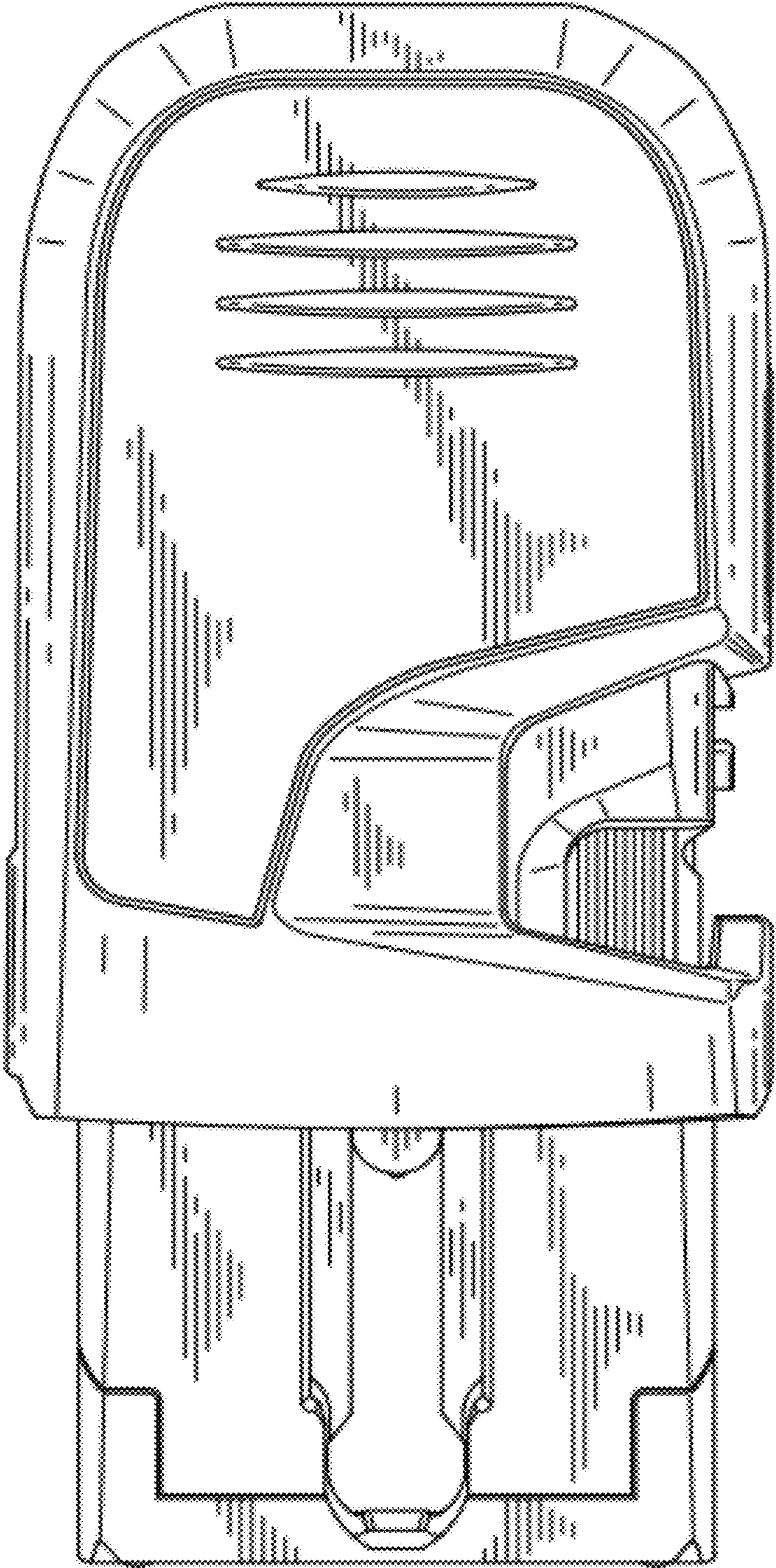
