(57) **CLAIM**

The ornamental design for a desk blotter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a desk blotter showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front side elevational view thereof;

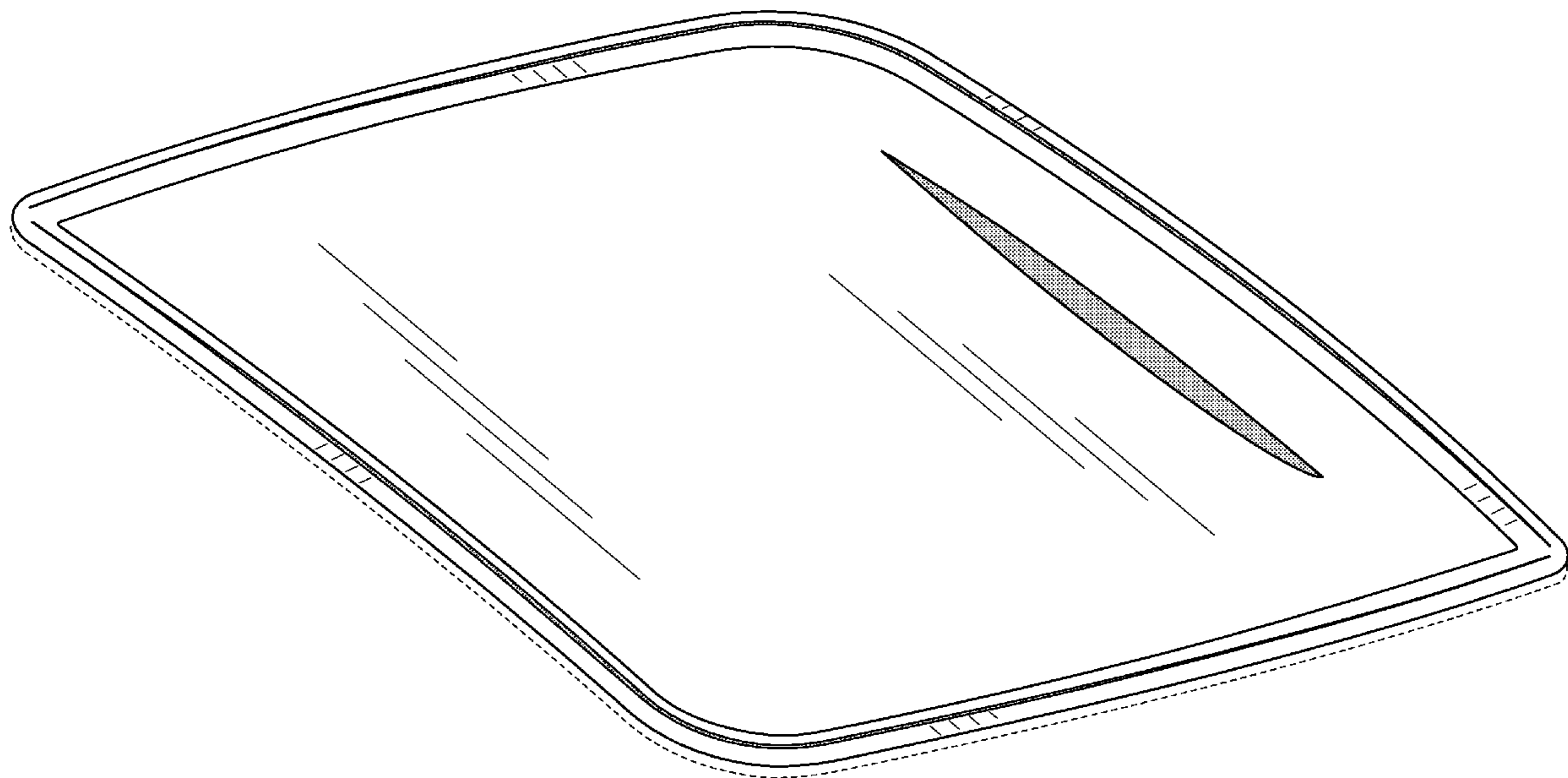
FIG. 4 is a rear side elevational view thereof;

FIG. 5 is a right side view thereof; and,

FIG. 6 is a left side view thereof.

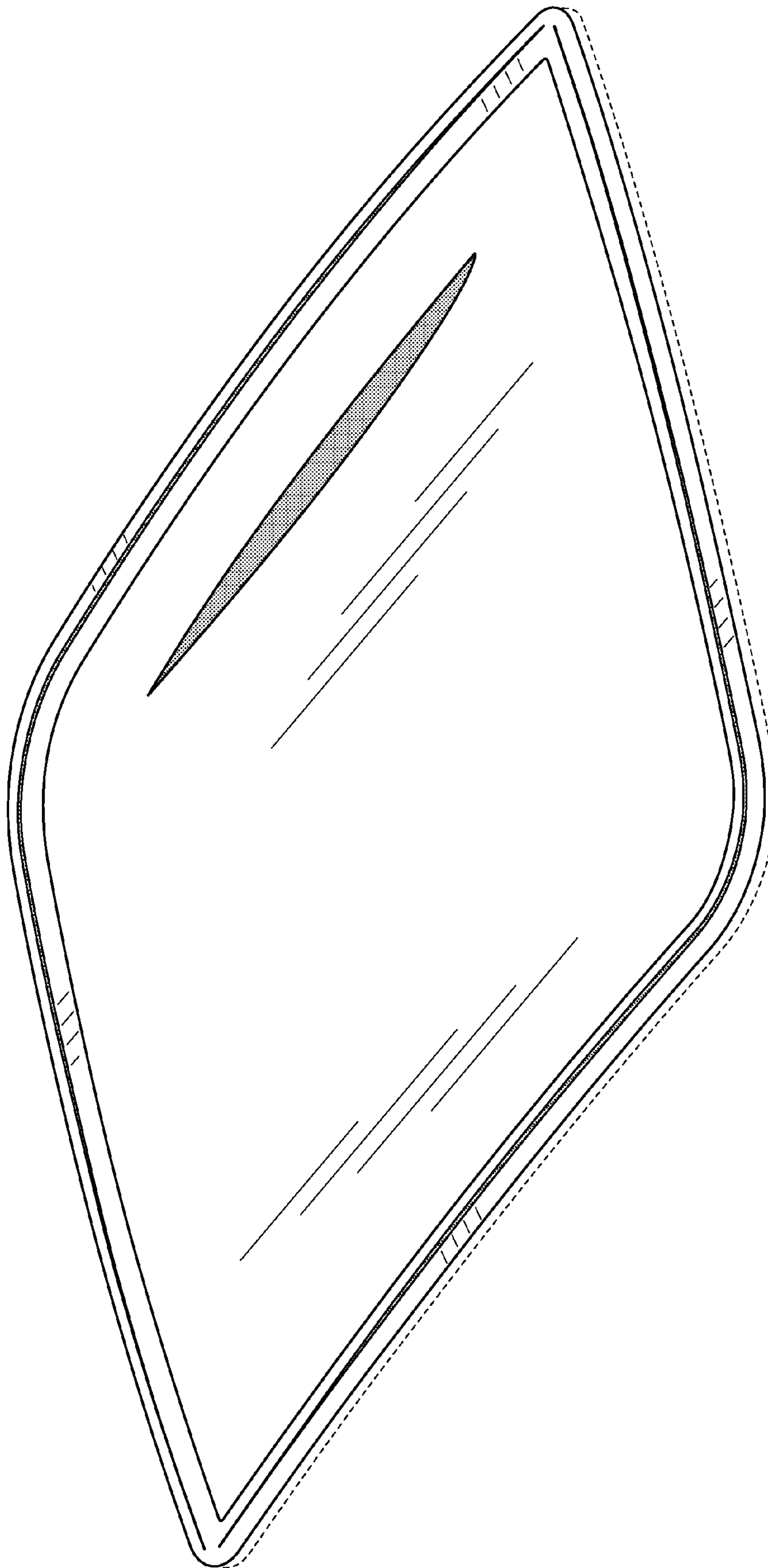

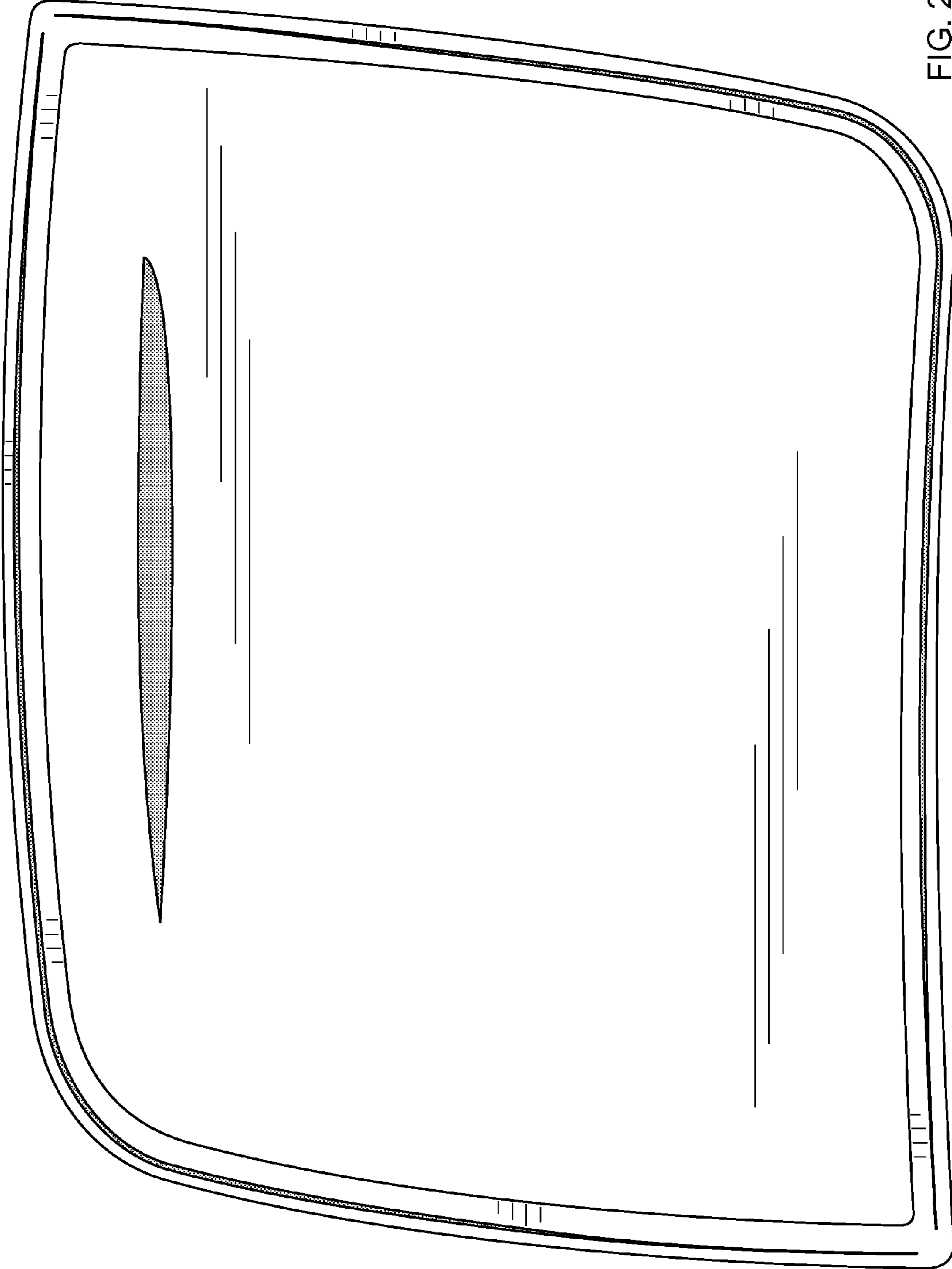
