FIG. 5 is a top view thereof;

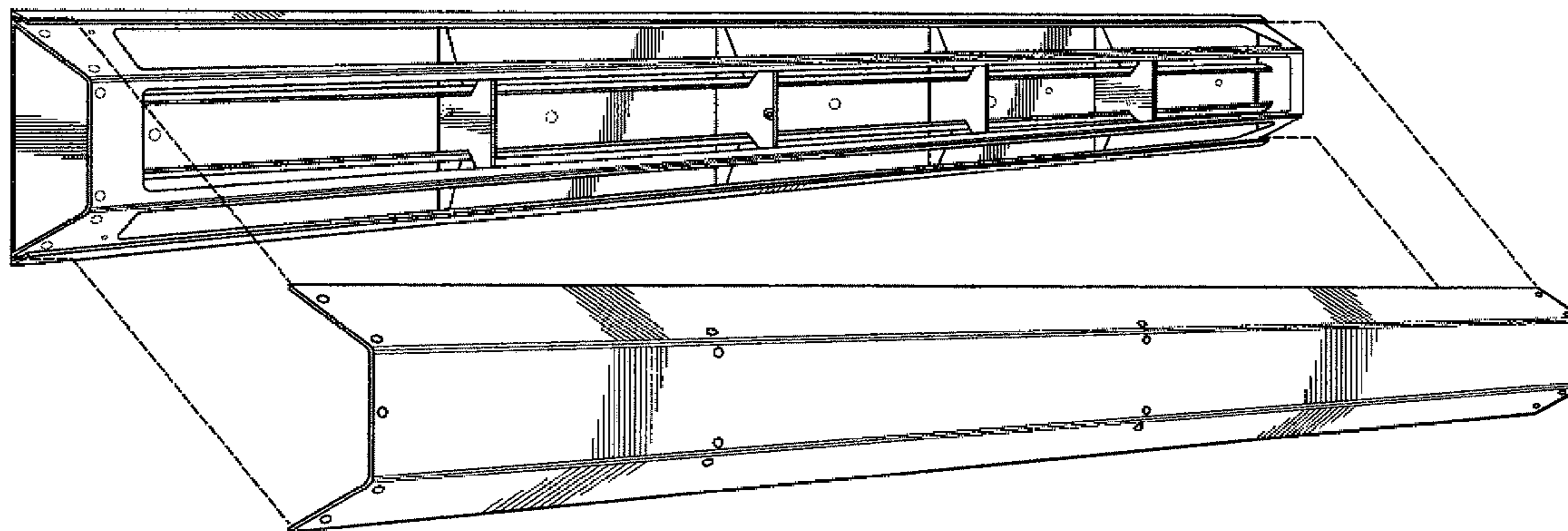
FIG. 6 is an enlarged end view thereof, the opposite end view being a mirror image thereof;

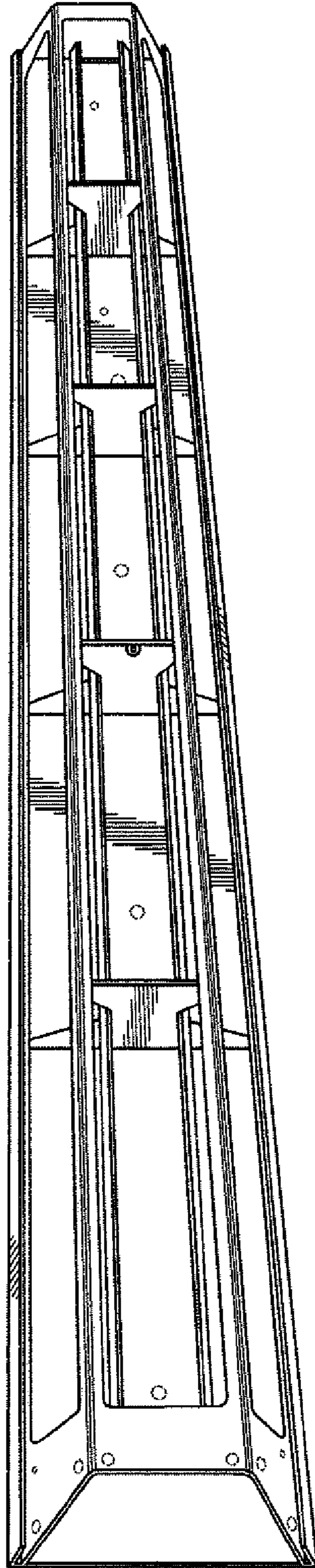

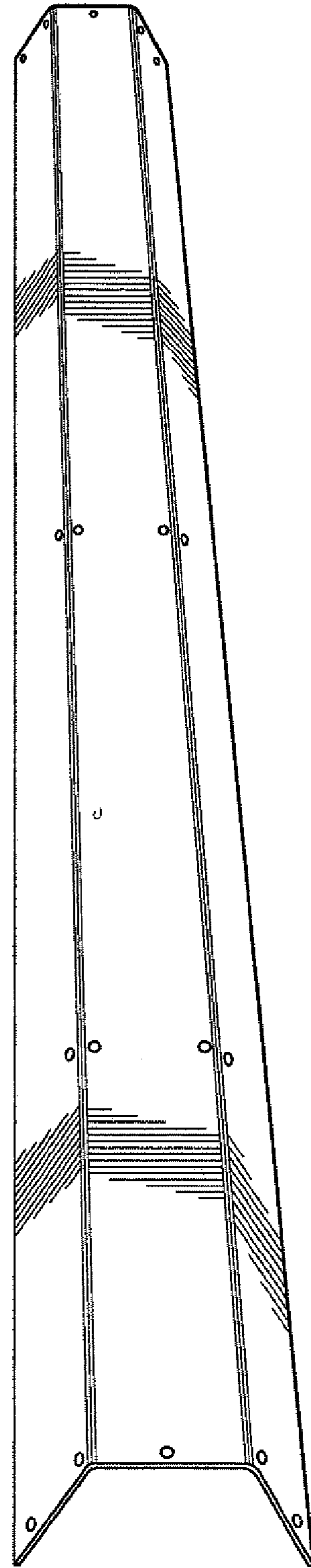

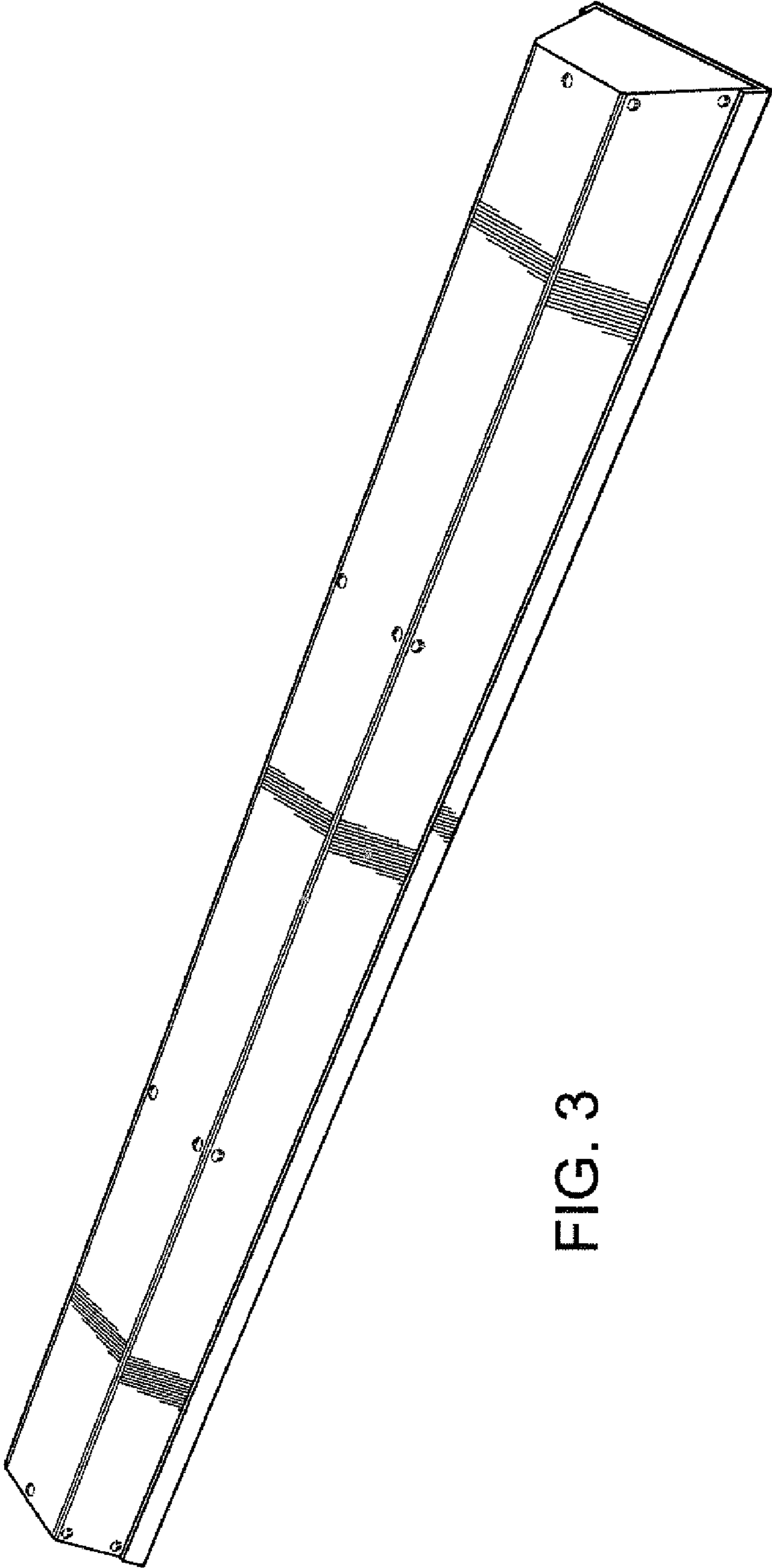

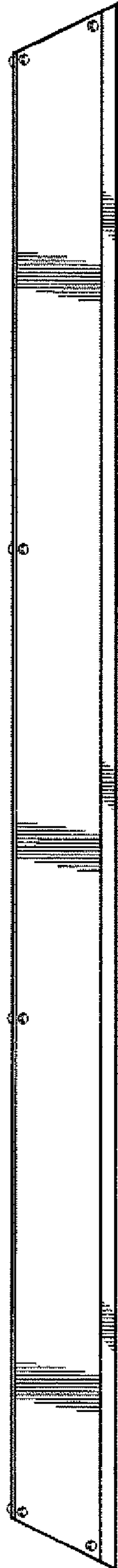

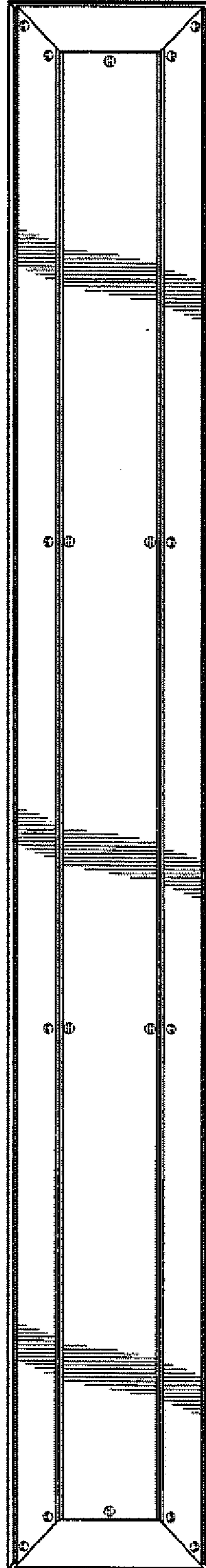

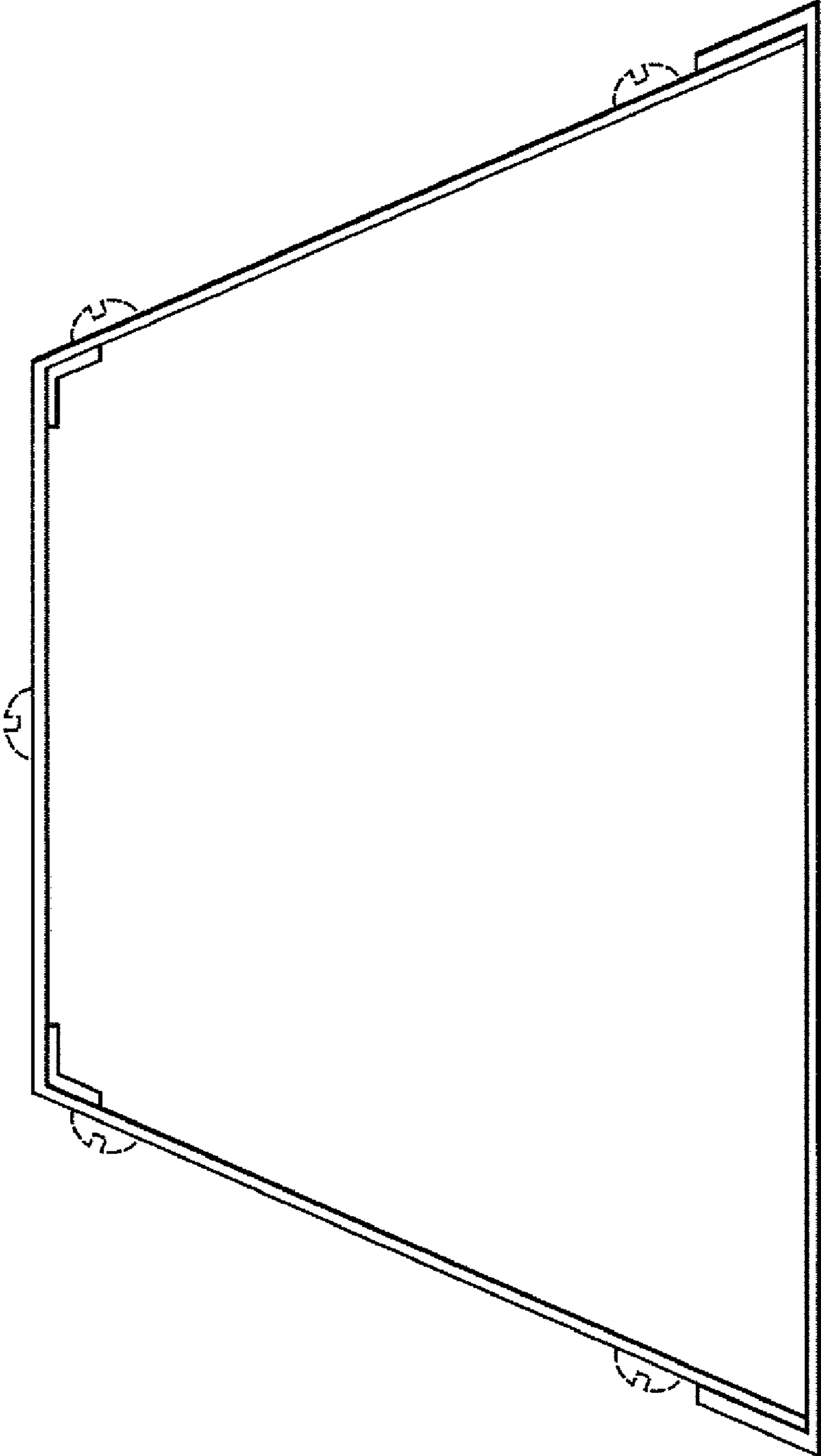

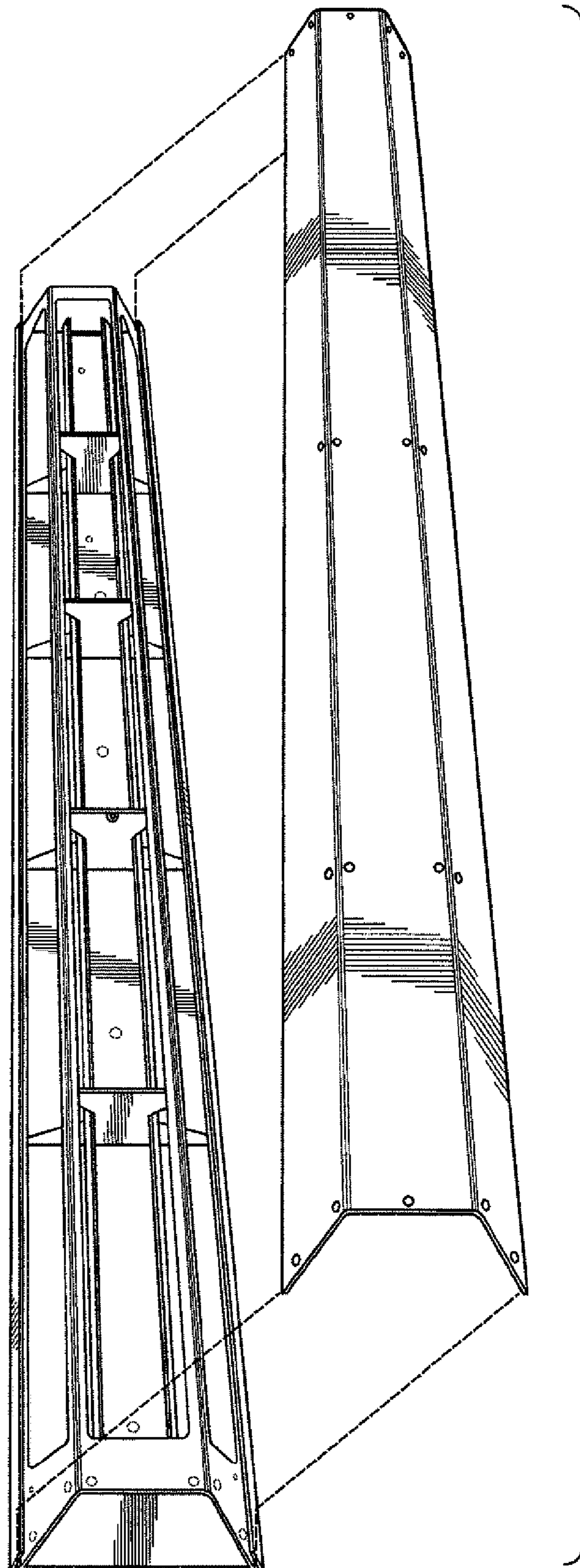
