FIG. 5 is a left side view of the body wrap.

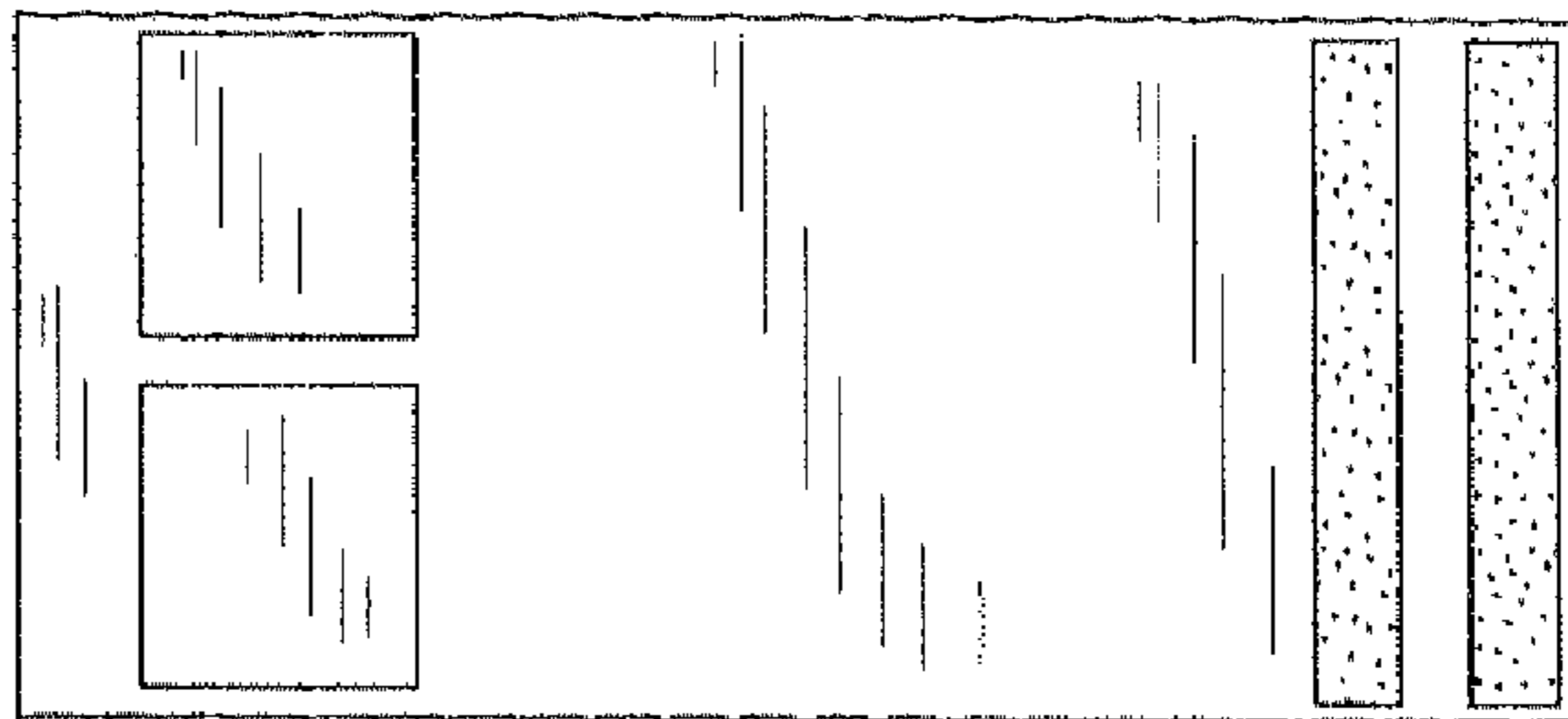
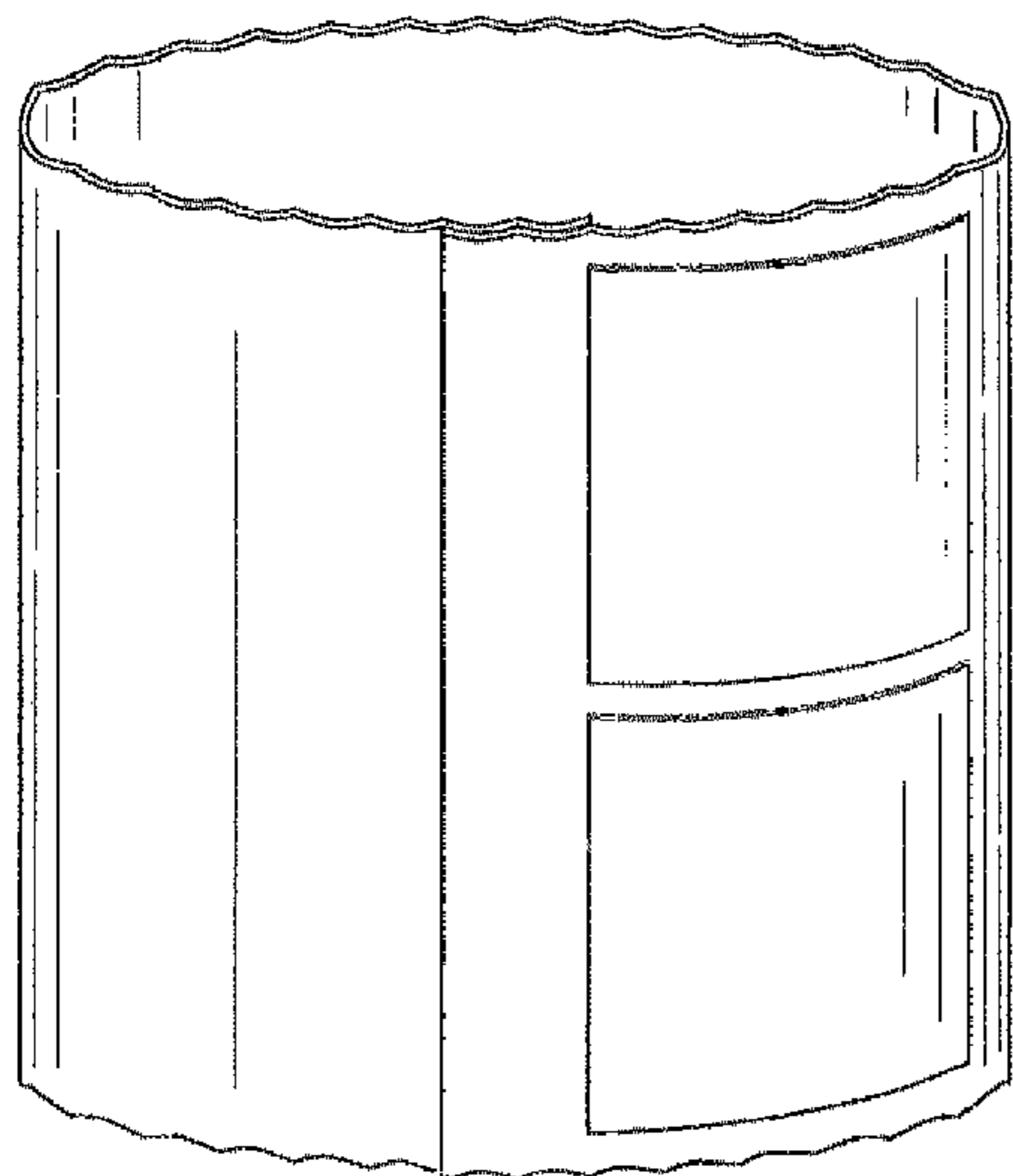
FIG. 6 is a top view of the body wrap.

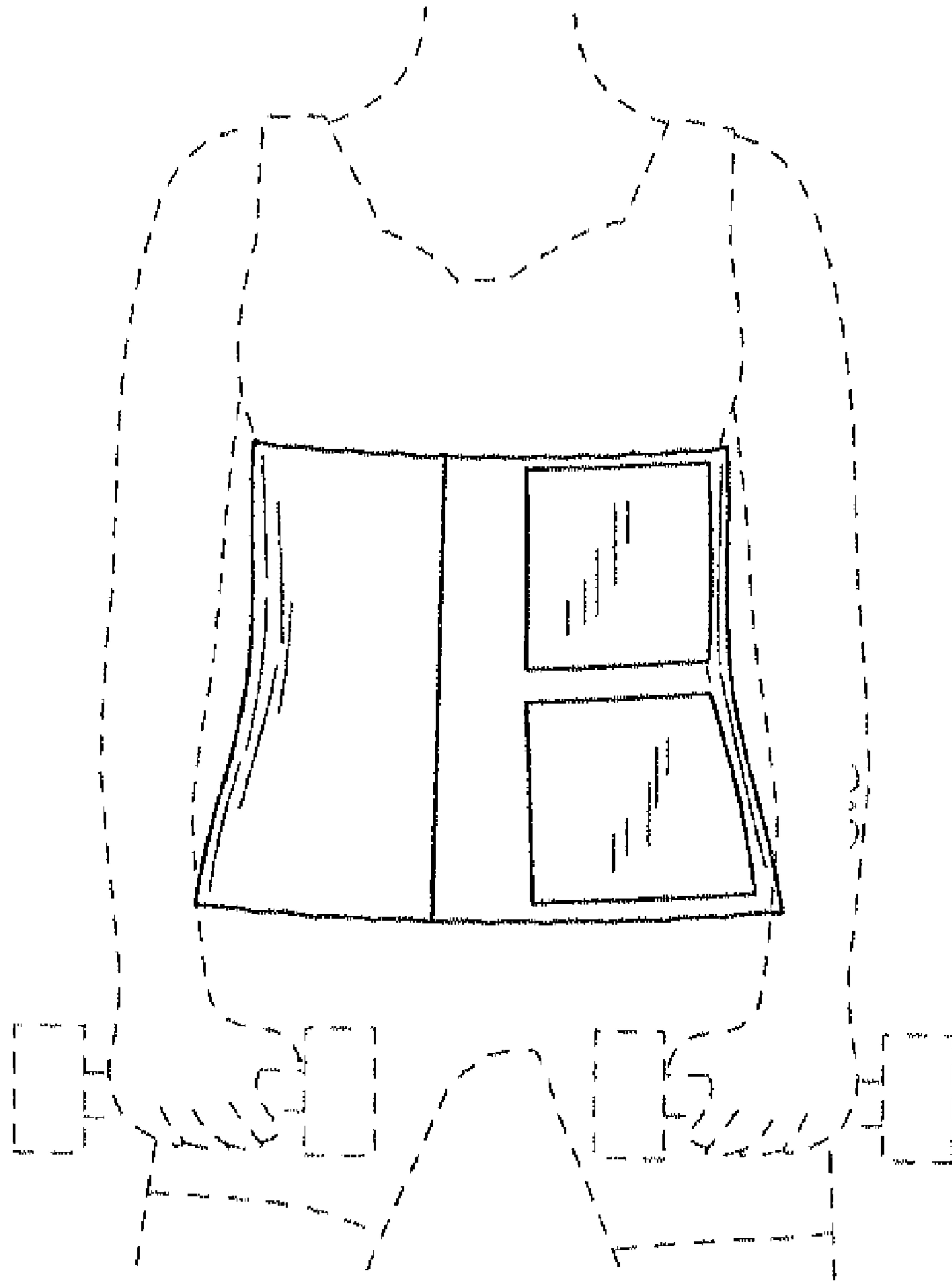

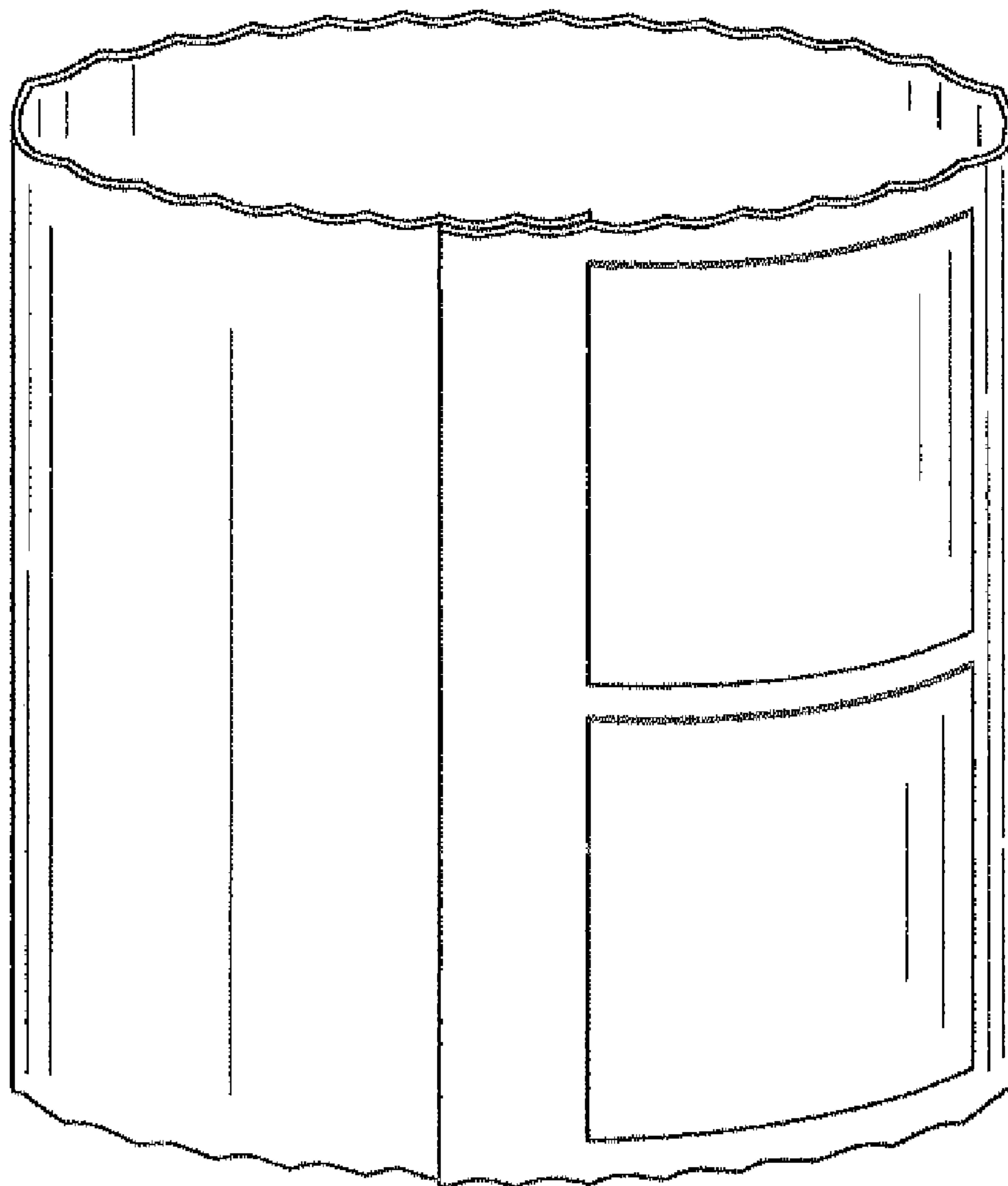

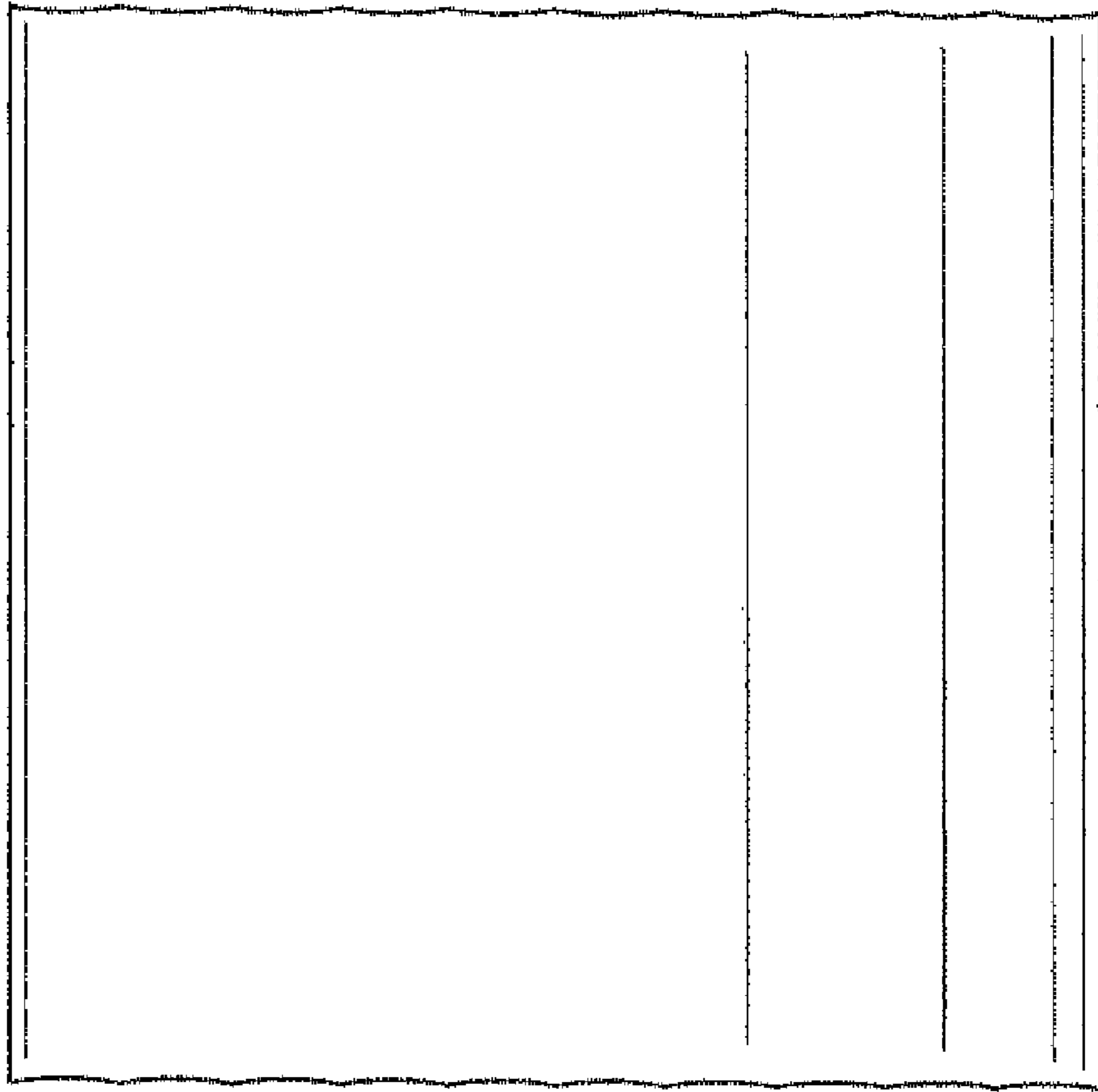

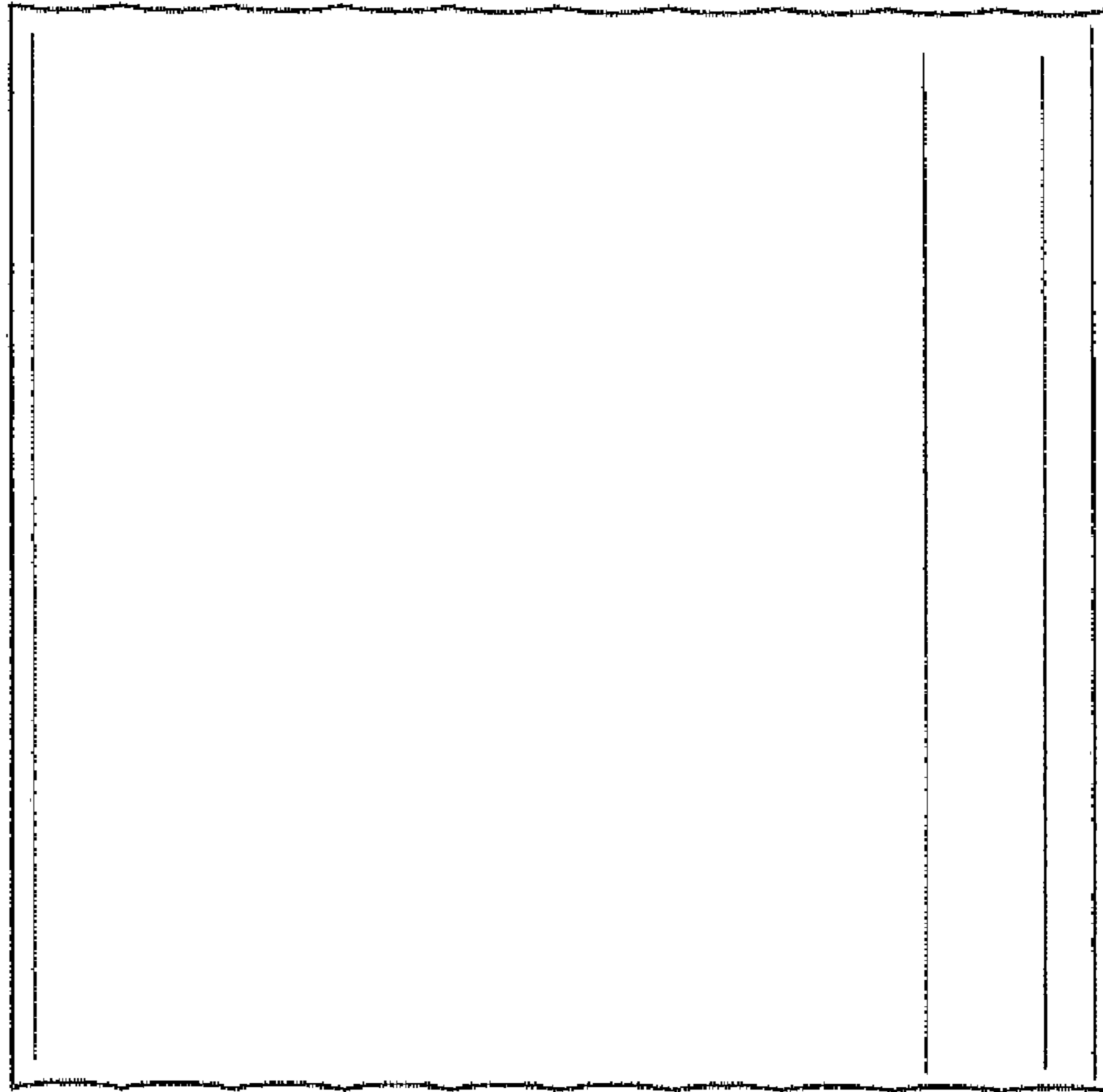

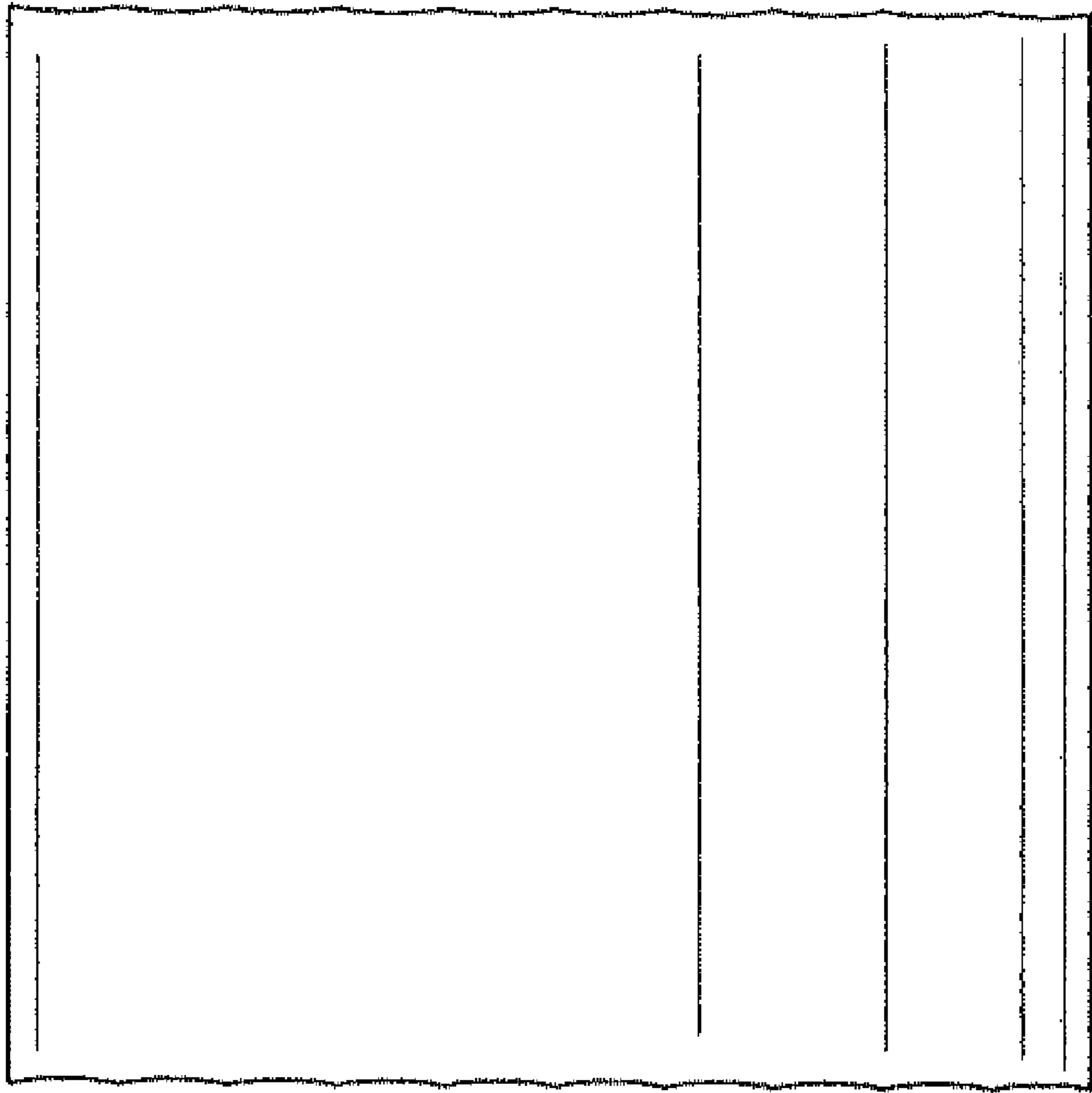

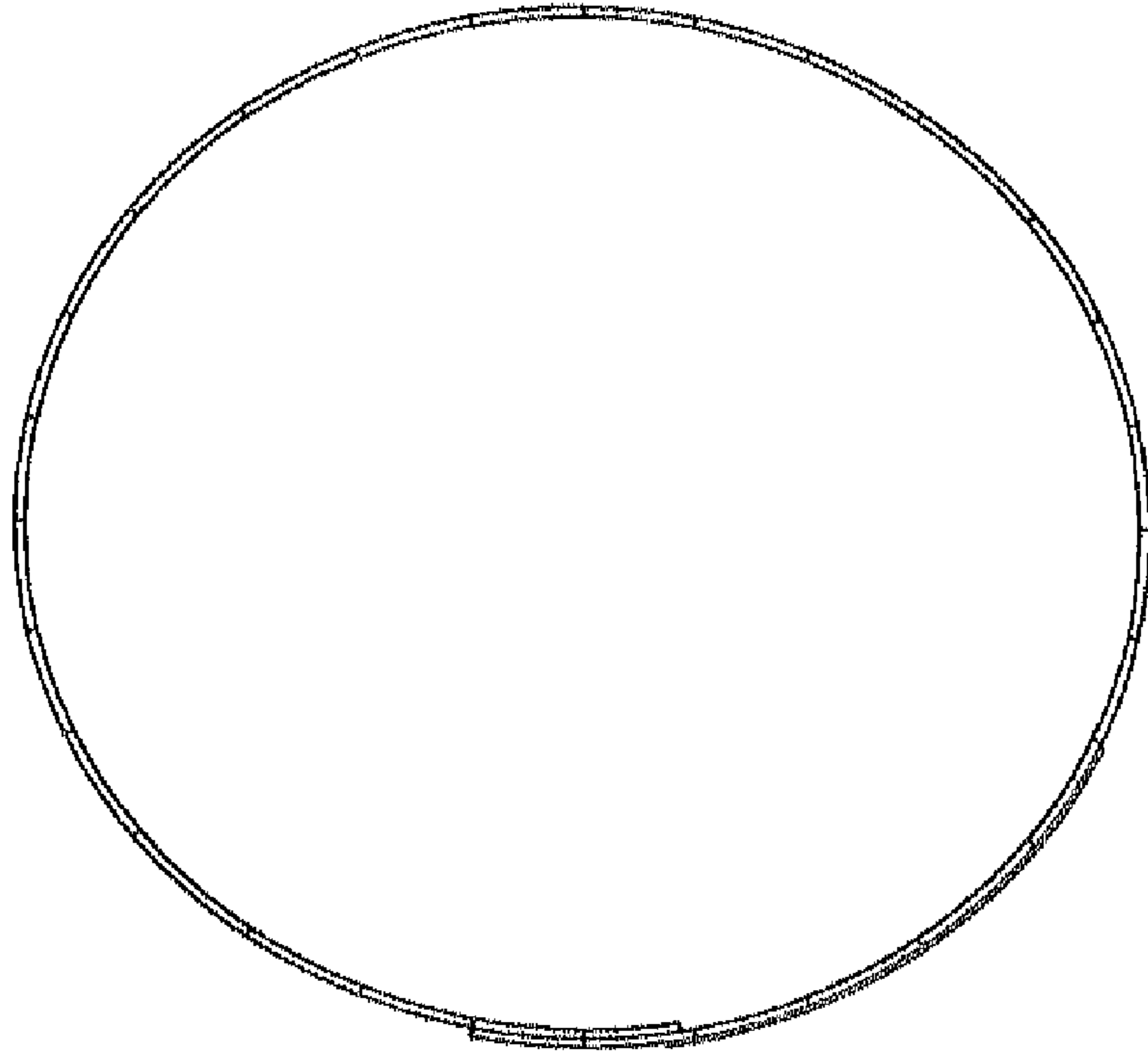

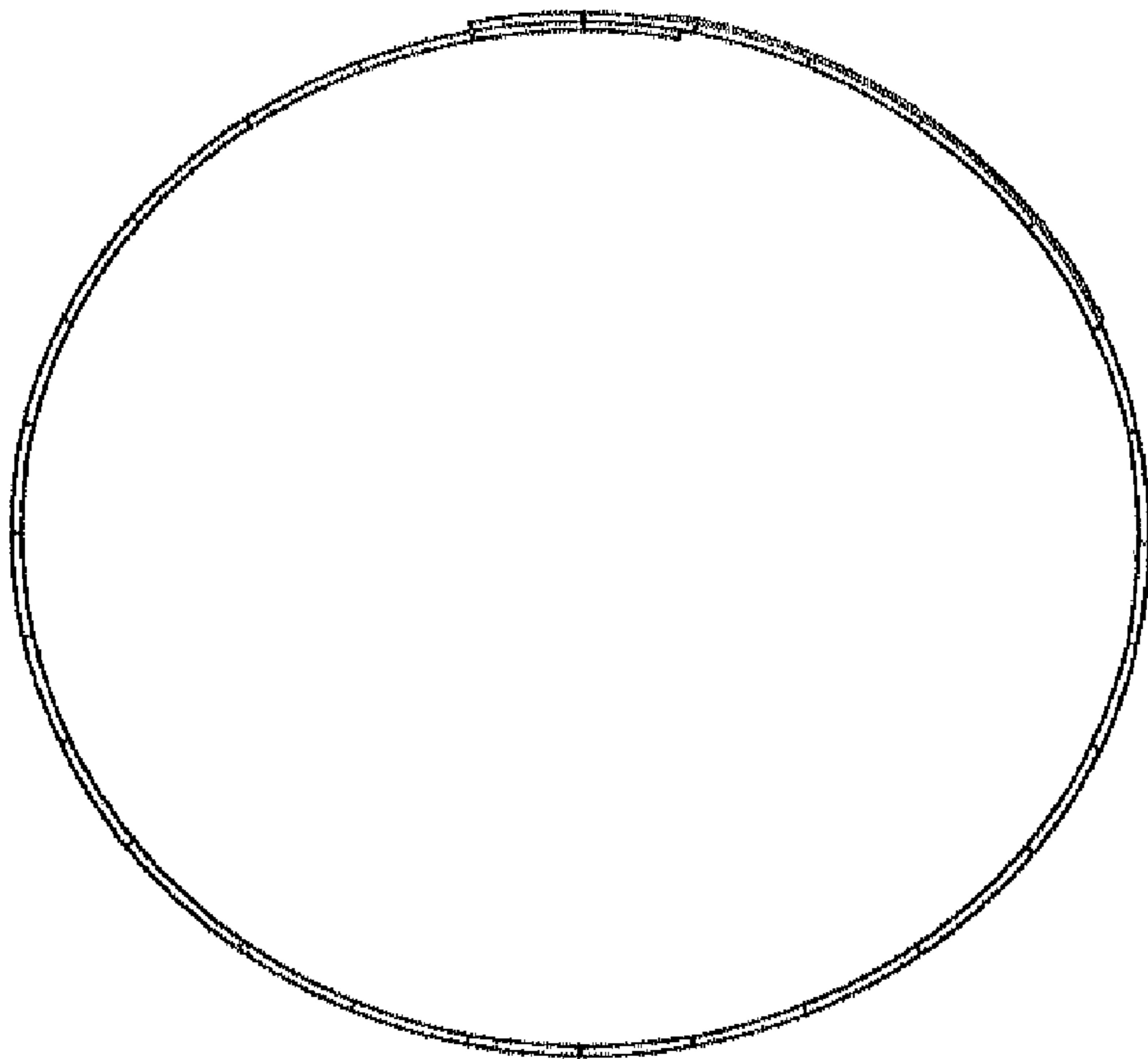

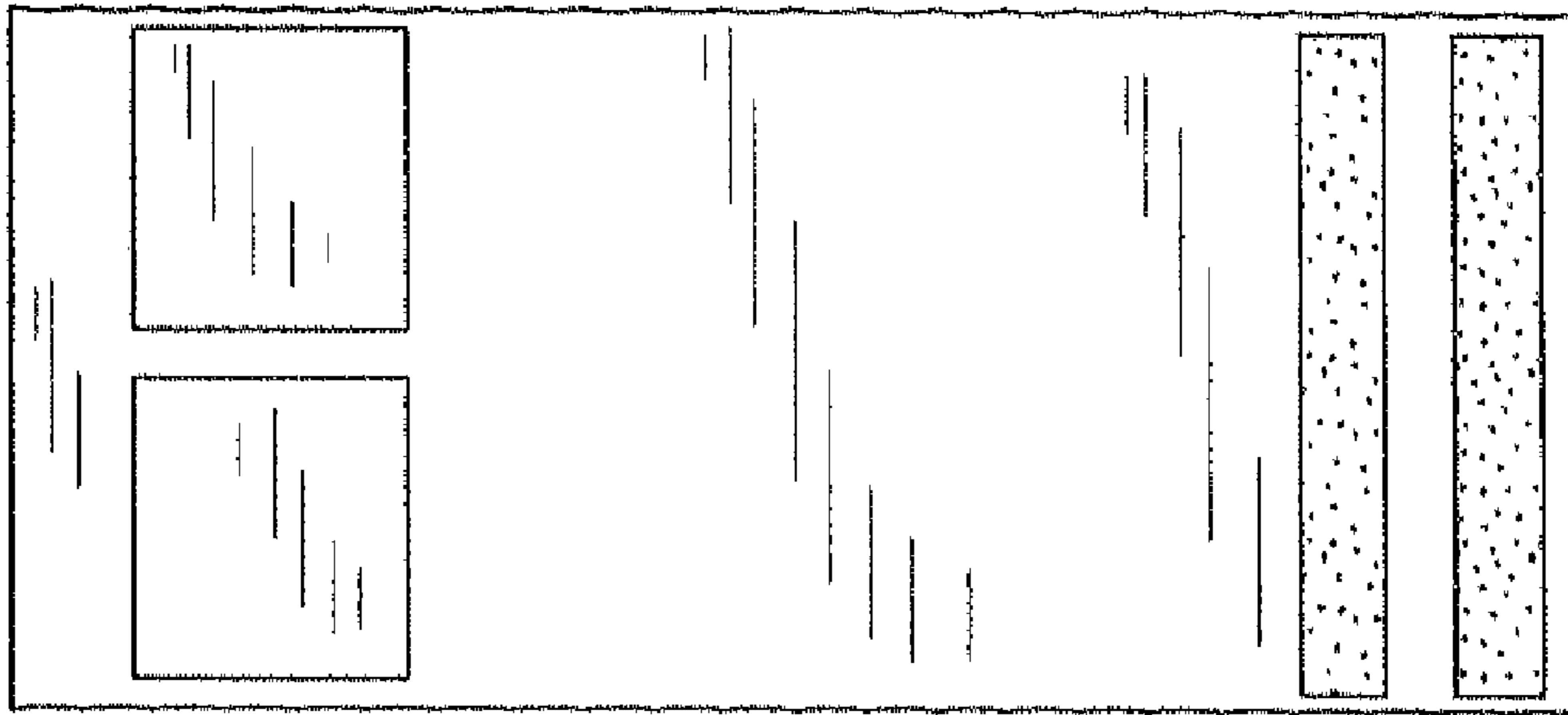
