FIG. 1 is a front perspective view of the thermal wrap of the invention in the folded configuration.

FIG. 2 is a left side perspective view of the thermal wrap of the invention in the folded configuration.

FIG. 3 is a right side perspective view of the thermal wrap of the invention in the folded configuration.

FIG. 4 is a plan view of the exterior side of the thermal wrap of the invention in the unfolded configuration.

FIG. 5 is a plan view of the interior side of the thermal wrap of the invention in the unfolded configuration.

FIG. 6 is a perspective view of an alternative embodiment of the thermal wrap of the invention in the folded configuration.

FIG. 7 is a left side perspective view of the thermal wrap of FIG. 6 in the folded configuration.

FIG. 8 is a right side perspective view of the thermal wrap of FIG. 6 in the folded configuration.

FIG. 9 is a plan view of the thermal wrap of FIG. 6 in the unfolded configuration; and,

FIG. 10 a plan view of the thermal wrap of FIG. 6 in the unfolded configuration.

The broken lines in FIGS. 1 and 6 illustrate environmental structure and form no part of the claimed design.

The arrows shown in FIGS. 2 and 7 depict the direction of movement of the straps and form no part of the claimed design.

The break lines shown in FIGS. 4, 5, 9, and 10 depict truncation, and form no part of the claimed design.






















