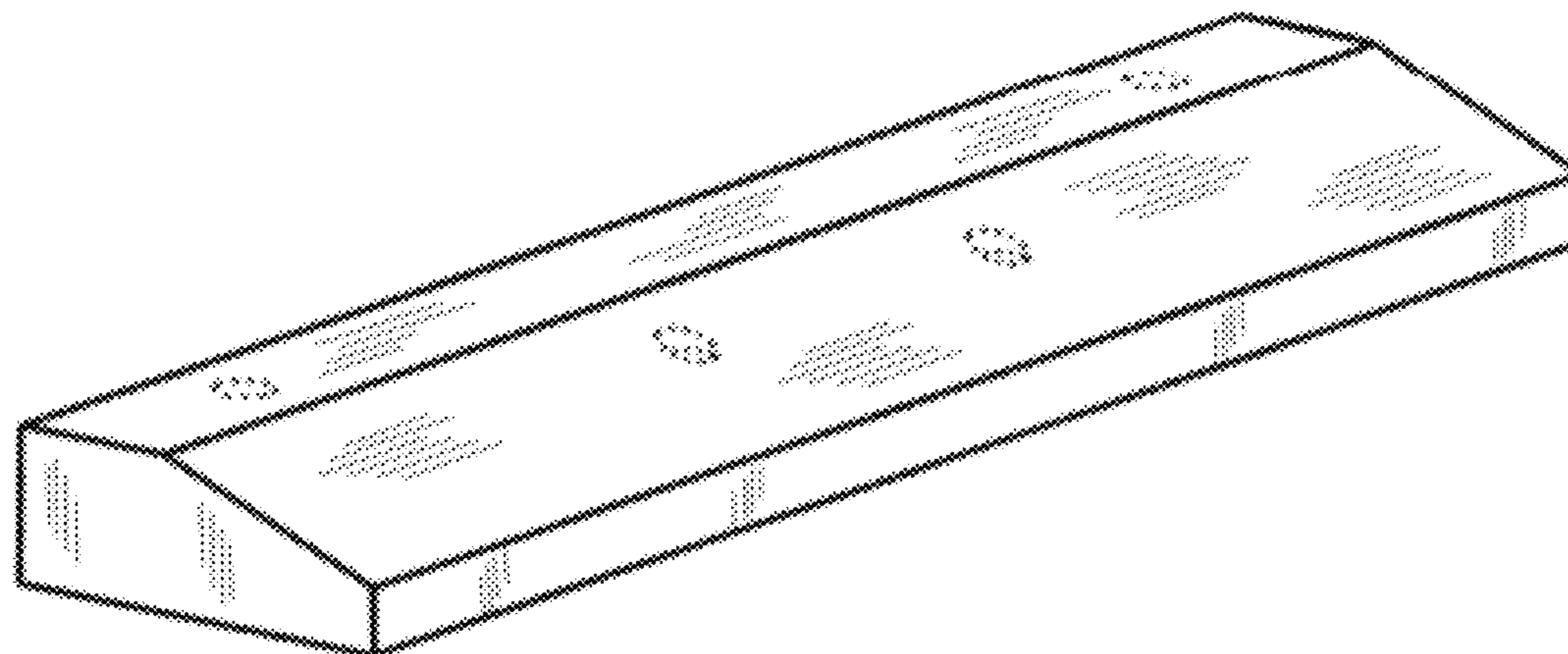
FIG. 1 is a perspective view of a masonry ledge; and,

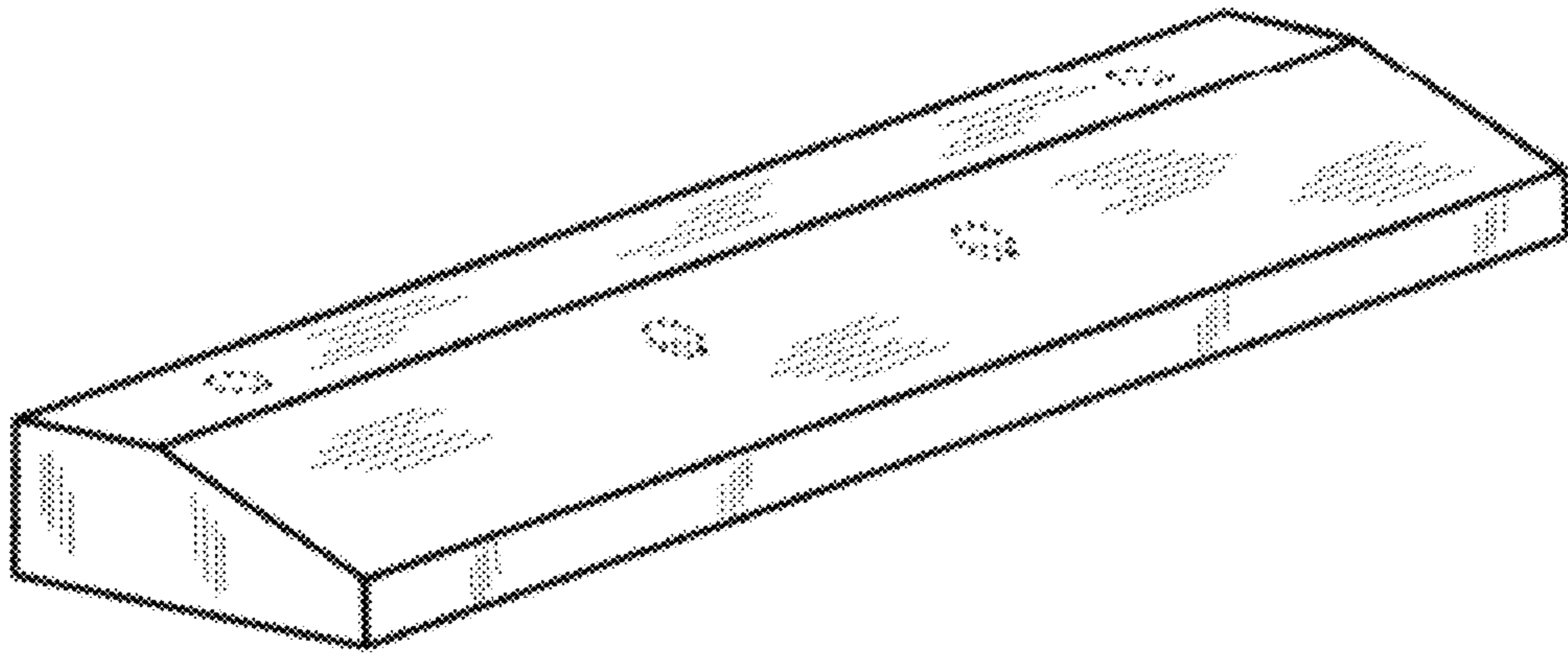

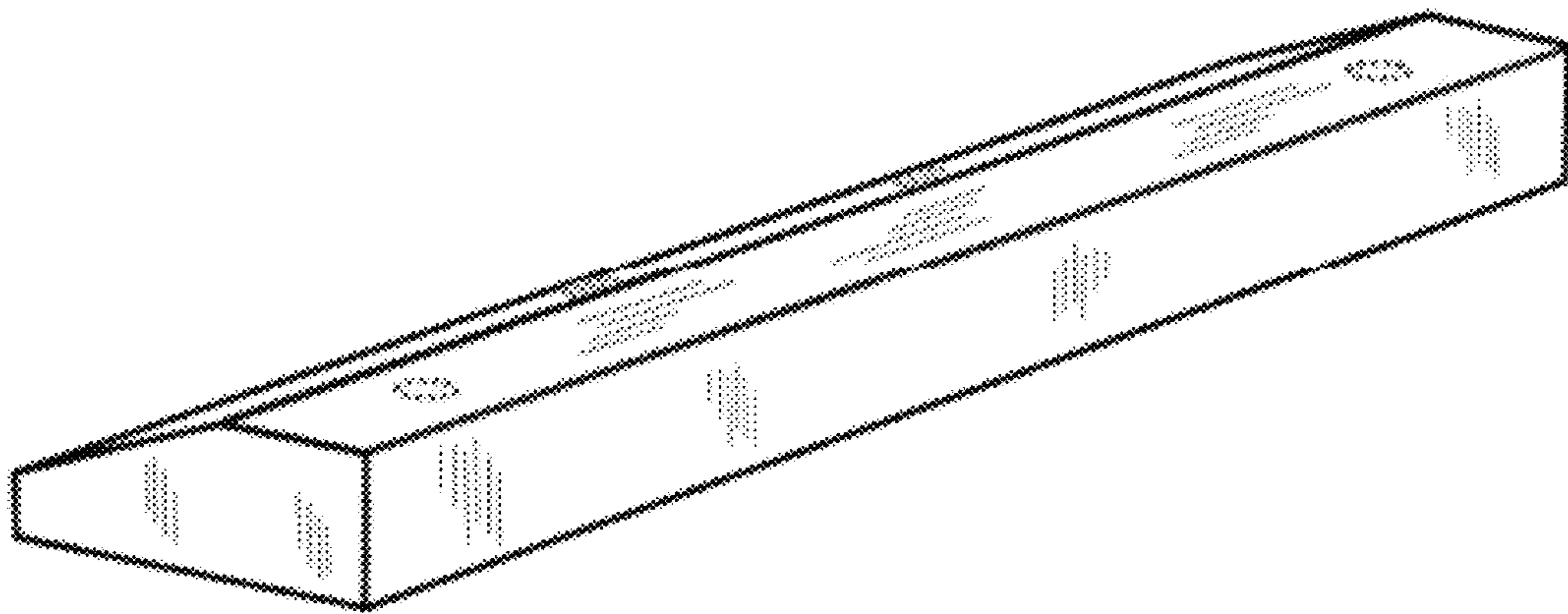
