DESCRIPTION

FIG. 1 is an upper perspective view of a face mask showing our new design;

FIG. 6 is a top plan view thereof;

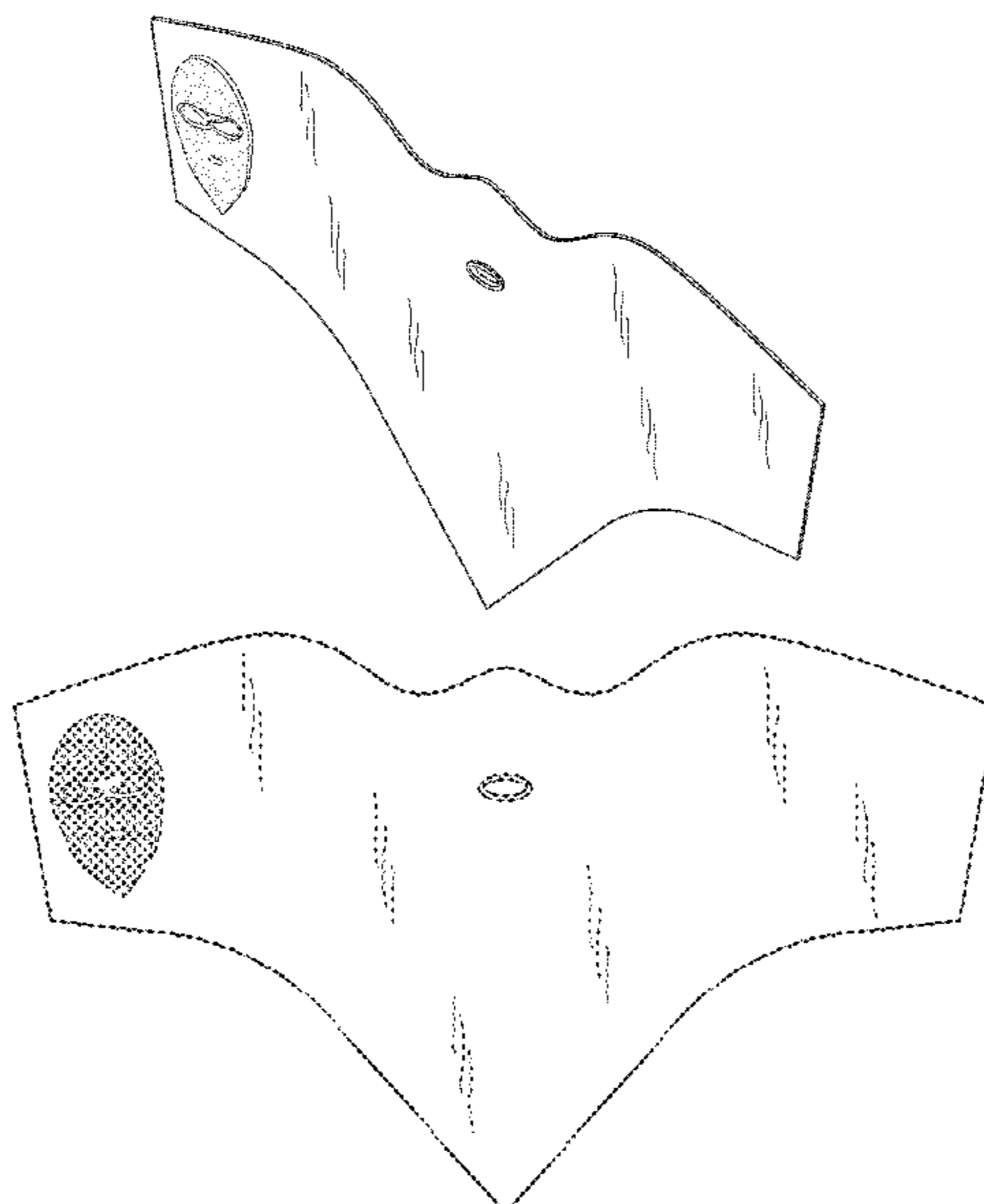
FIG. 7 is a bottom plan view thereof;

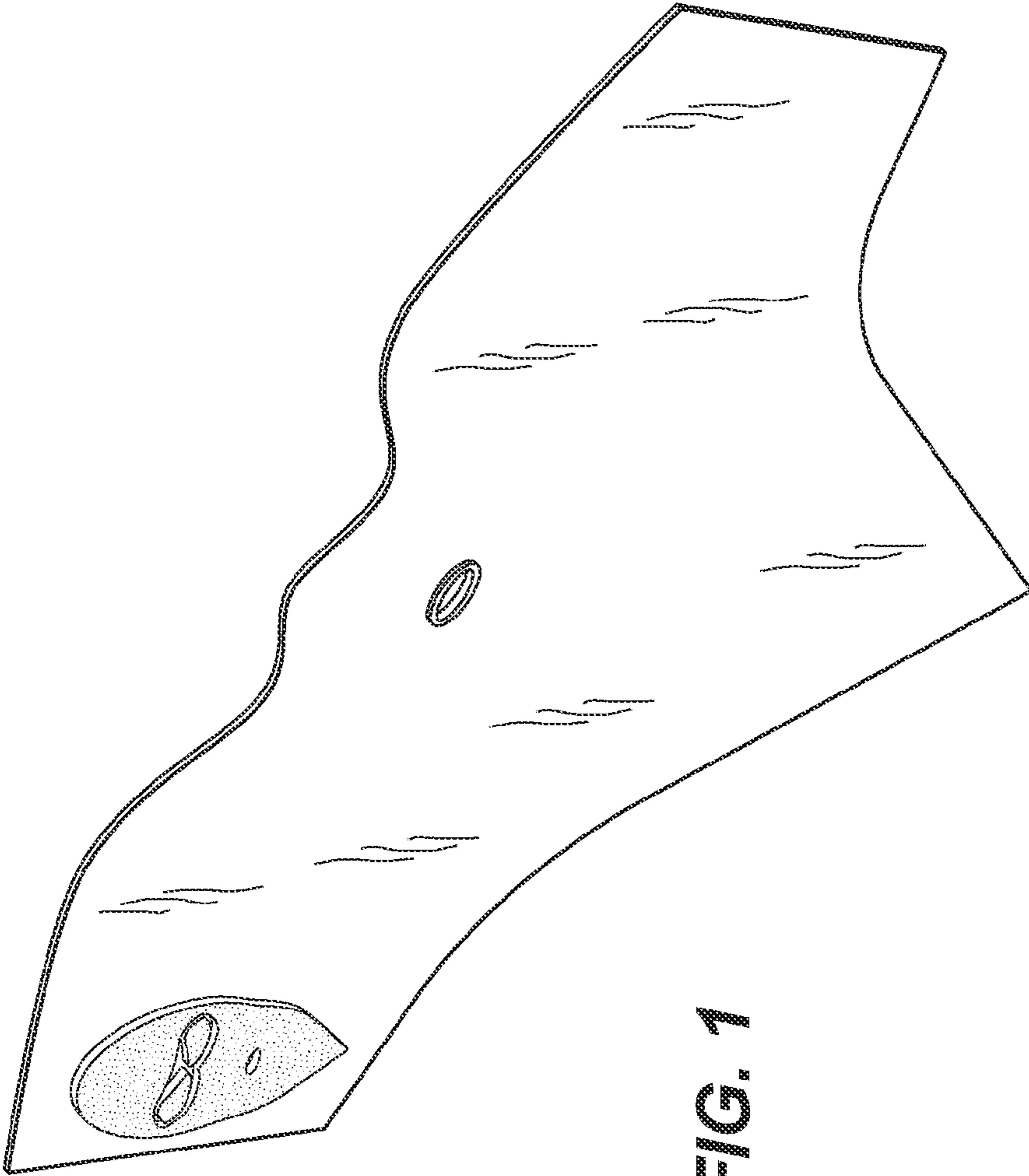

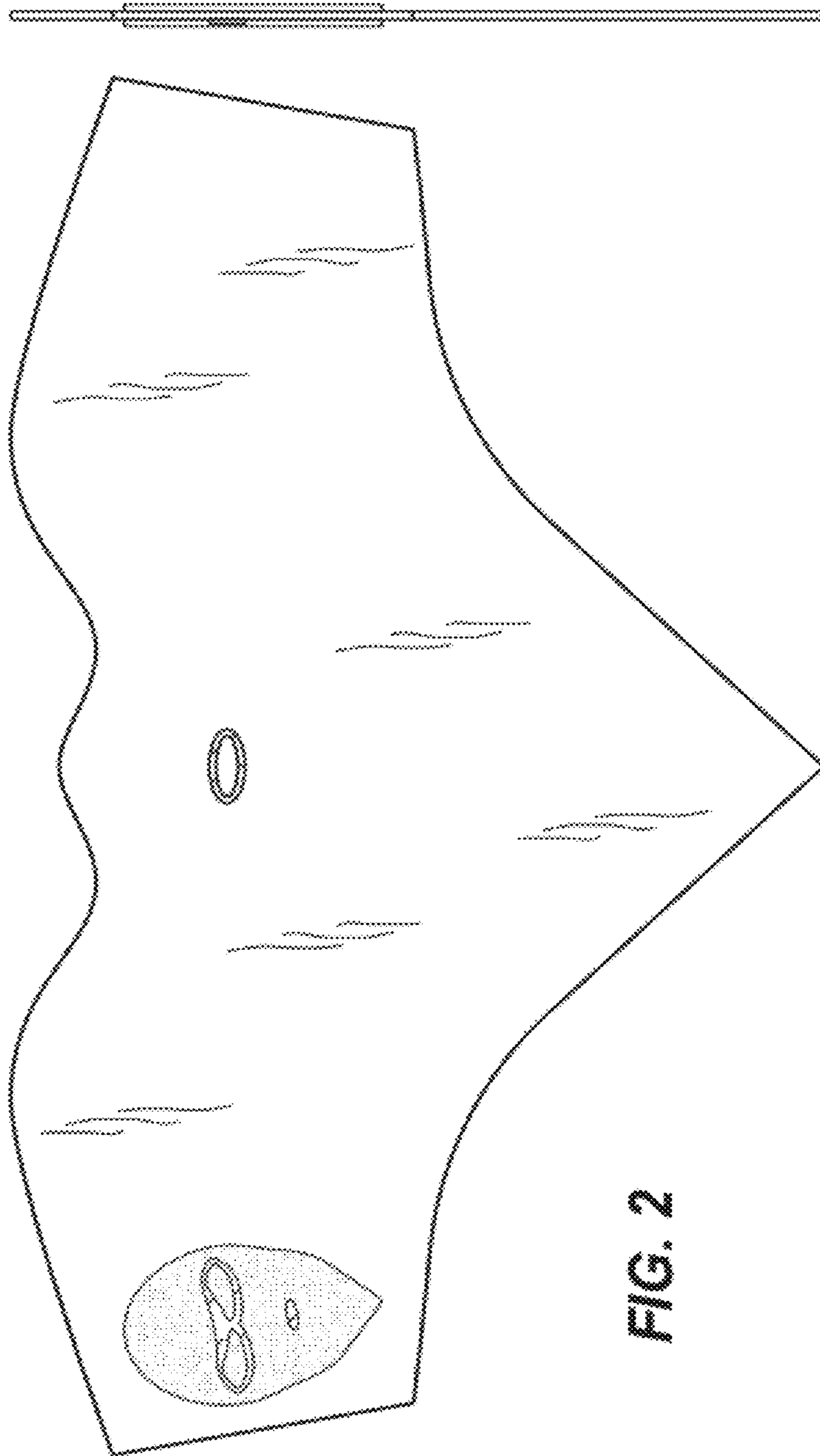

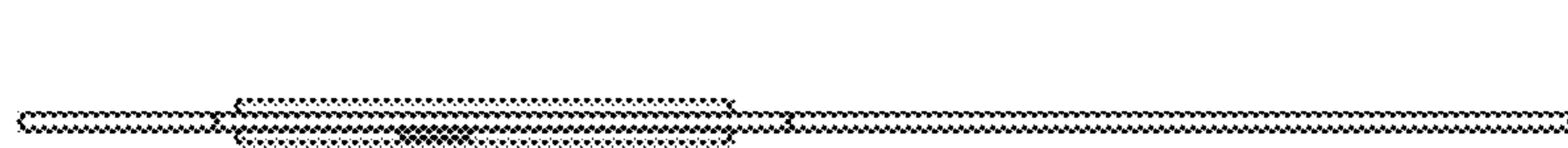

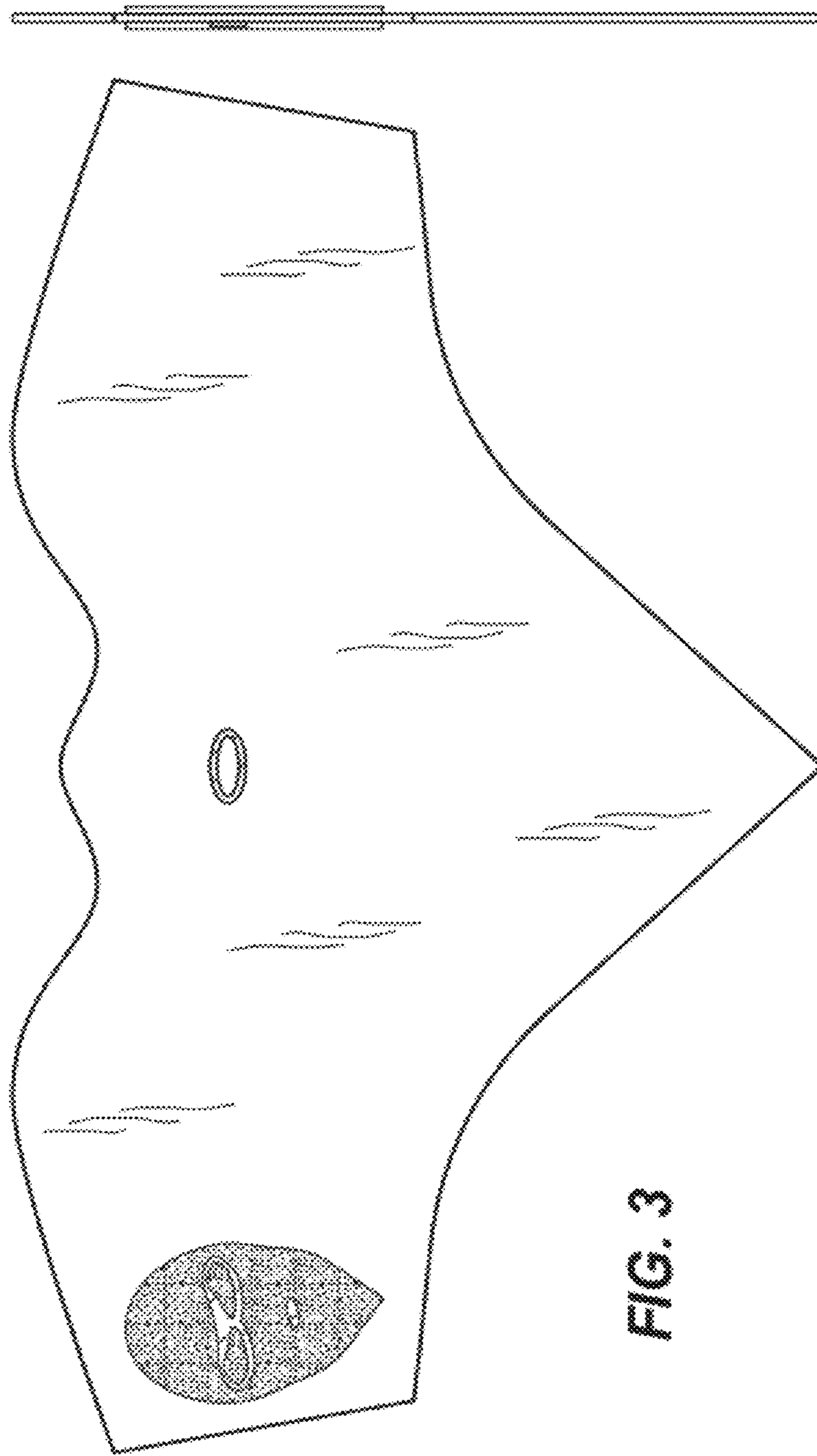

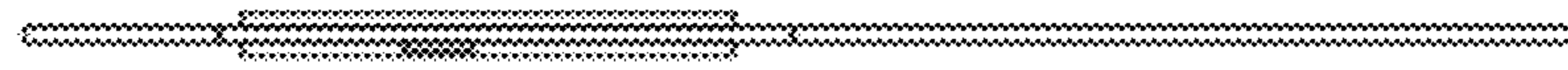

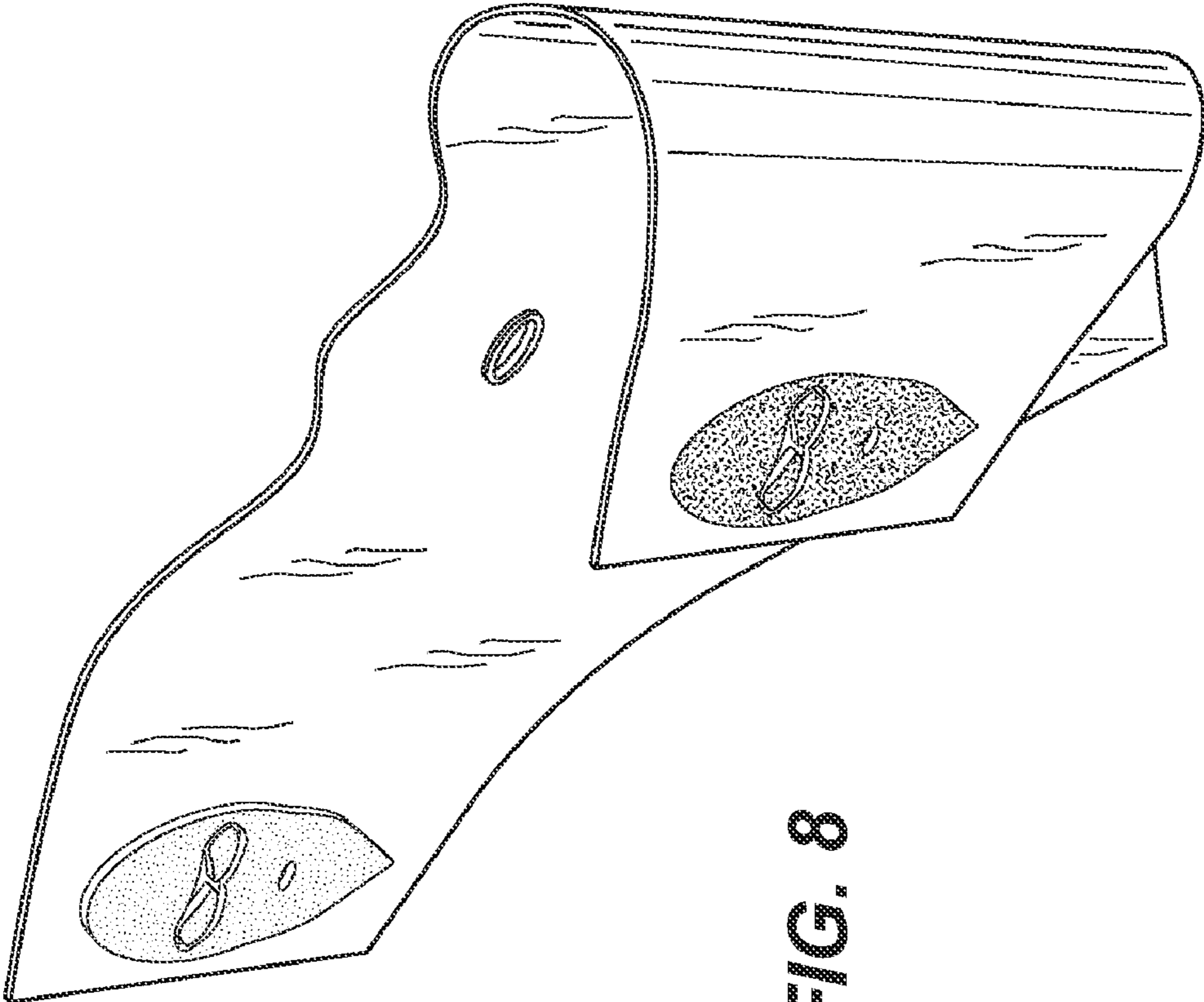
