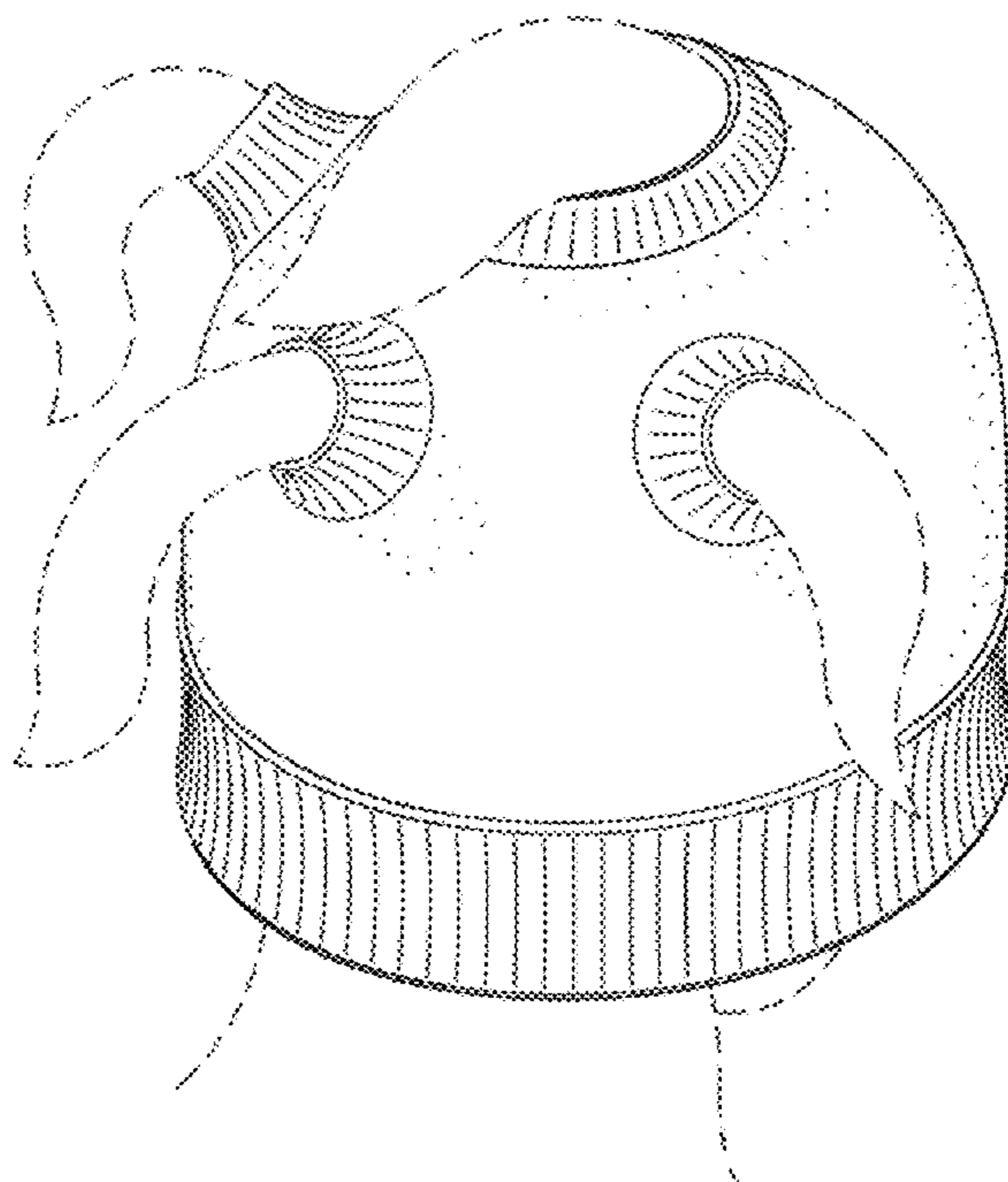
(57) **CLAIM**

The ornamental design for a hat, as shown and described.

DESCRIPTION

FIG. 1 is a right rear perspective view of the hat;
 FIG. 2 is a right frontal perspective view of the hat;
 FIG. 3 is a top view of the hat;
 FIG. 4 is a right side view of the hat; the other side is a mirror image thereof and is not shown;
 FIG. 5 is an rear view of the hat; and,
 FIG. 6 is a front view of the hat.
 In FIG. 1, the broken lines showing the wearer of the hat and hair are for the purpose of illustrating environmental structure only and form no part of the claimed design.
 The hat is characterized by distinctive openings and brim.

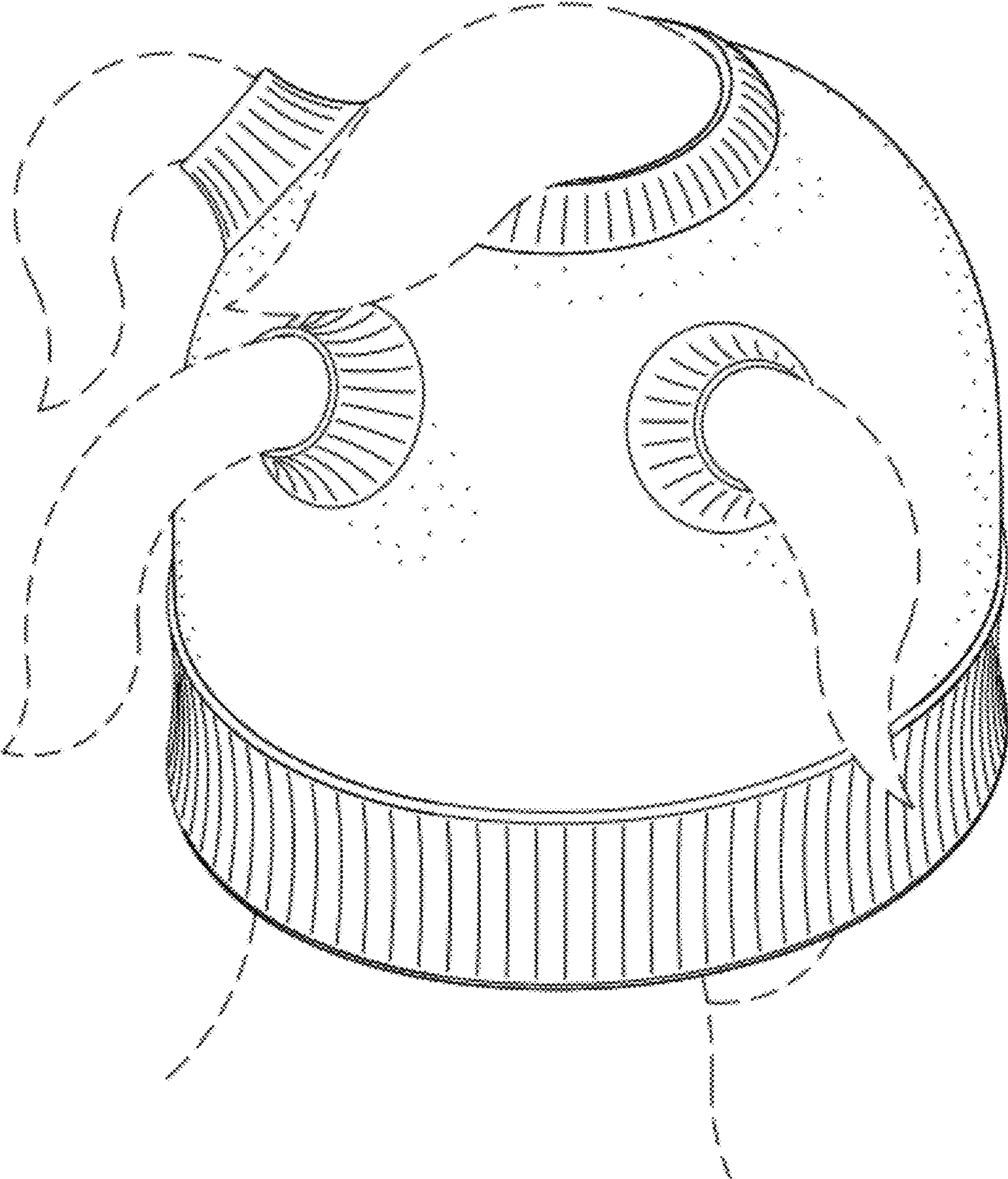

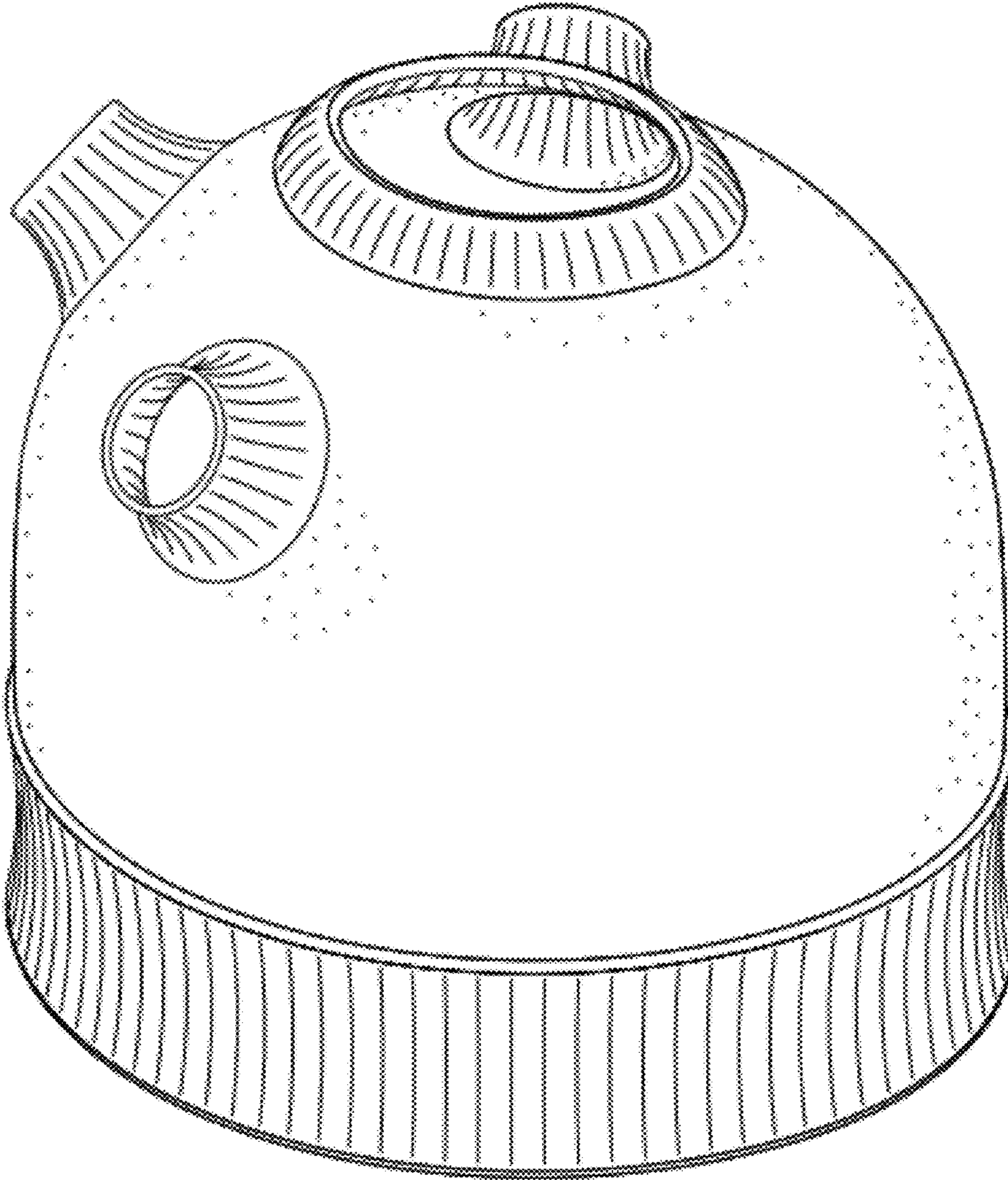

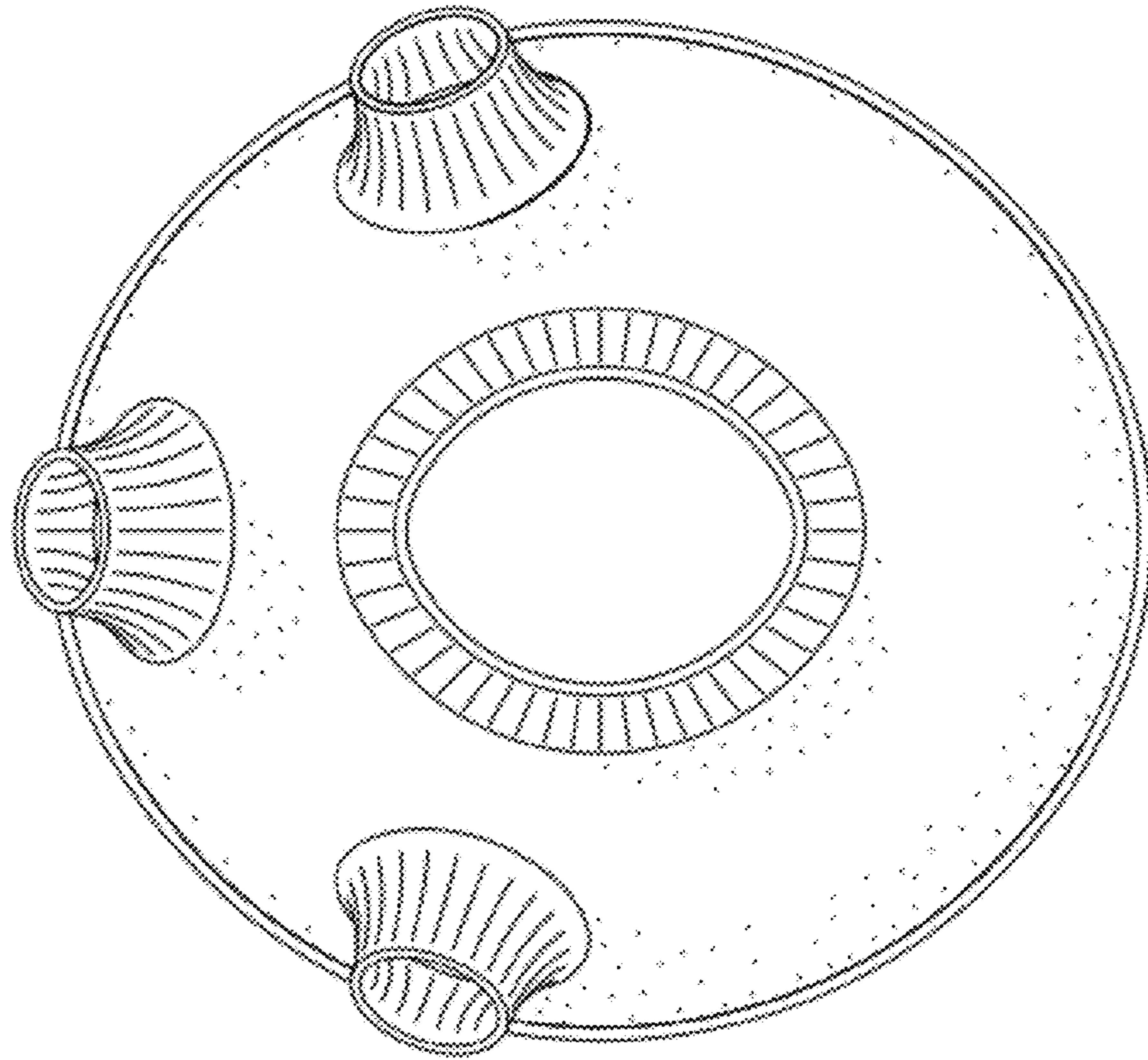

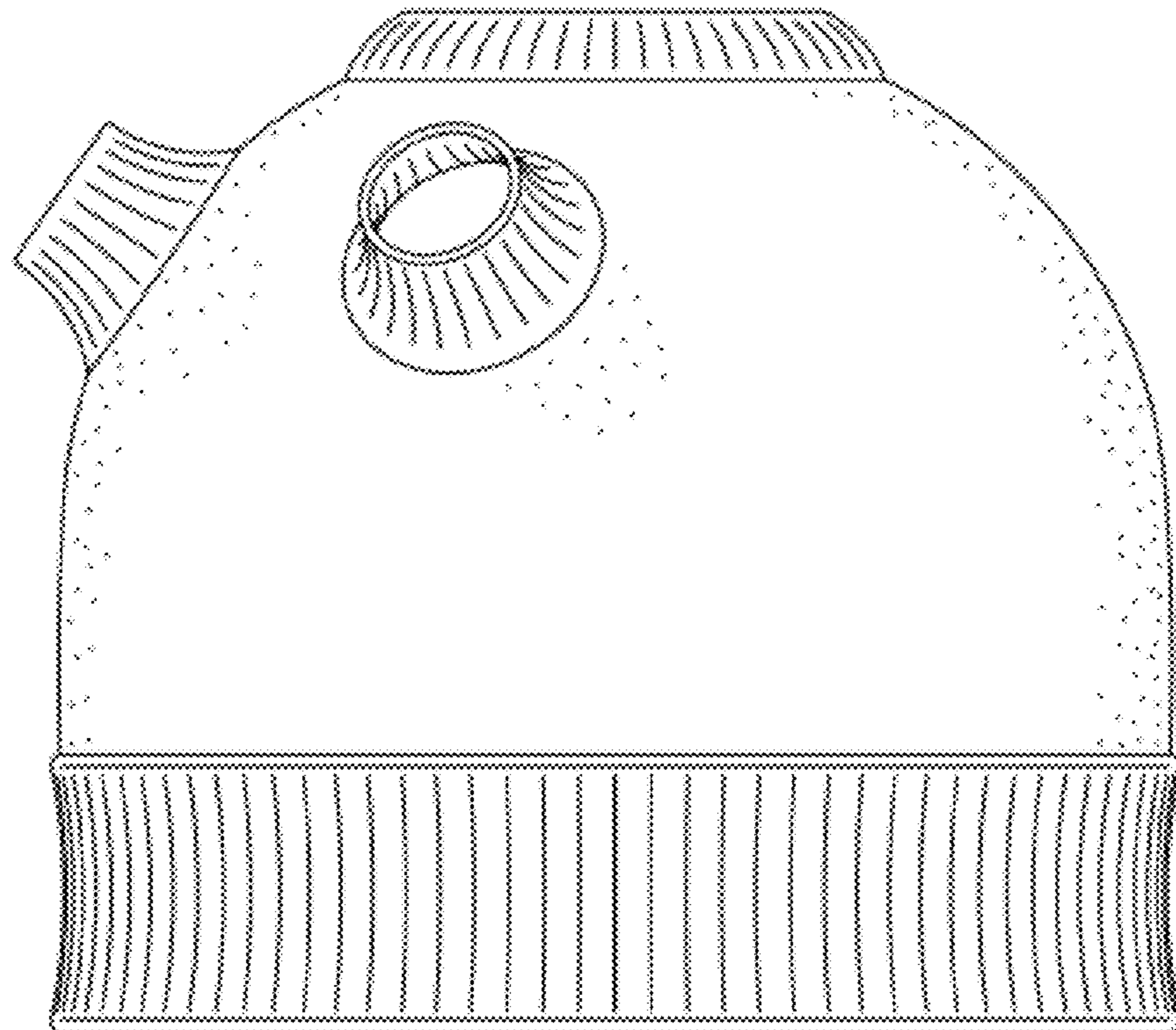

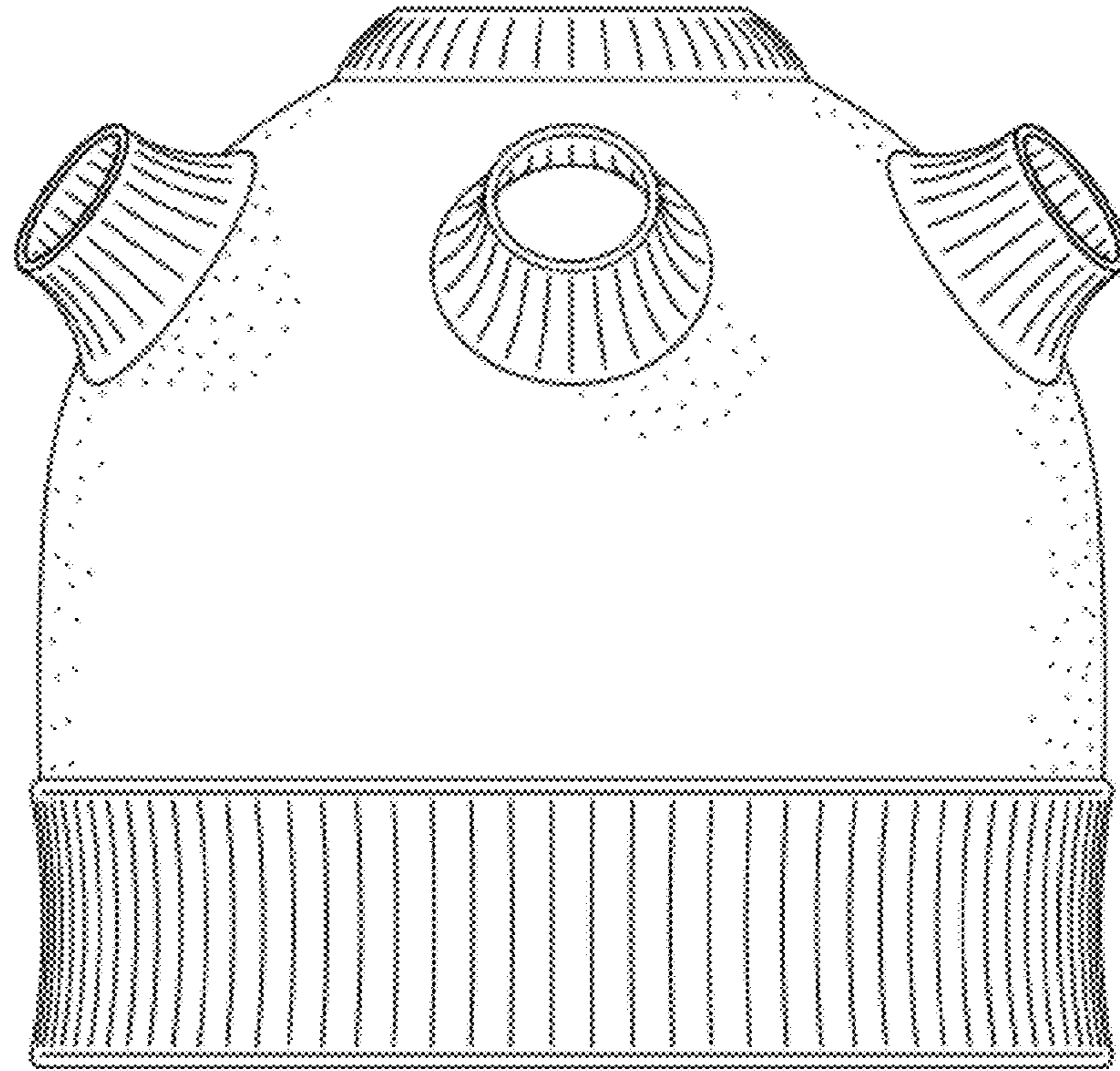

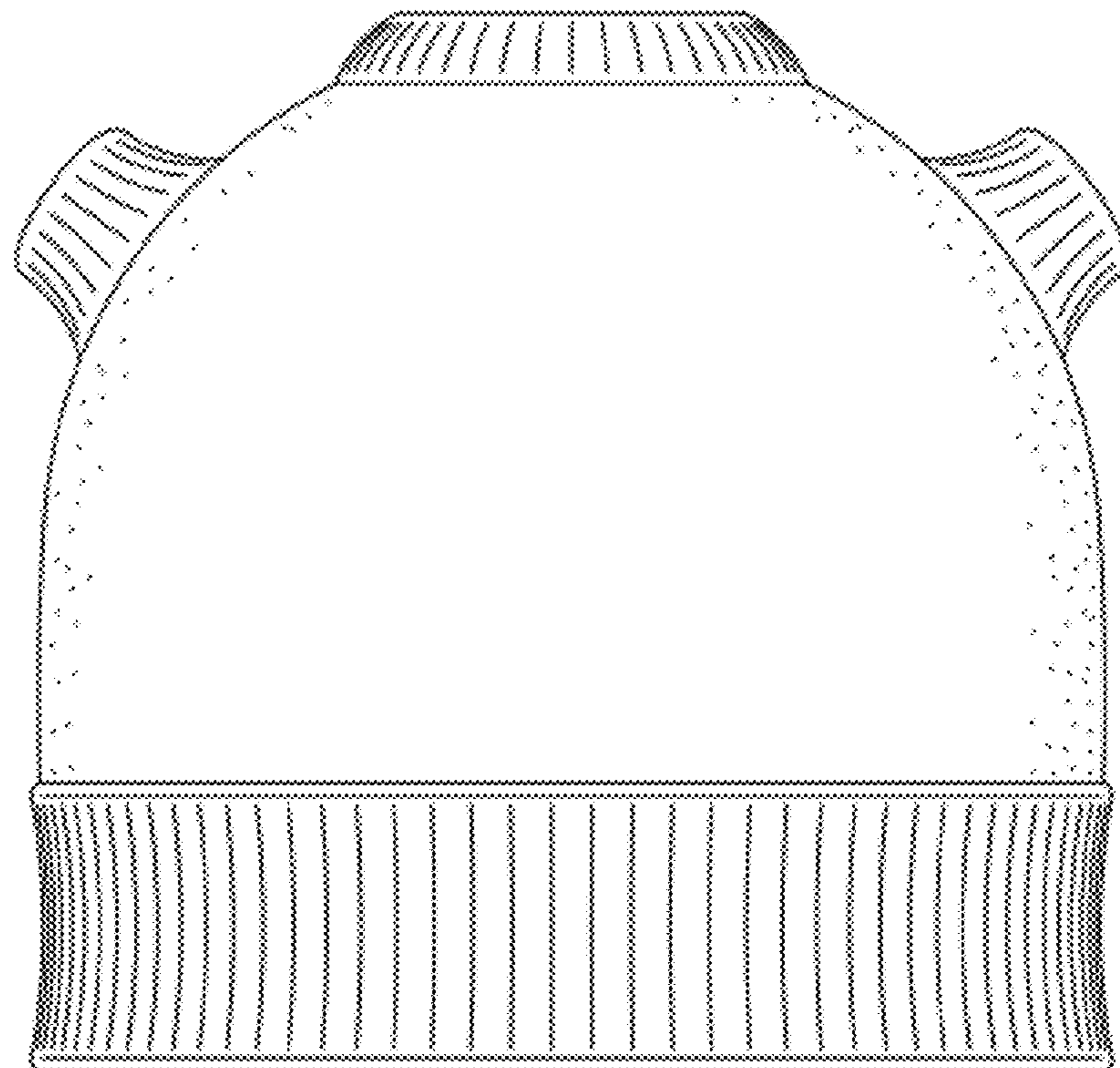
