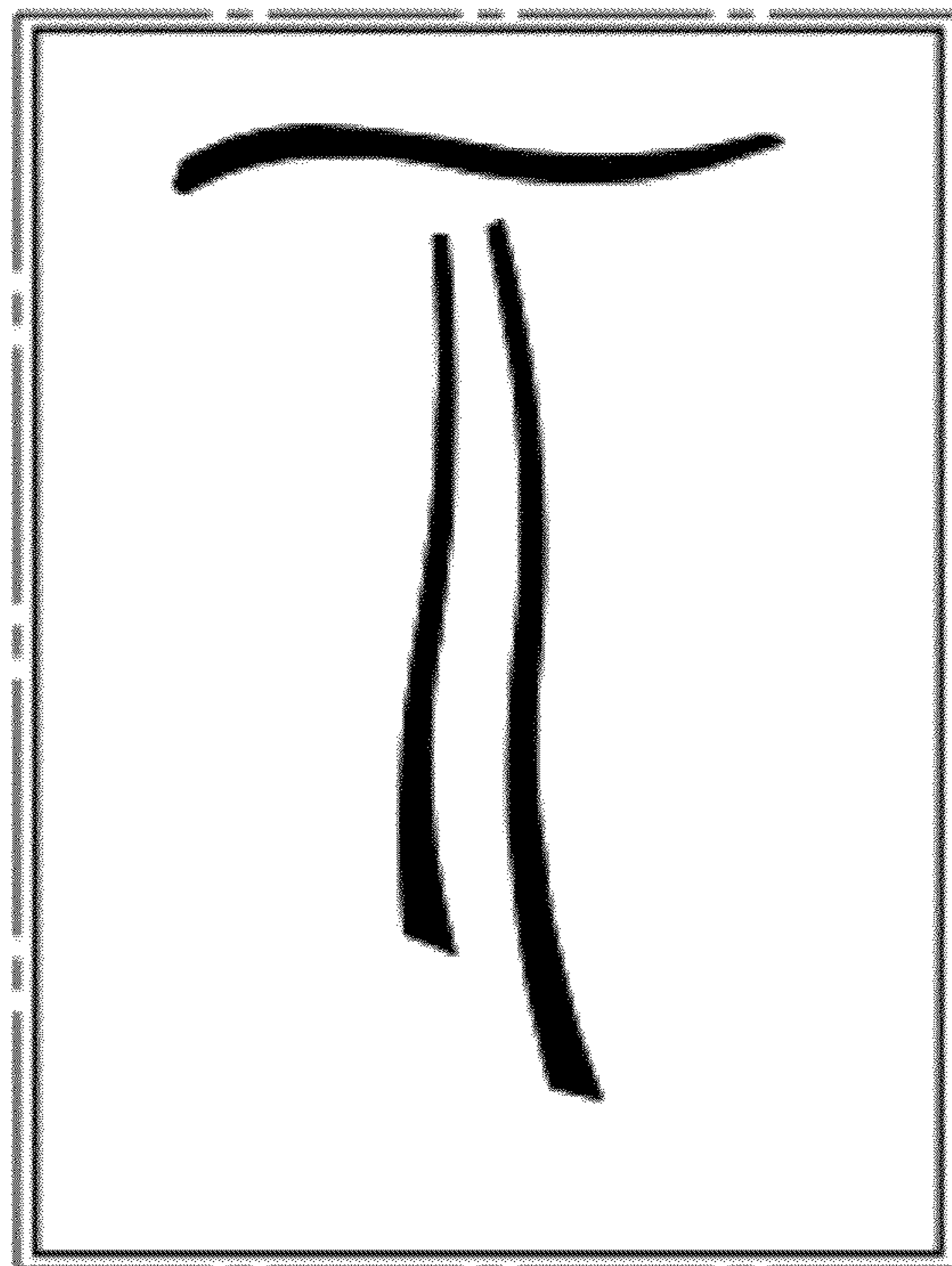
(57) **CLAIM**

The ornamental design for a cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the cabinet having a door adorned with a stylized symbol in the shape of the Greek letter pi; FIG. 2 is a top view of the cabinet of FIG. 1; FIG. 3 is a right side view of the cabinet of FIG. 1; FIG. 4 is a left side view of the cabinet of FIG. 1; FIG. 5 is a rear view of the cabinet of FIG. 1; FIG. 6 is a bottom view of the cabinet of FIG. 1; and, FIG. 7 is a perspective view of the cabinet of FIG. 1. The broken lines in the drawing are for illustrative purposes only and form no part of the claimed design.

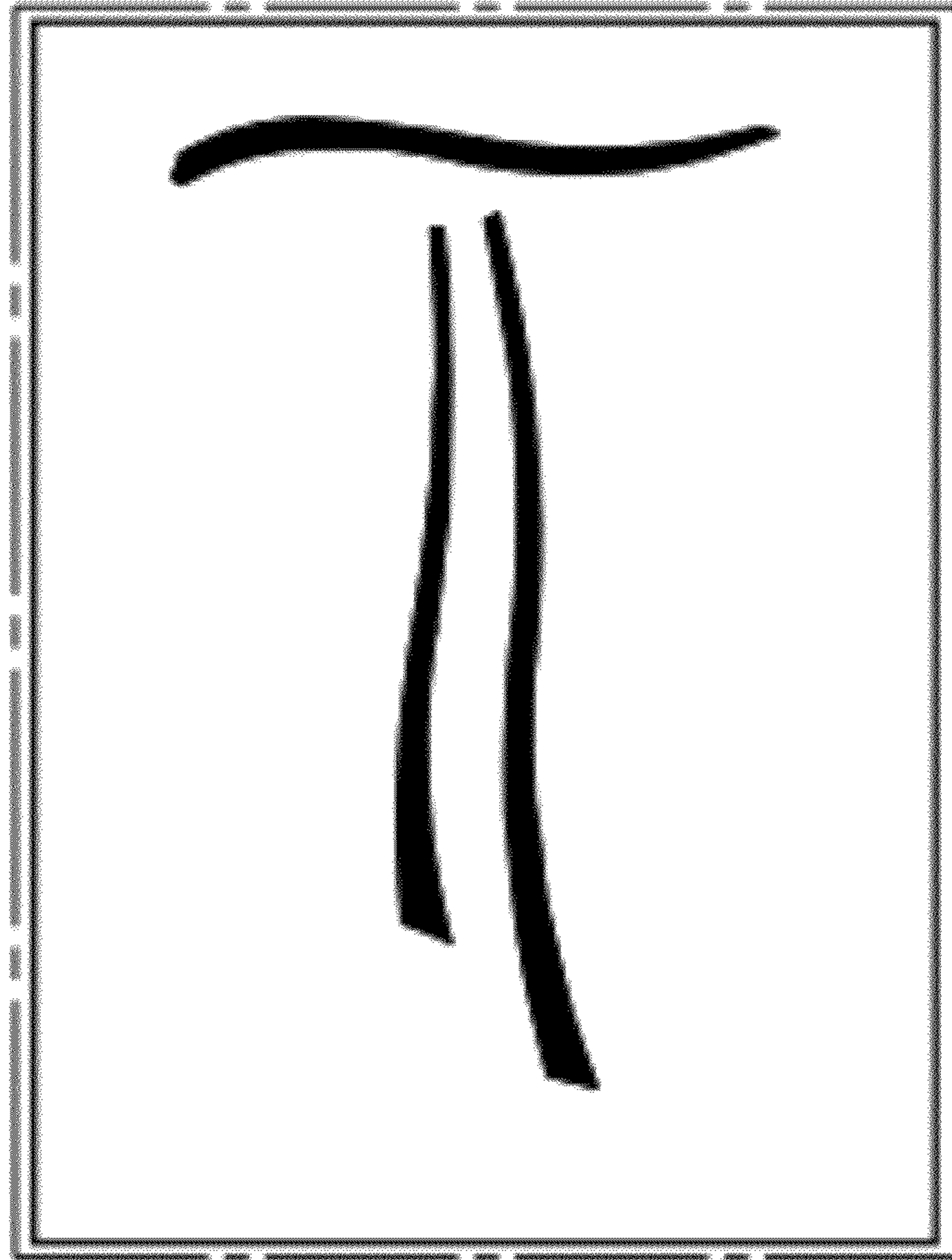

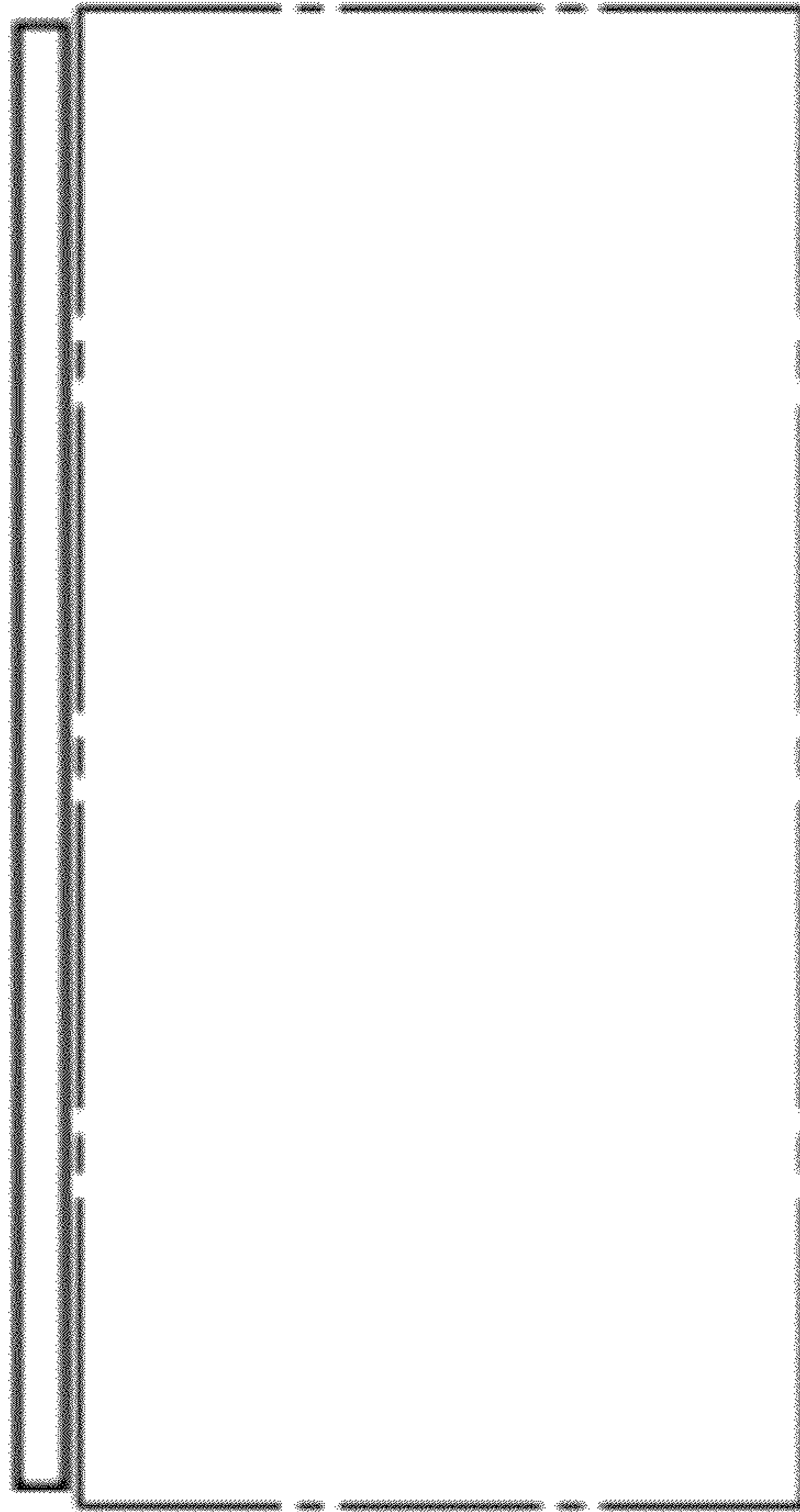

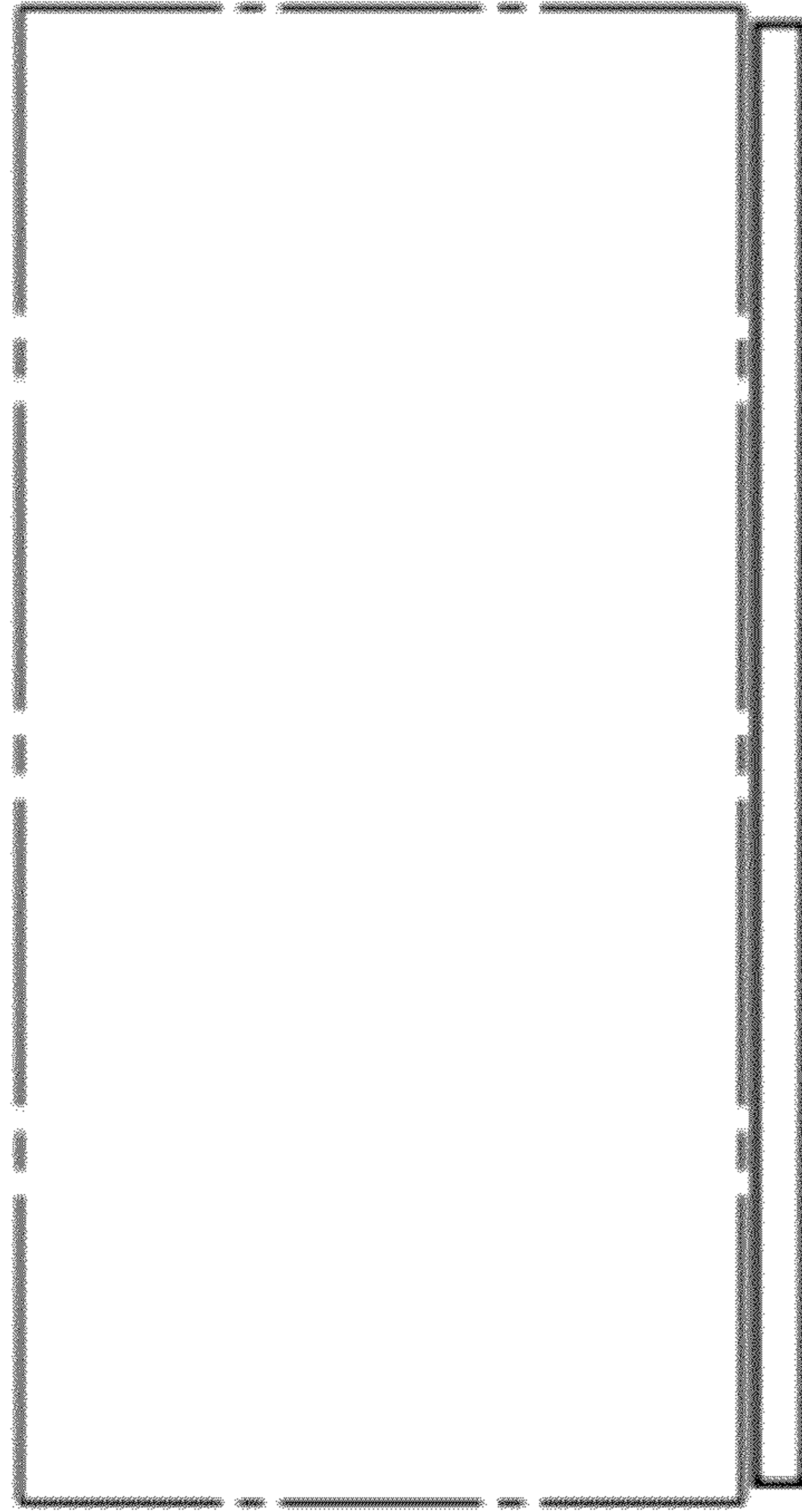

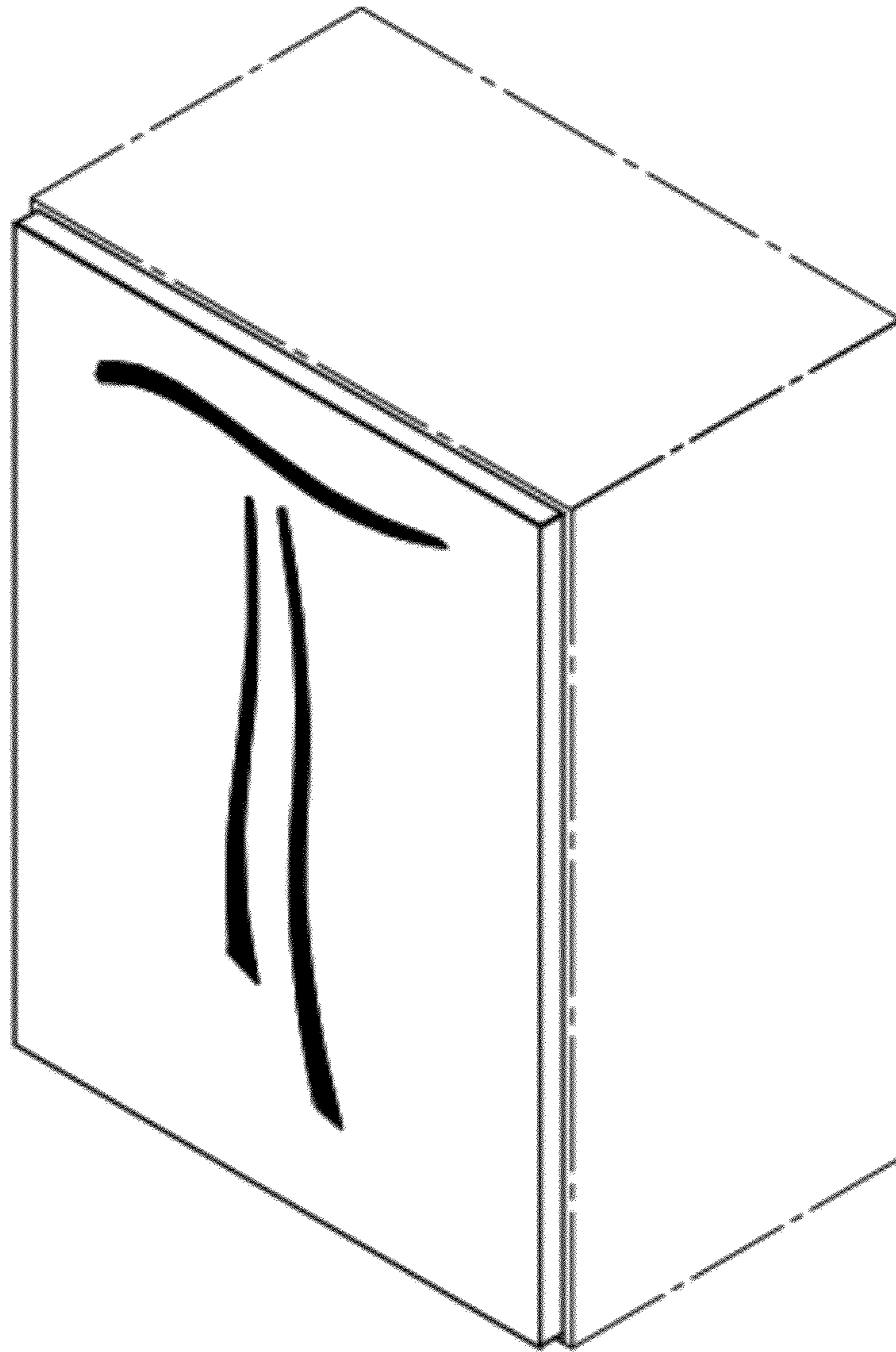
