(57) **CLAIM**

The ornamental design for an all-terrain vehicle body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from a front, left side of an all-terrain vehicle body according to our design;

FIG. 2 is a perspective view taken from a rear, left side thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a right side elevation view thereof;

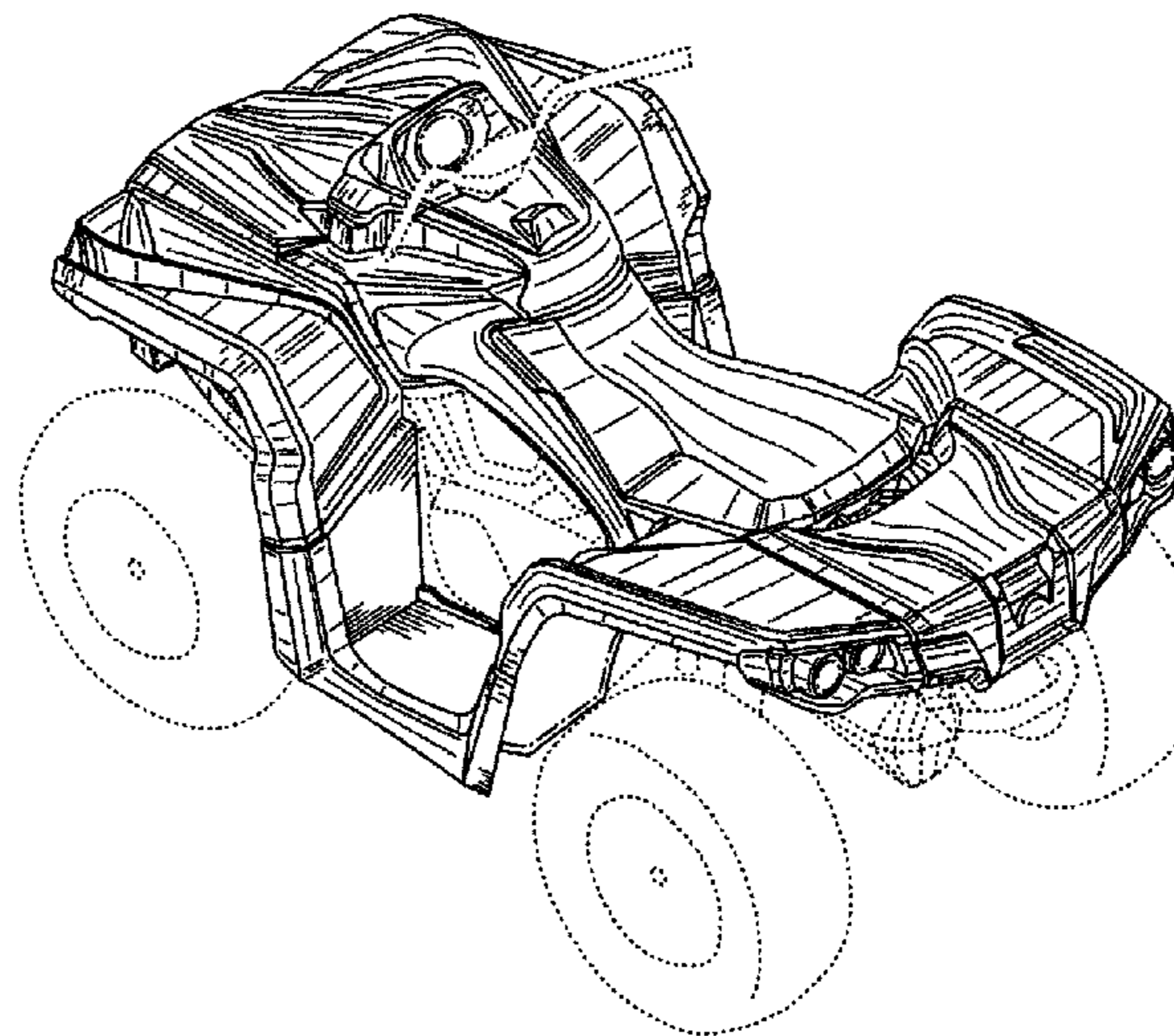
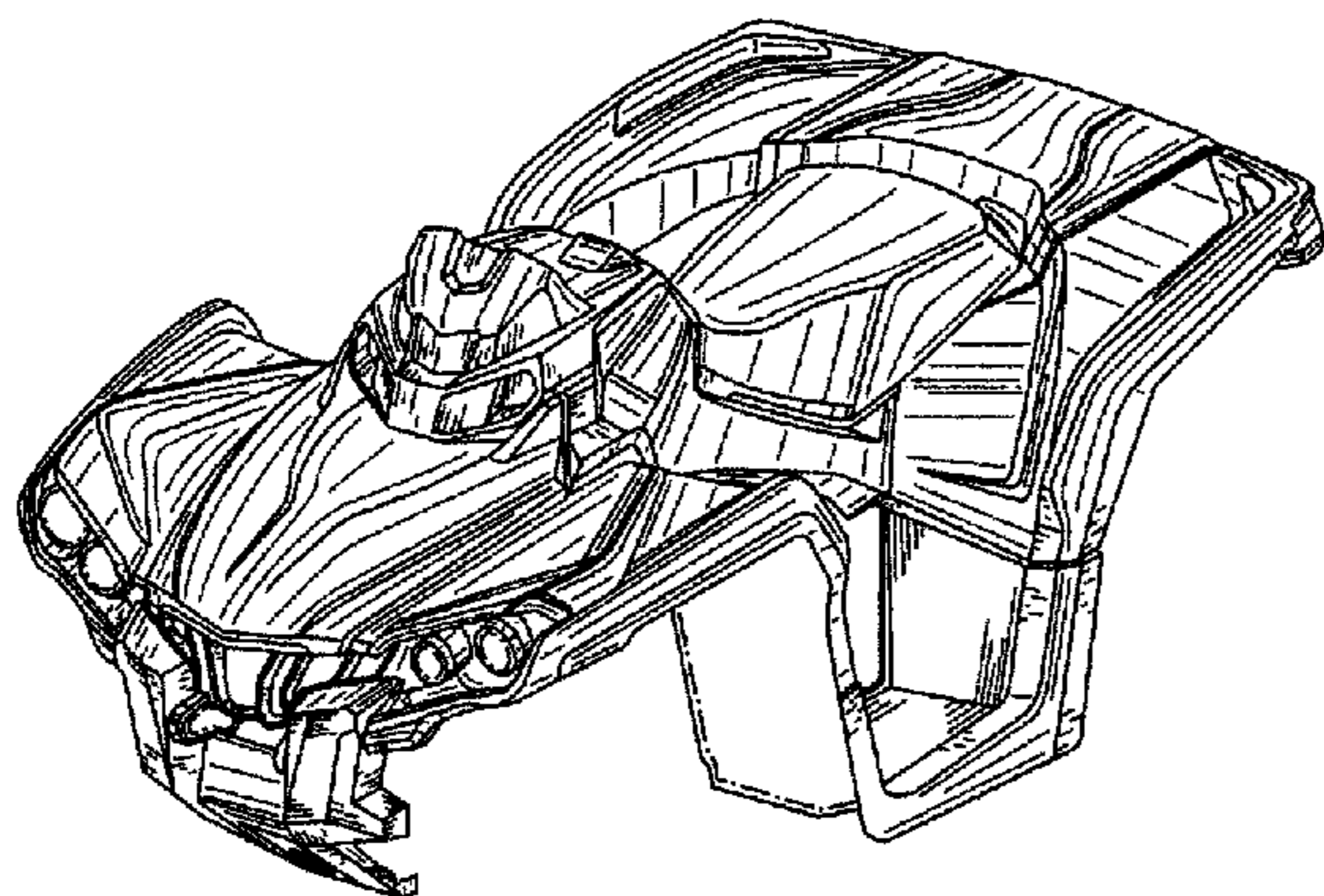
FIG. 7 is a front elevation view thereof;

FIG. 8 is a rear elevation view thereof; and,

FIG. 9 is a perspective view taken from a rear, left side thereof shown on an all-terrain vehicle shown in dotted lines.

Throughout the Figures, where shown: (i) the broken lines showing additional structure of the all-terrain vehicle body and the all-terrain vehicle on which it is shown in FIG. 9 are for illustrative purposes only and form no part of the claimed design; and (ii) in FIGS. 1, 2, 3, 4, 5, 7, 8 and 9, the dotted/dashed lines immediately adjacent solid lines represent unclaimed boundaries of the claimed design and as such, the unshaded surfaces defined by those dotted/dashed lines form no part of the claimed design. Portions of the all-terrain vehicle body not shown in the Figures and not otherwise described in this Specification do not form part of the claimed design.

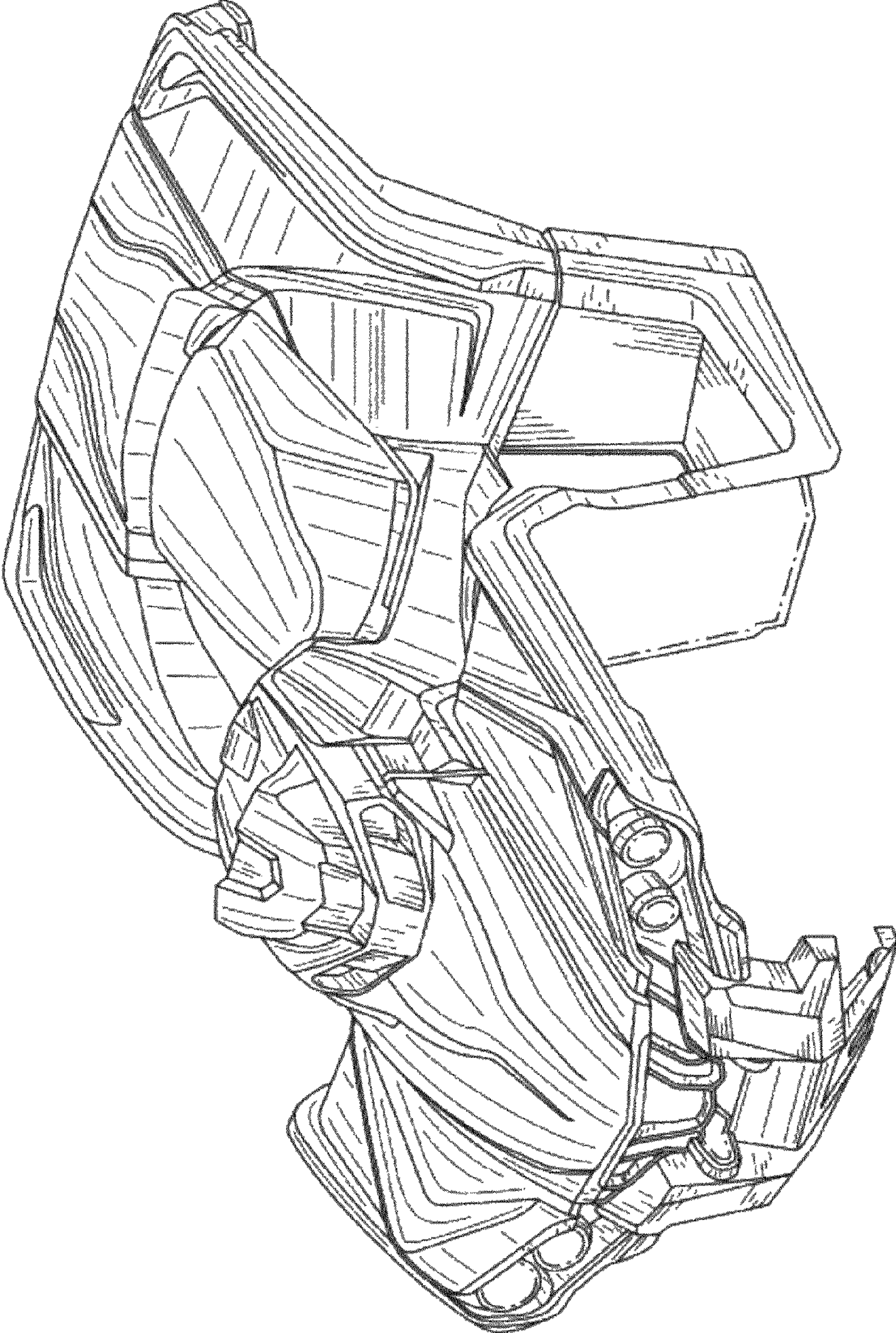

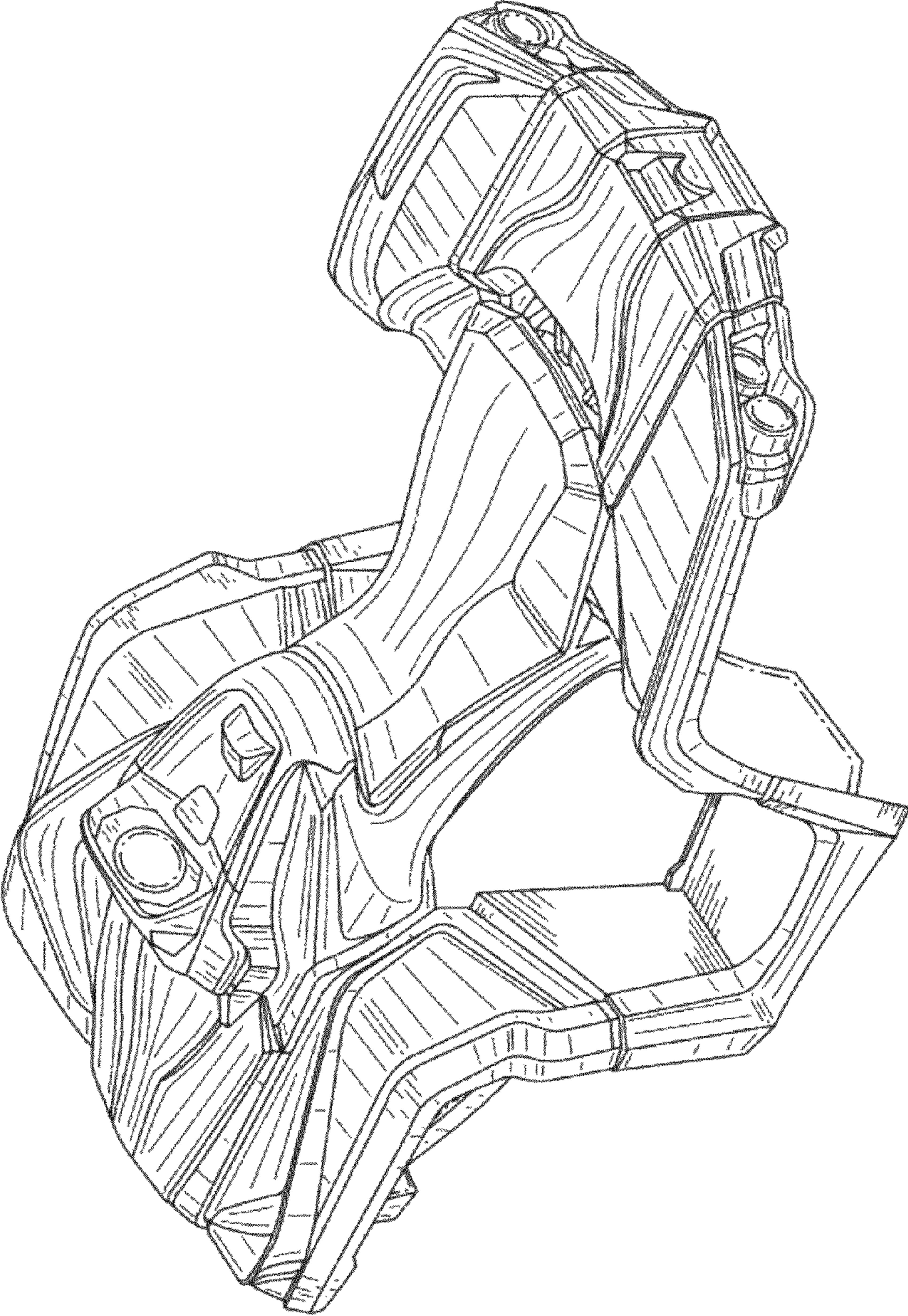

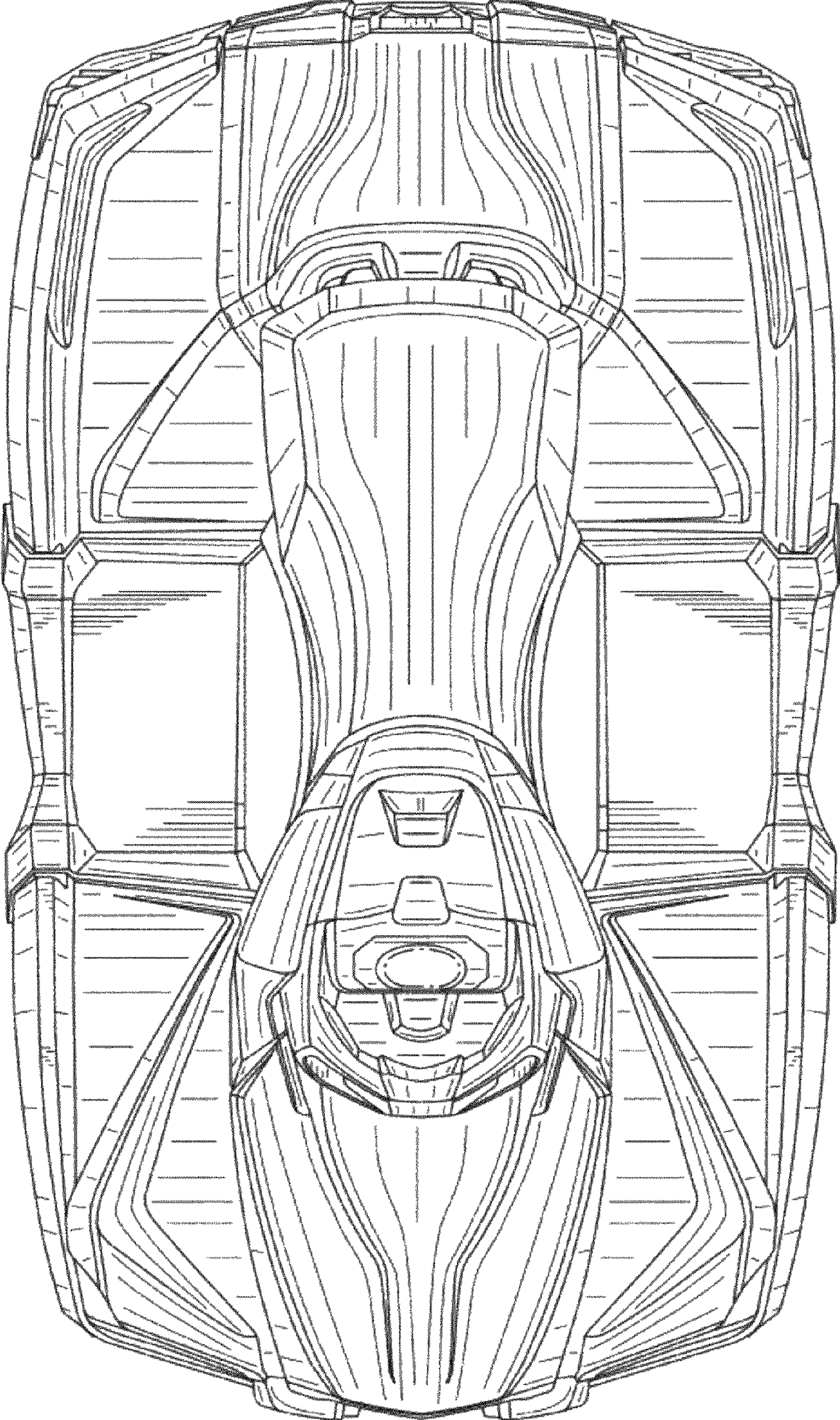

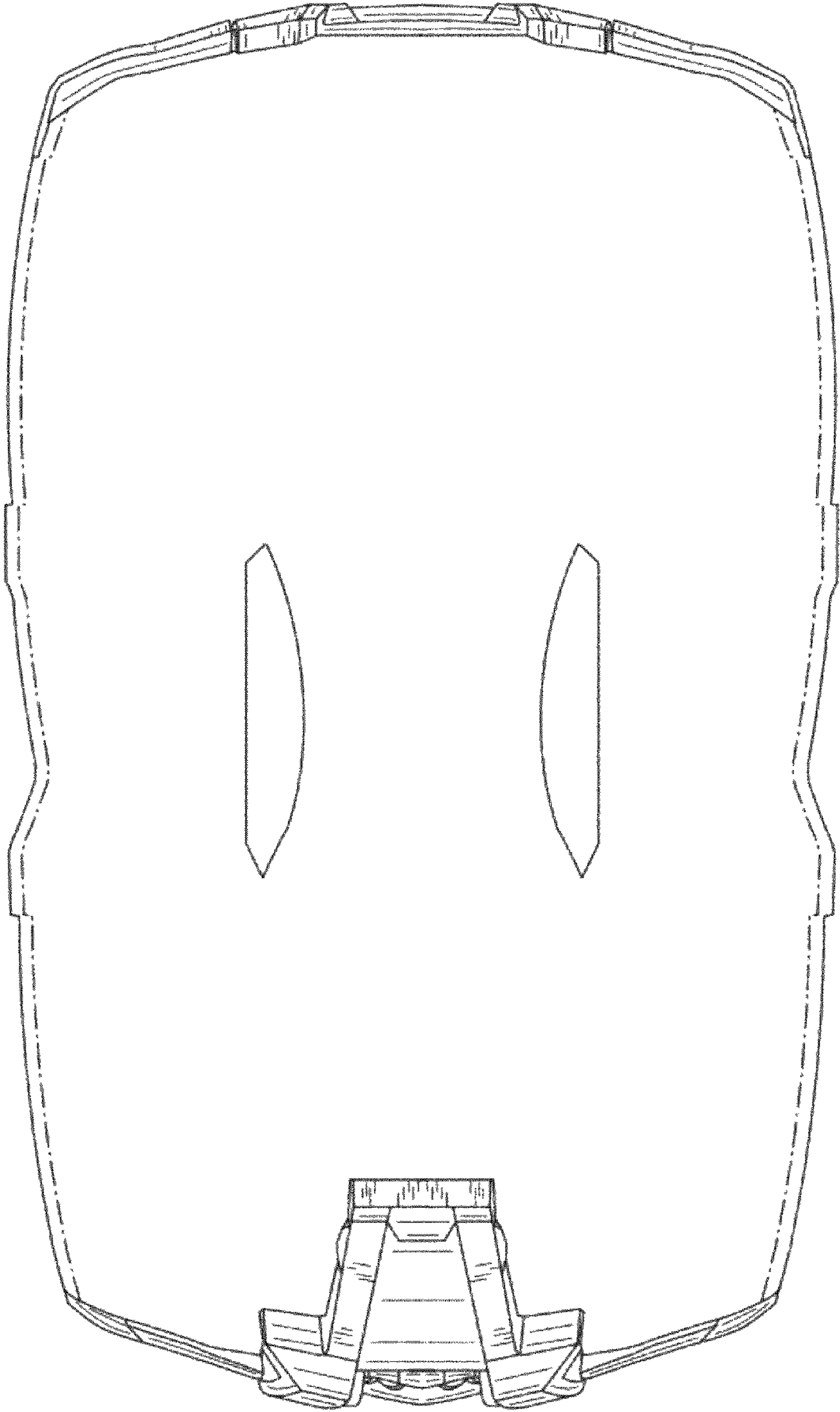

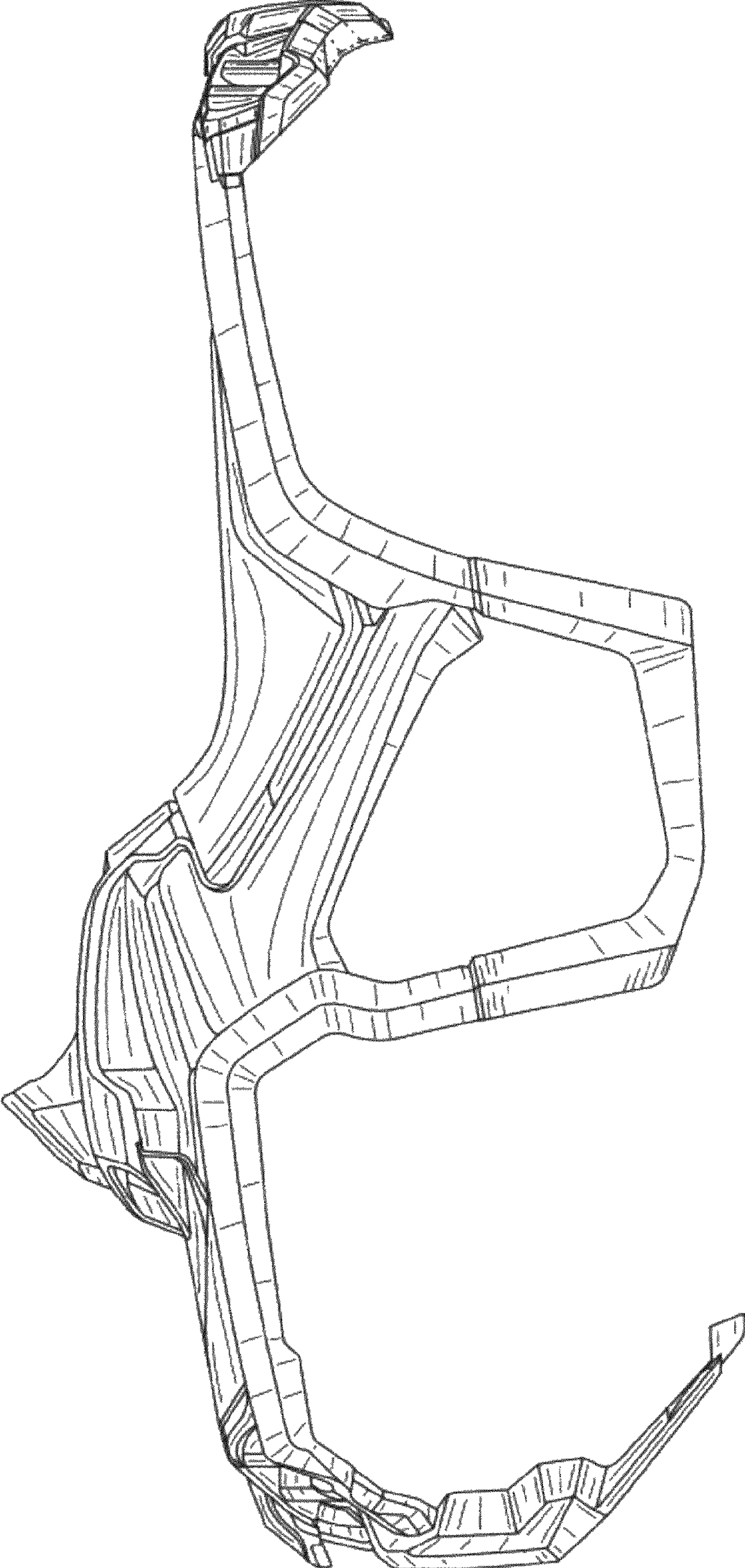

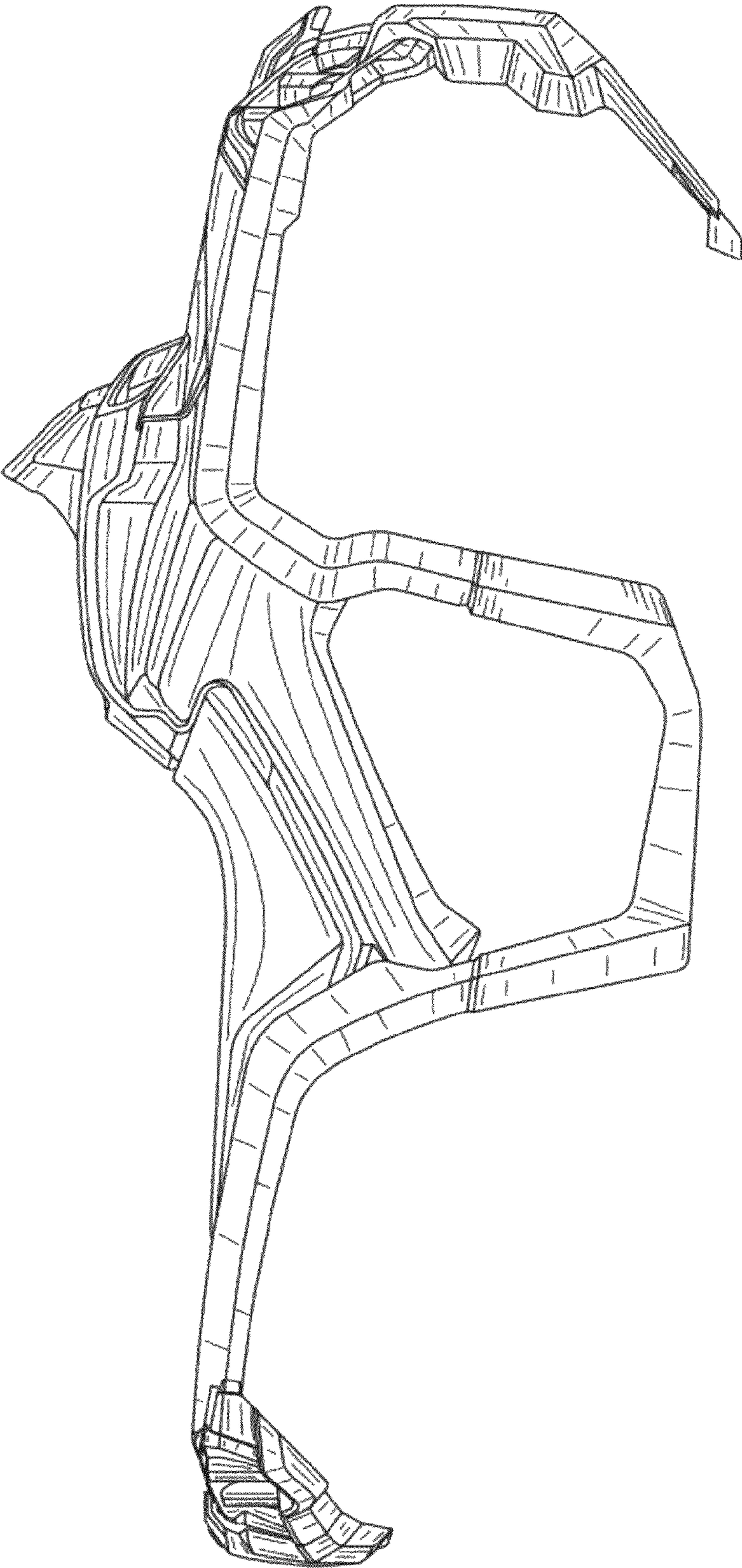

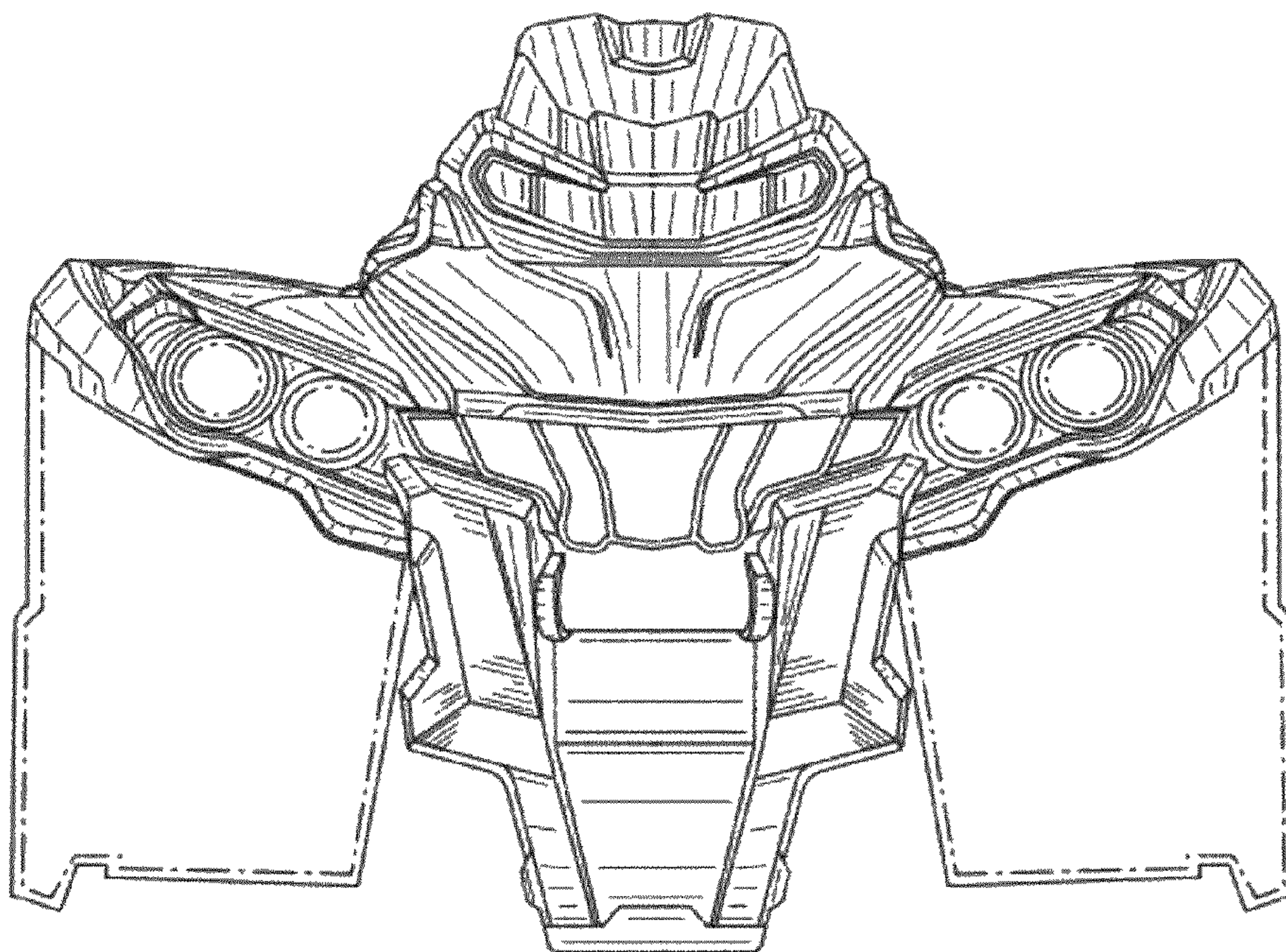

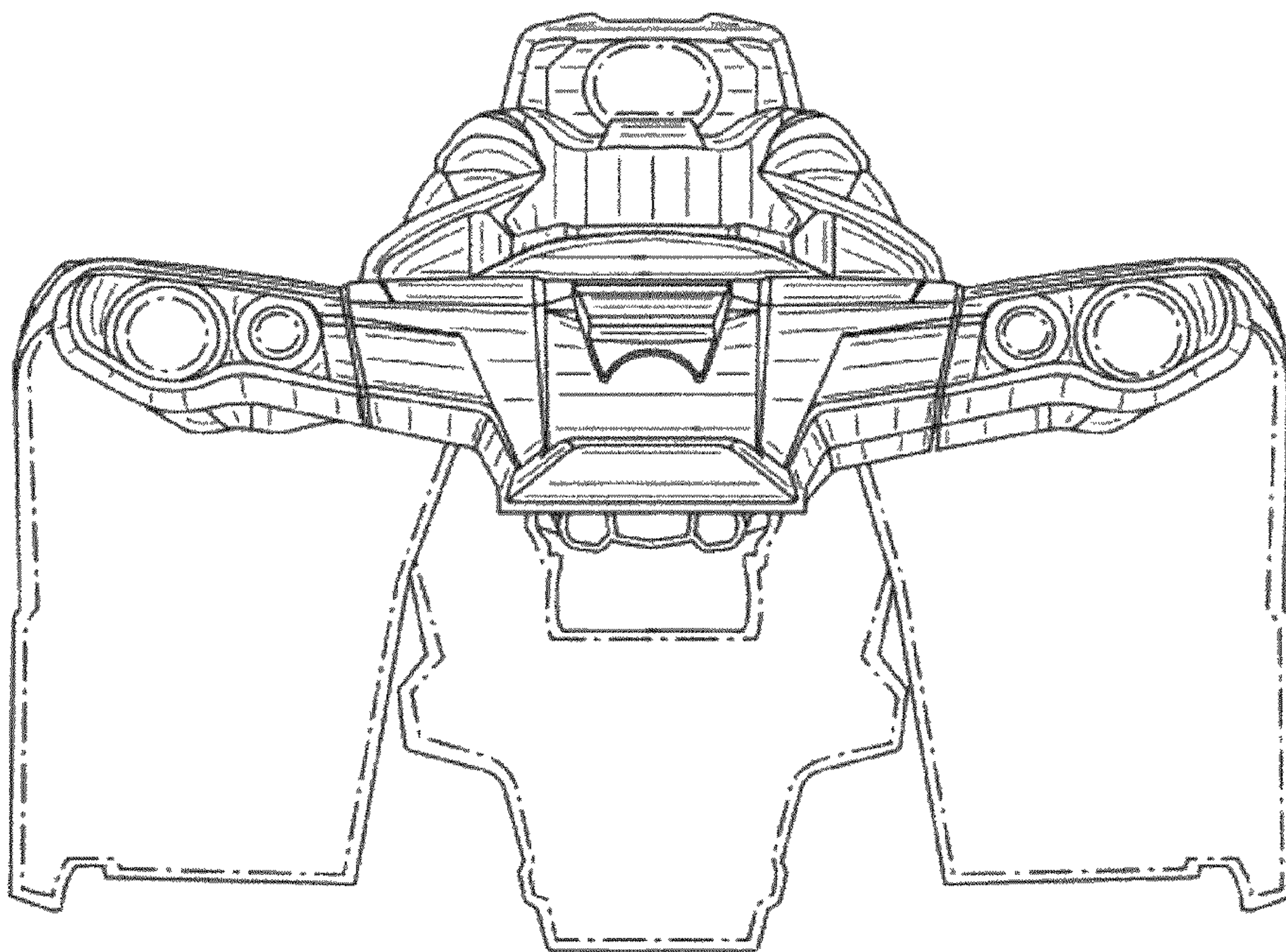

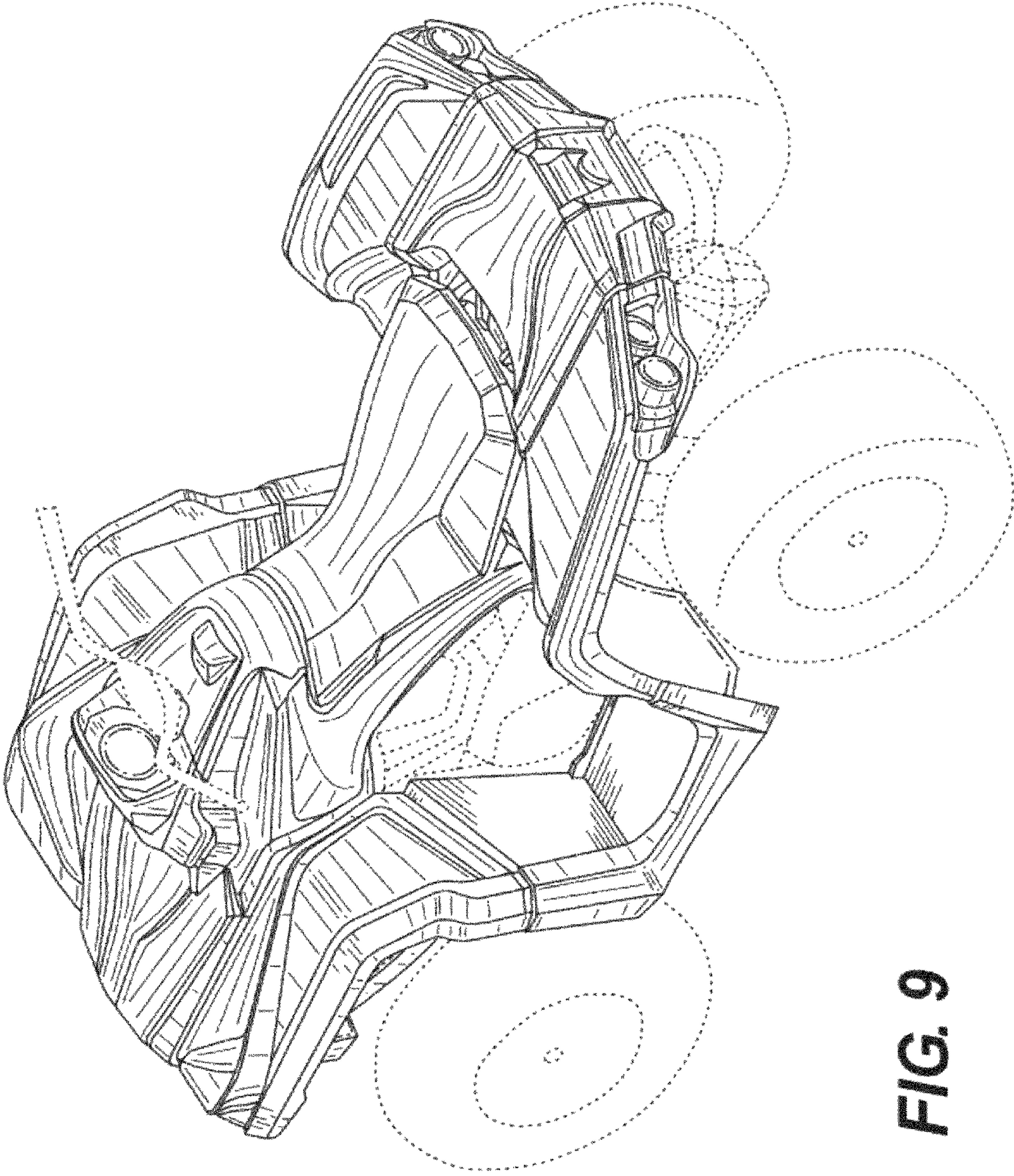
