(57) **CLAIM**

The ornamental design for a headband for eyeglass shaped headphones, as shown and described.

DESCRIPTION

FIG. 1 is a front, left perspective view of a headband for eyeglass shaped headphones showing our new design, the headband is drawn as a sectional view for purposes of illustration;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is an elevated left view thereof;

FIG. 5 is an elevated right view thereof;

FIG. 6 is an top plan view thereof; and,

FIG. 7 is bottom plan view thereof.

The dotted lines illustrate environmental features of exemplary eyeglass shaped headphones, and form no part of the claimed design.

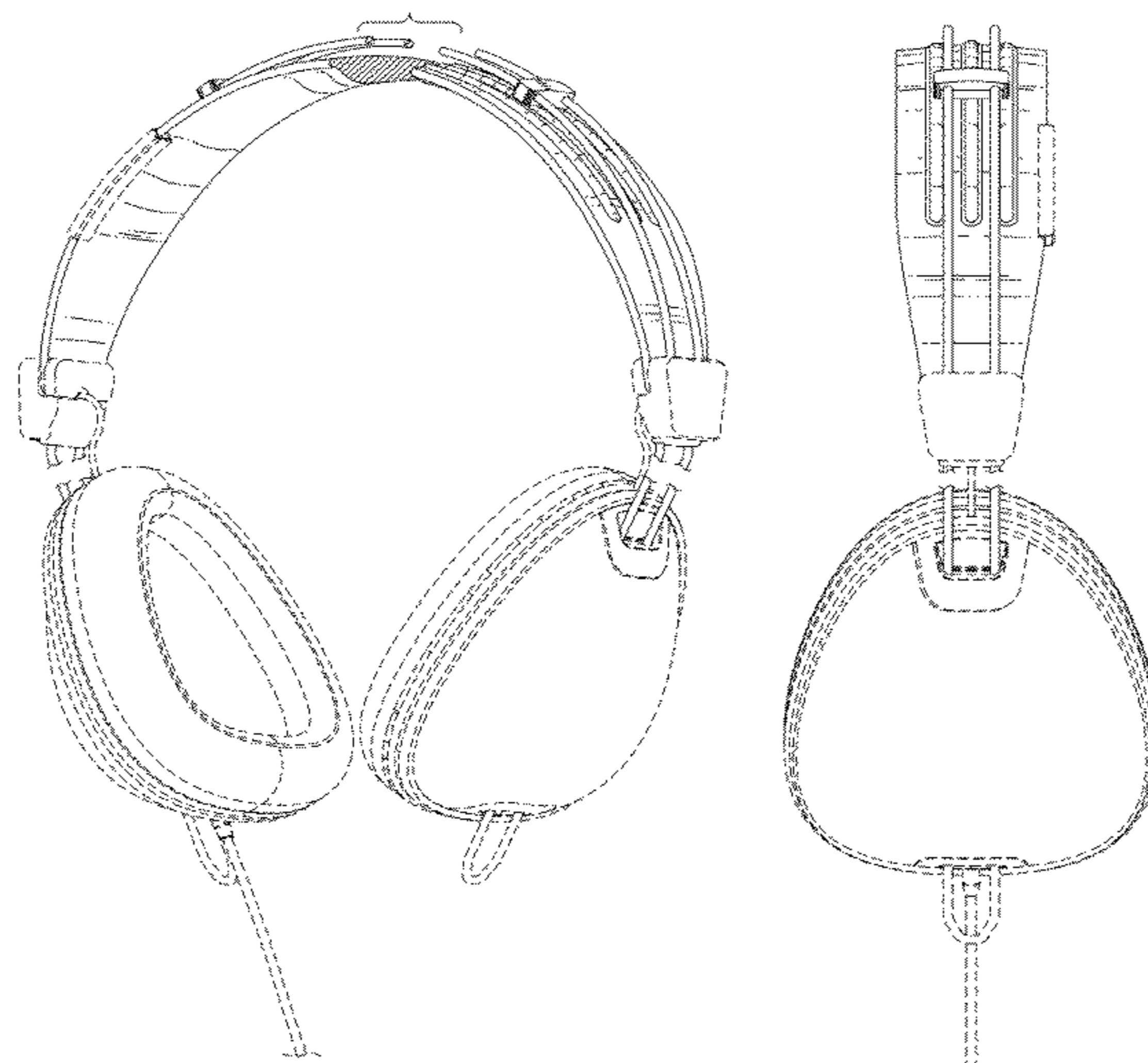

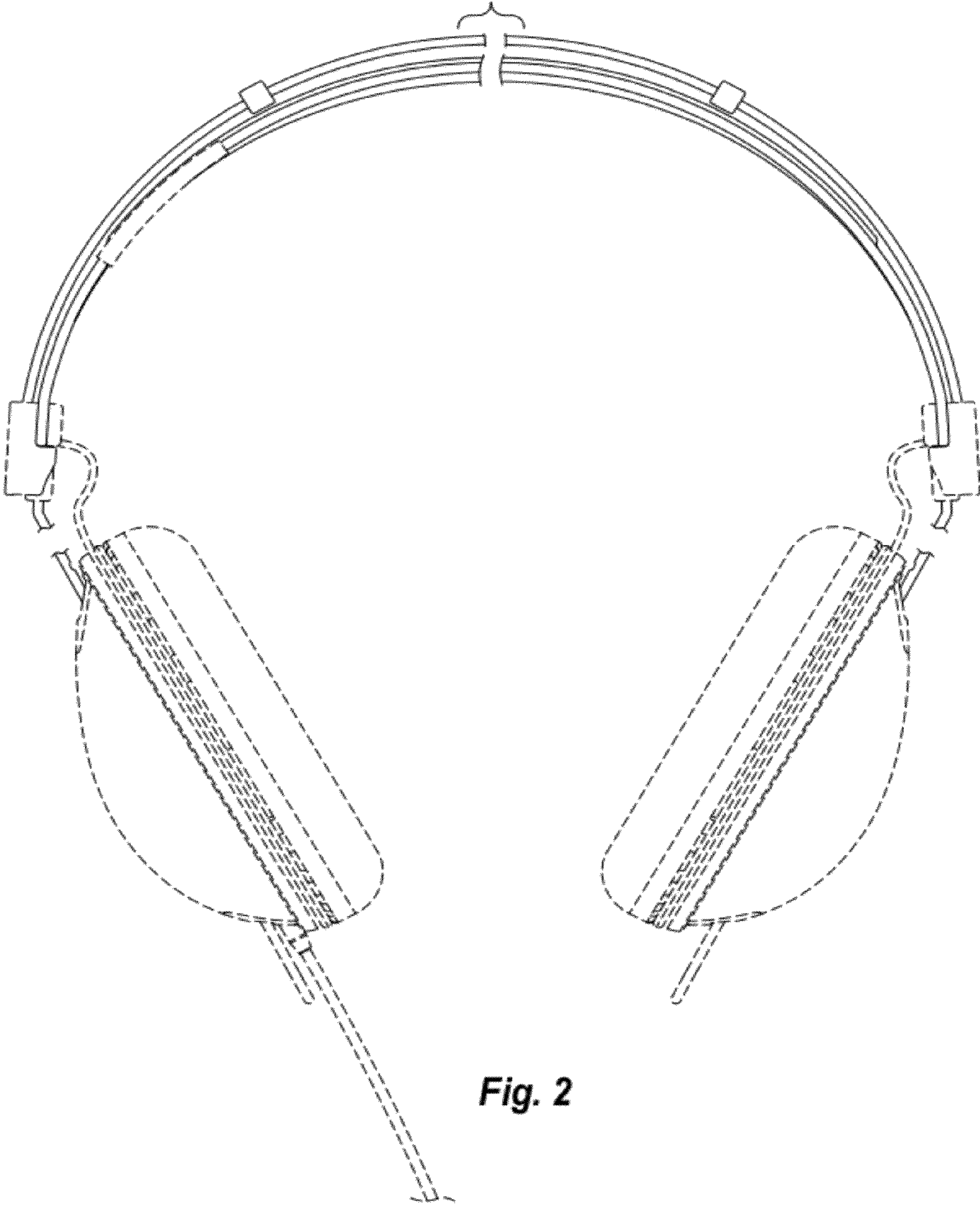

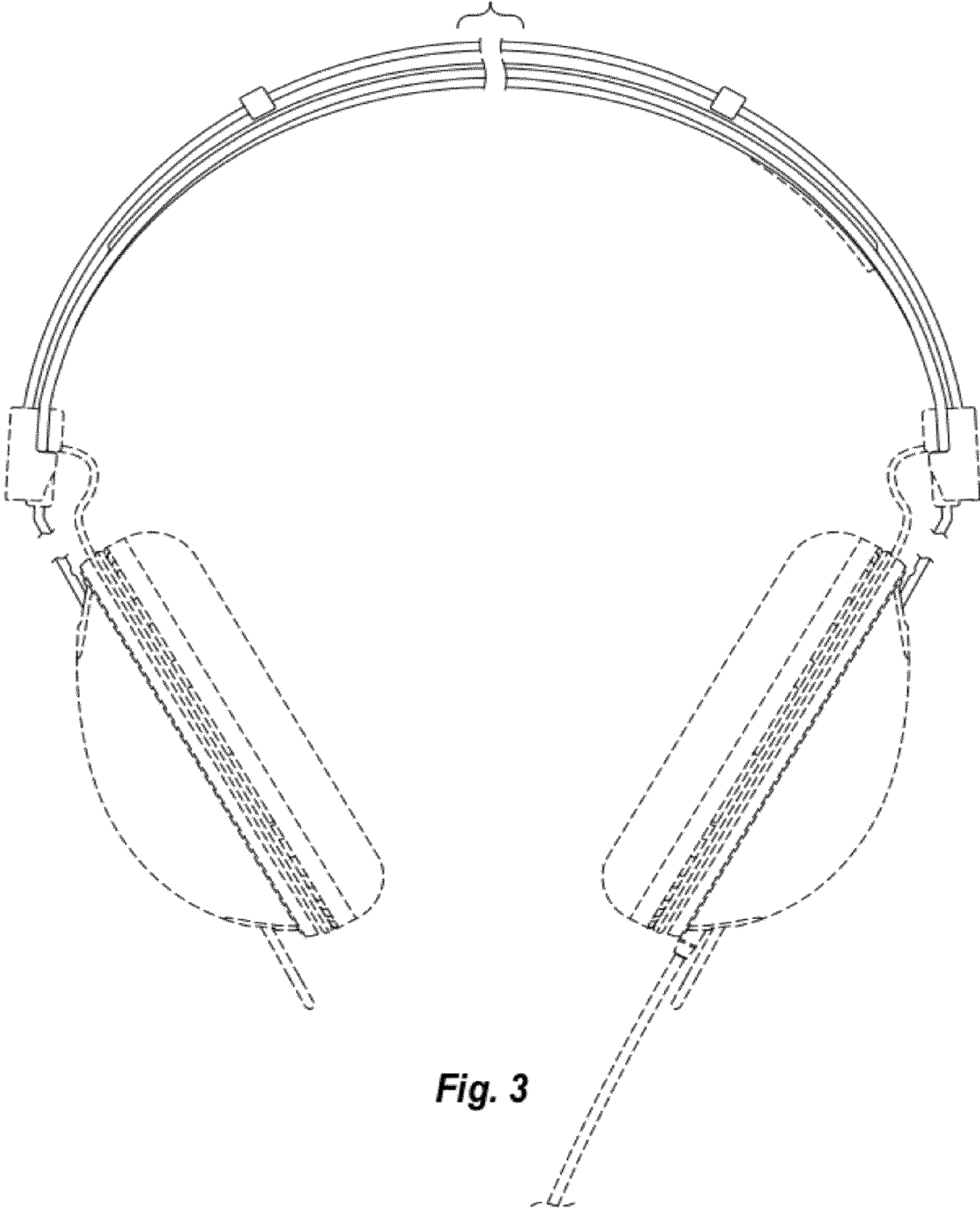

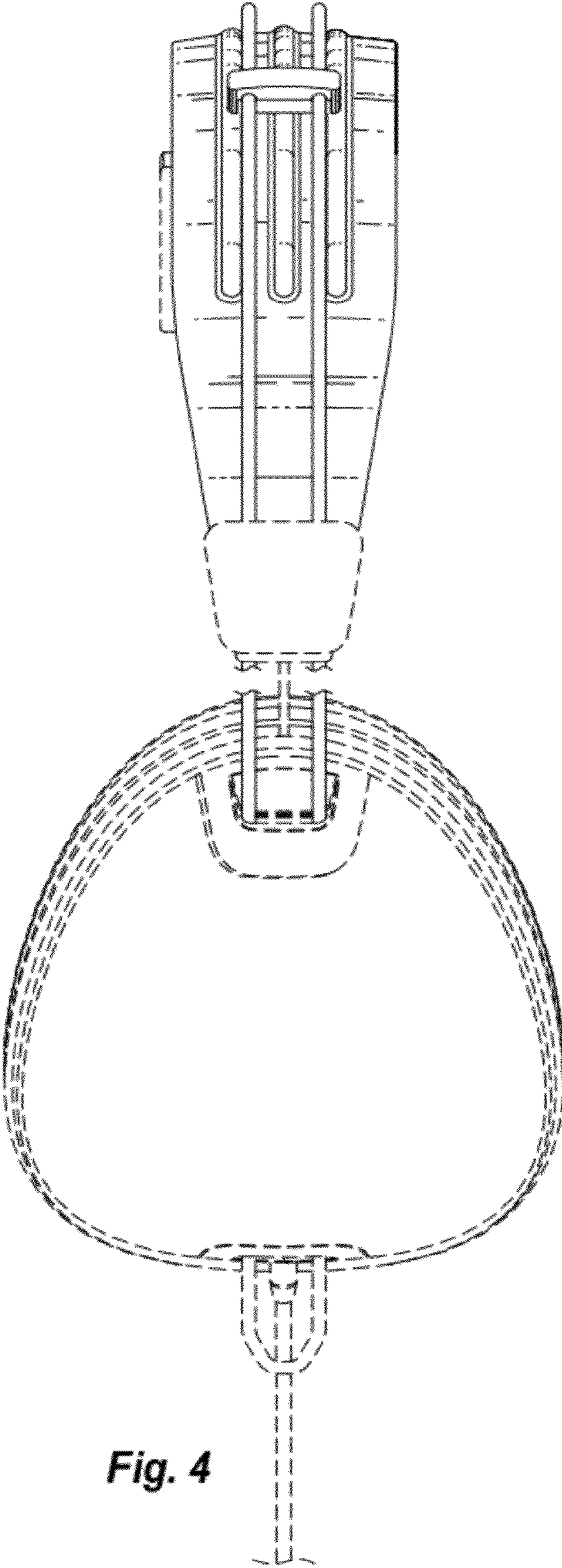
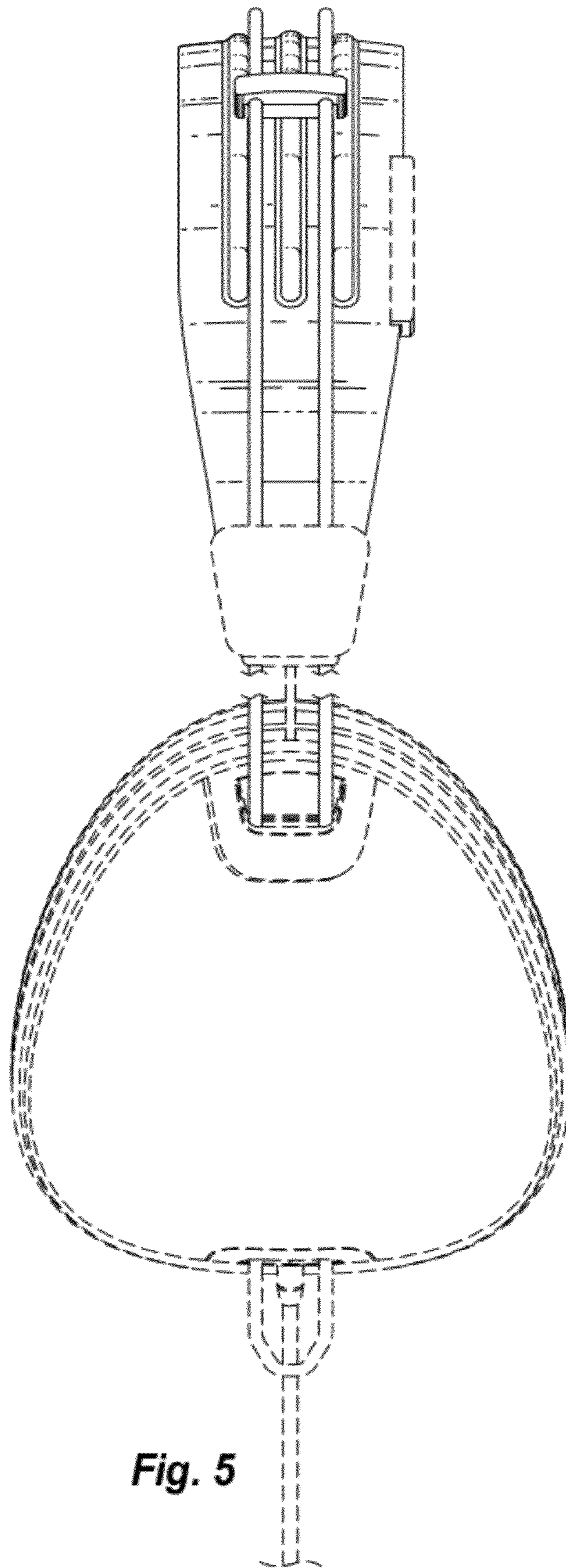

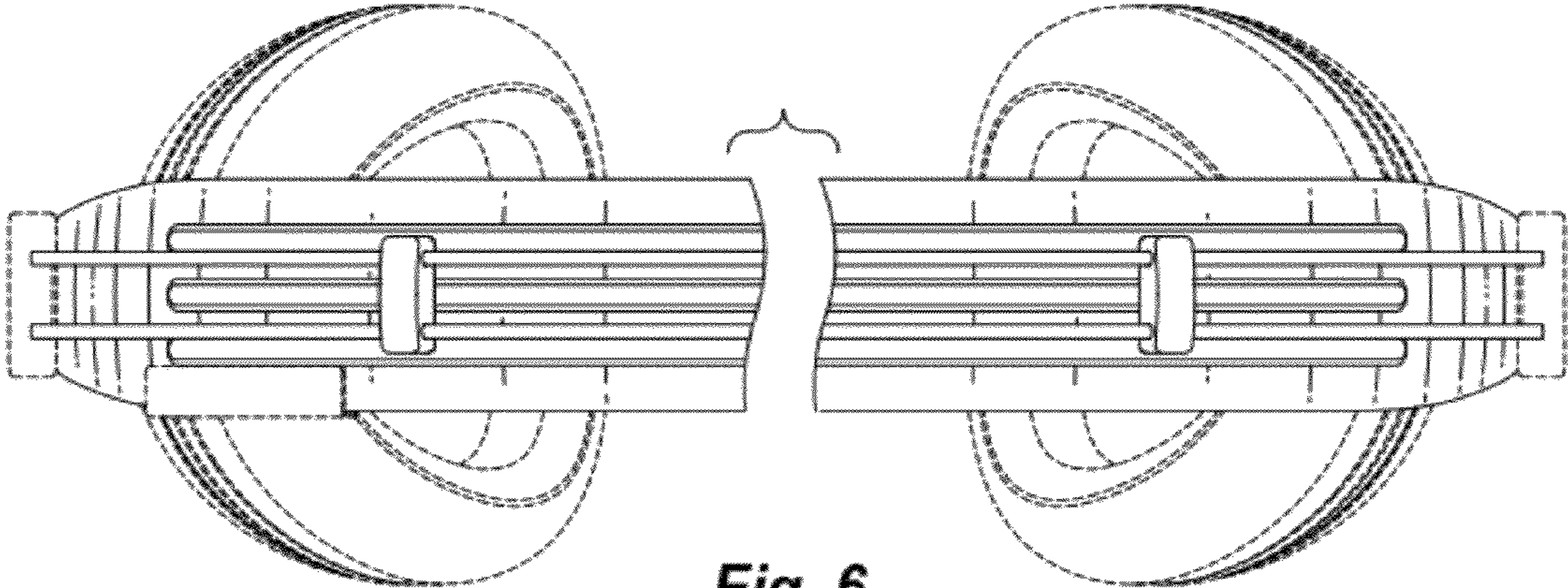

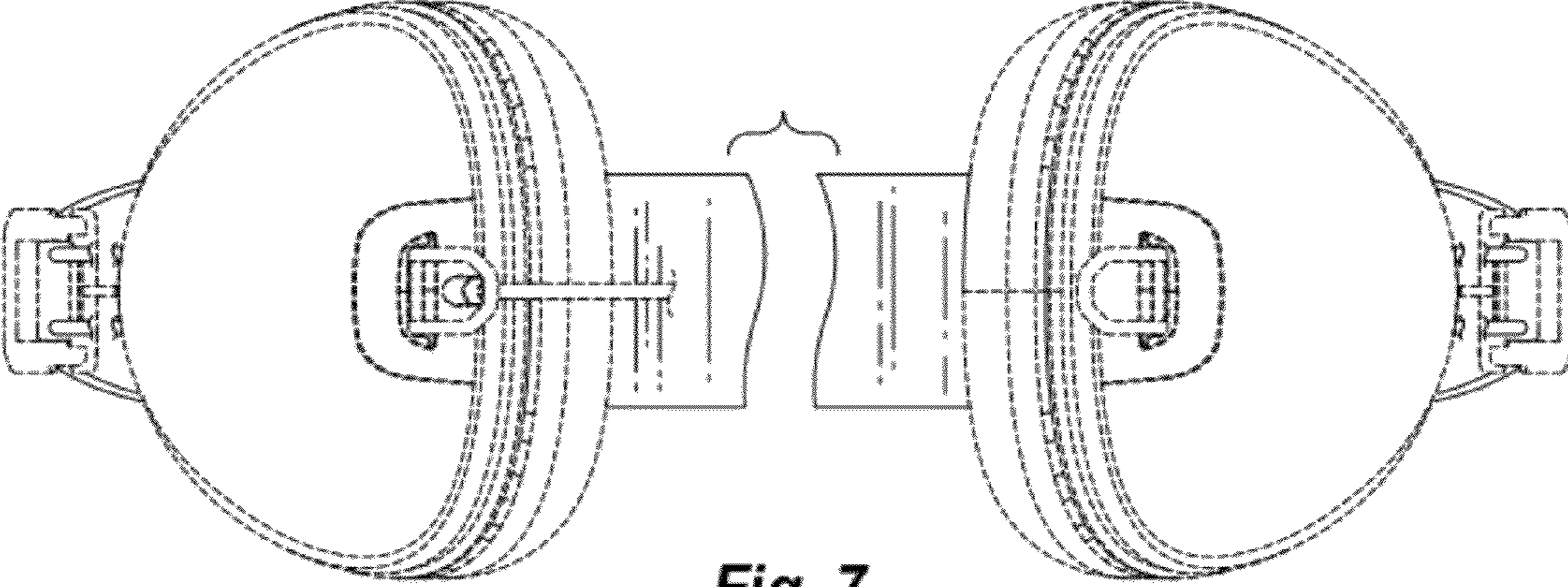
