DESCRIPTION

FIG. 1 is a top plan view of a flat keyboard with character symbols;

FIG. 5 is a bottom view thereof;

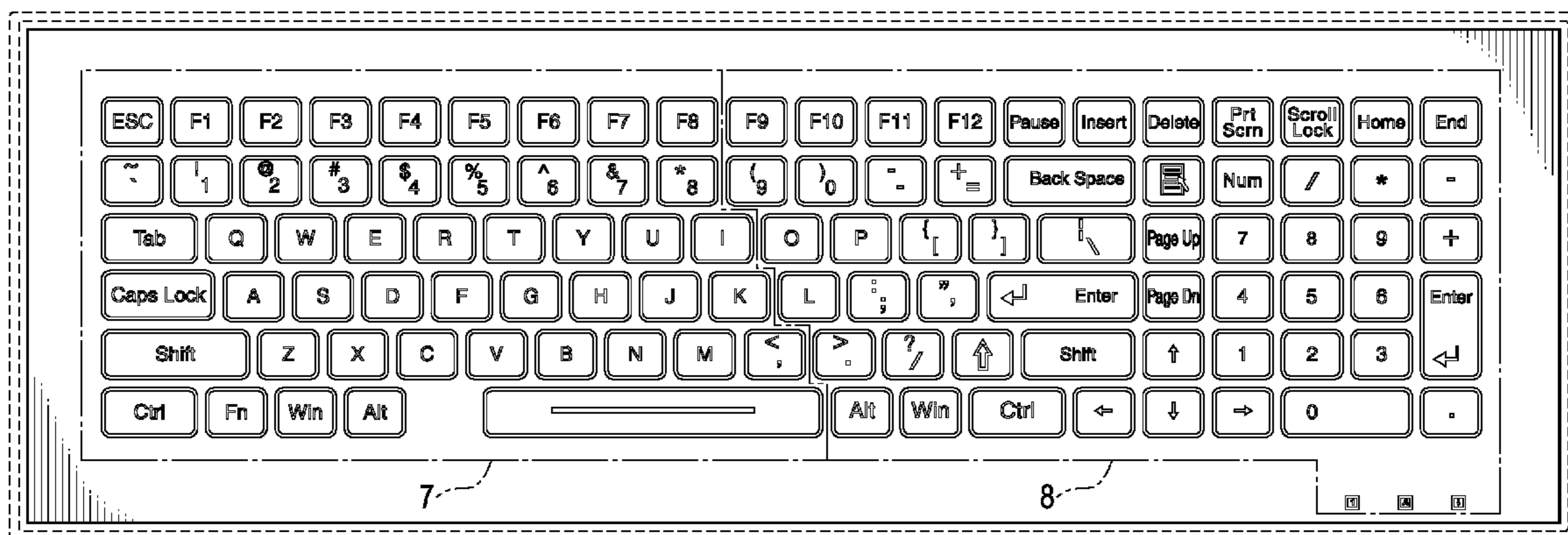
FIG. 6 is a rear view thereof;

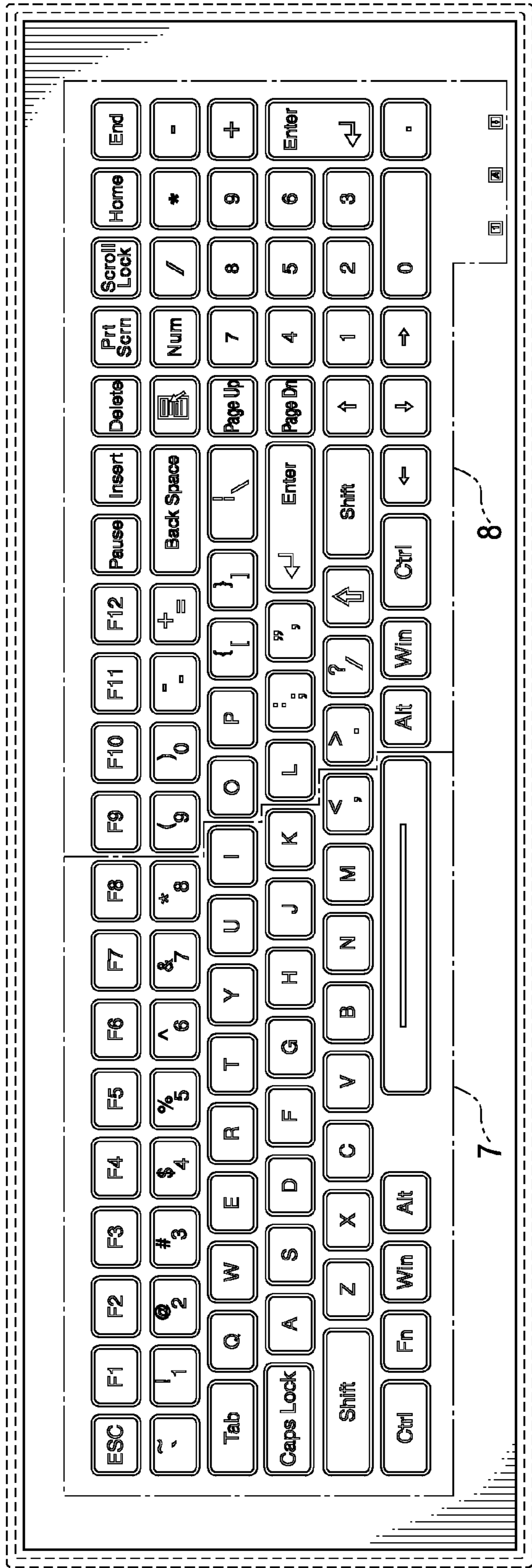

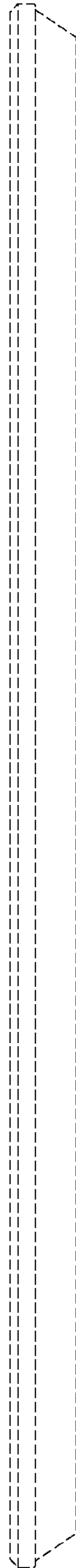

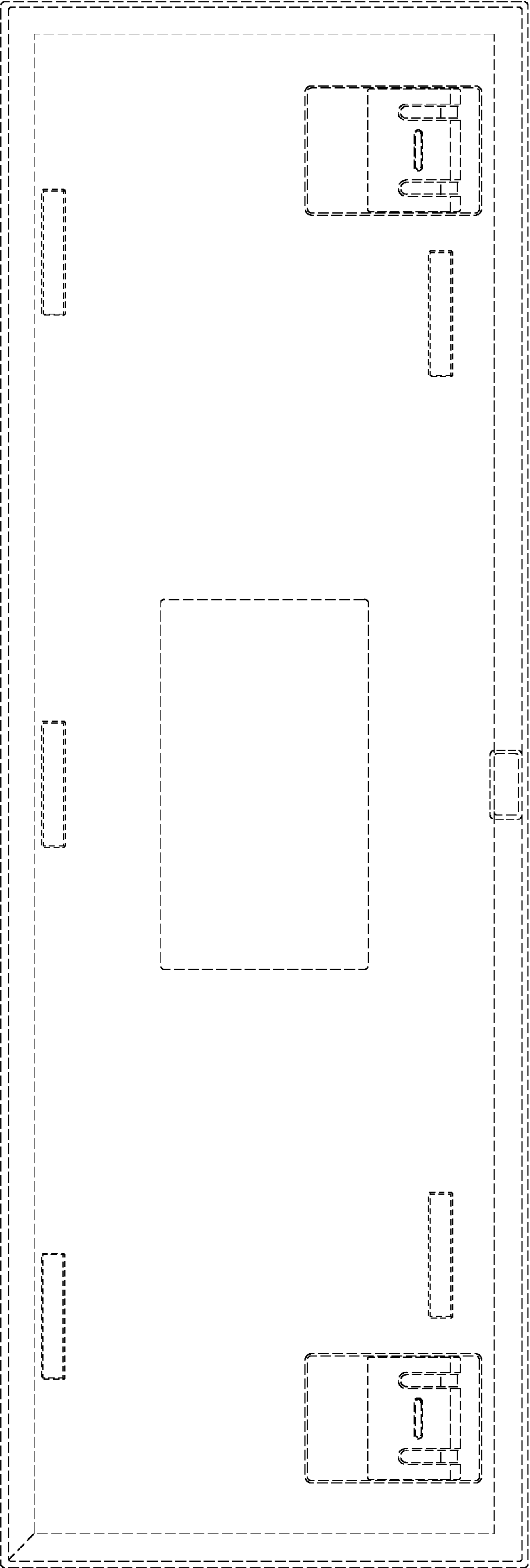

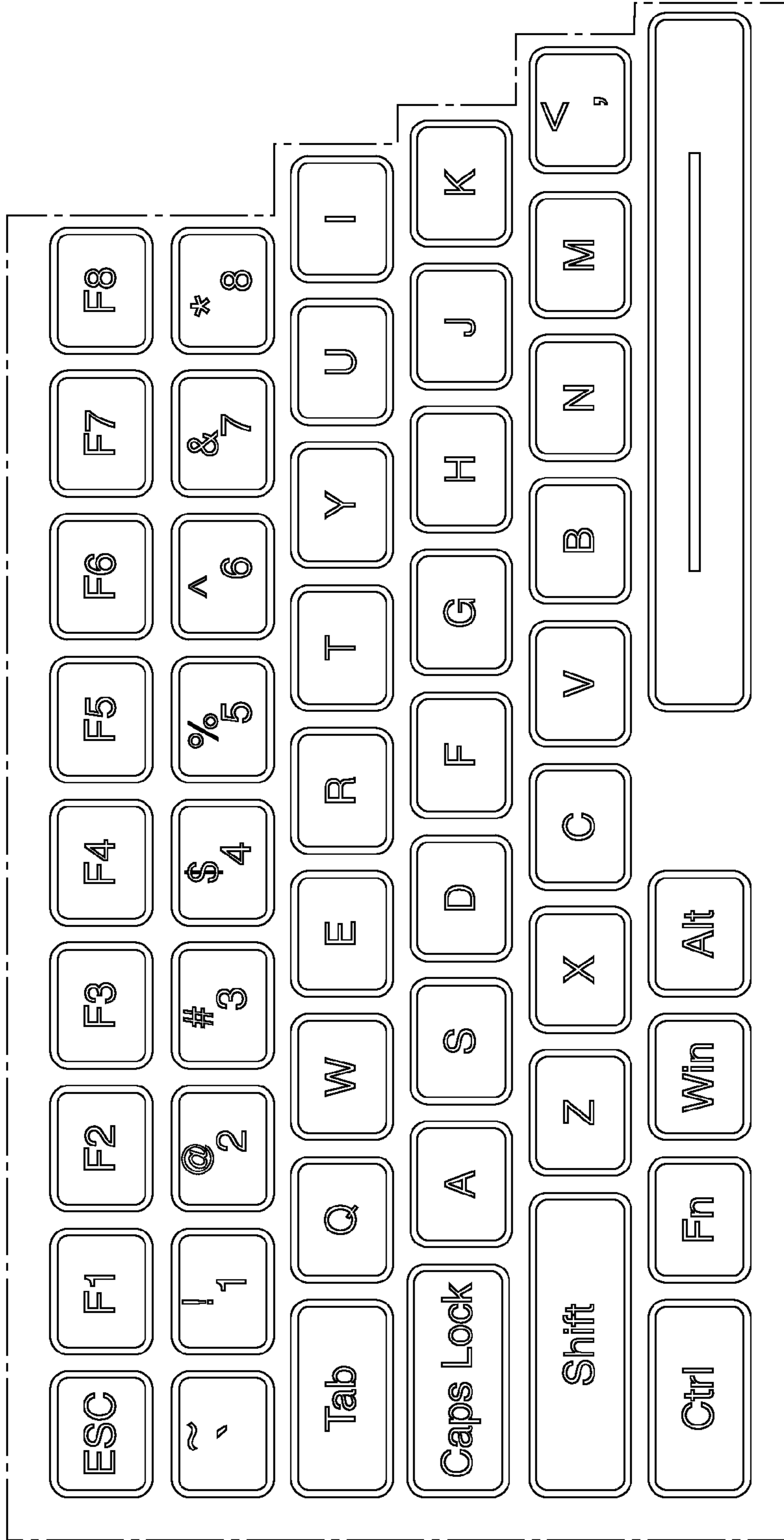

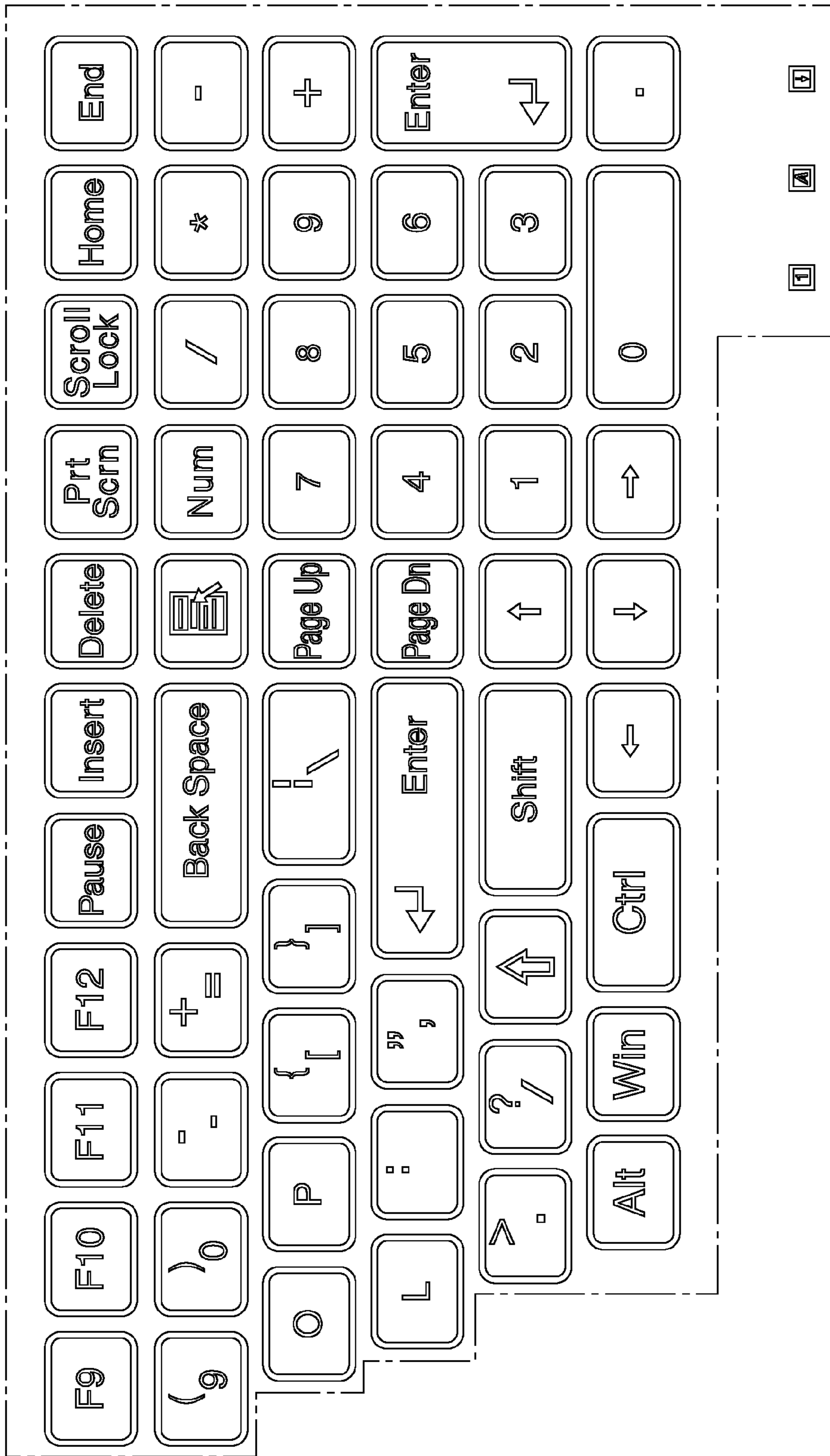
