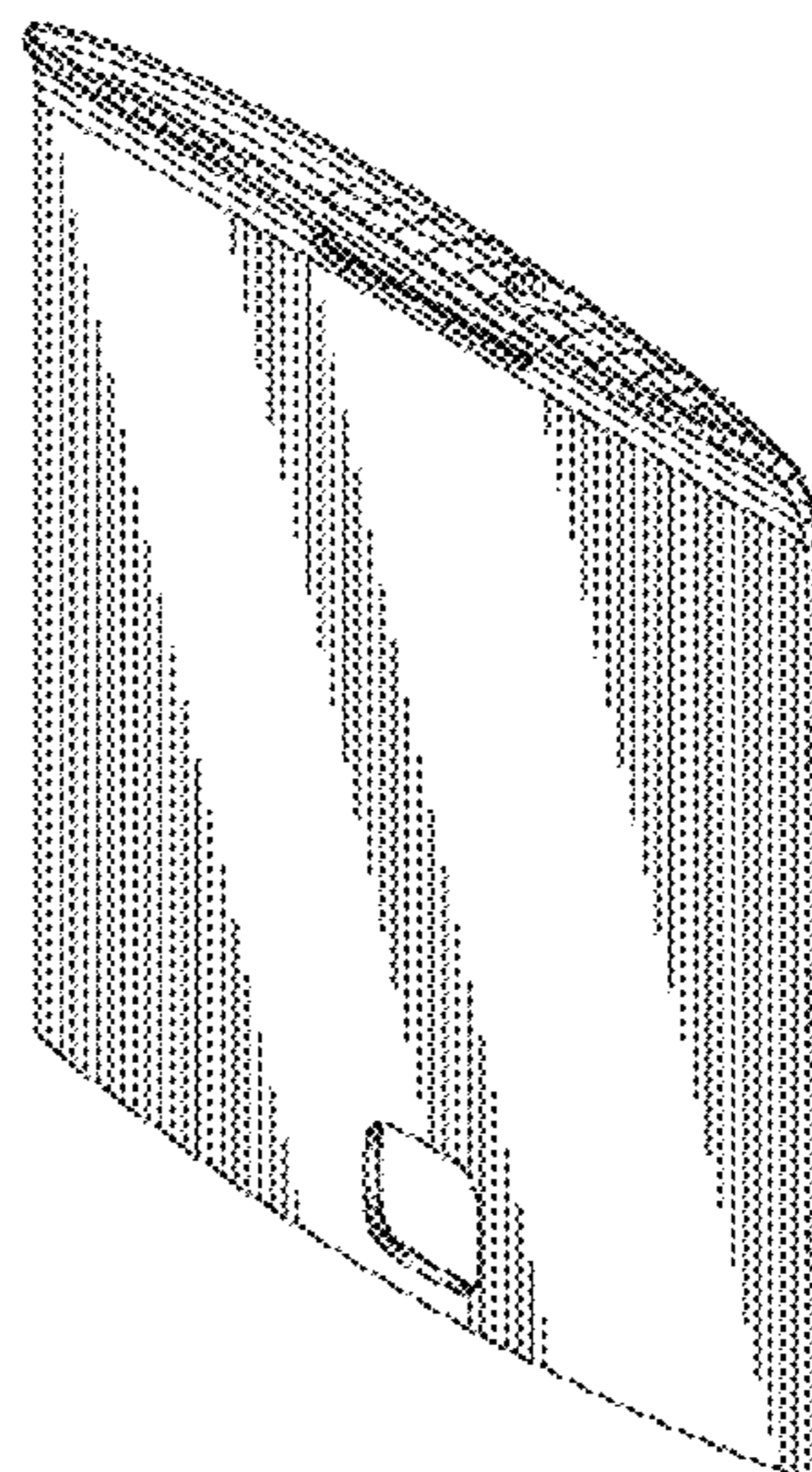
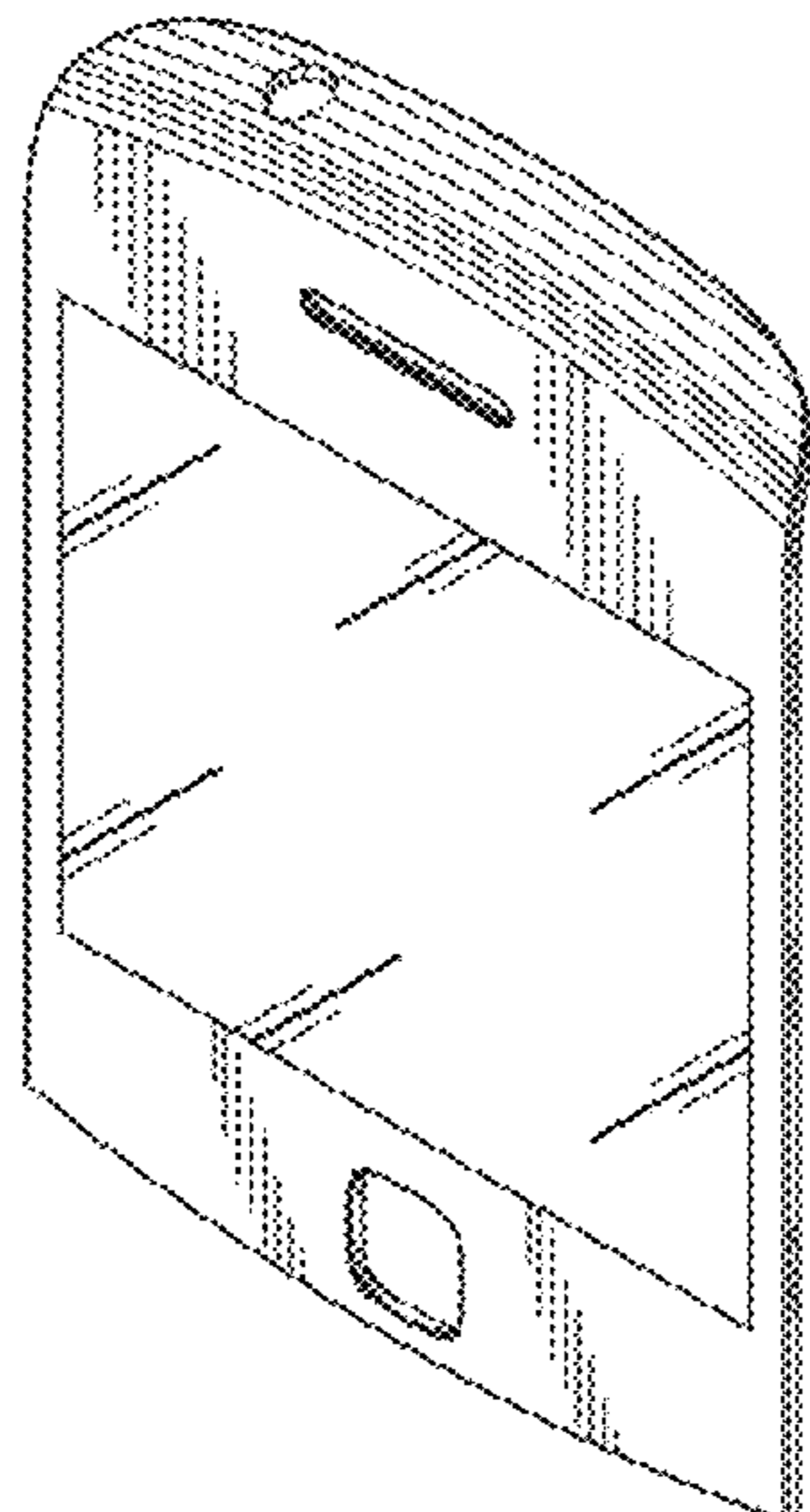
(57) **CLAIM**

We claim the ornamental design for a device lens, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a device lens;  
FIG. 2 is a back perspective view of the device lens;  
FIG. 3 is a back elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a left elevational view thereof;  
FIG. 6 is a right elevational view thereof;

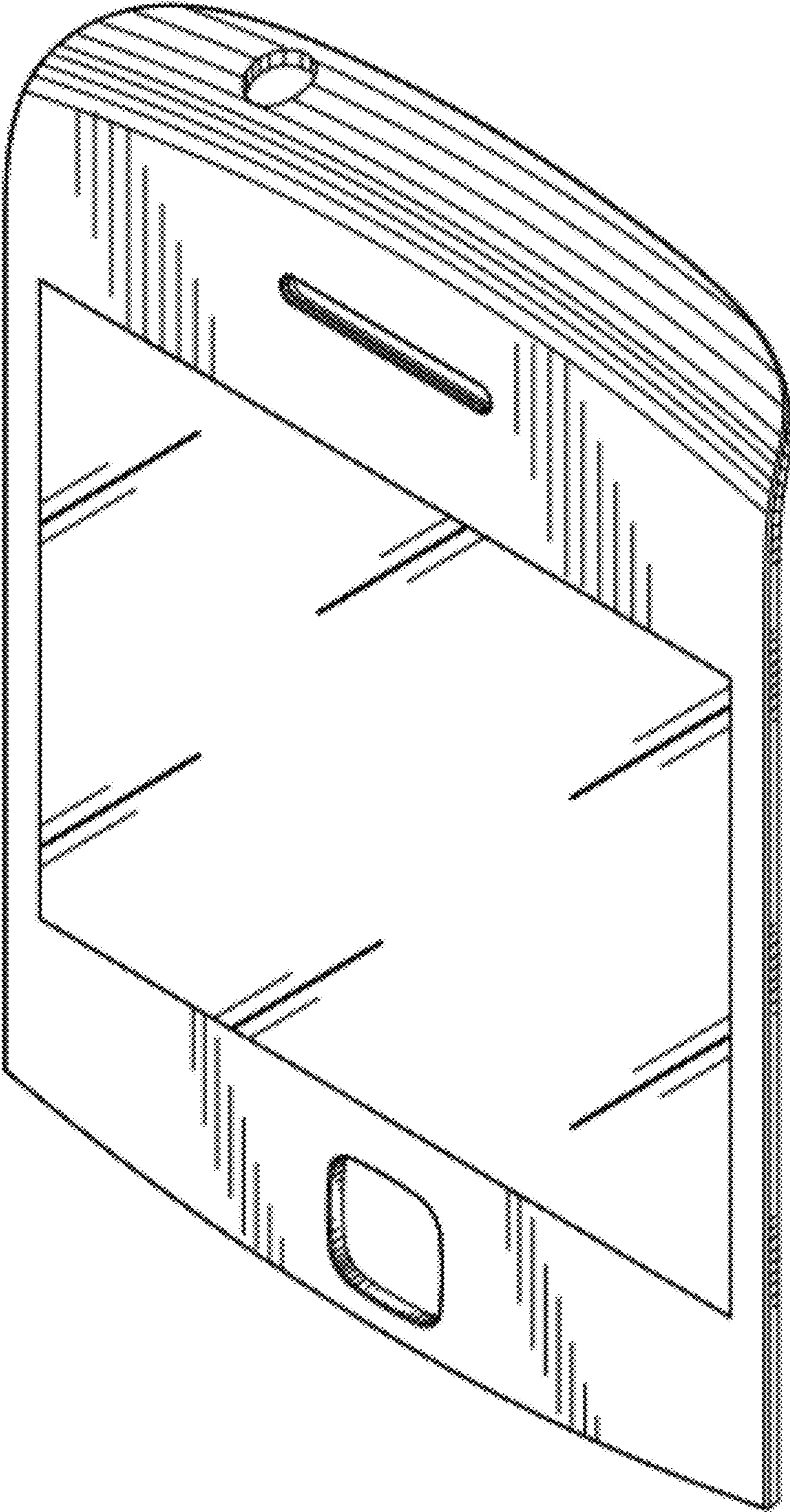

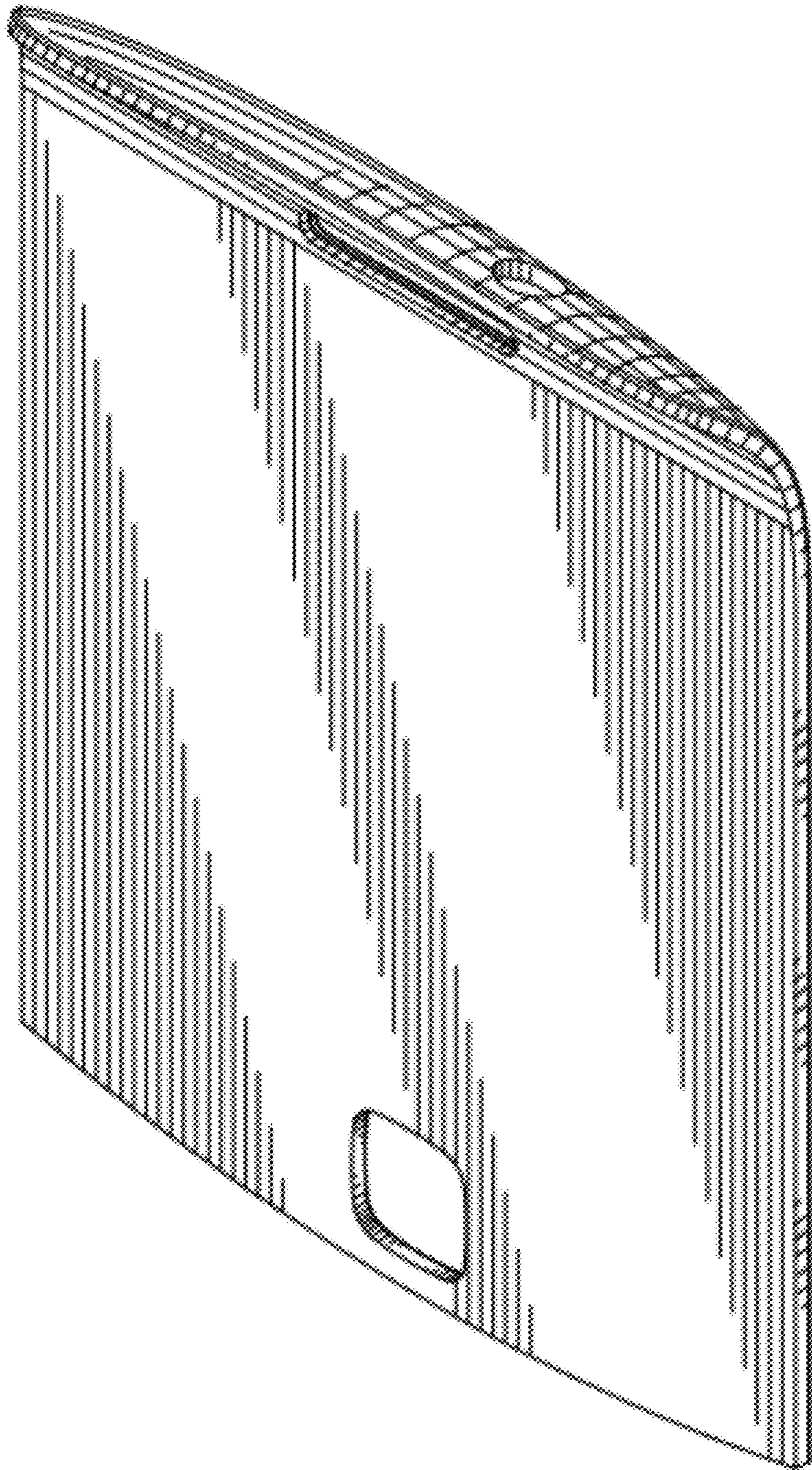

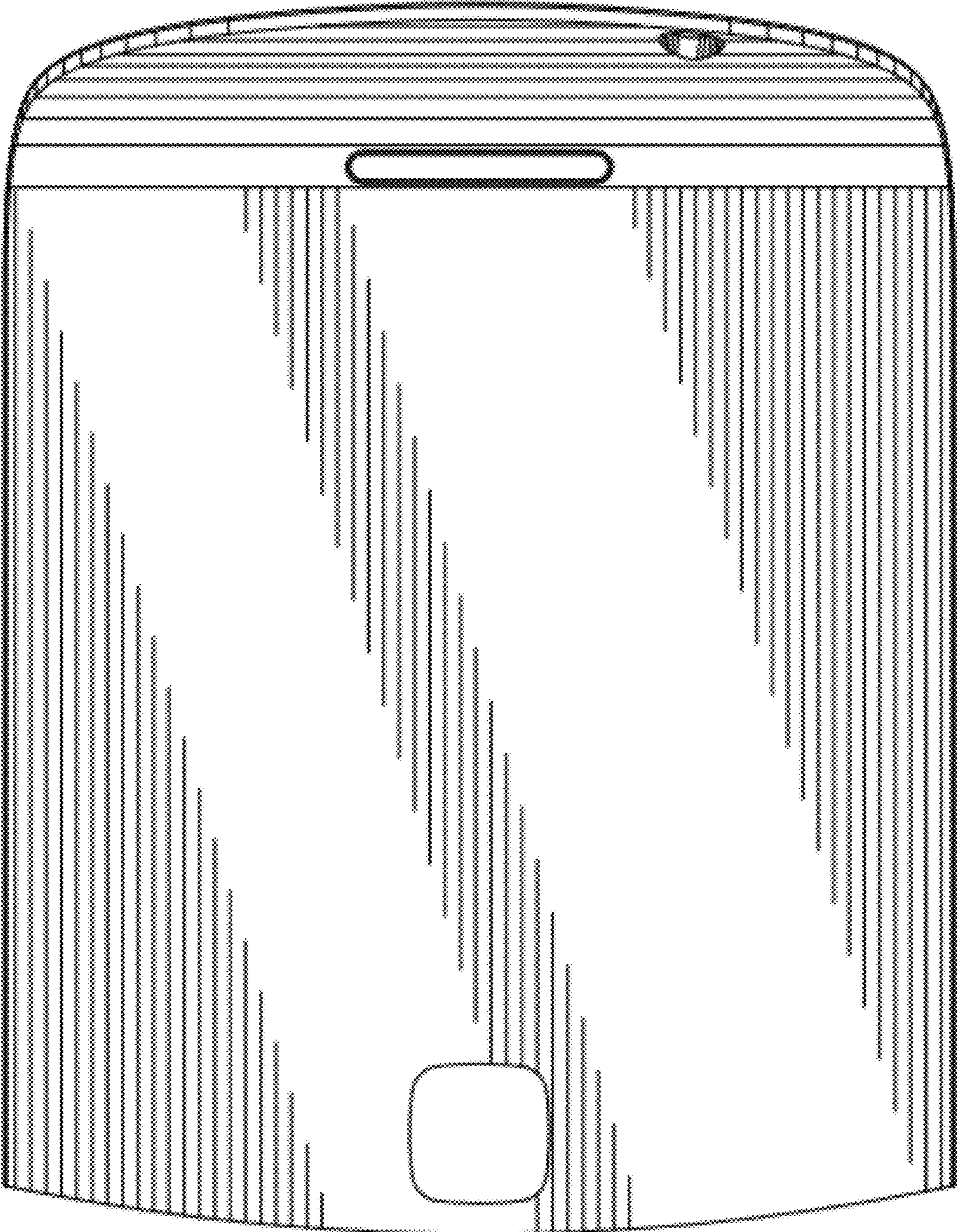

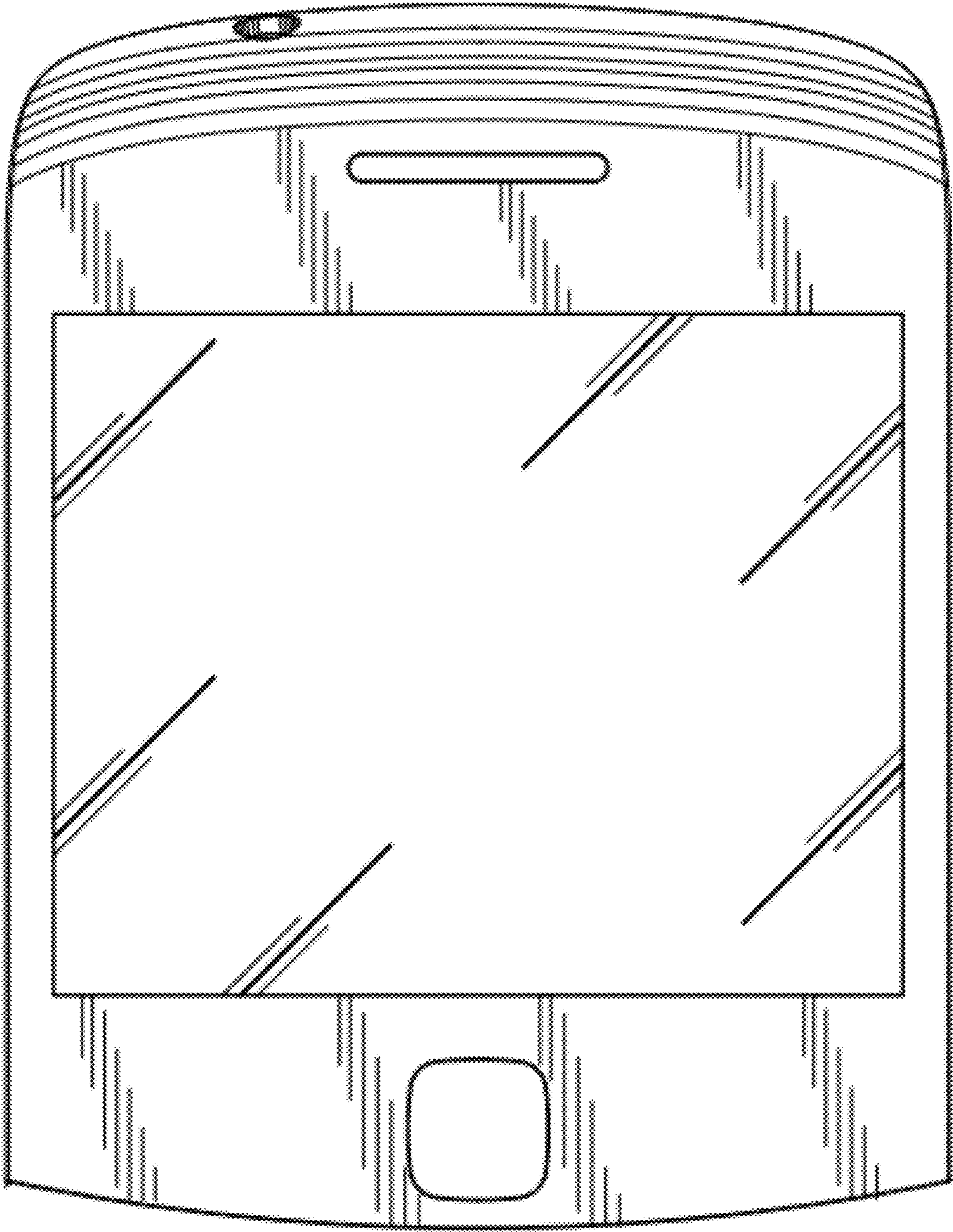

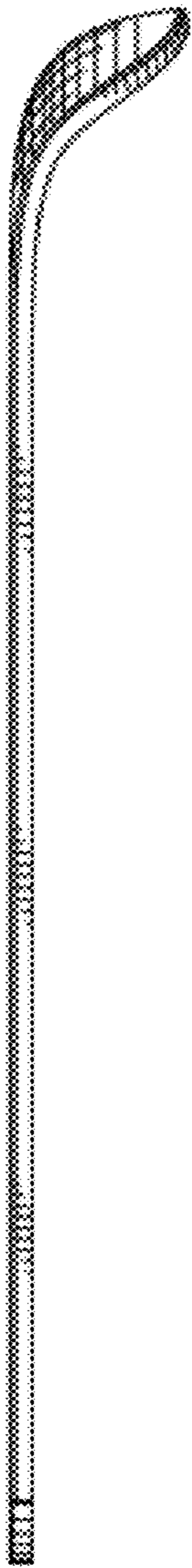

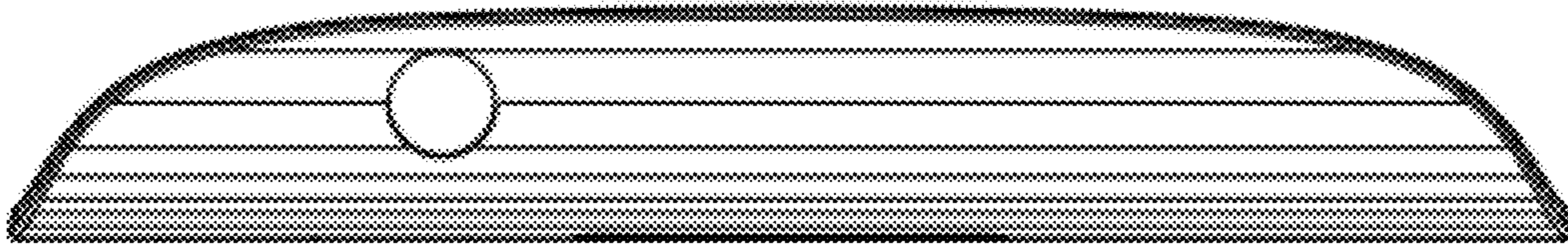

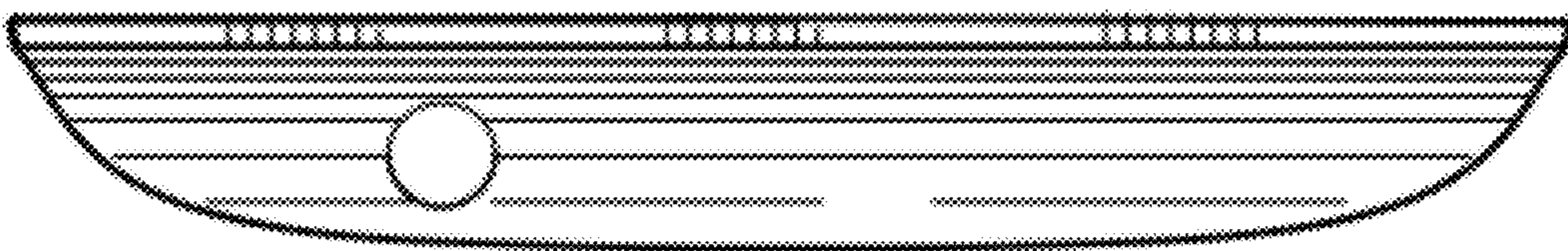
