(57) **CLAIM**

The ornamental design for an intake manifold having intake ports with consolidated shape, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of an intake manifold having intake ports with consolidated shape in accordance with our design;

FIG. 2 is a front elevational view of the design shown in FIG. 1;

FIG. 3 is a rear elevational view of the design shown in FIG. 1;

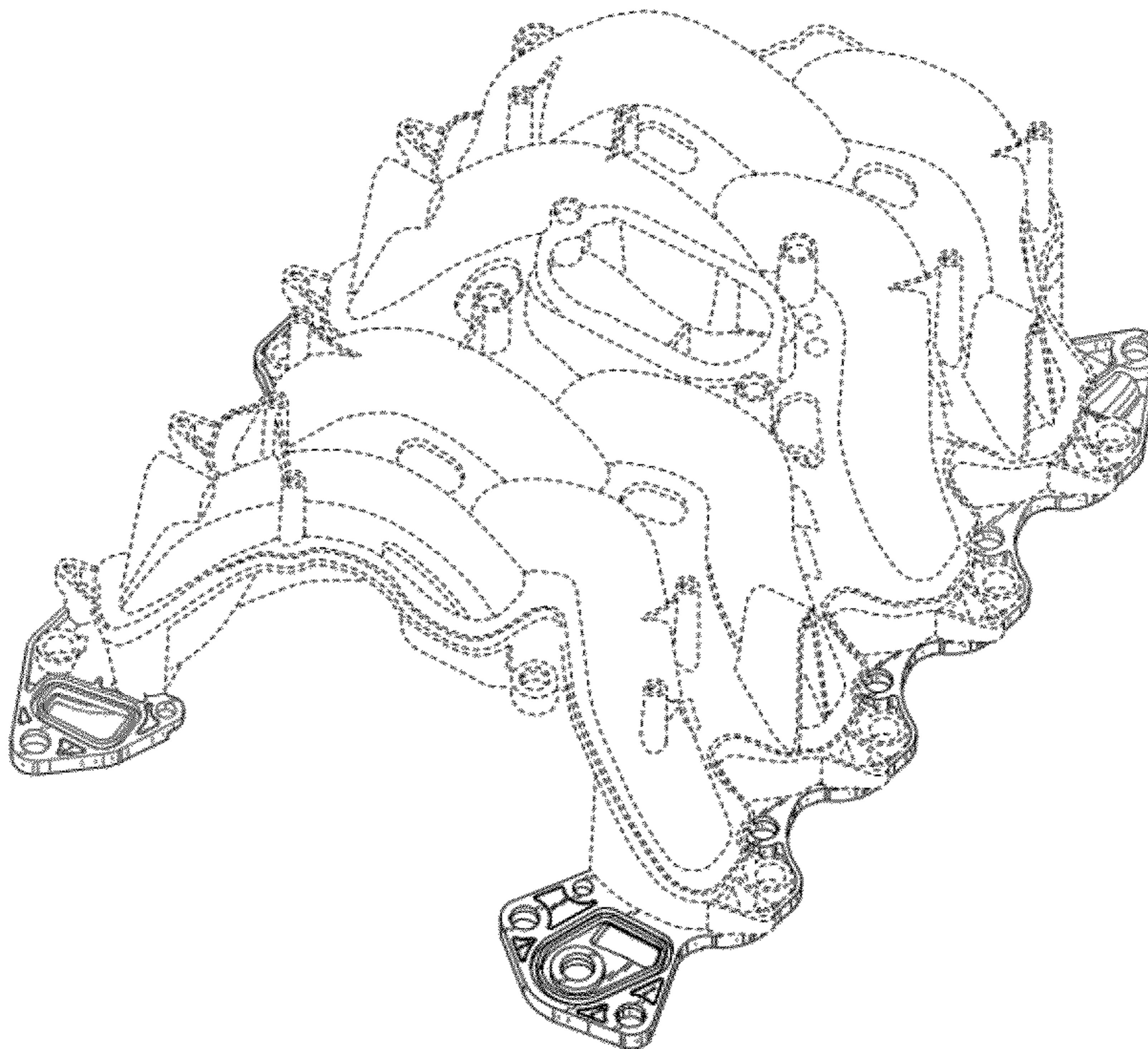
FIG. 4 is a left side elevational view of the design shown in FIG. 1;

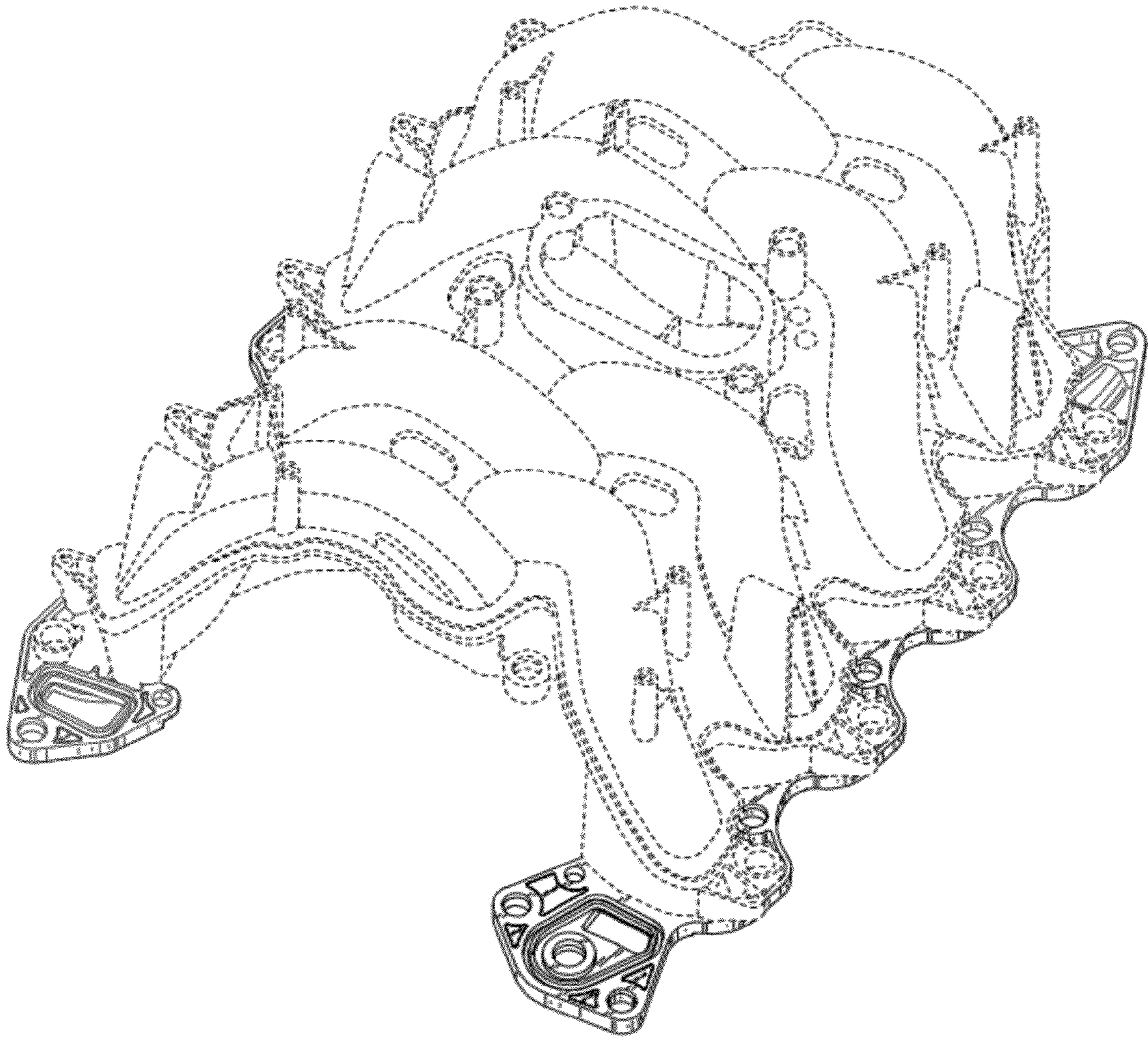

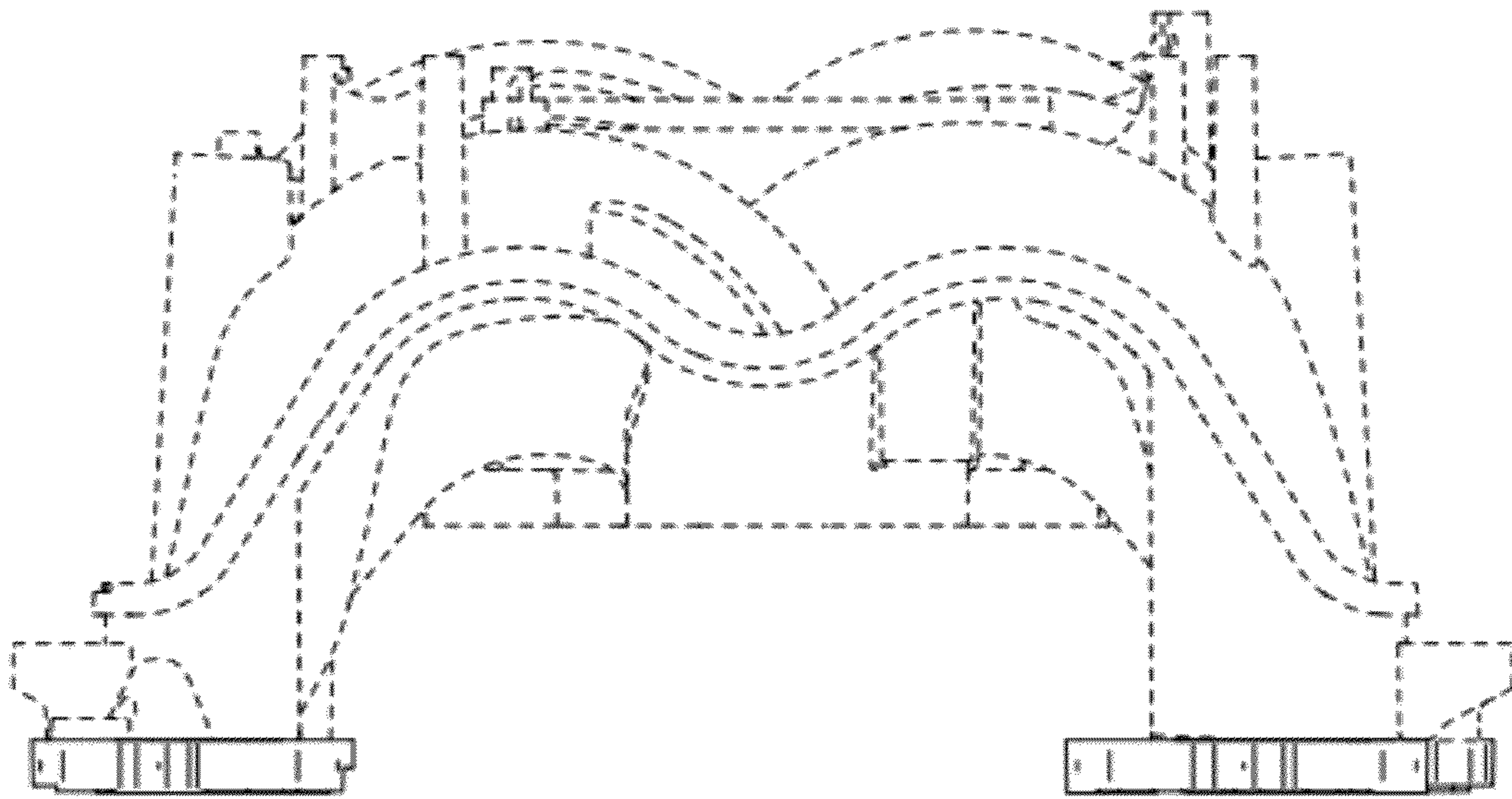

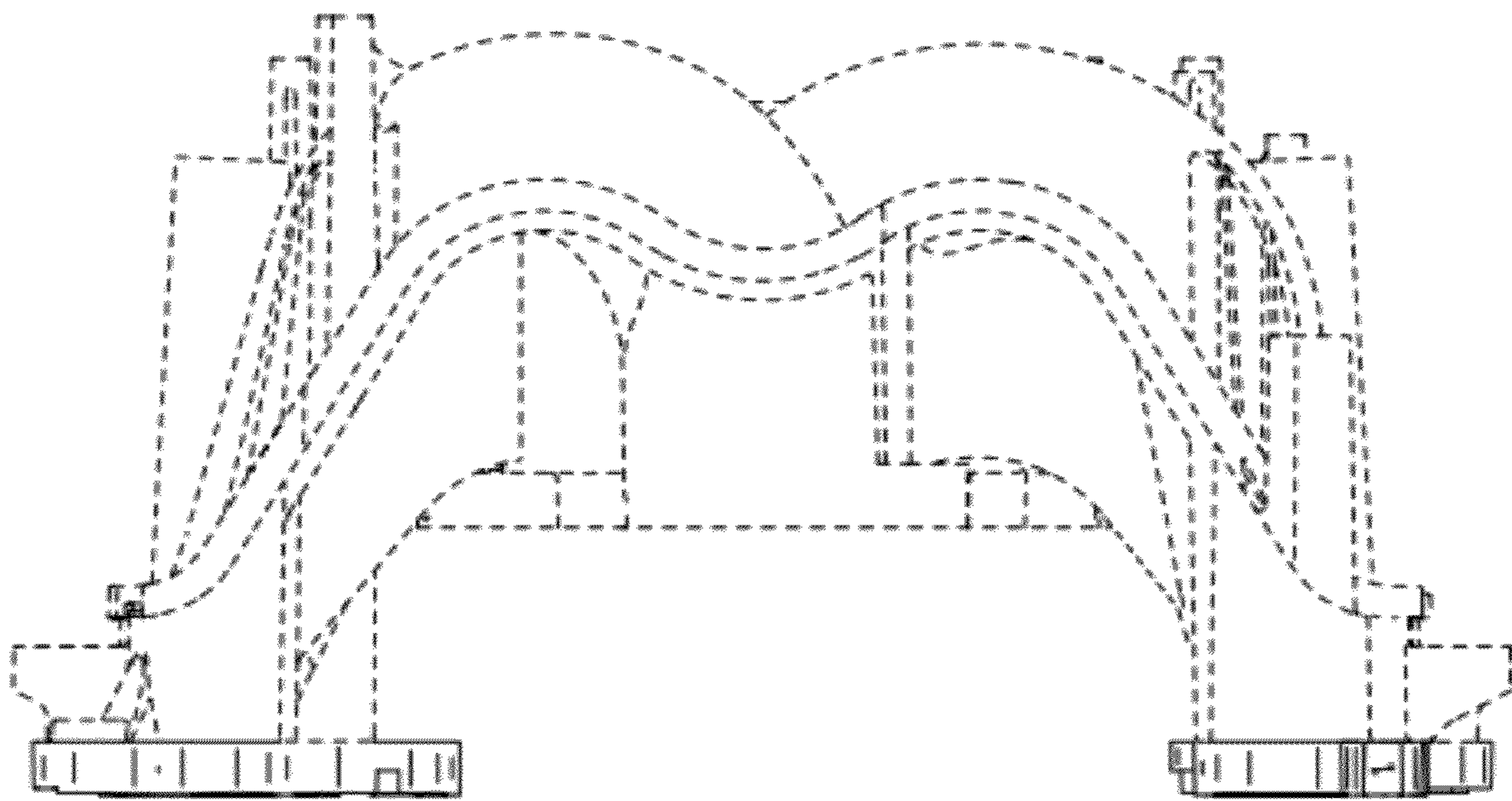

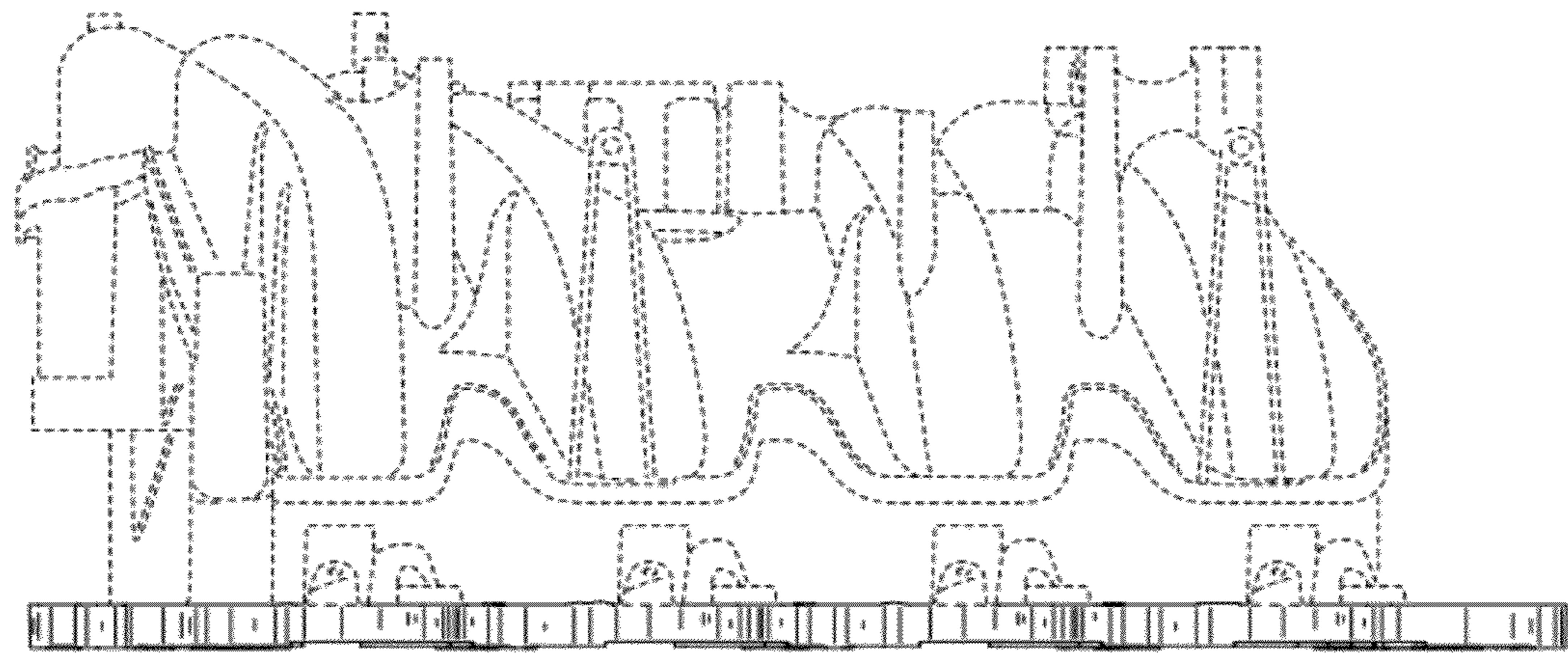

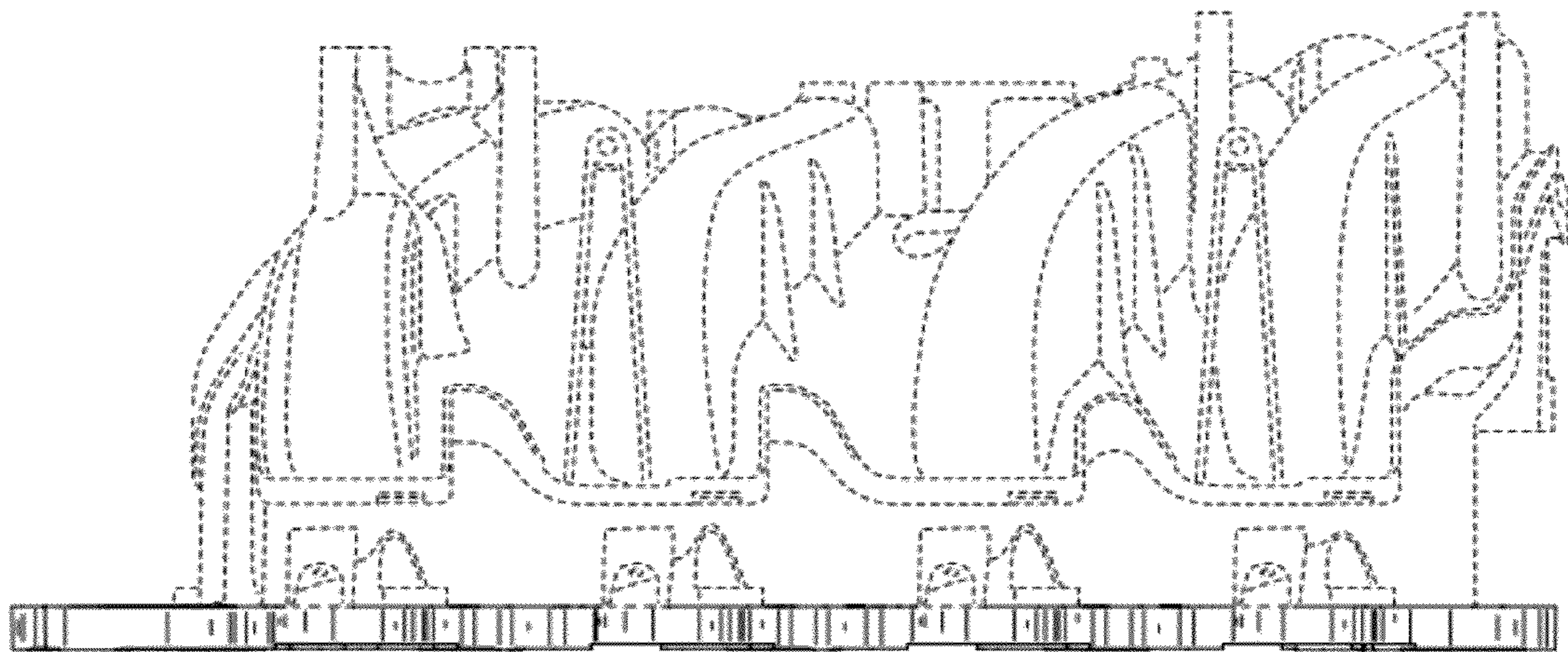

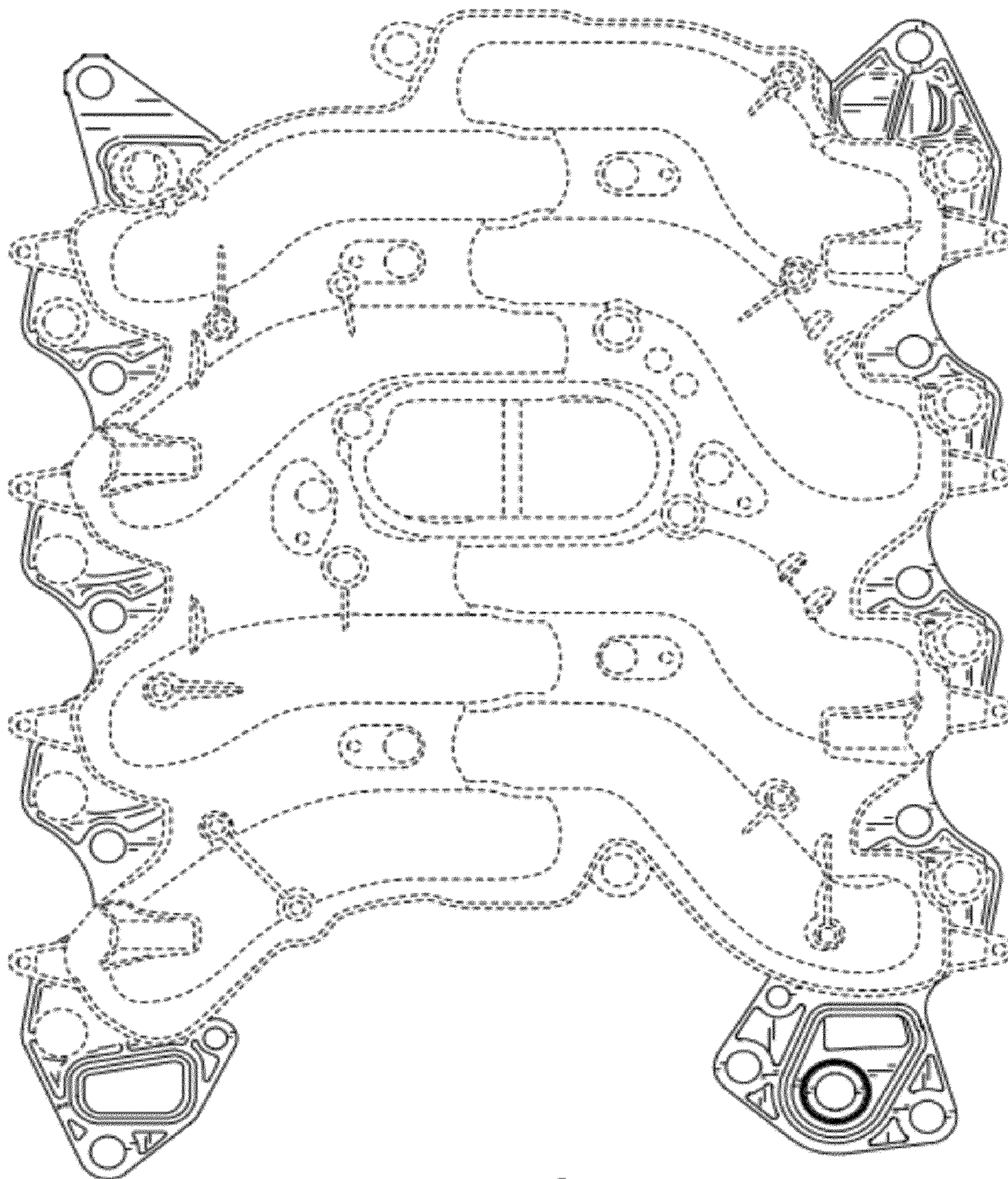

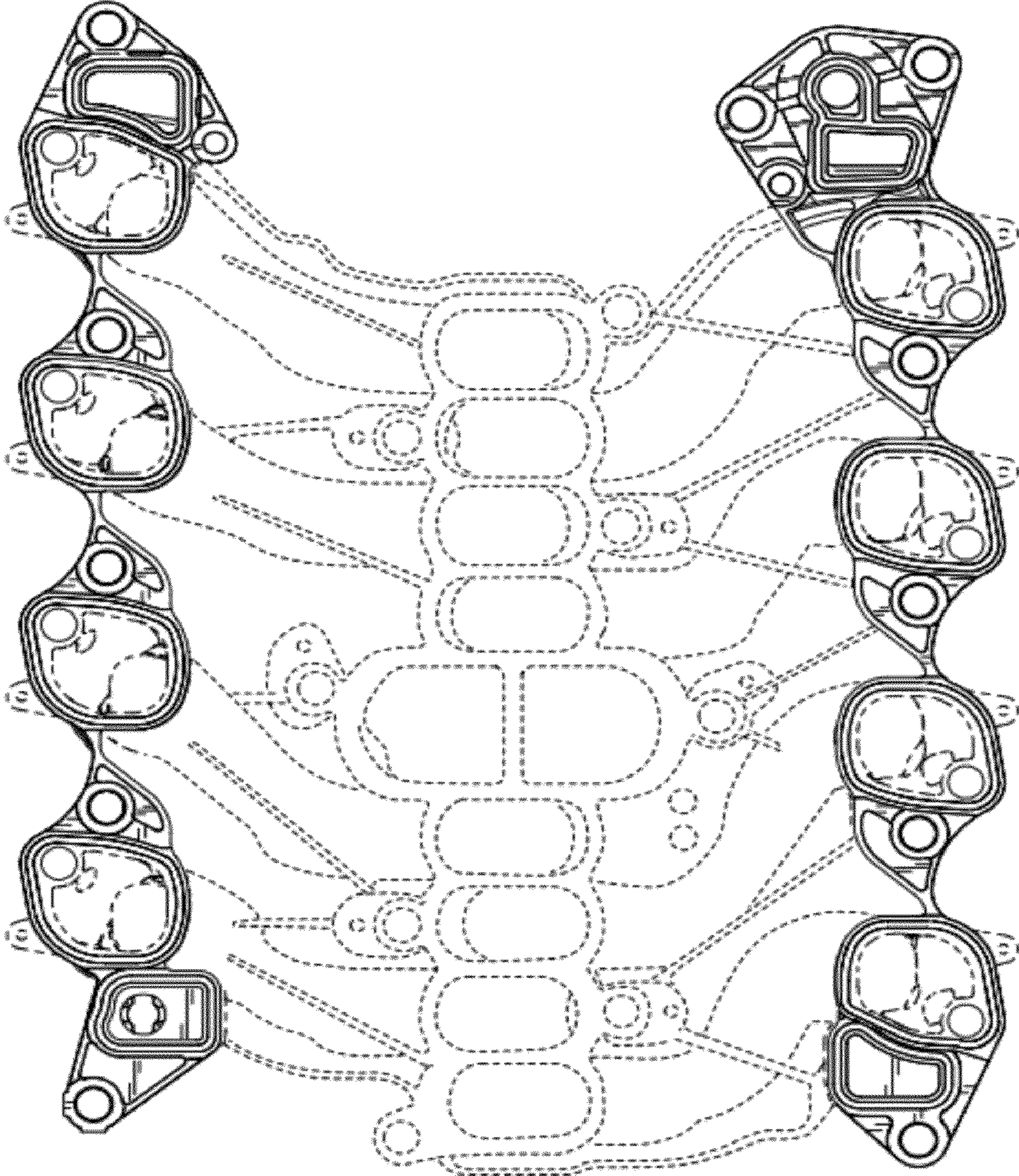
