(57) **CLAIM**

The ornamental design for a body surfing board, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and side perspective of a body surfing board embodying my new design.

FIG. 2 is a top, back, and side perspective thereof.

FIG. 3 is a top view thereof.

FIG. 4 is a bottom view thereof.

FIG. 5 is a side view thereof, the opposite side being a mirror image.

FIG. 6 is a front plan view thereof; and,

FIG. 7 is a back plan view thereof.

Broken lines are used to illustrate features of the body surfing board which form no part of the claimed design.

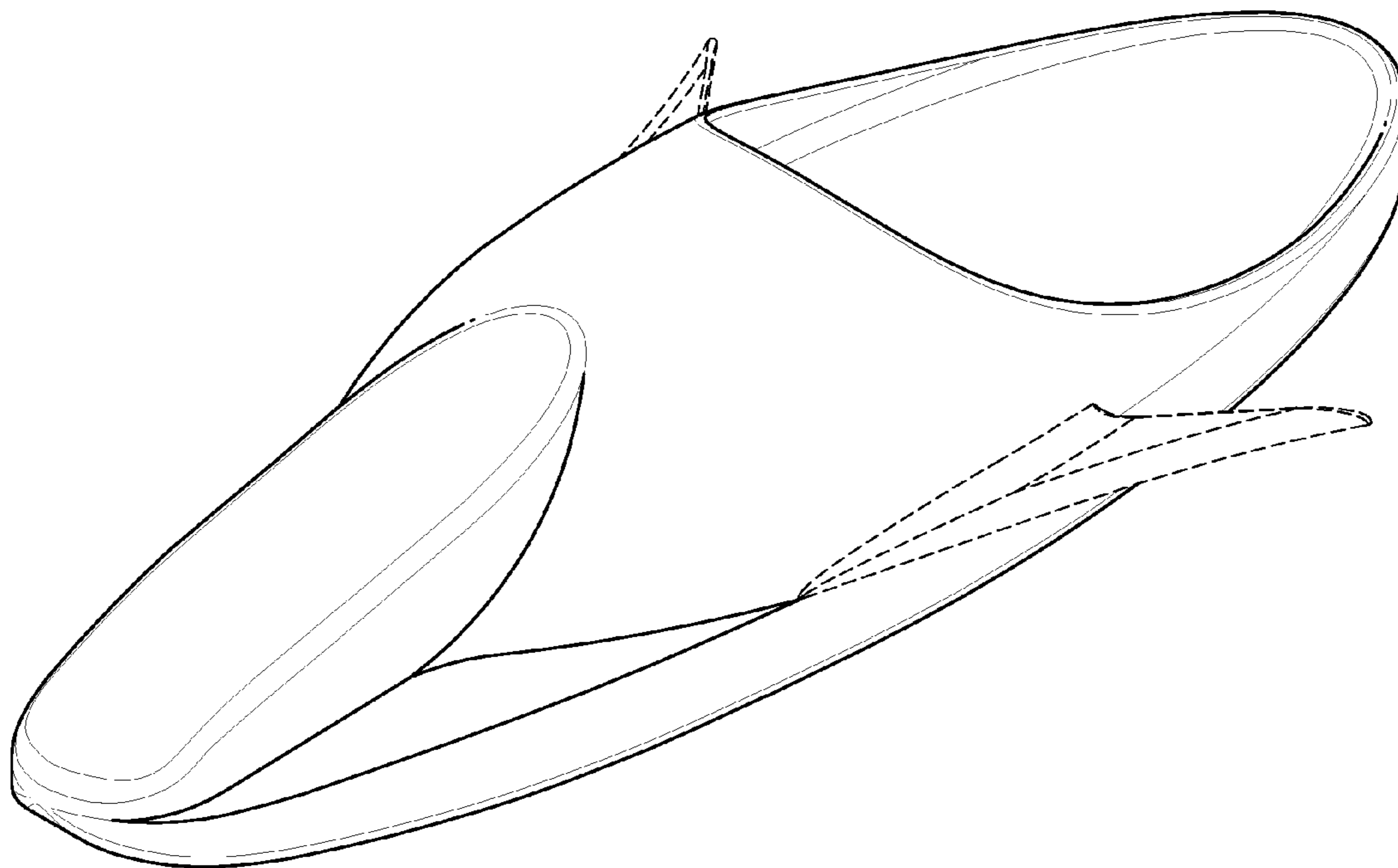

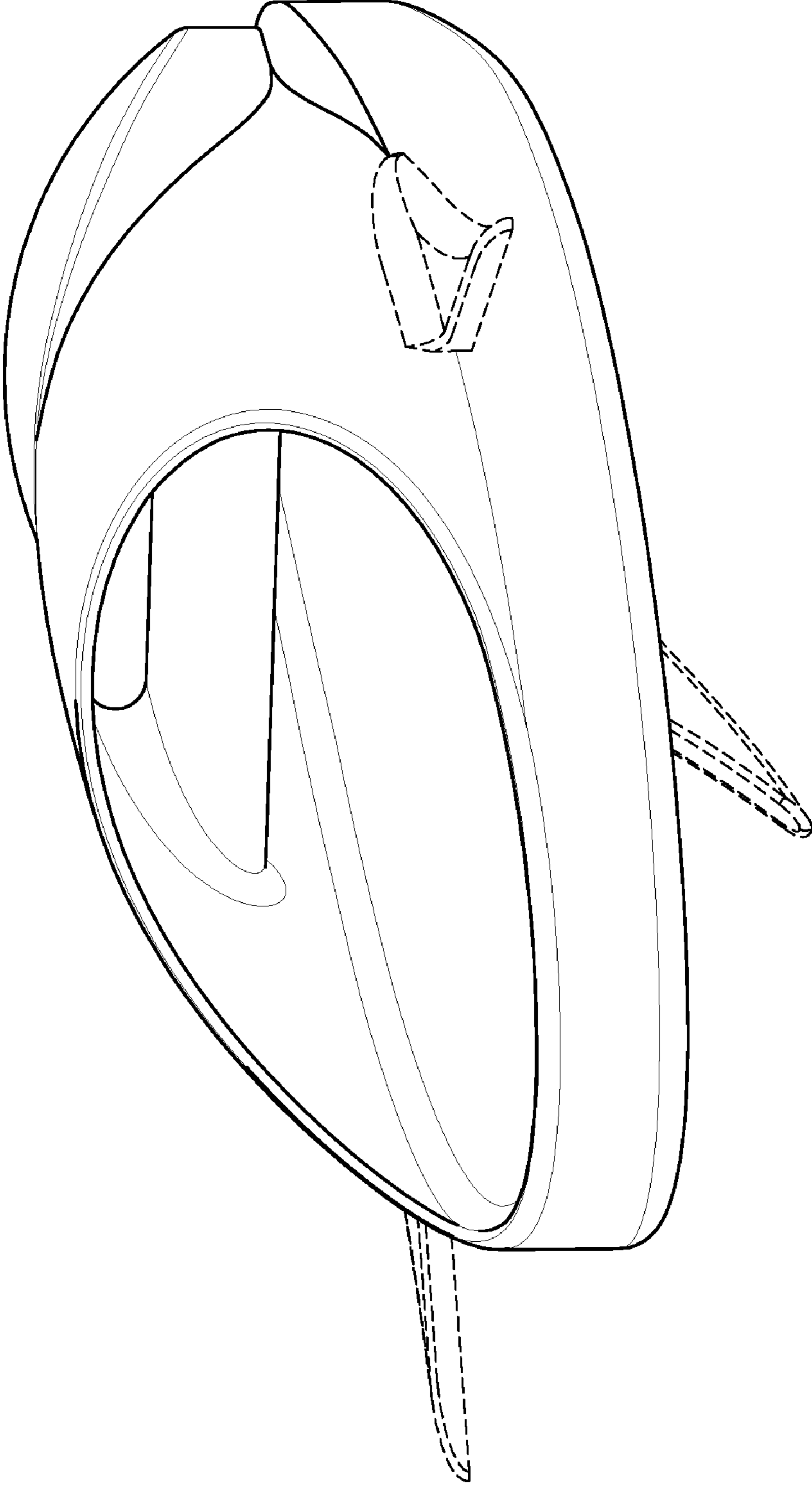

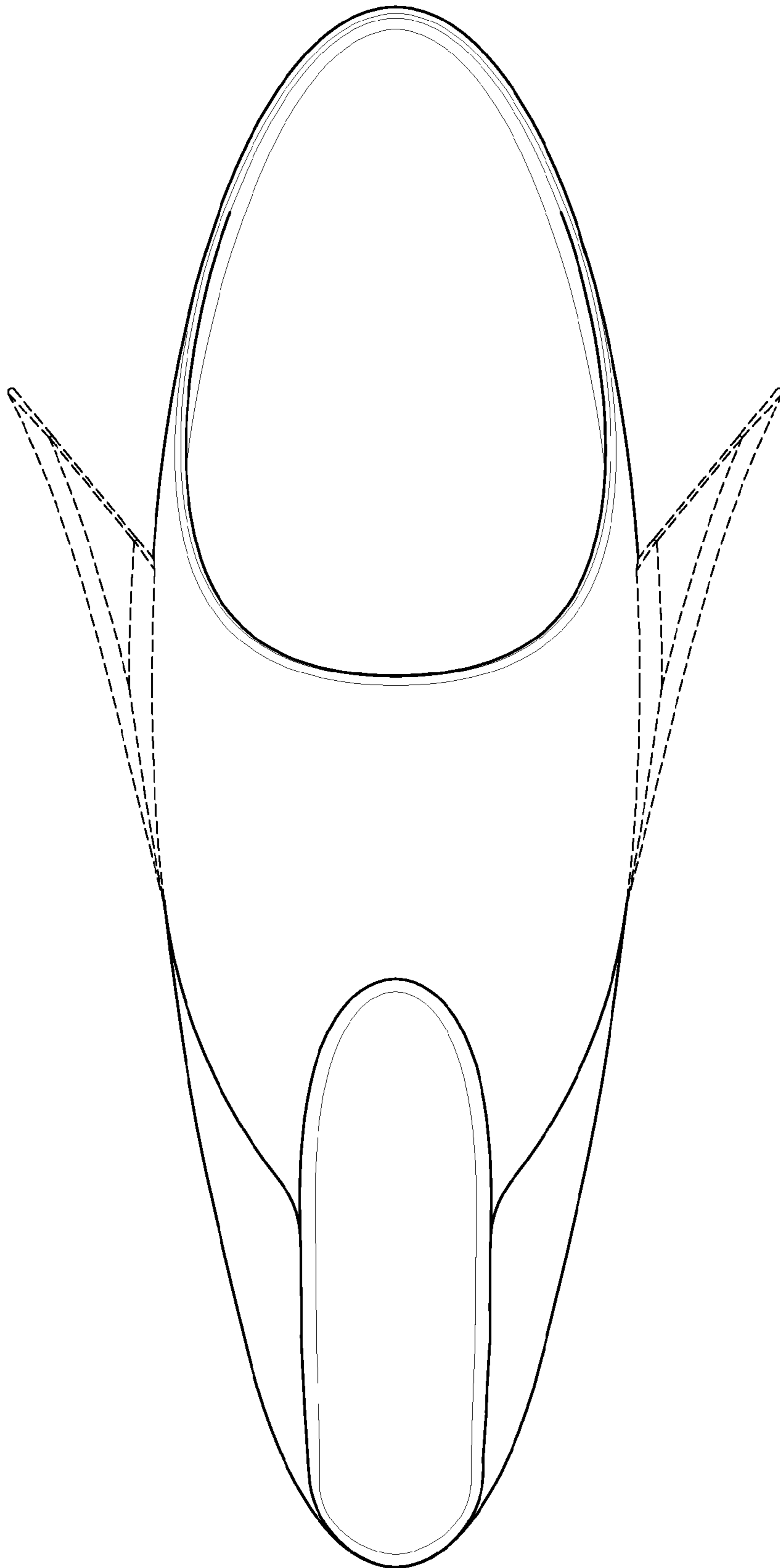

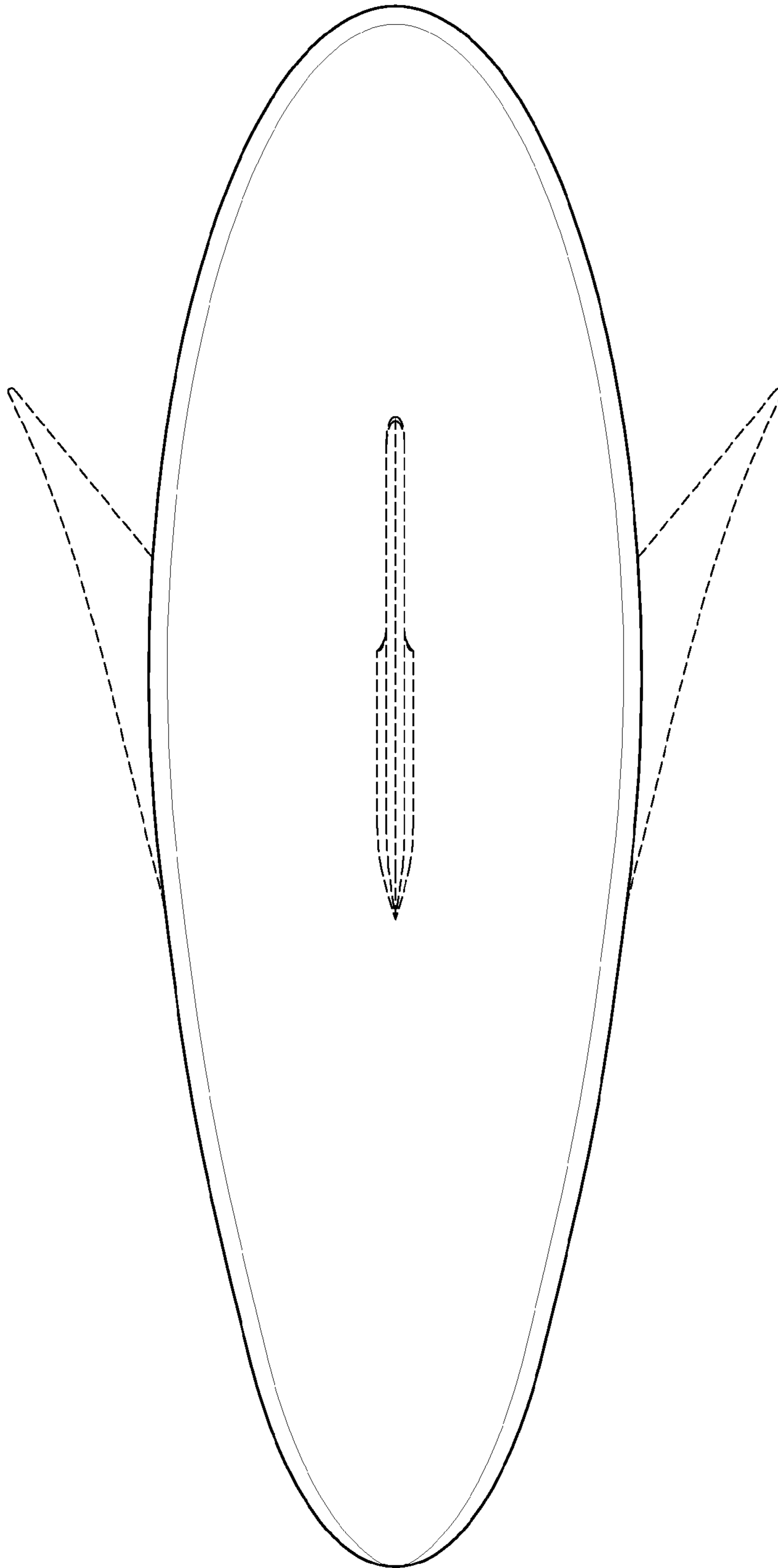

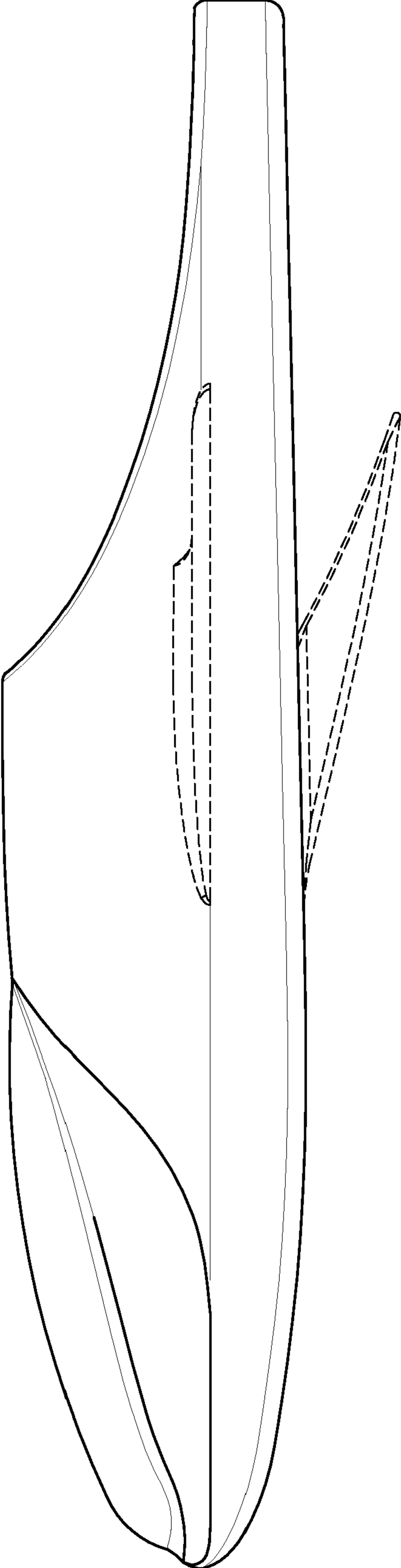

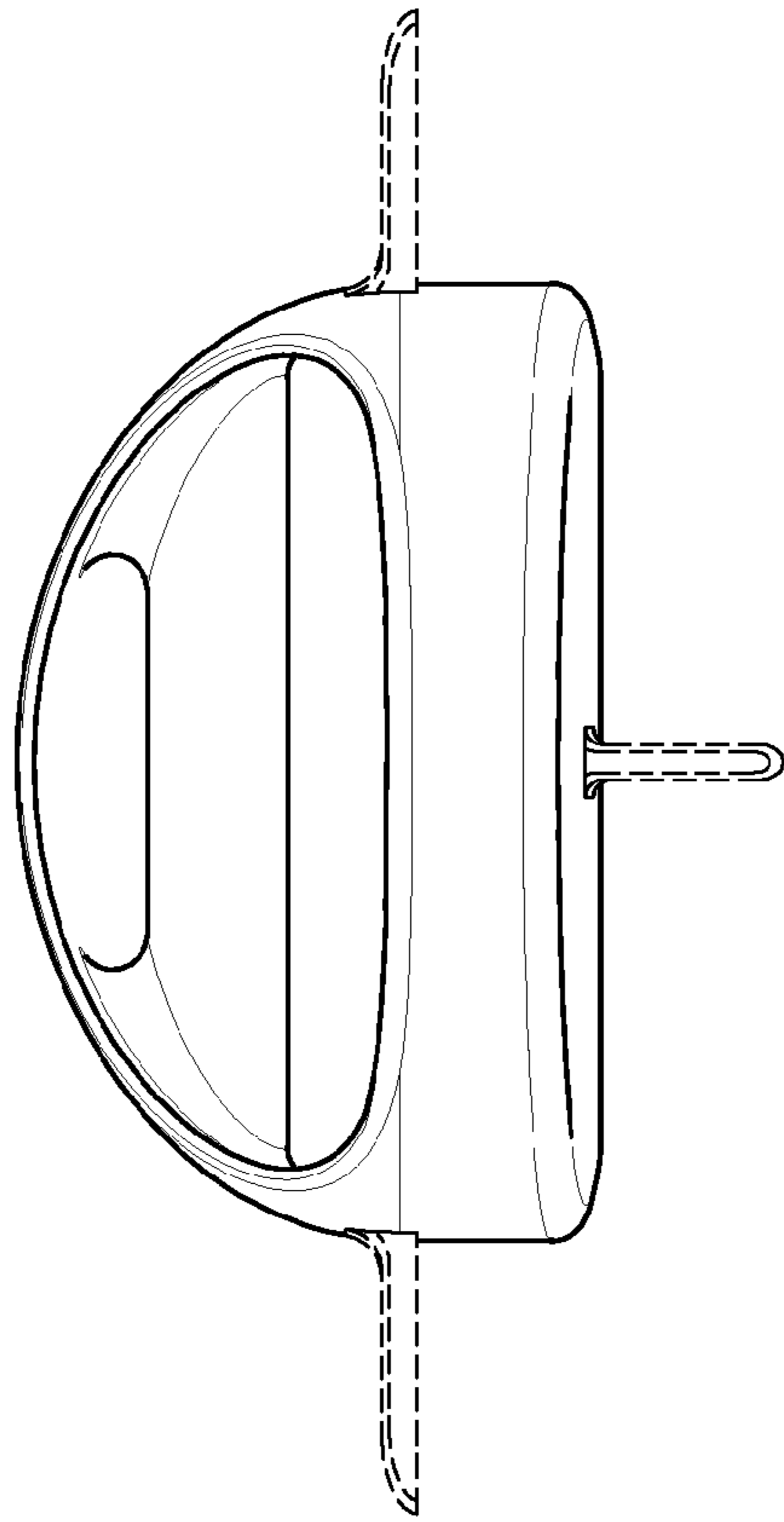

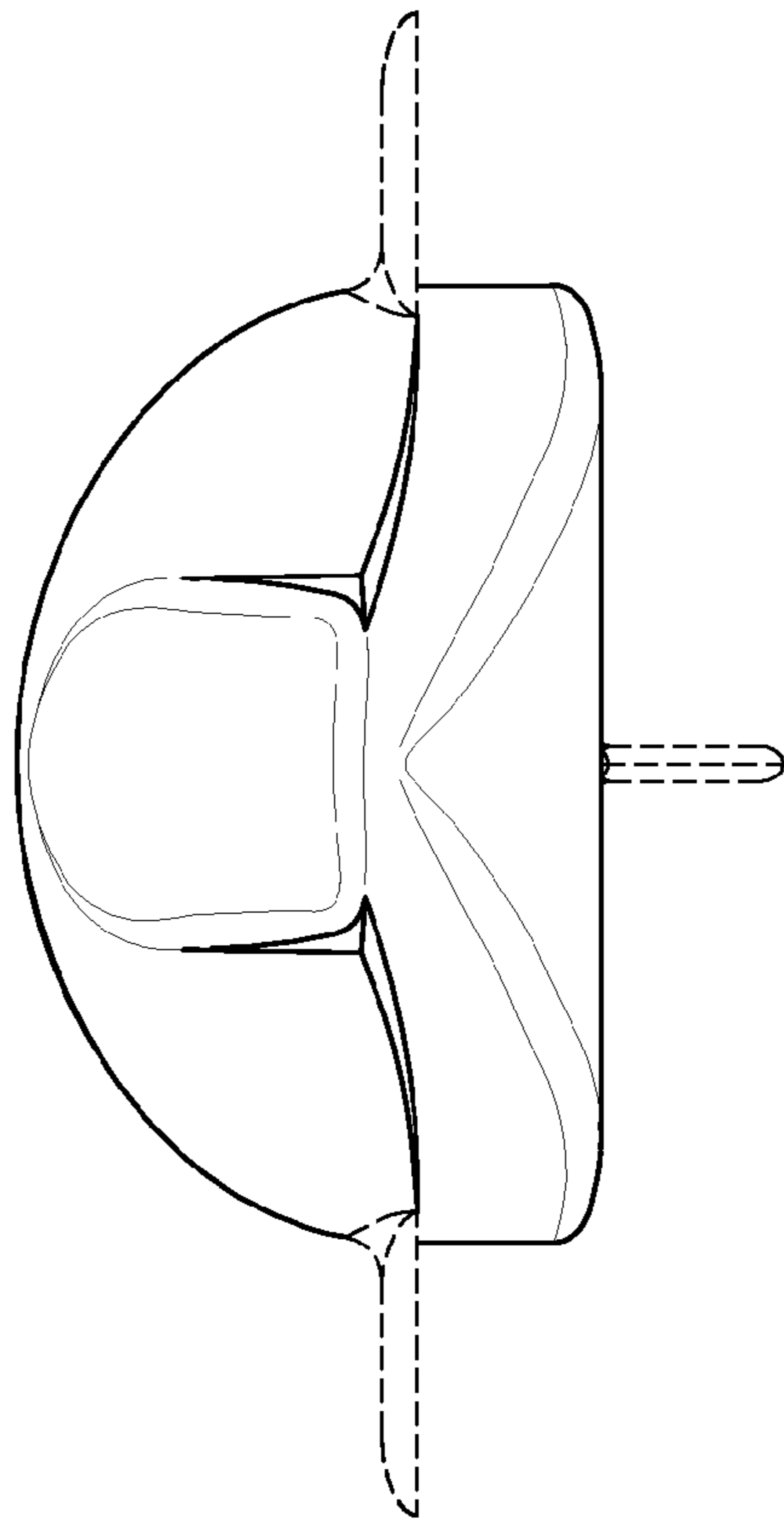
