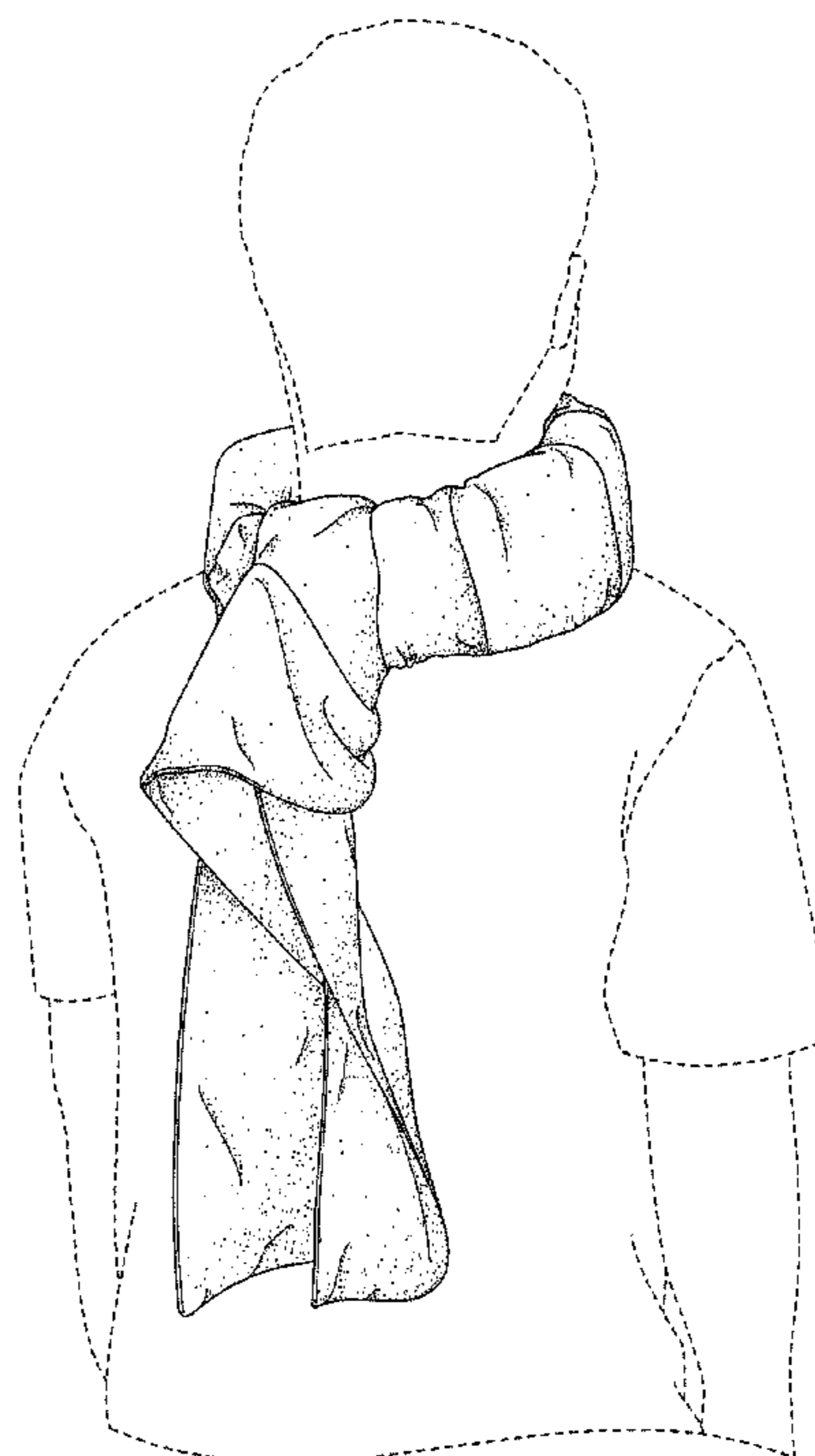
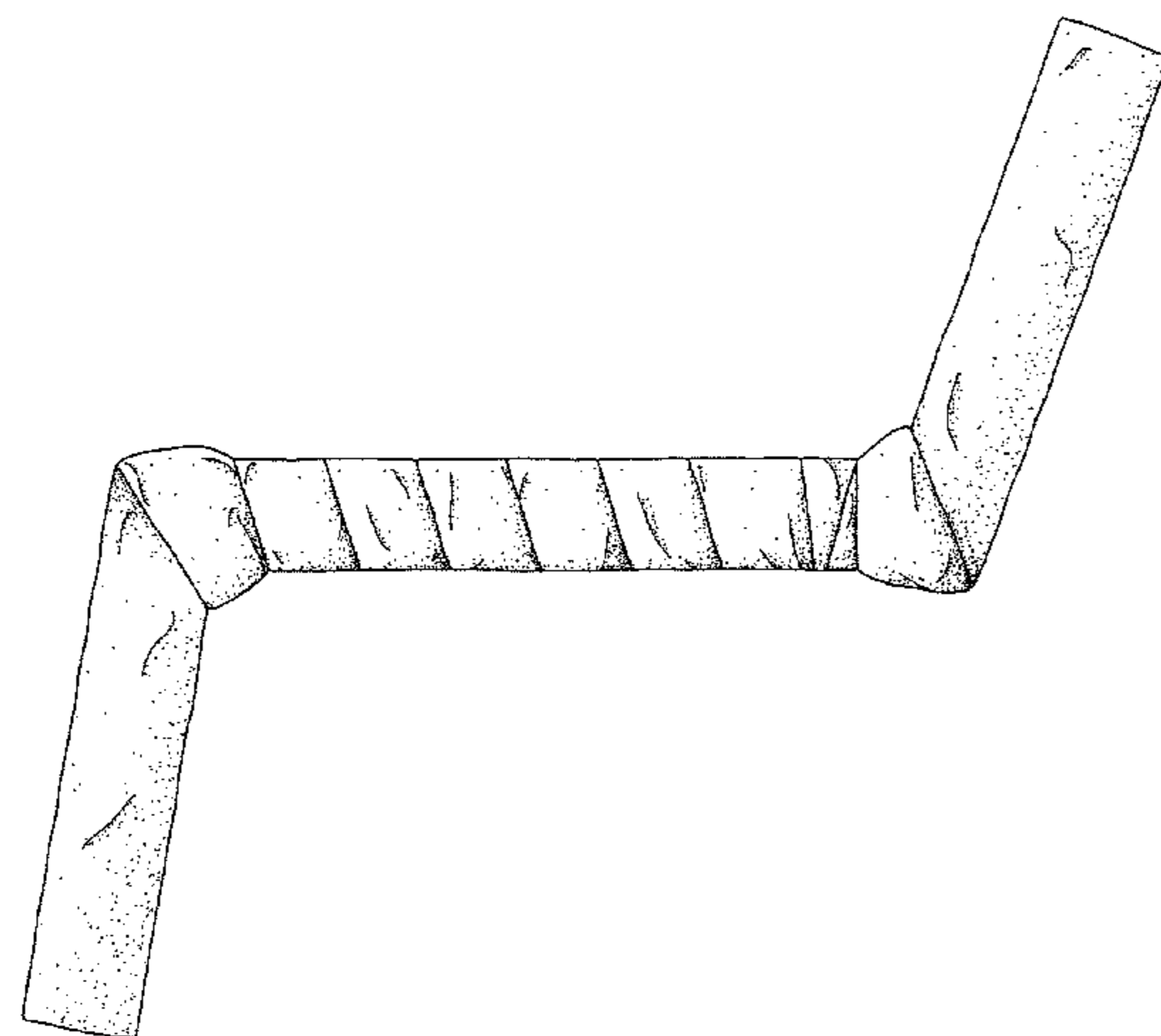
(57) **CLAIM**

The ornamental design for a cervical collar cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a cervical collar cover. FIG. 2 is a front elevational view of the cervical collar cover. FIG. 3 is a rear elevational view of the cervical collar cover. FIG. 4 is a left side elevational view of the cervical collar cover. FIG. 5 is a right side elevational view of the cervical collar cover. FIG. 6 is a top plan view of the cervical collar cover. FIG. 7 is a bottom plan view of the cervical collar cover; and, FIG. 8 is a front perspective view of the cervical collar cover as it would appear with a cervical collar inserted therein and being worn. The broken lines illustrate environmental structure and form no part of the claimed design.

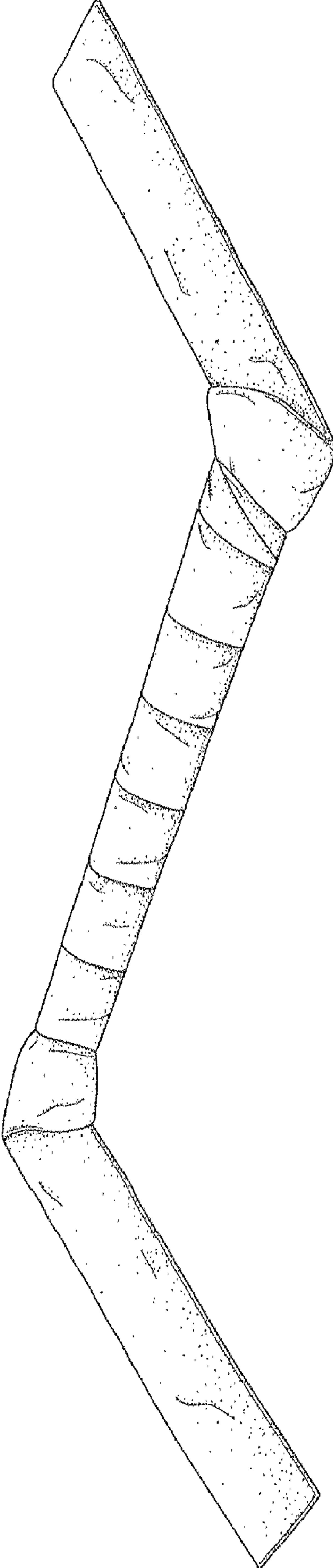

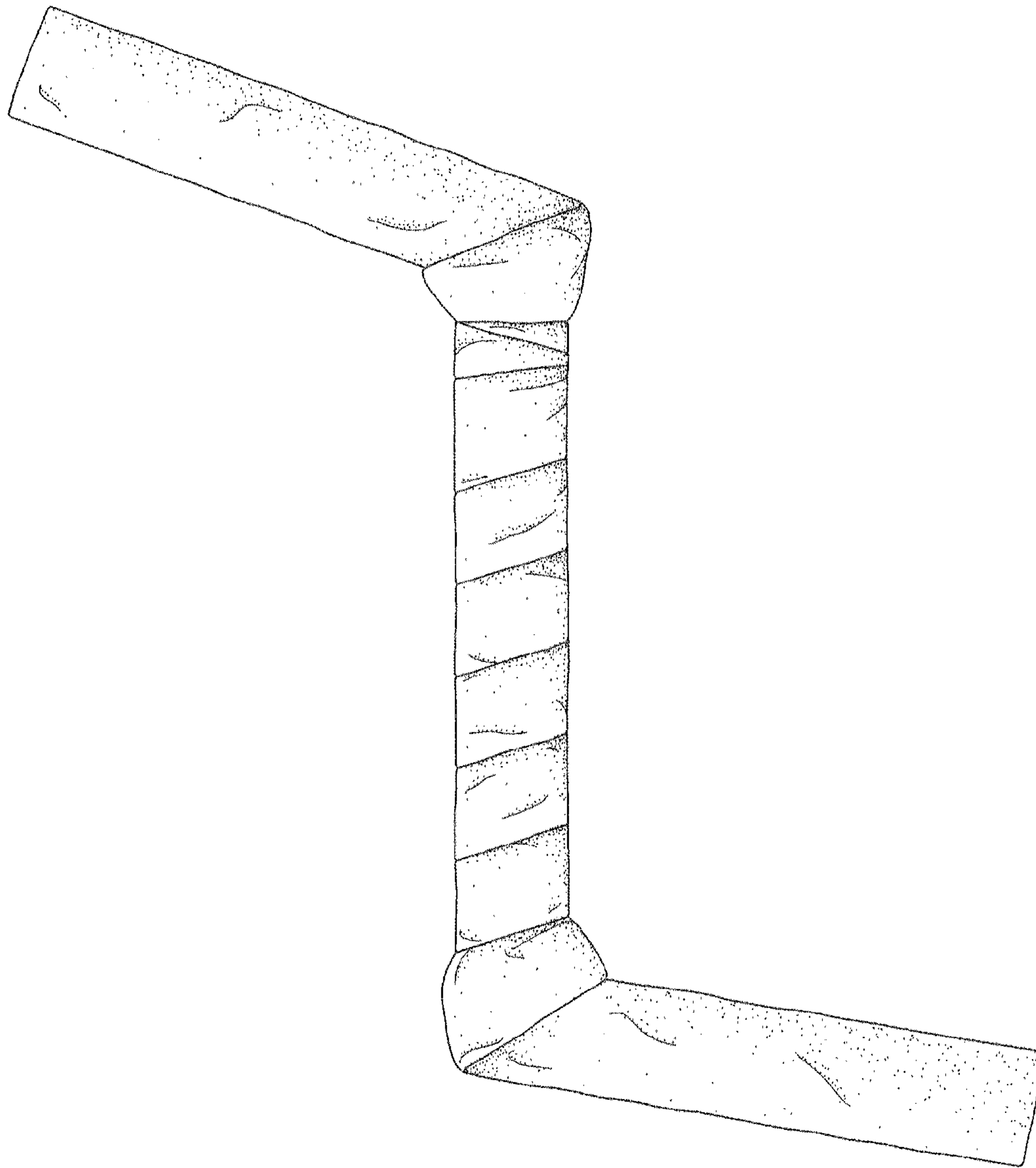

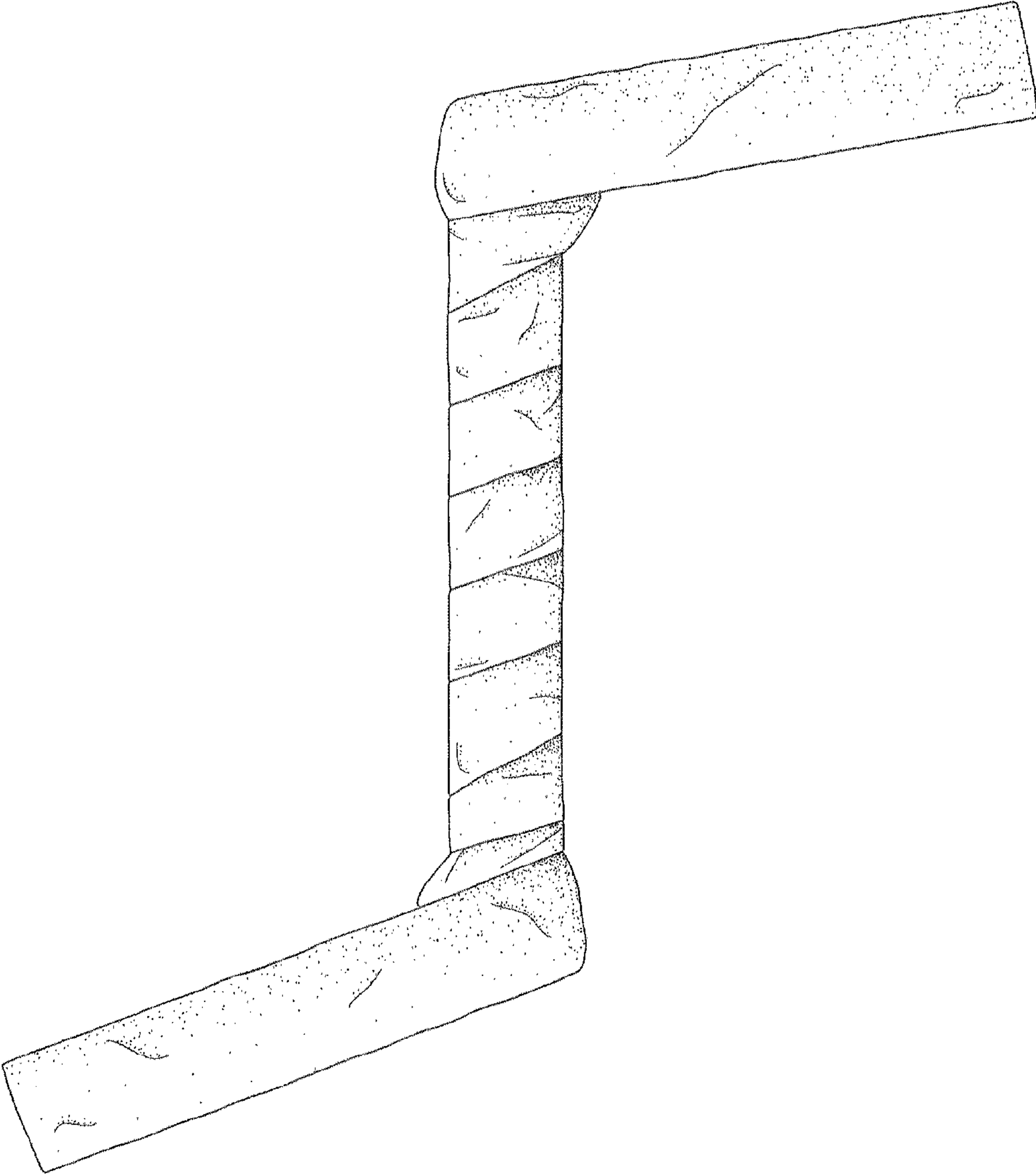

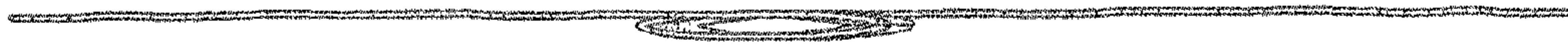

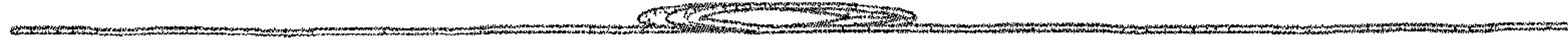

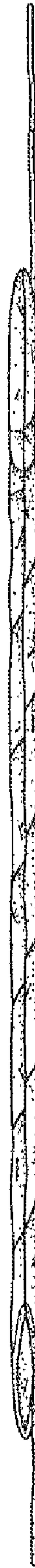

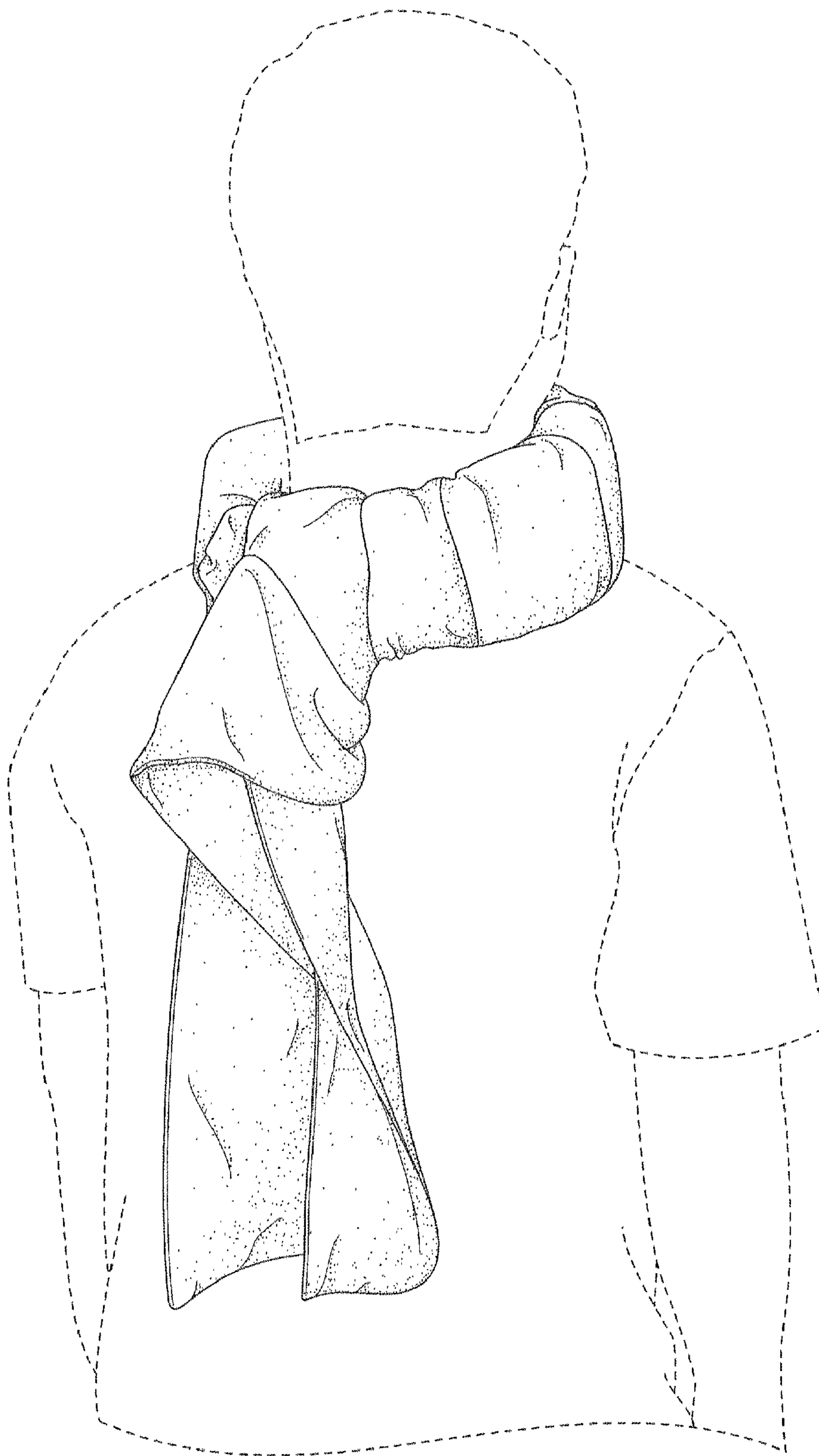
