FIG. 1 is a perspective view of a confection showing my new design;

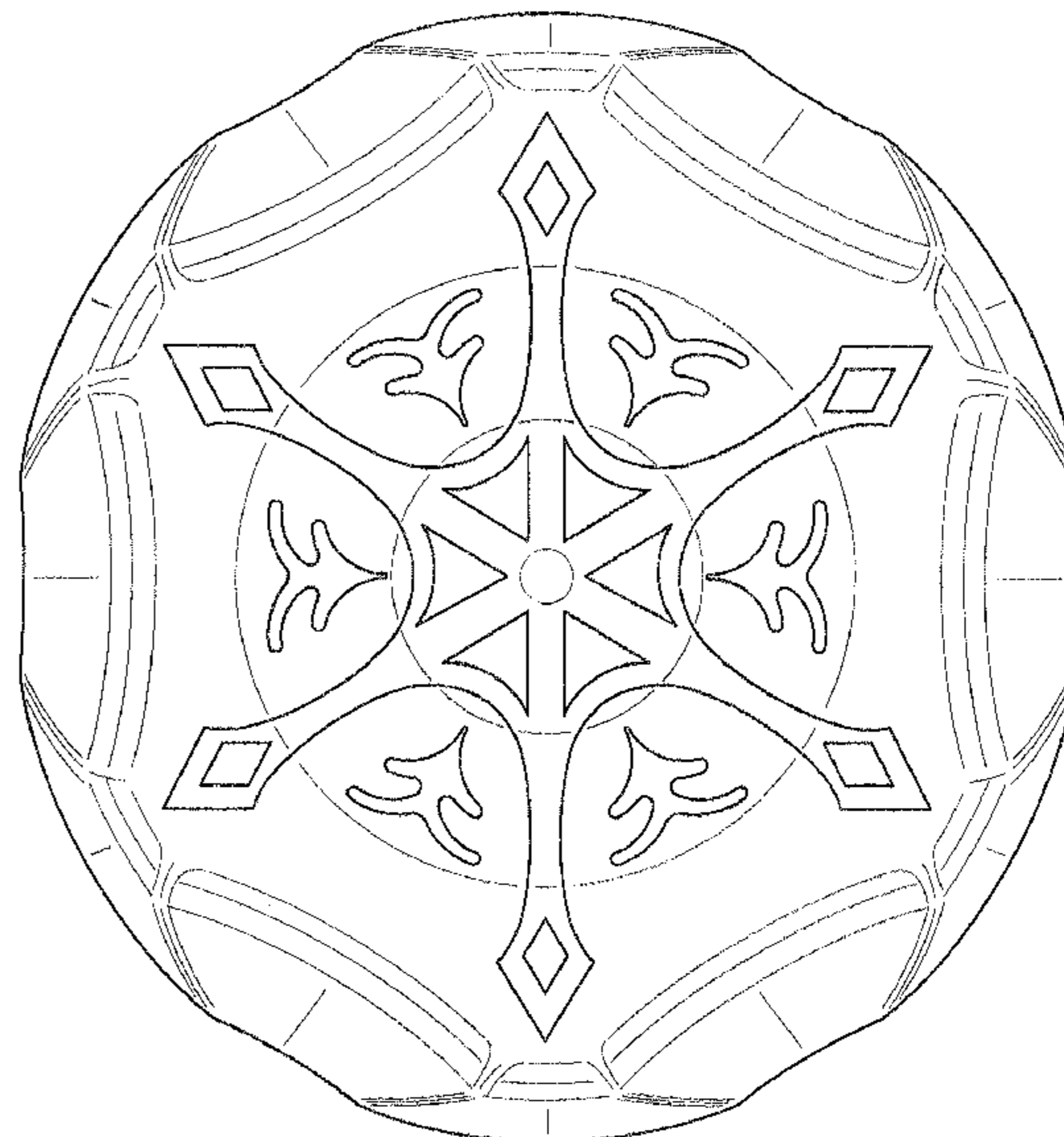
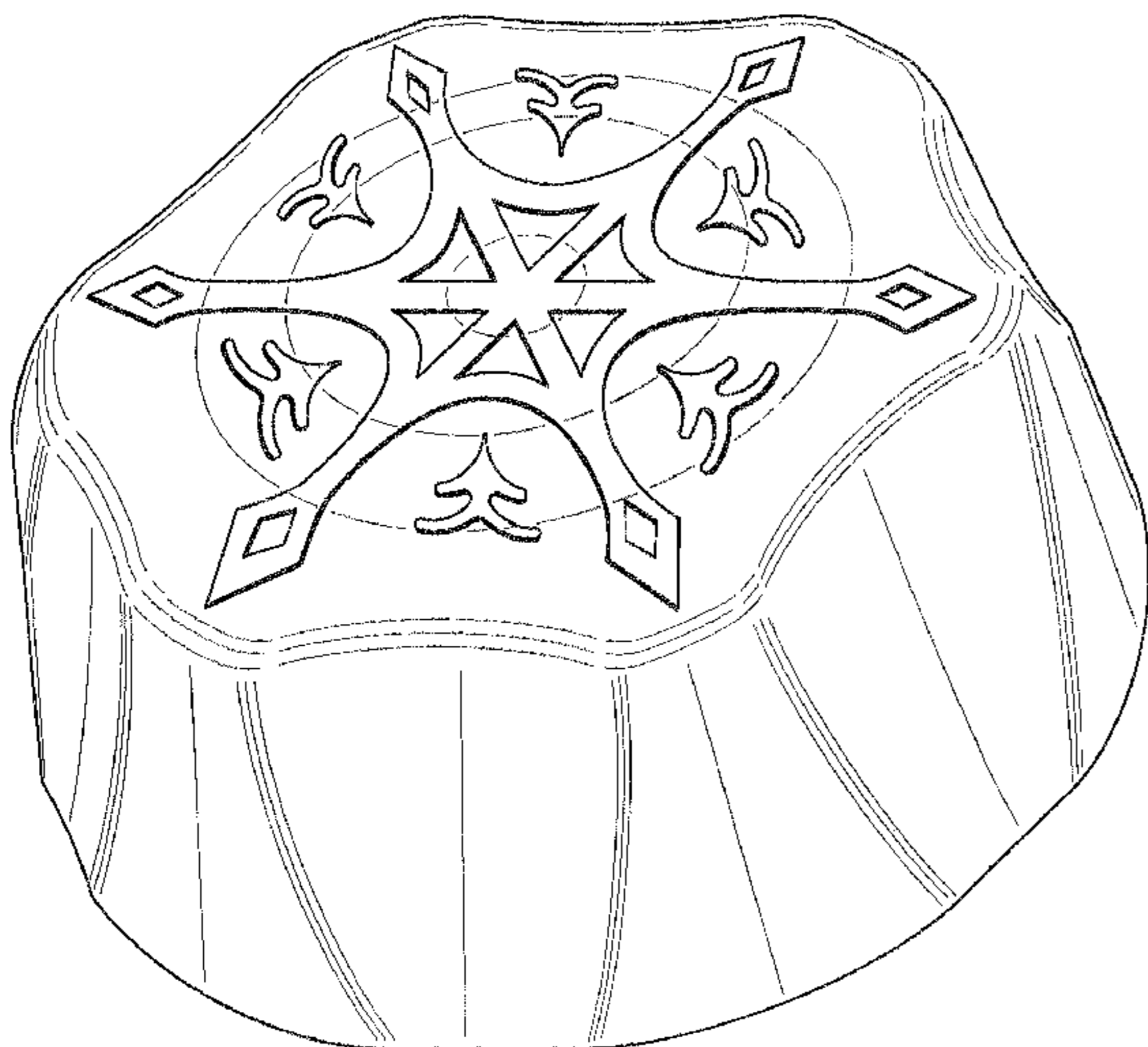
FIG. 2 is a top view of the design shown in FIG. 1;

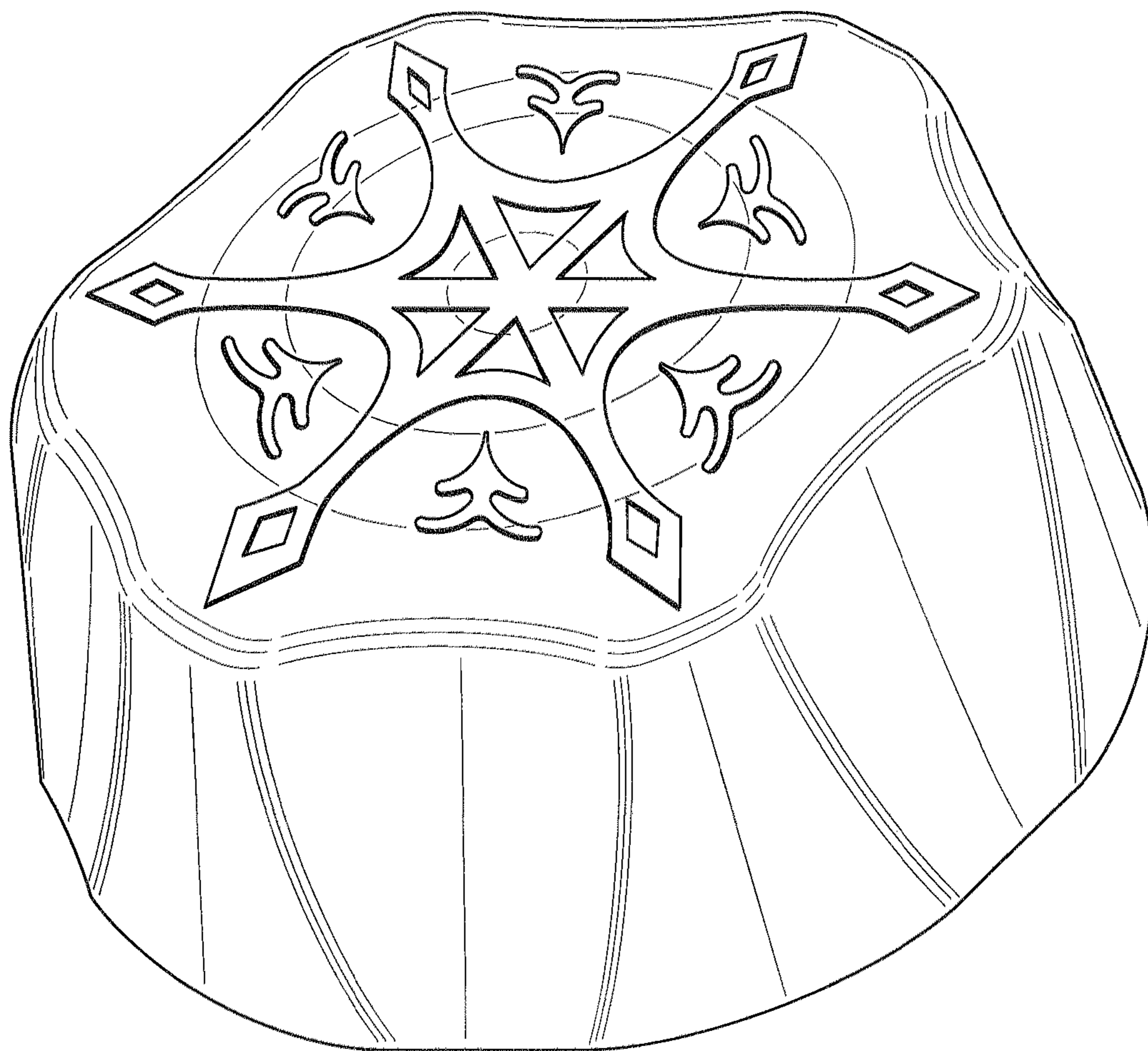

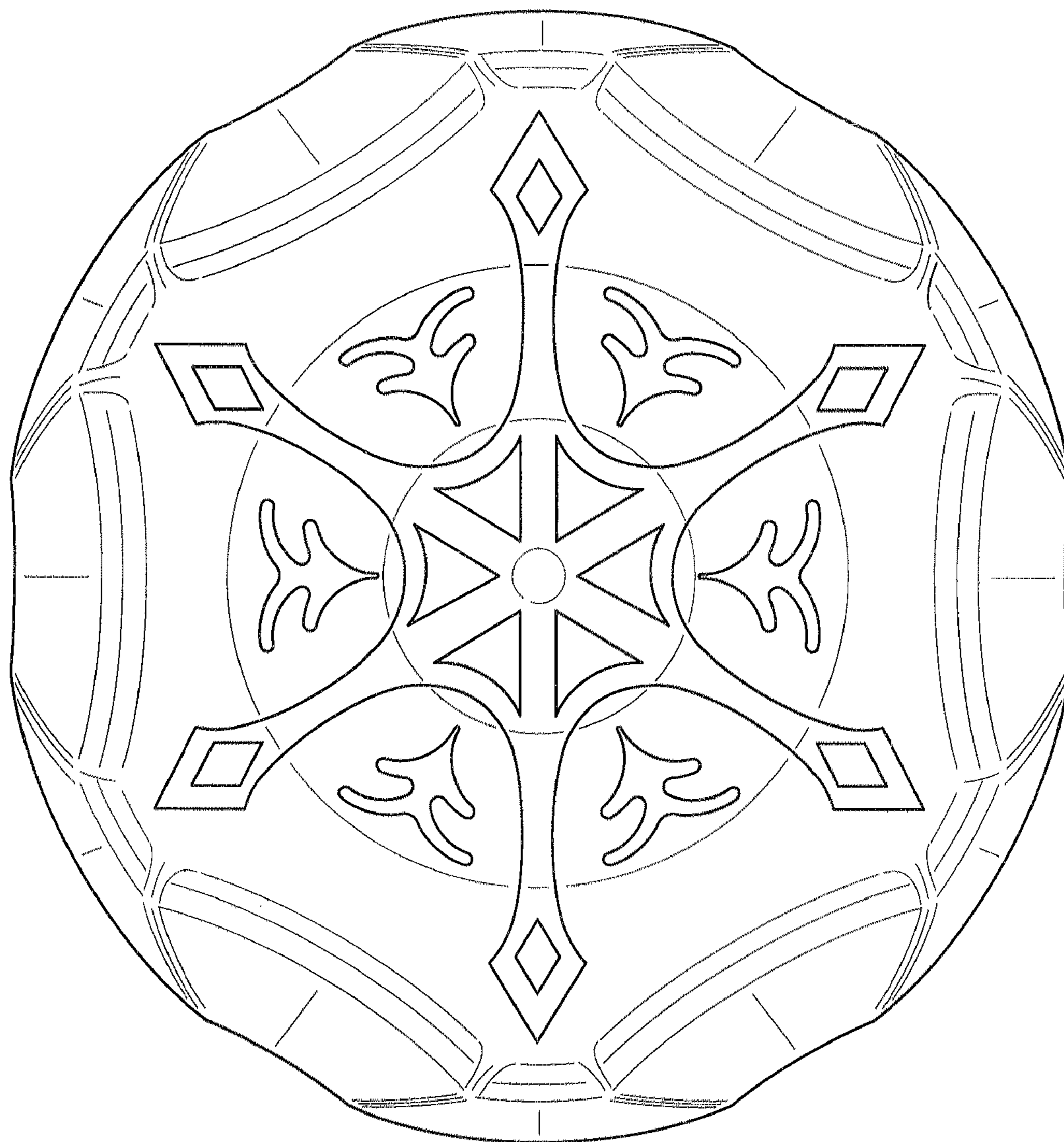

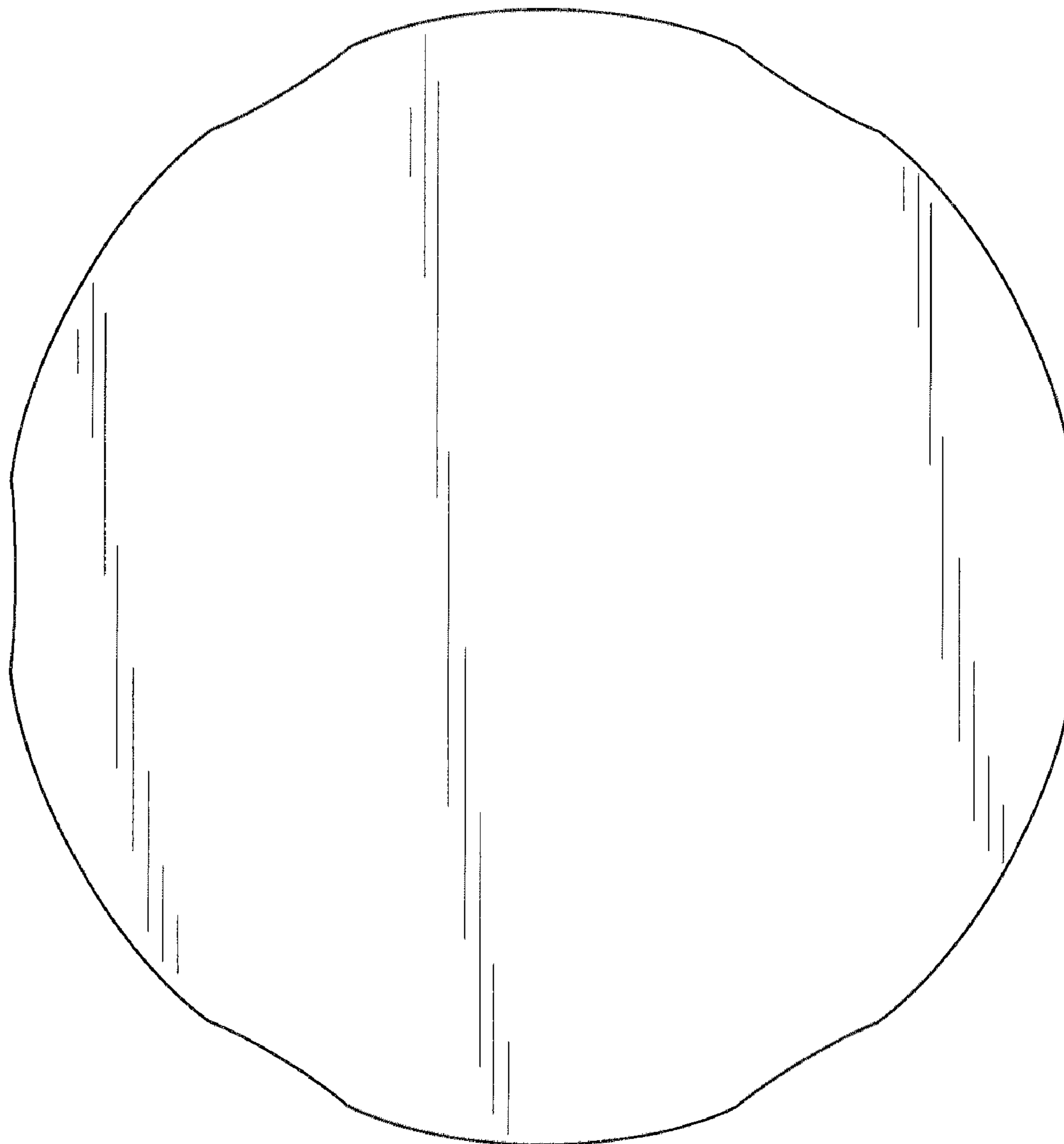

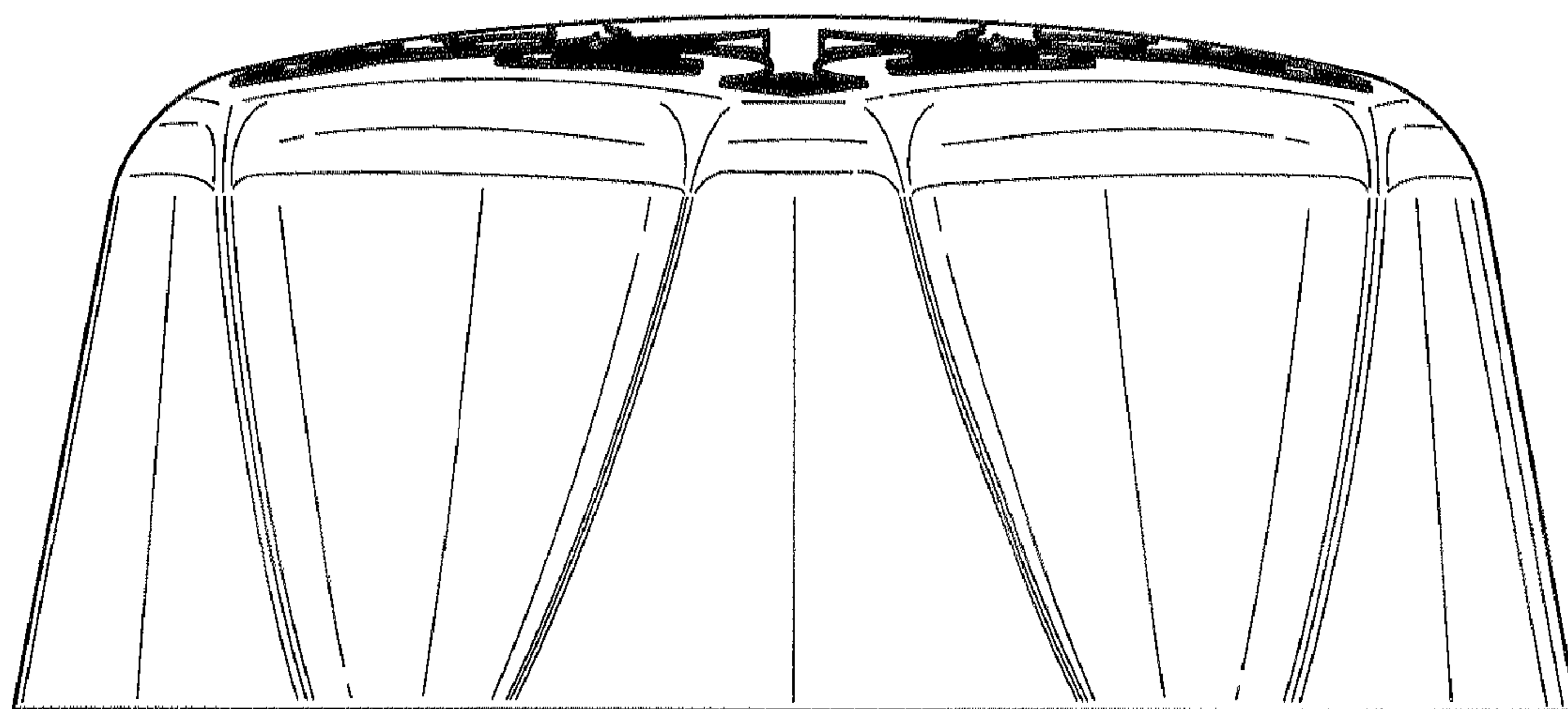

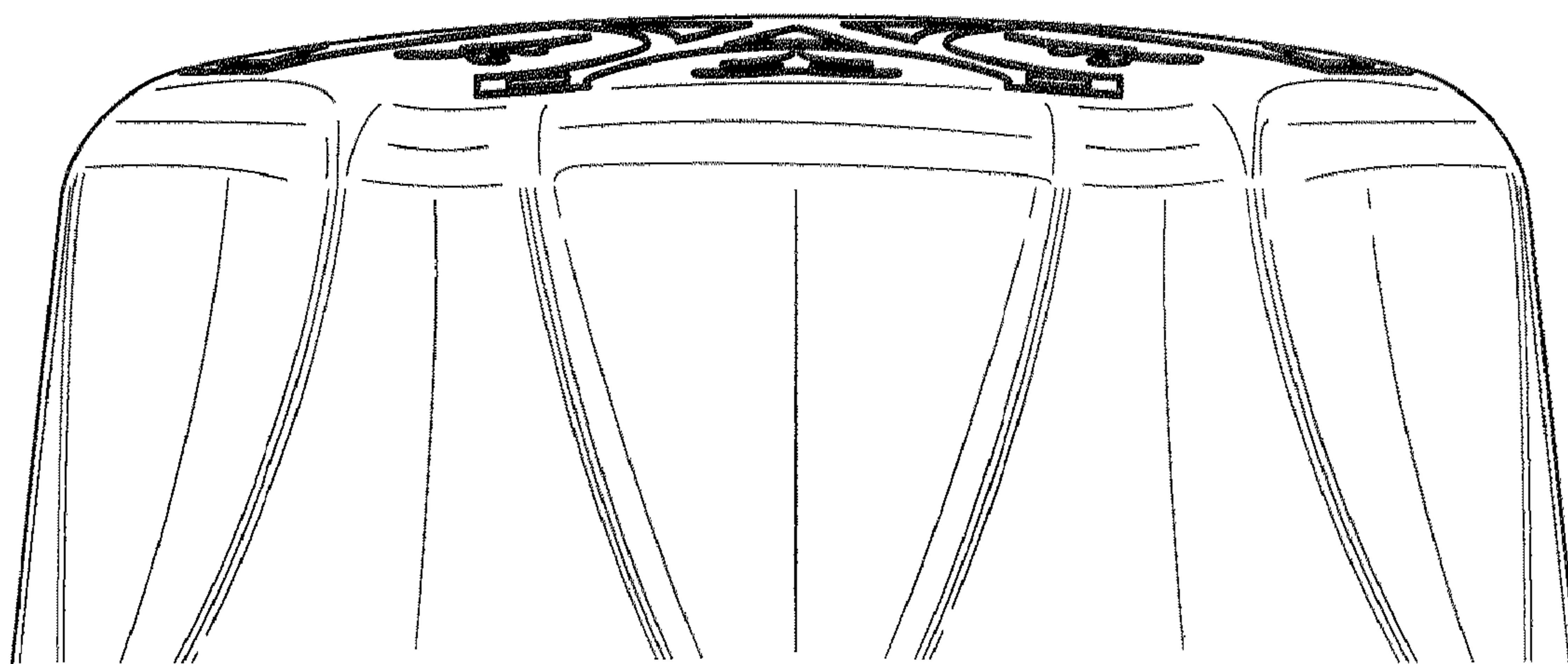
