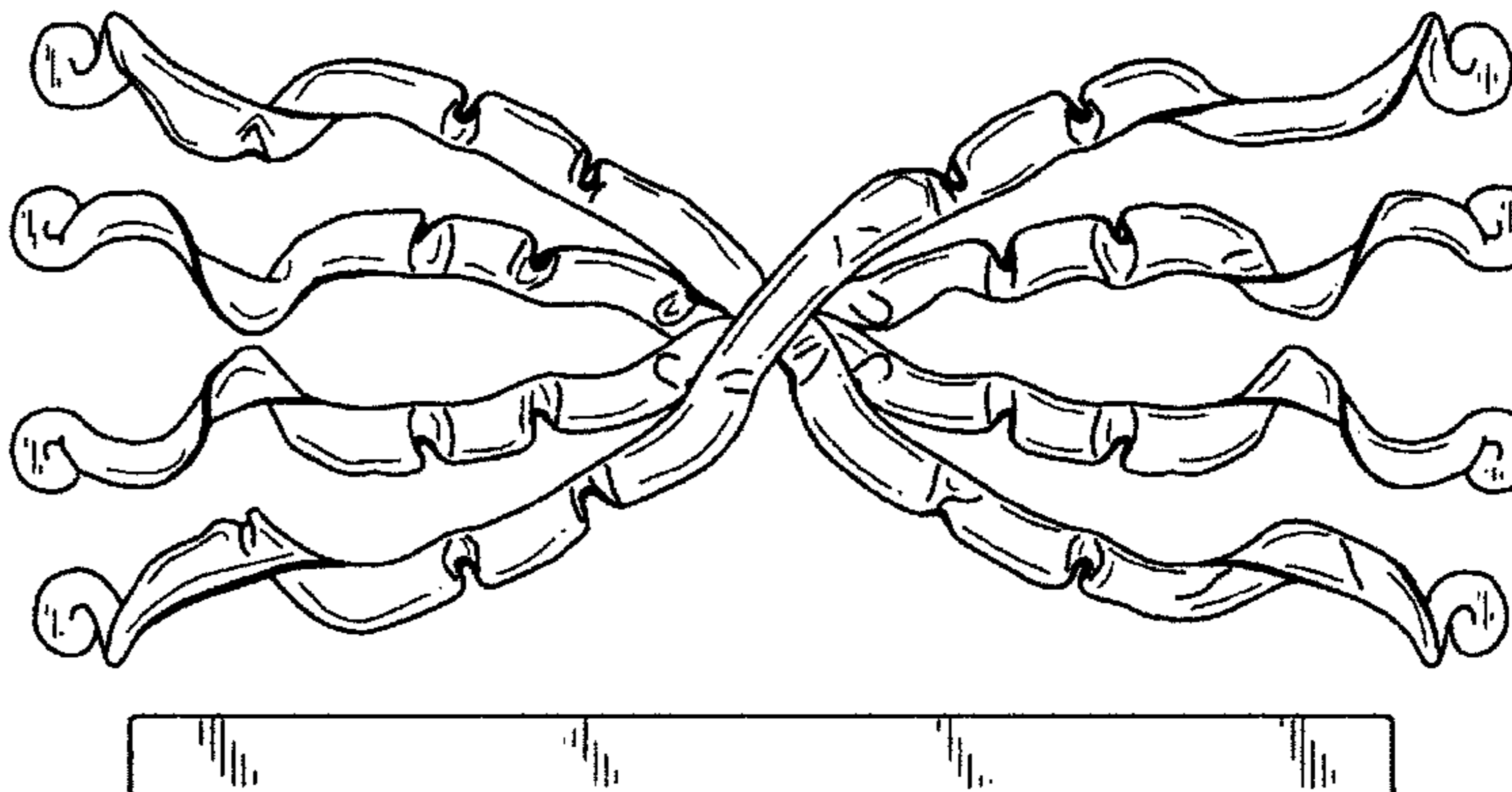
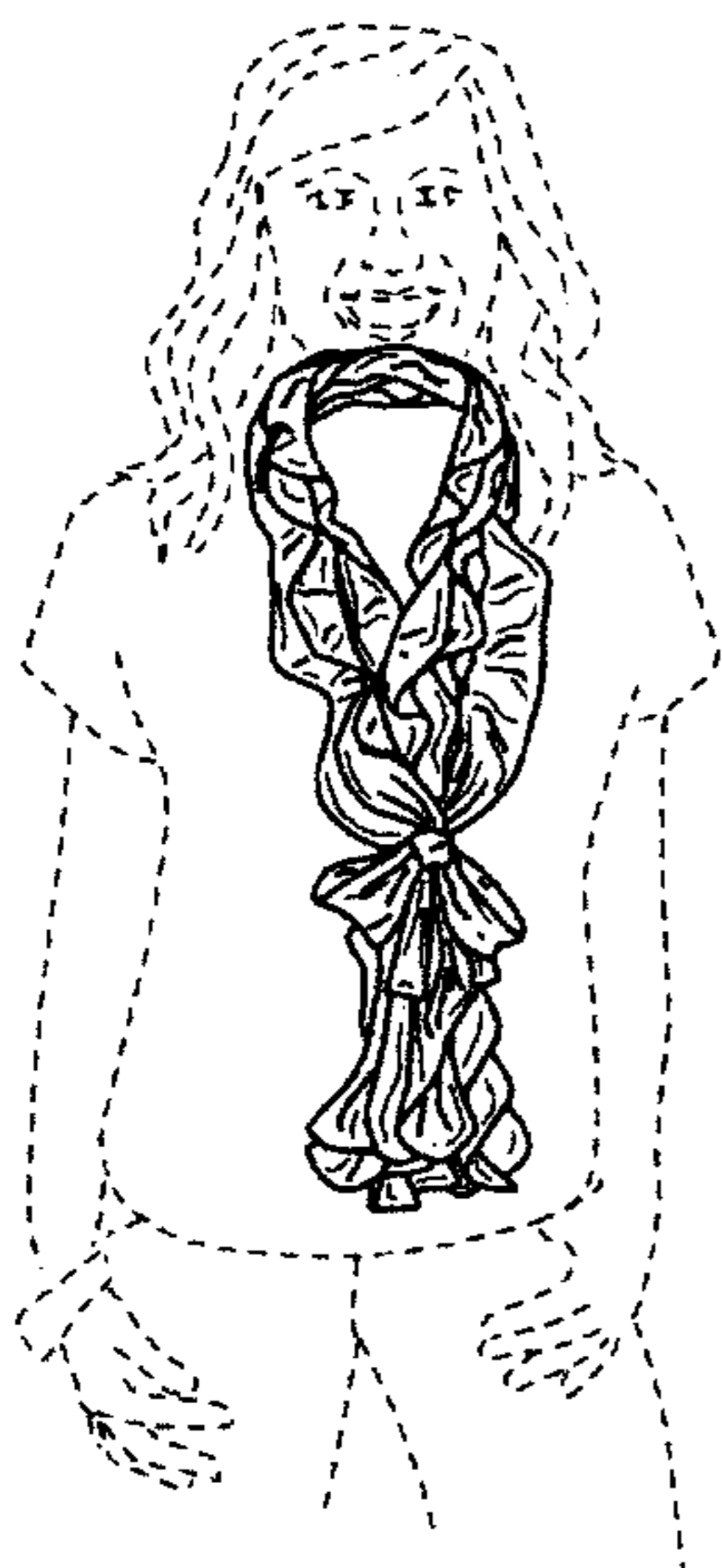
(57) **CLAIM**

I claim the ornamental design for a fabric scarf and tie there-  
fore, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a fabric scarf and tie therefore, showing my new design in a worn configuration, the tie forming a knot around a portion of the scarf;  
FIG. 2 is an exploded top plan view thereof in a flat configuration;  
FIG. 3 is an exploded front elevational view of FIG. 2;  
FIG. 4 is an exploded rear elevational view of FIG. 2;  
FIG. 5 is an exploded bottom plan view of FIG. 2;  
FIG. 6 is an exploded left-side elevational view of FIG. 2; and,  
FIG. 7 is an exploded right-side elevational view of FIG. 2.  
The broken lines showing a person in FIG. 1 depict environmental matter and form no part of the claimed design.

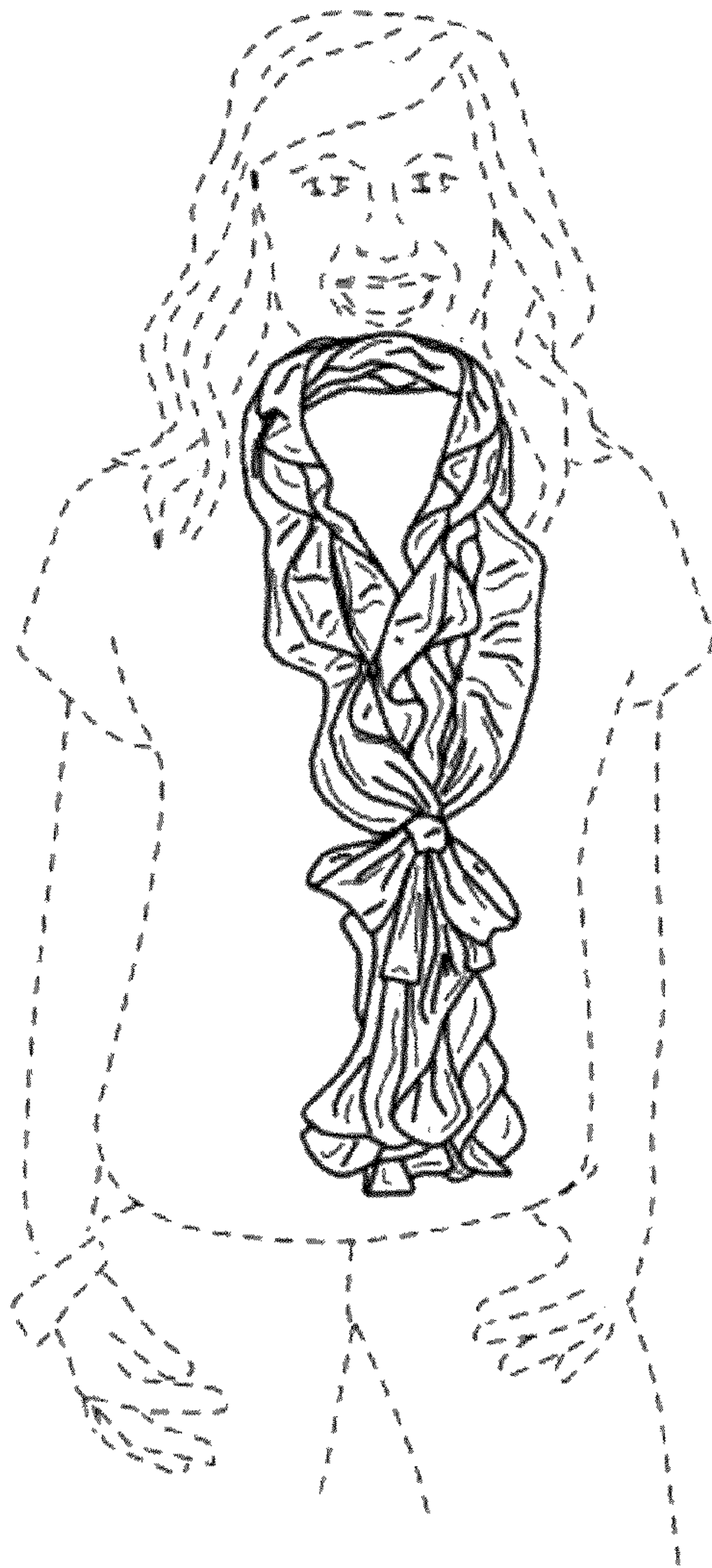

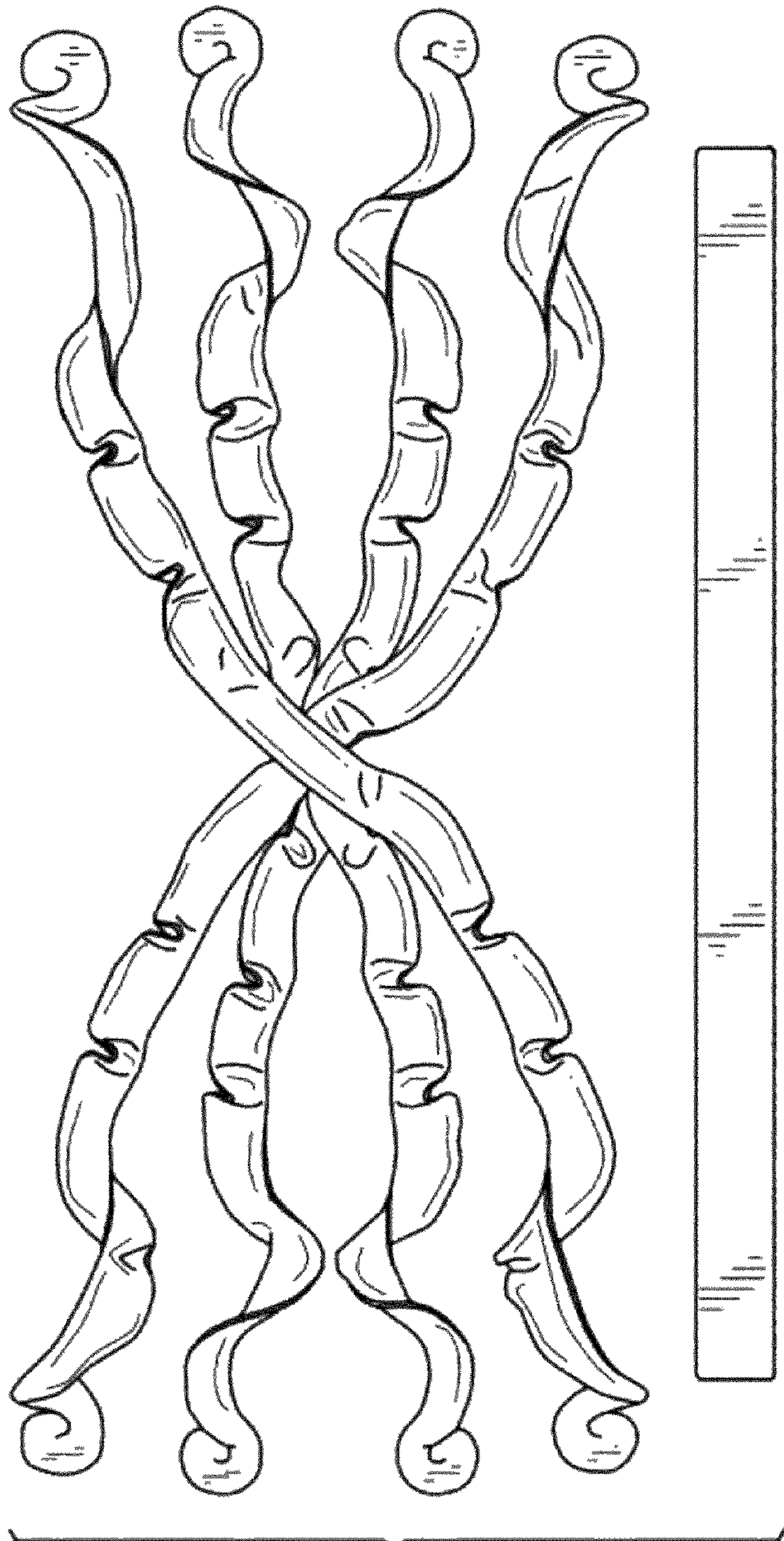

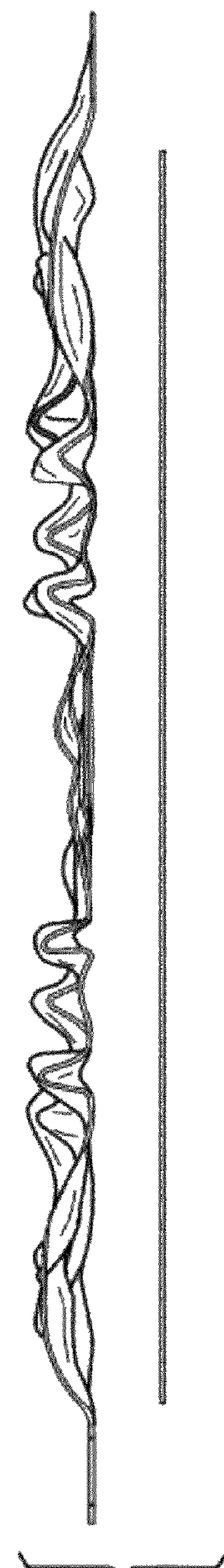
