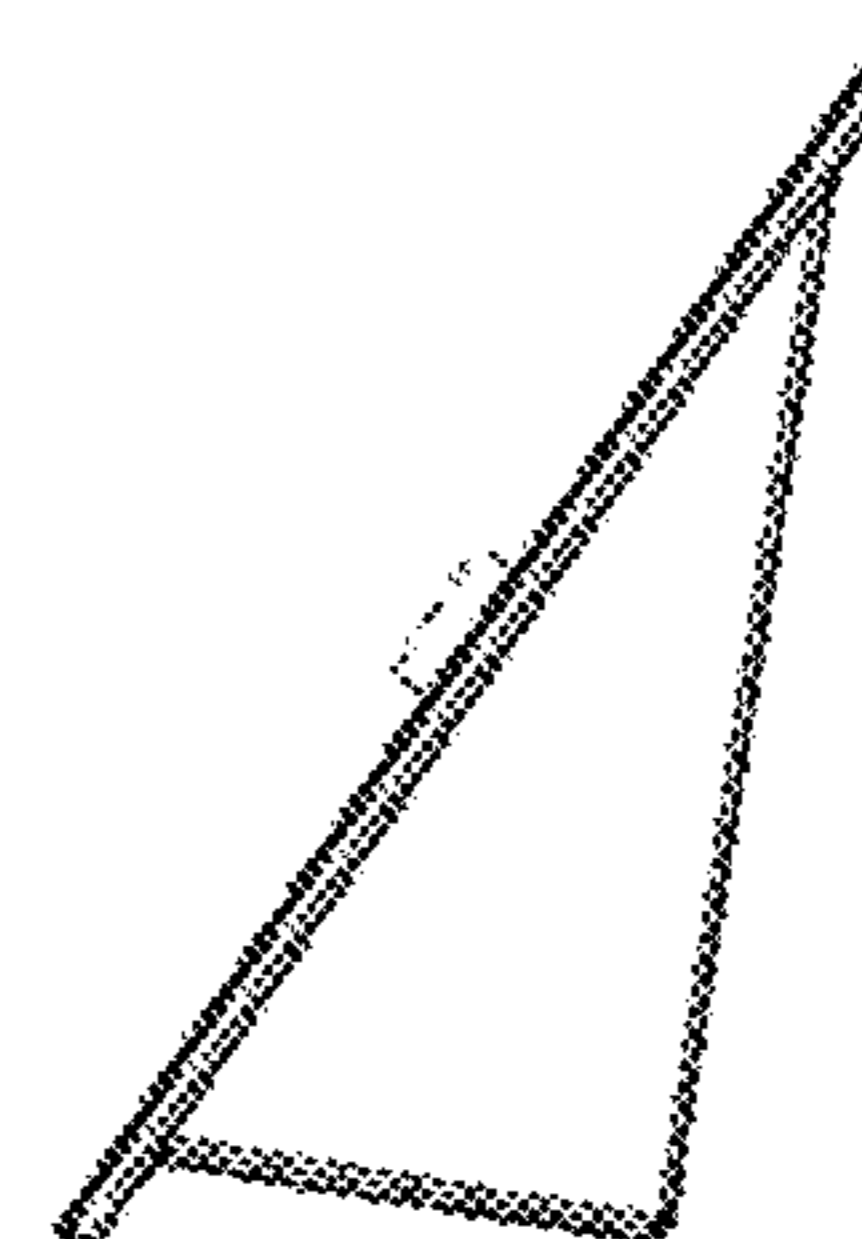
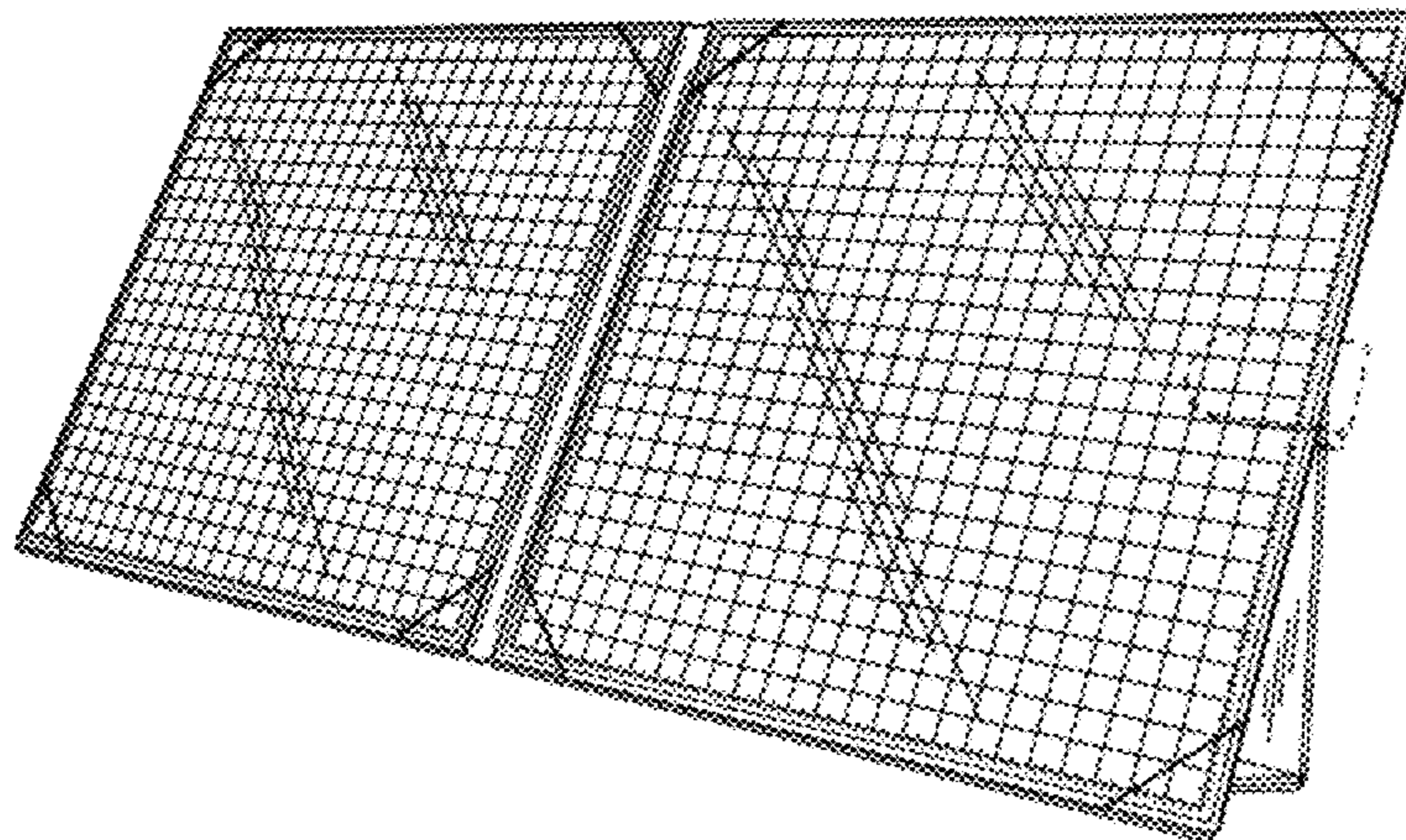

FIG. 1 is a perspective view of an easel, showing my new design in an open configuration;  
FIG. 2 is a front elevational view of FIG. 1;

FIG. 5 is a right-side elevational view of FIG. 1;  
FIG. 6 is a top plan view of FIG. 1;  
FIG. 7 is a bottom plan view of FIG. 1;  
FIG. 8 is an exploded top plan view of FIG. 1; and,  
FIG. 9 is a left-side elevational view thereof, illustrated in a closed configuration.

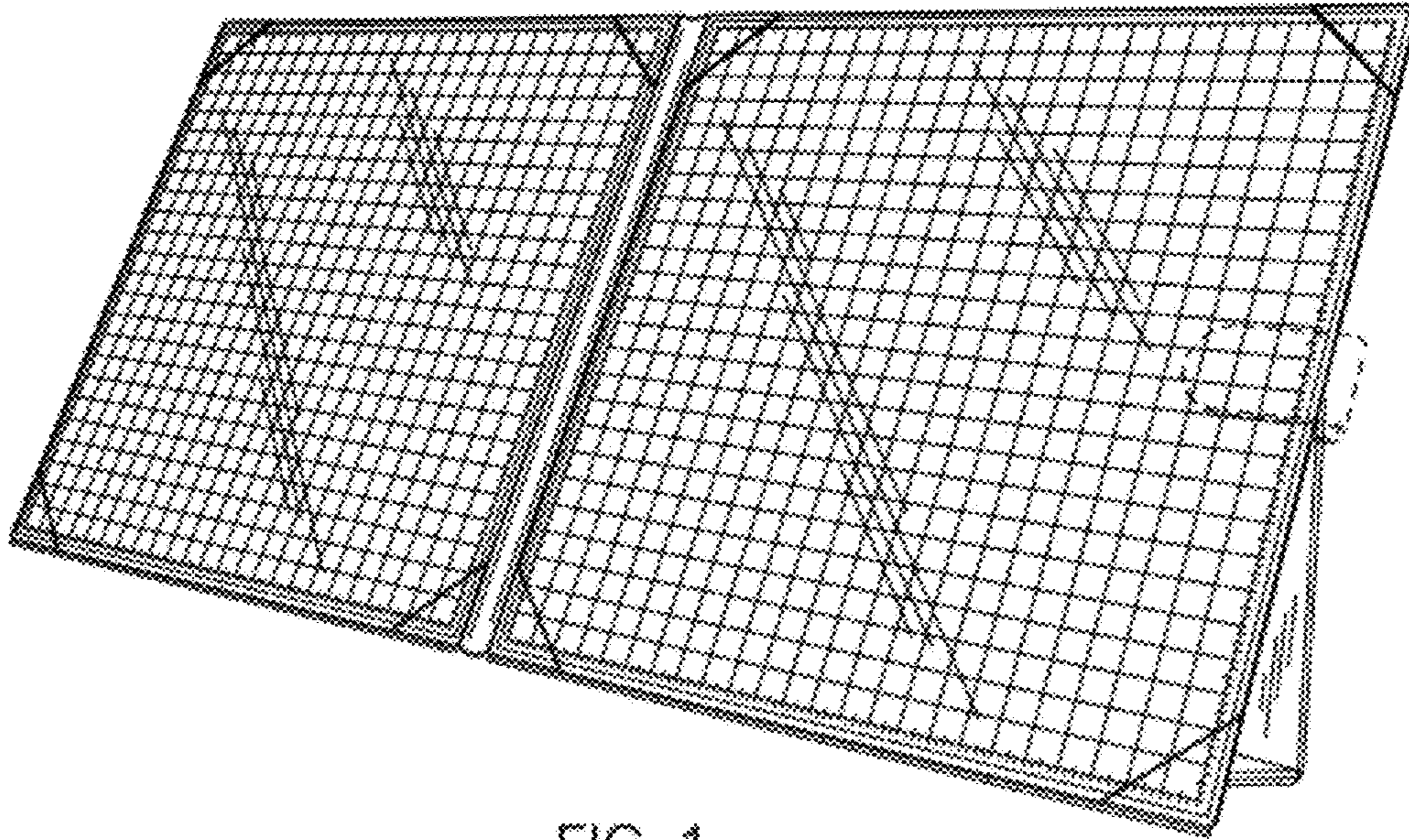

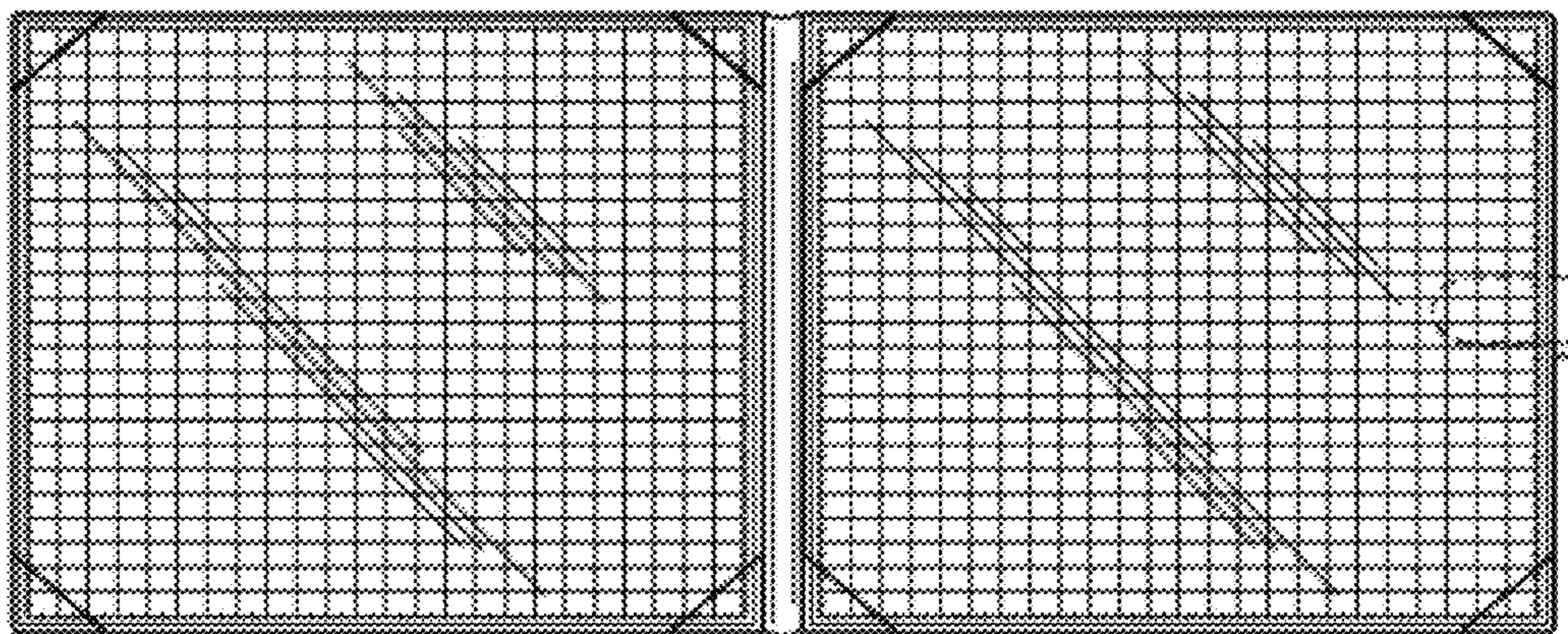

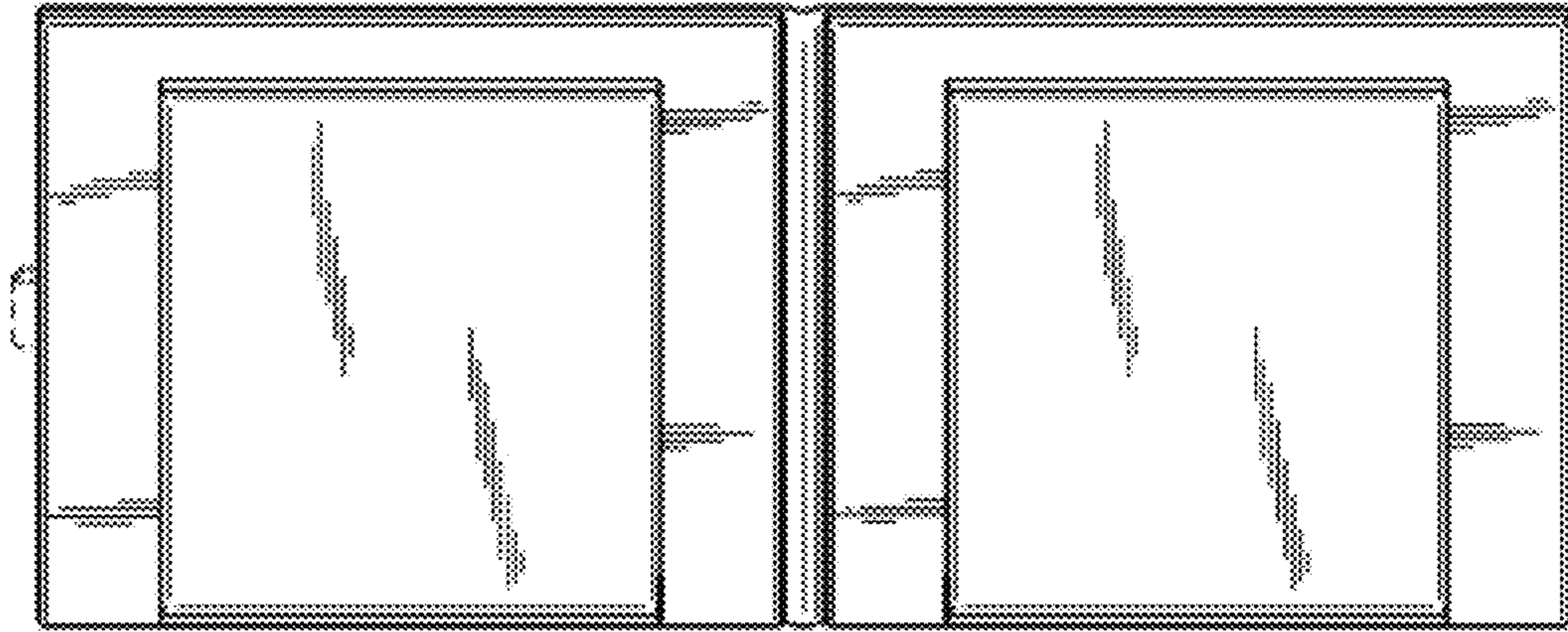

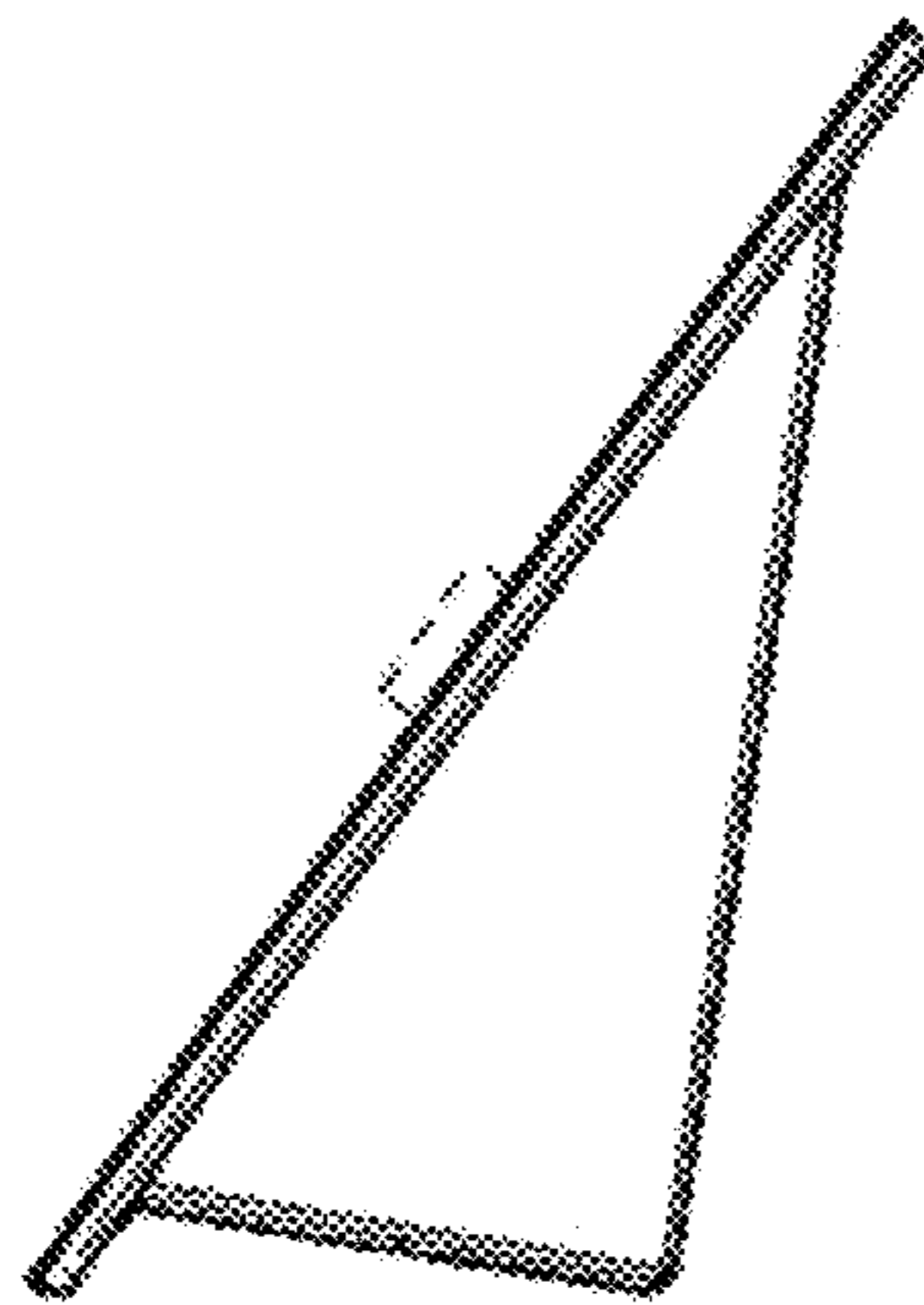

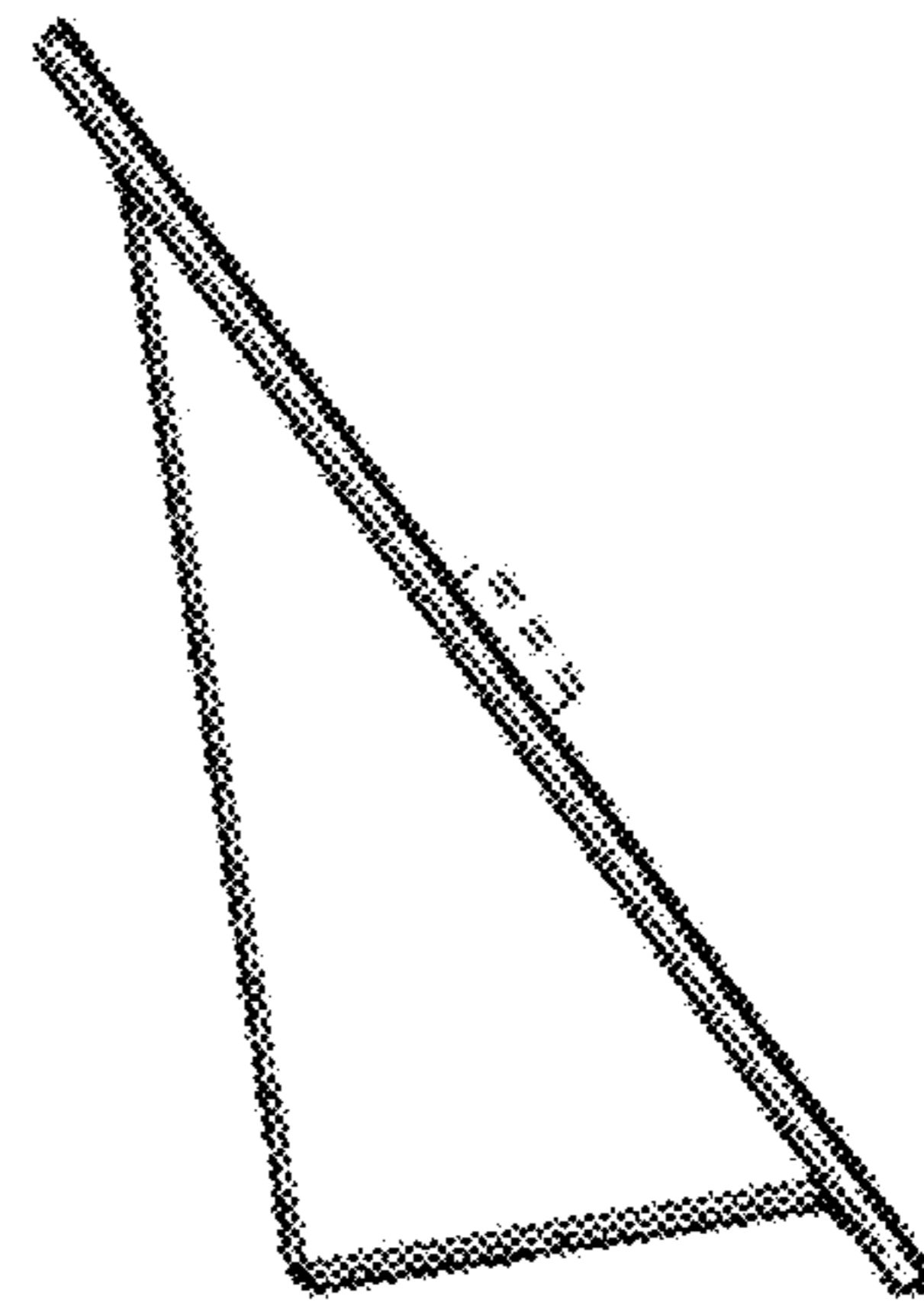

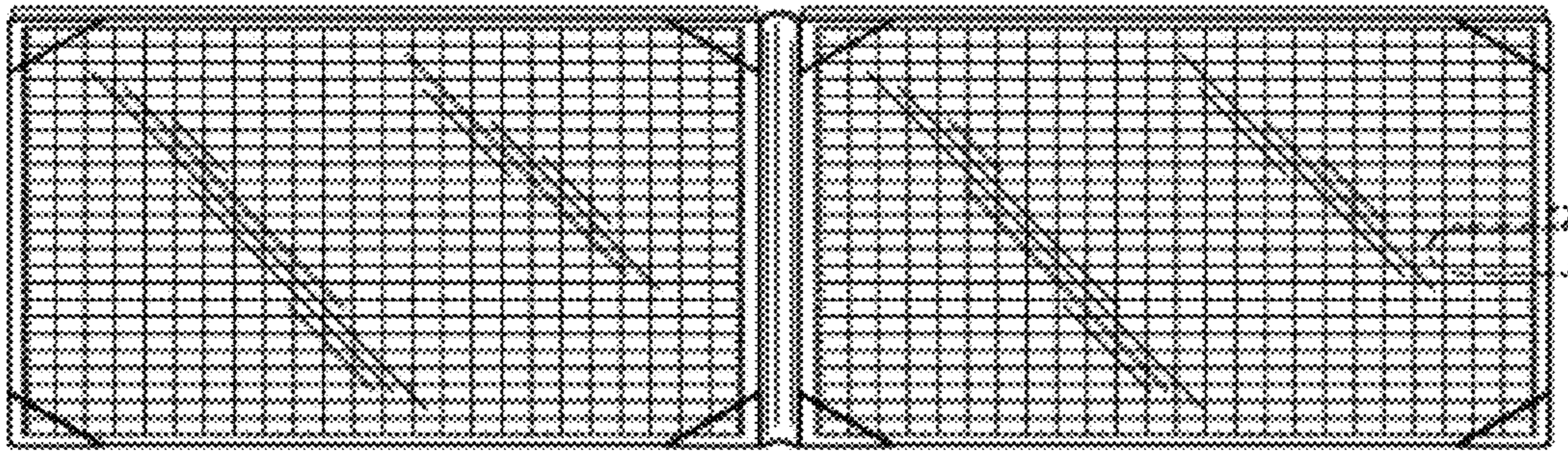

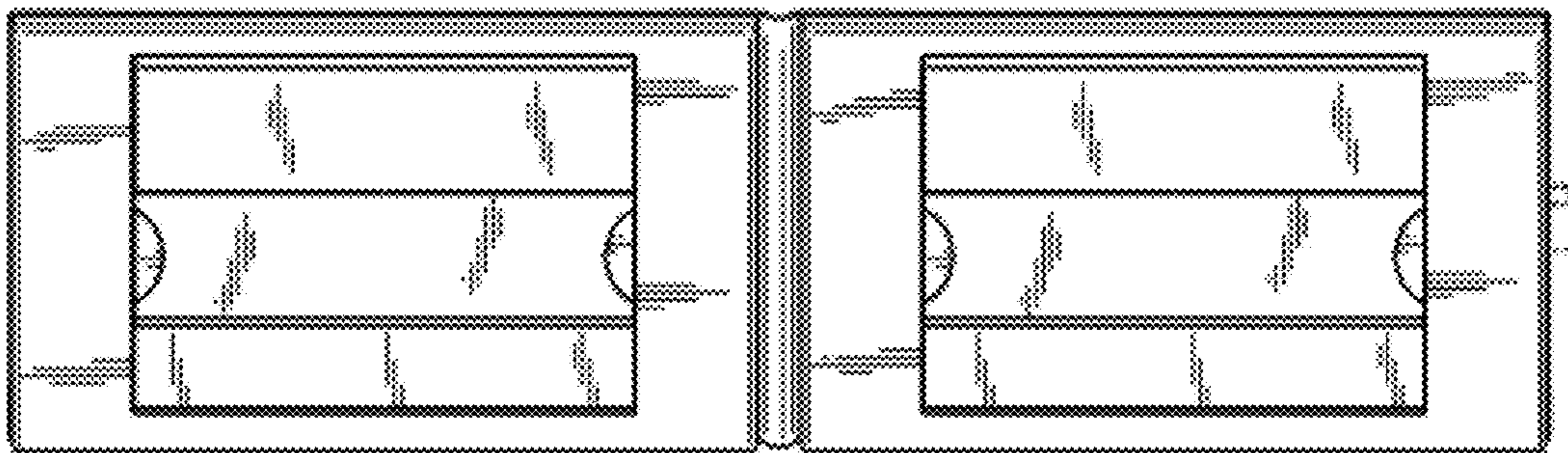

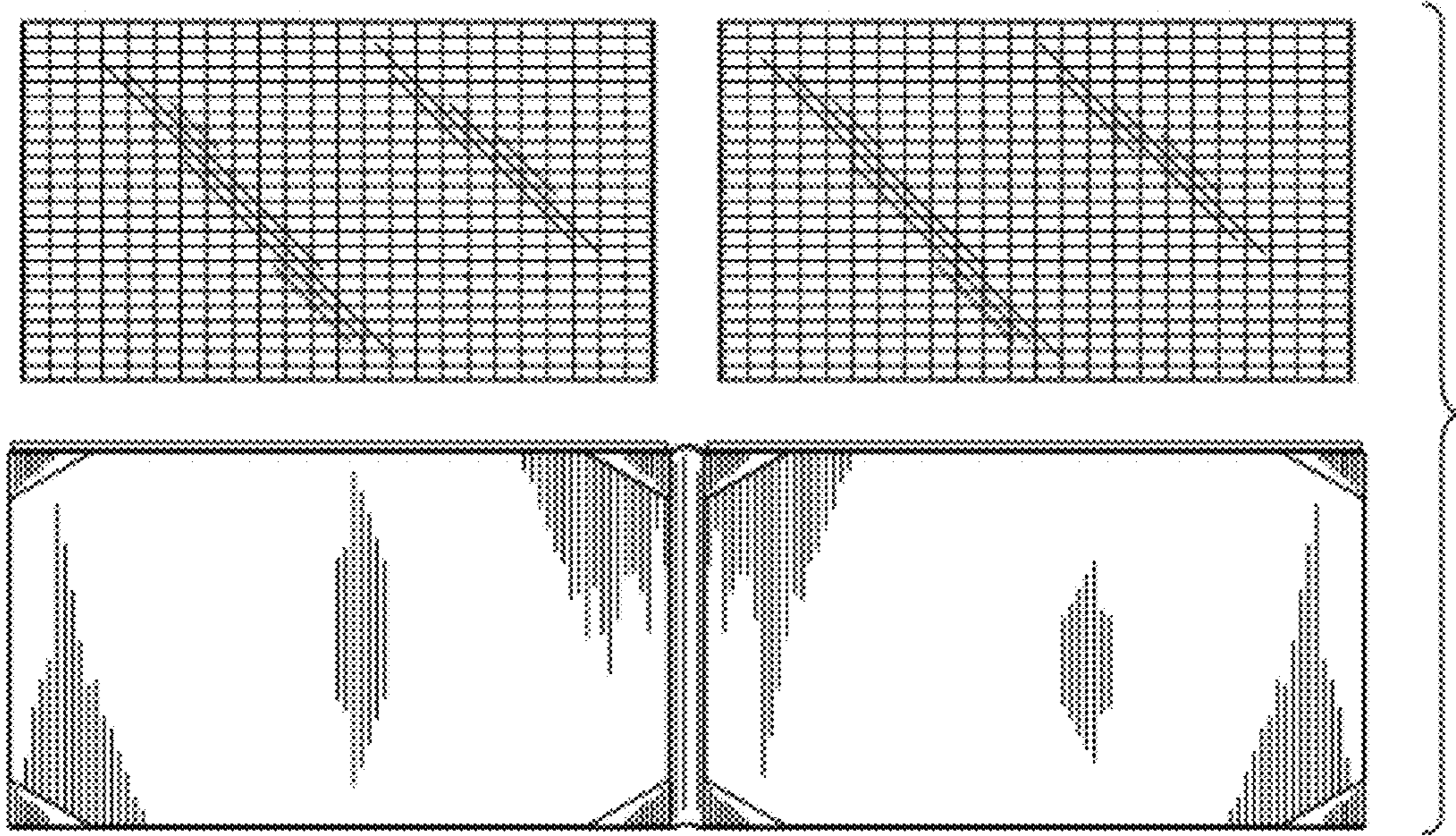
