DESCRIPTION

FIG. 1 is a top perspective view of a serving dish showing my new design;

FIG. 2 is a front view of the serving dish shown in FIG. 1;

FIG. 3 is a left side view of the serving dish shown in FIG. 1;

FIG. 4 is a rear view of the serving dish shown in FIG. 1;

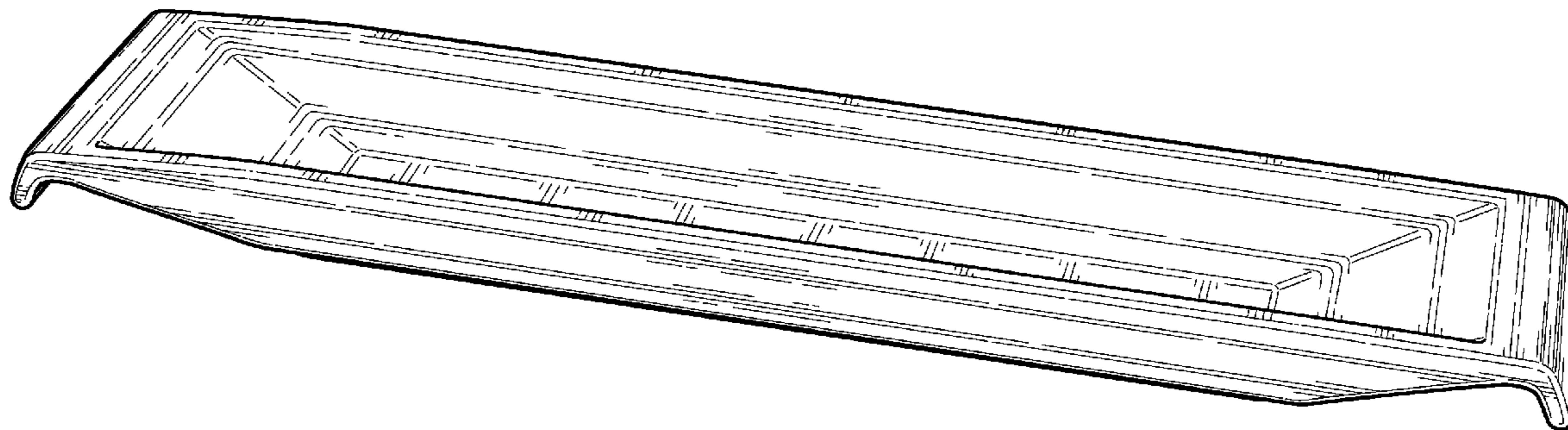
FIG. 5 is a right side view of the serving dish shown in FIG. 1;

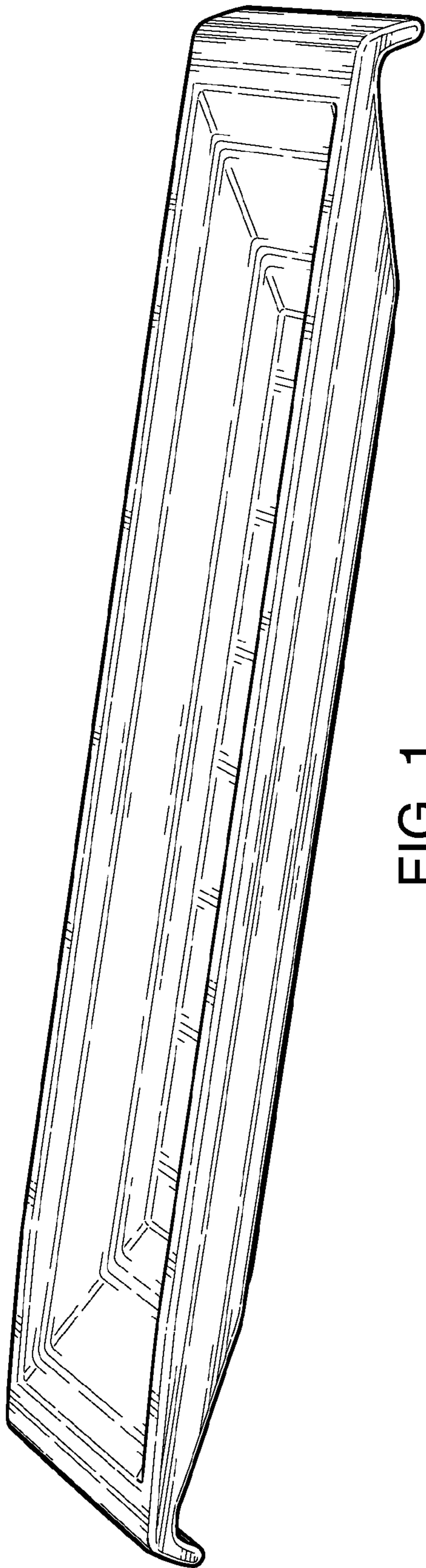

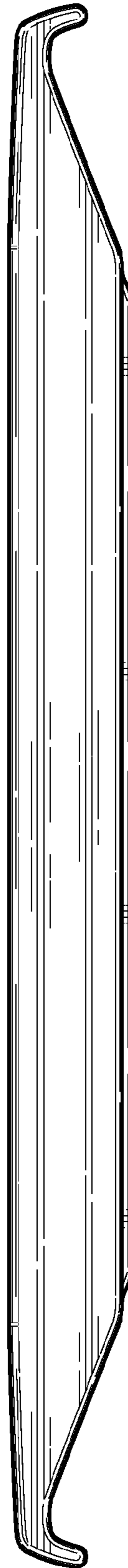

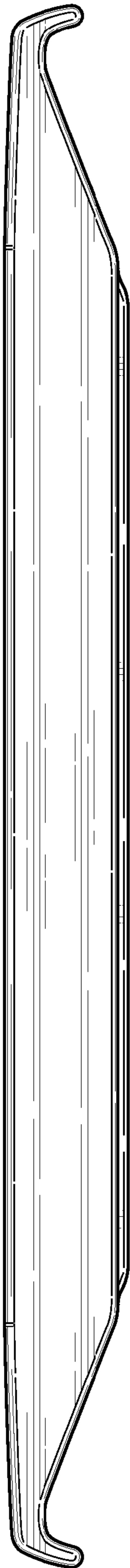

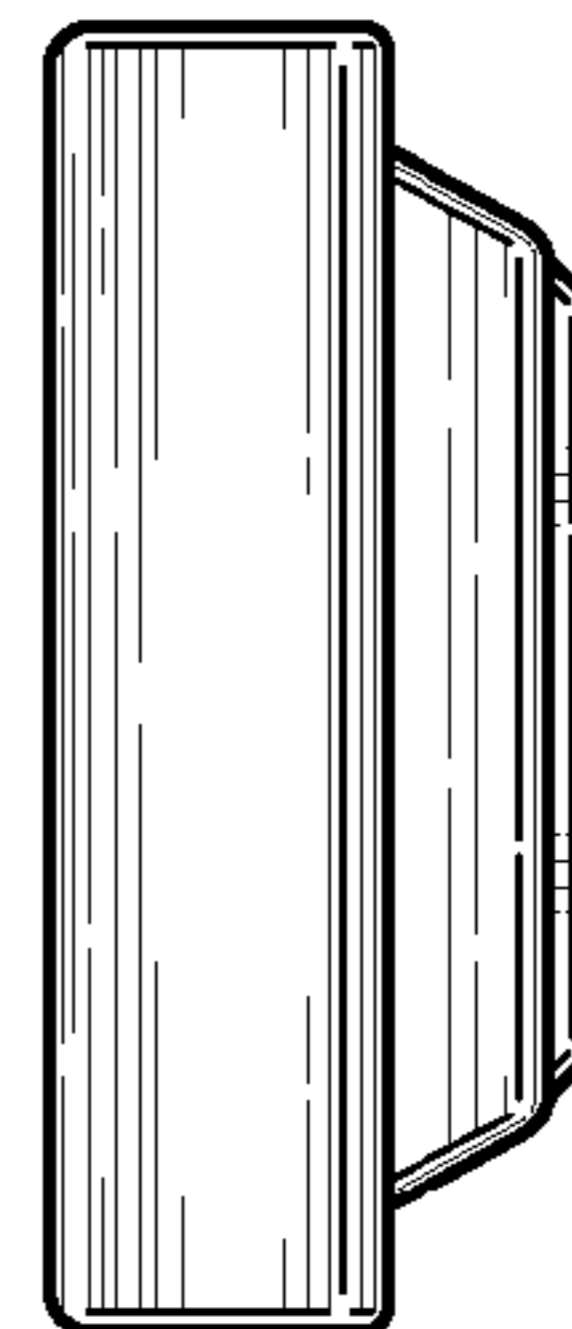

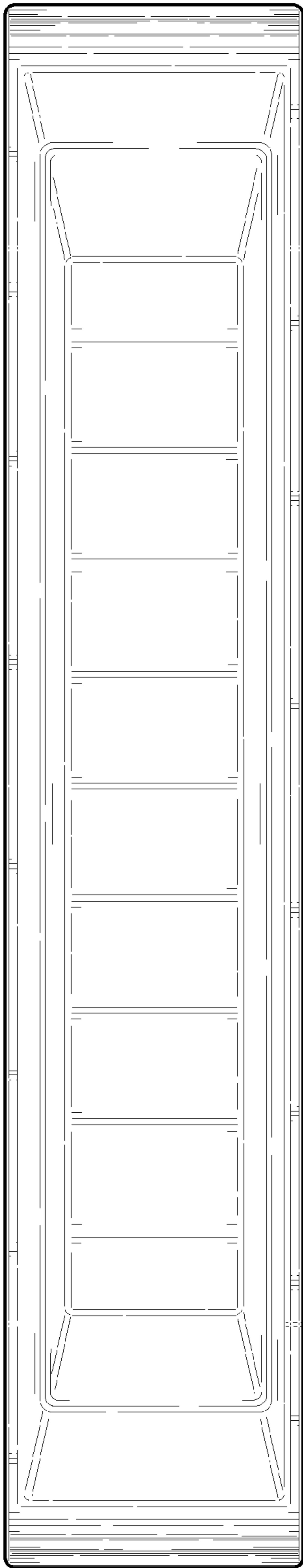

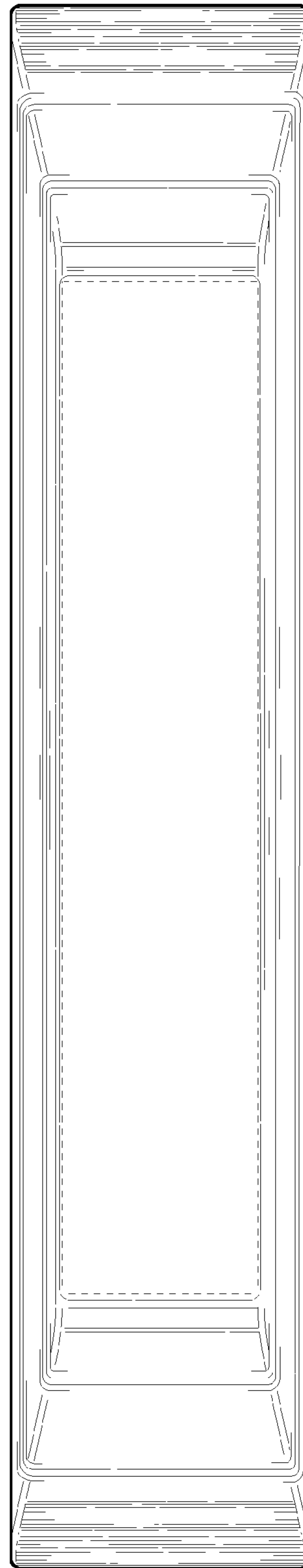
