**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of our container;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

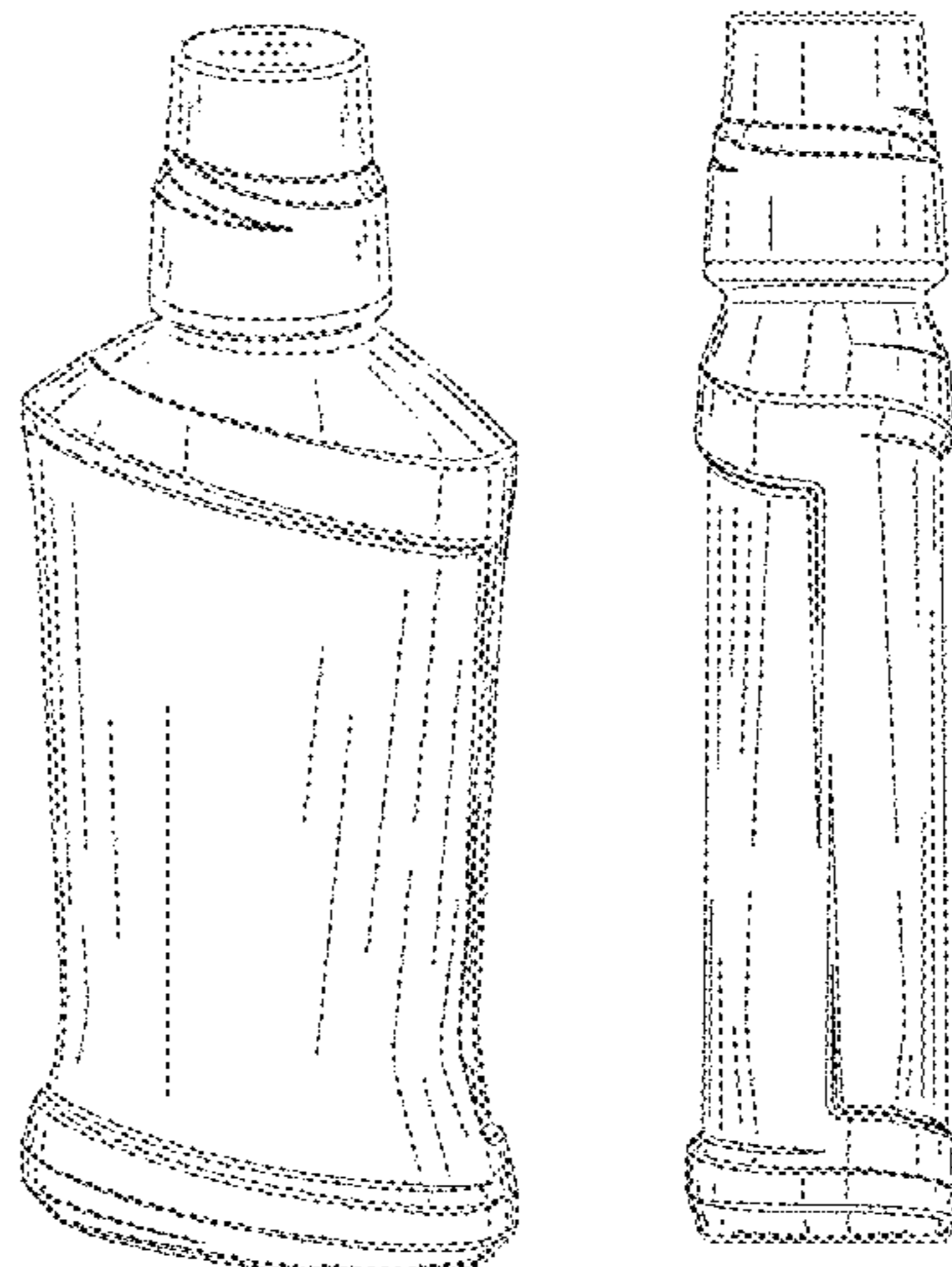
FIG. 6 is a right side elevational view thereof;

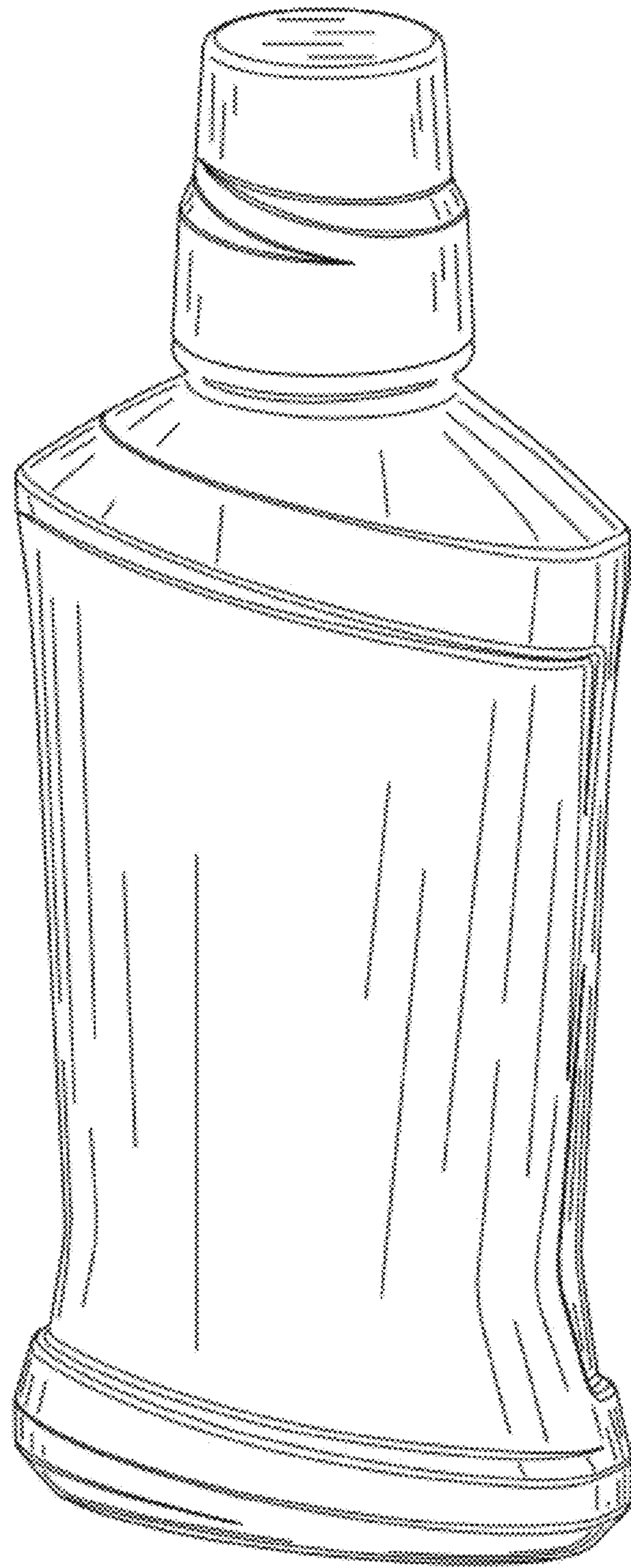

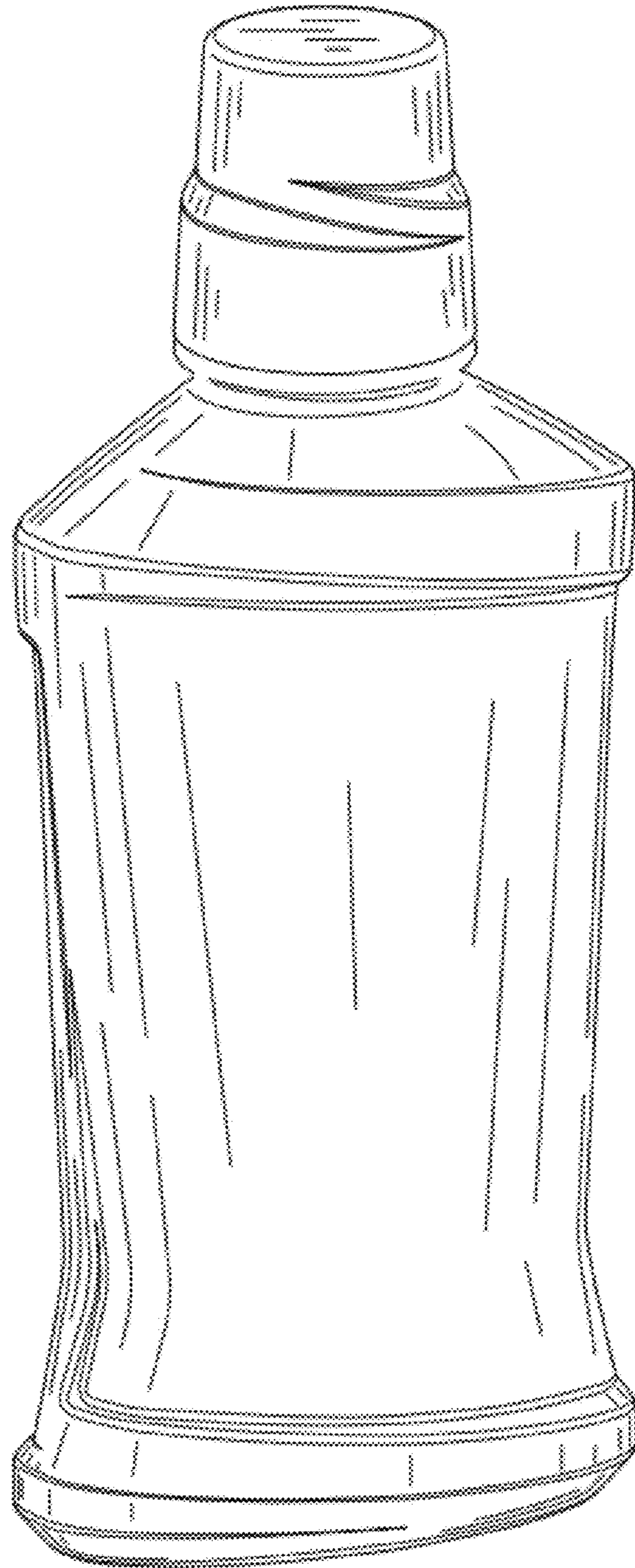

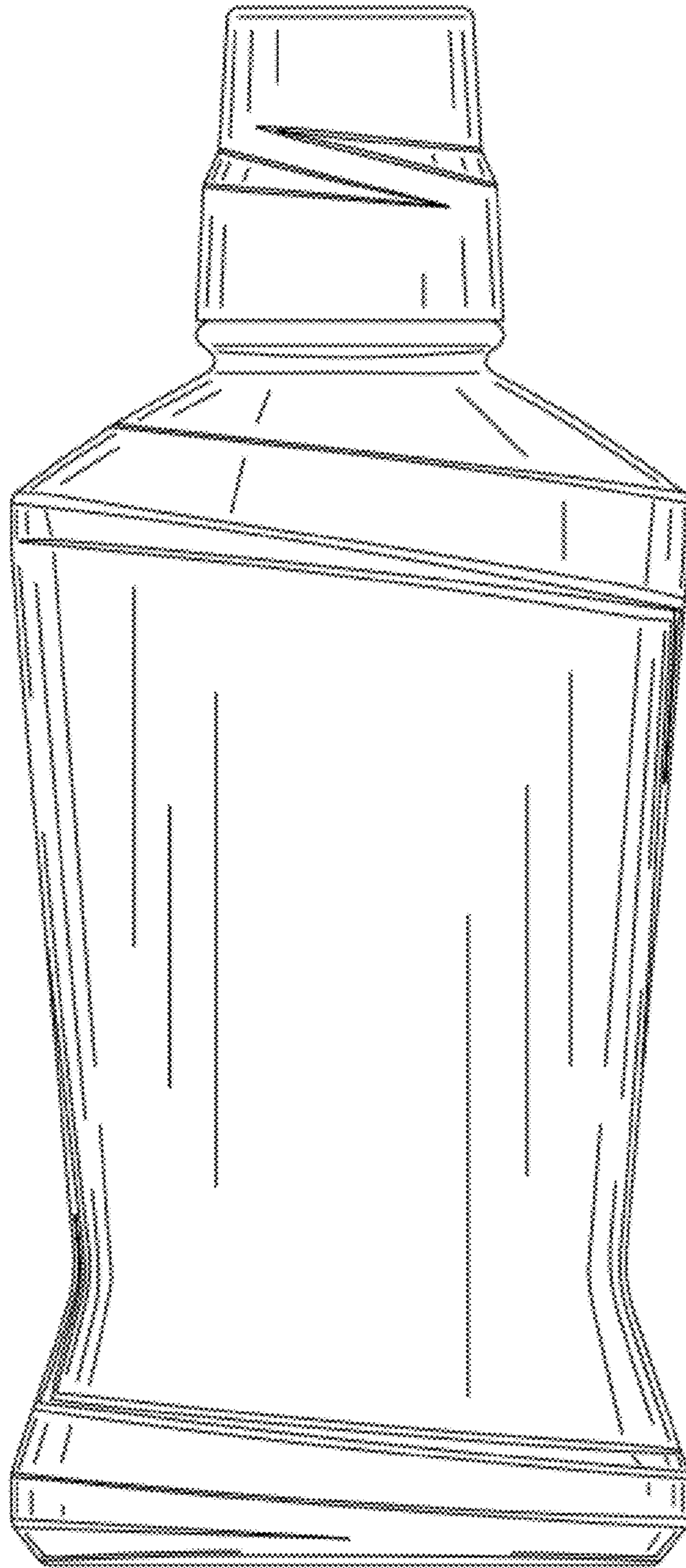

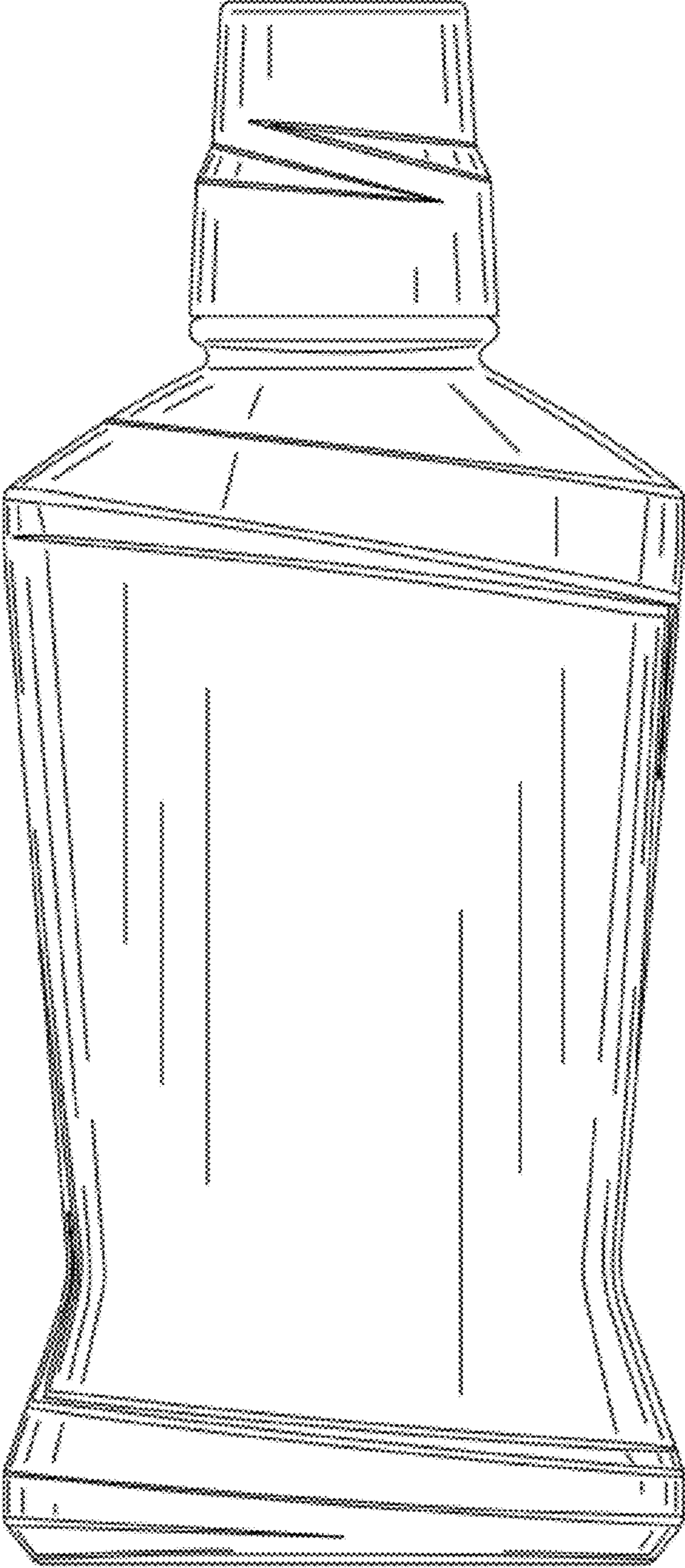

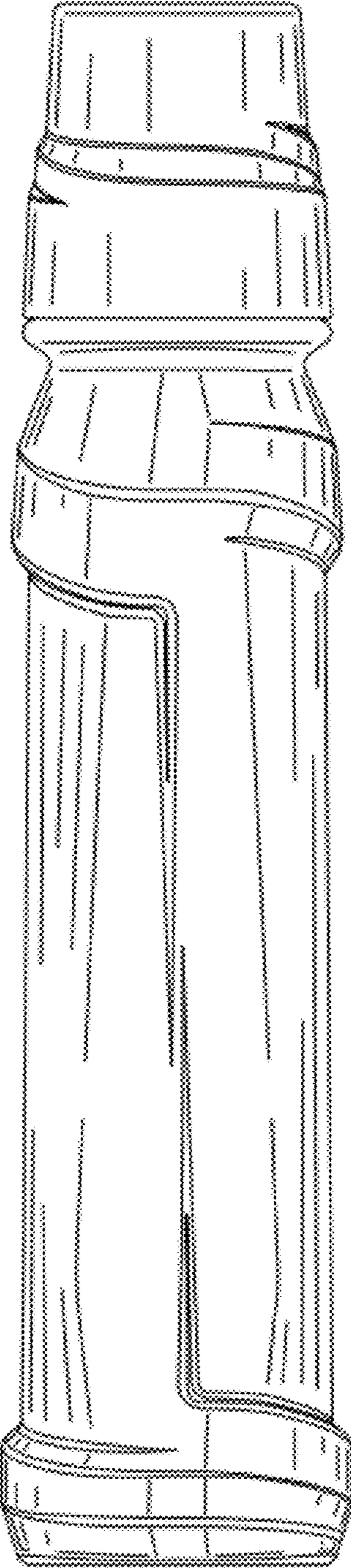

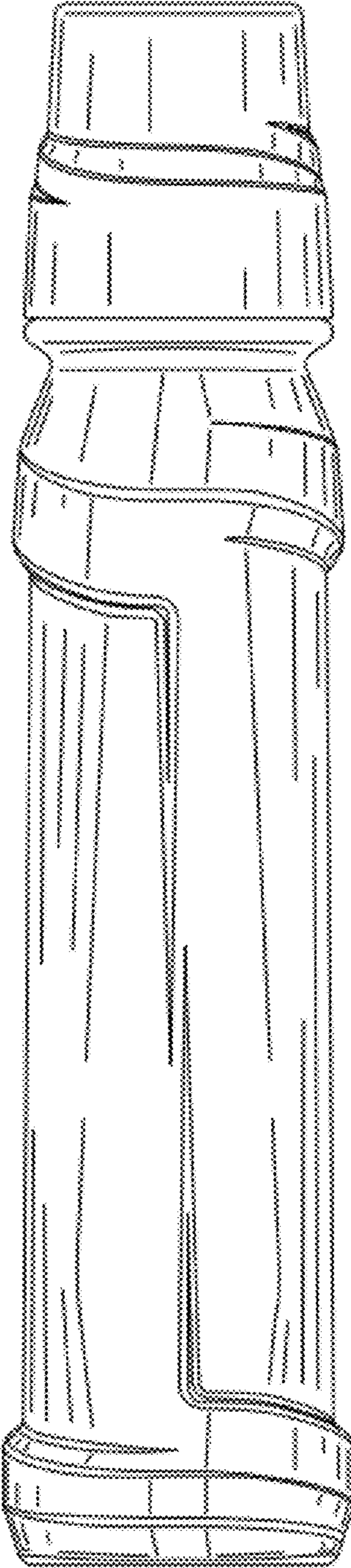

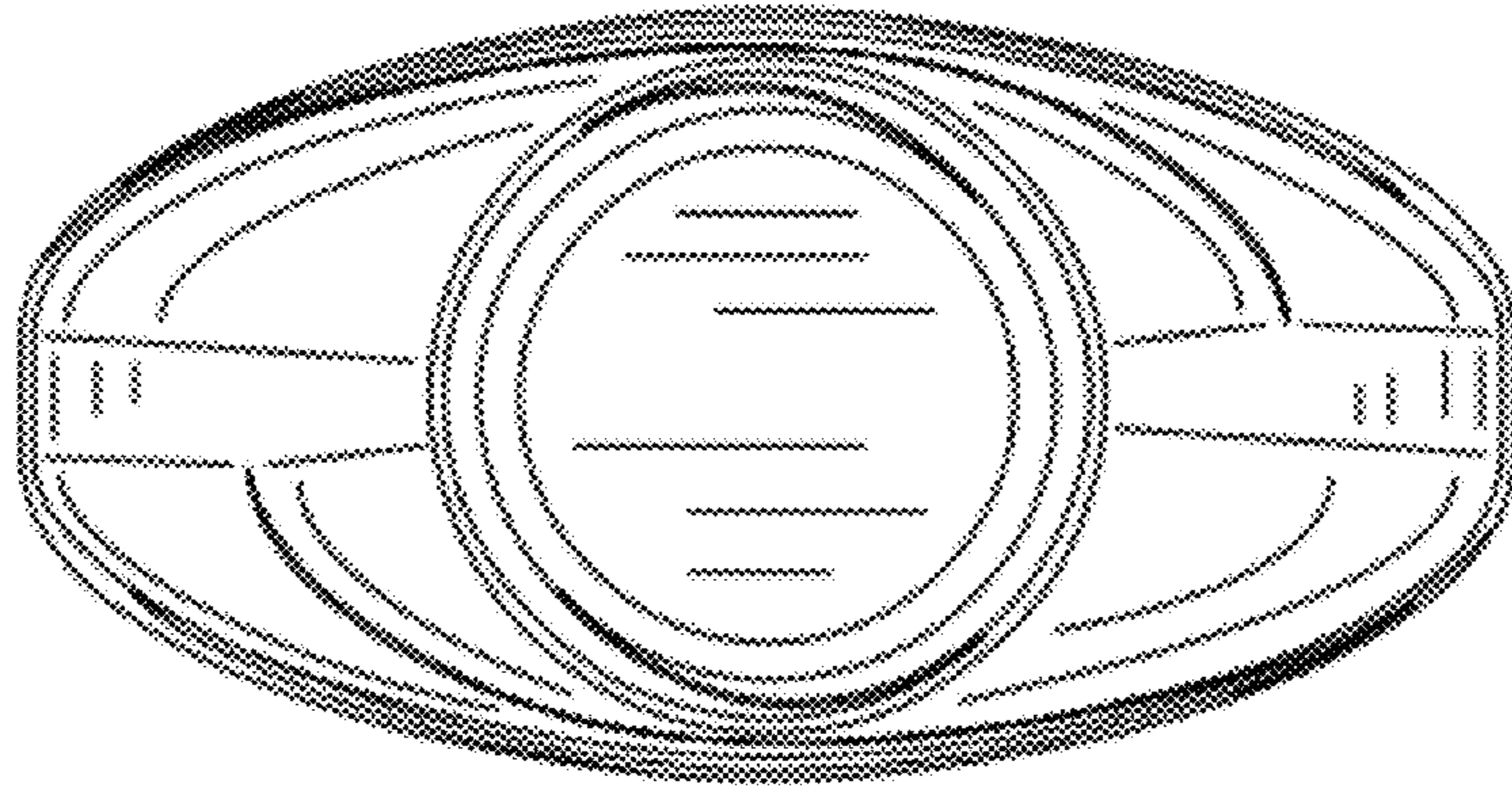

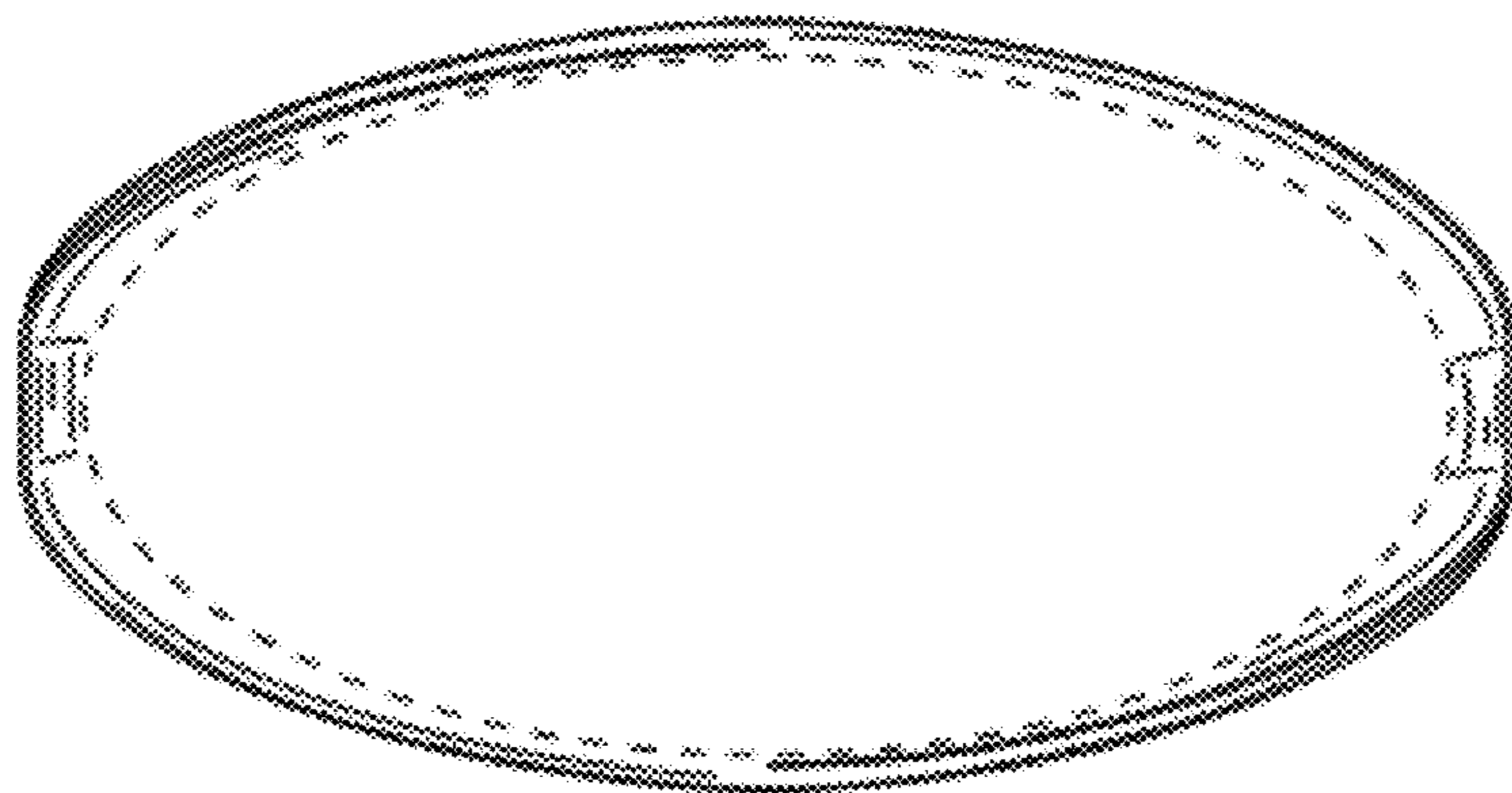
