FIG. 3 is a second side view thereof;

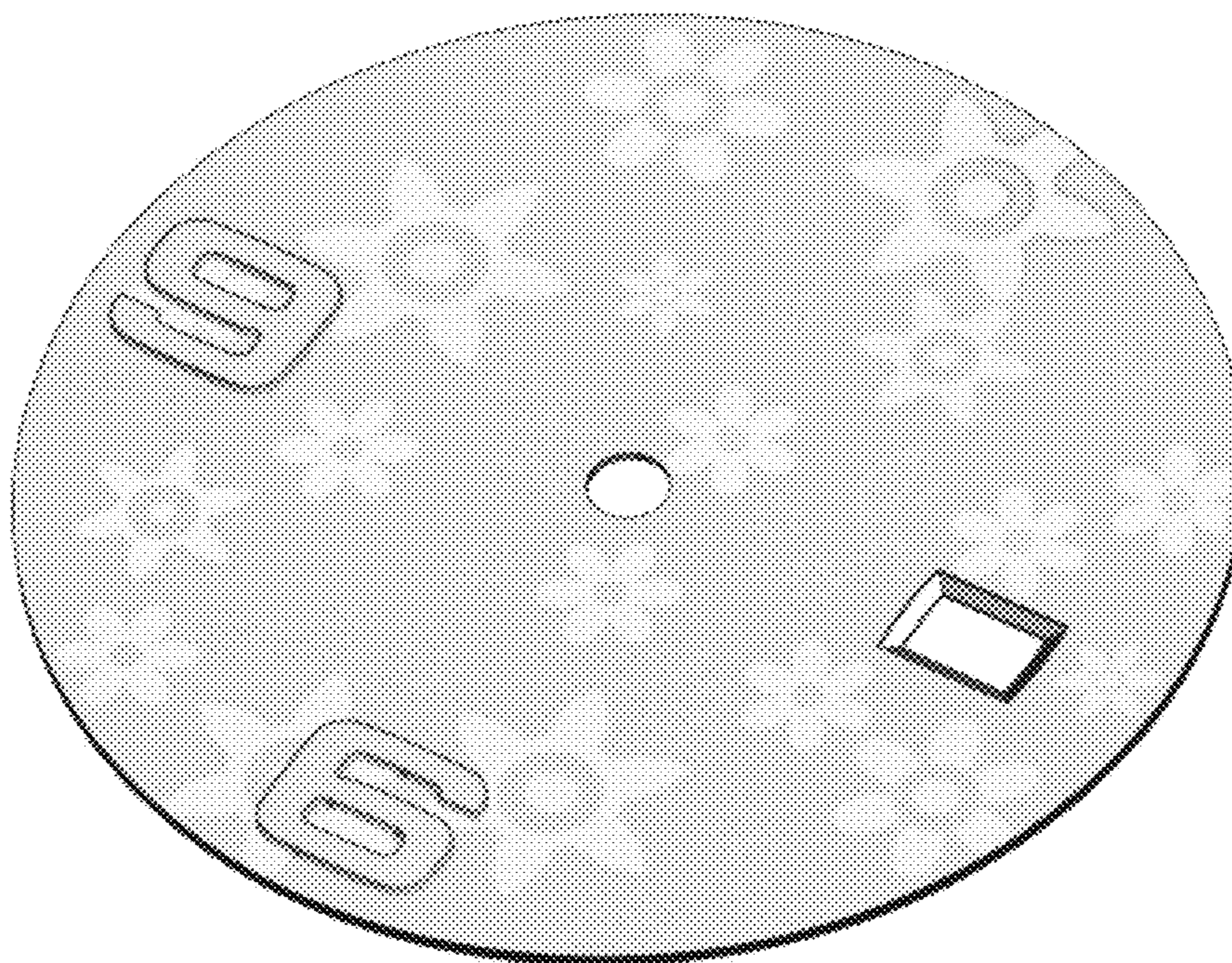
FIG. 4 rear view thereof;

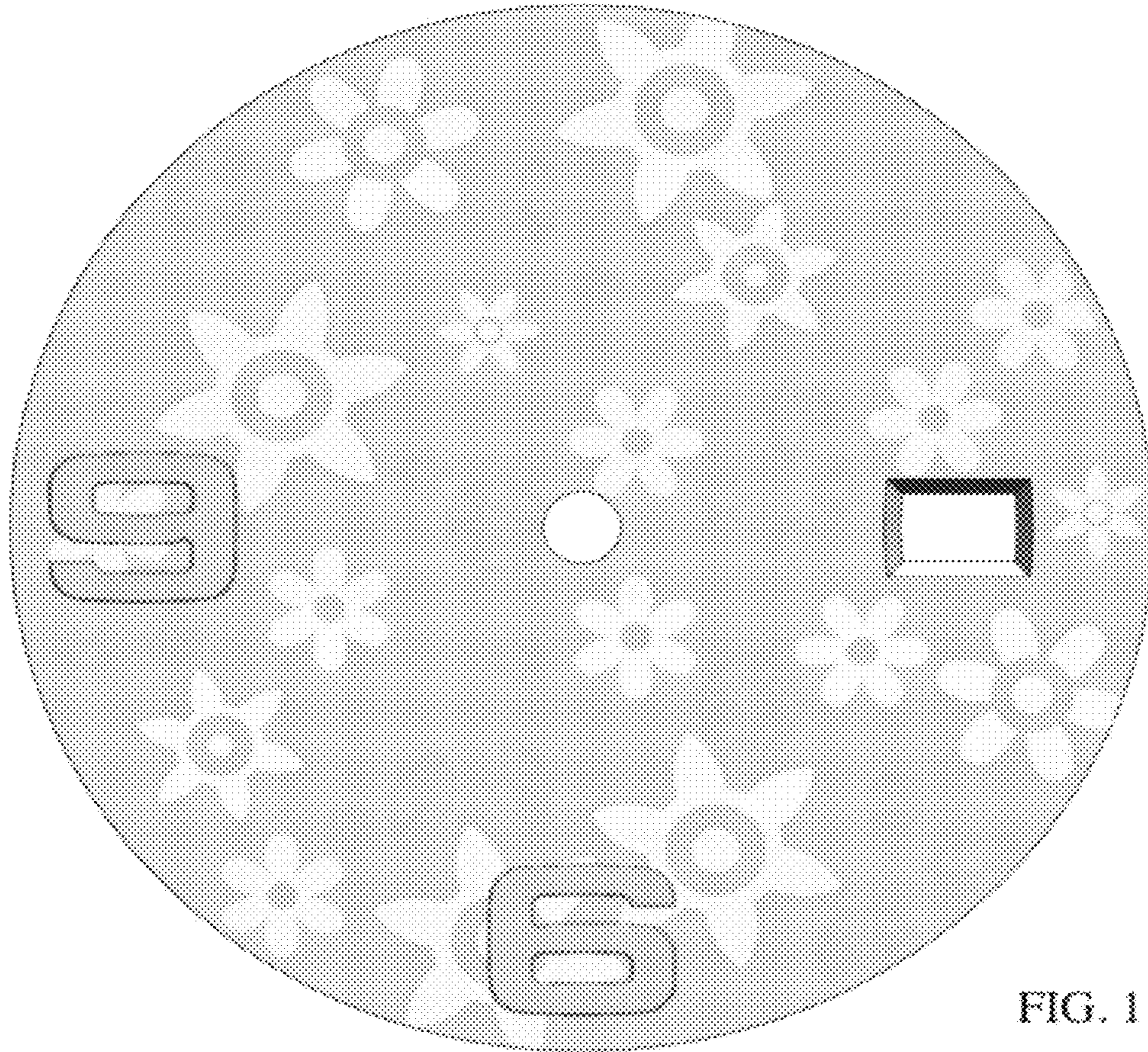

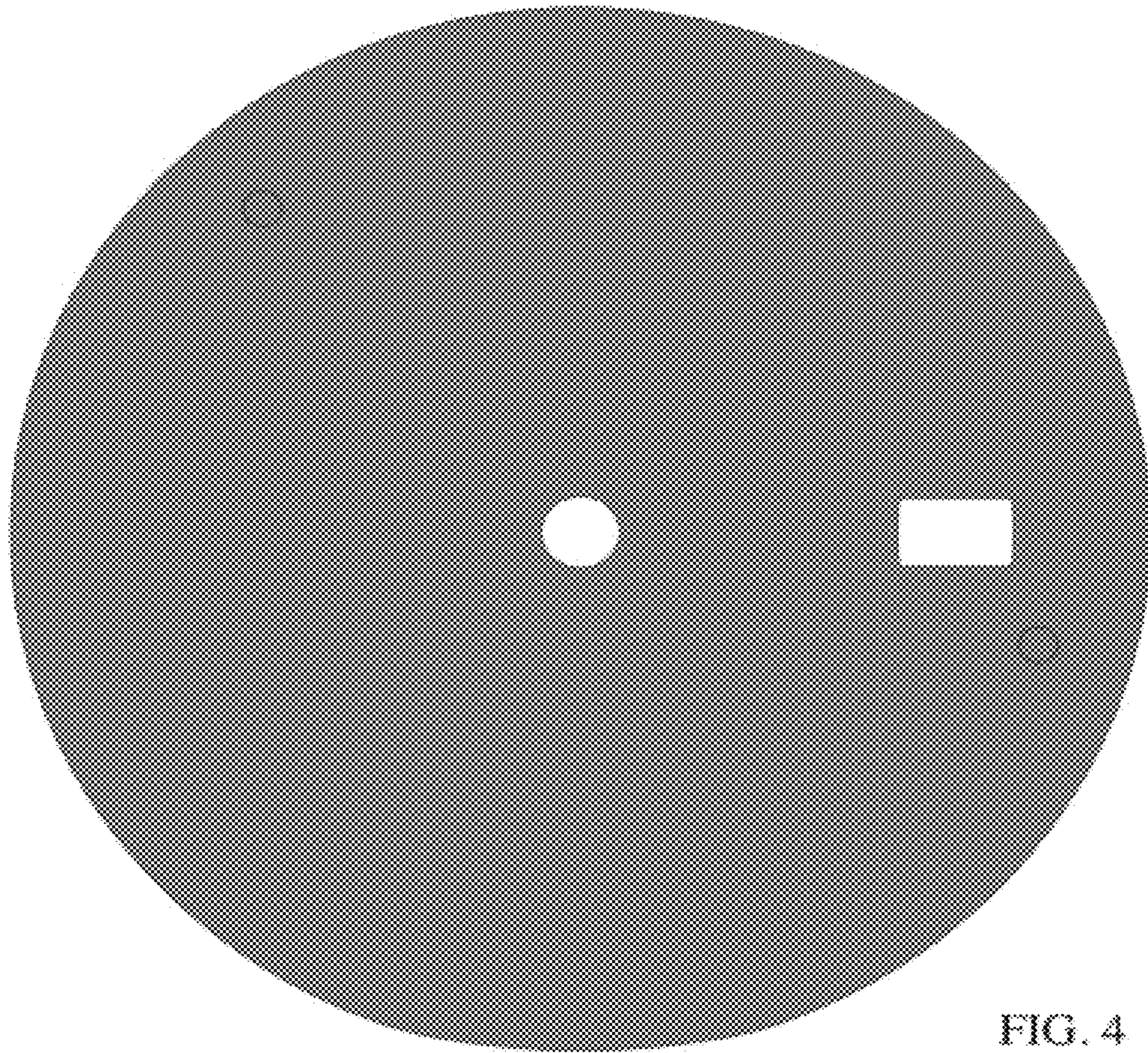

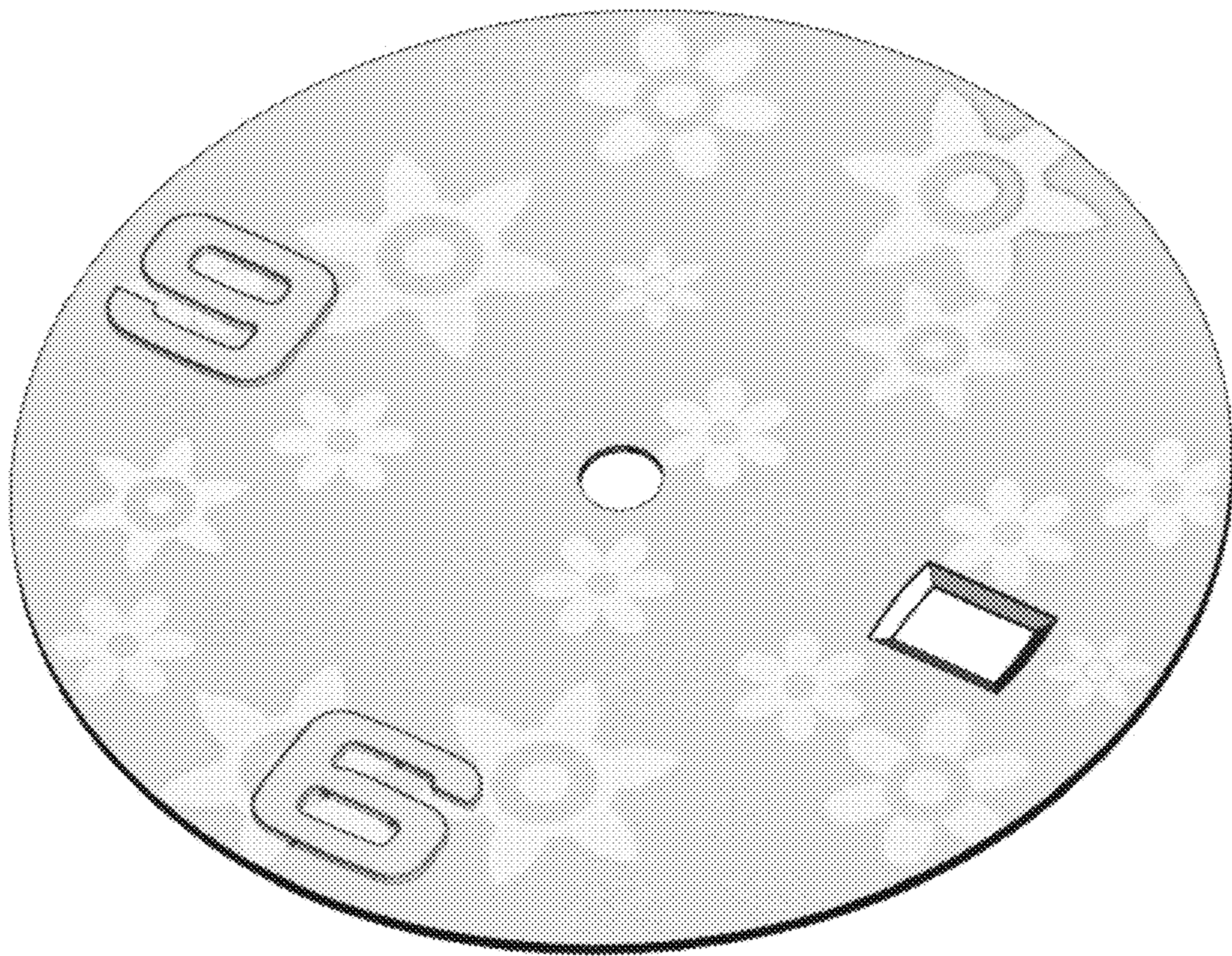
