(57) **CLAIM**

I claim, the ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of an automobile tire, with the sidewall structure removed for clarity of disclosure, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

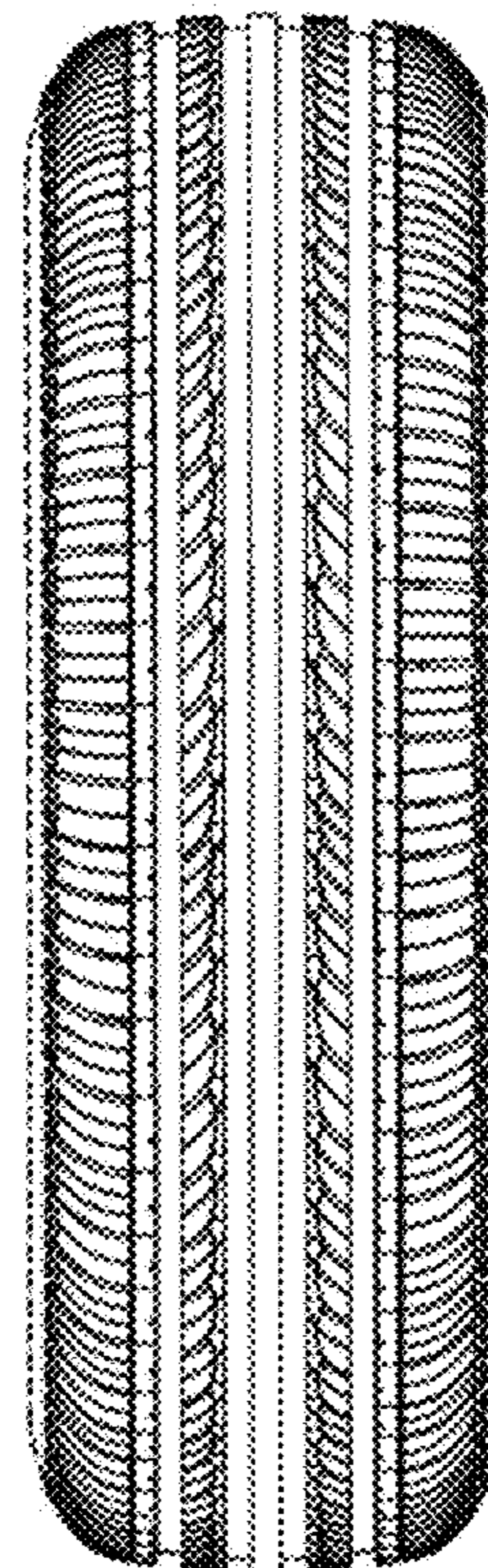
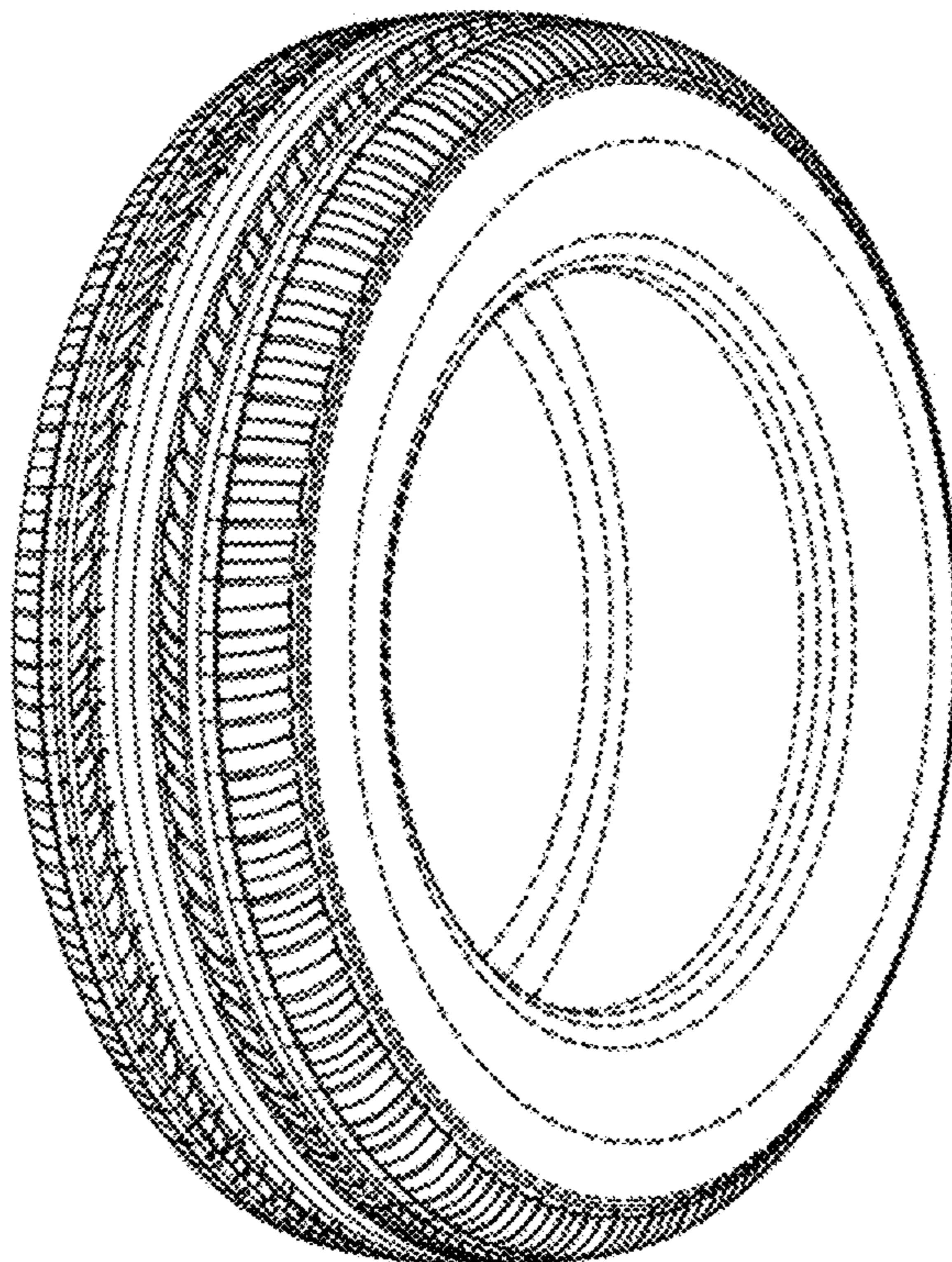

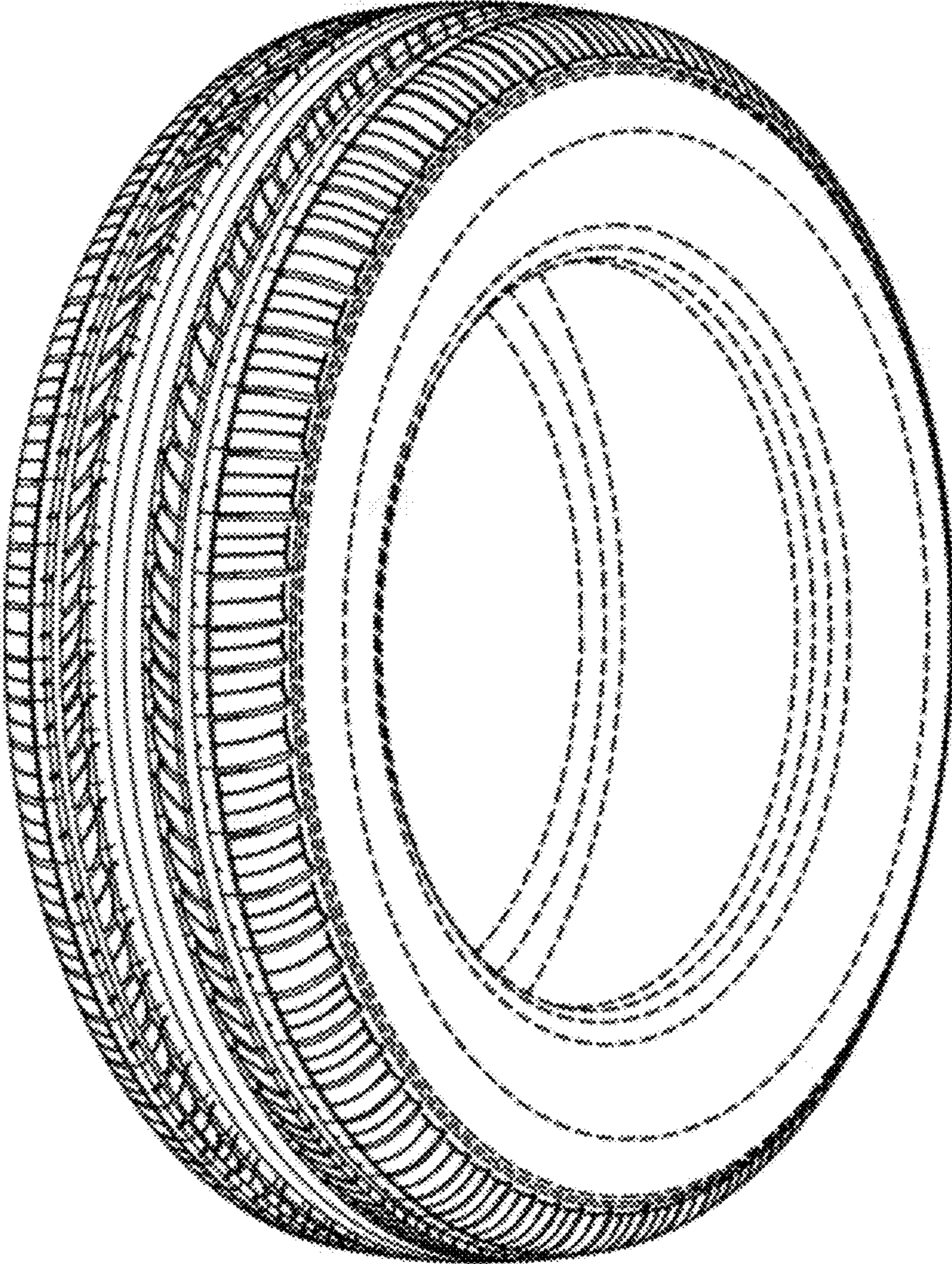

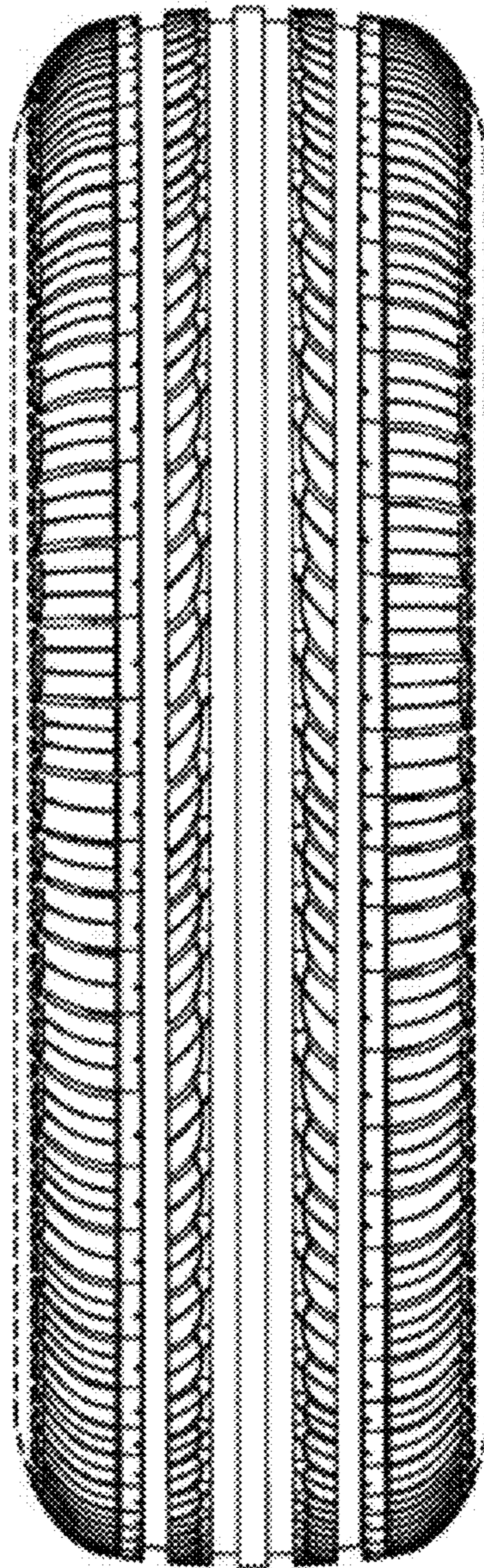

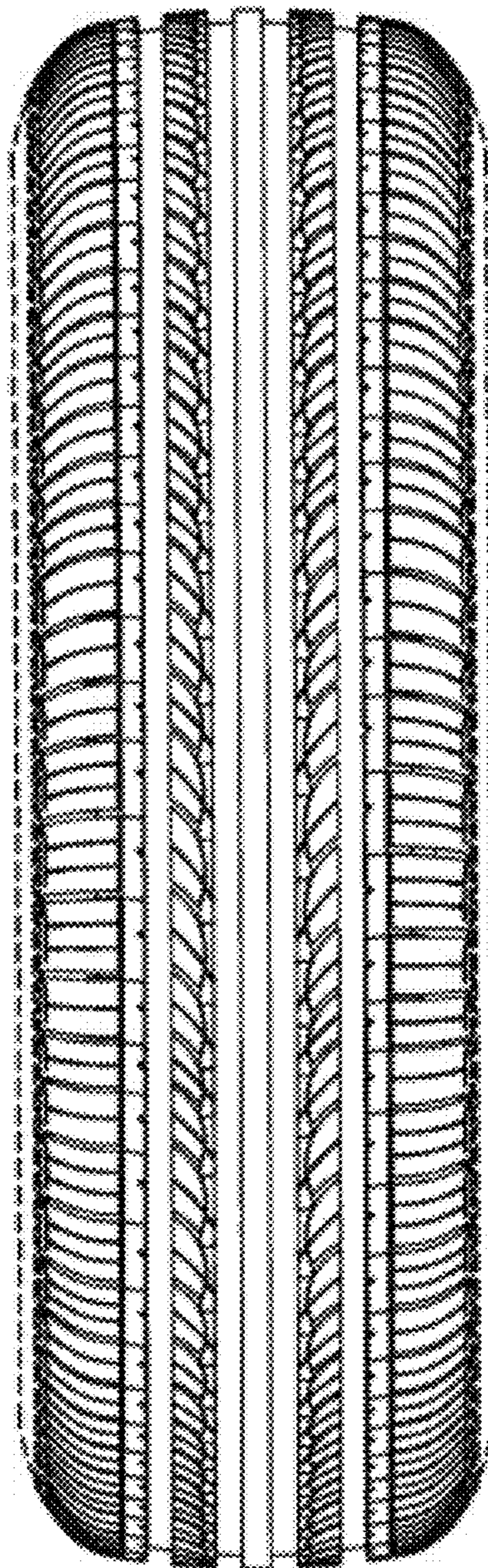

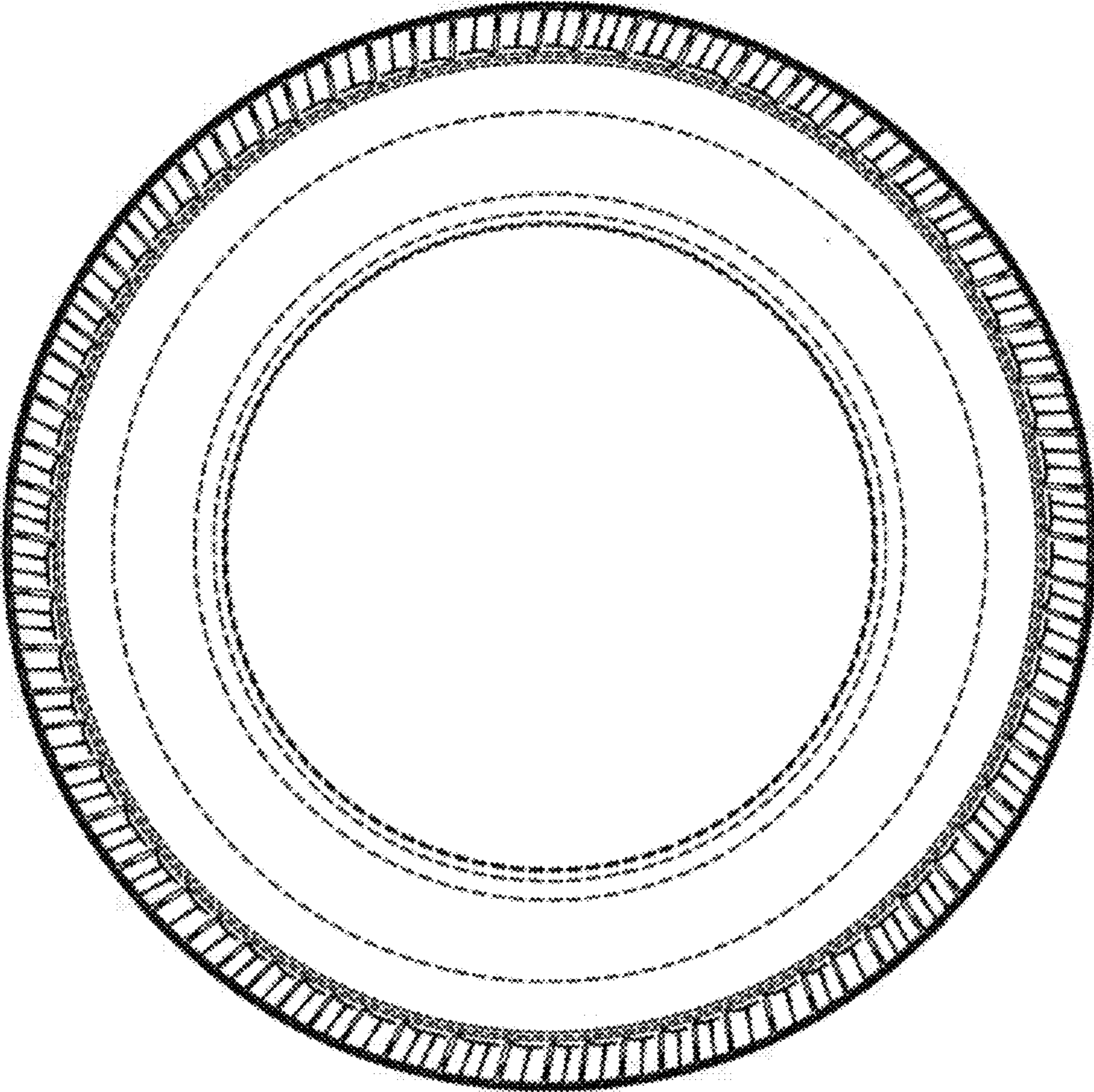

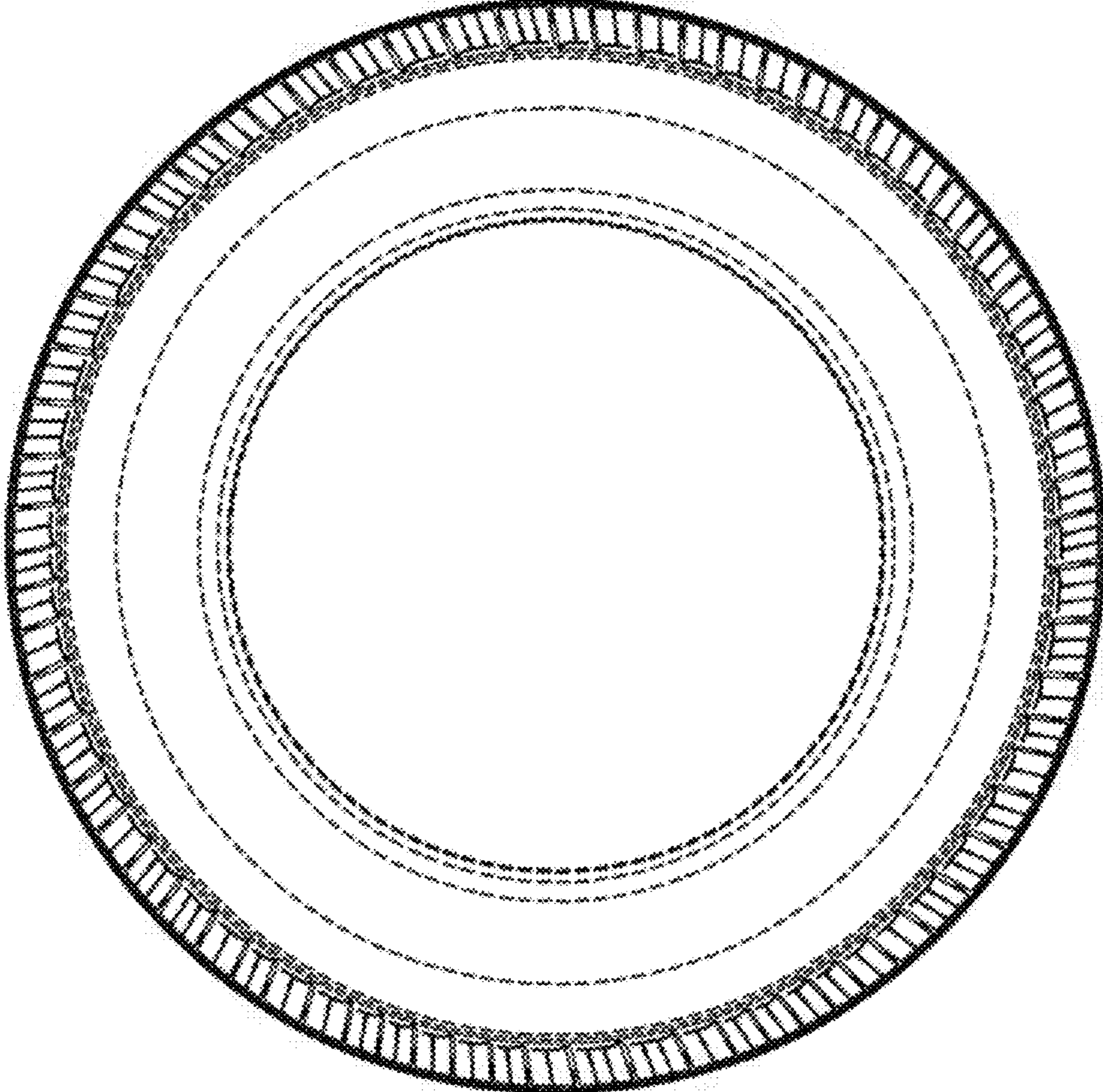

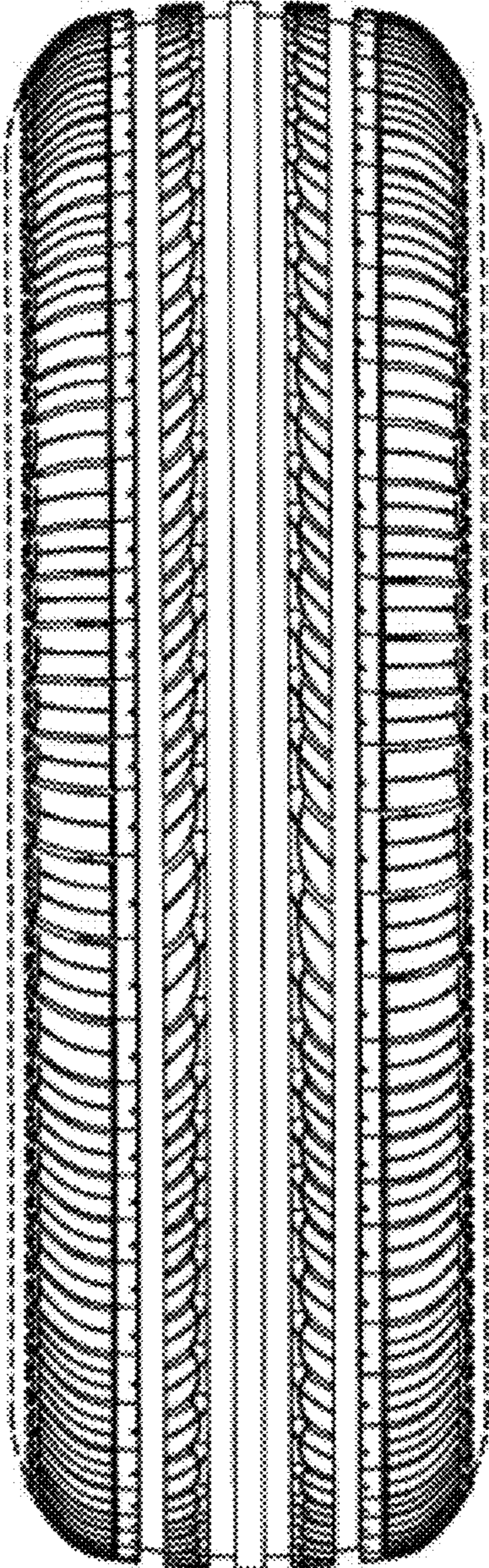
