DESCRIPTION

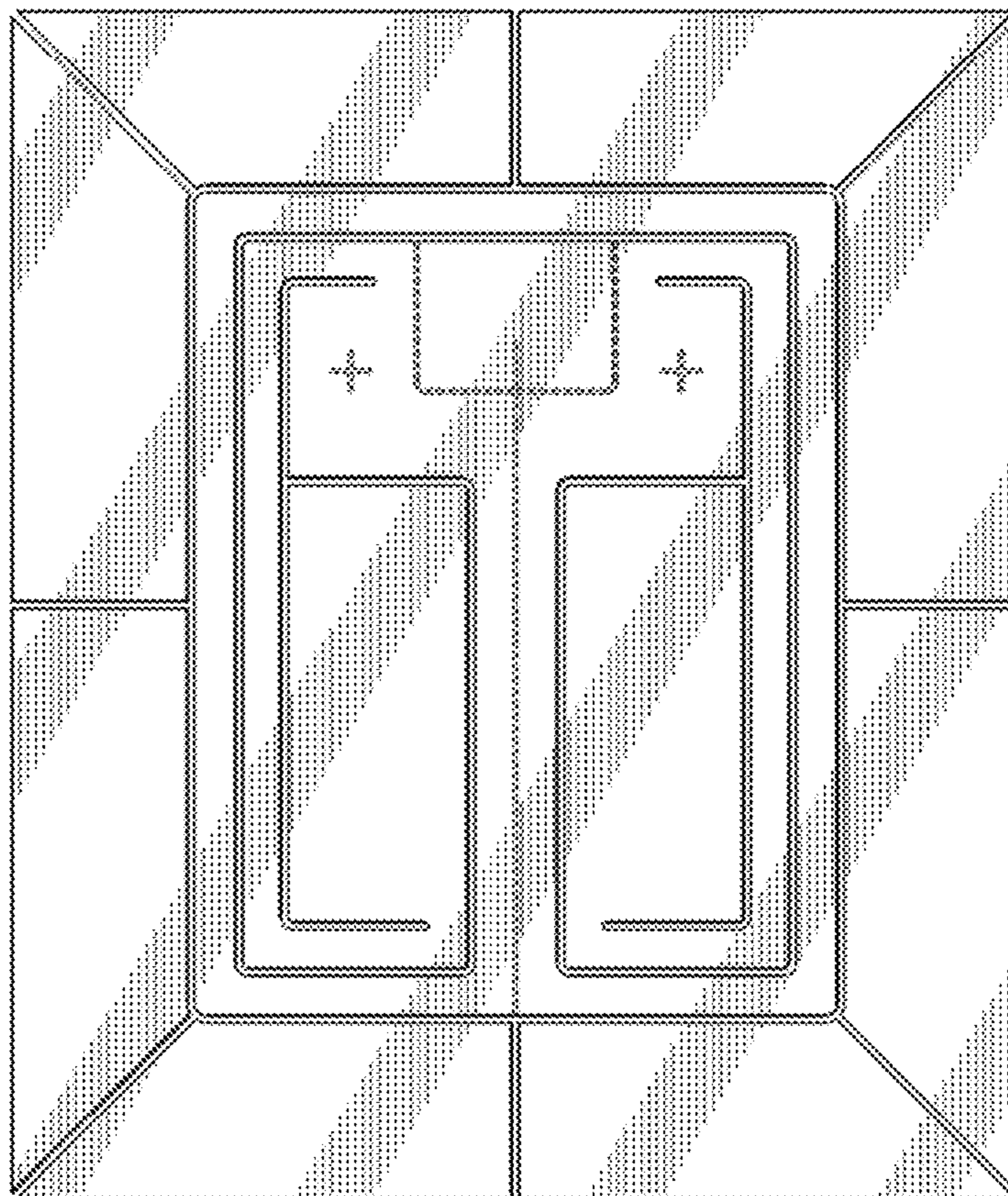
FIG. 1 is an isometric view of an RFID inlay showing my new design;

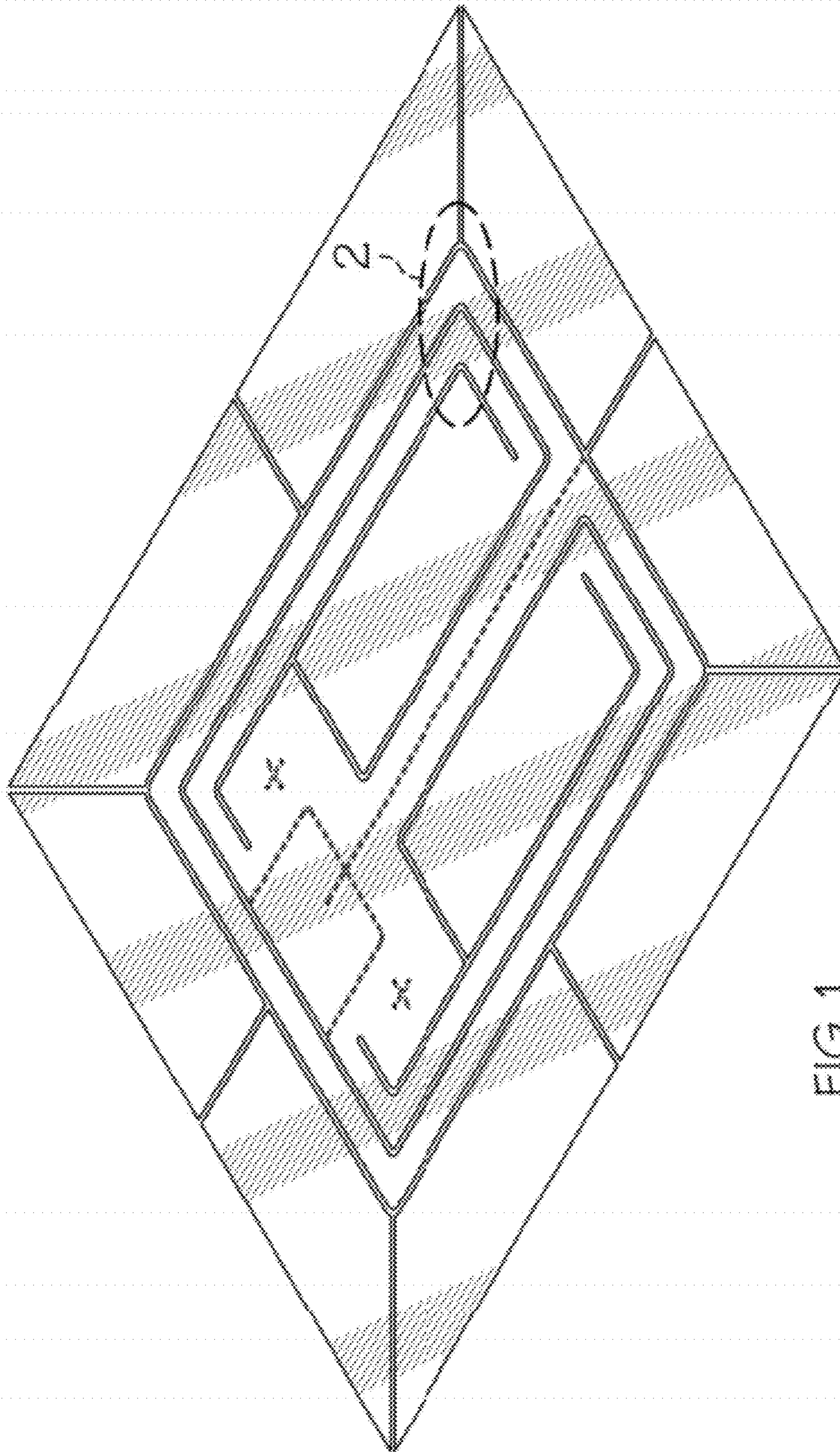

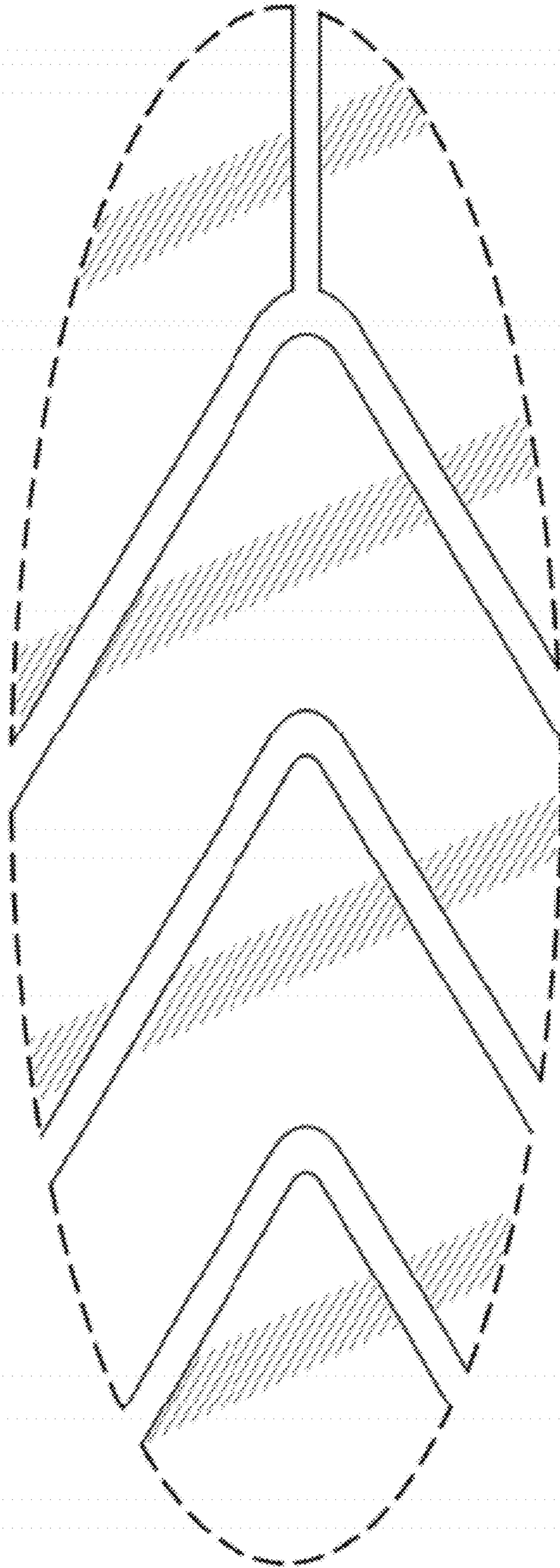

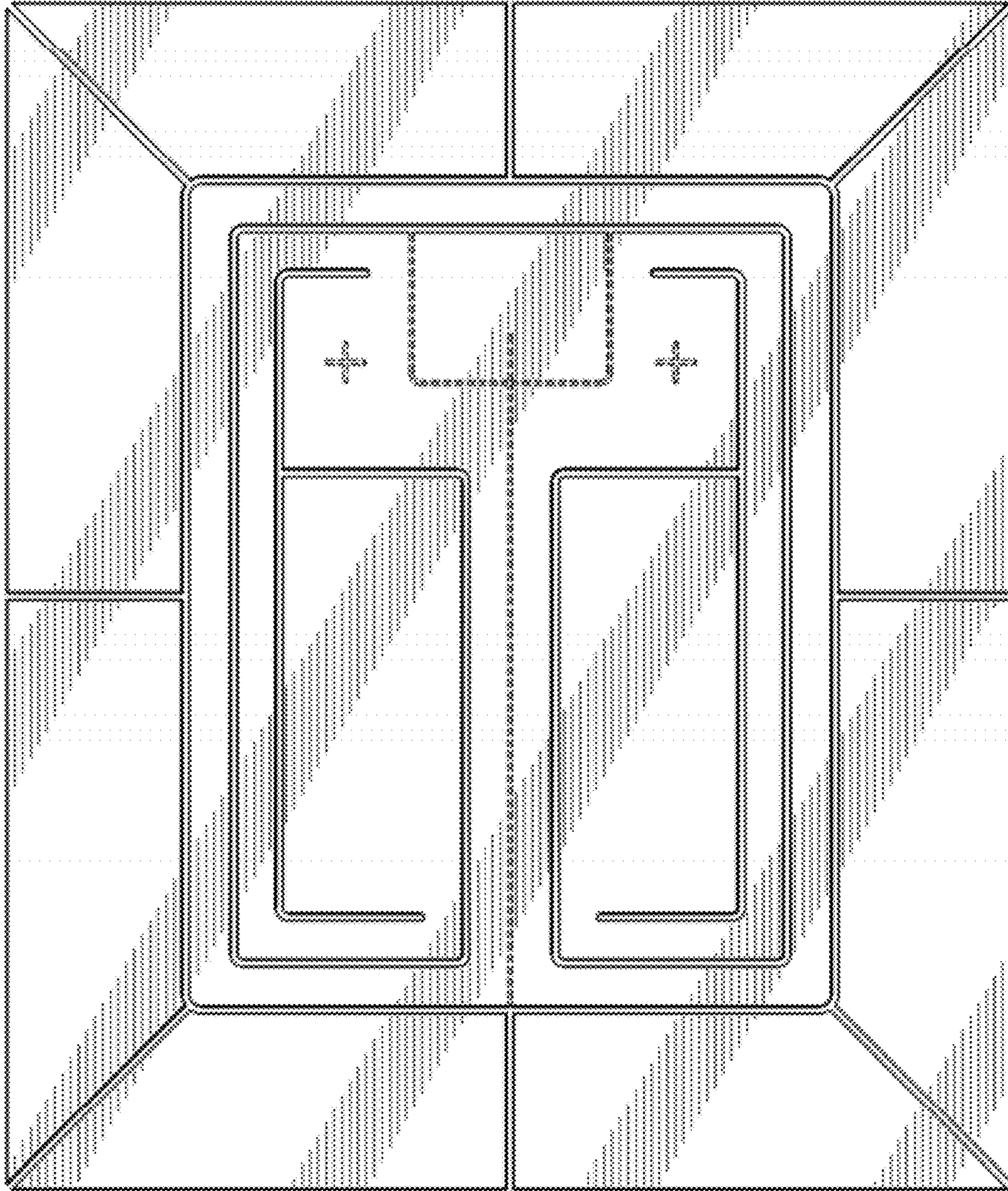
