(57) **CLAIM**

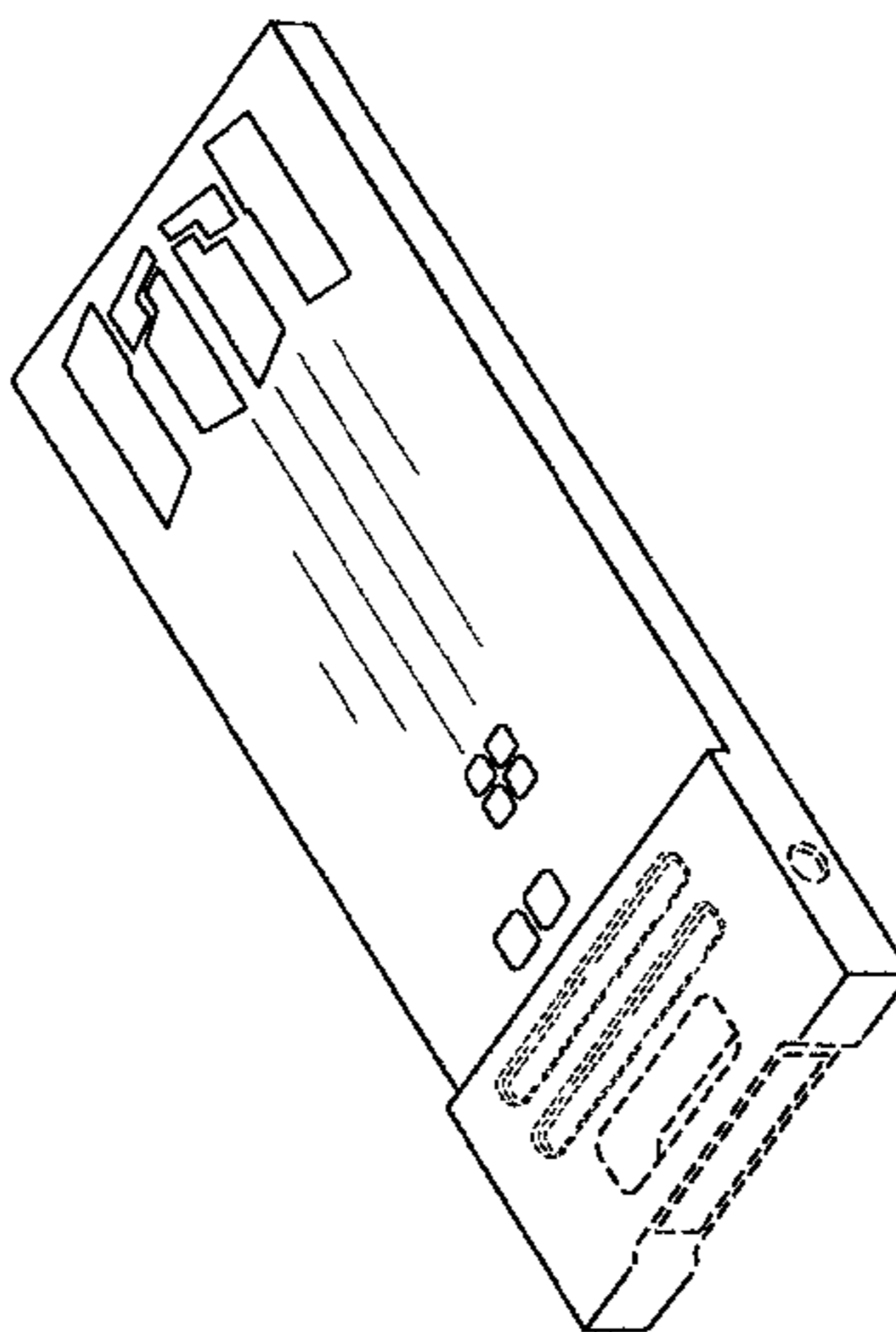
We claim the ornamental design for a digital storage medium, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a digital storage medium showing the new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a side elevational view thereof;
FIG. 6 is another side elevational view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.

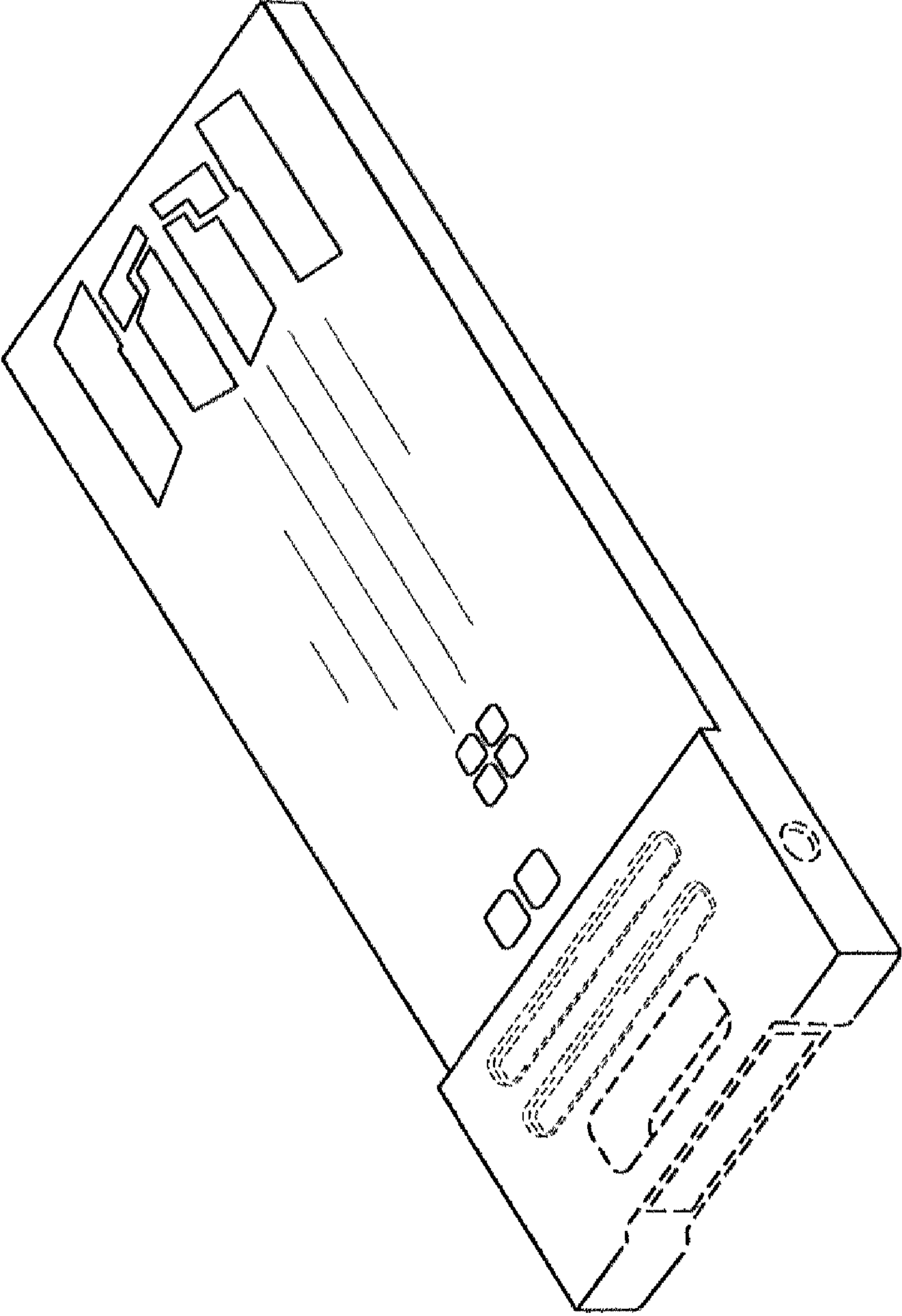

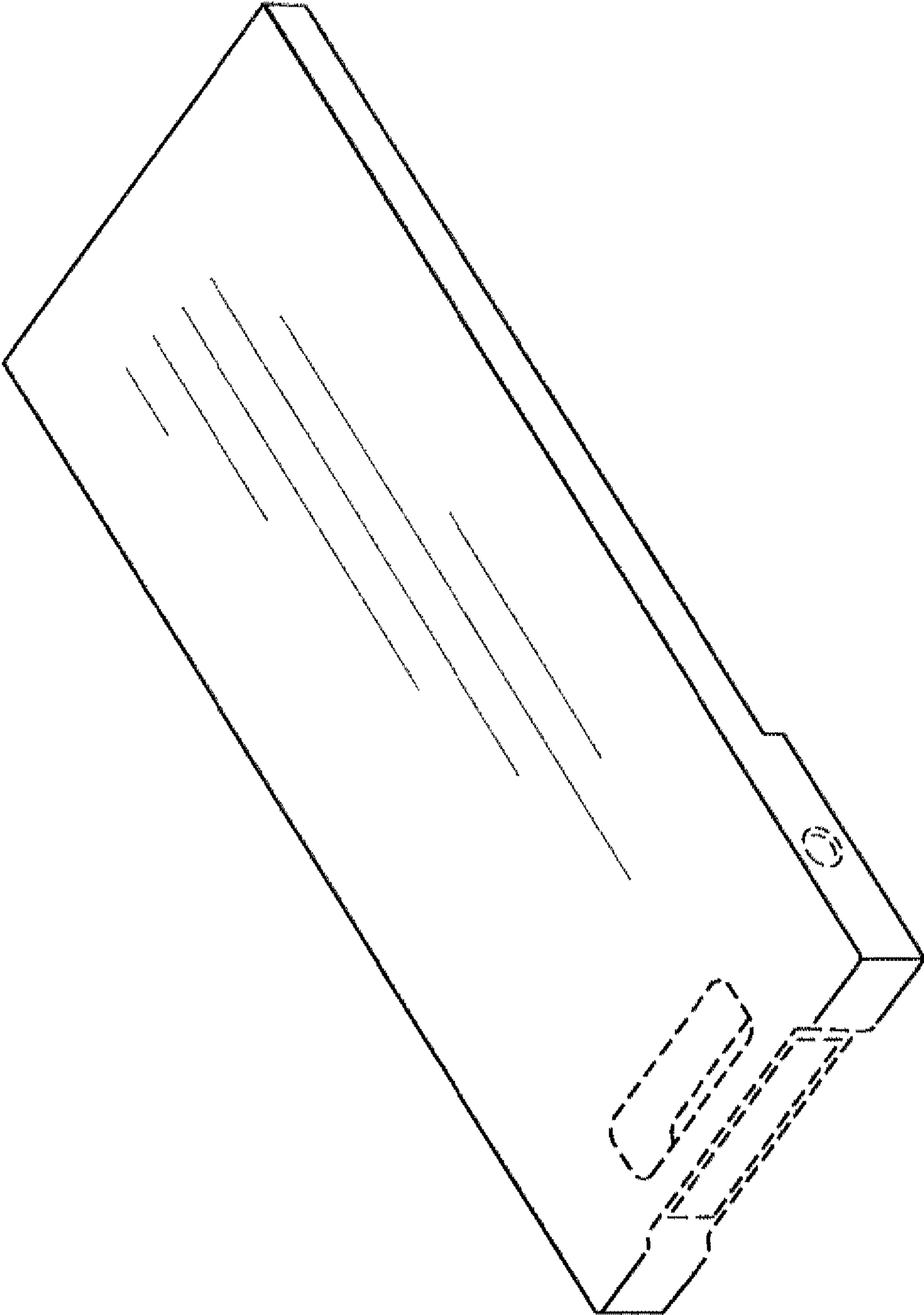

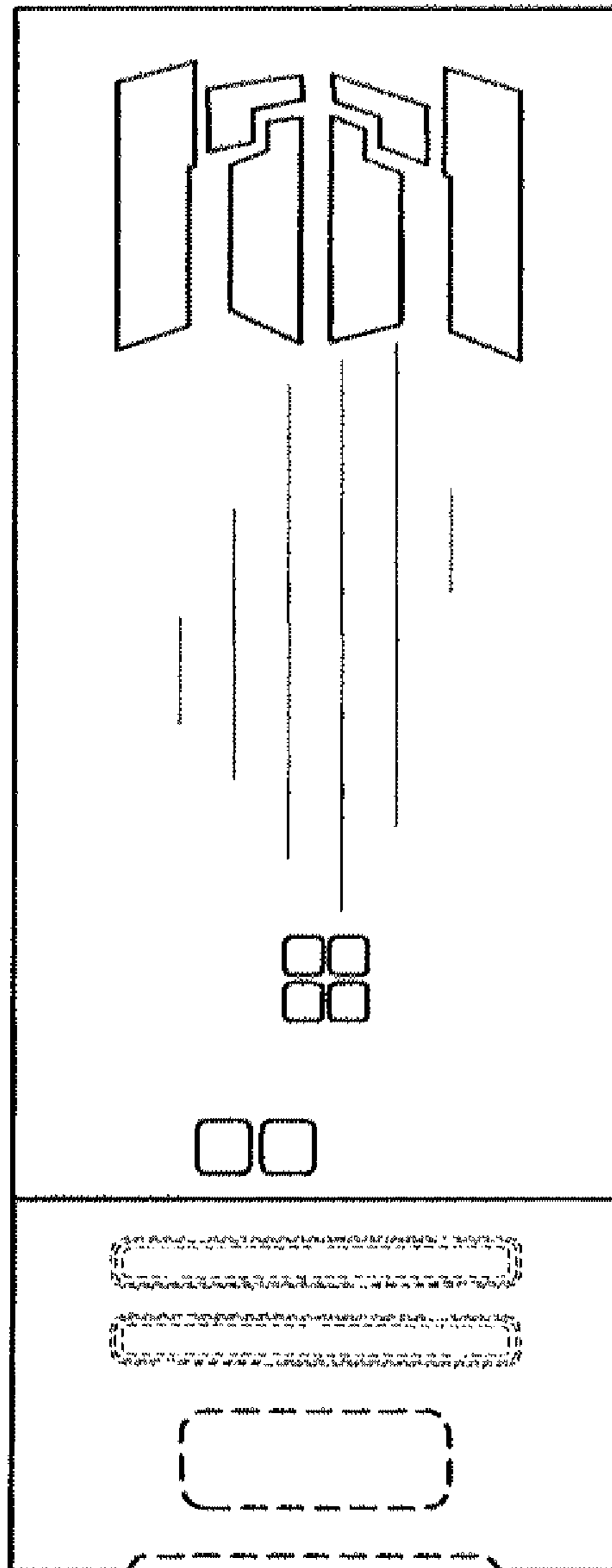

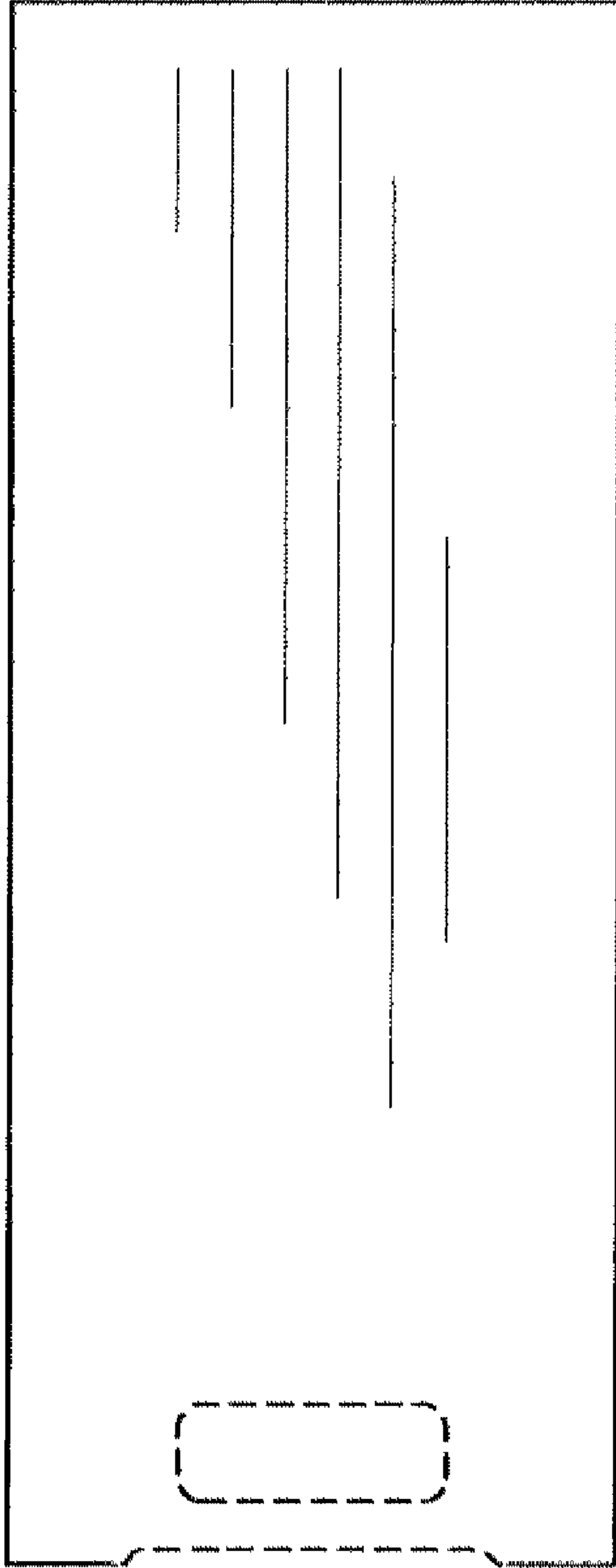
