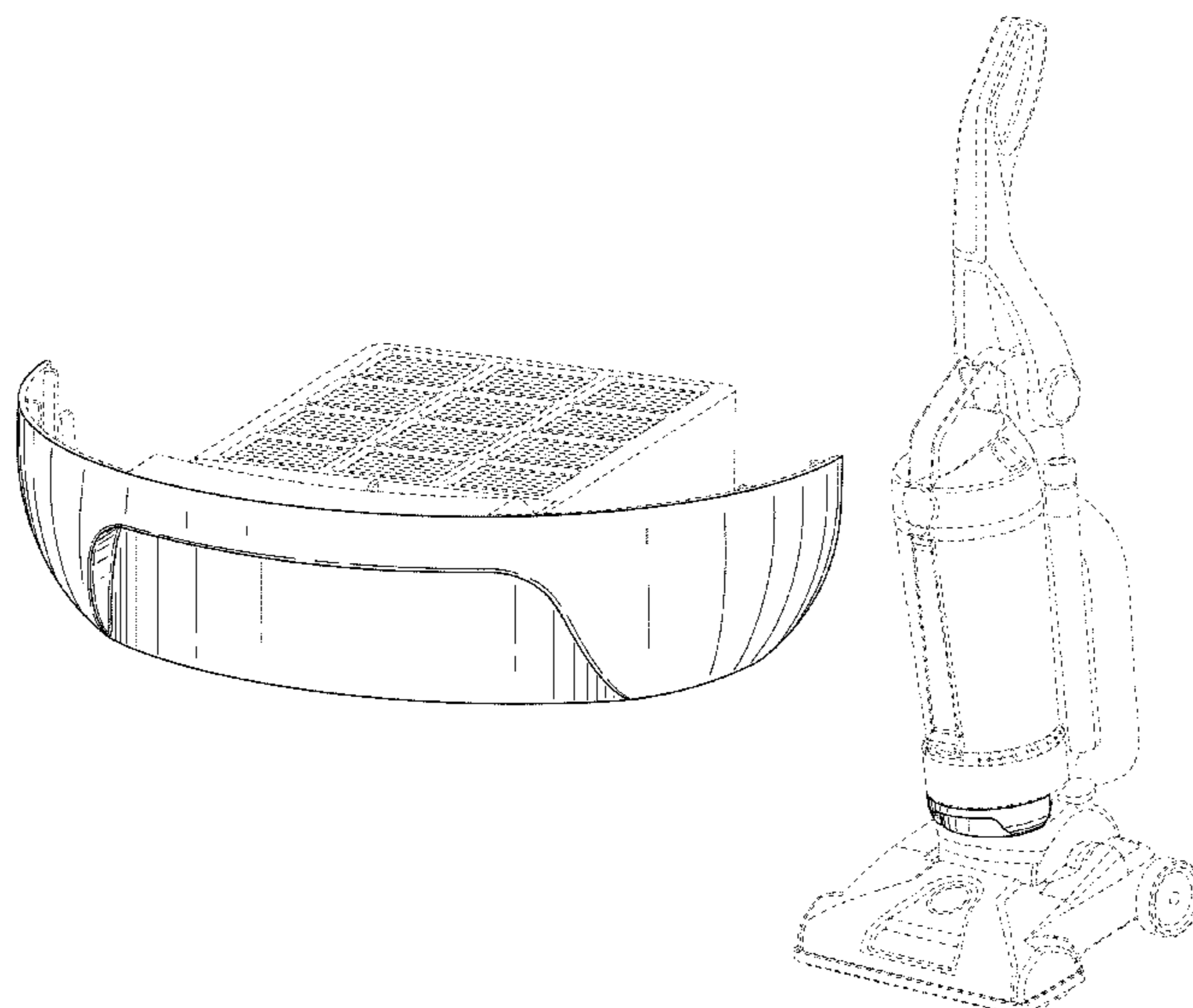
(57) **CLAIM**

I claim the ornamental design for a filter housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a filter housing showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof; and,
FIG. 8 is a perspective view thereof, shown in a position of use on a vacuum cleaner.

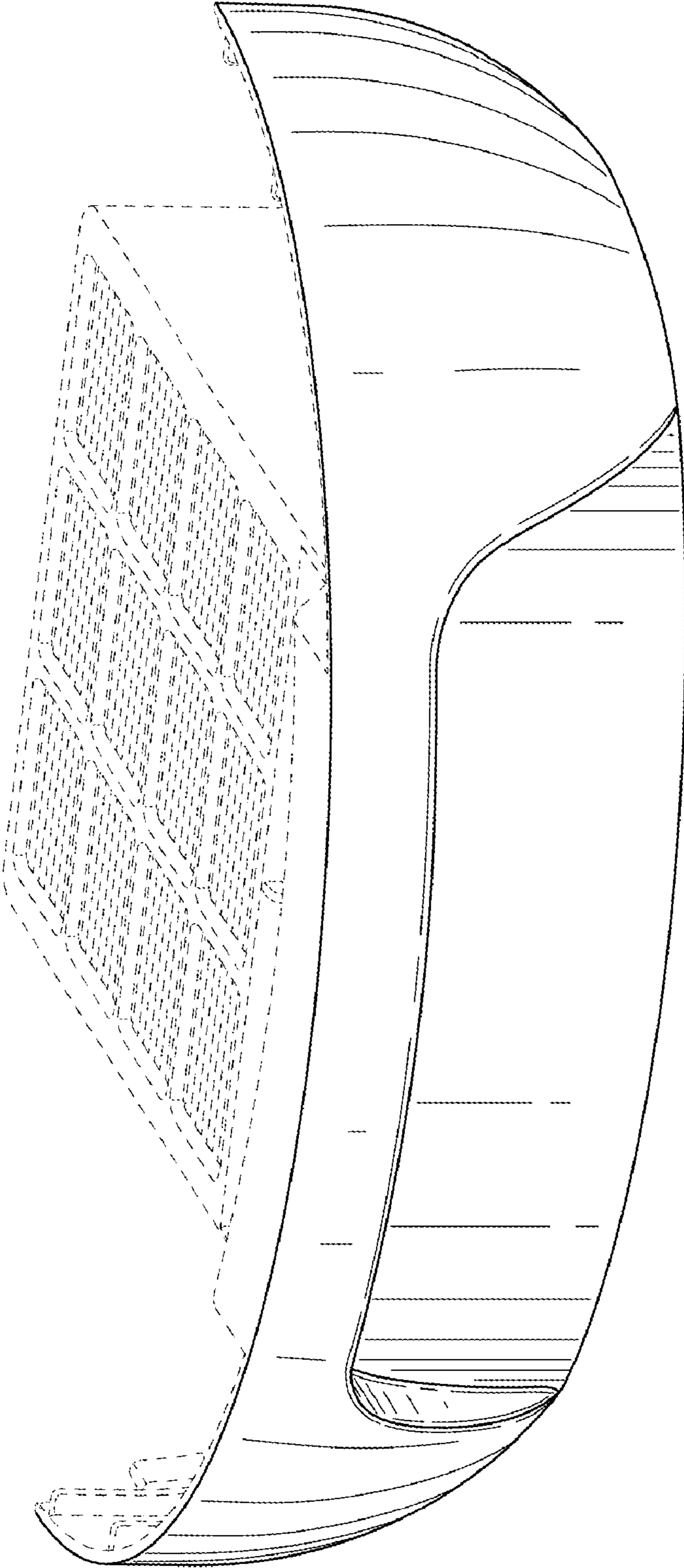

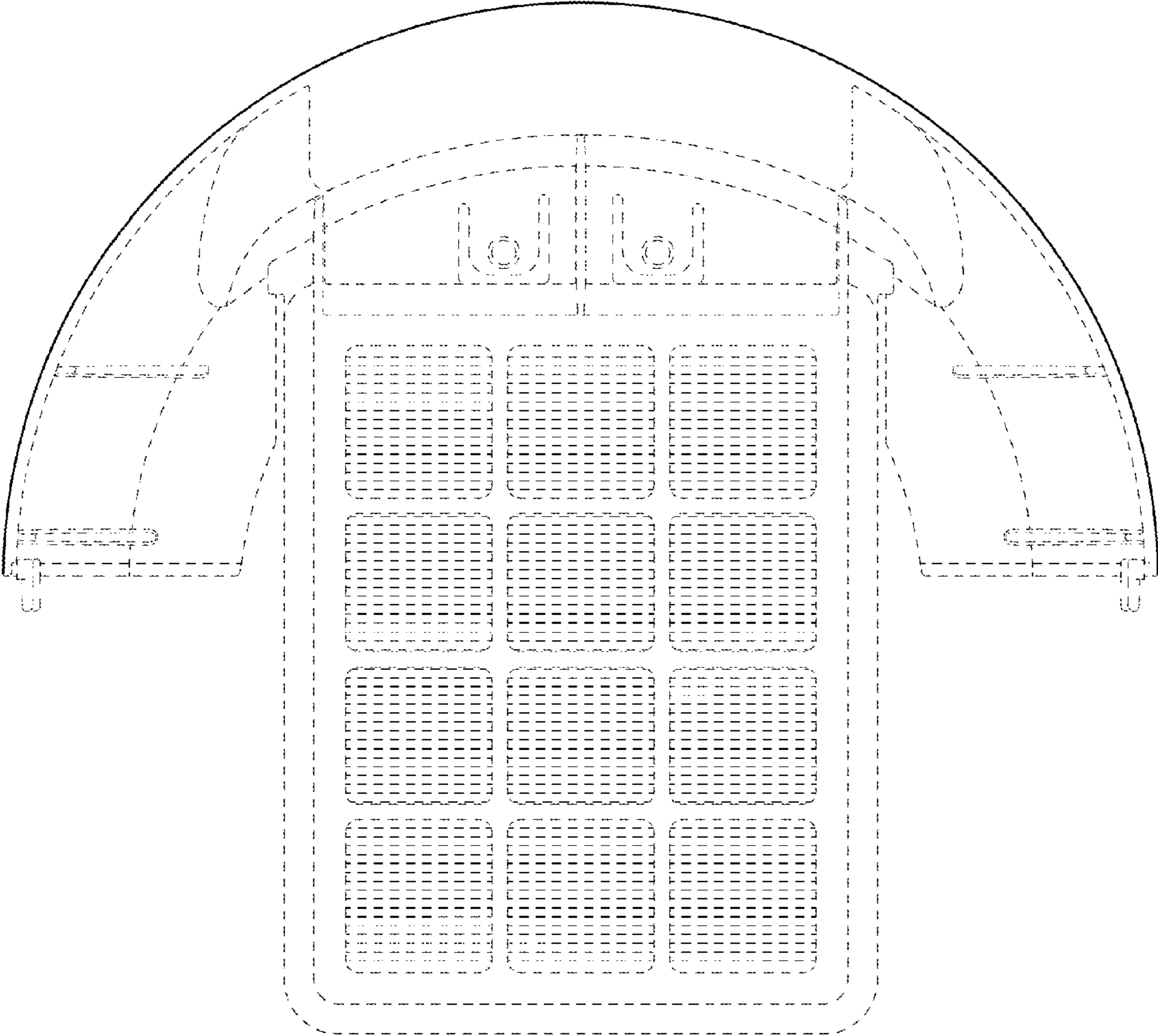

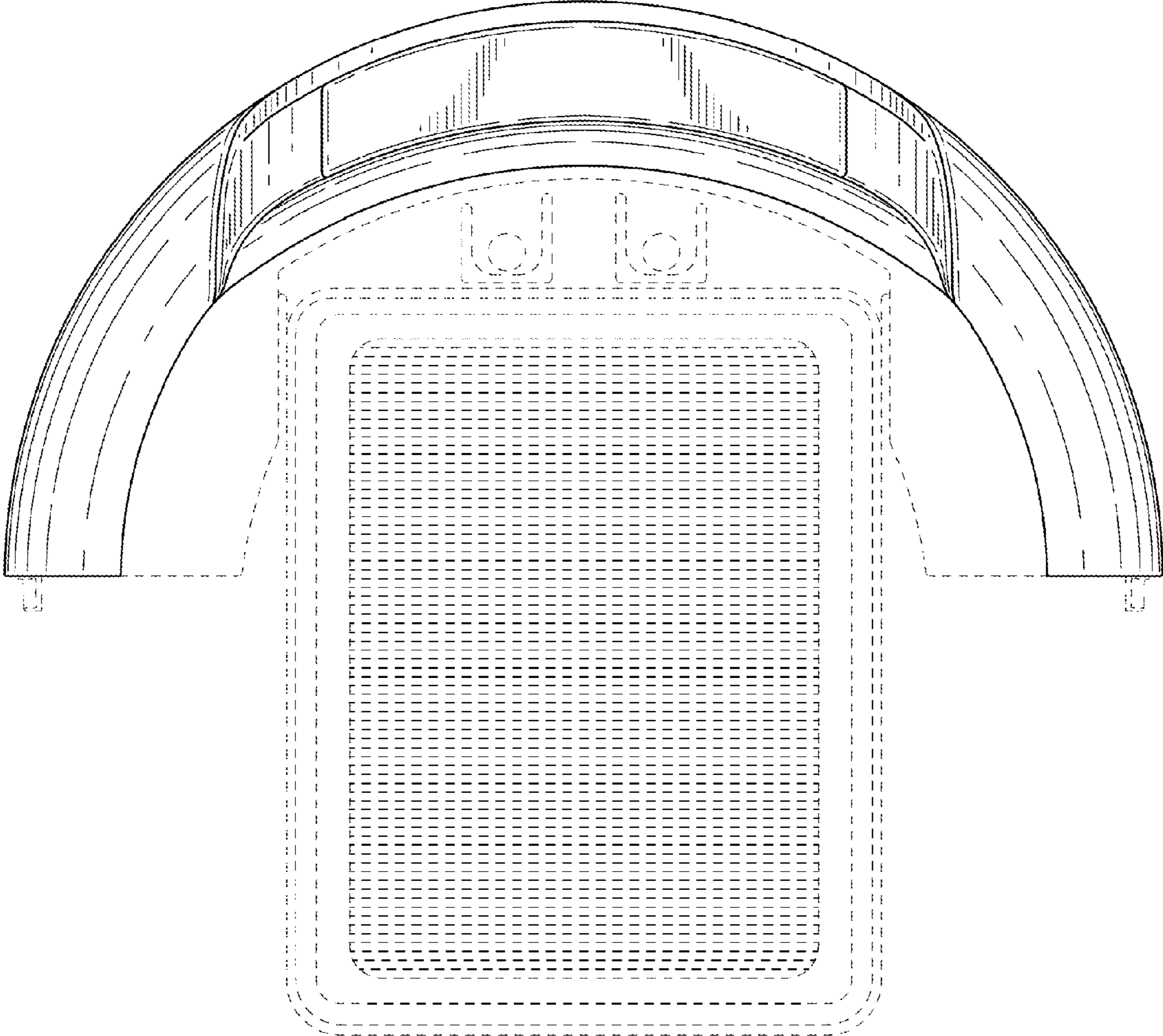

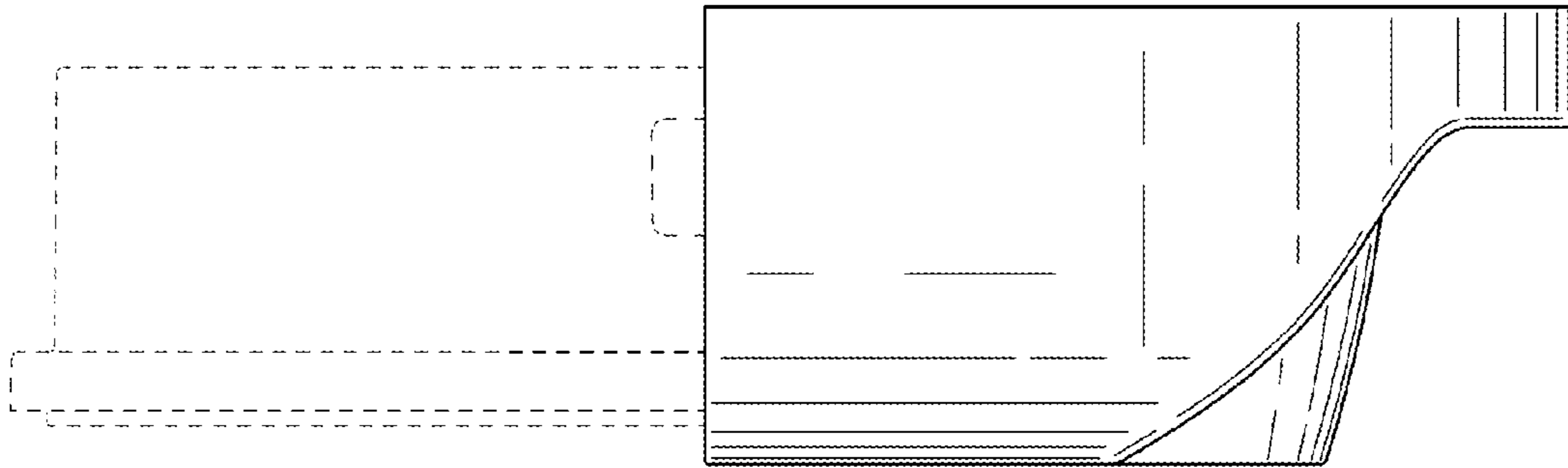

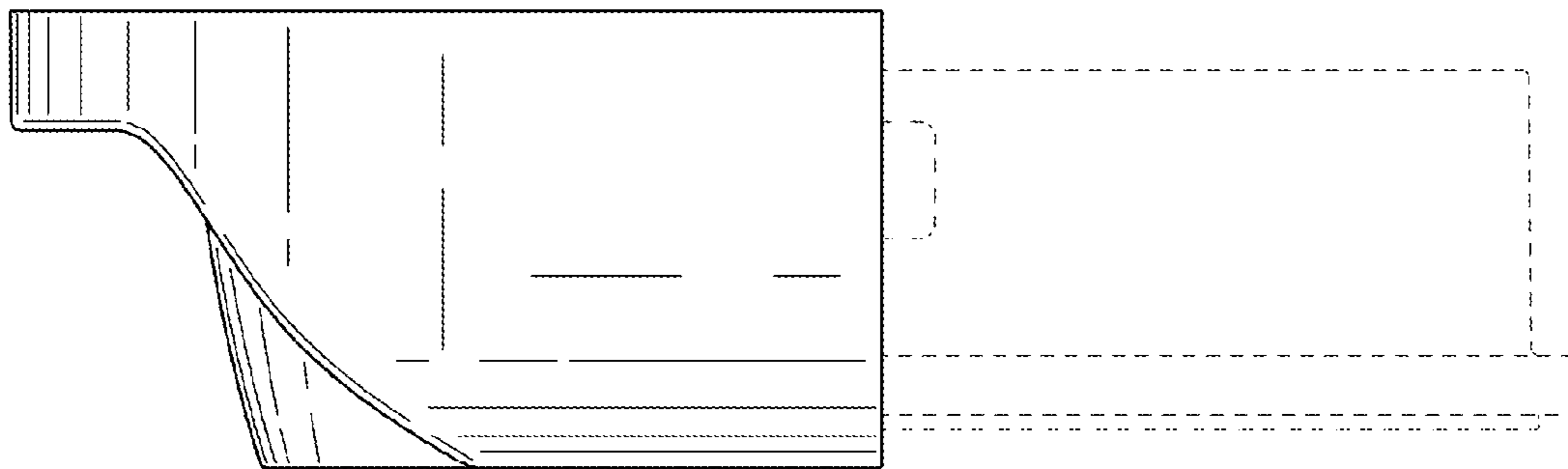

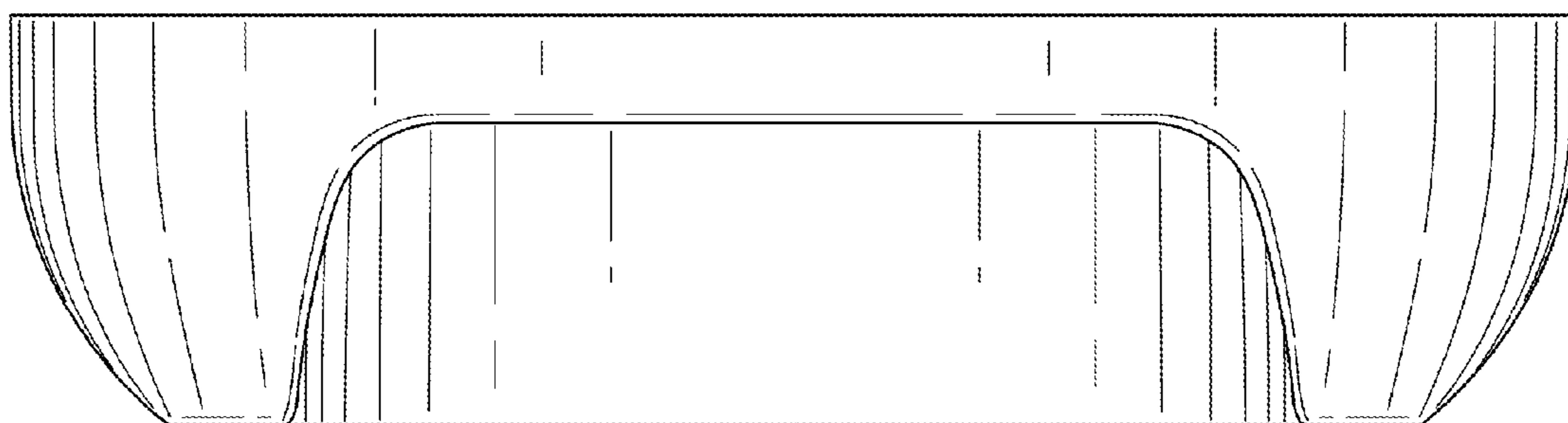

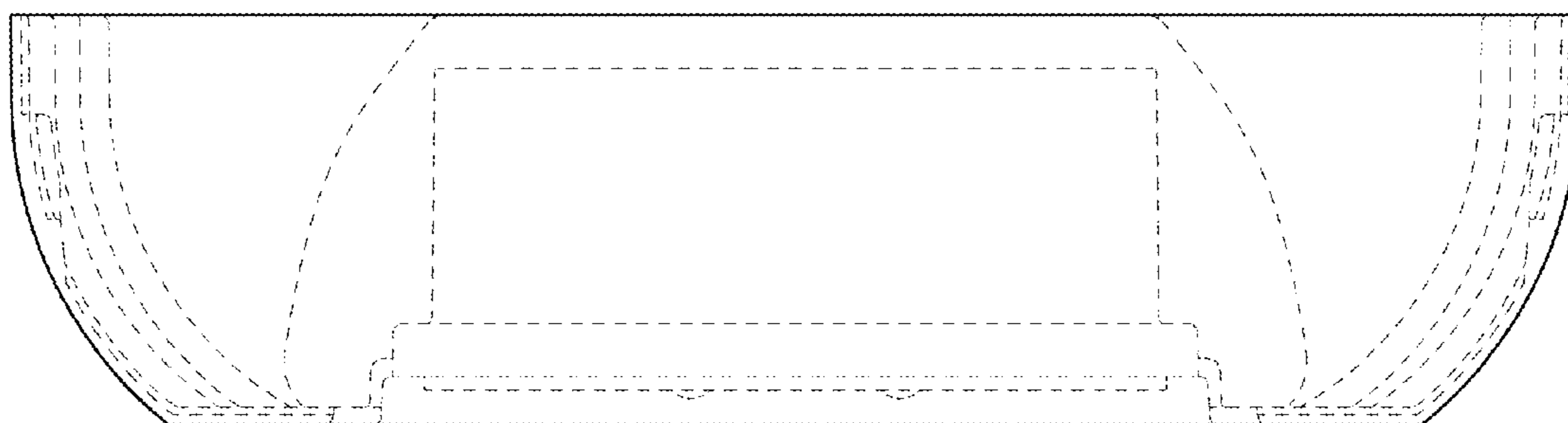

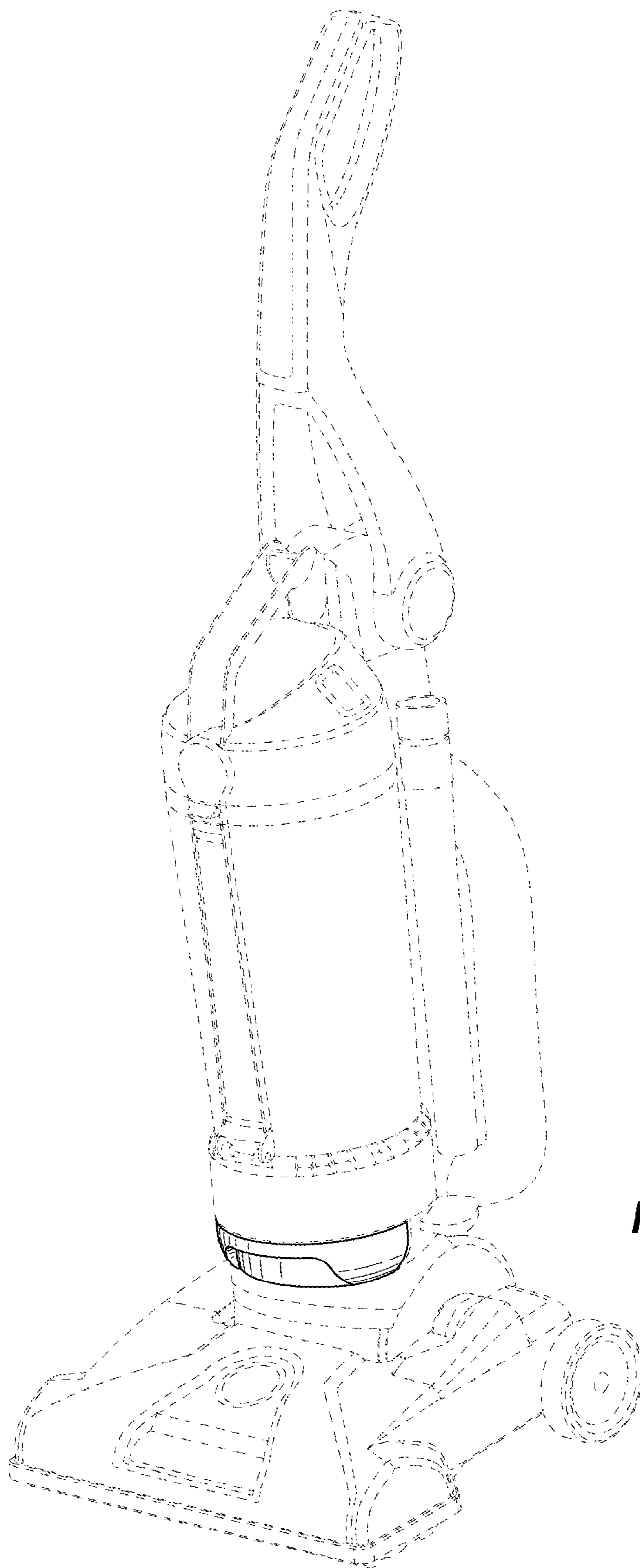
