(57) **CLAIM**

The ornamental design for a backless strapless bra with side extensions, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a backless strapless bra with side extensions showing our new design. The broken lines showing portions of a human form are to show the design as it would appear when worn; the broken-line subject matter forms no part of the claim;

FIG. 2 is a top plan view of the bra of FIG. 1;

FIG. 3 is a front elevational view of the bra of FIG. 1;

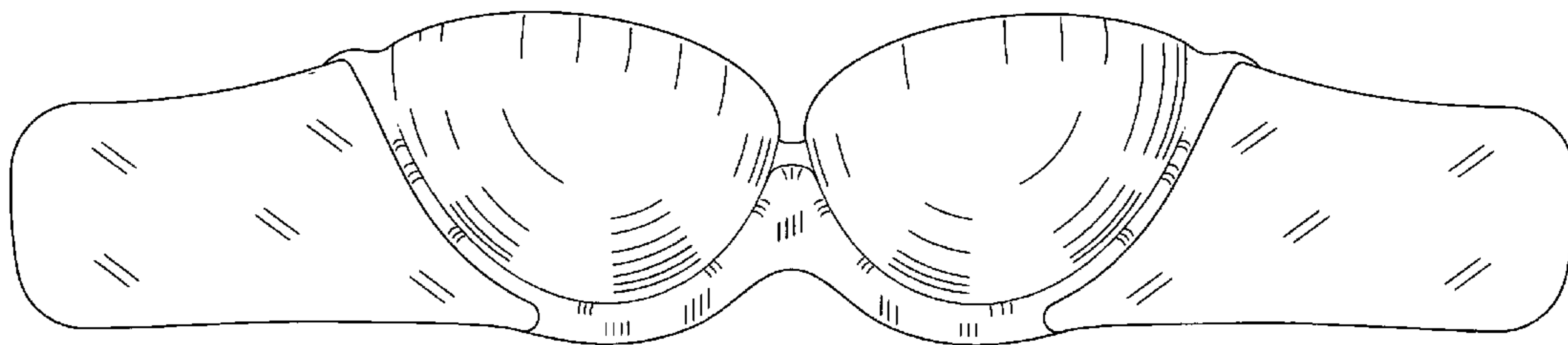
FIG. 4 is a left side elevational view of the bra of FIG. 1;

FIG. 5 is a rear elevational view of the bra of FIG. 1;

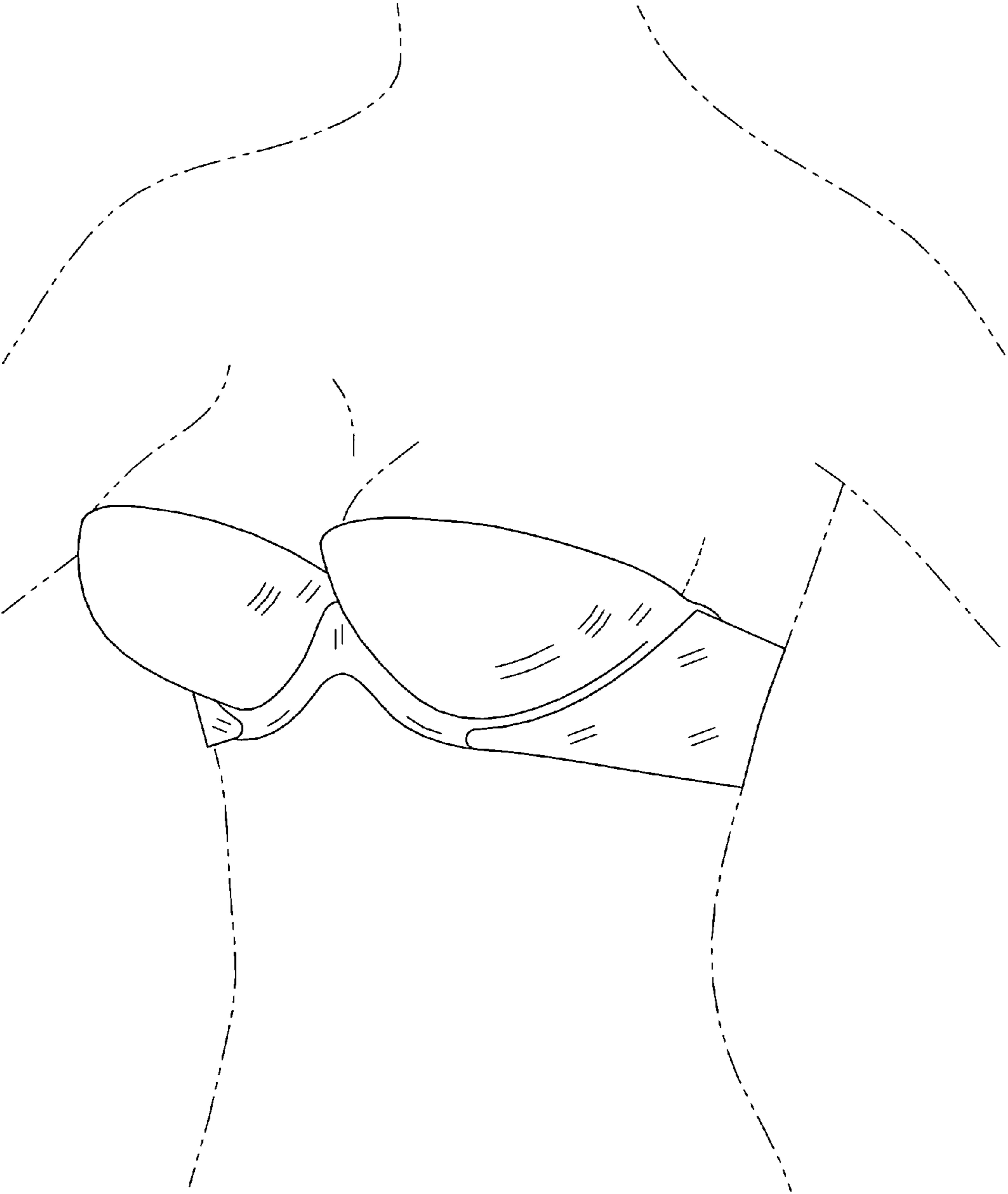

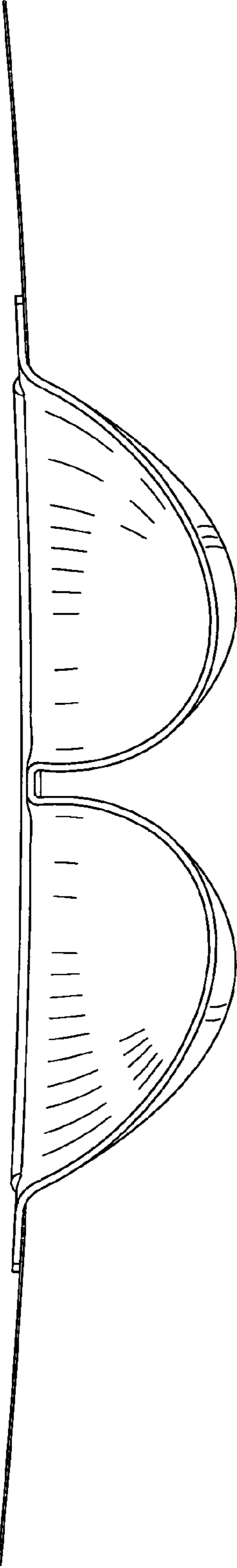

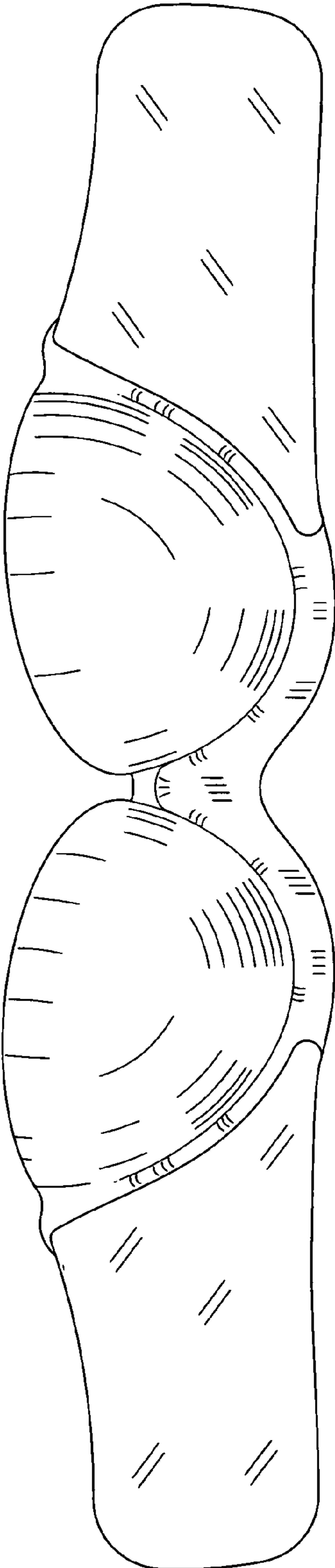

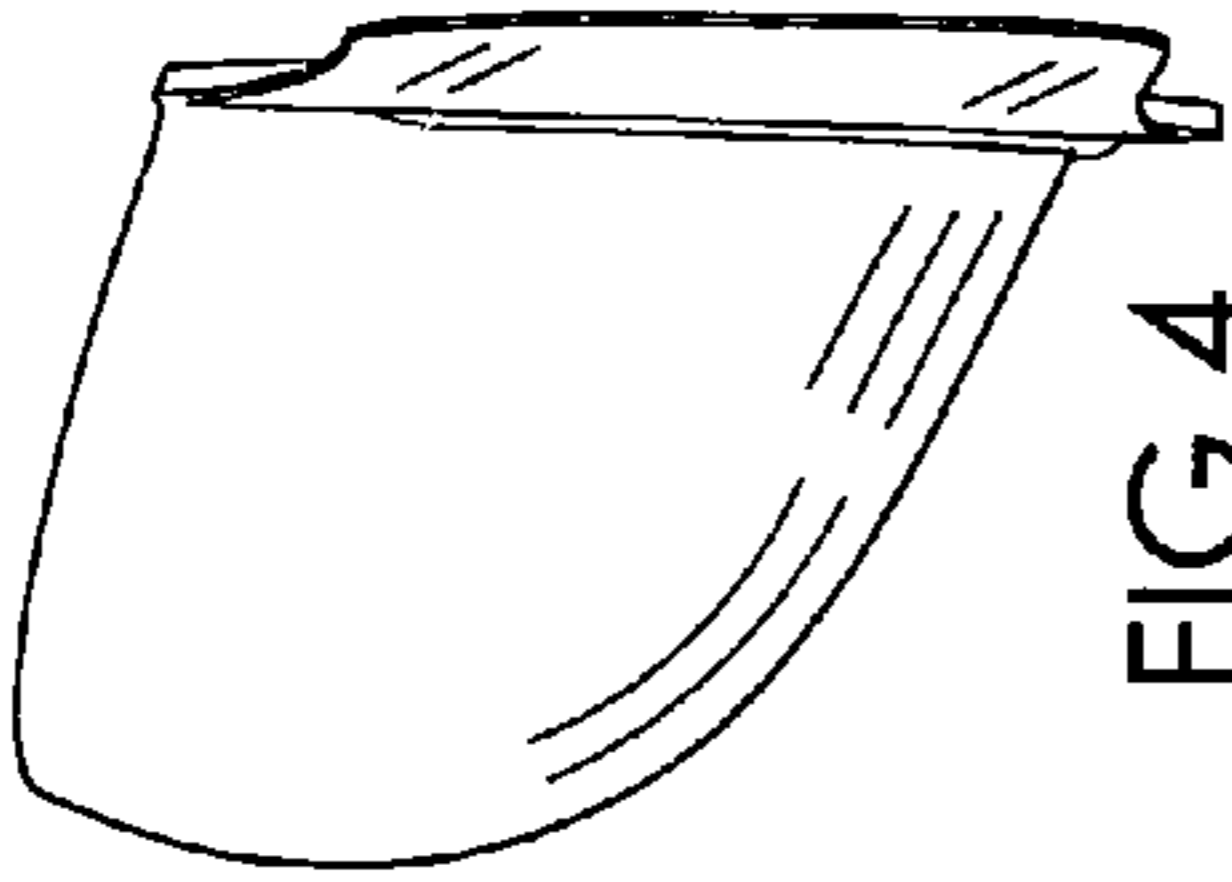

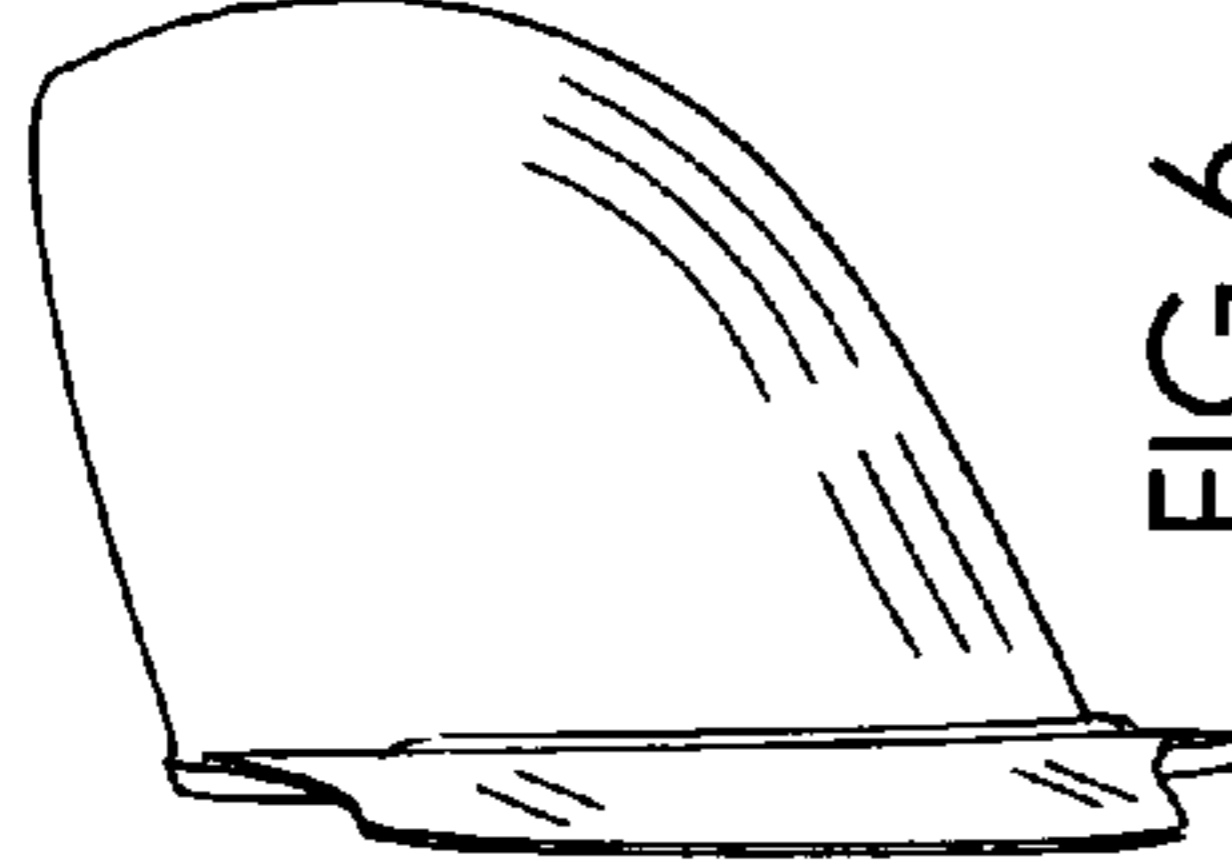

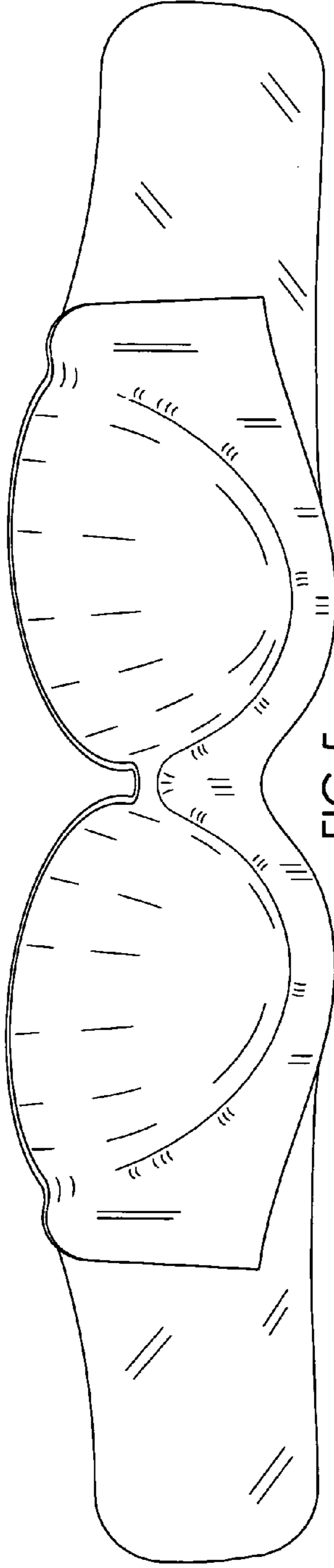

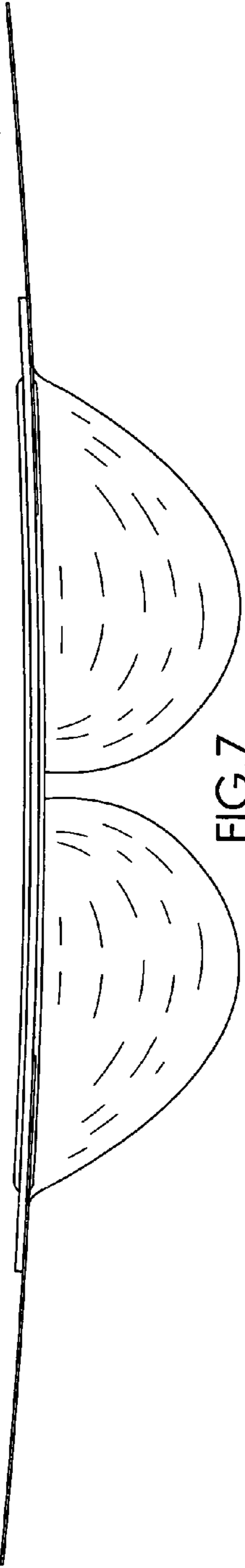
