FIG. 4 is an opposite side elevational view thereof;

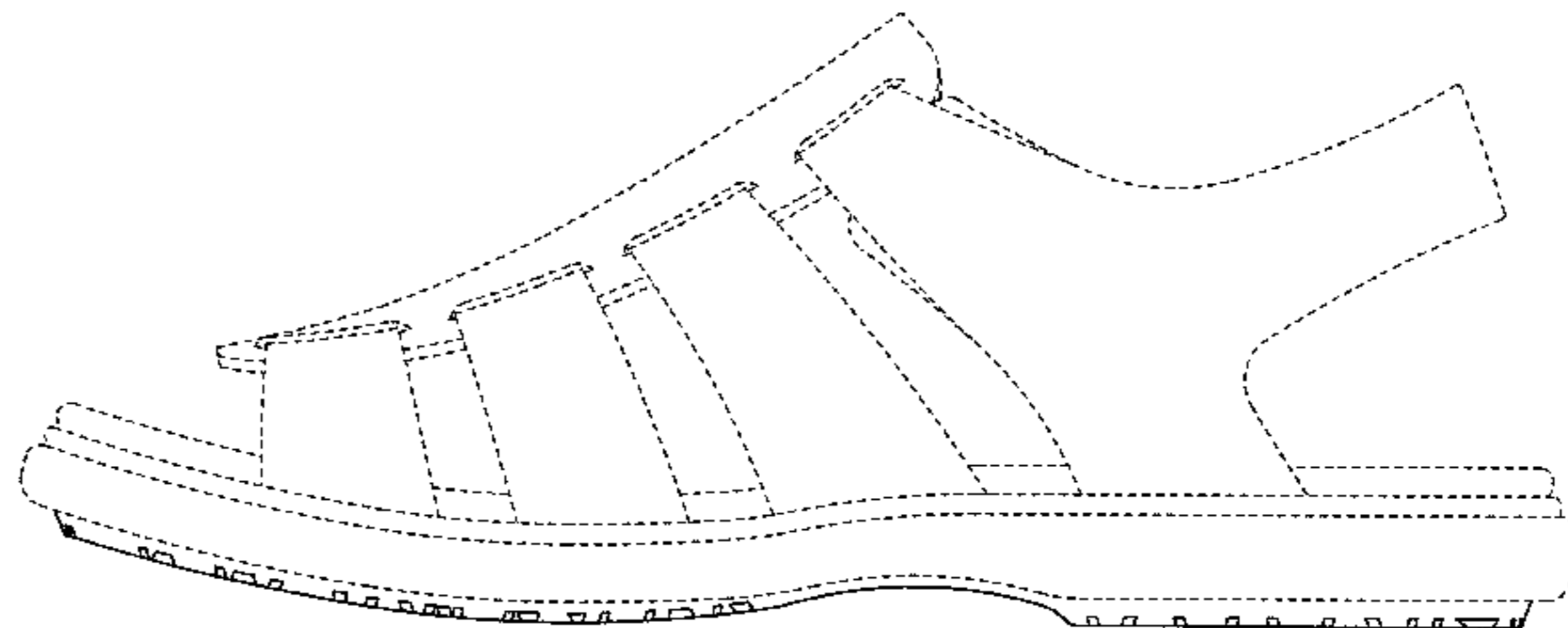
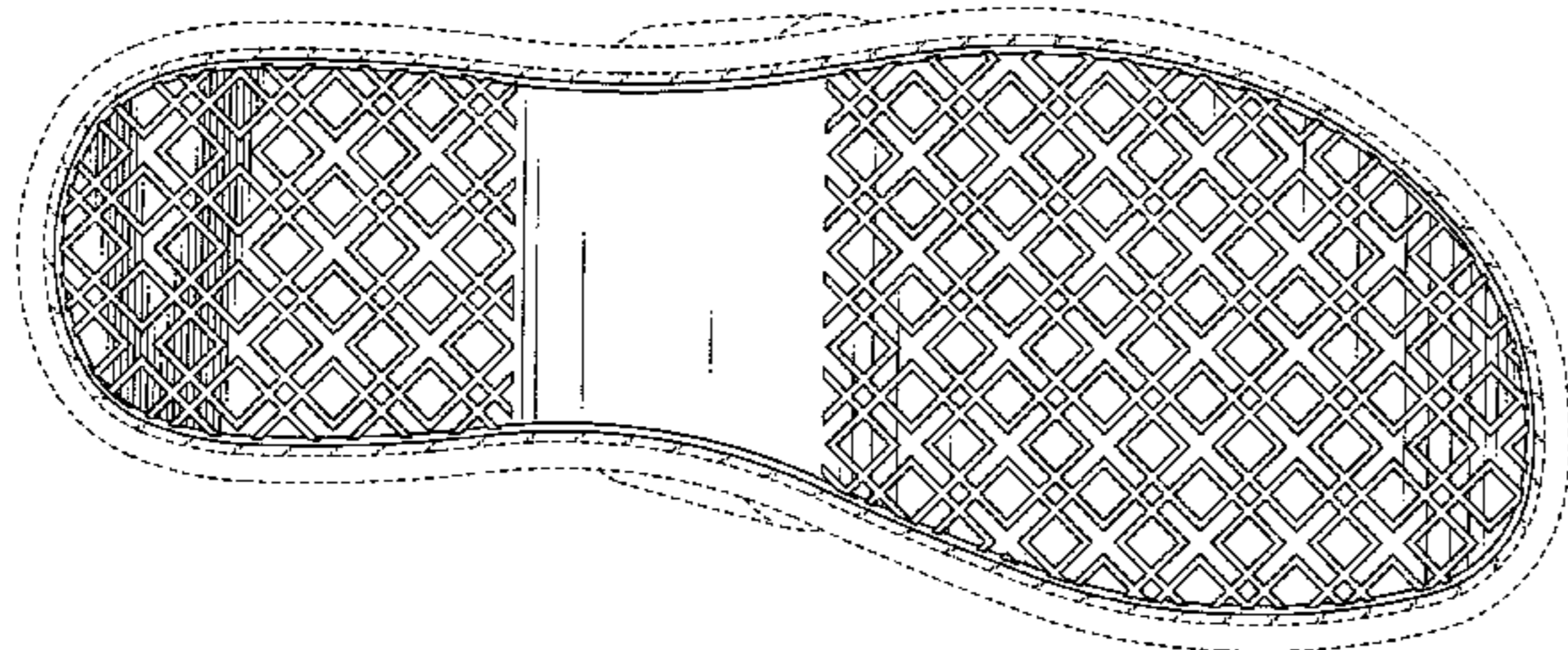
FIG. 5 is a front elevational view thereof;

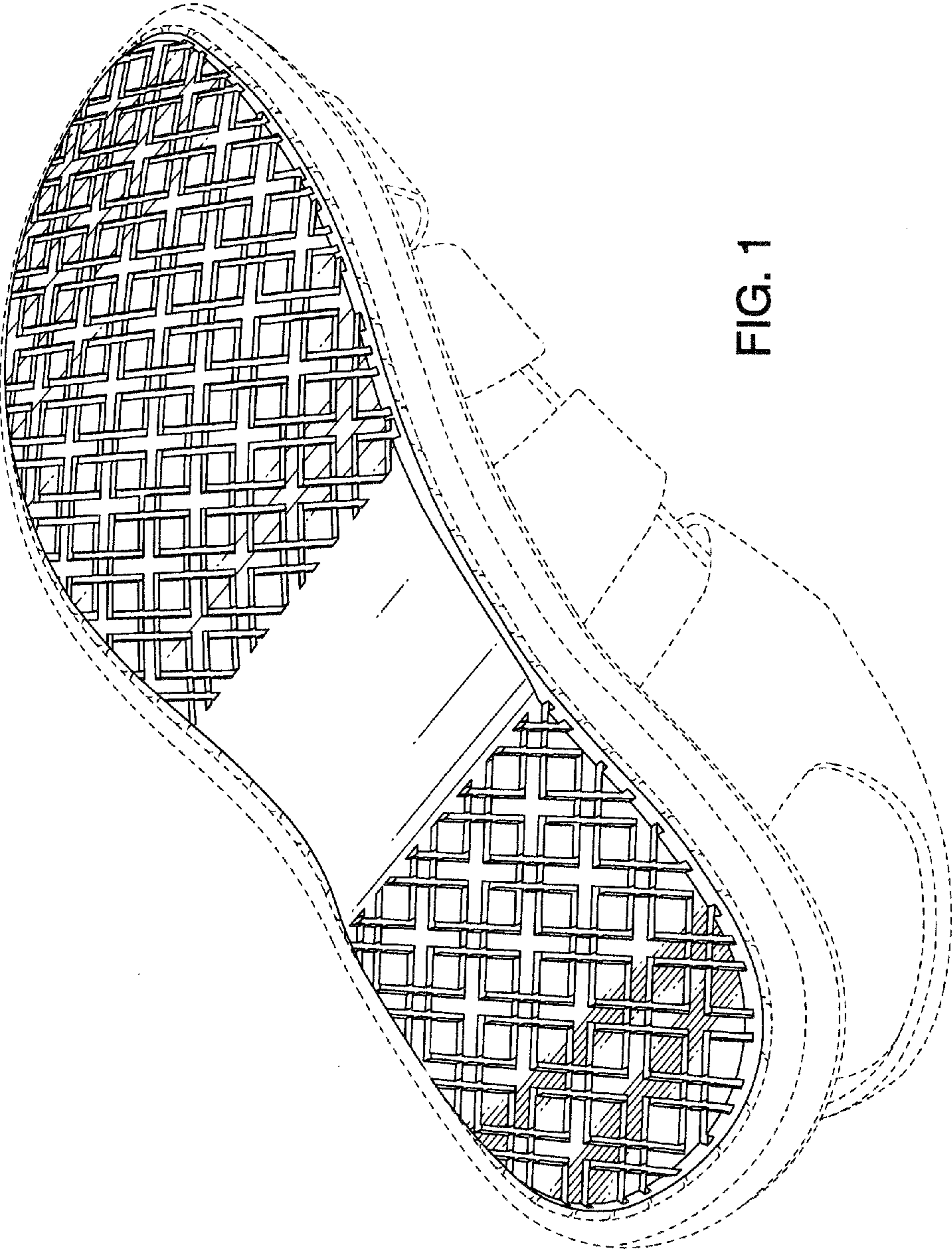

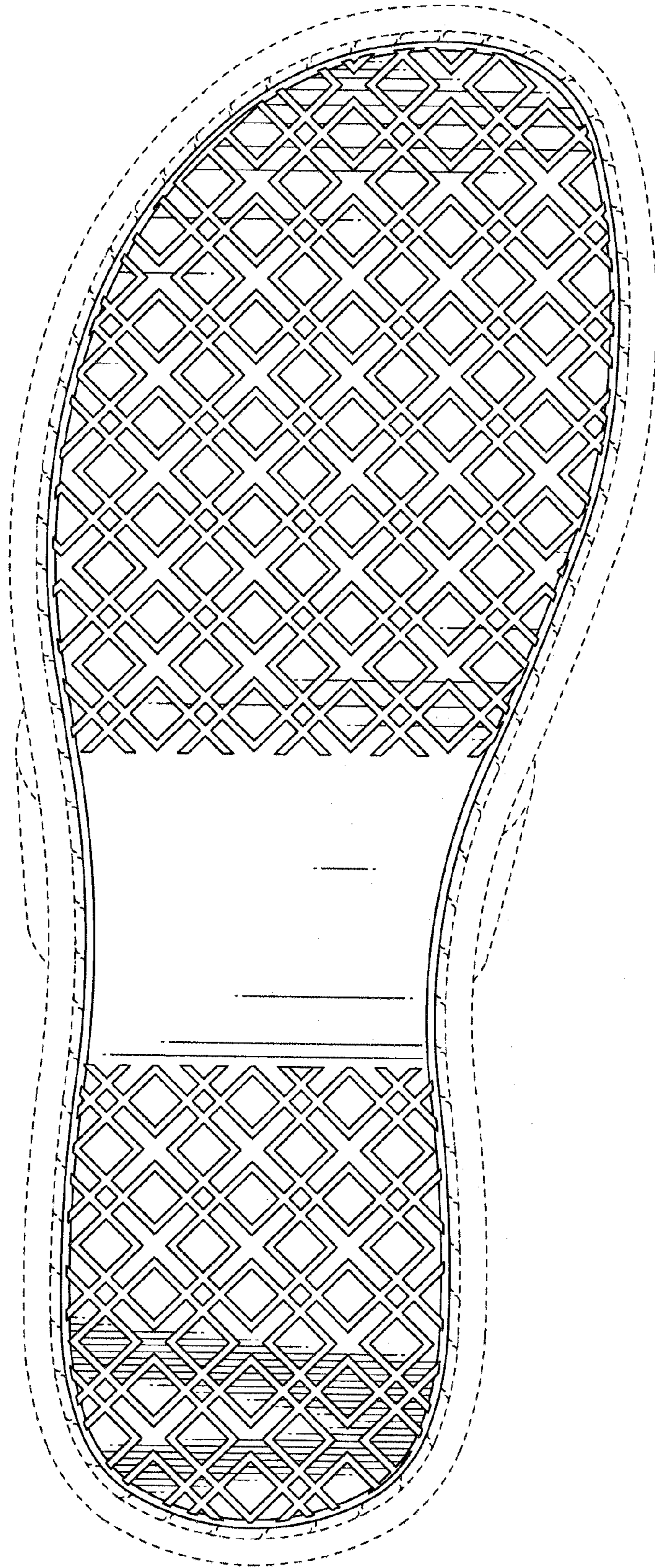

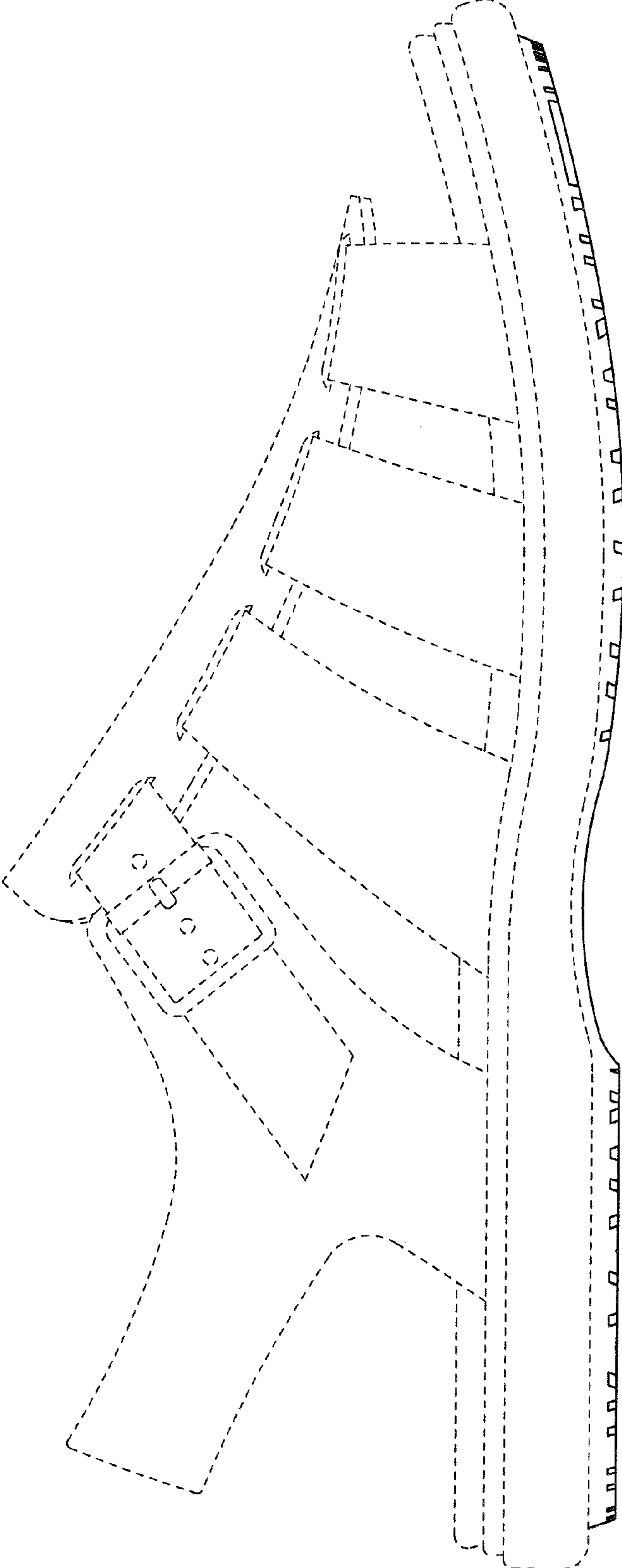

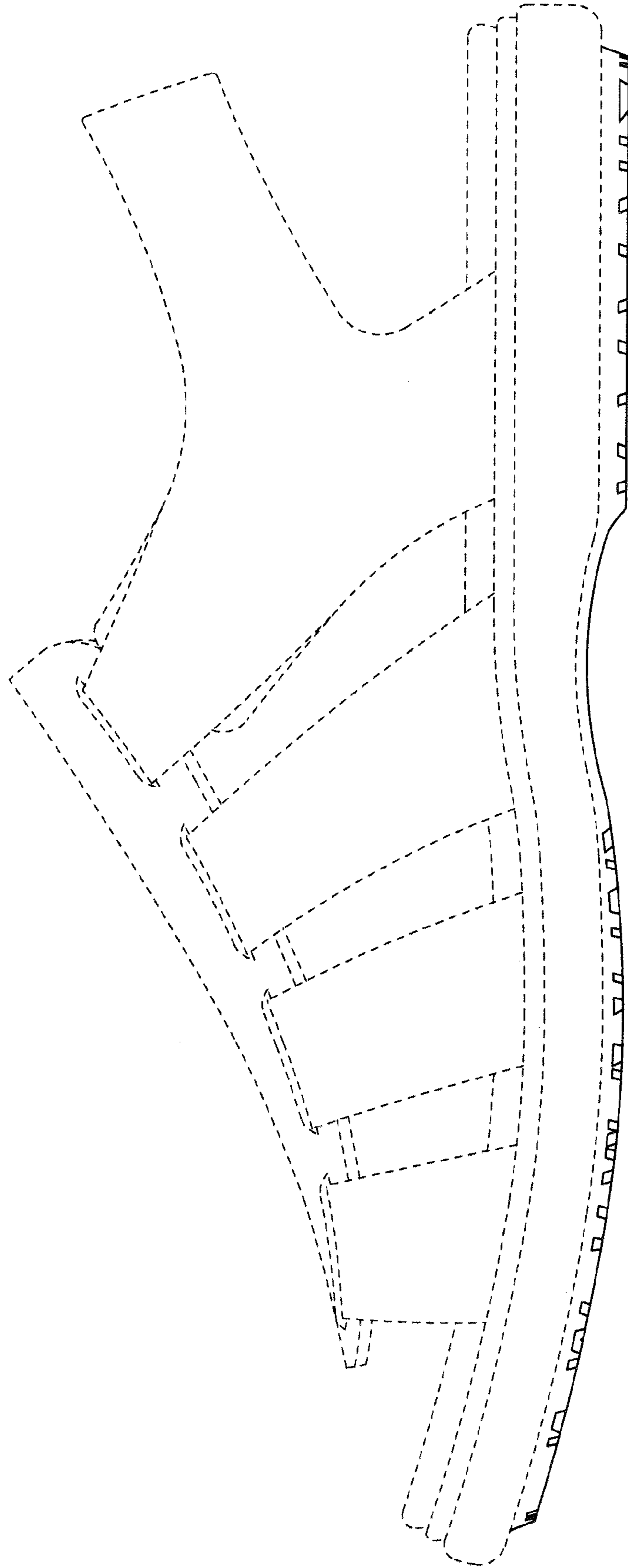

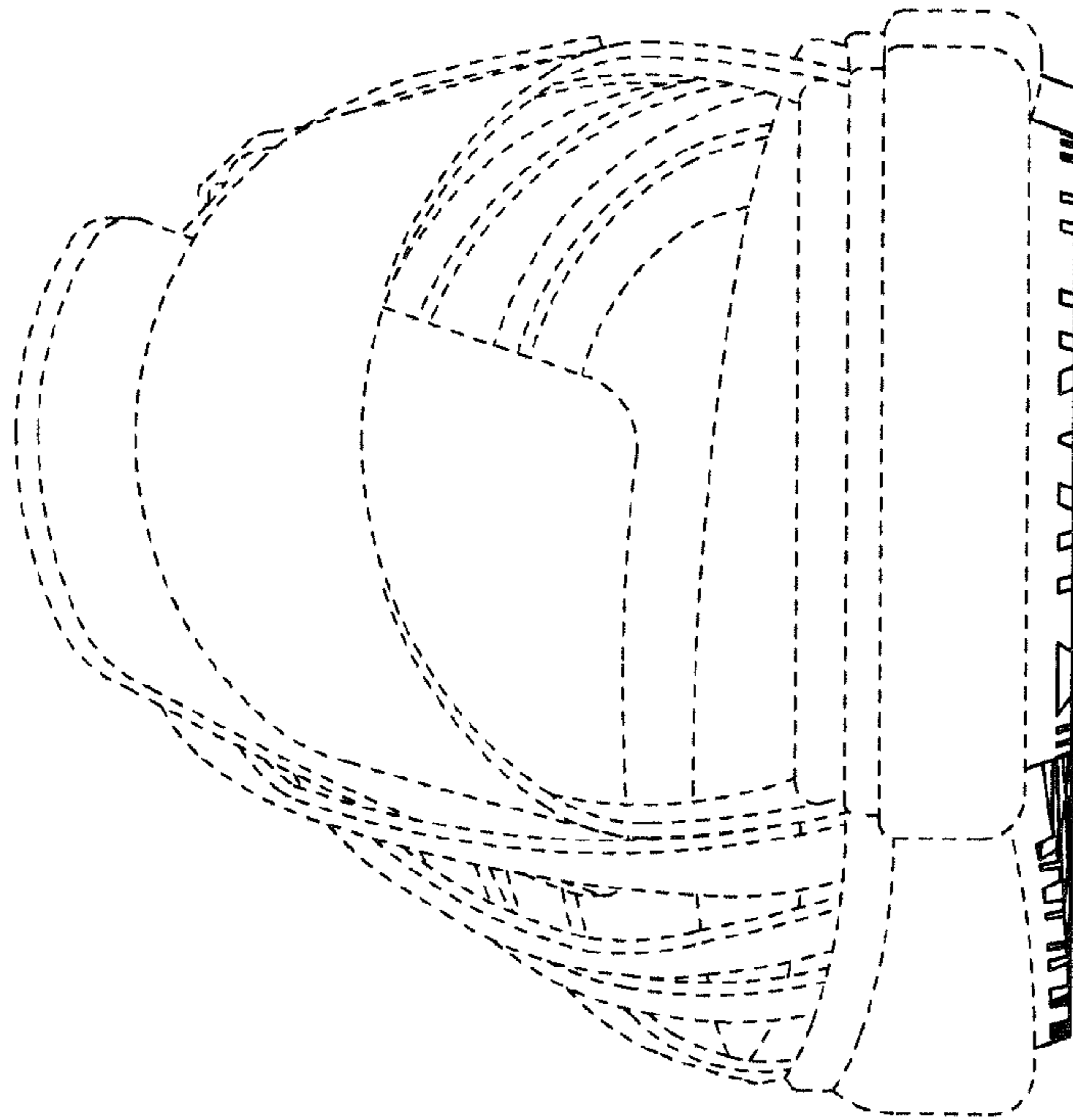

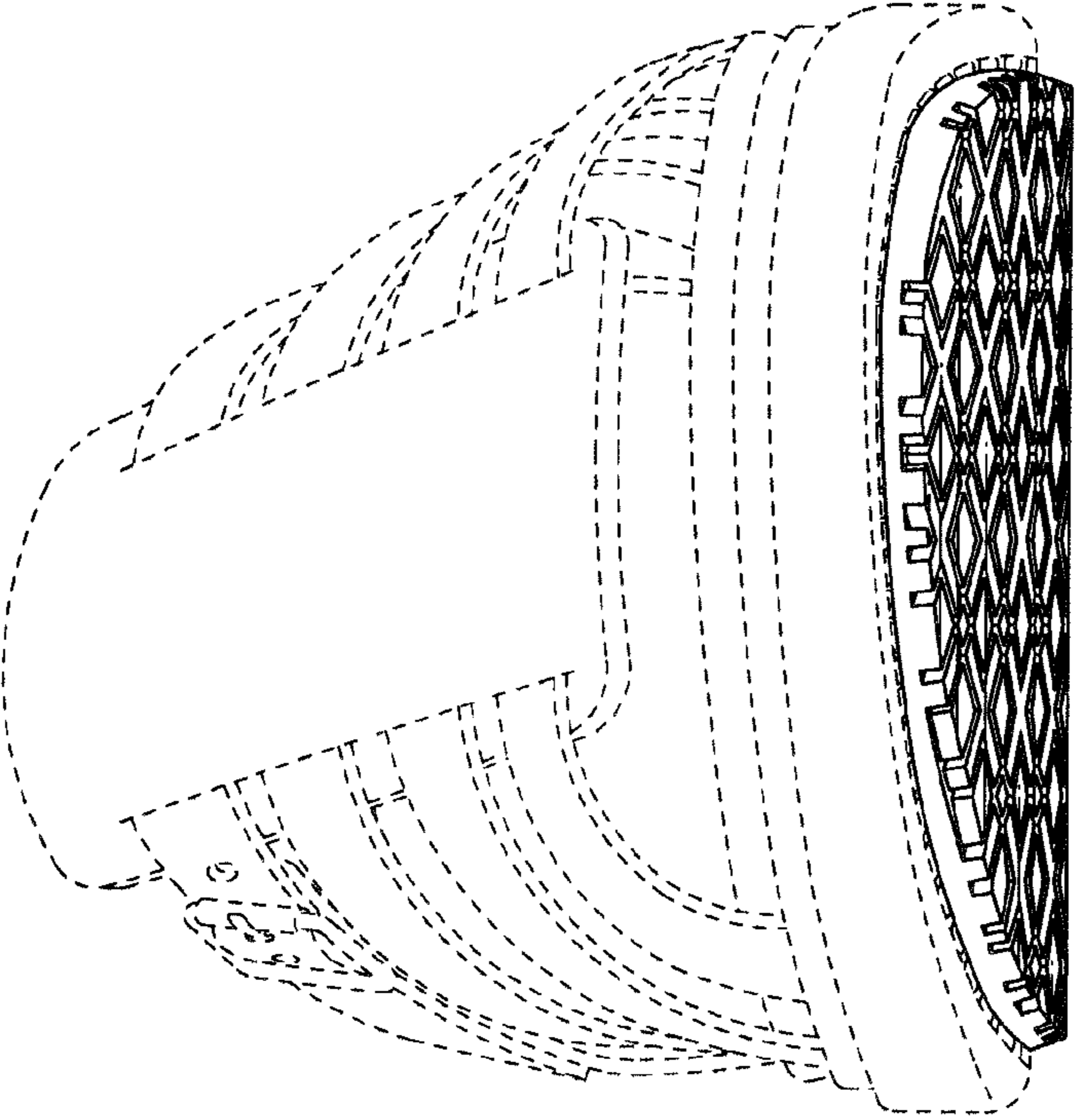

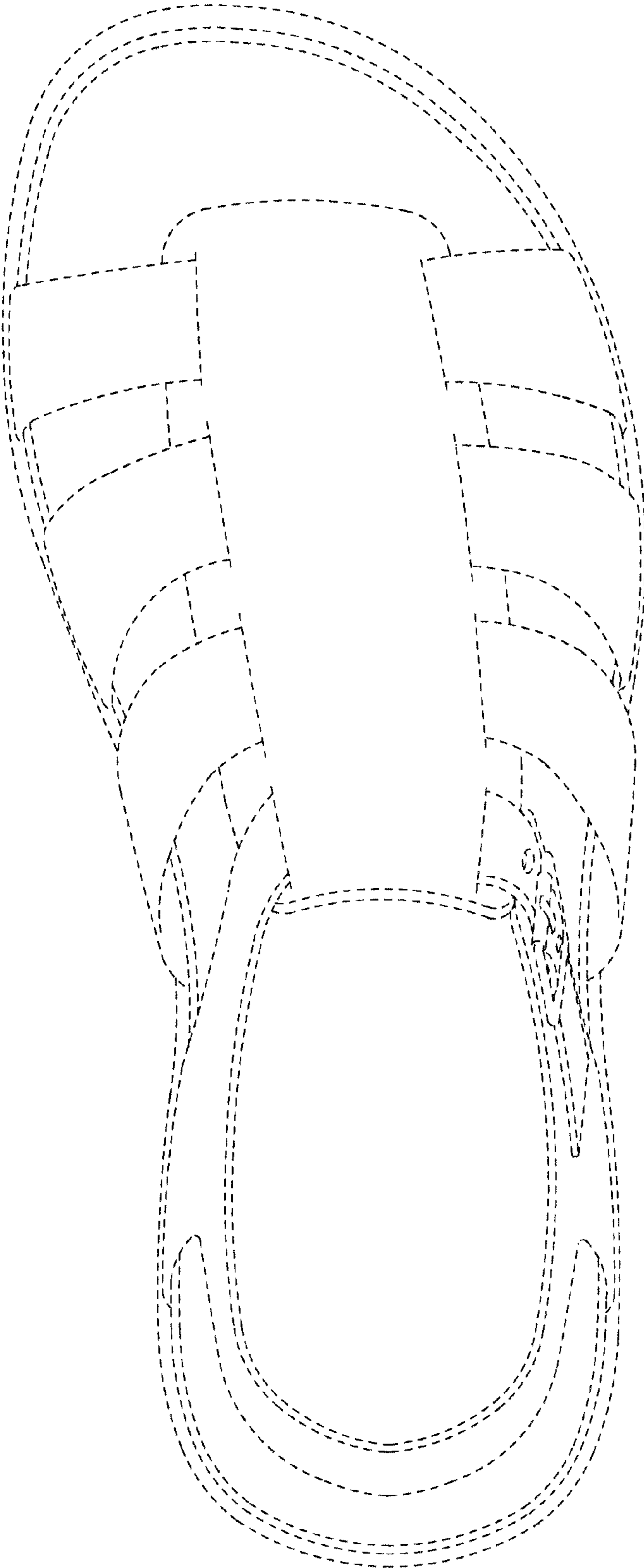
