(57) **CLAIM**

The ornamental design for a full sectional gatherable bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a full sectional gatherable bag in an uncompressed state, the rear elevational view being a mirror image thereof.

FIG. 2 is a left side perspective view of FIG. 1, the right side perspective view being a mirror image thereof.

FIG. 3 is a top front perspective view of FIG. 1

FIG. 4 is a bottom rear perspective view of FIG. 1

FIG. 5 is a front elevational view of a full sectional gatherable bag partially compressed at the center of the bag, the rear elevational view being a mirror image thereof.

FIG. 6 is a left side perspective view of a FIG. 5, the right side perspective view being a mirror image thereof.

FIG. 7 is a top front perspective view of FIG. 5

FIG. 8 is a bottom perspective view of FIG. 5

FIG. 9 is a front elevational view of full sectional gatherable bag fully compressed at the center of the bag and at the sides, the rear elevational view being a mirror image thereof.

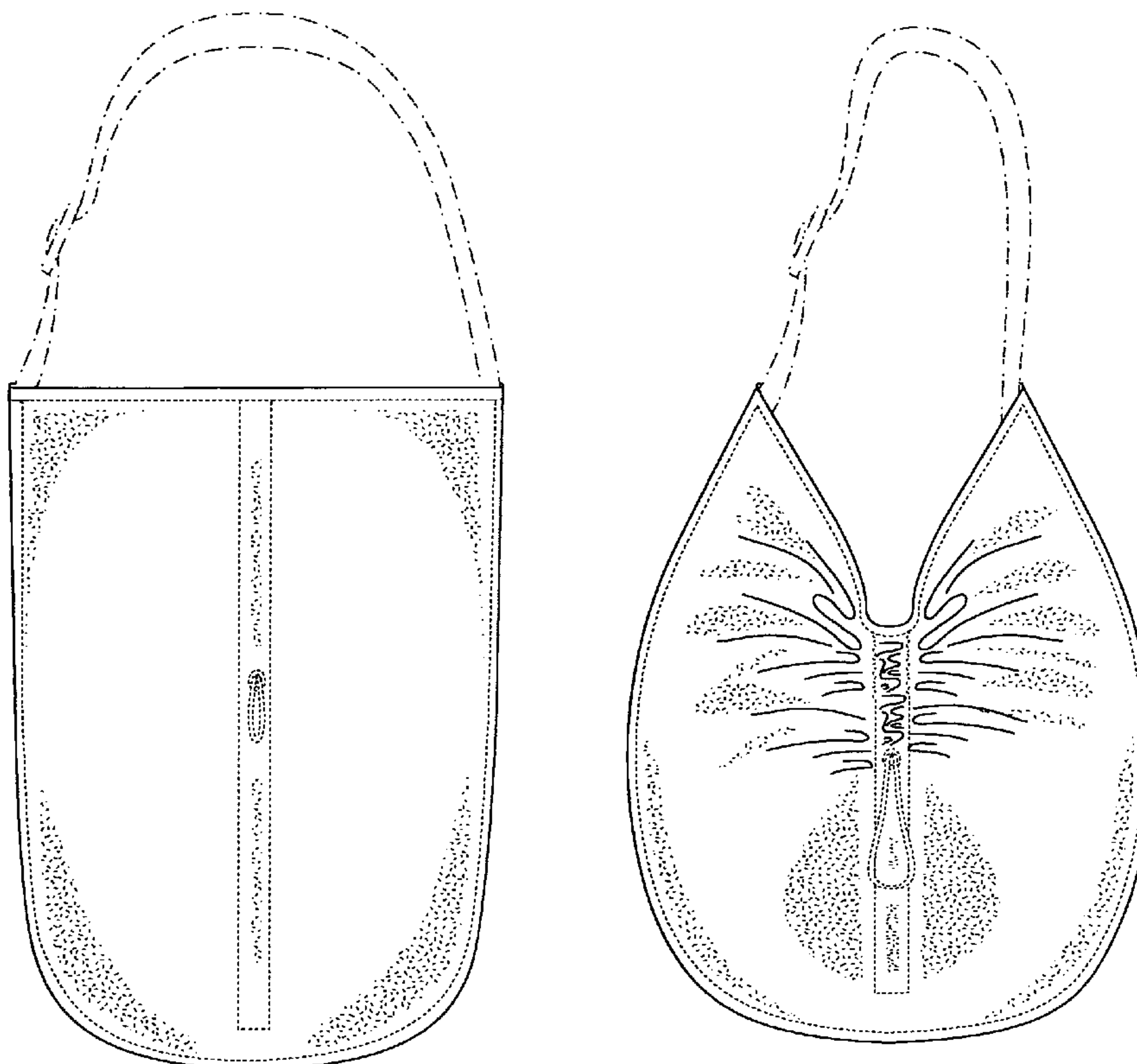
FIG. 10 is a left side perspective view of a FIG. 9, the right side perspective view being a mirror image thereof.

FIG. 11 is a top front perspective view of FIG. 9; and,

FIG. 12 is a bottom rear perspective view of FIG. 9.

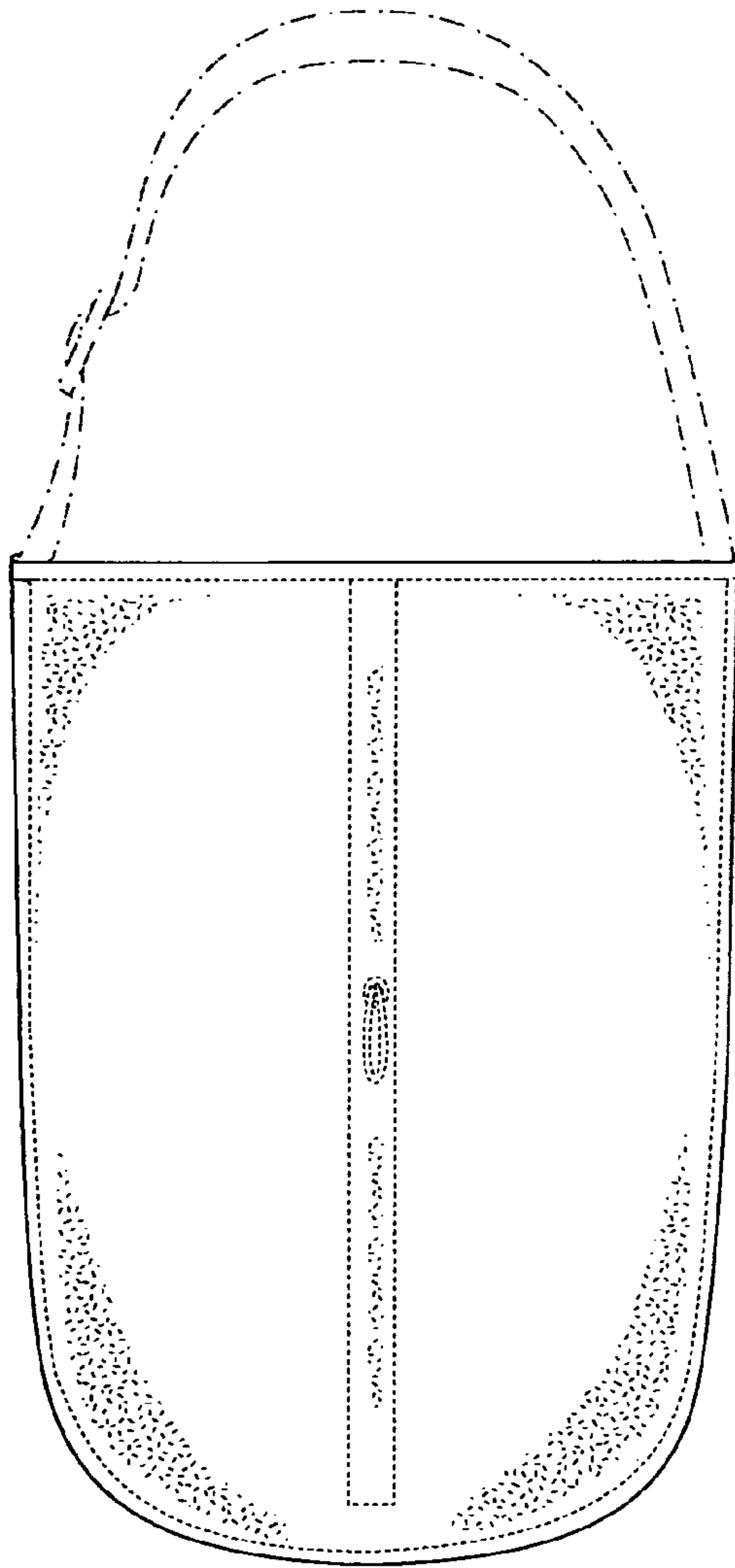

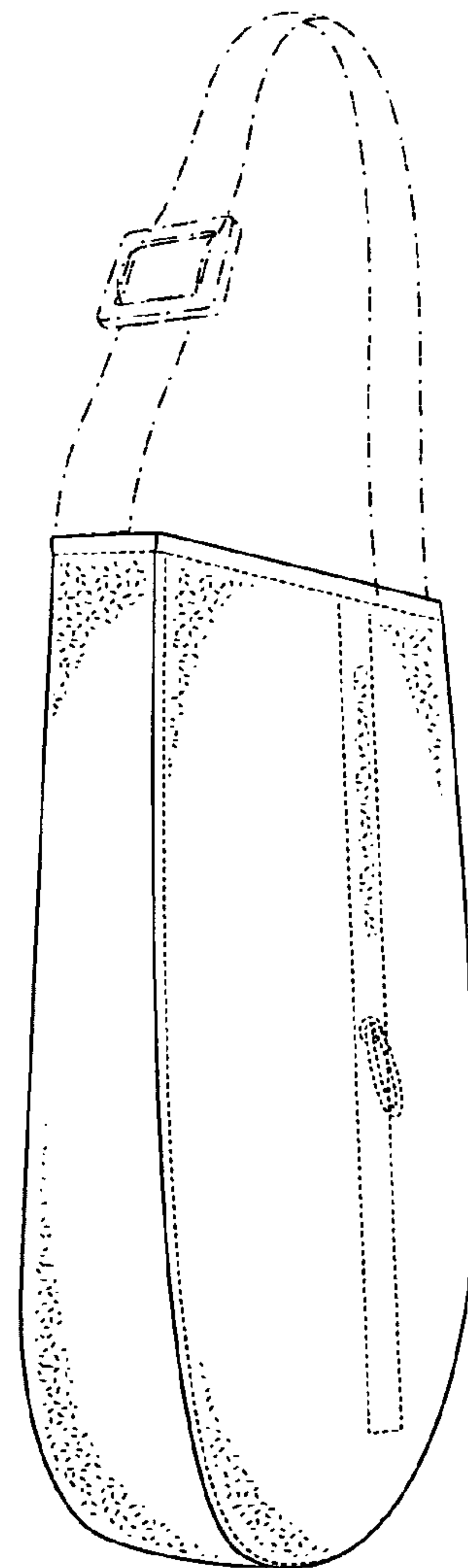

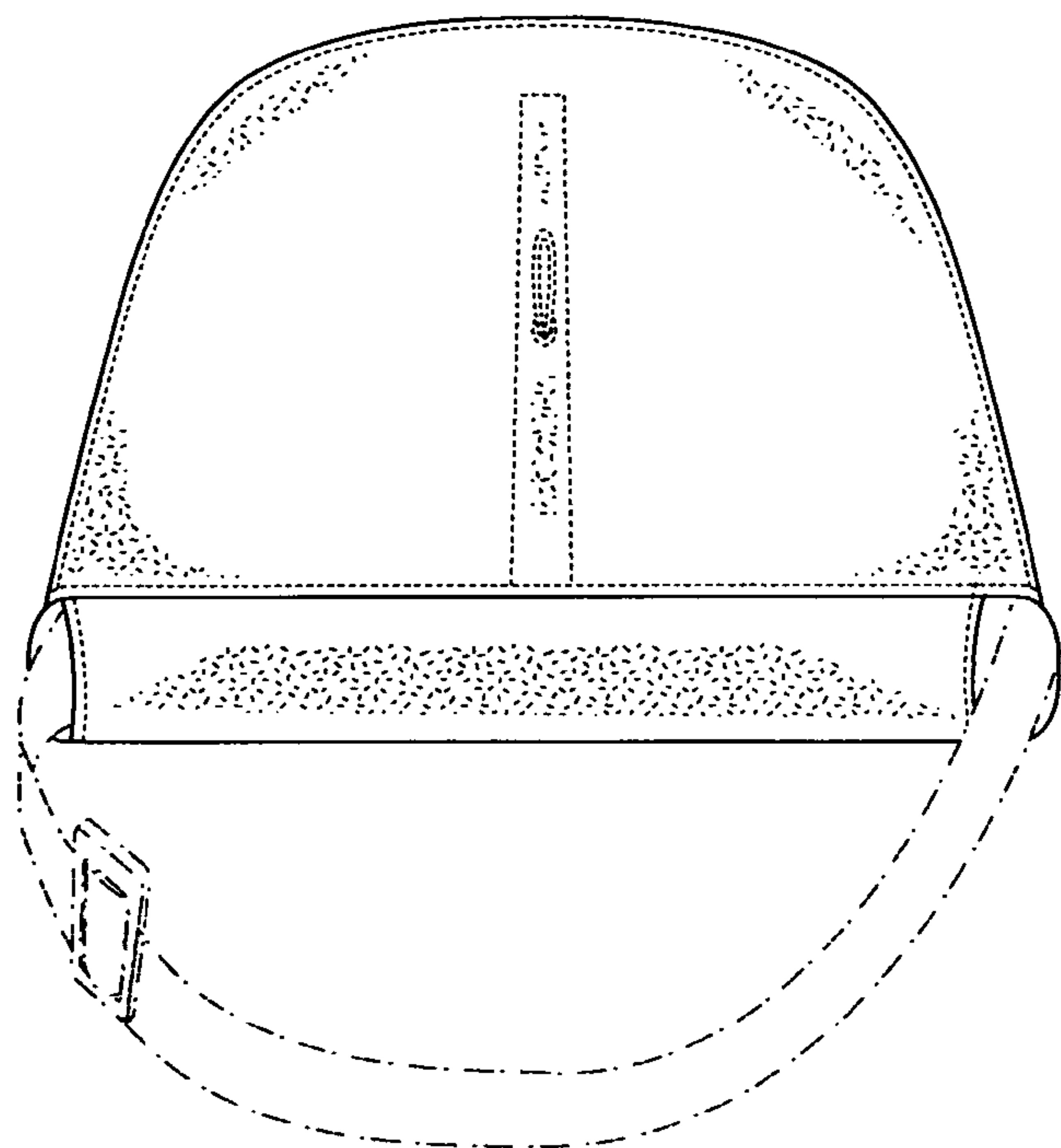

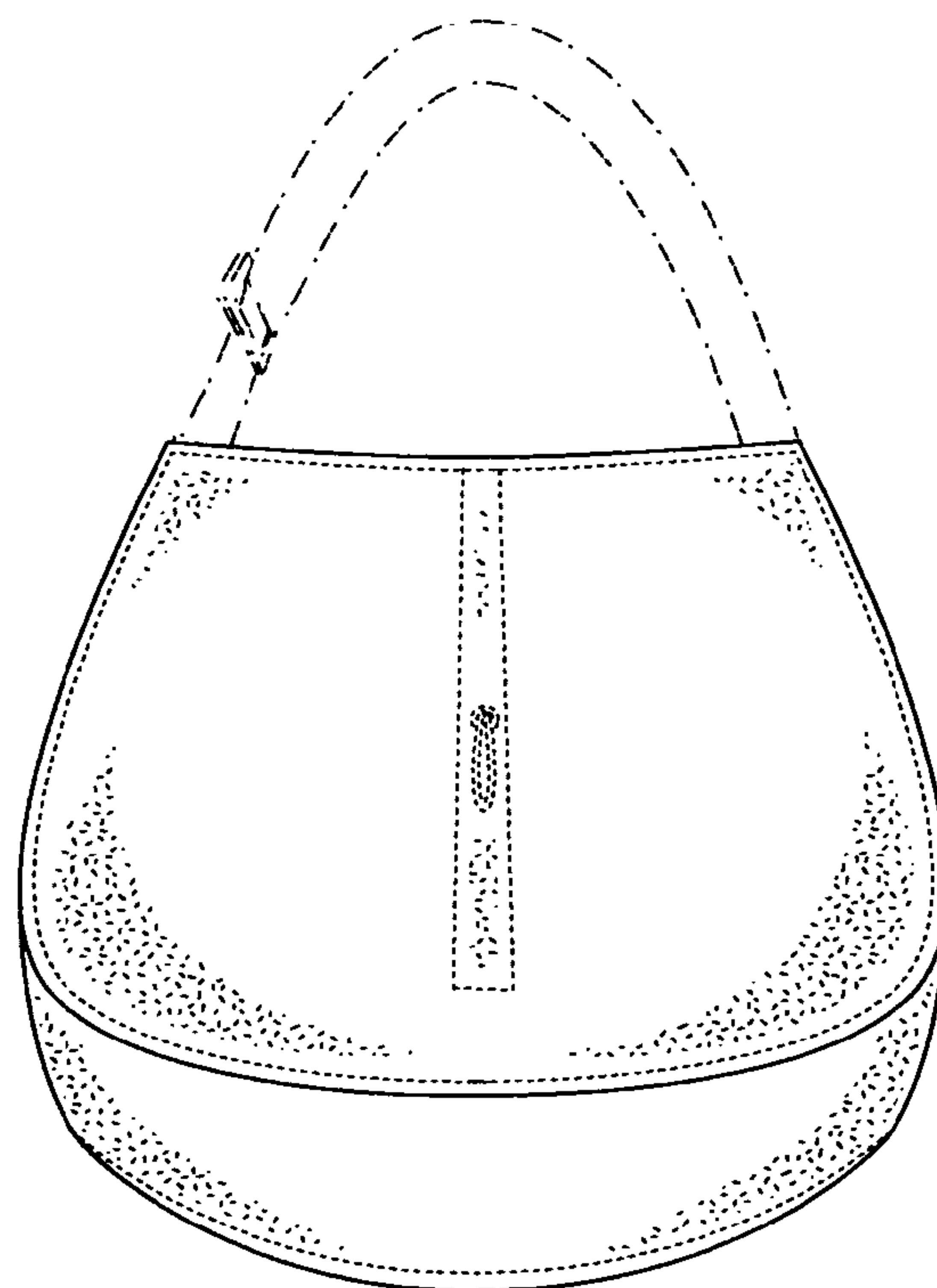

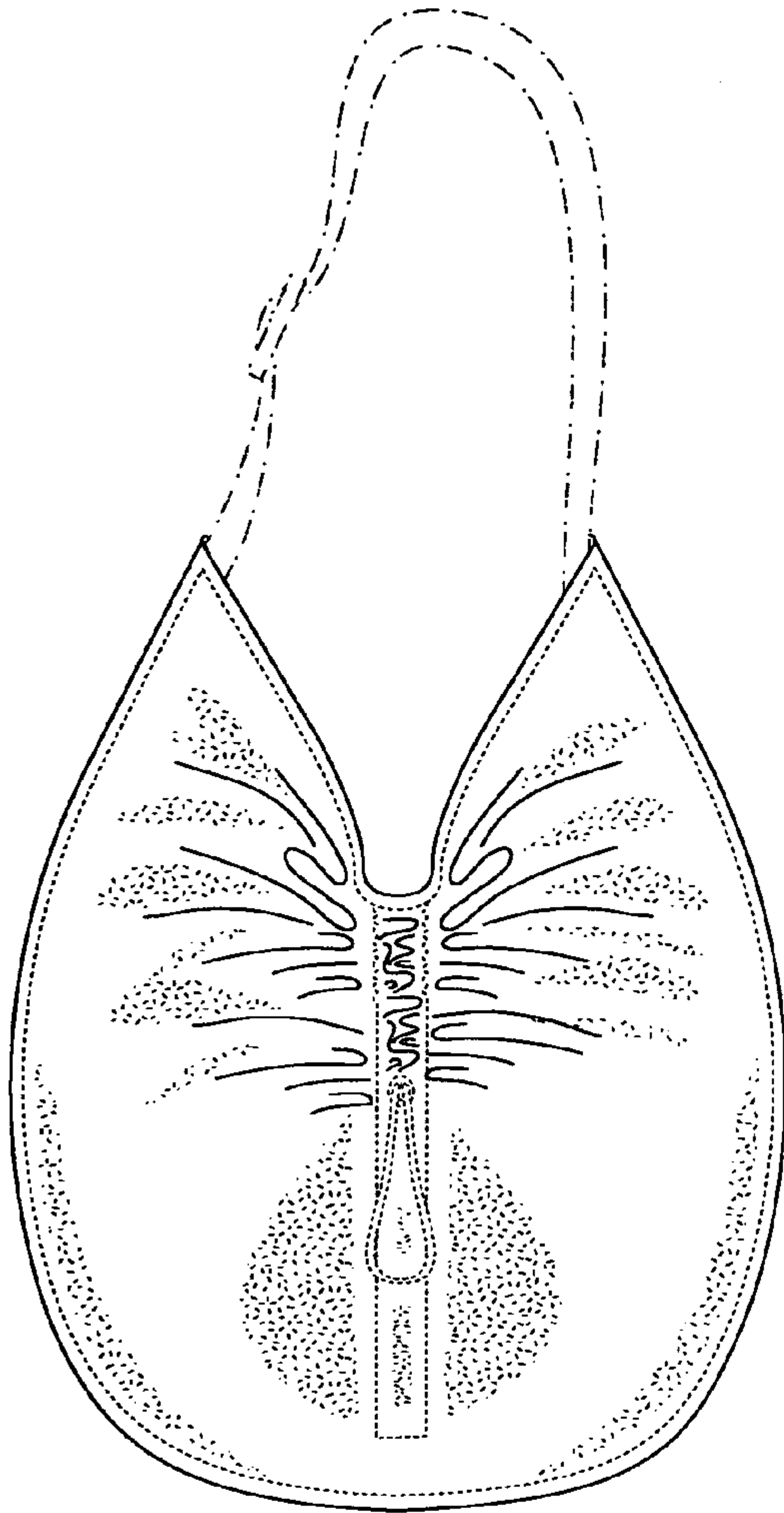

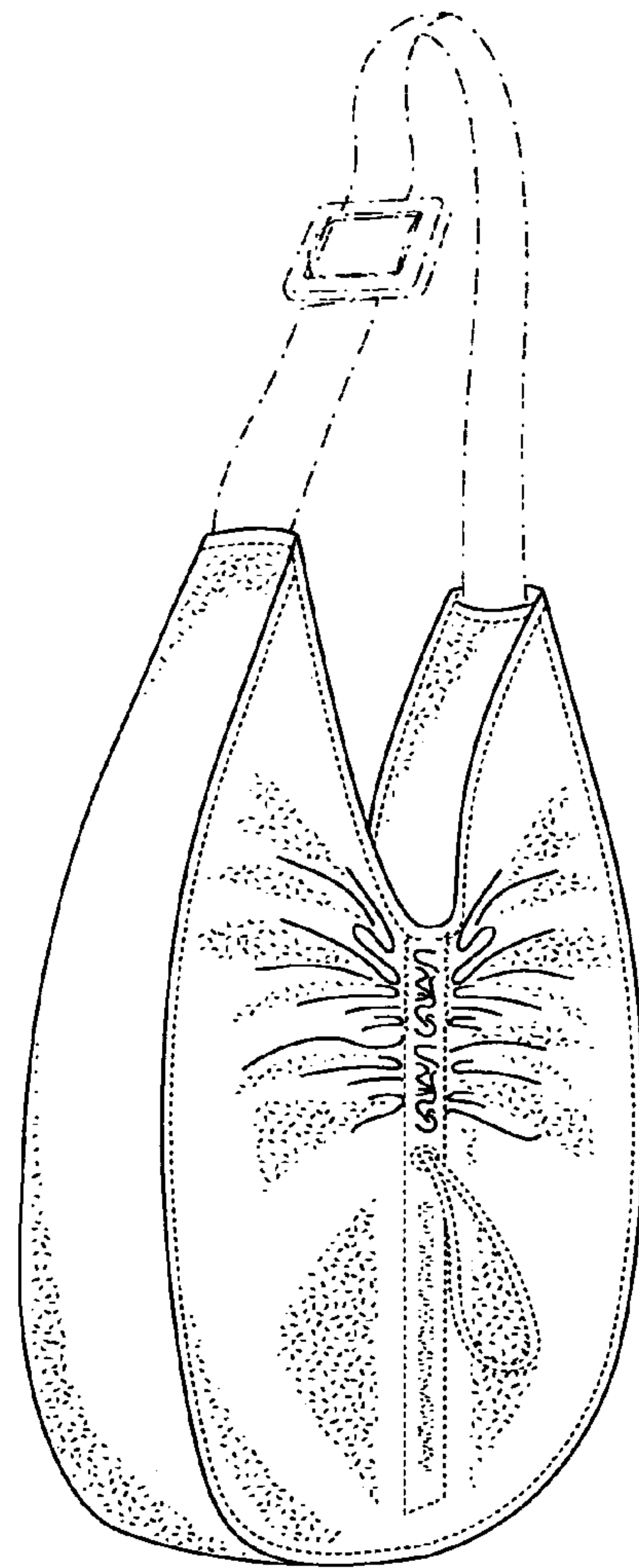

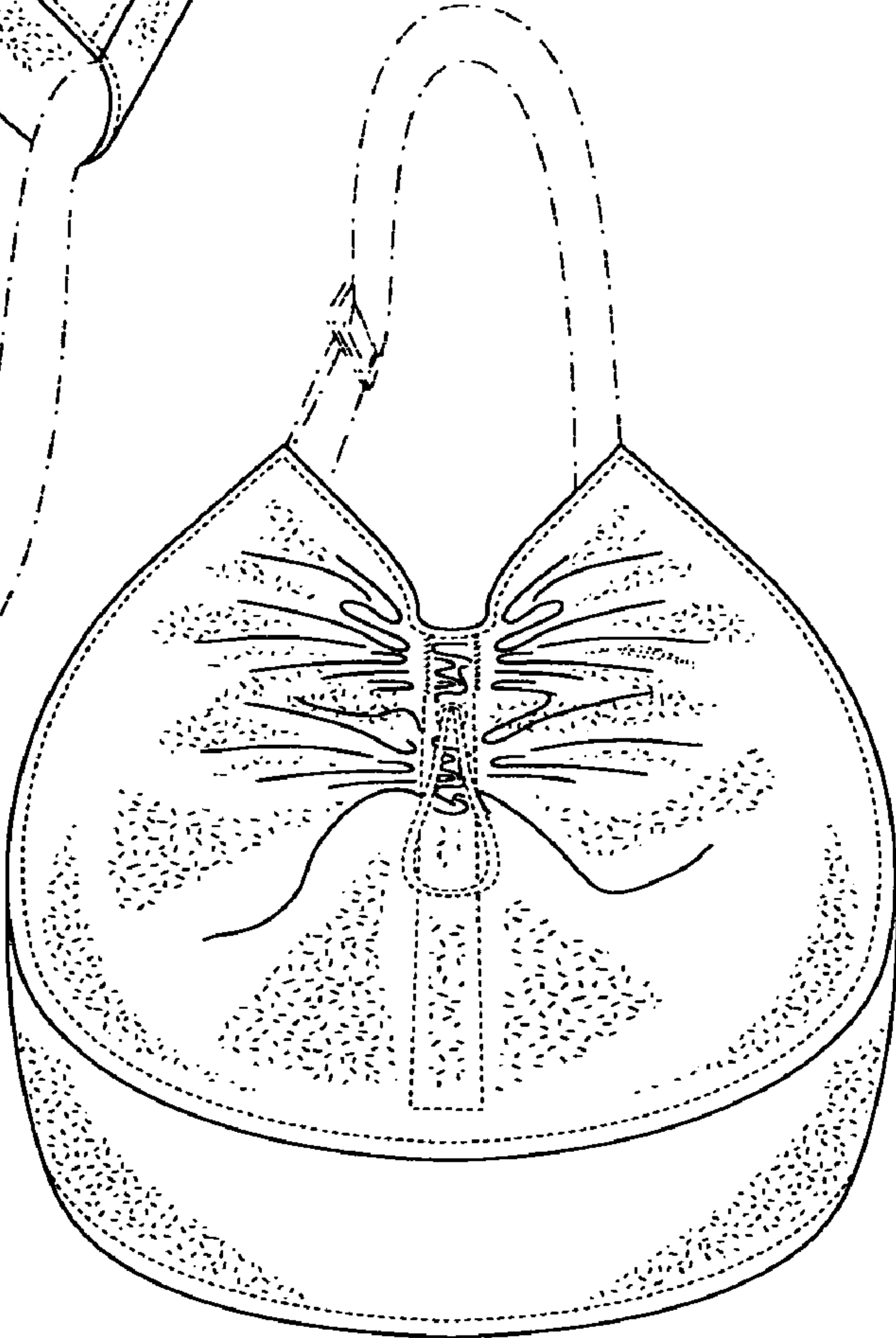
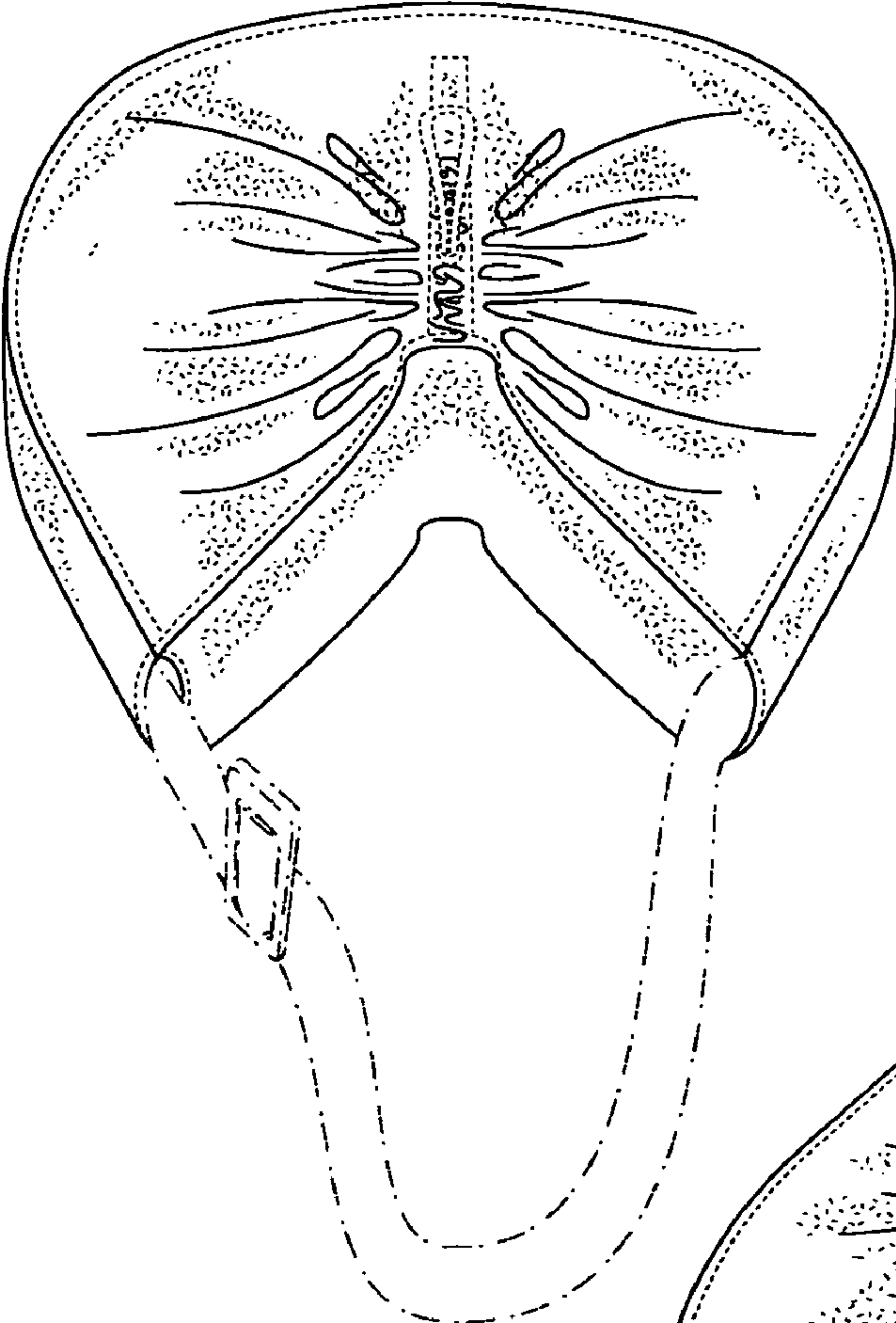

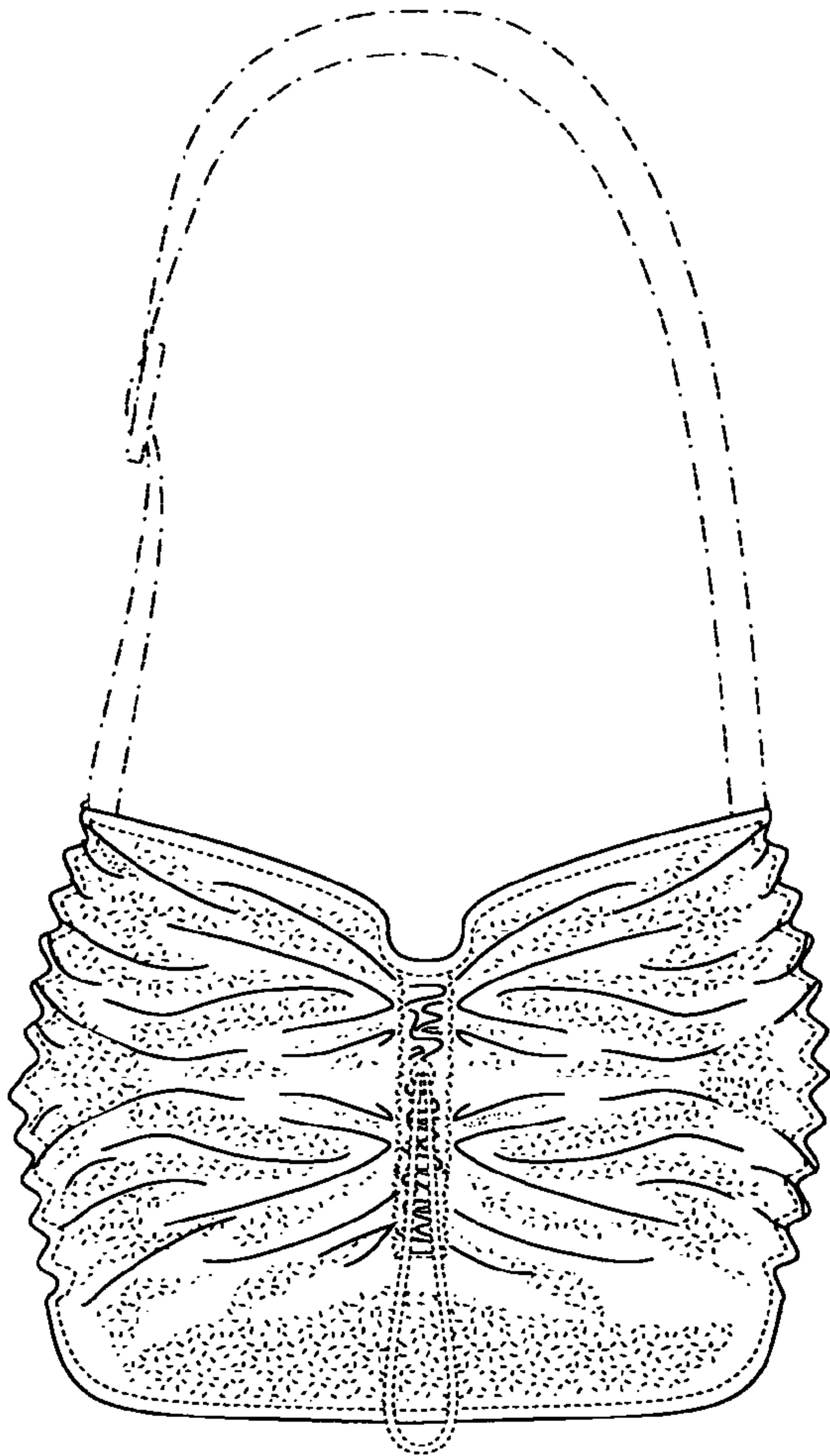

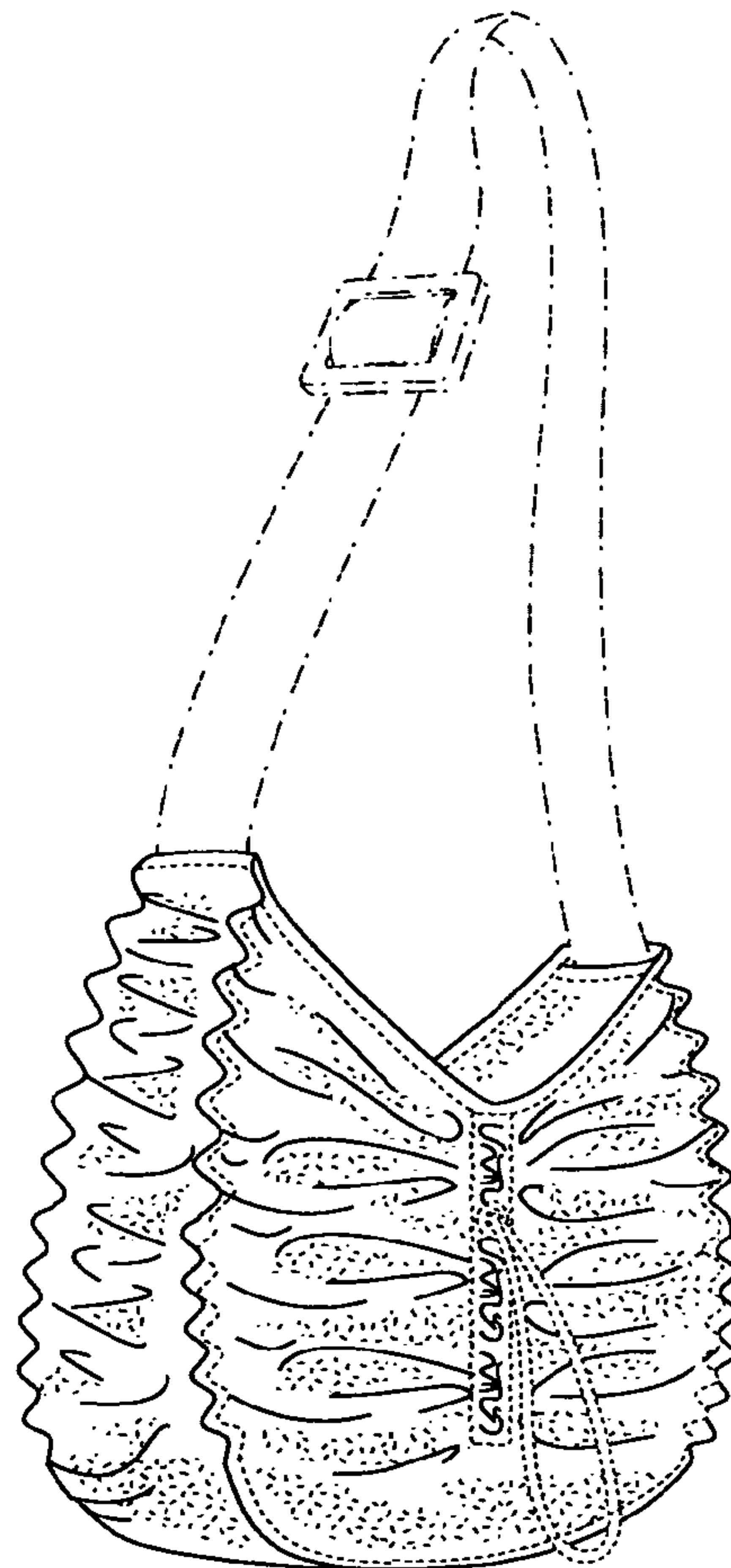

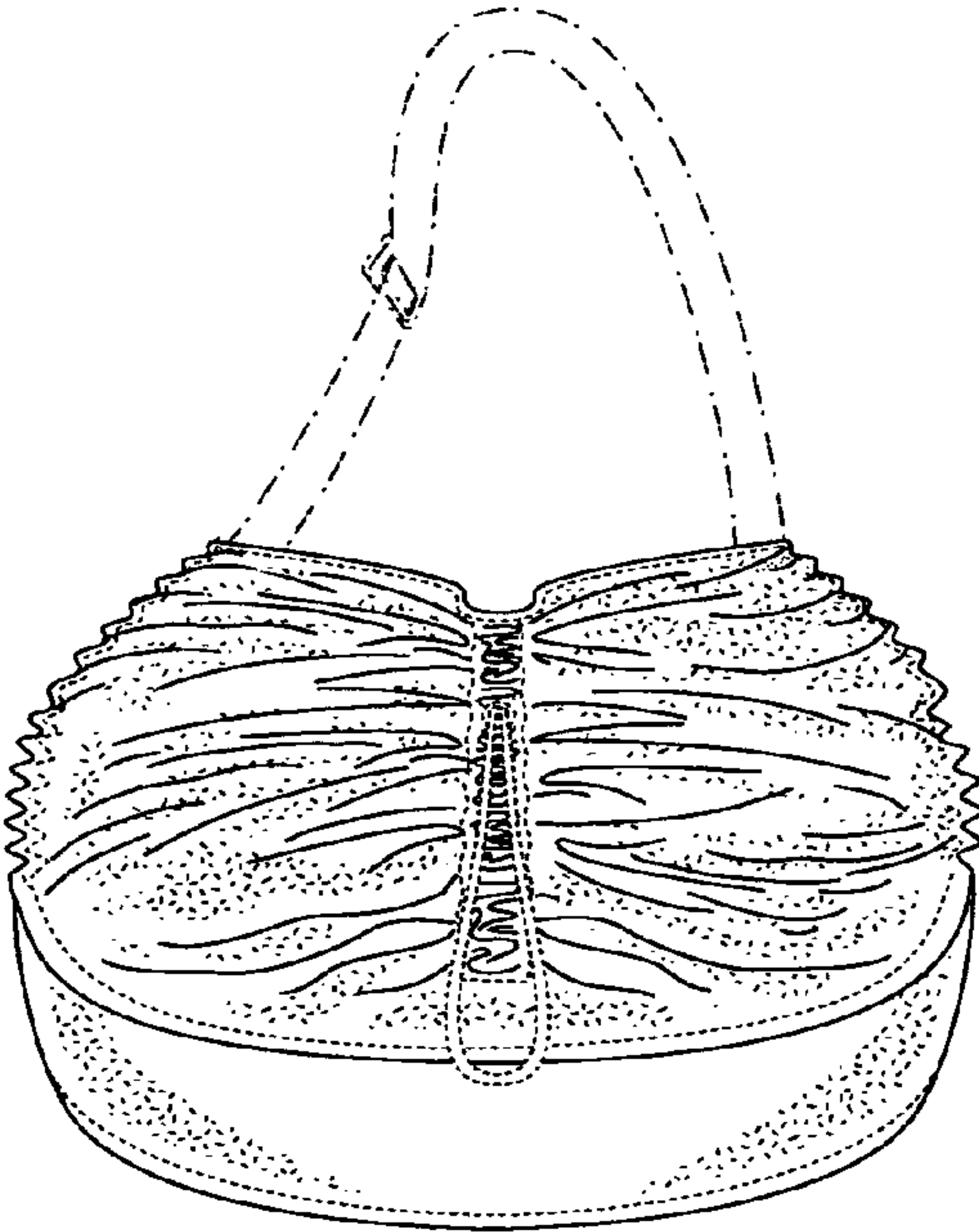
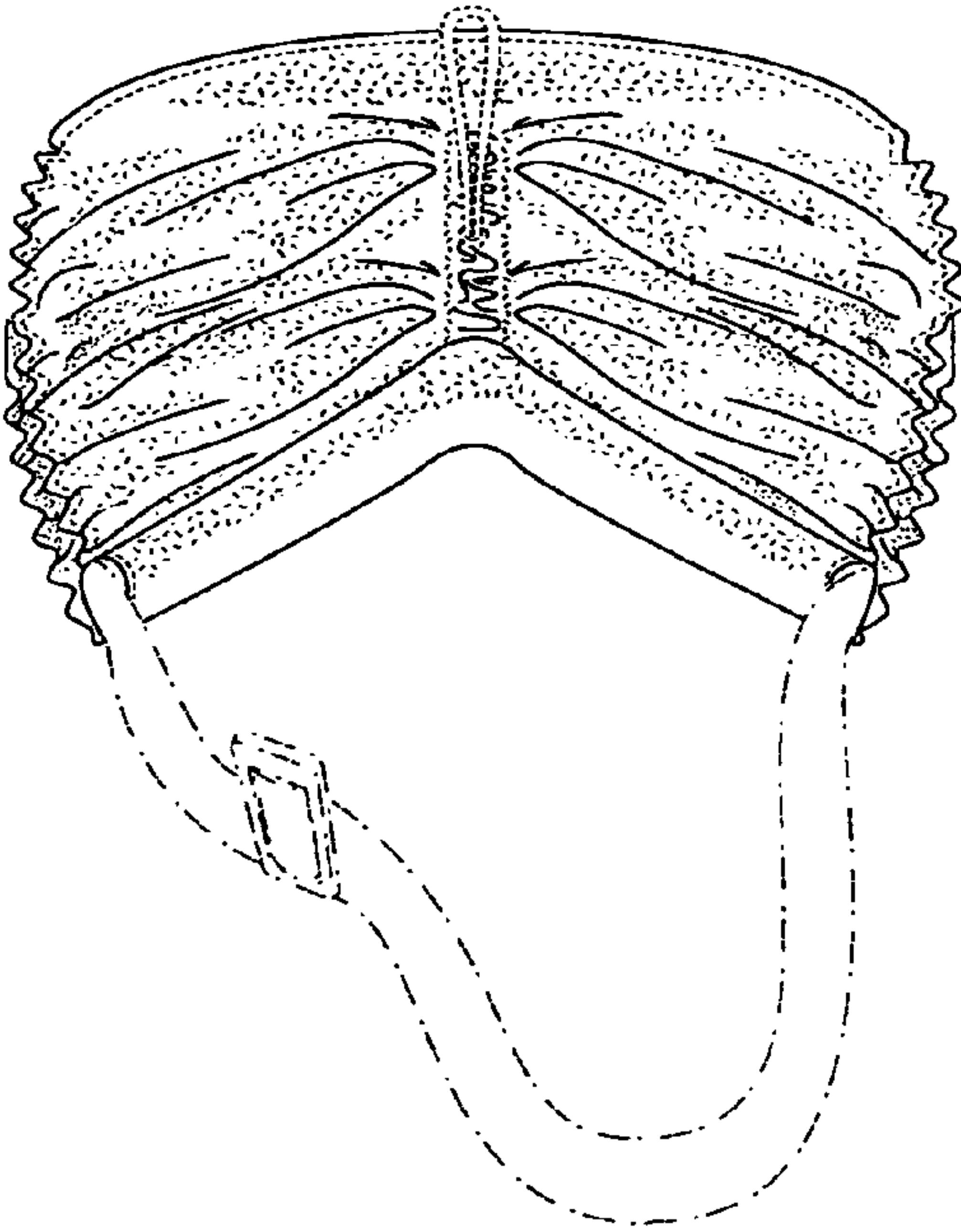
