DESCRIPTION

FIG. 1 is a perspective view of a ribbon shown in a flattened position;

FIG. 10 is a rear elevational view thereof;

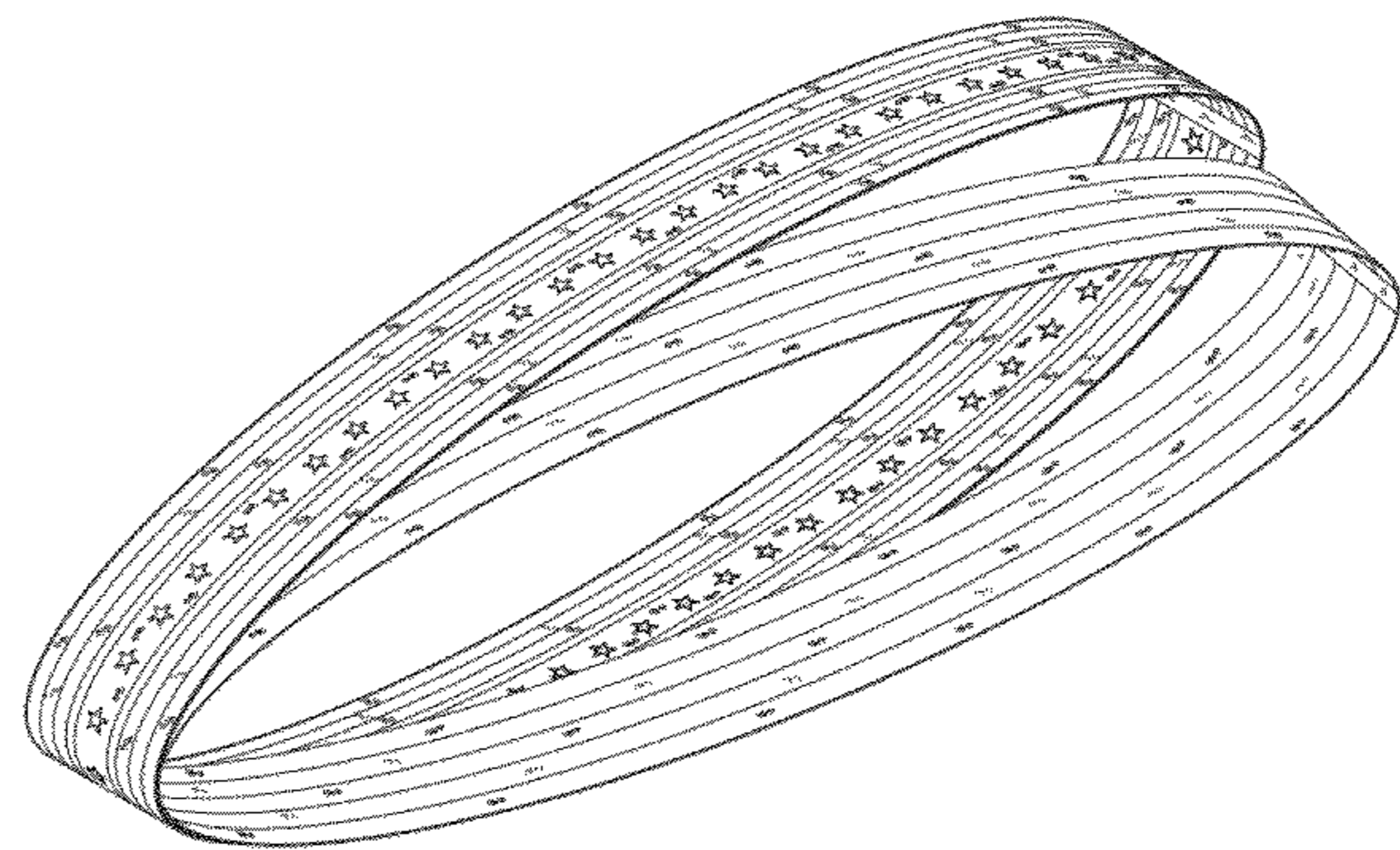
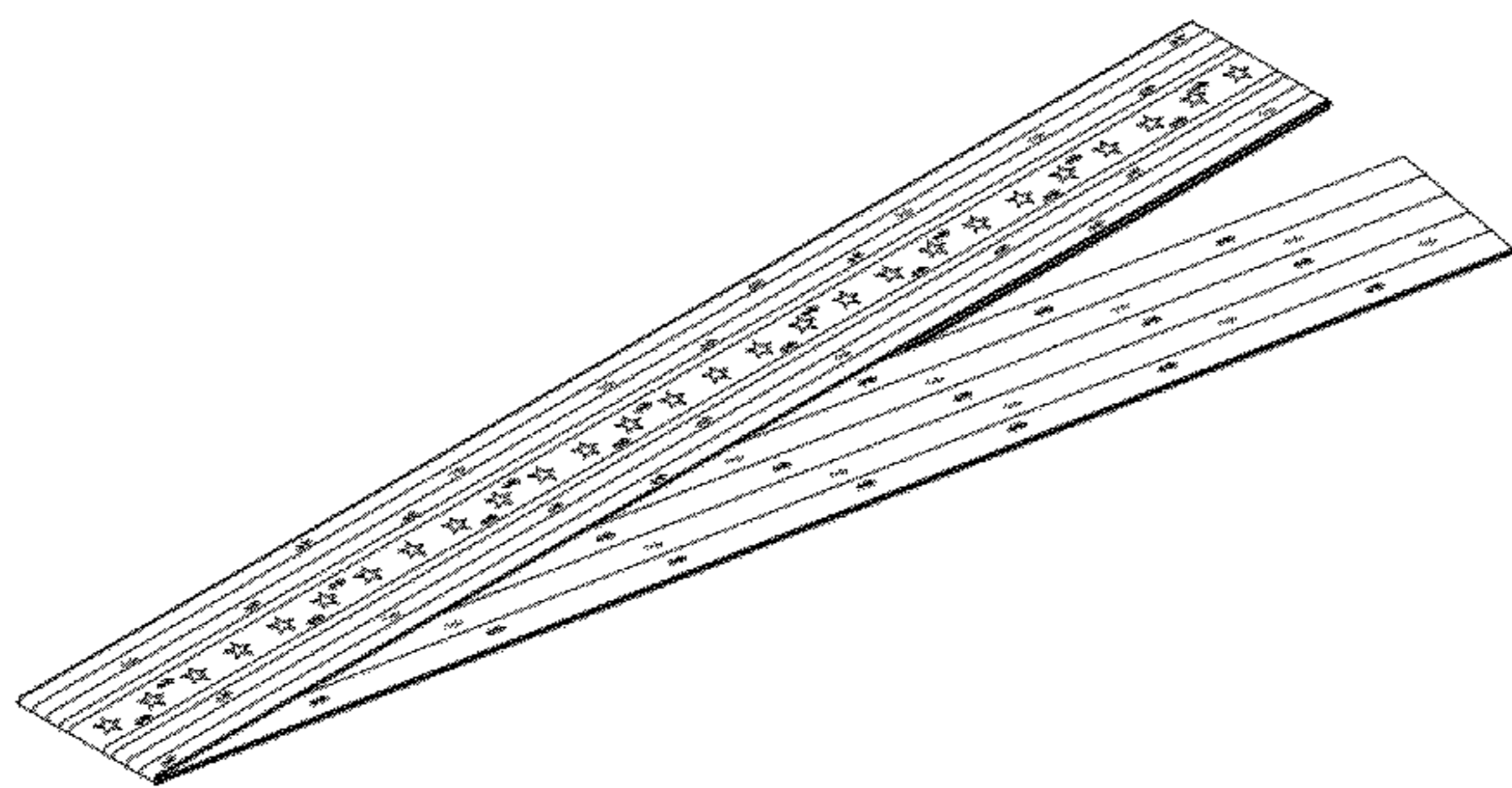
FIG. 11 is a right-side elevational view thereof;

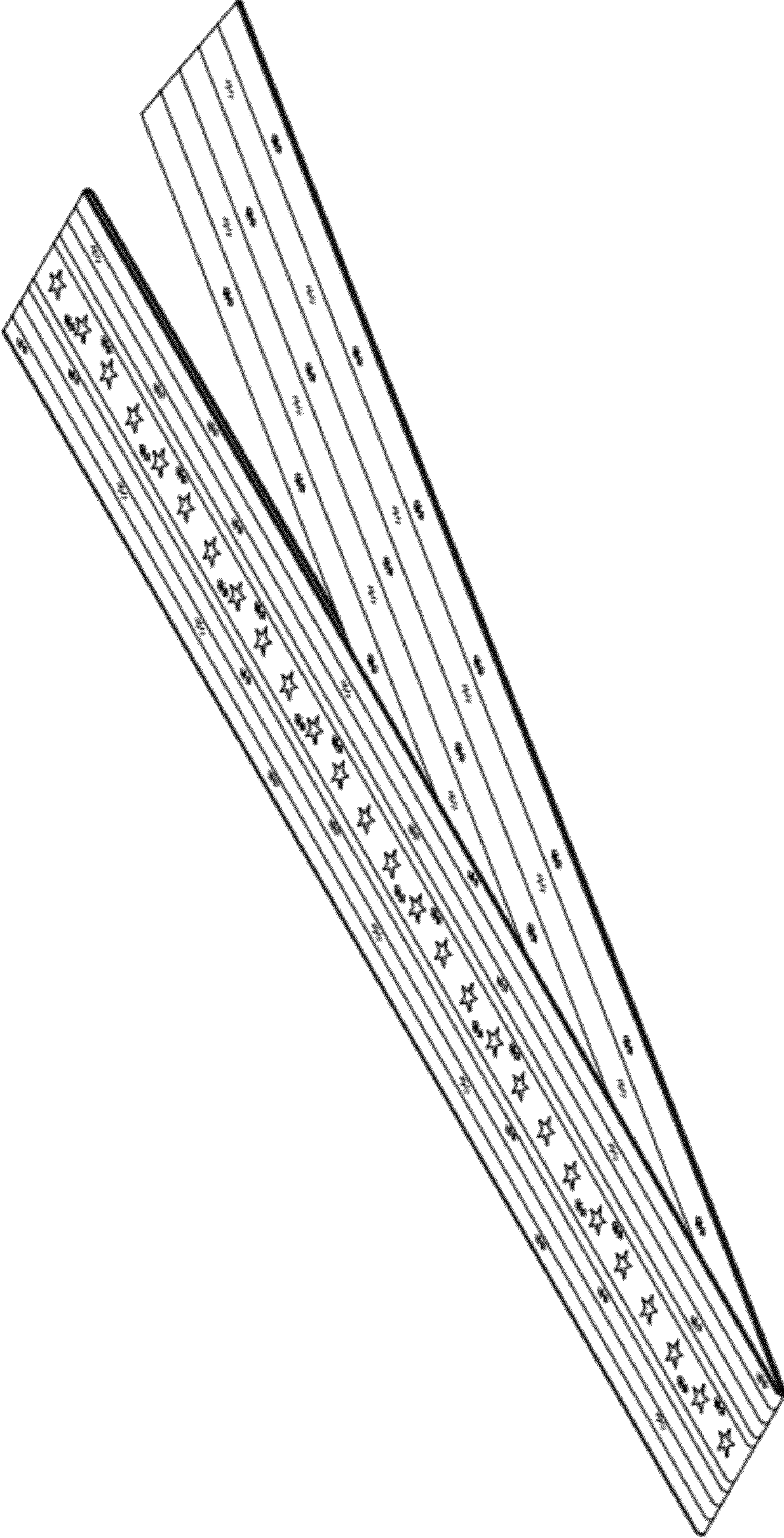

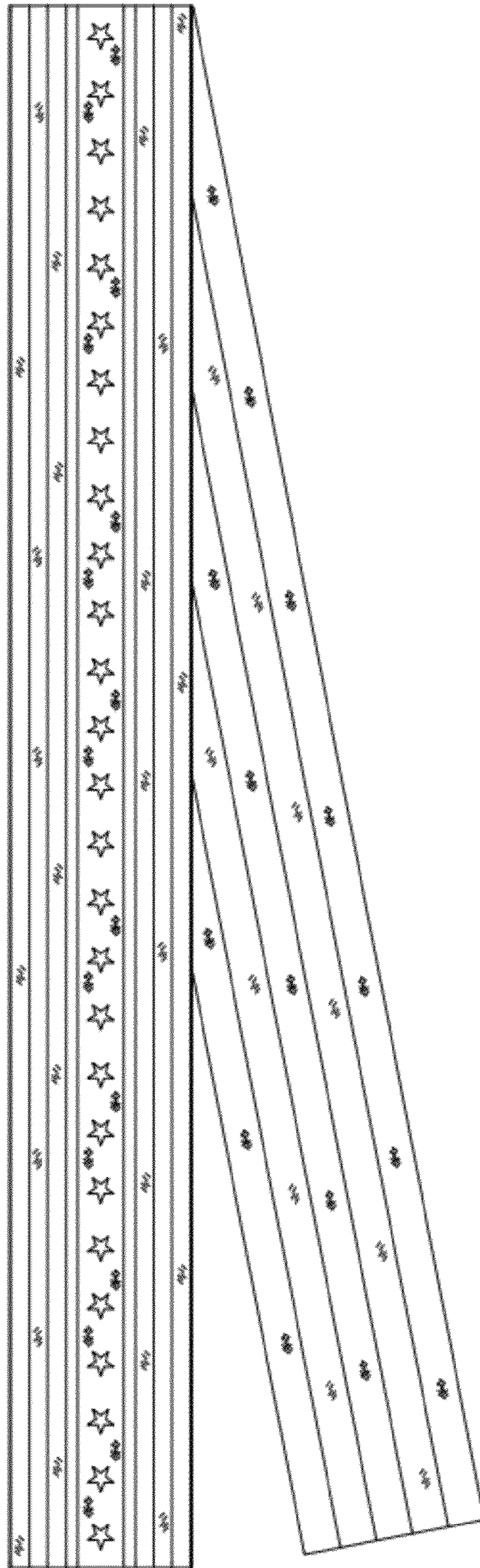

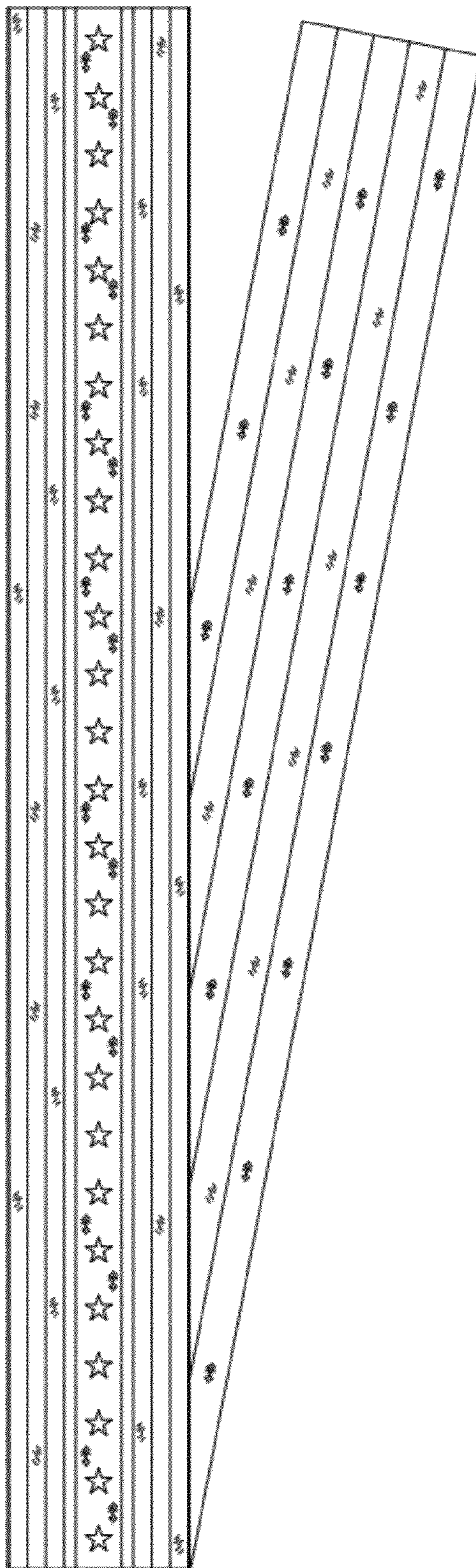

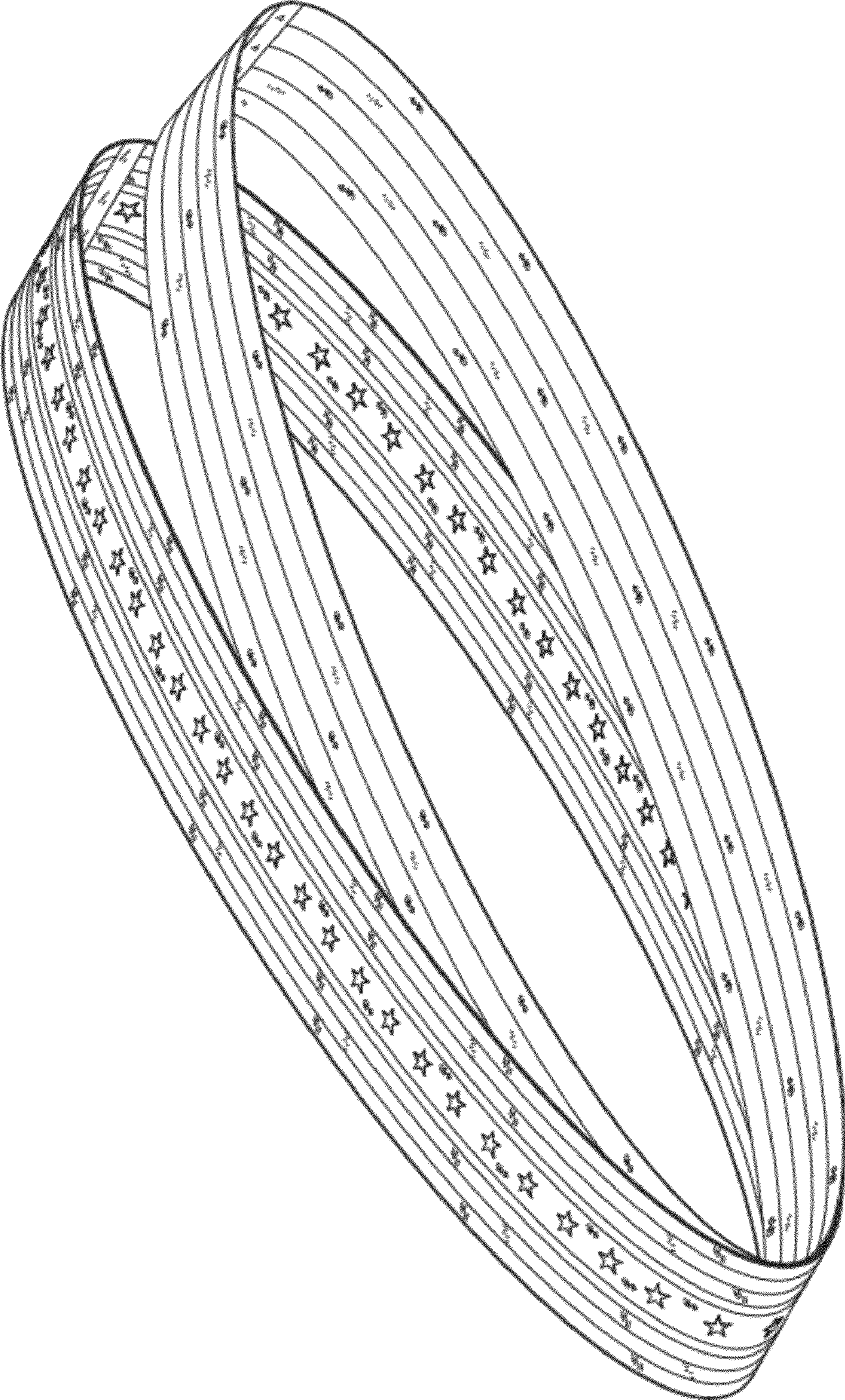

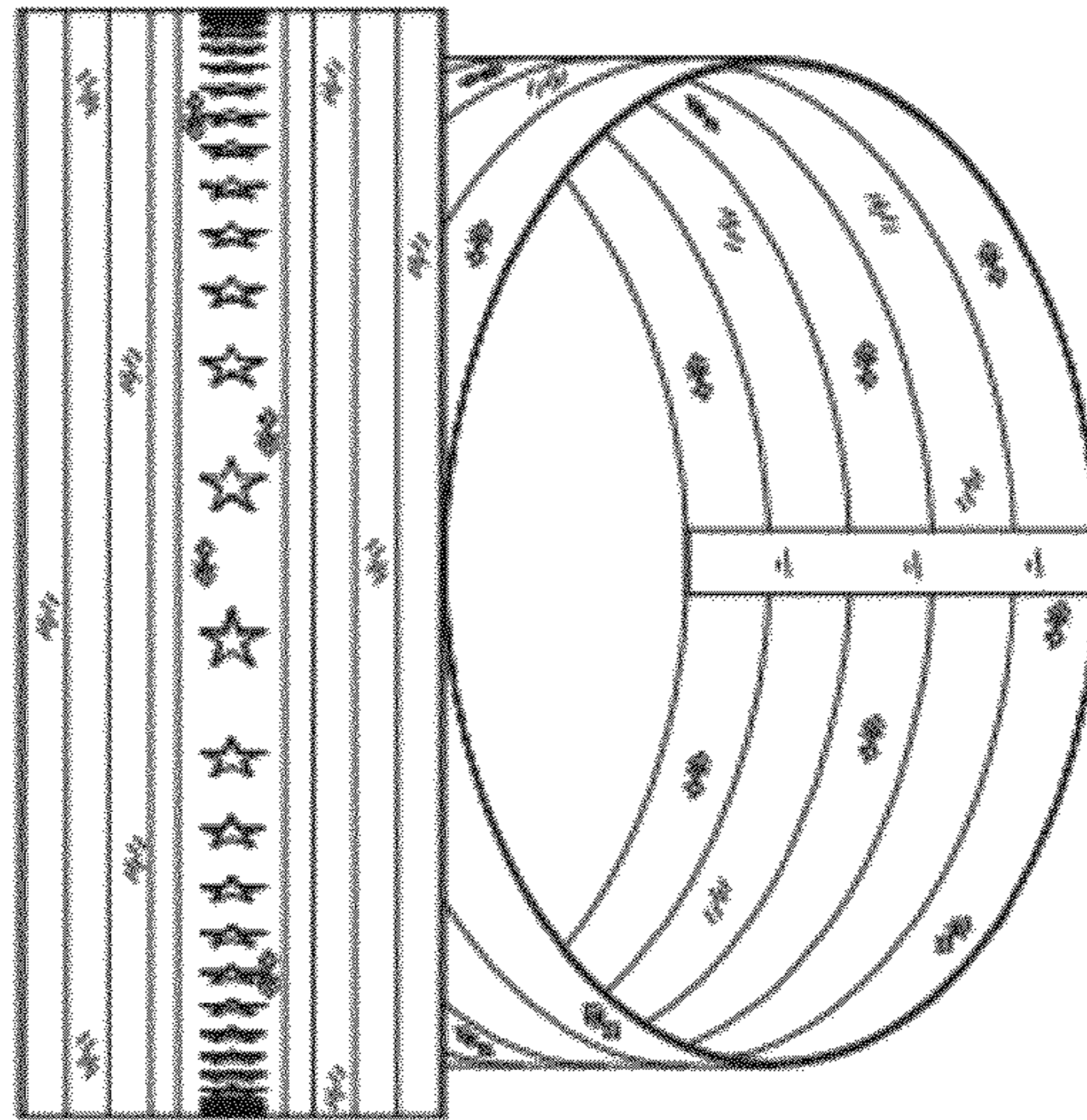

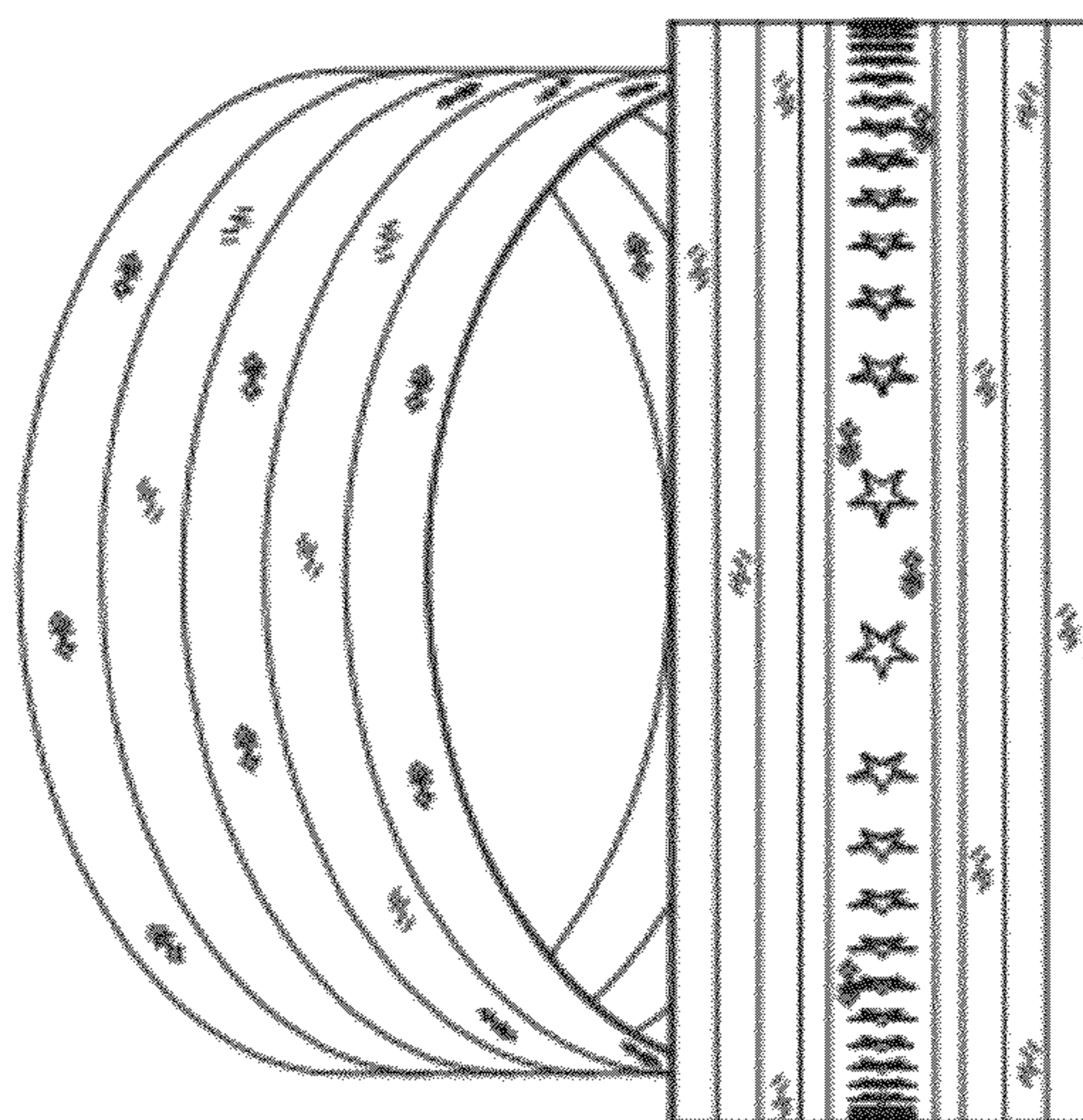

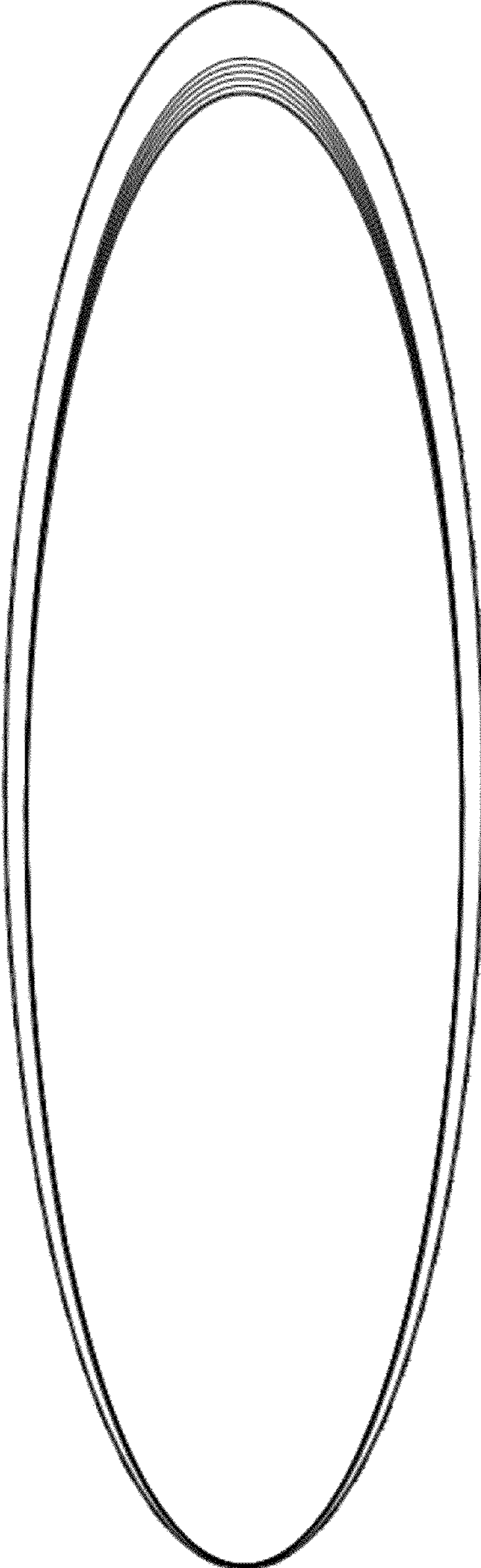

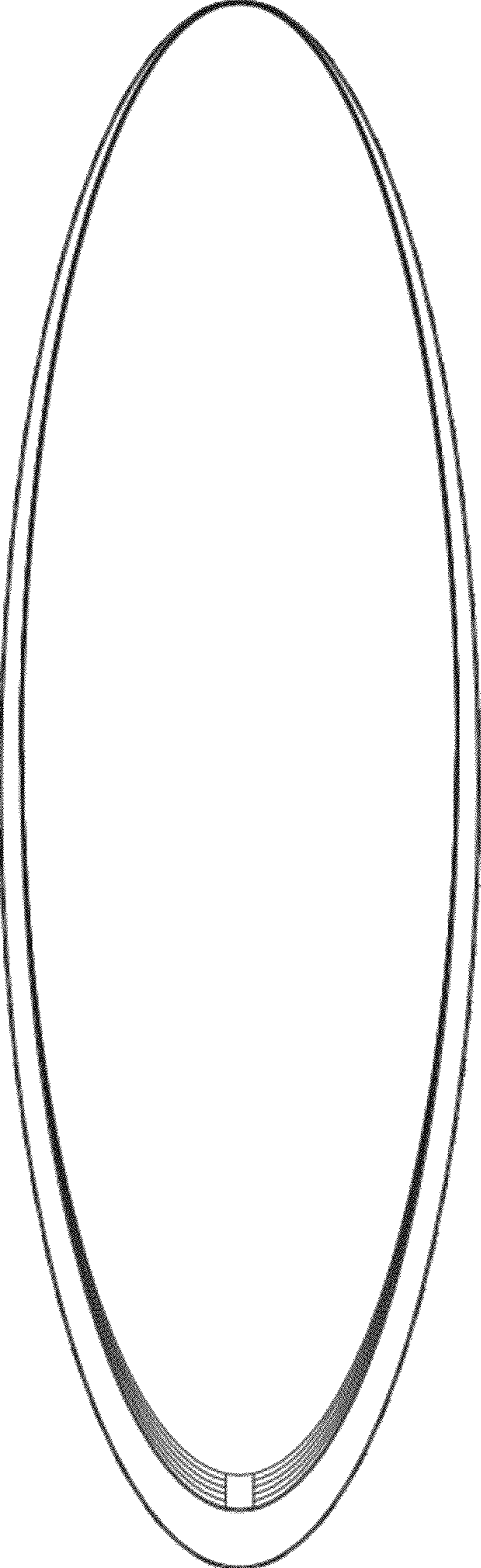

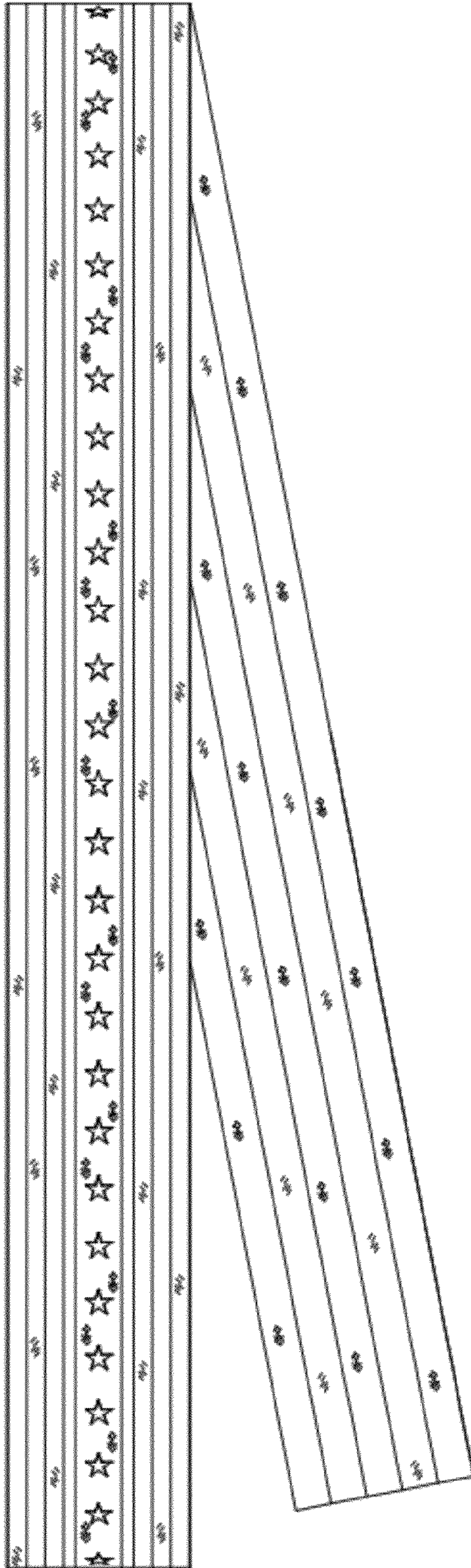

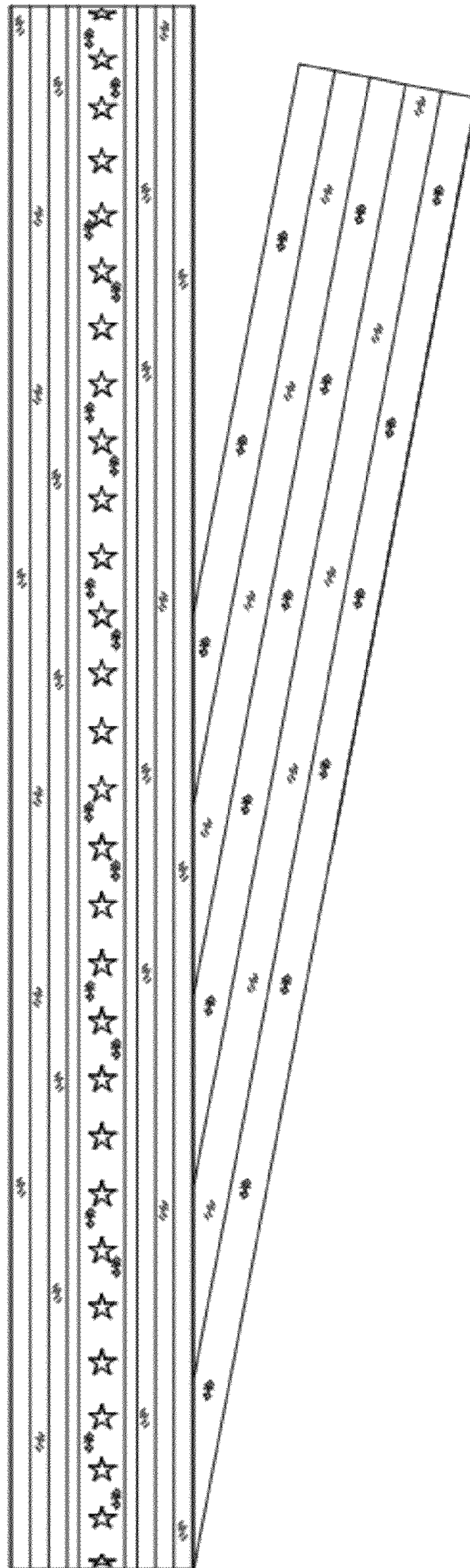
