FIG. 1 is a top perspective view of a footing plate showing my new design.

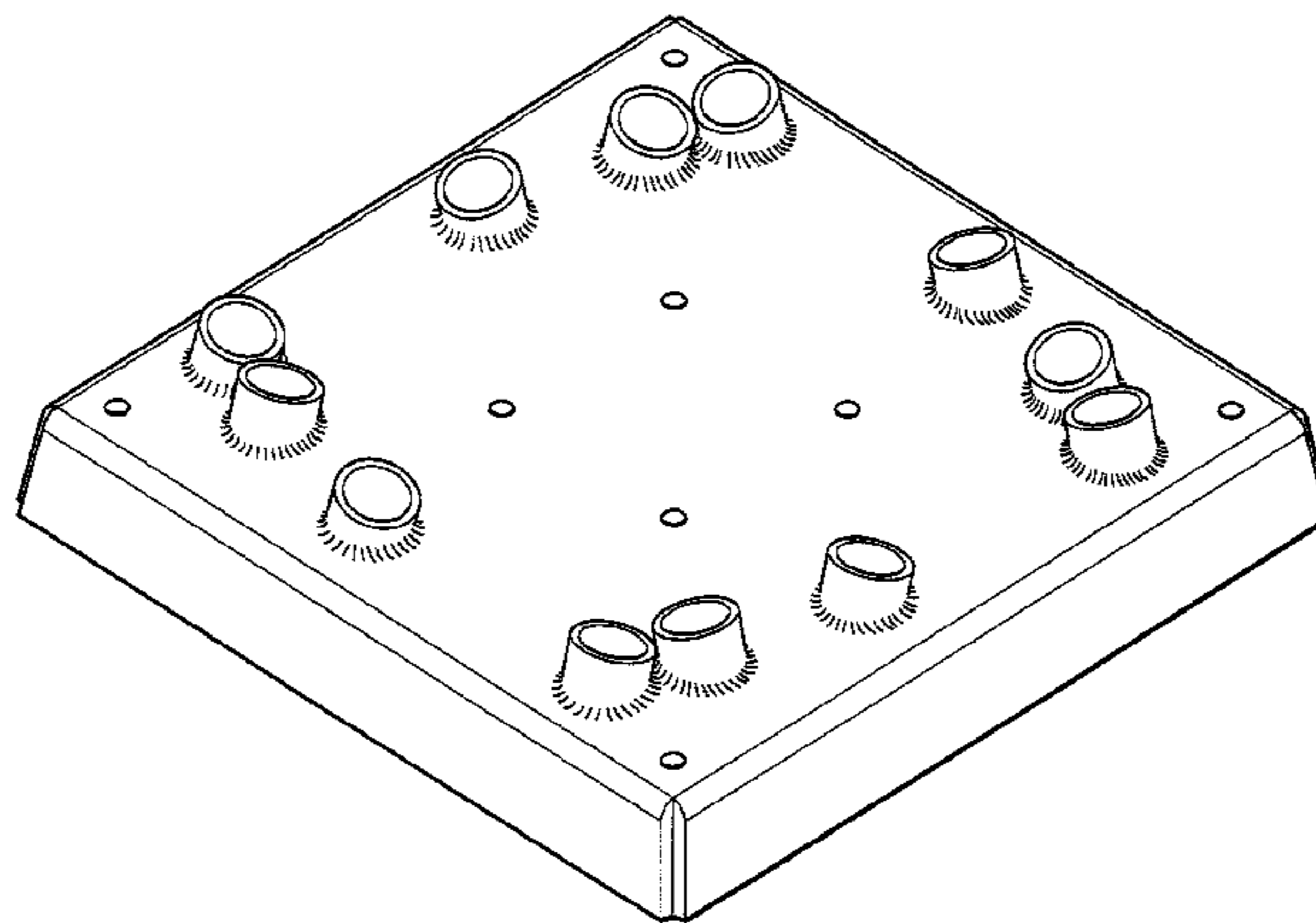
FIG. 2 is a bottom perspective view thereof.

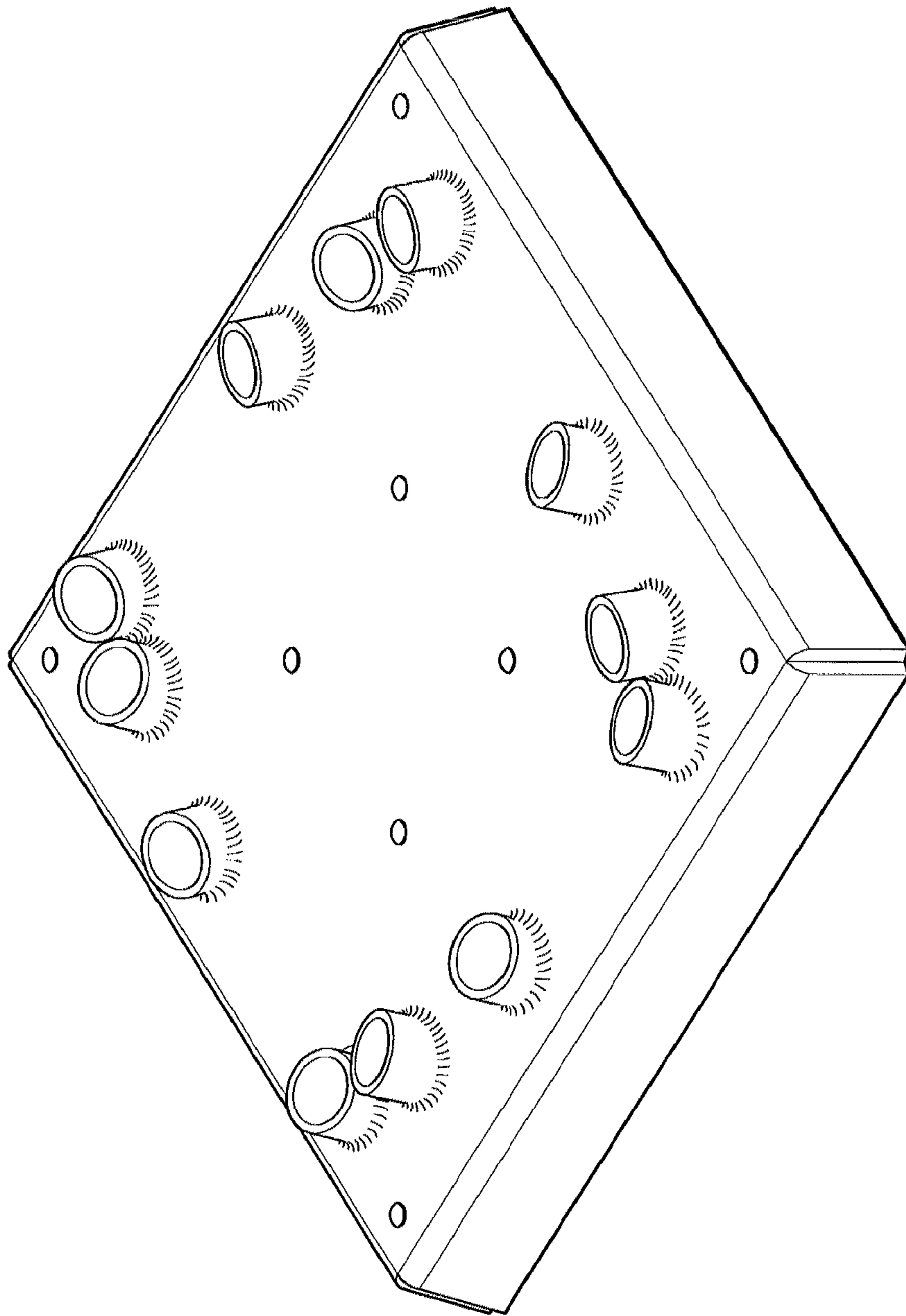

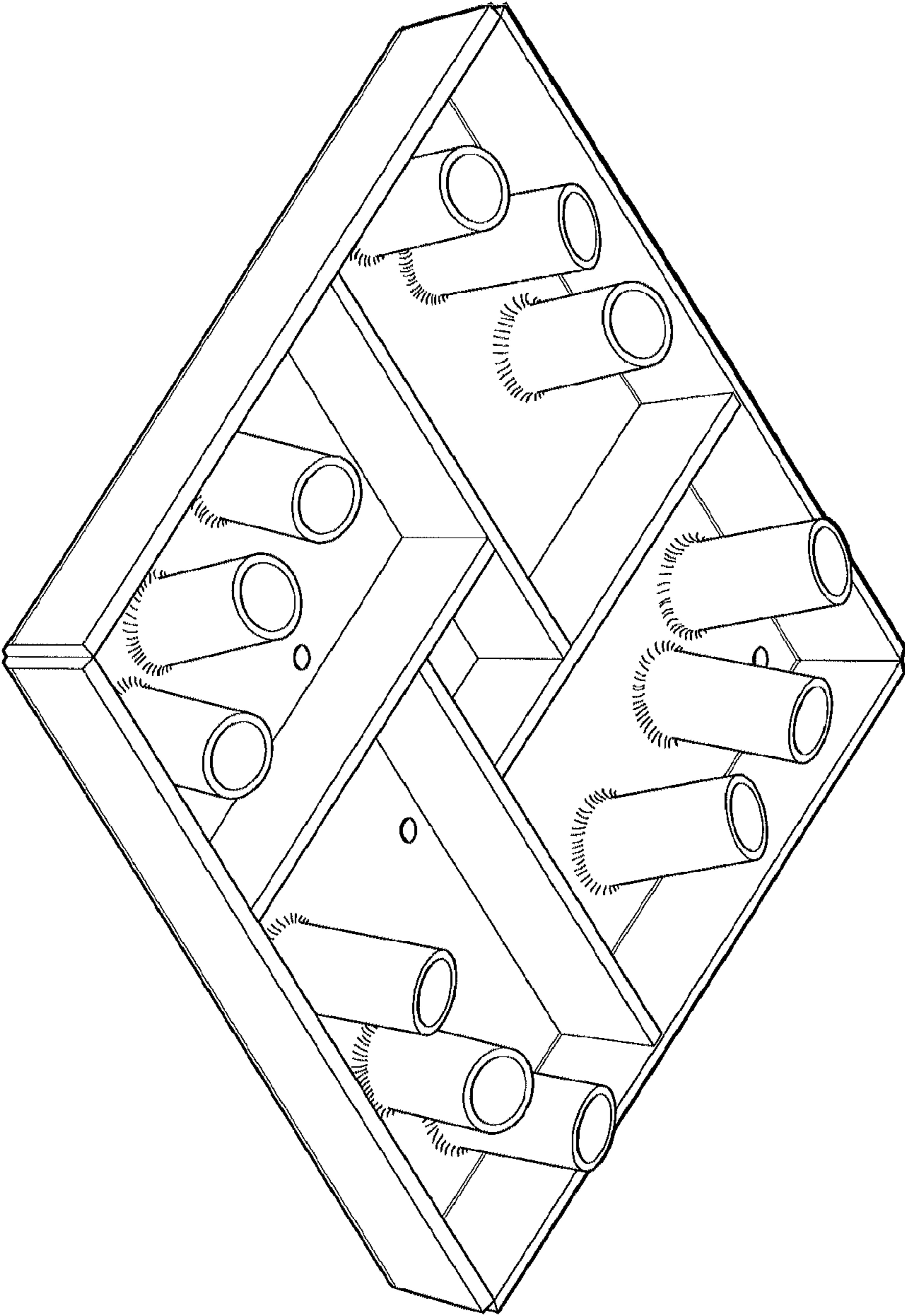

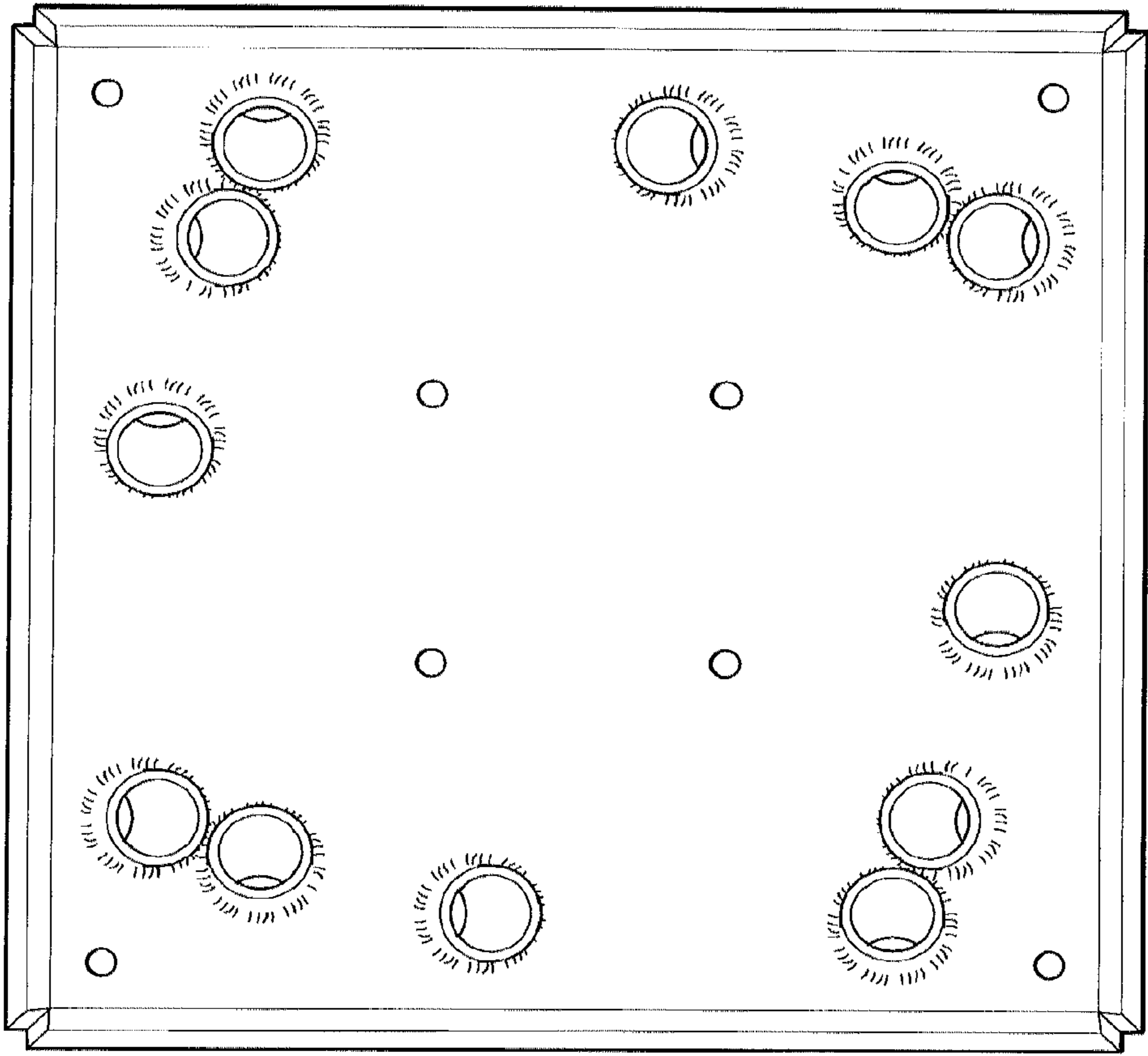

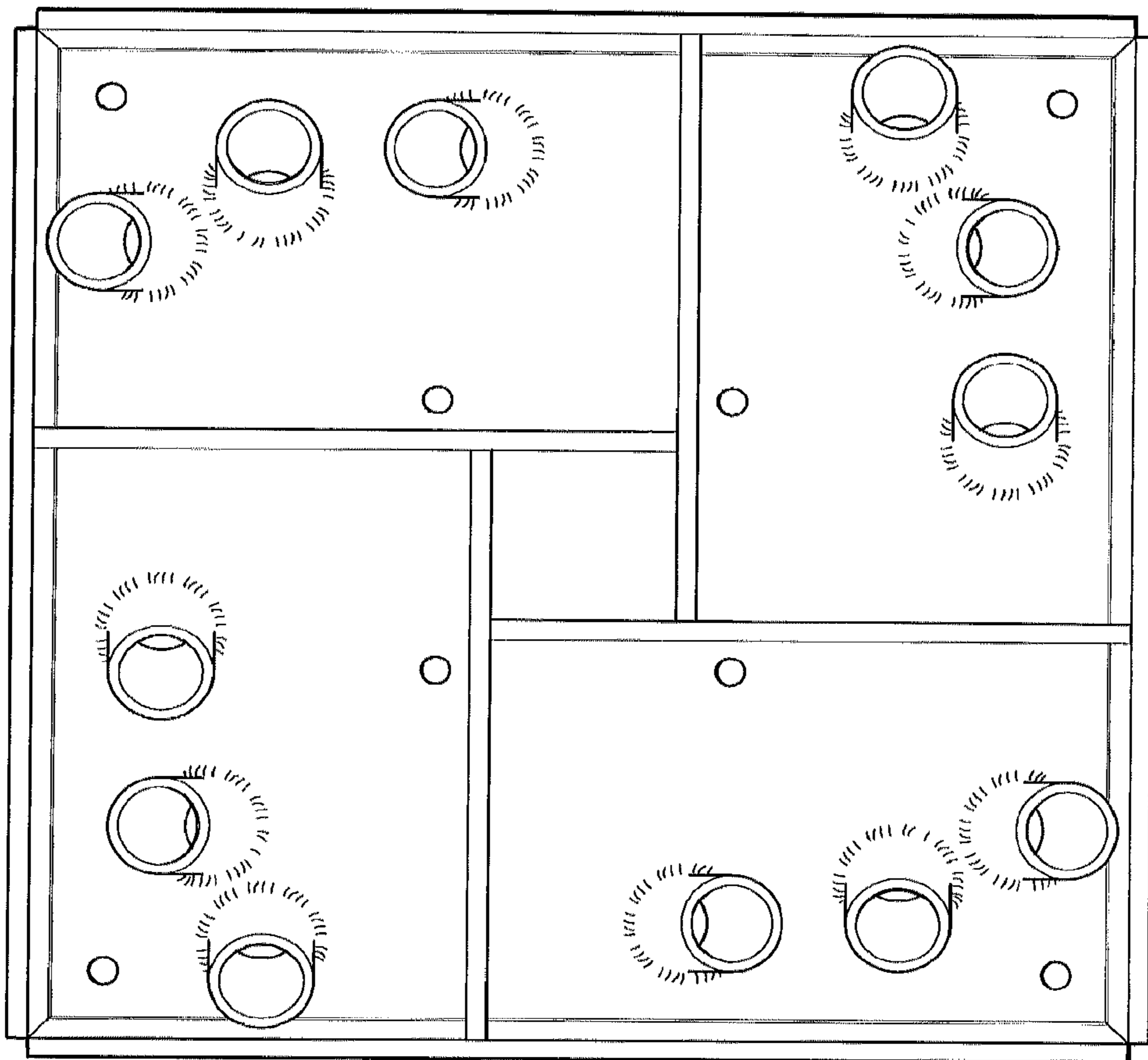

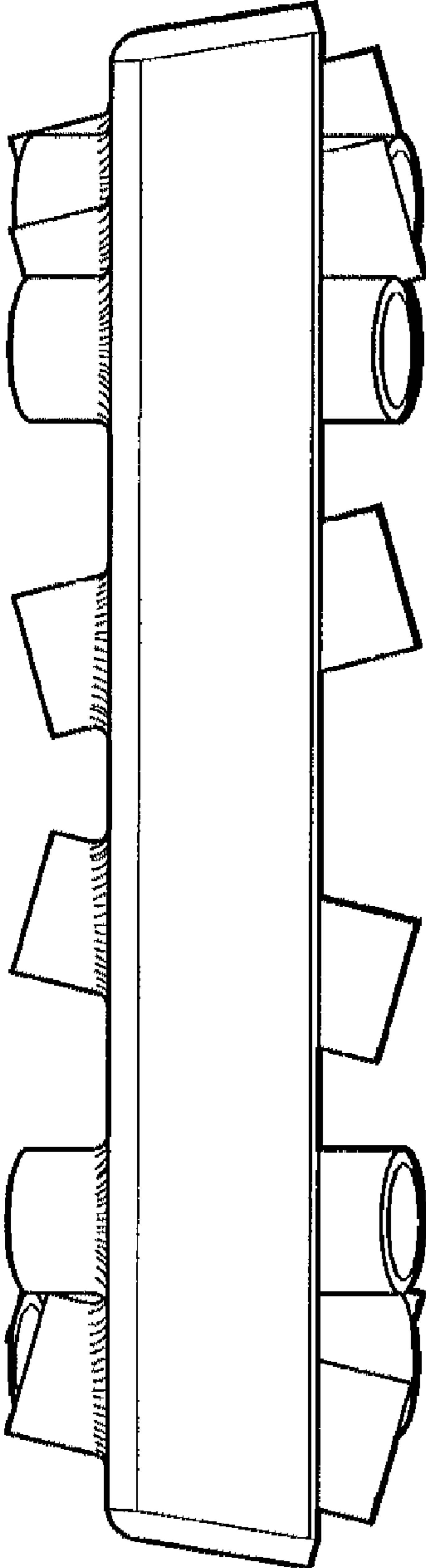
