(57) **CLAIM**
The ornamental design for an automobile floor mat clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automobile floor mat clip showing our new design;
FIG. 2 is a reference perspective view when a retention plug is inserted between a pair of locking members thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a left side view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a cross sectional view taken along line 8-8 in FIG. 4;
FIG. 9 is an end view taken along line 9-9 in FIG. 3;
FIG. 10 is a reference cross sectional view showing a usage state thereof; and,
FIG. 11 is a reference end view taken along line 11-11 in FIG. 10.
The broken lines in the drawings represent unclaimed environmental structure.

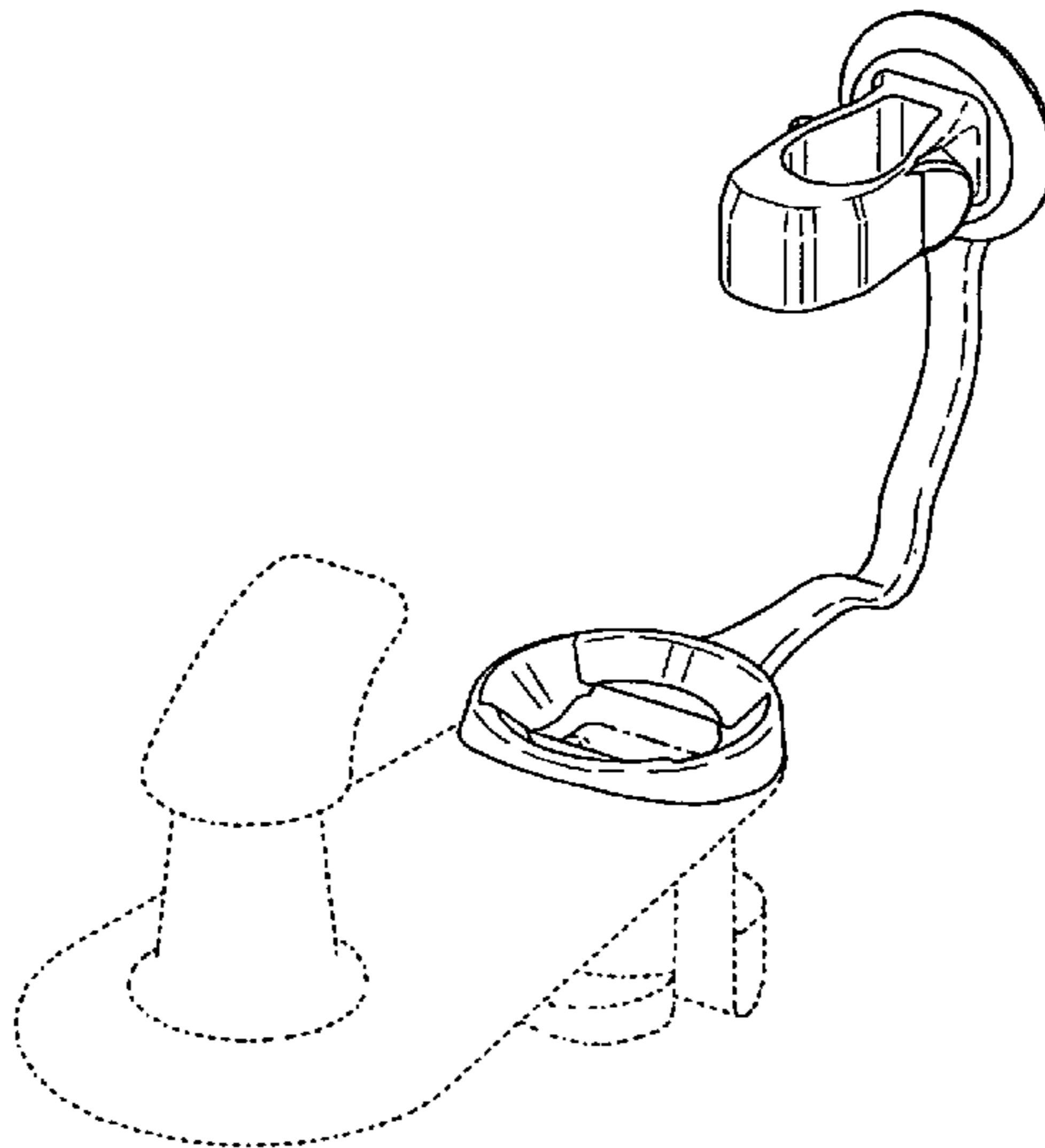

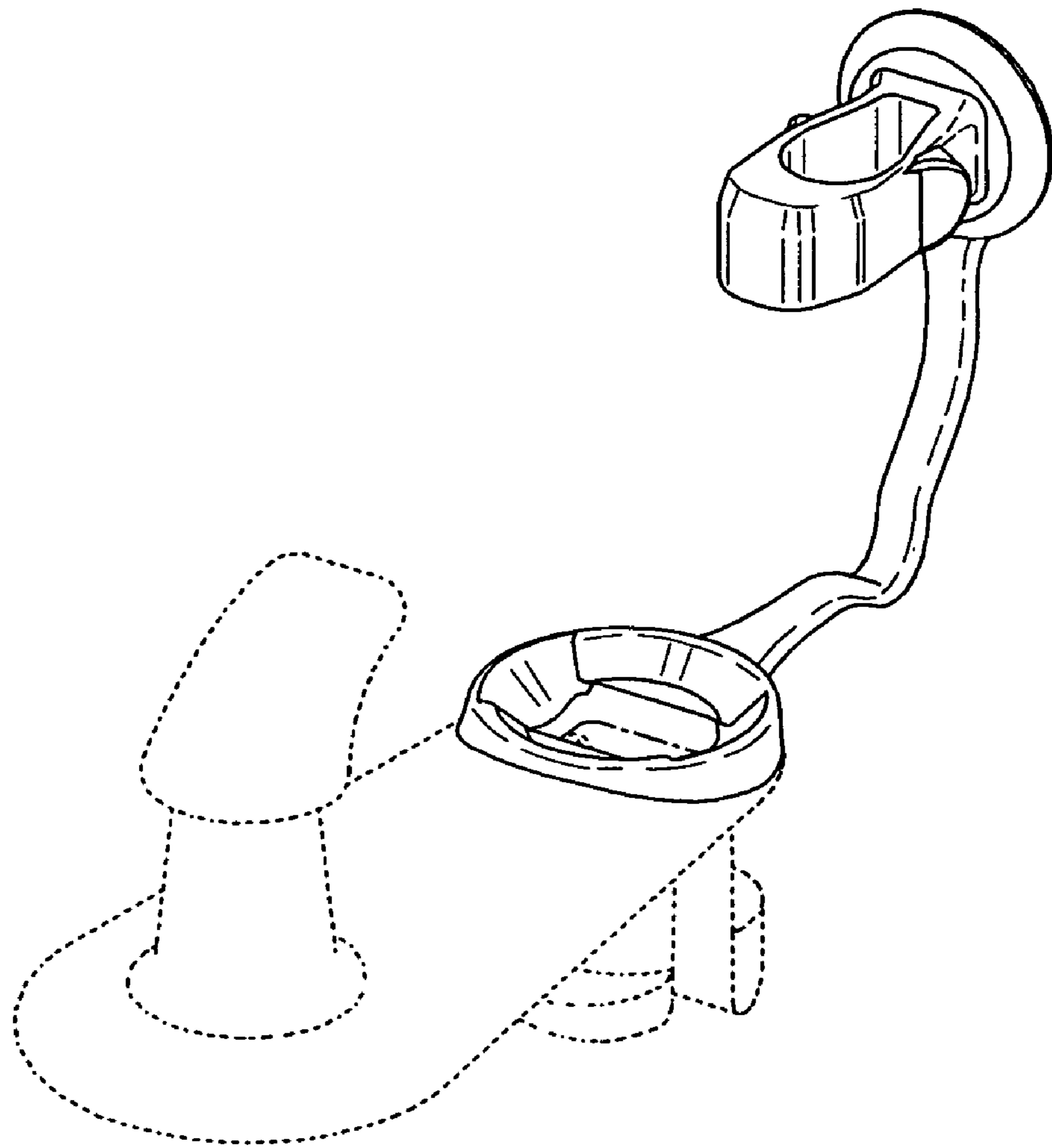

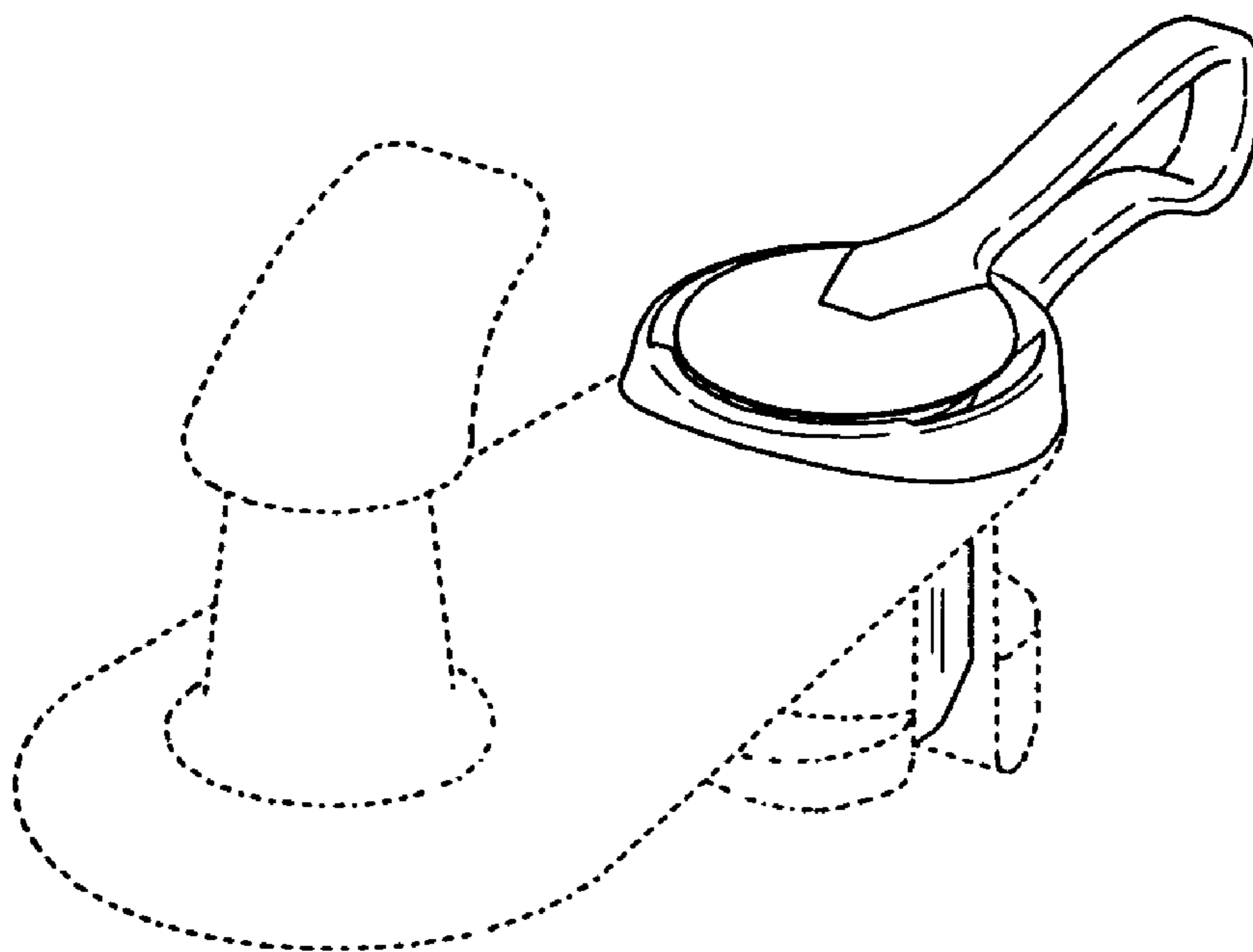

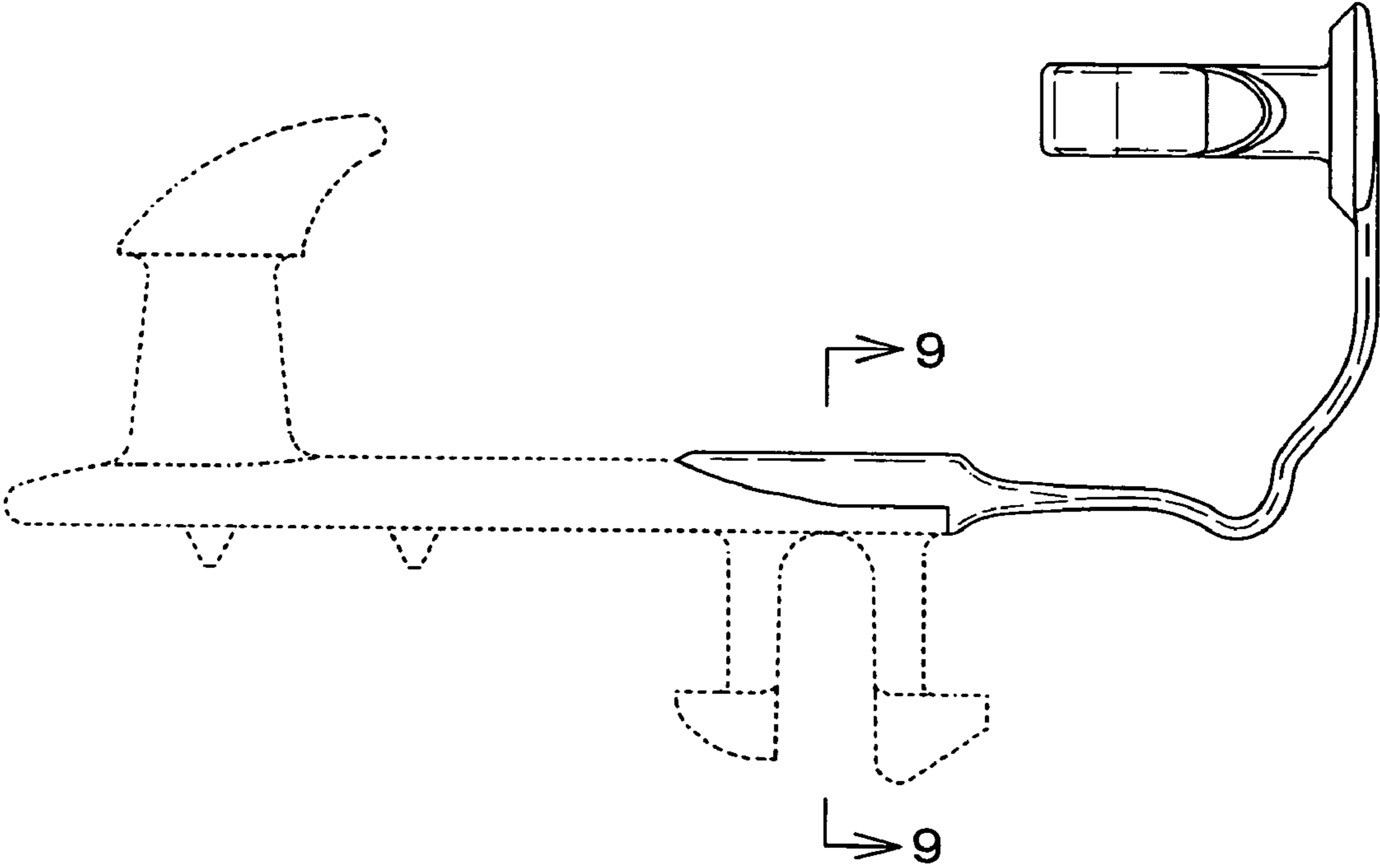

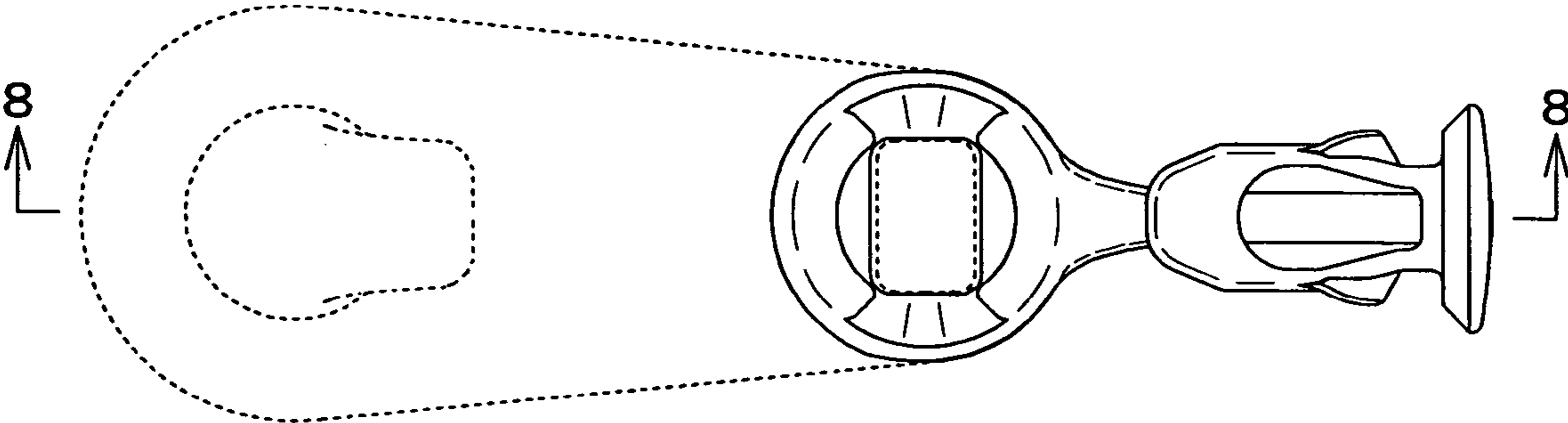

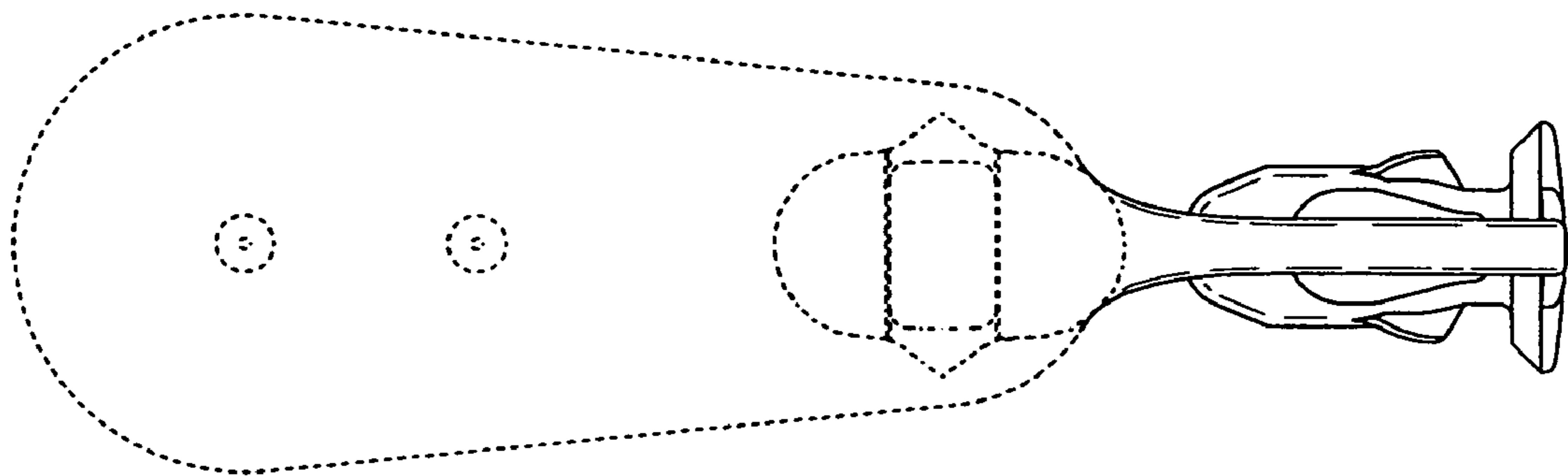

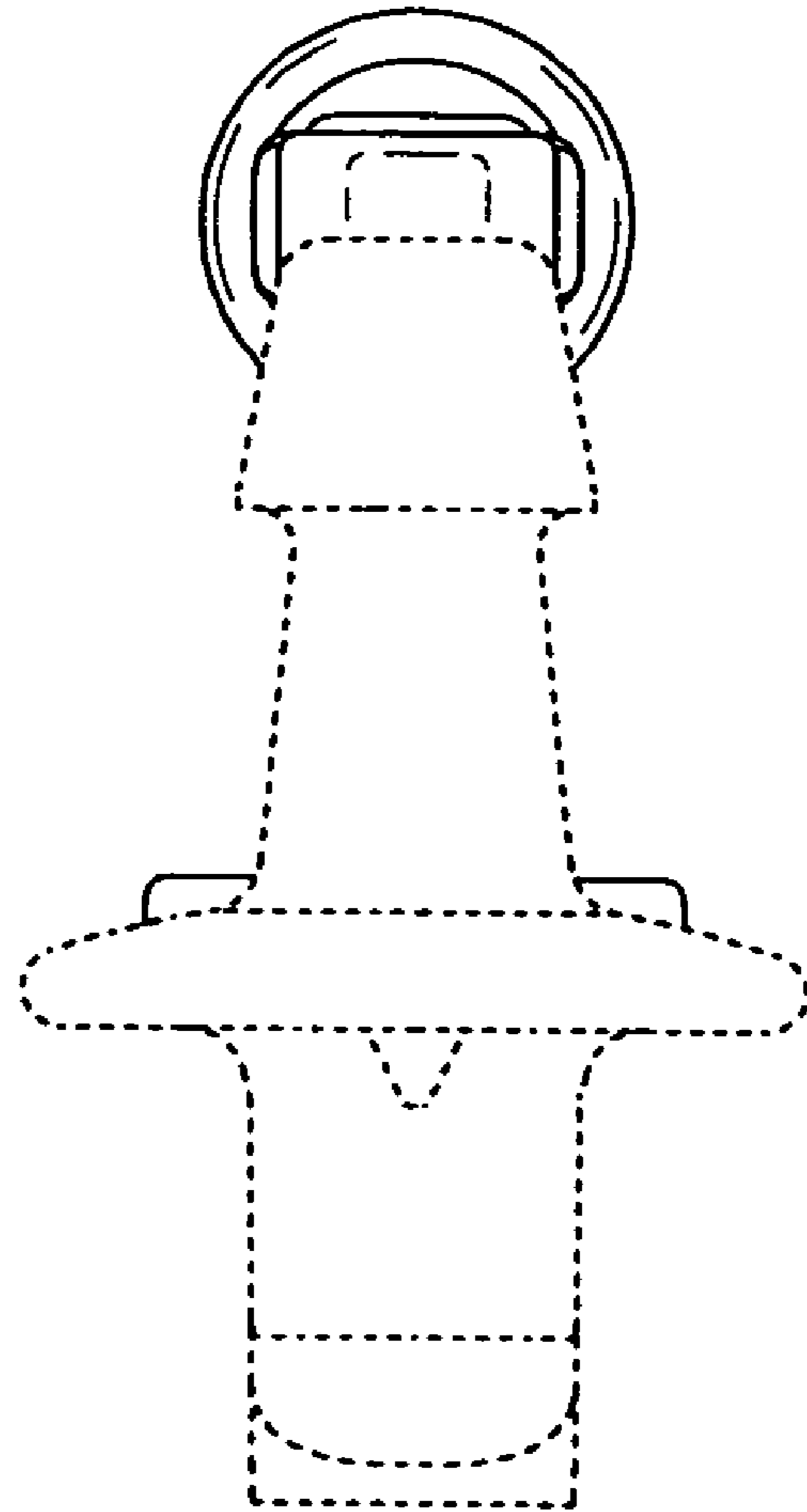

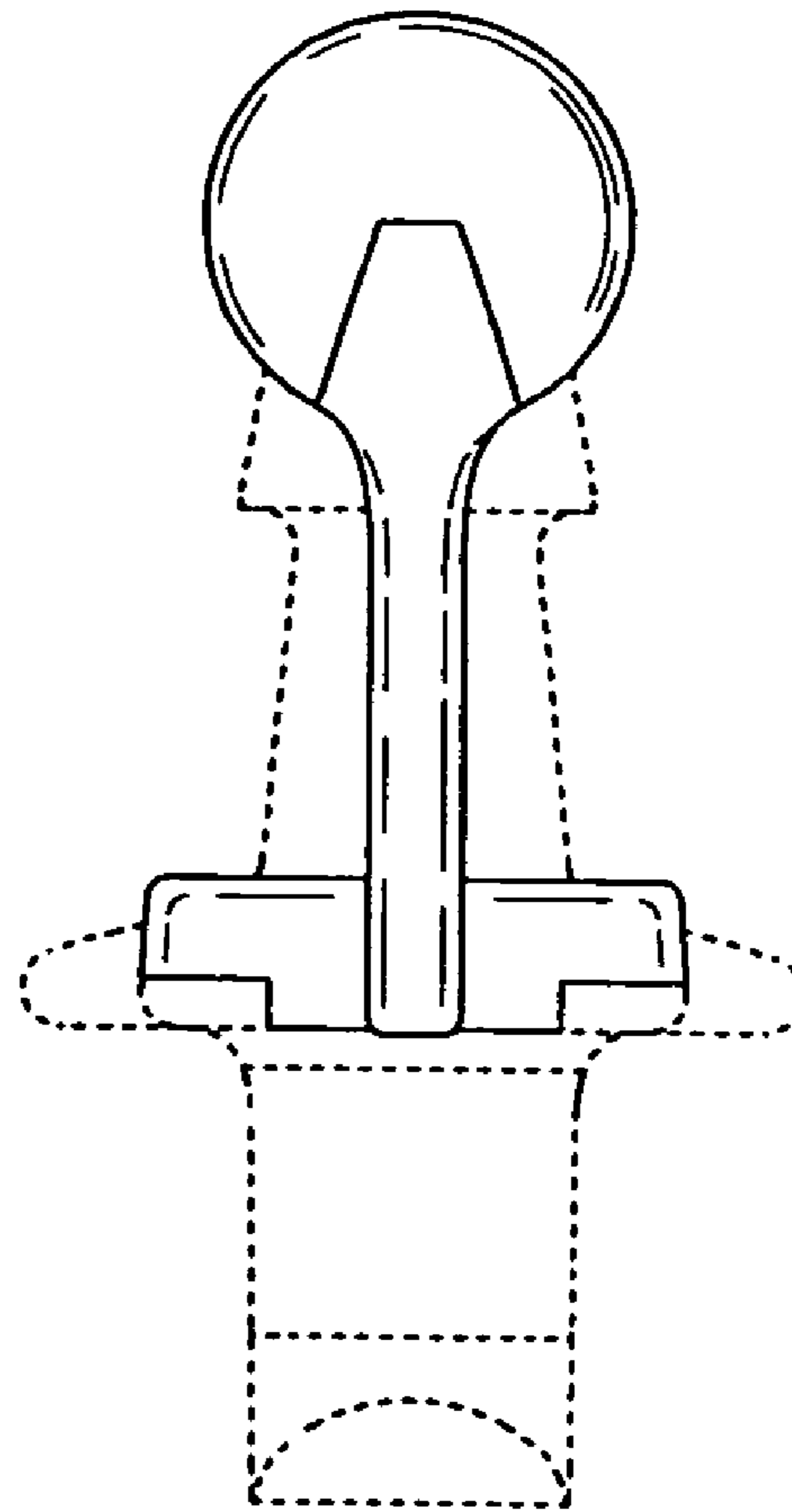

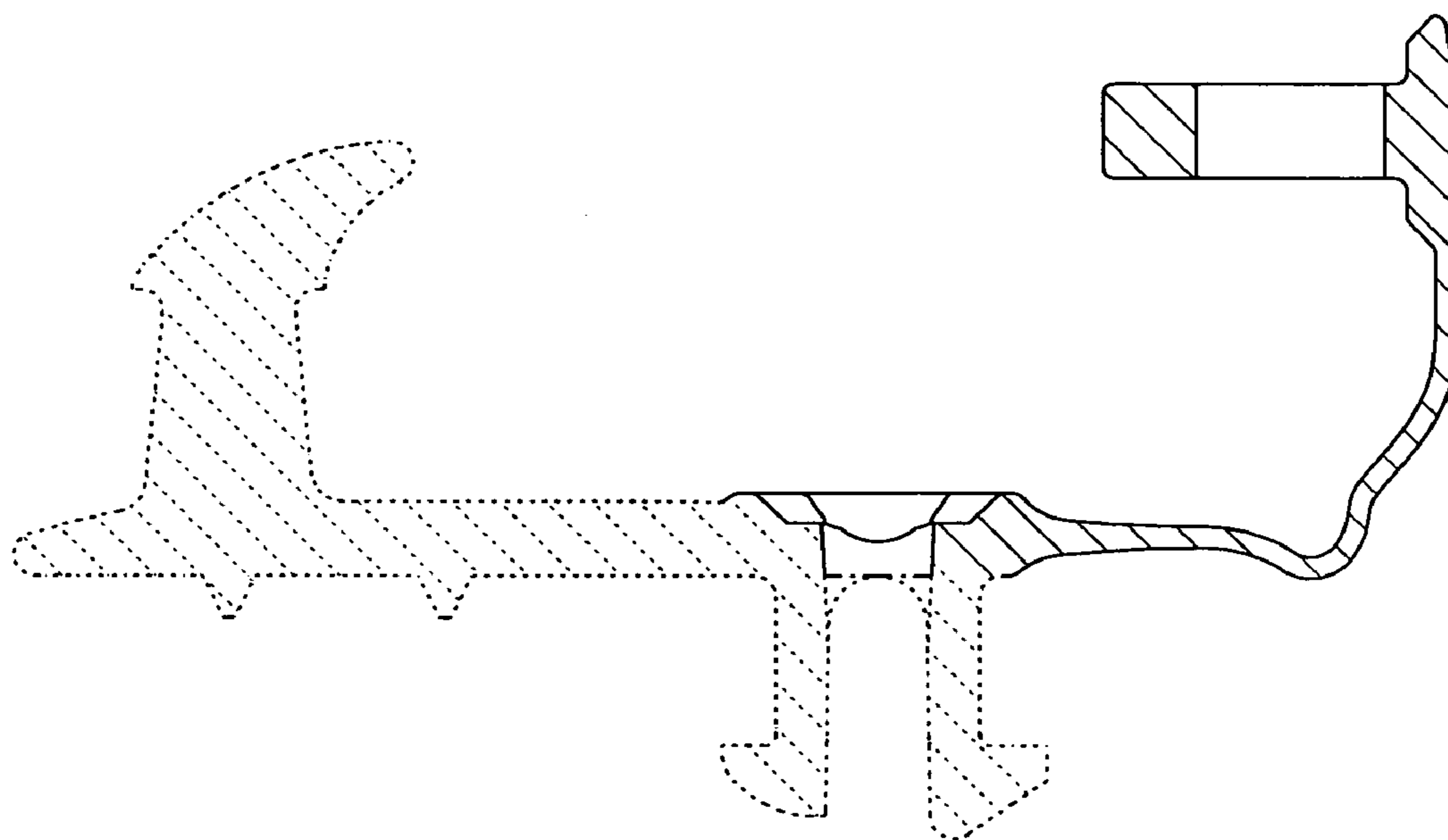

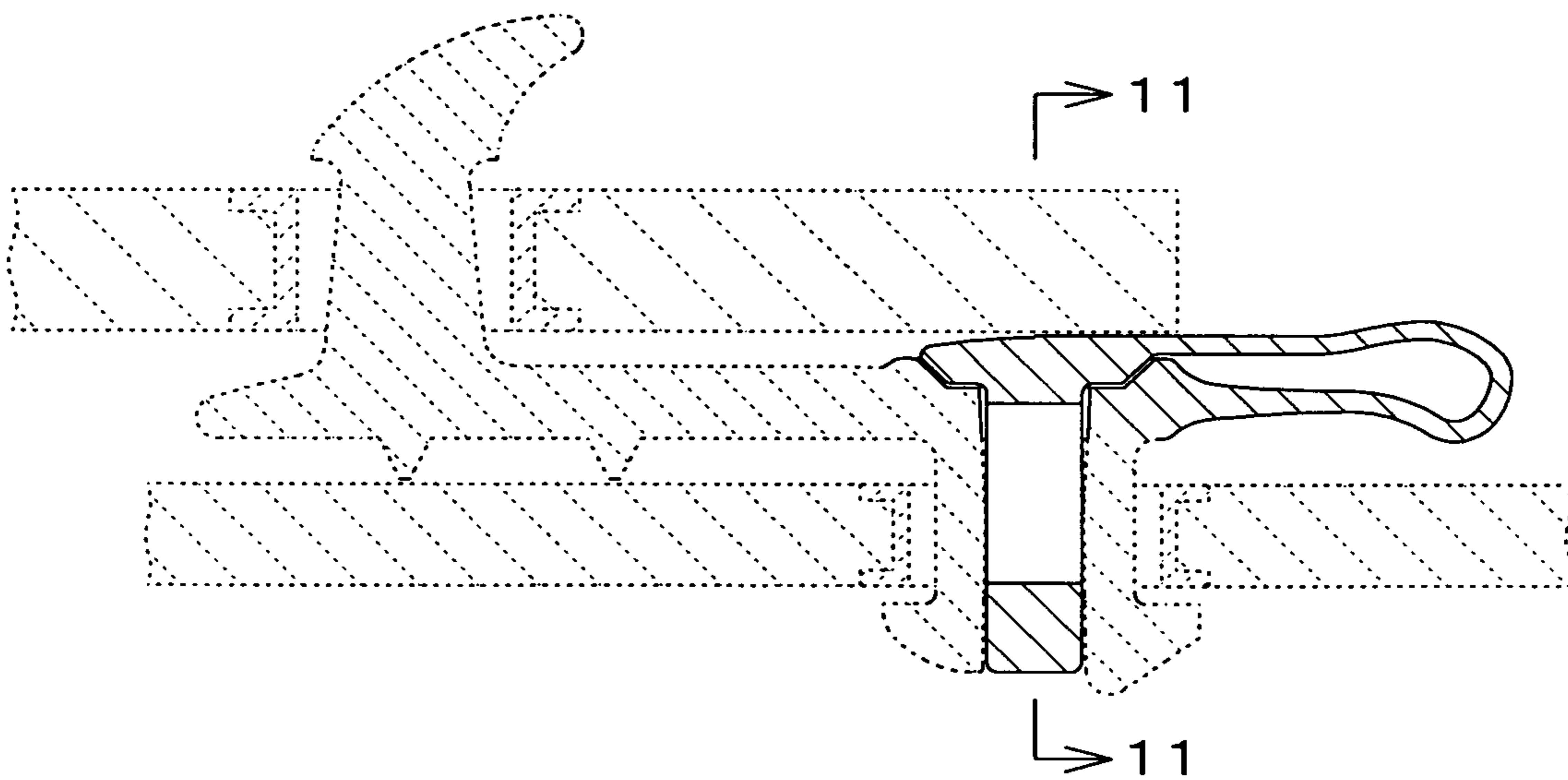
