DESCRIPTION

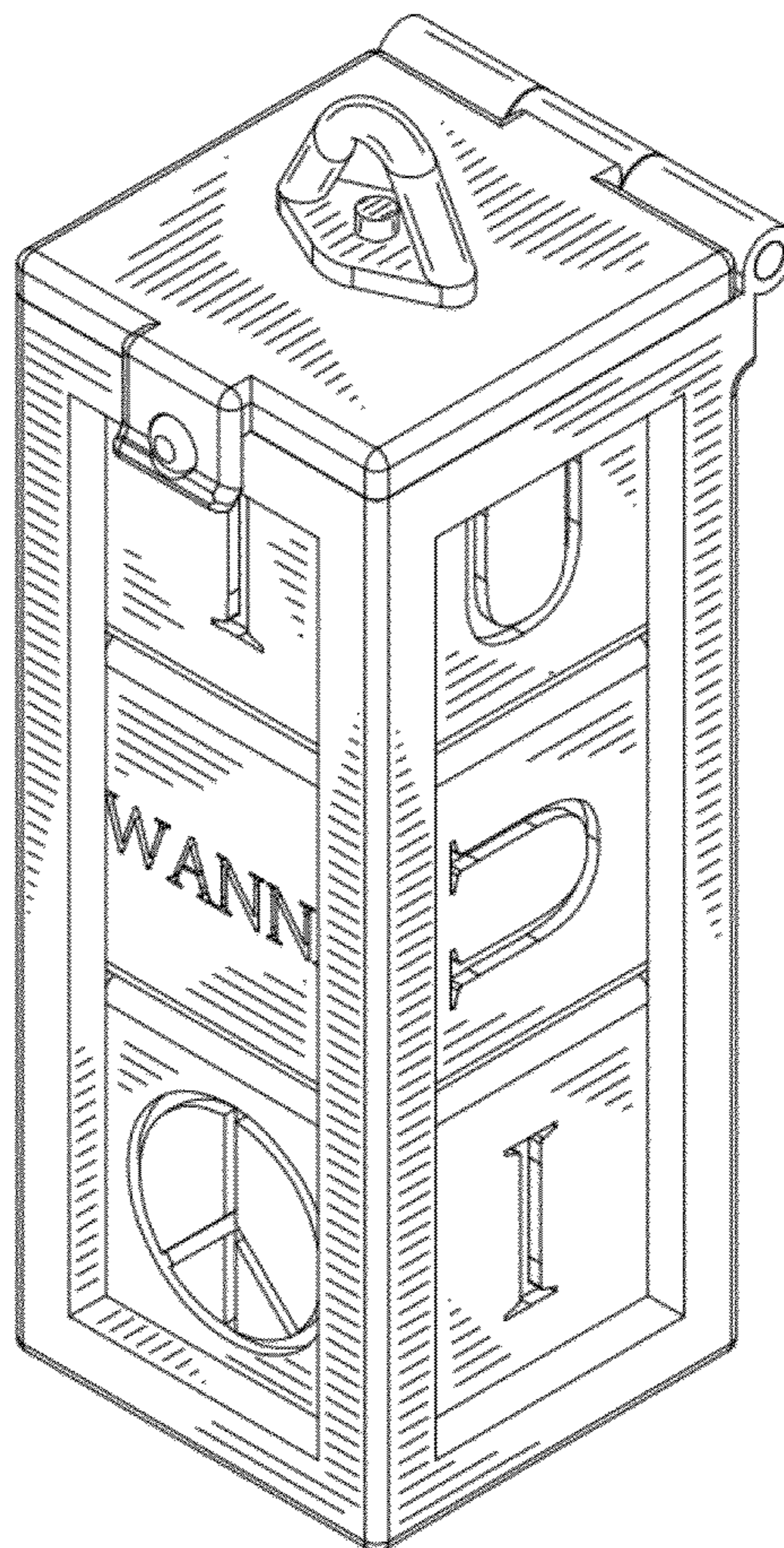
FIG. 1 is a front top right perspective view of a cube necklace;

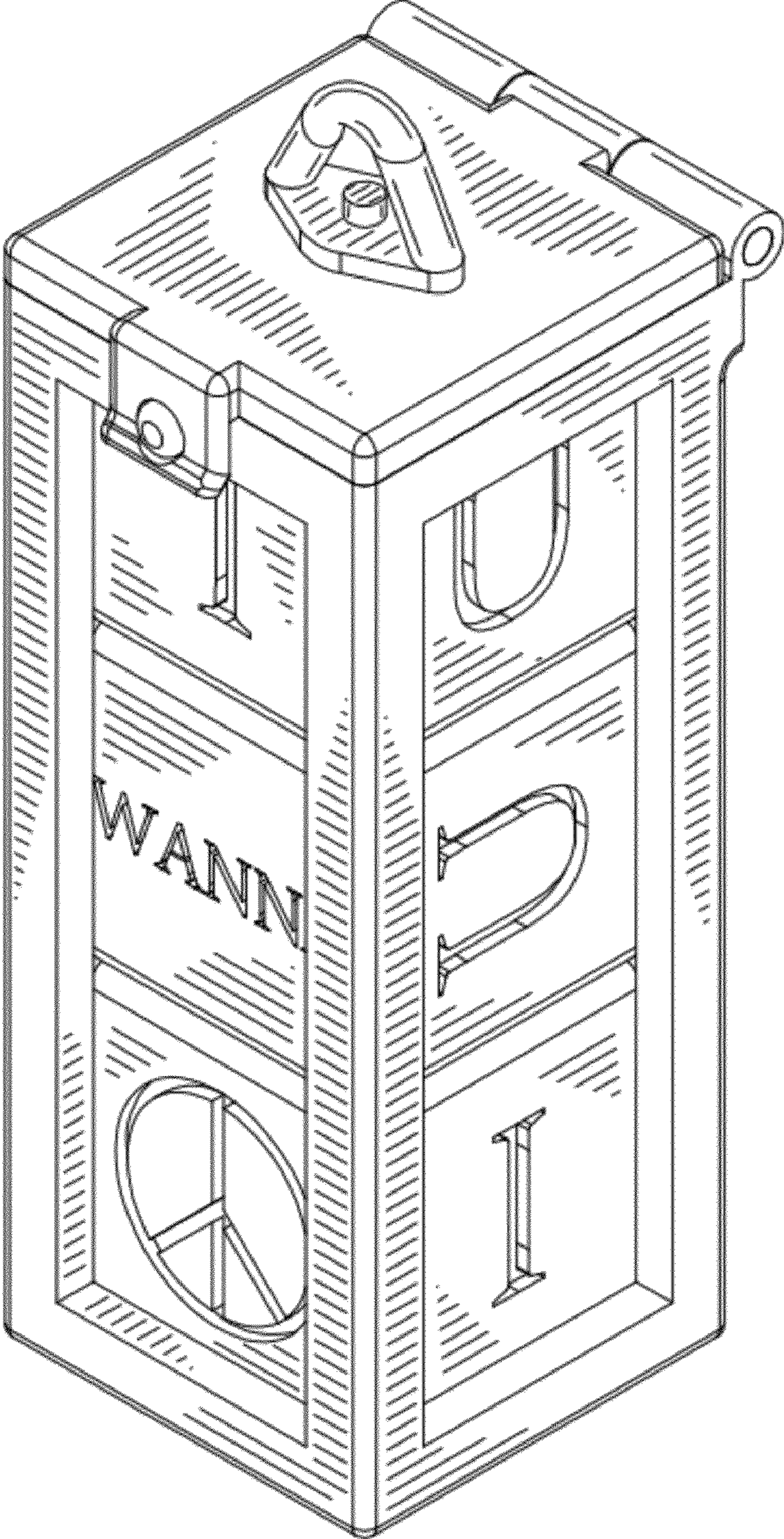

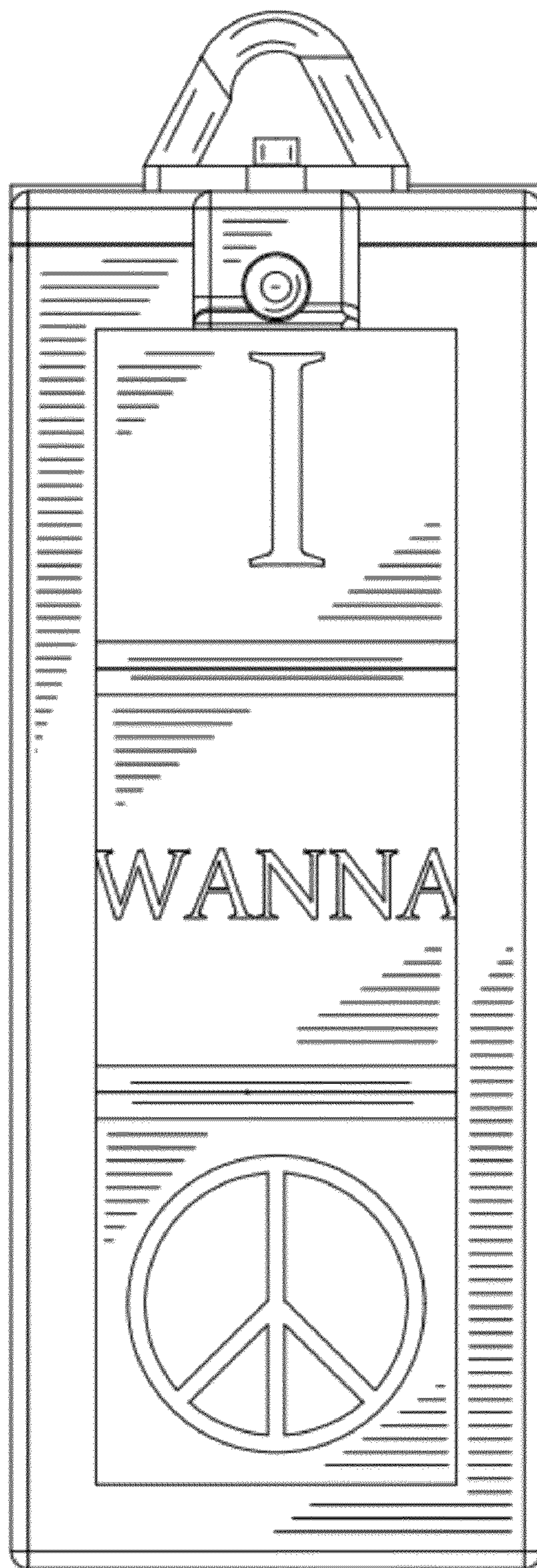

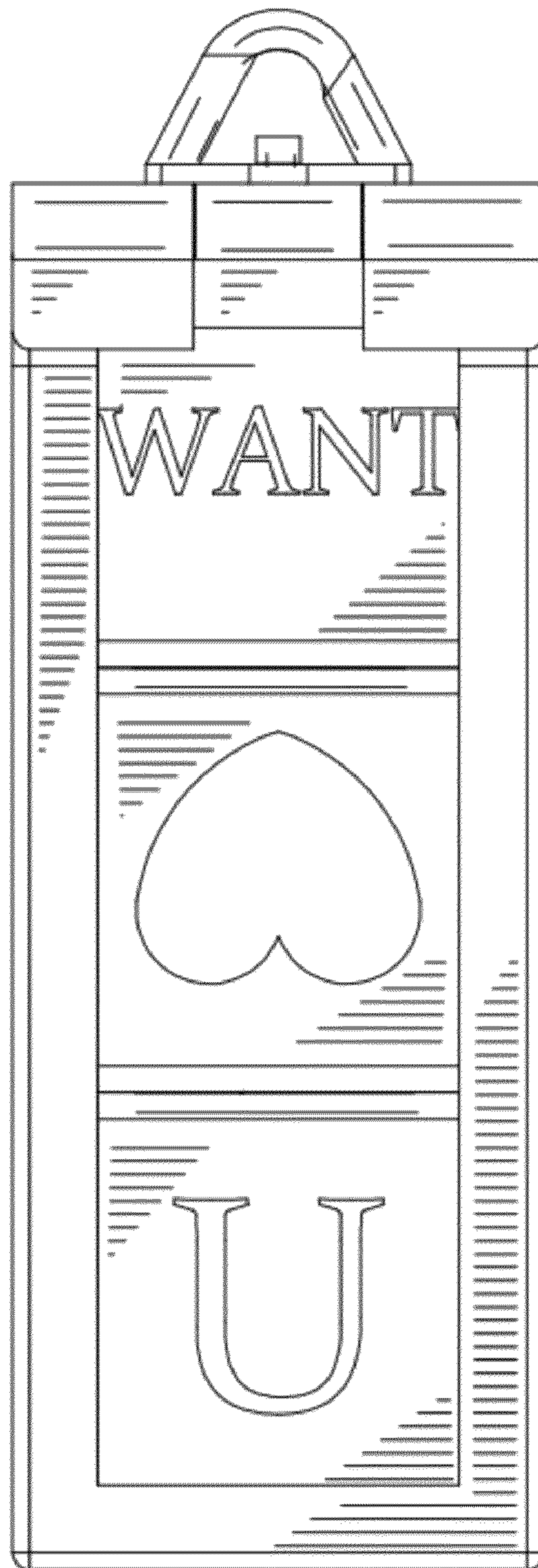

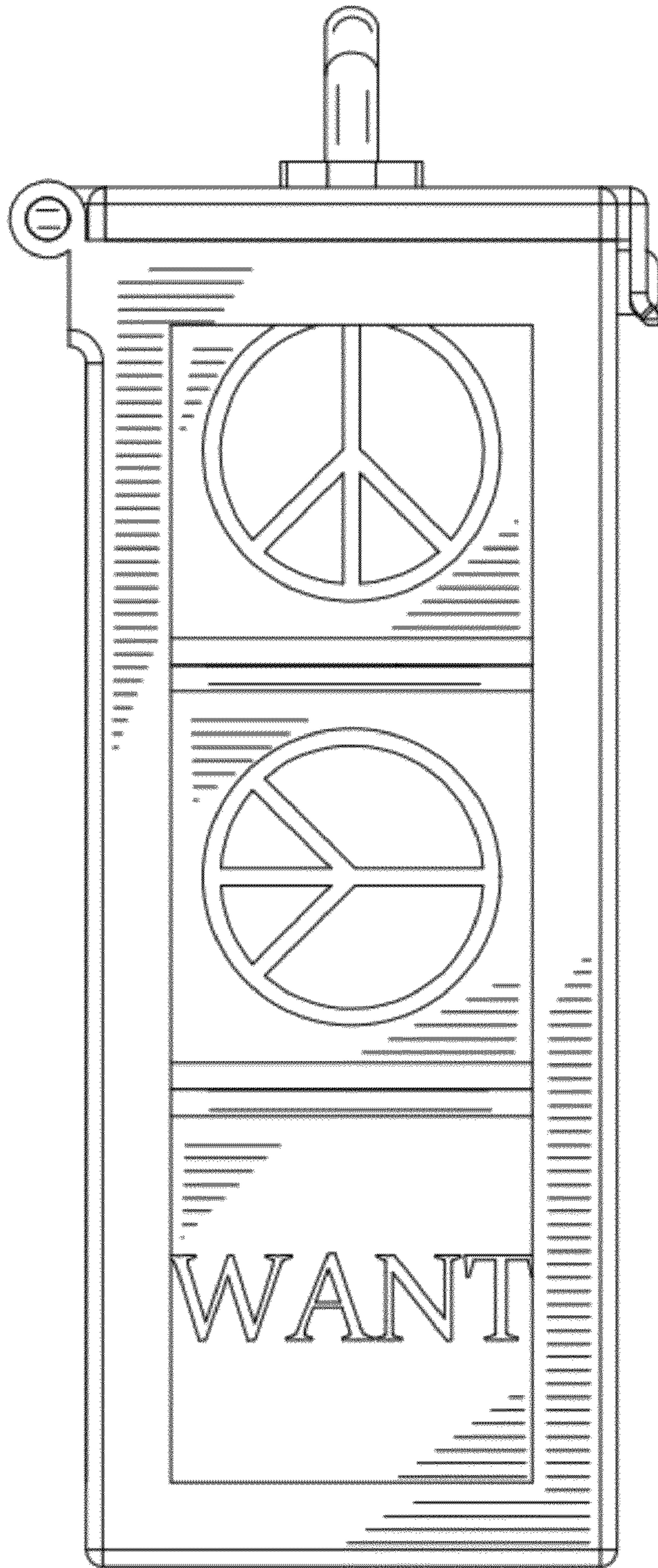

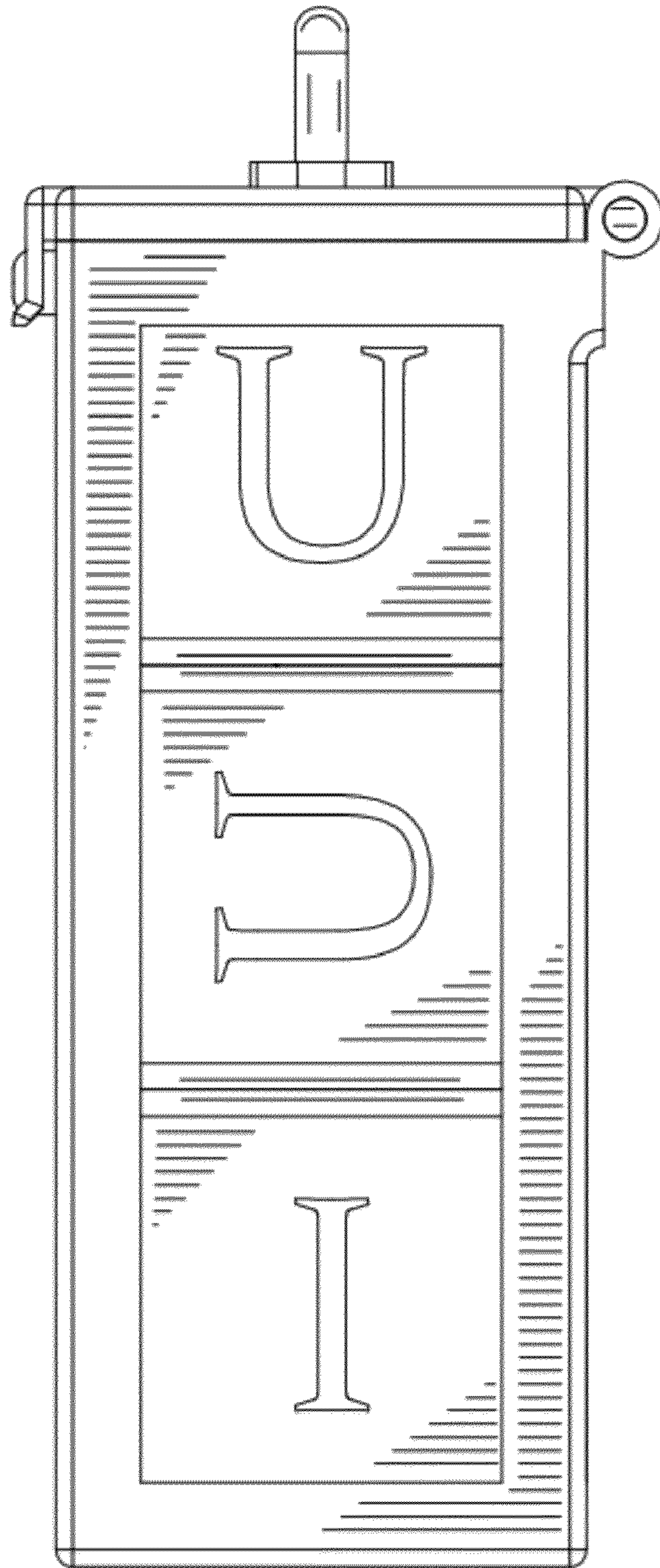

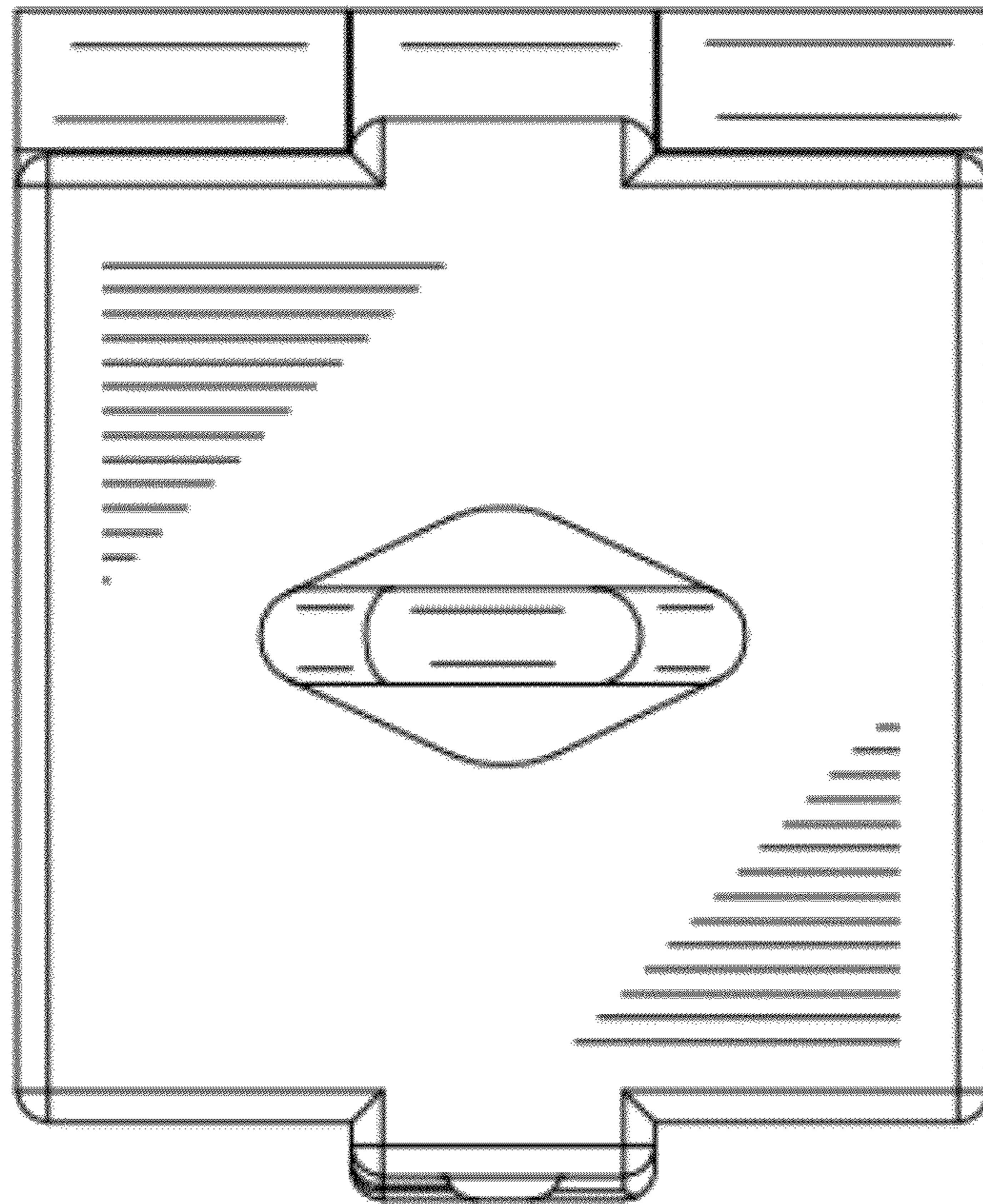

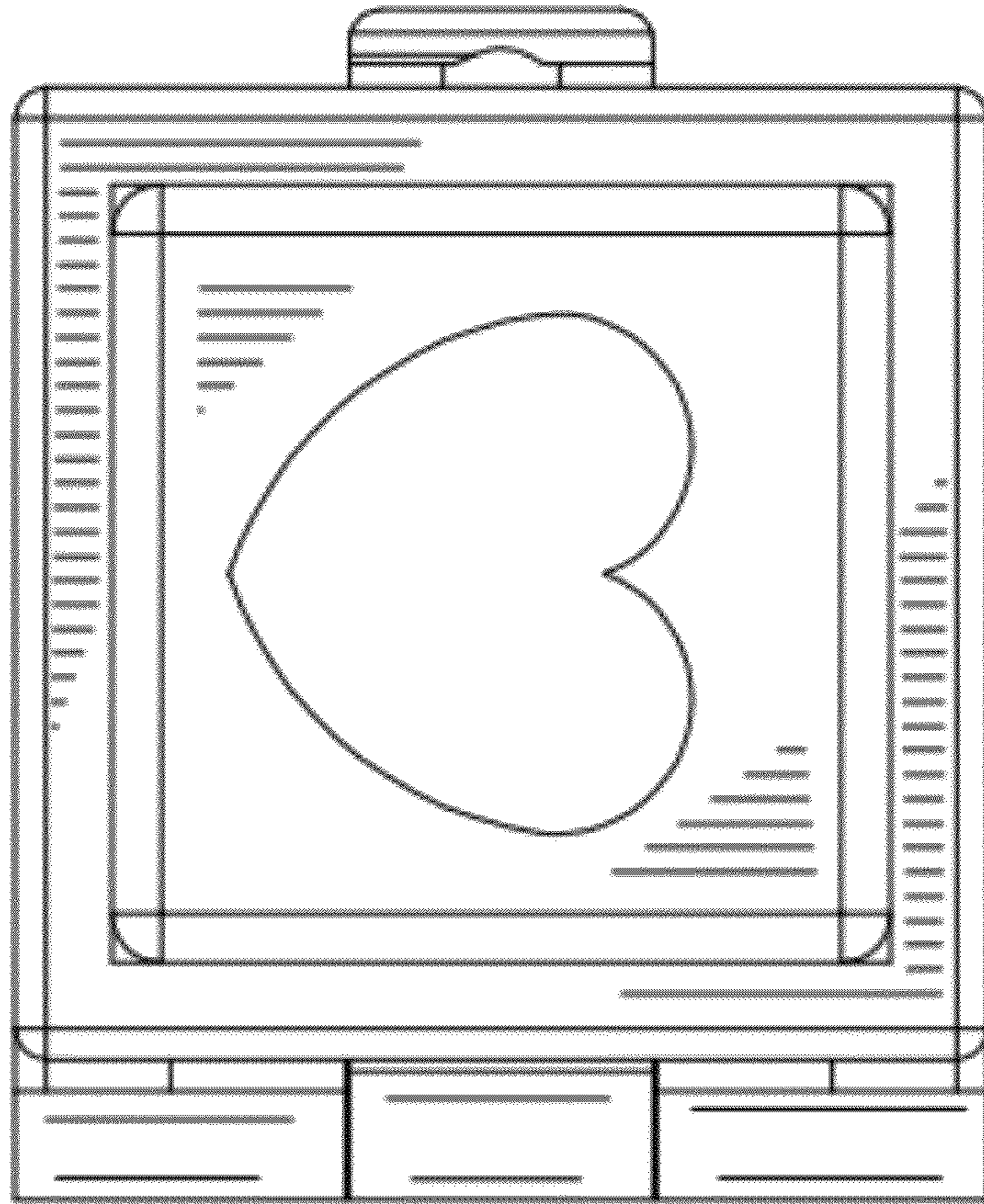
