DESCRIPTION

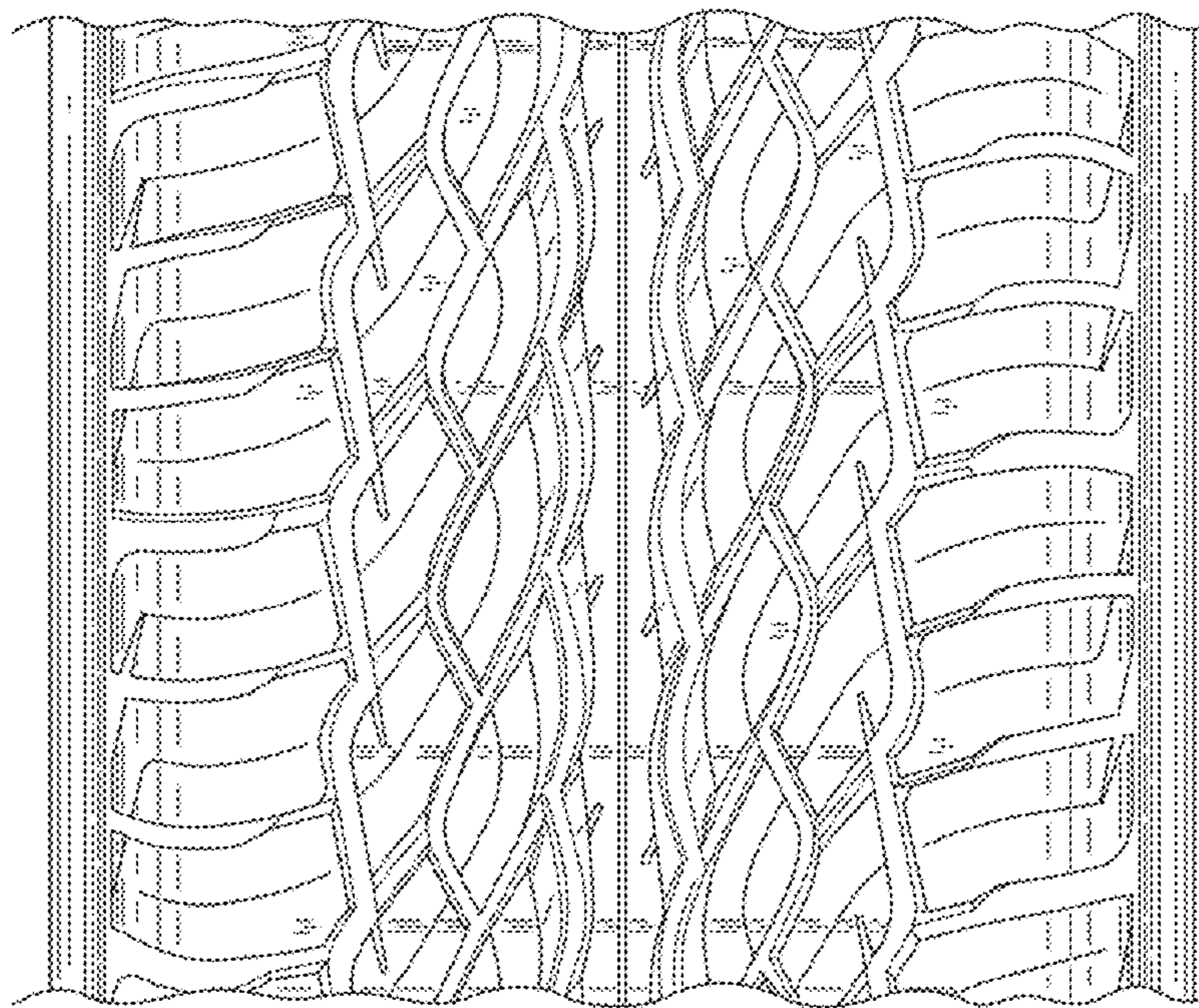
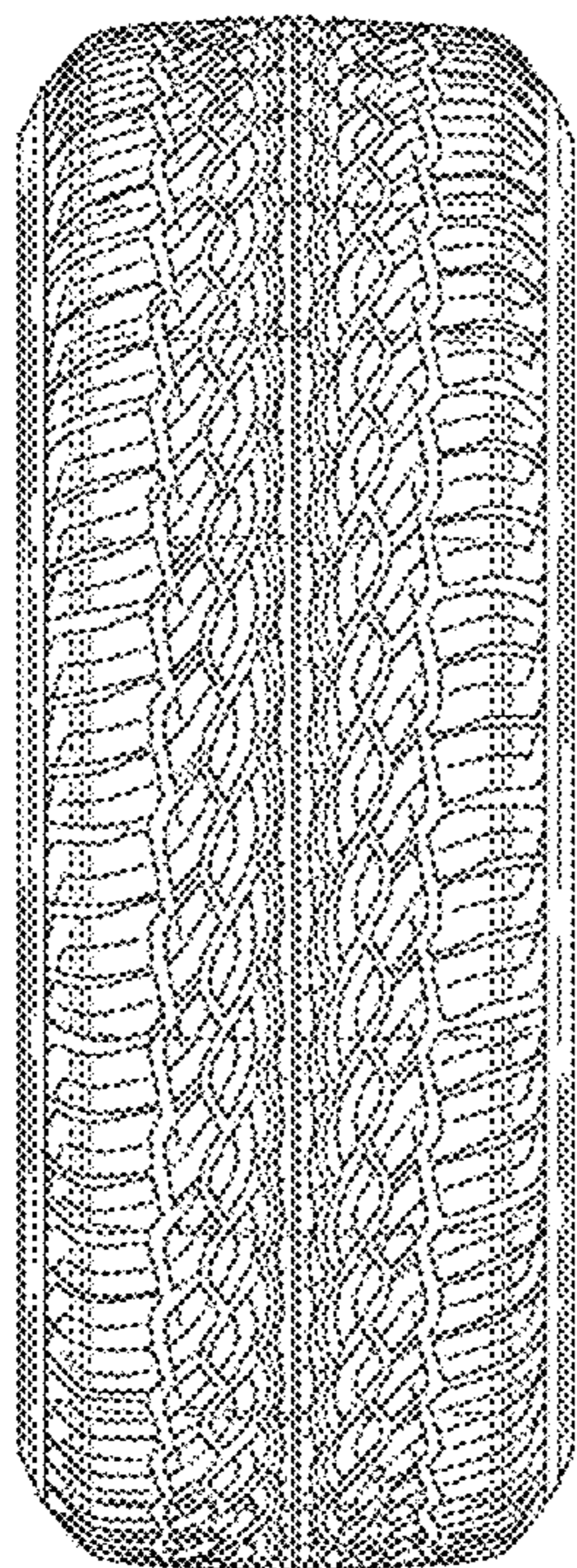
FIG. 1 is a left perspective view of a tire for automobile showing my new design;

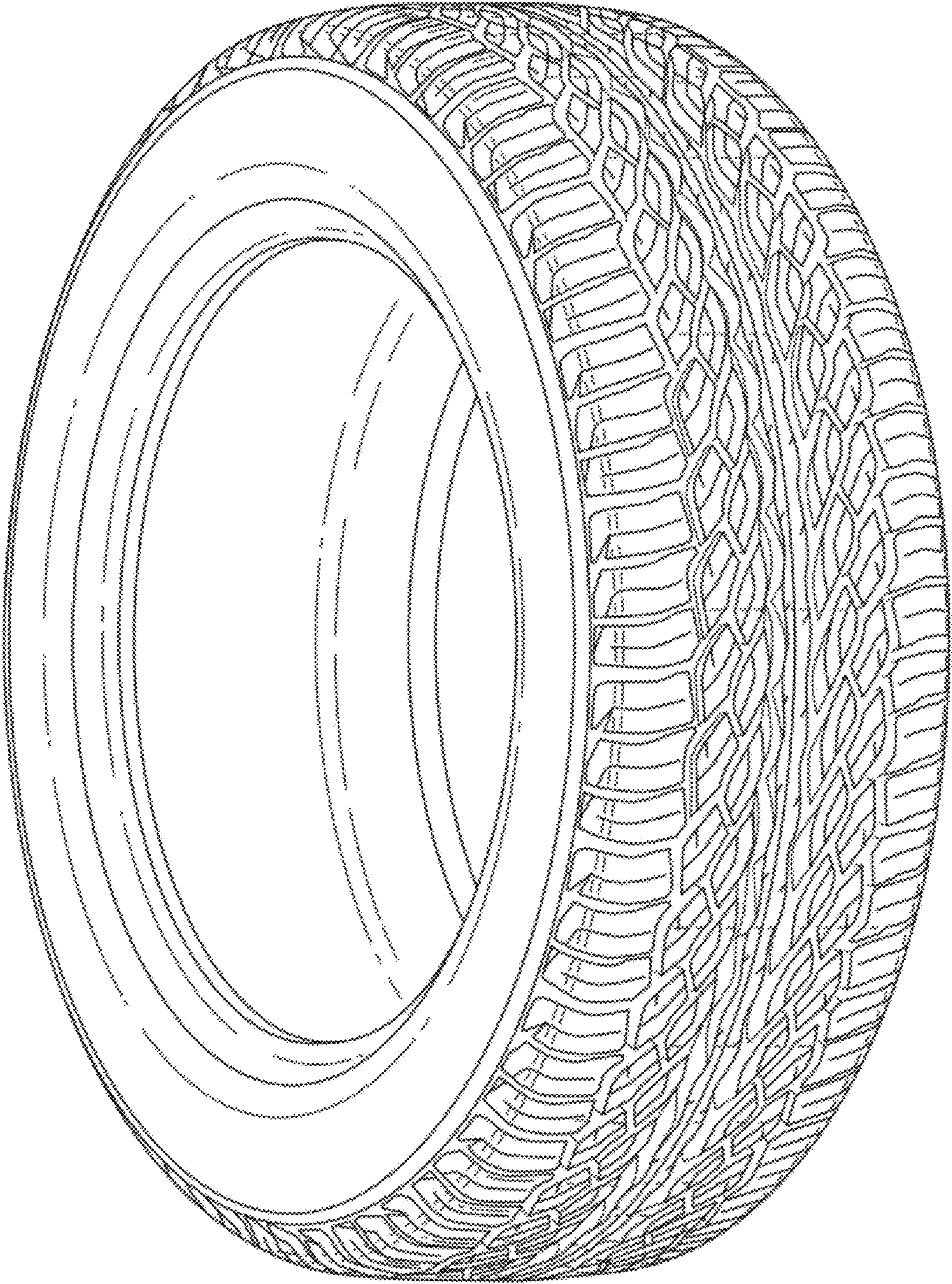

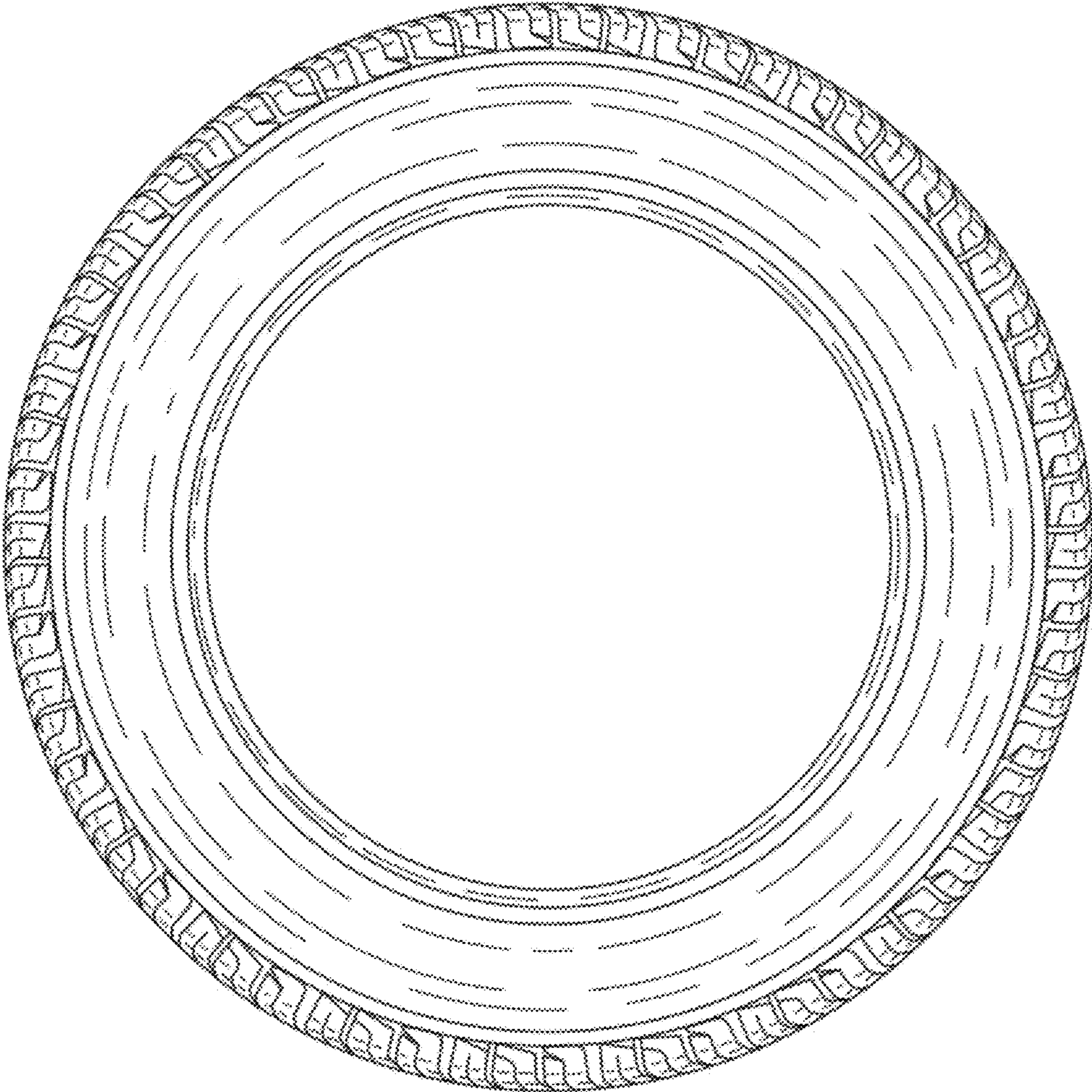

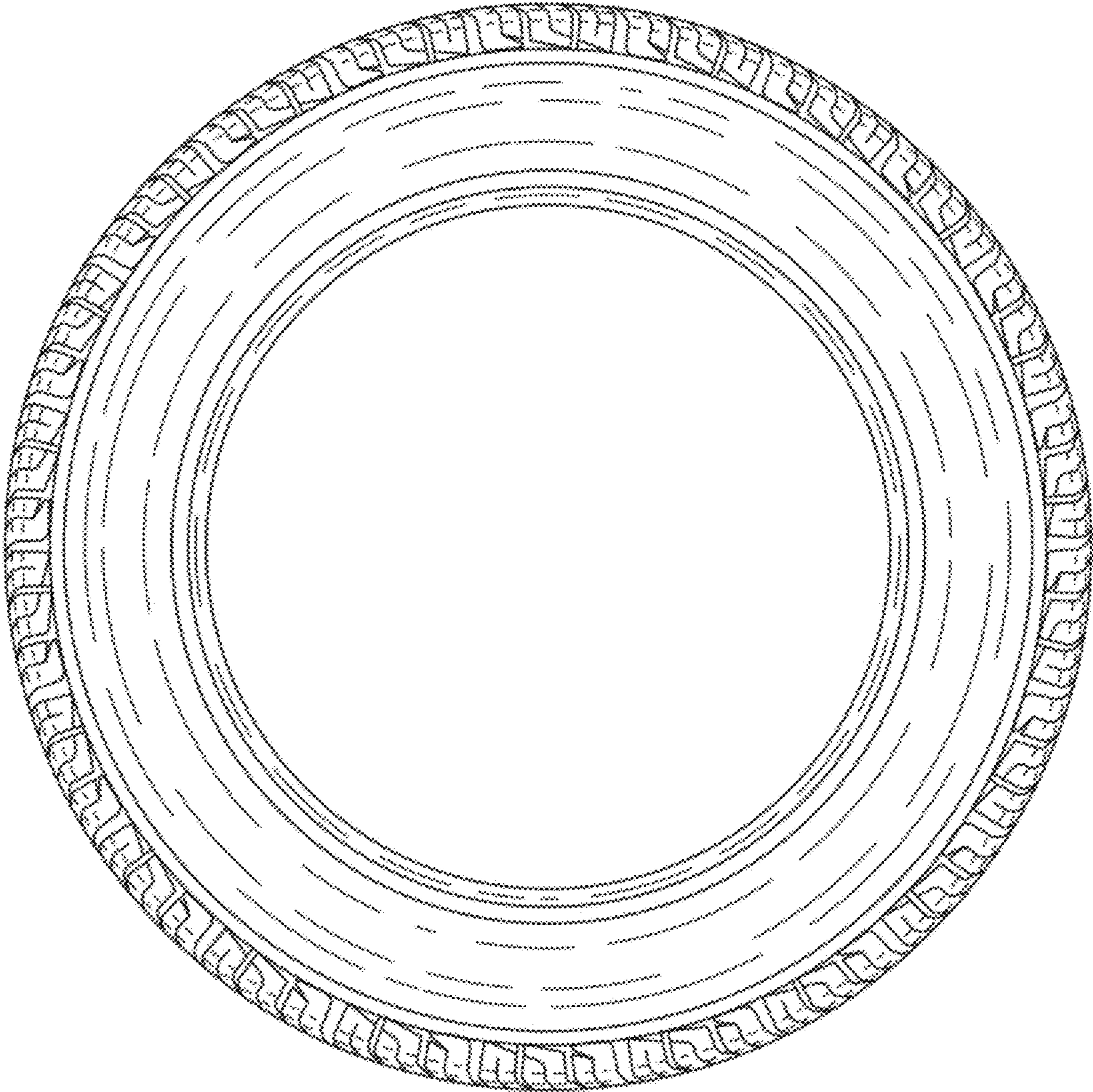

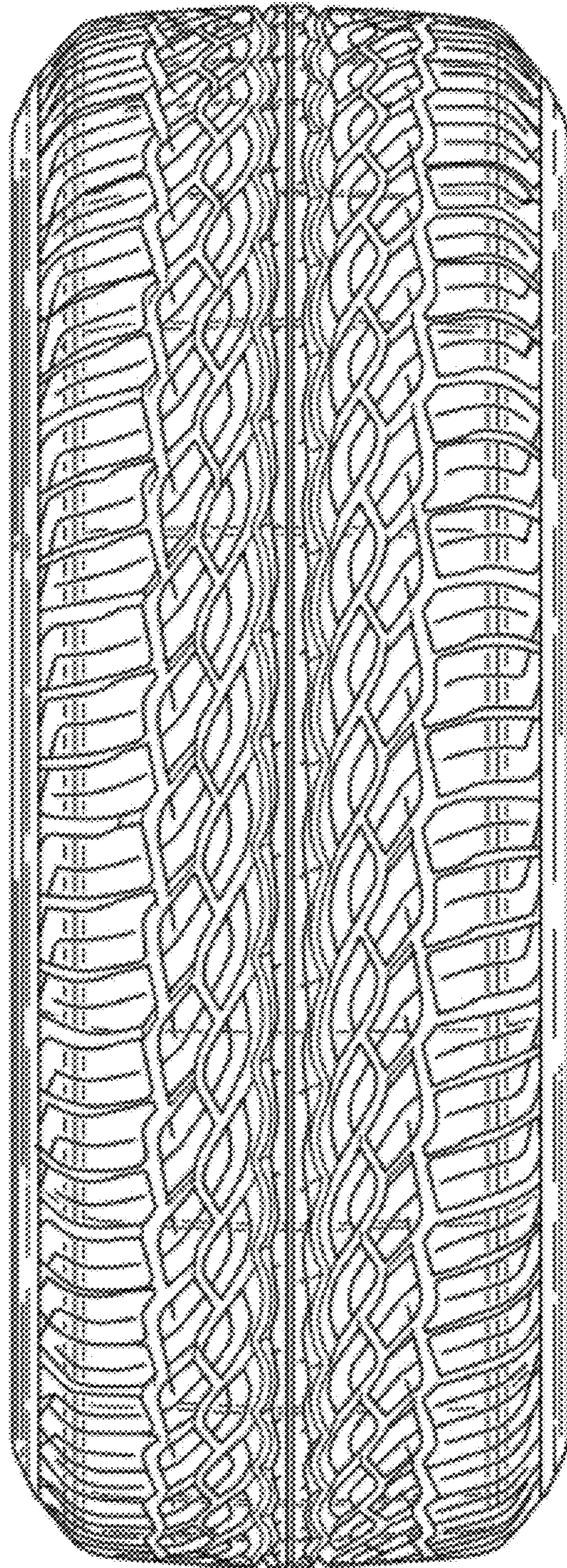

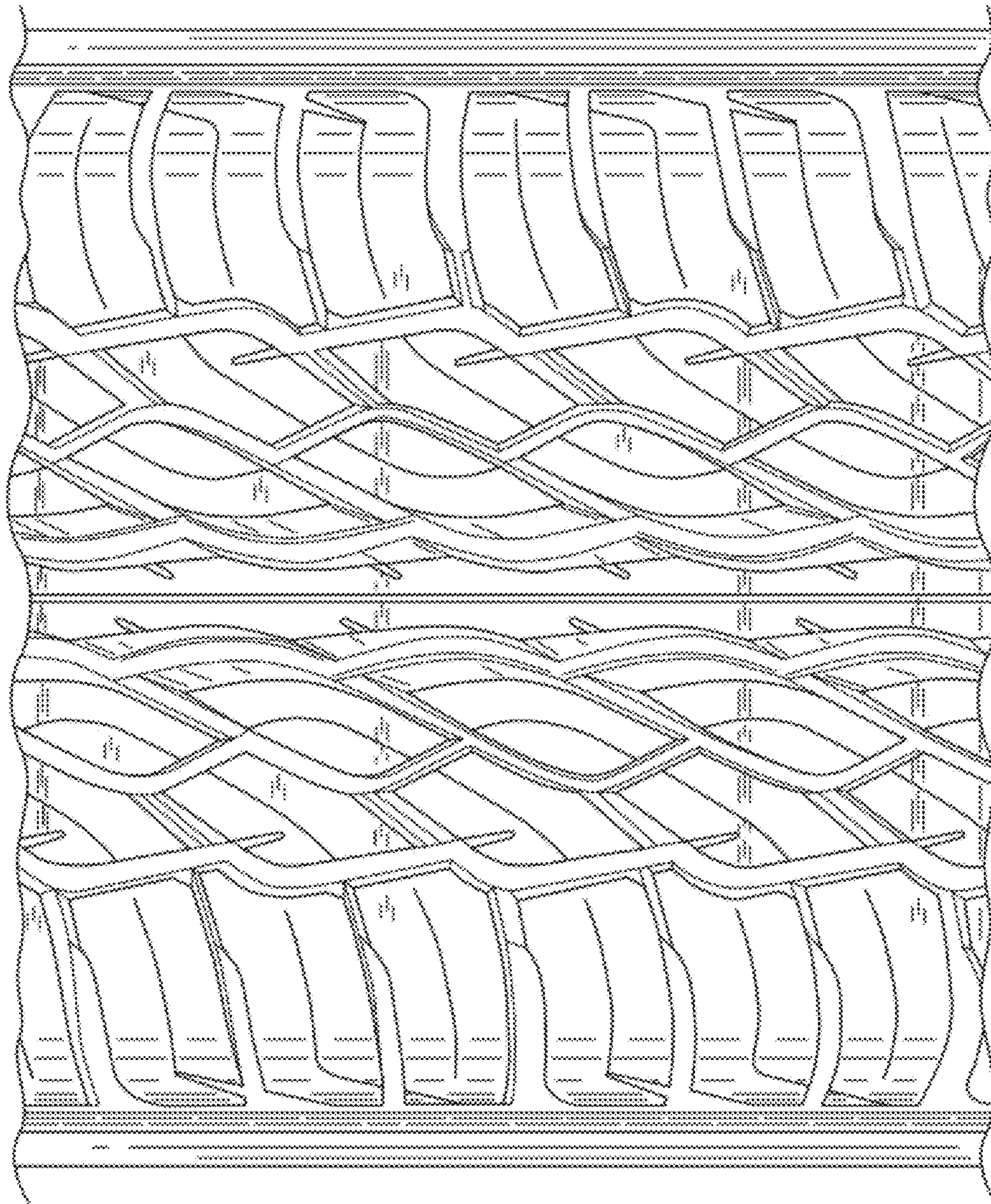
