The ornamental design for a television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a television receiver showing our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a partially enlarged view thereof taken along lines 3-3 and 3'-3' of FIG. 1;
 FIG. 4 is a partially enlarged view thereof taken along lines 4-4 and 4'-4' of FIG. 1; and
 FIG. 5 is a partially enlarged view thereof taken along lines 5-5 and 5'-5' of FIG. 1.
 FIG. 6 is a front elevational of a second embodiment of a television receiver showing our new design;
 FIG. 7 is a rear elevational view thereof;

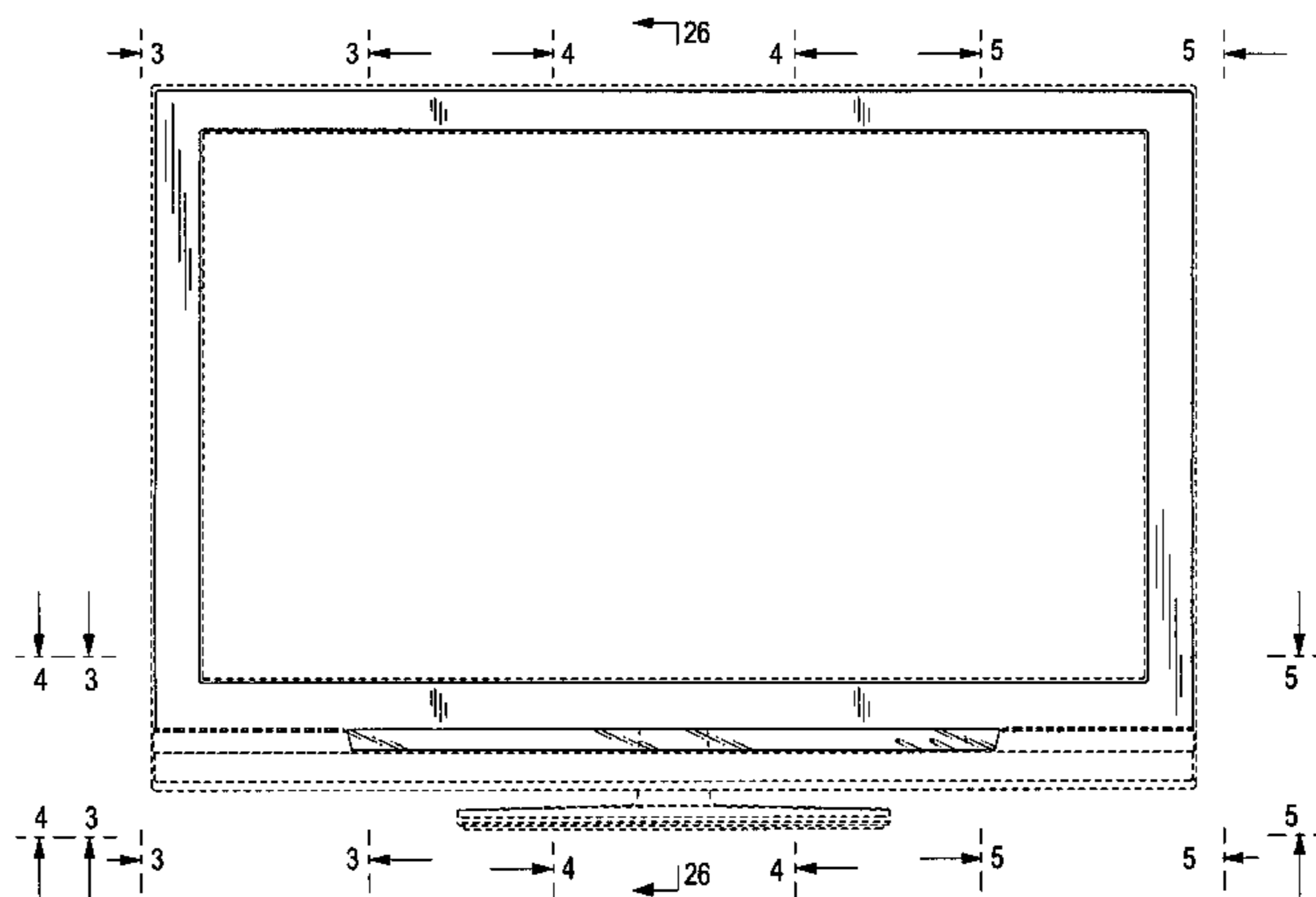


FIG. 8 is a partially enlarged view thereof taken along lines 8-8 and 8'-8' of FIG. 6;

FIG. 24 is a partially enlarged view thereof taken along lines 24-24 and 24'-24' of FIG. 21; and

FIG. 25 is a partially enlarged view thereof taken along lines 25-25 and 25'-25' of FIG. 21.

FIG. 26 is a cross sectional view along the line 26-26 of FIG. 1.

FIG. 27 is a cross sectional view along the line 27-27 of FIG. 6.

FIG. 28 is a cross sectional view along the line 28-28 of FIG. 11.

FIG. 29 is a cross sectional view along the line 29-29 of FIG. 16; and,

FIG. 30 is a cross sectional view along the line 30-30 of FIG. 21.

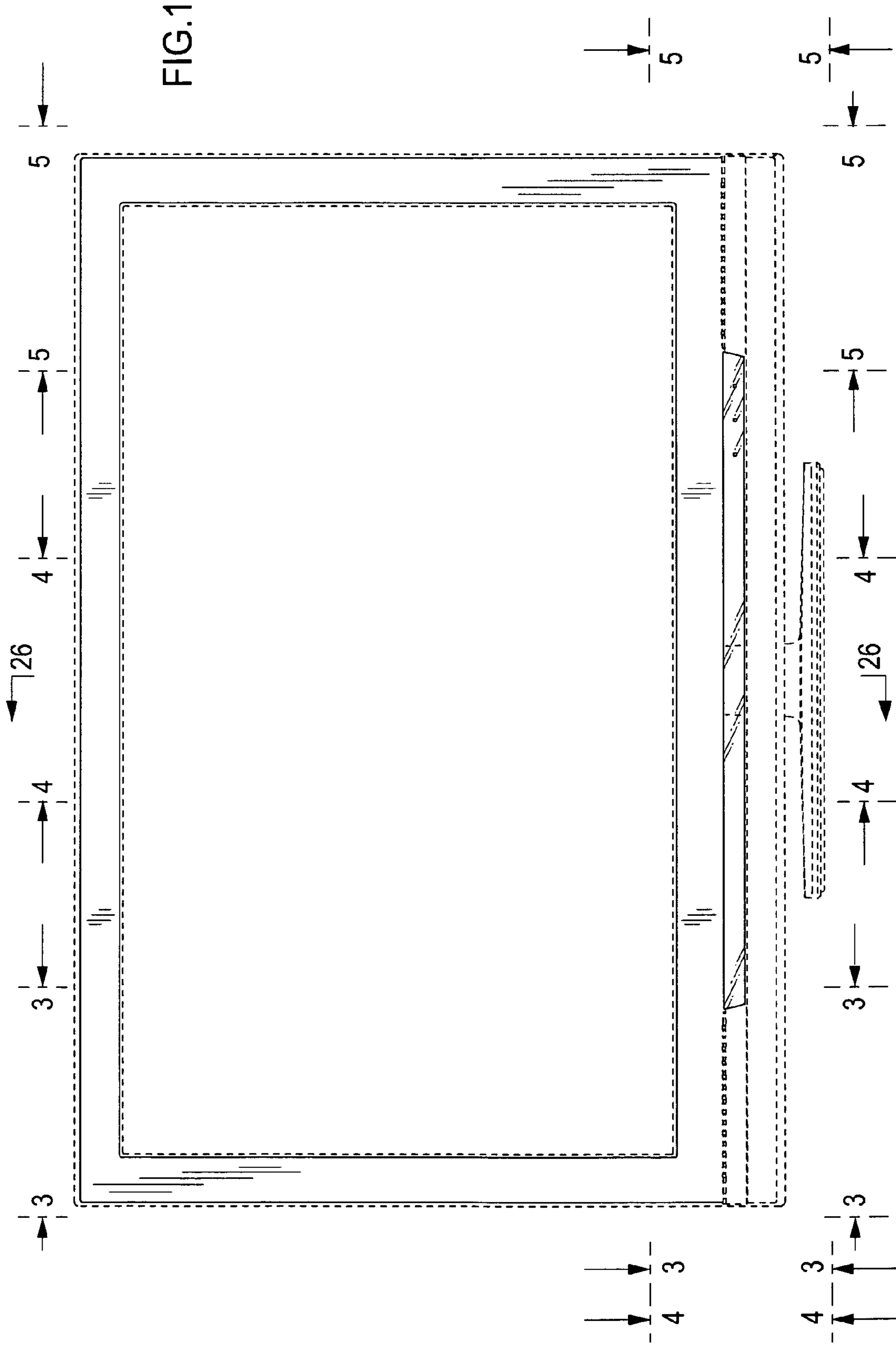

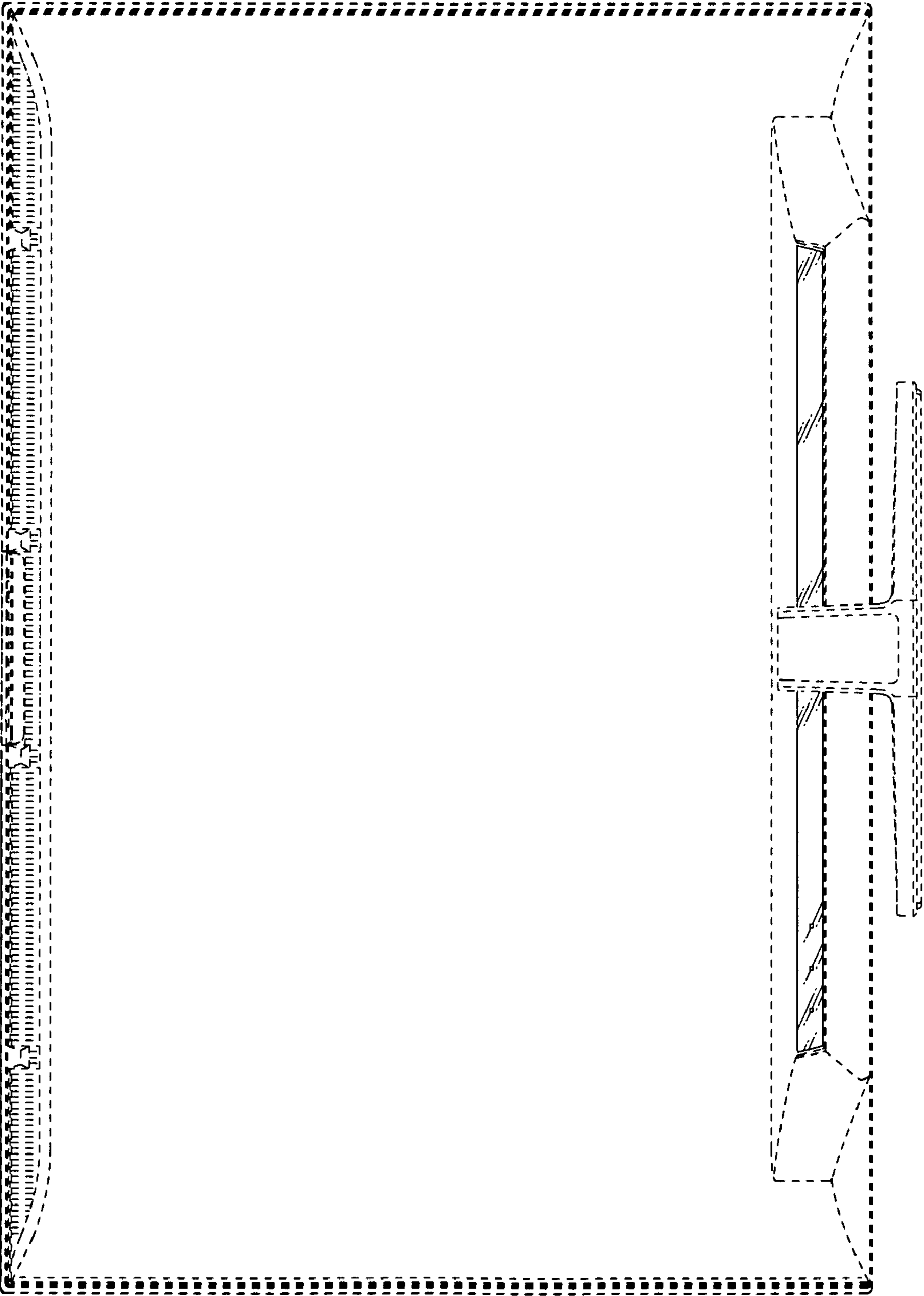

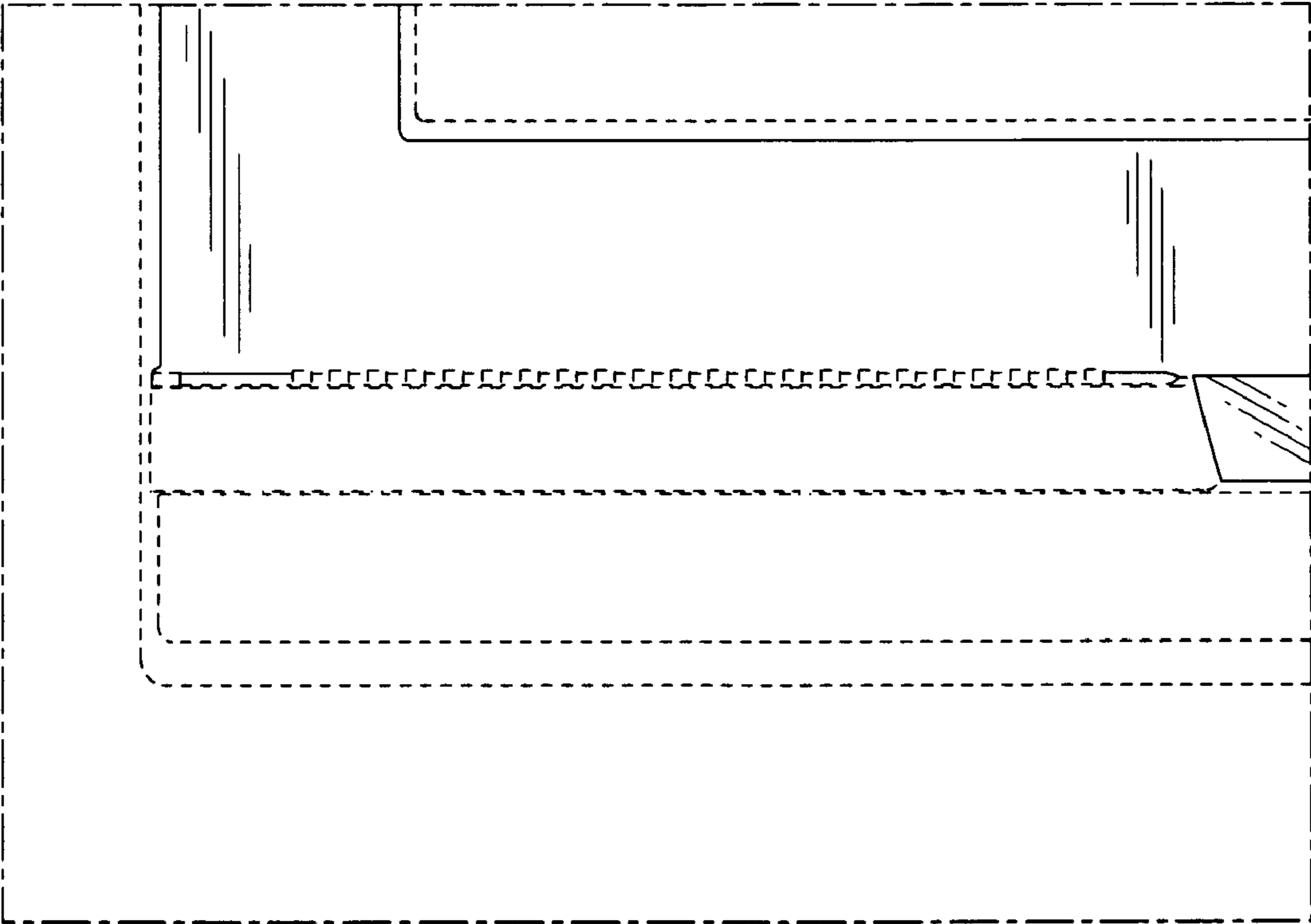

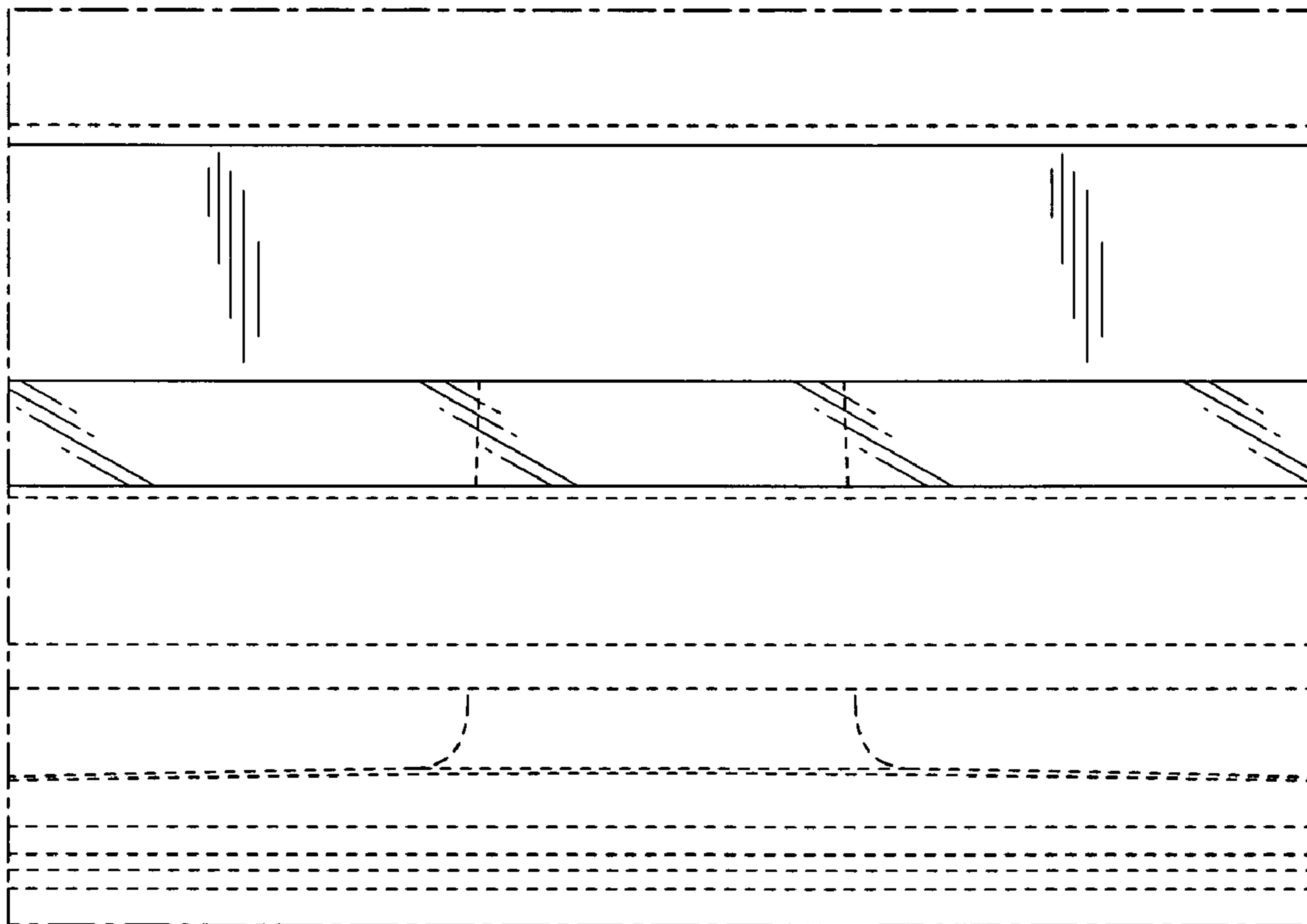
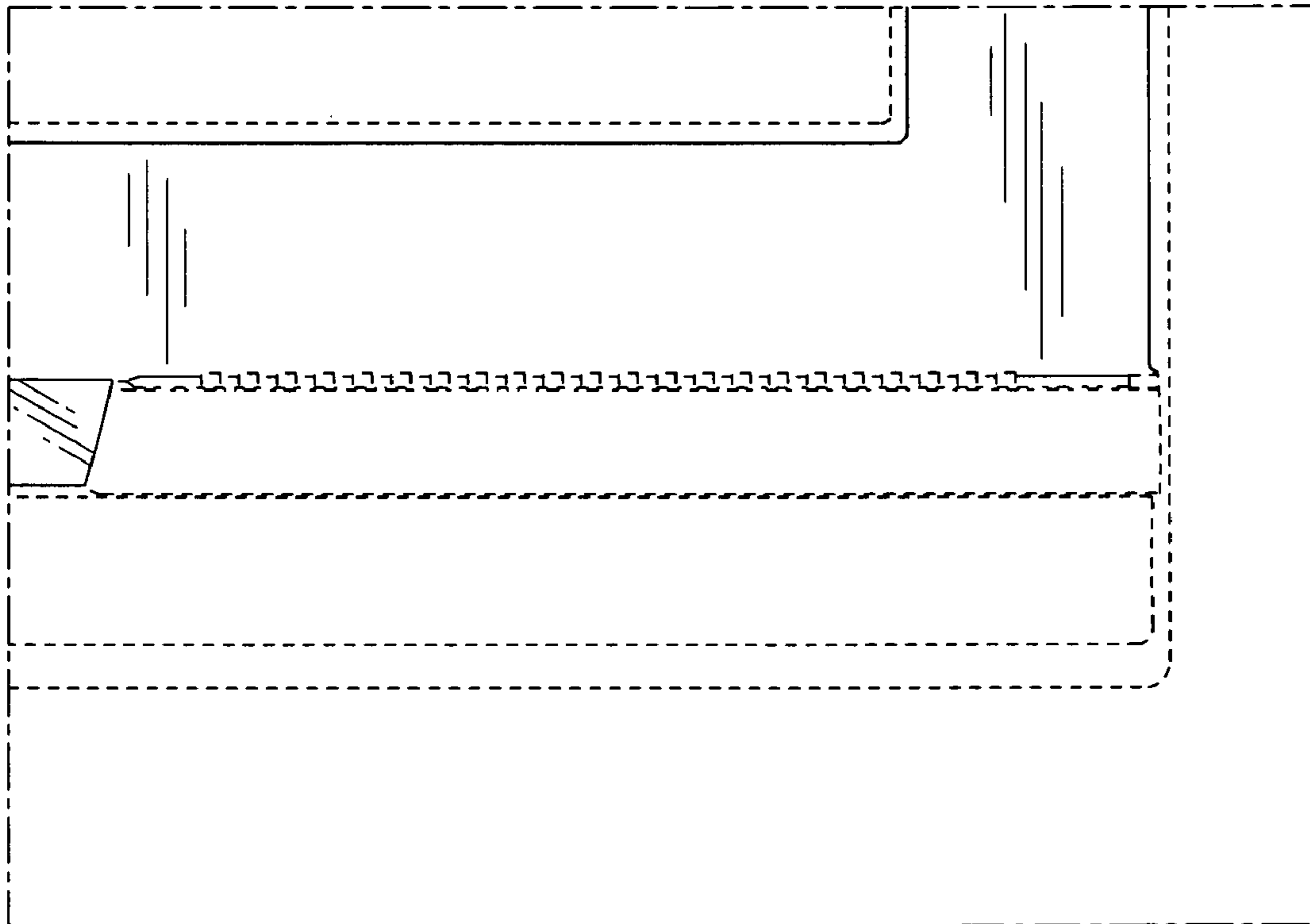

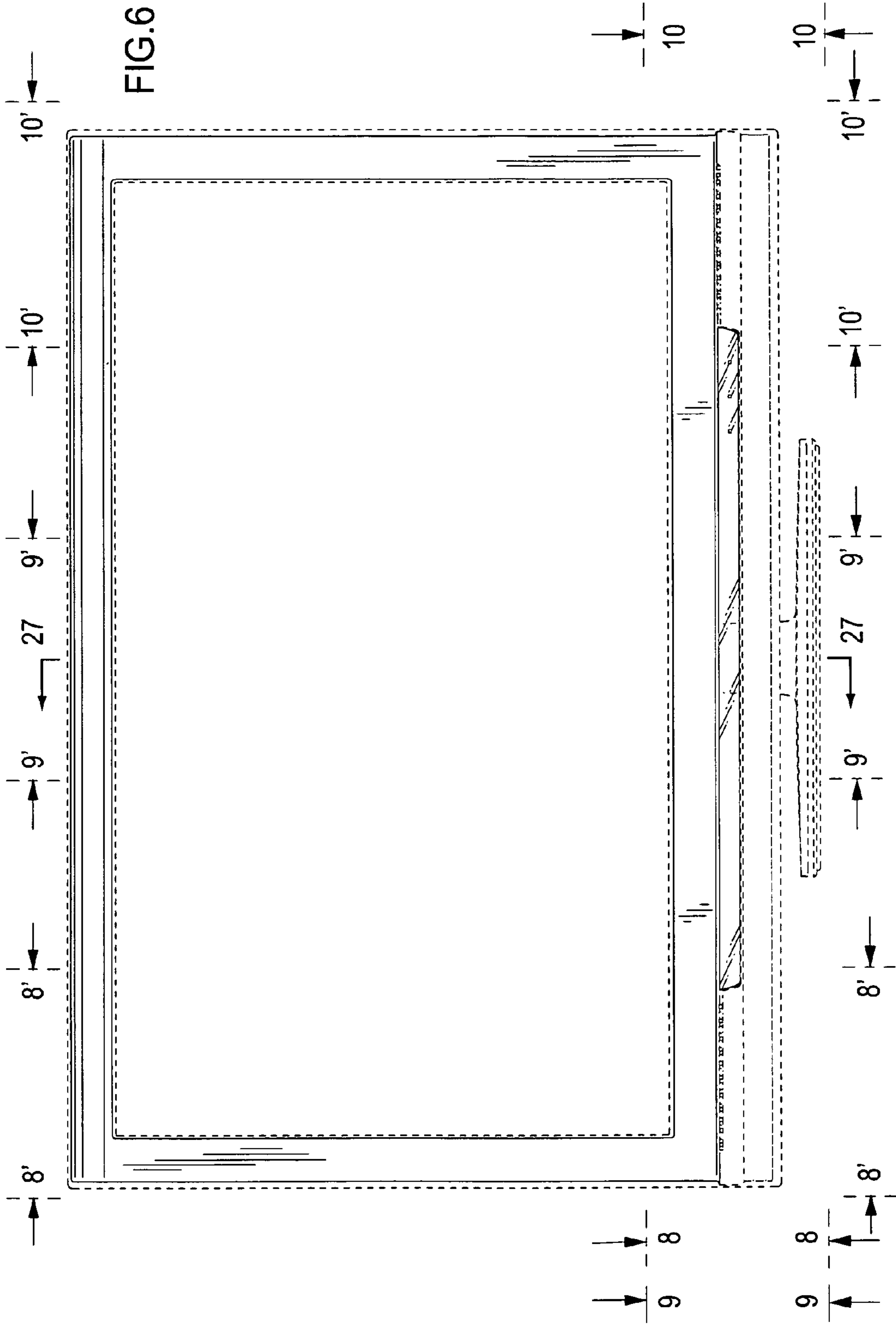

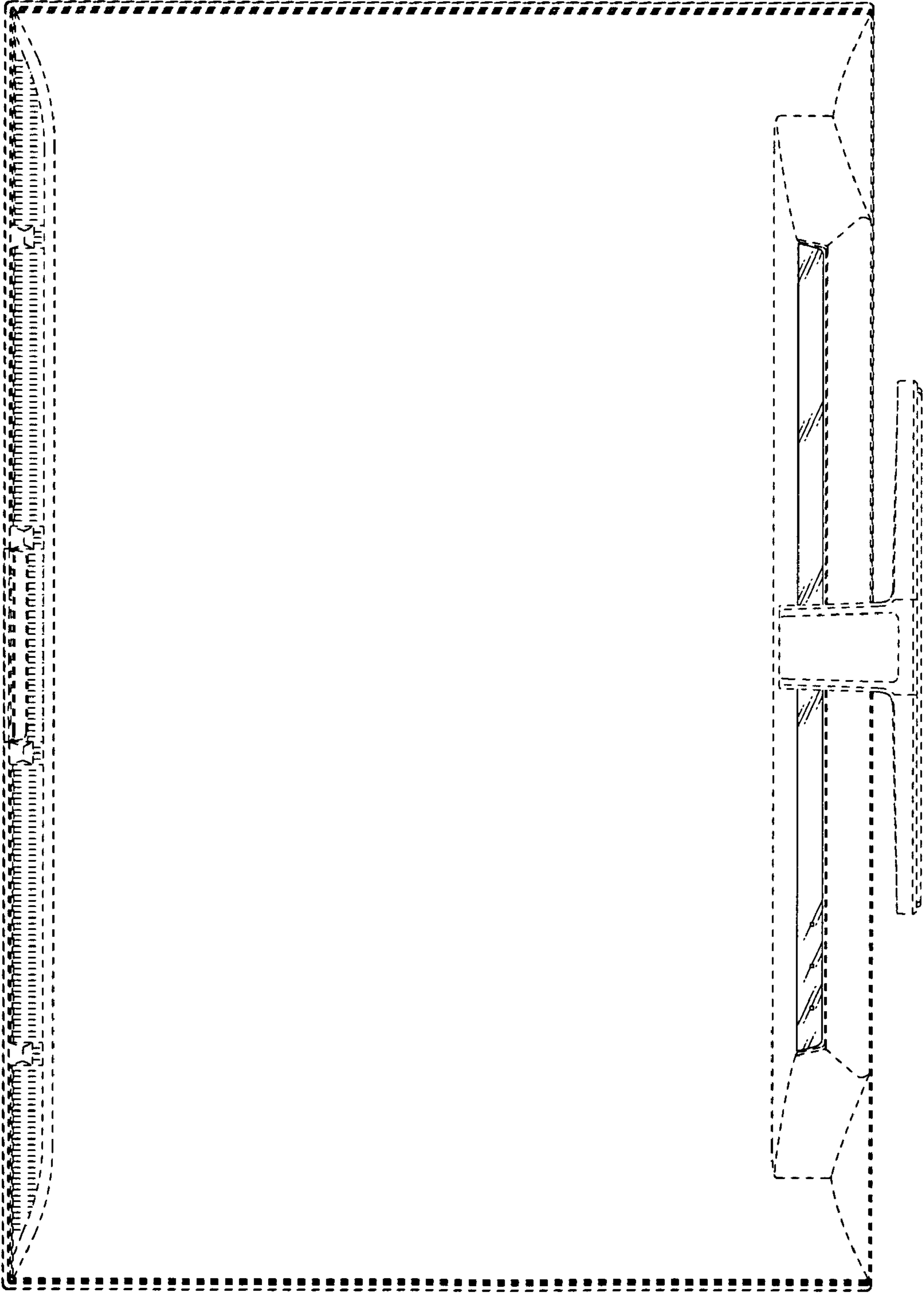

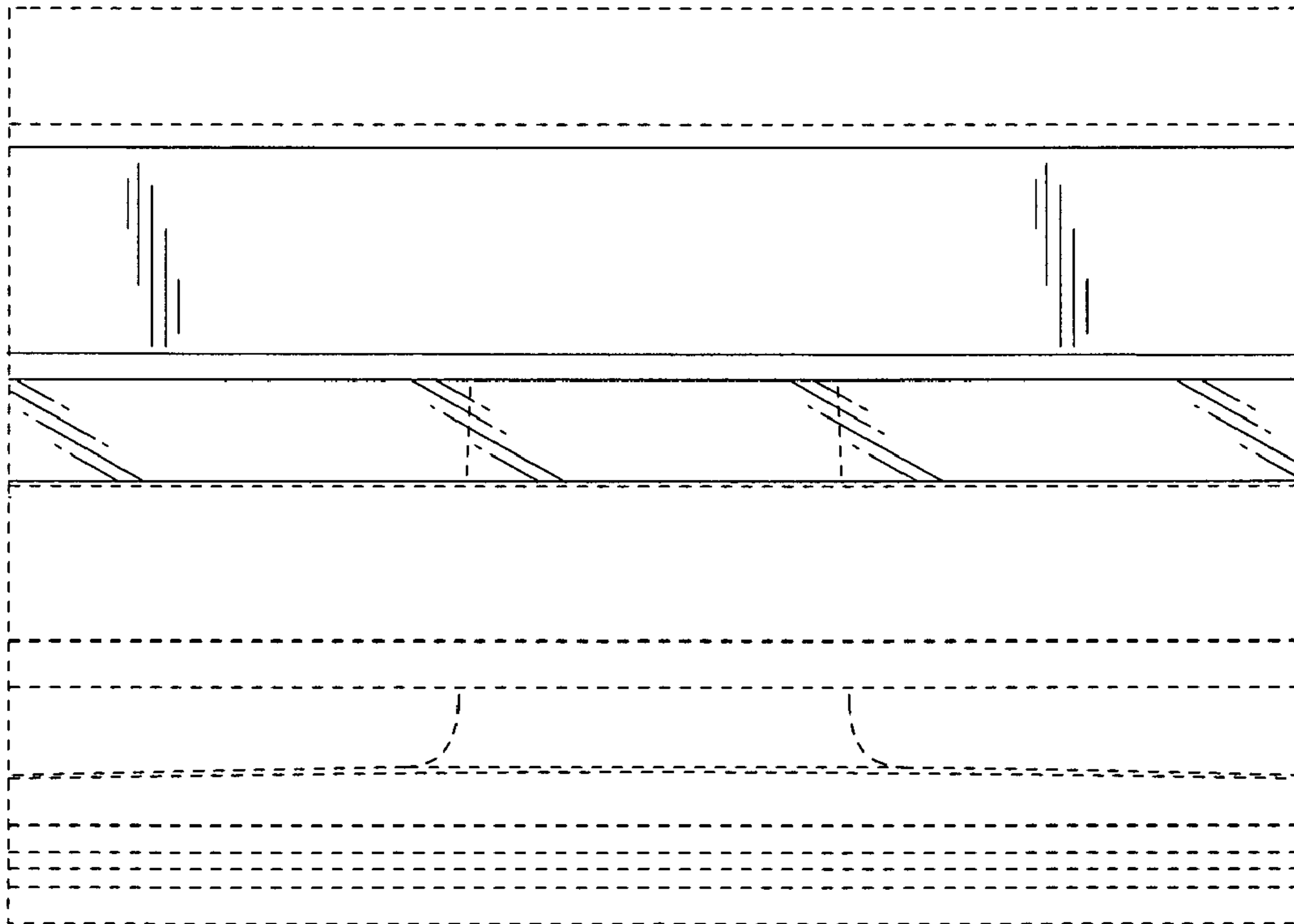
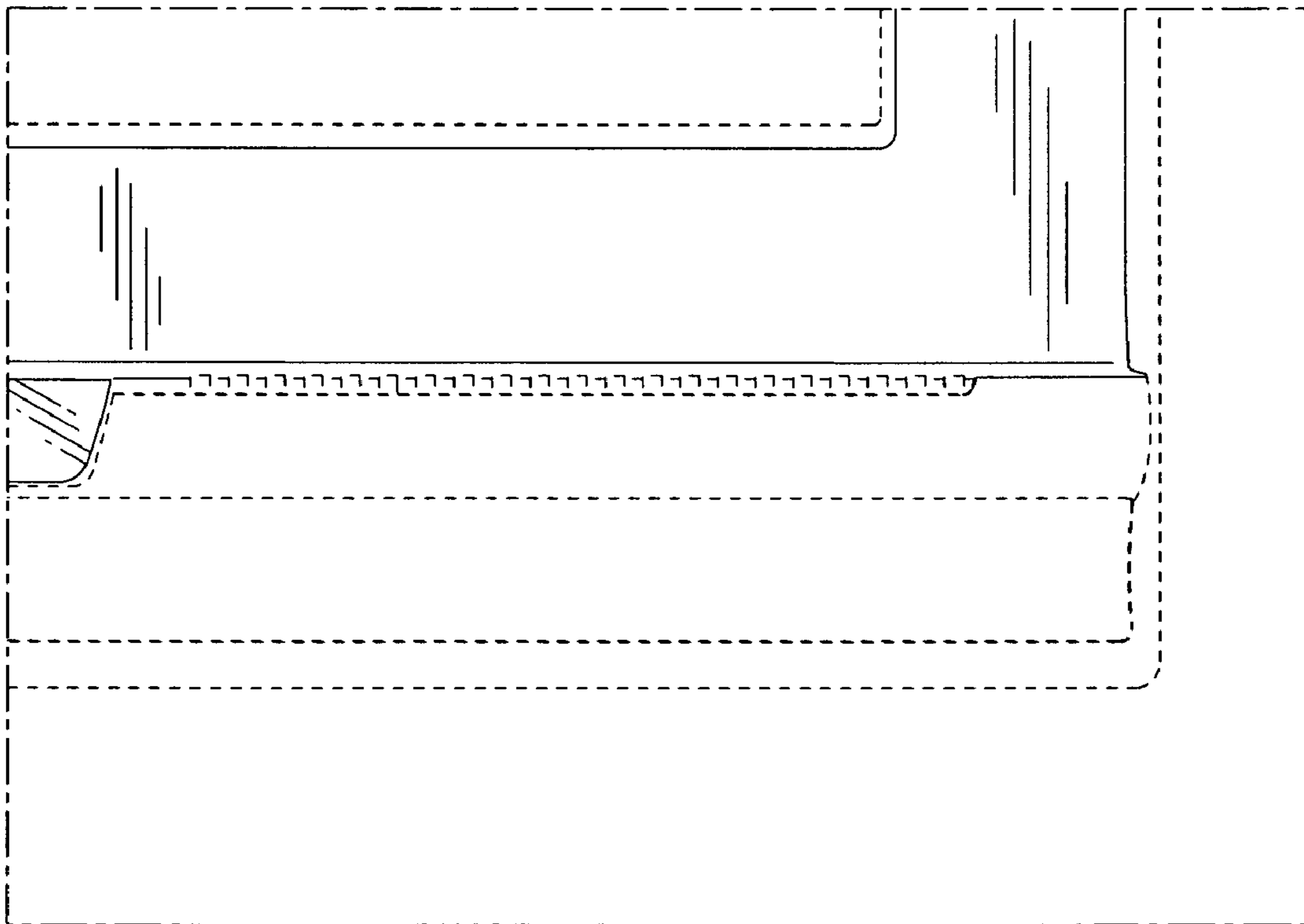

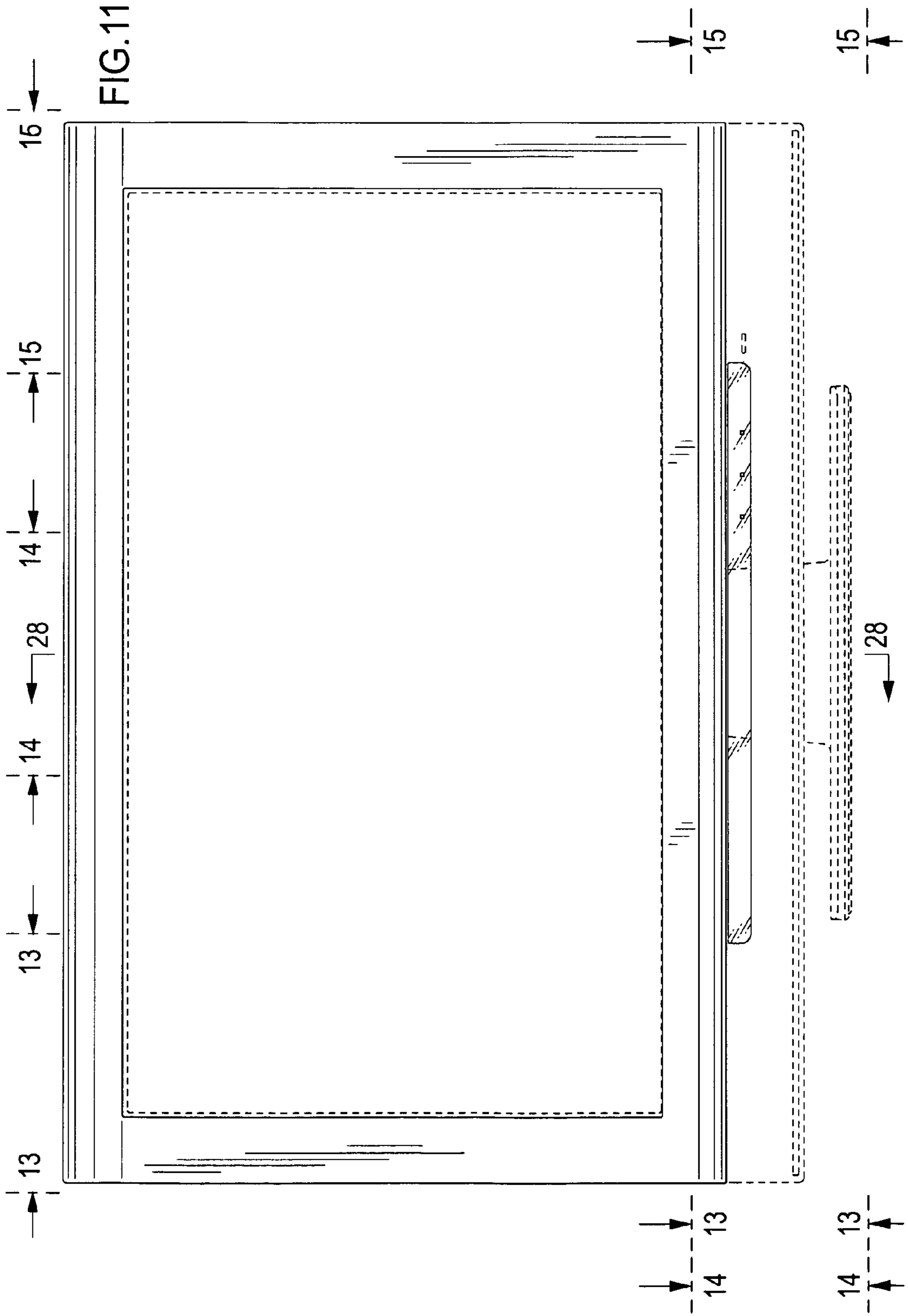

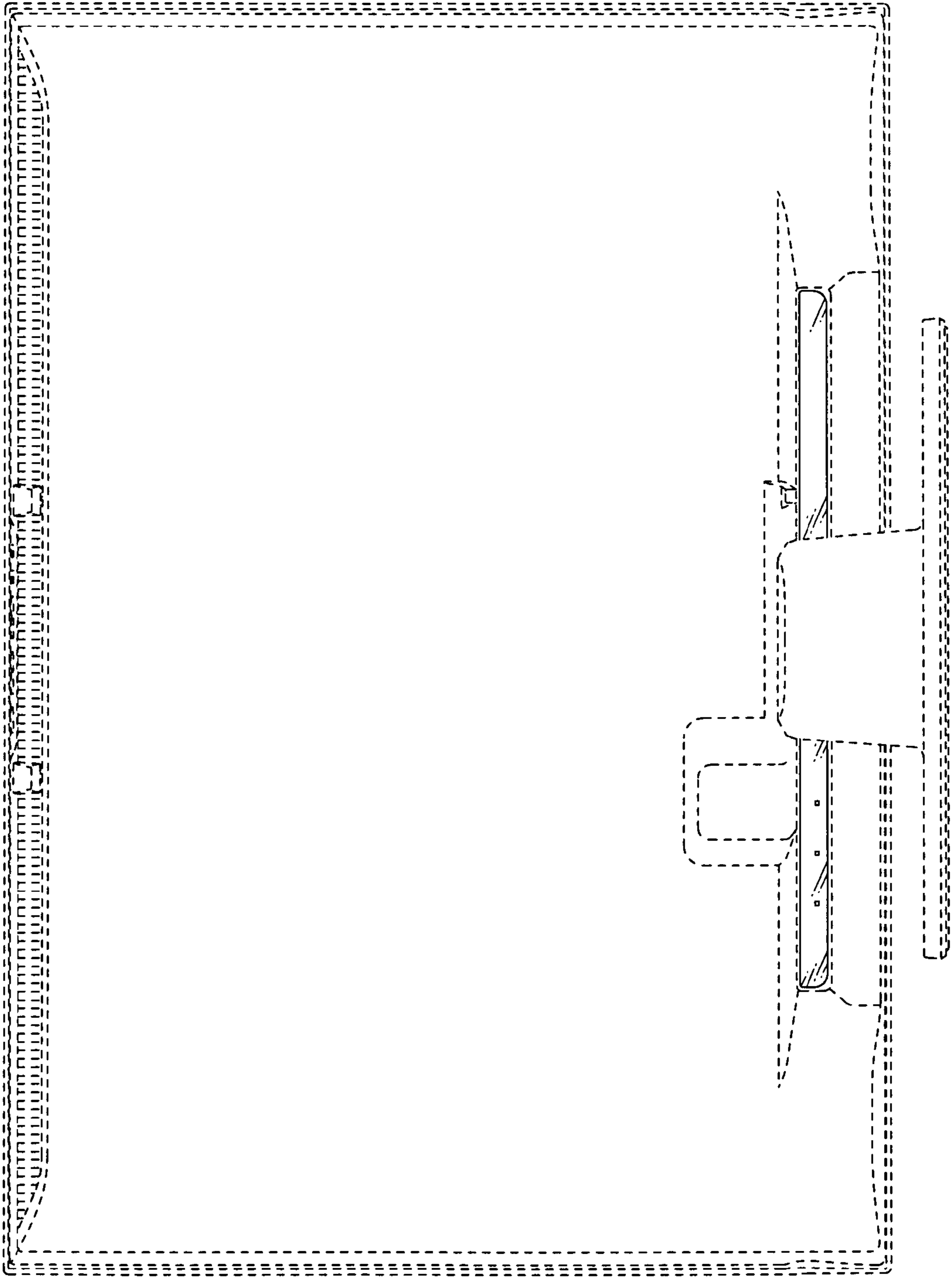

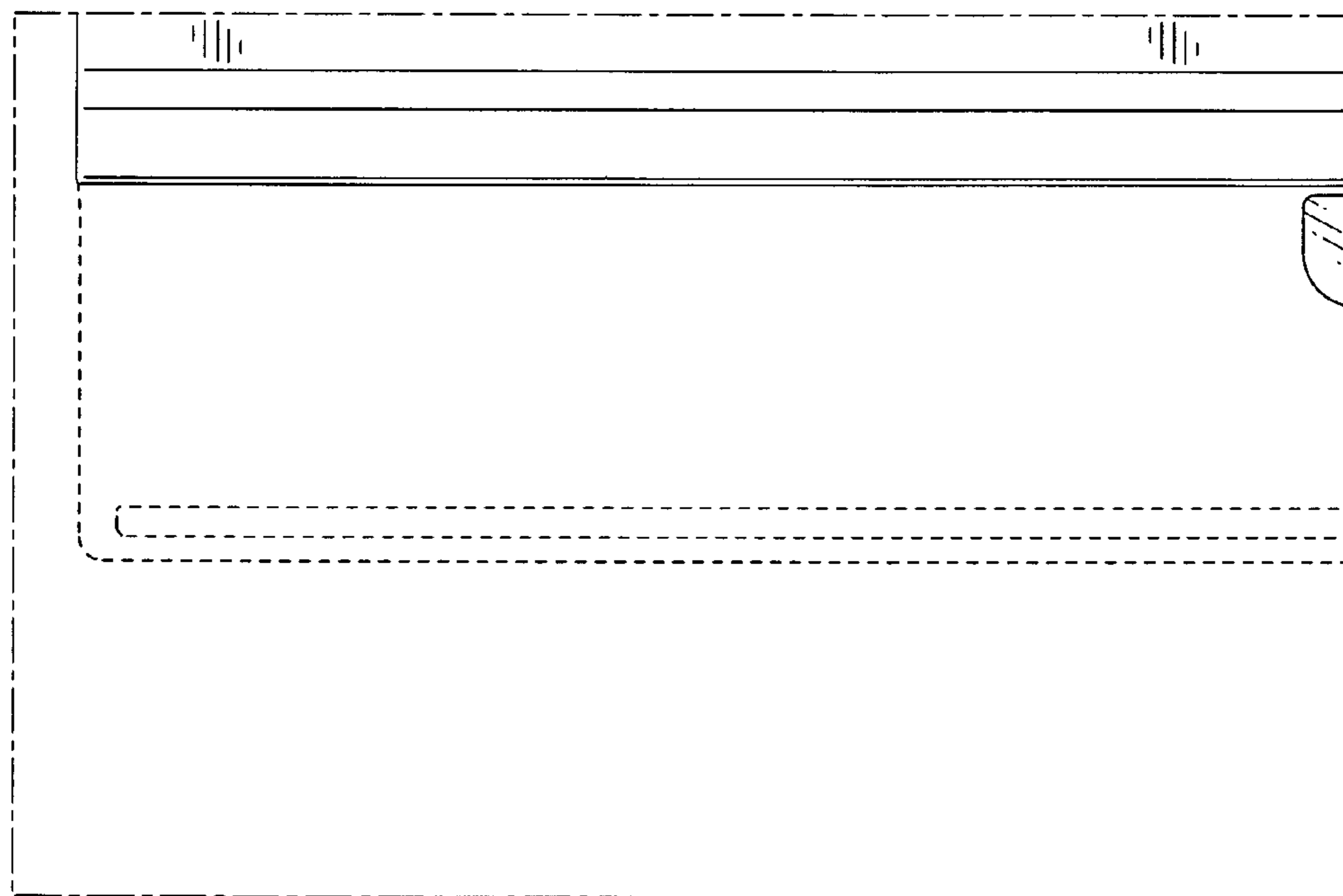

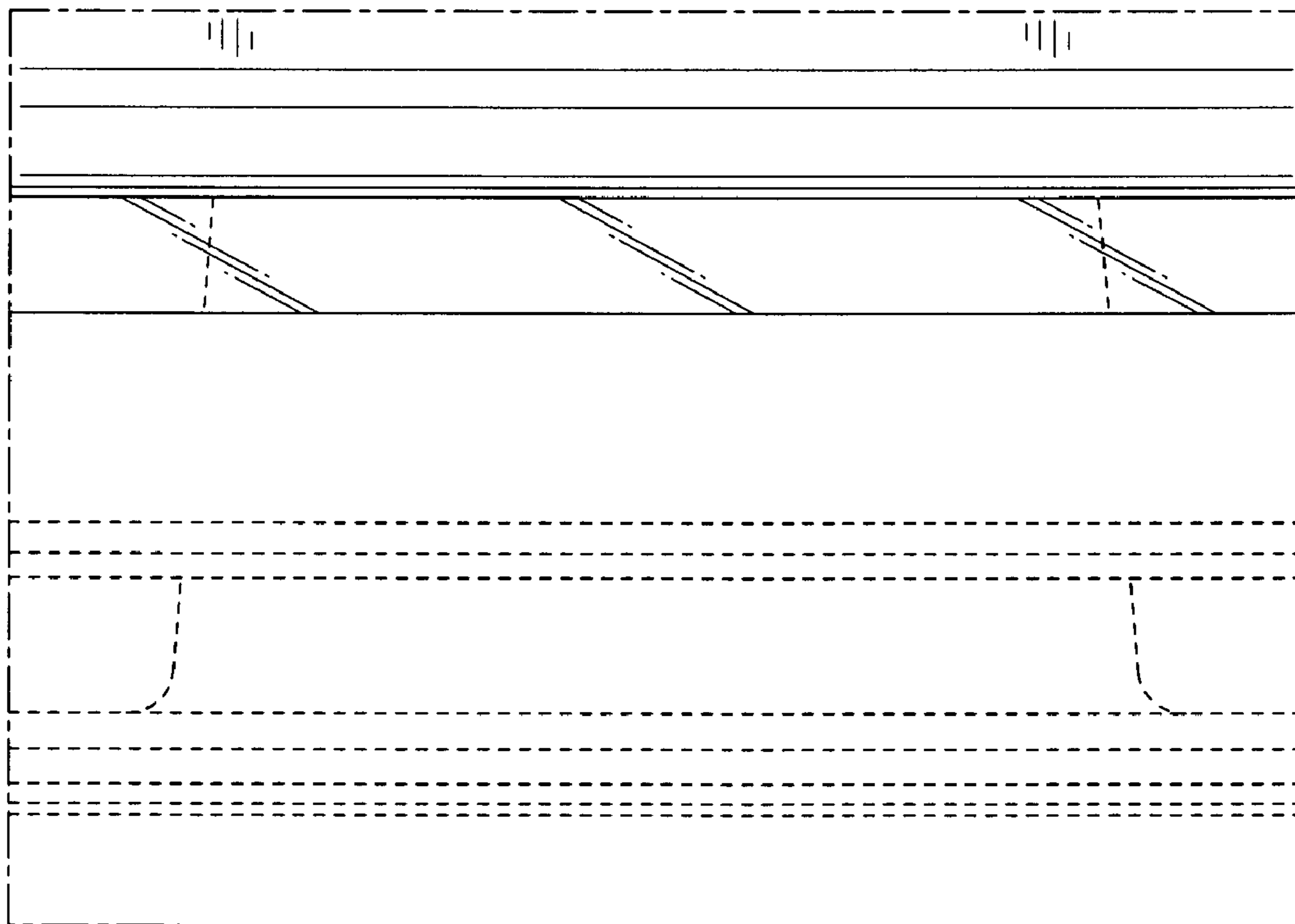
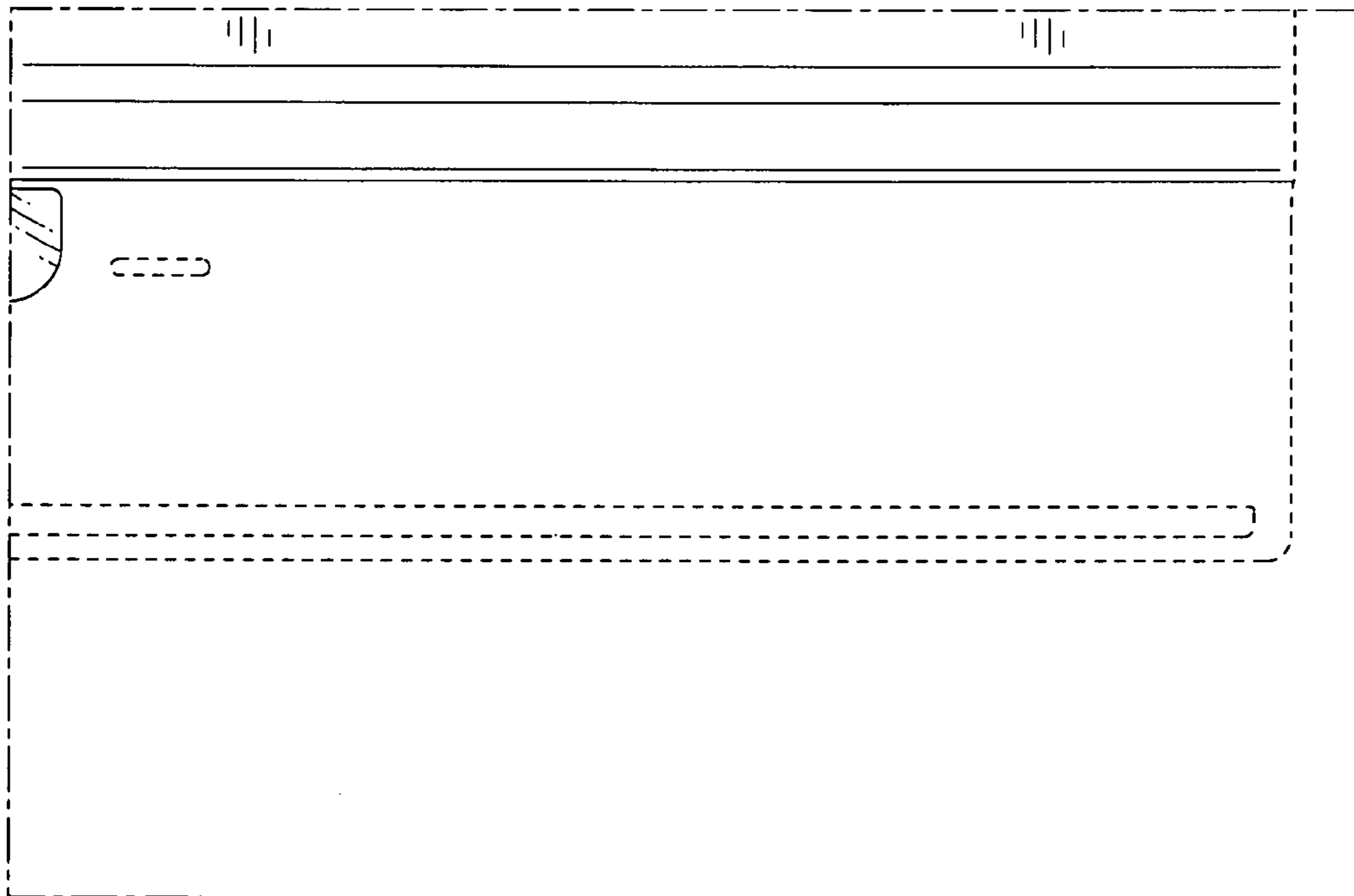

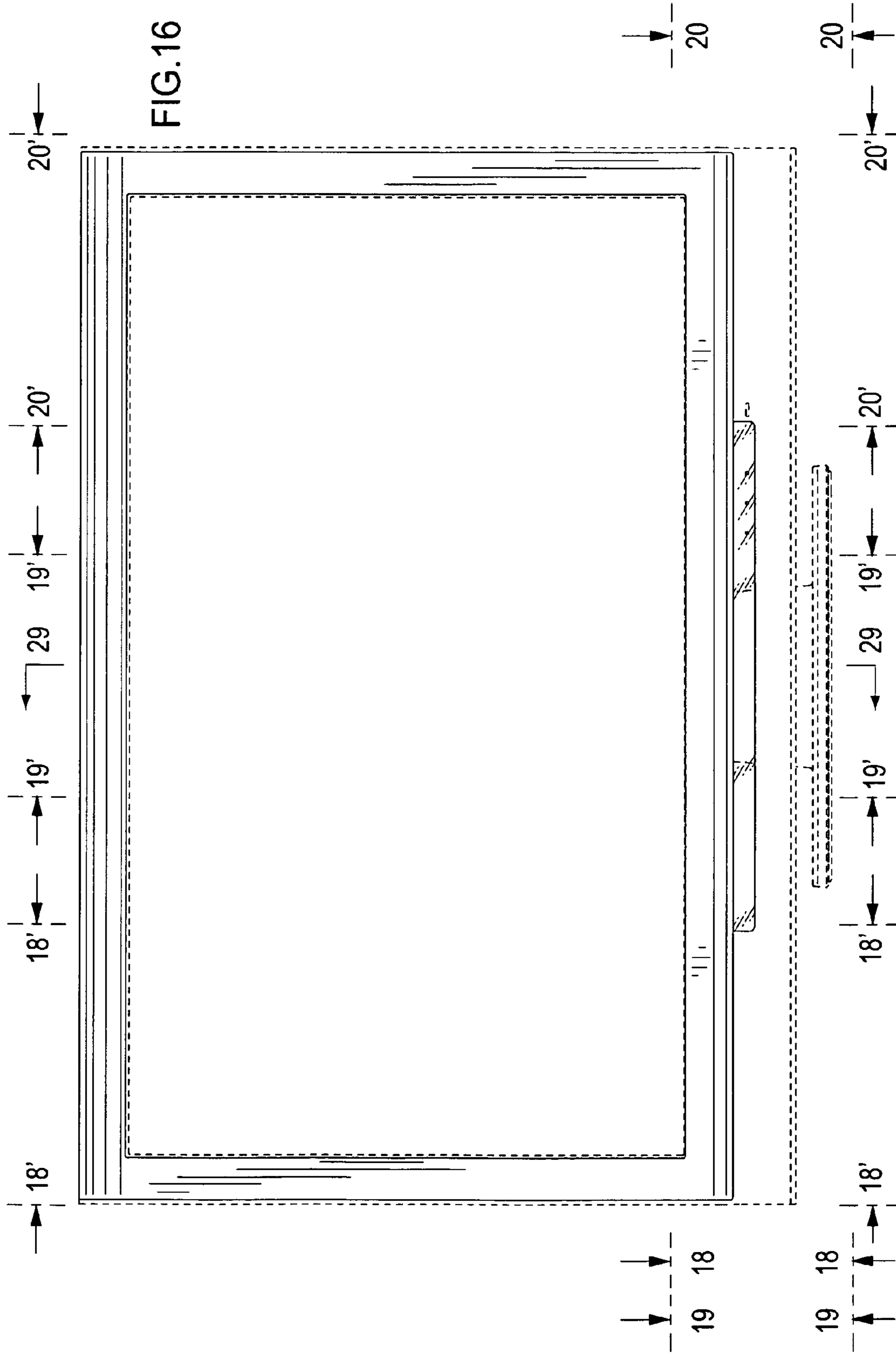

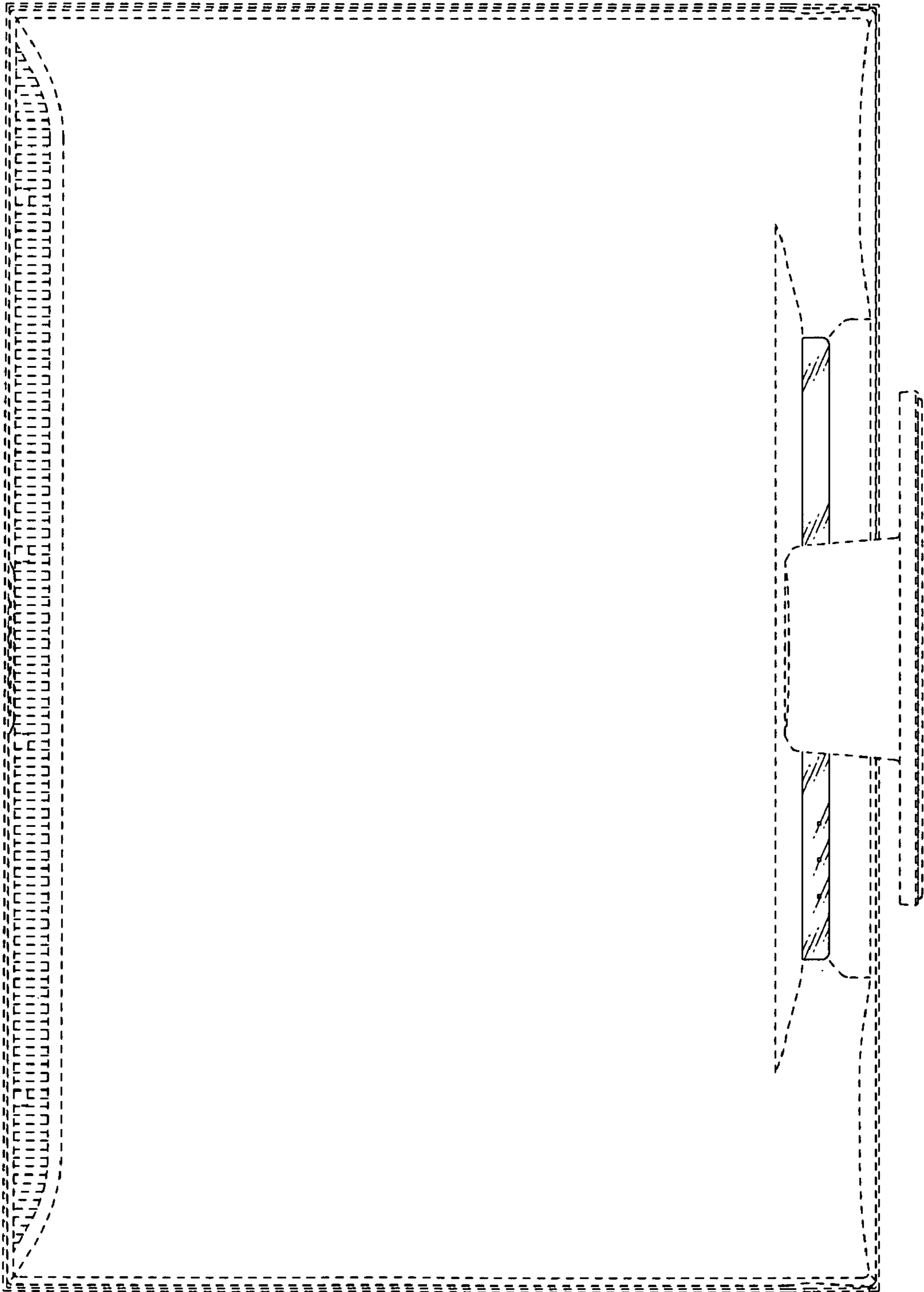

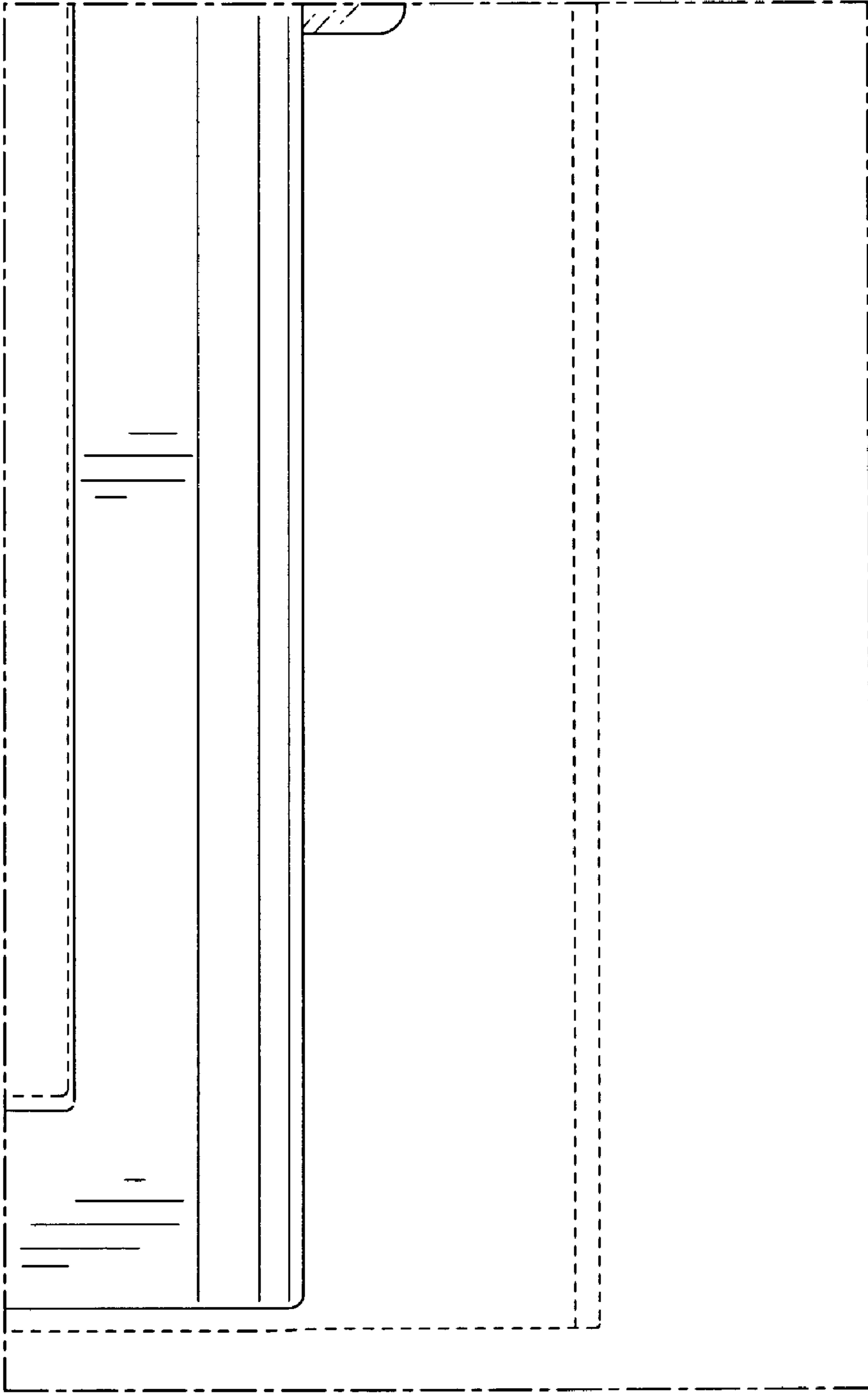

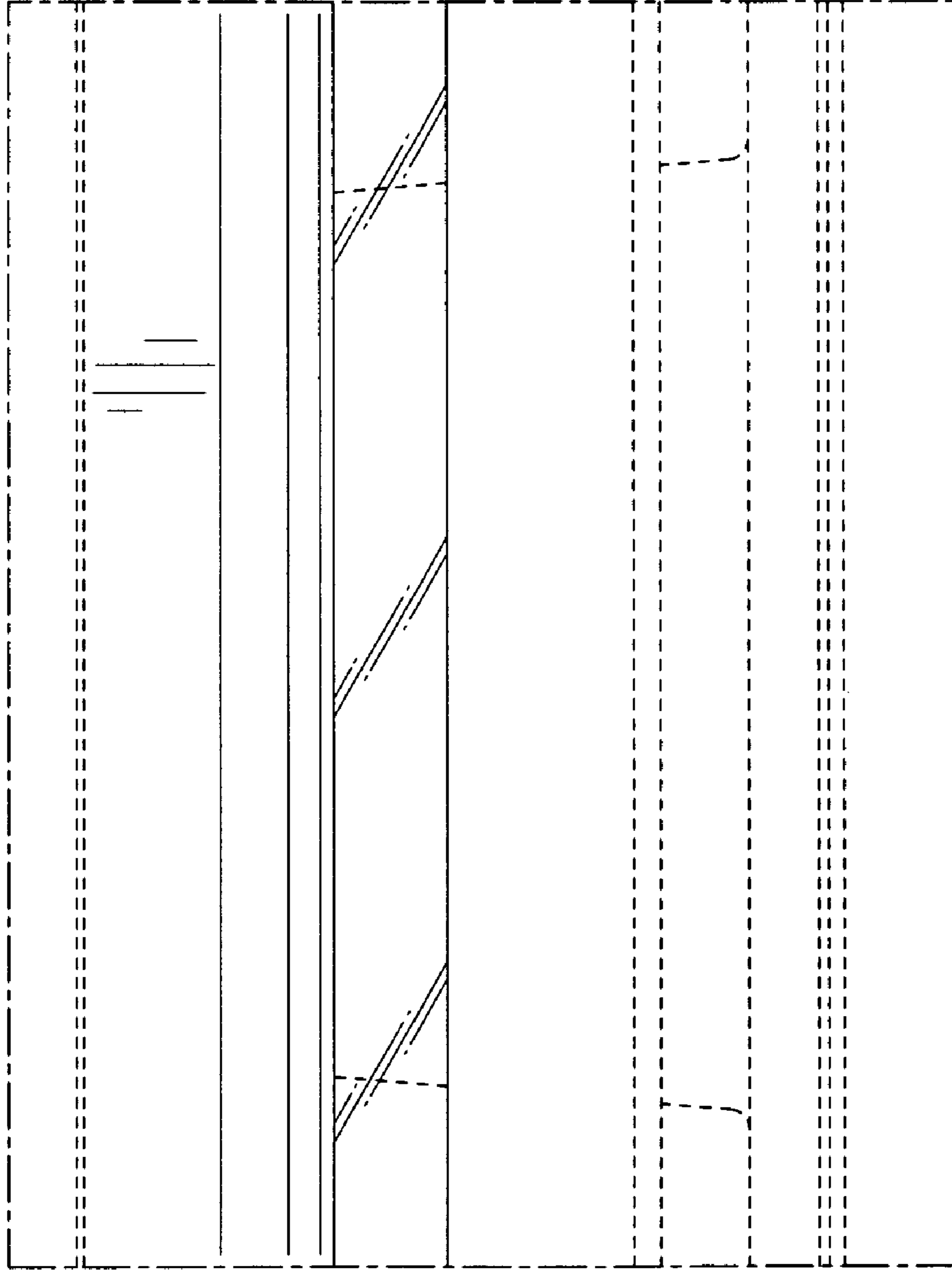
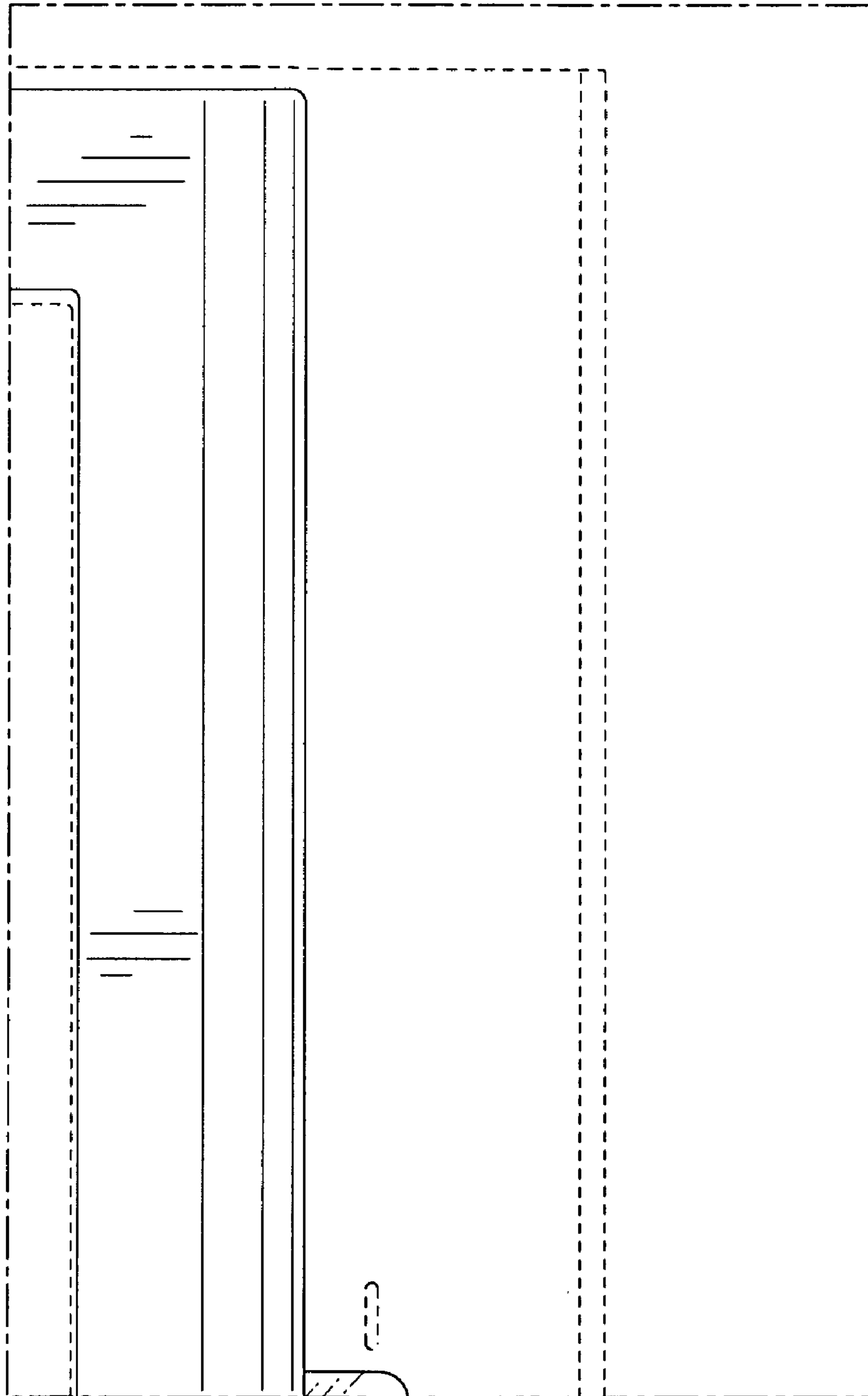

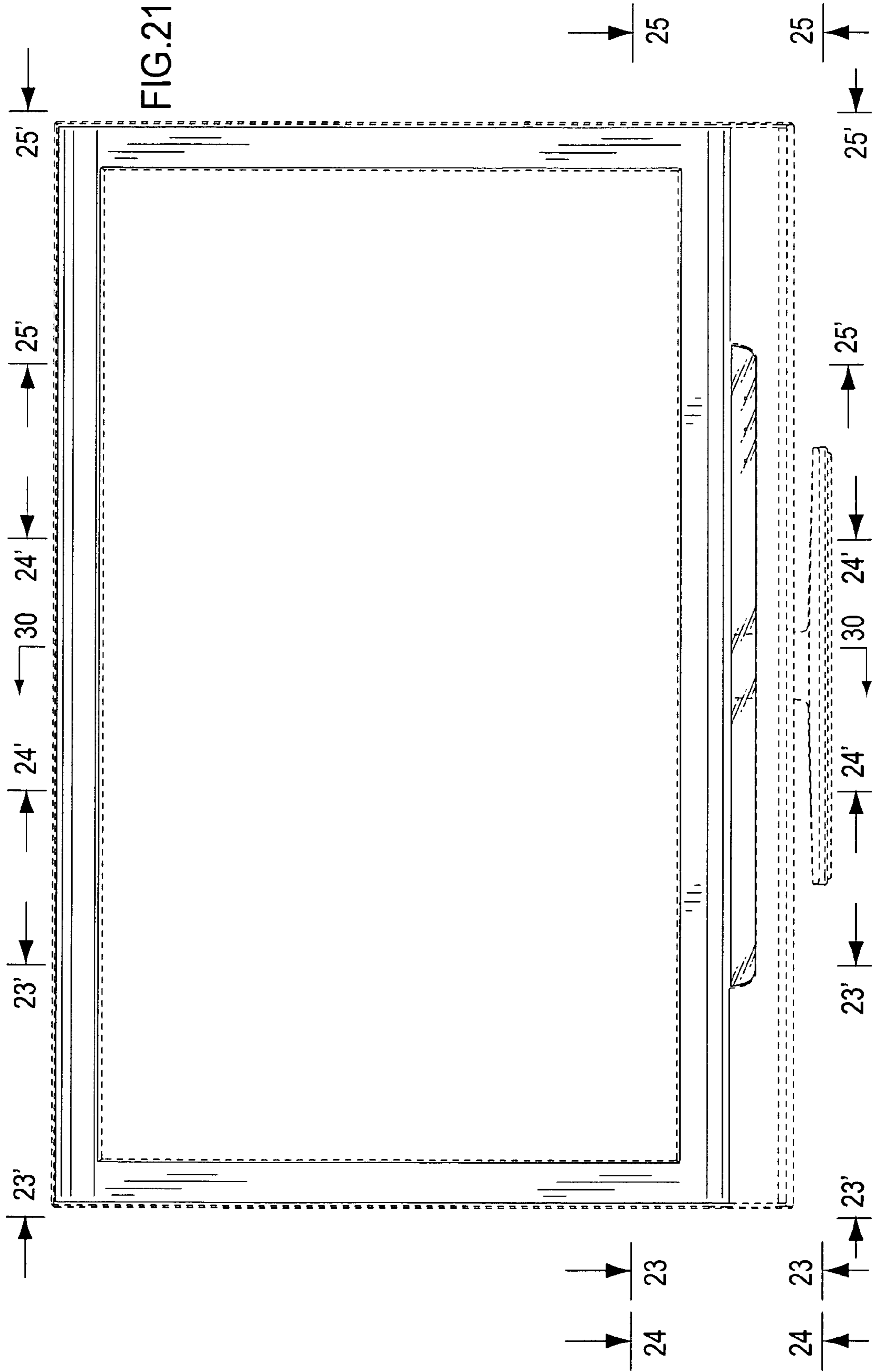

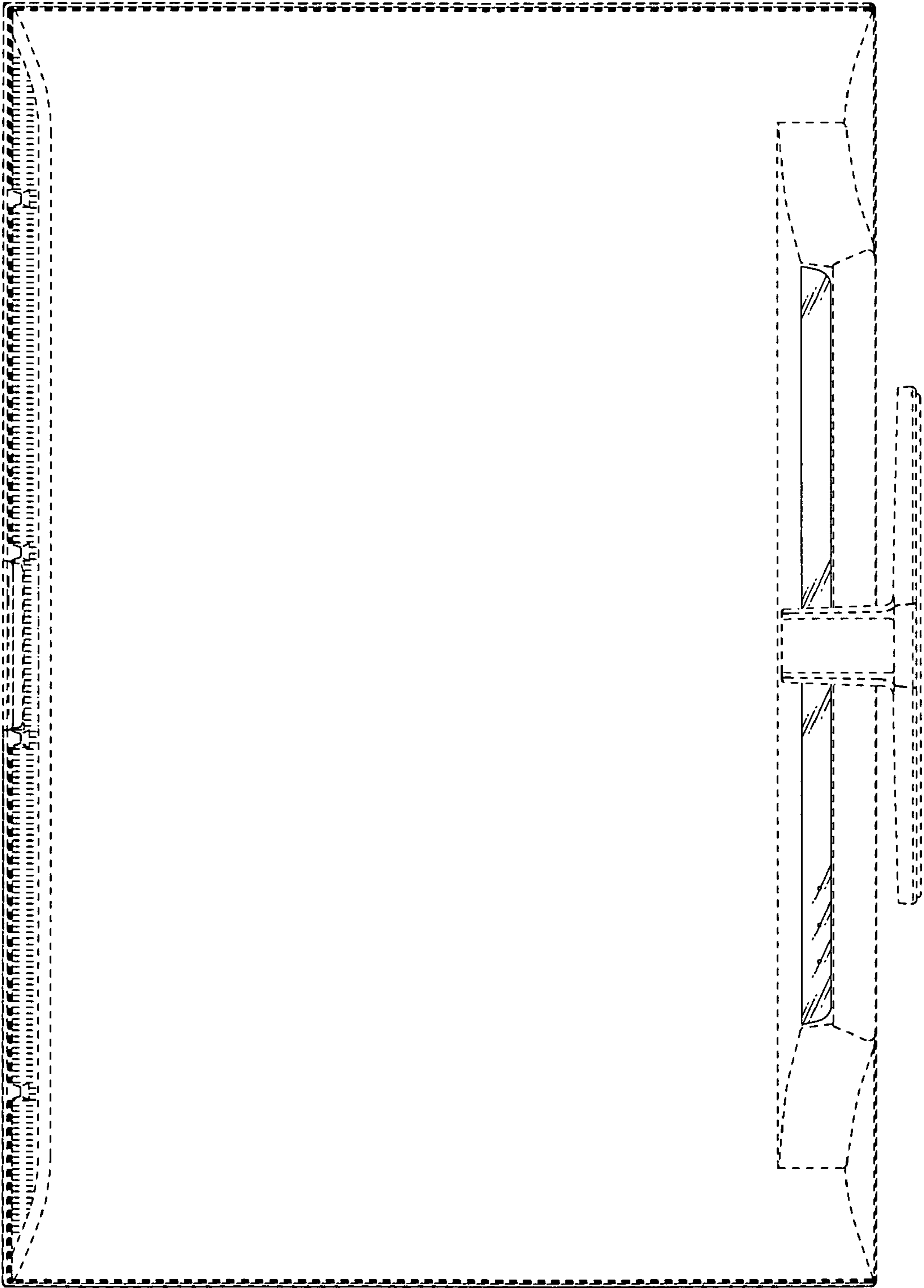

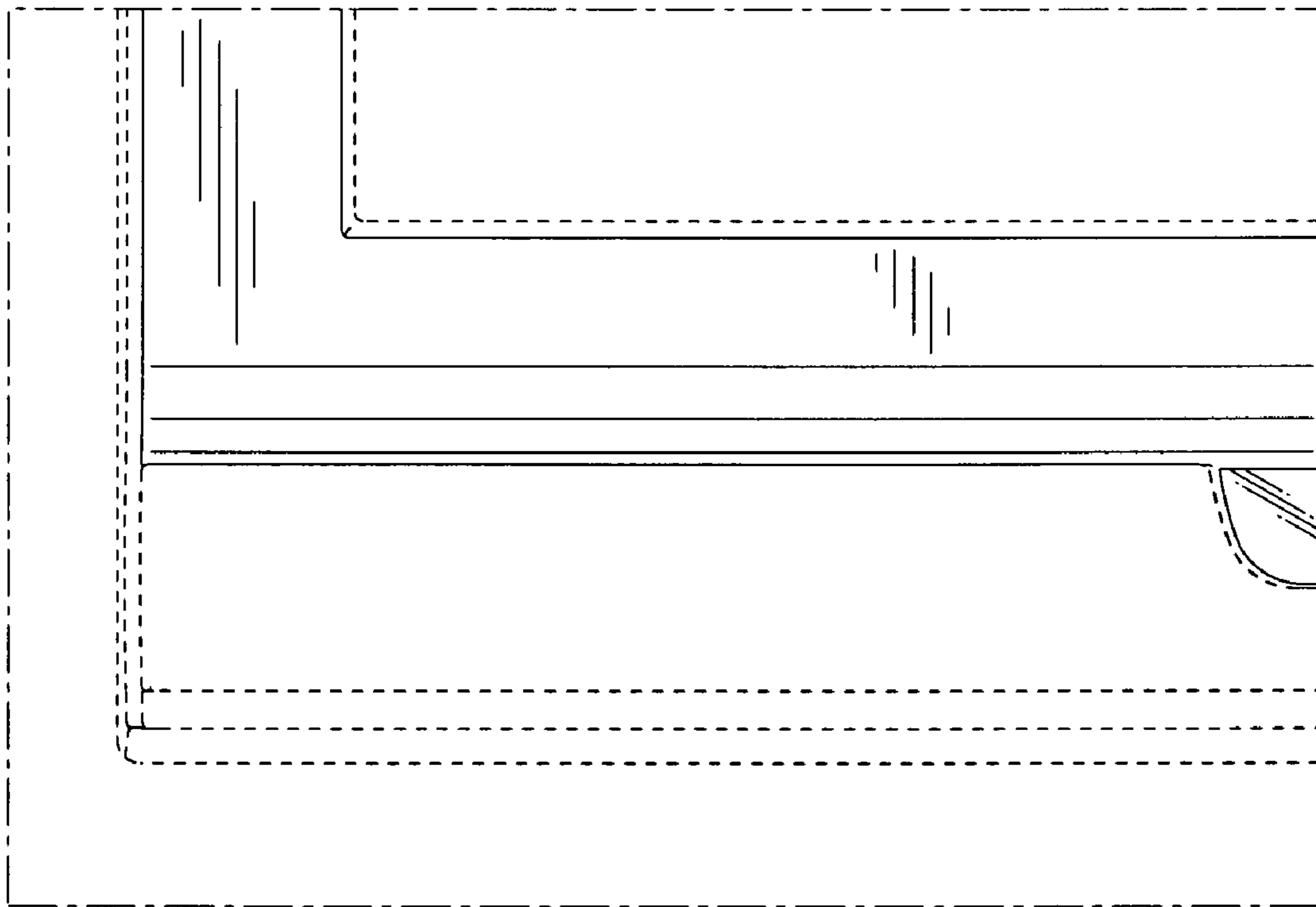

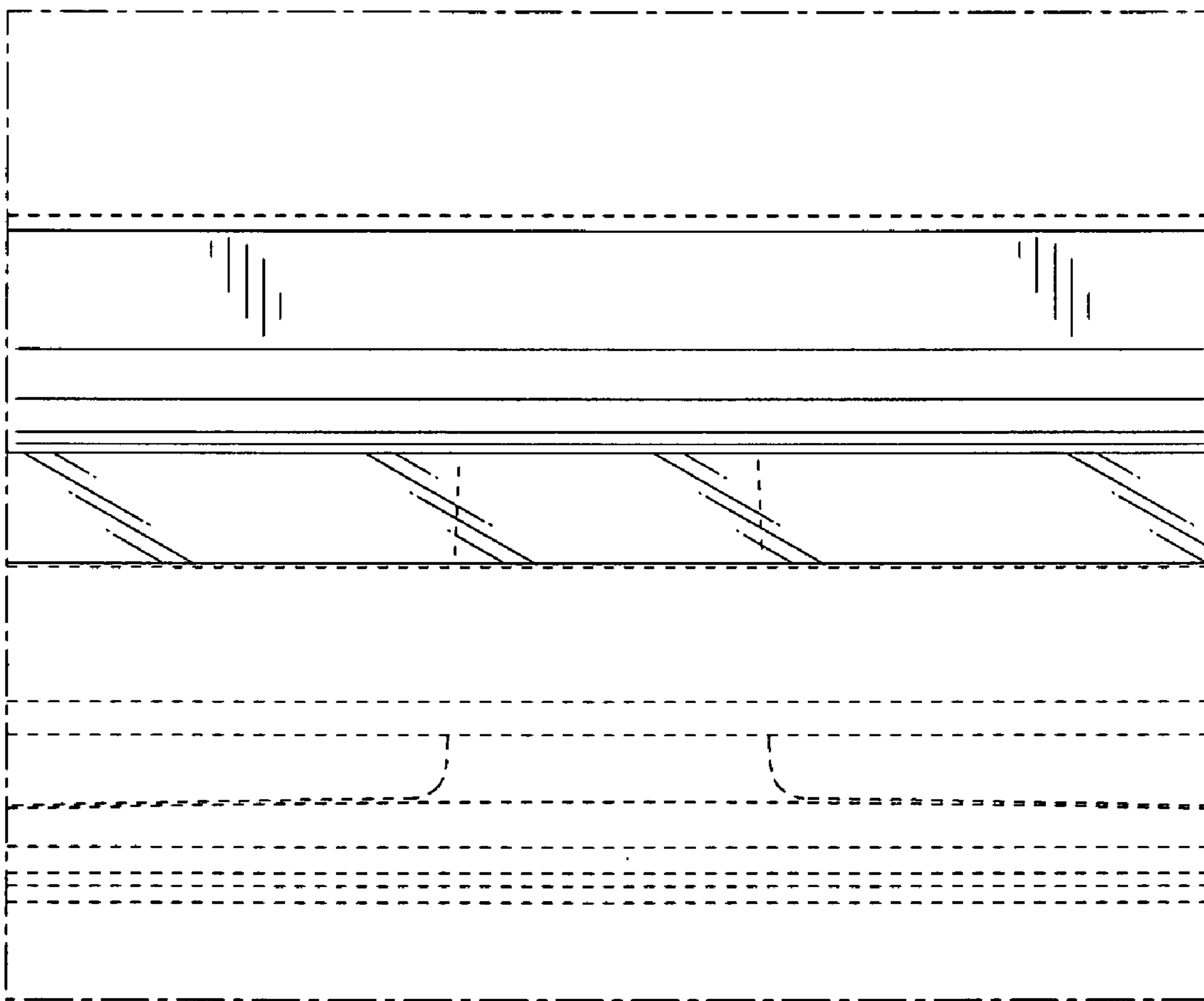

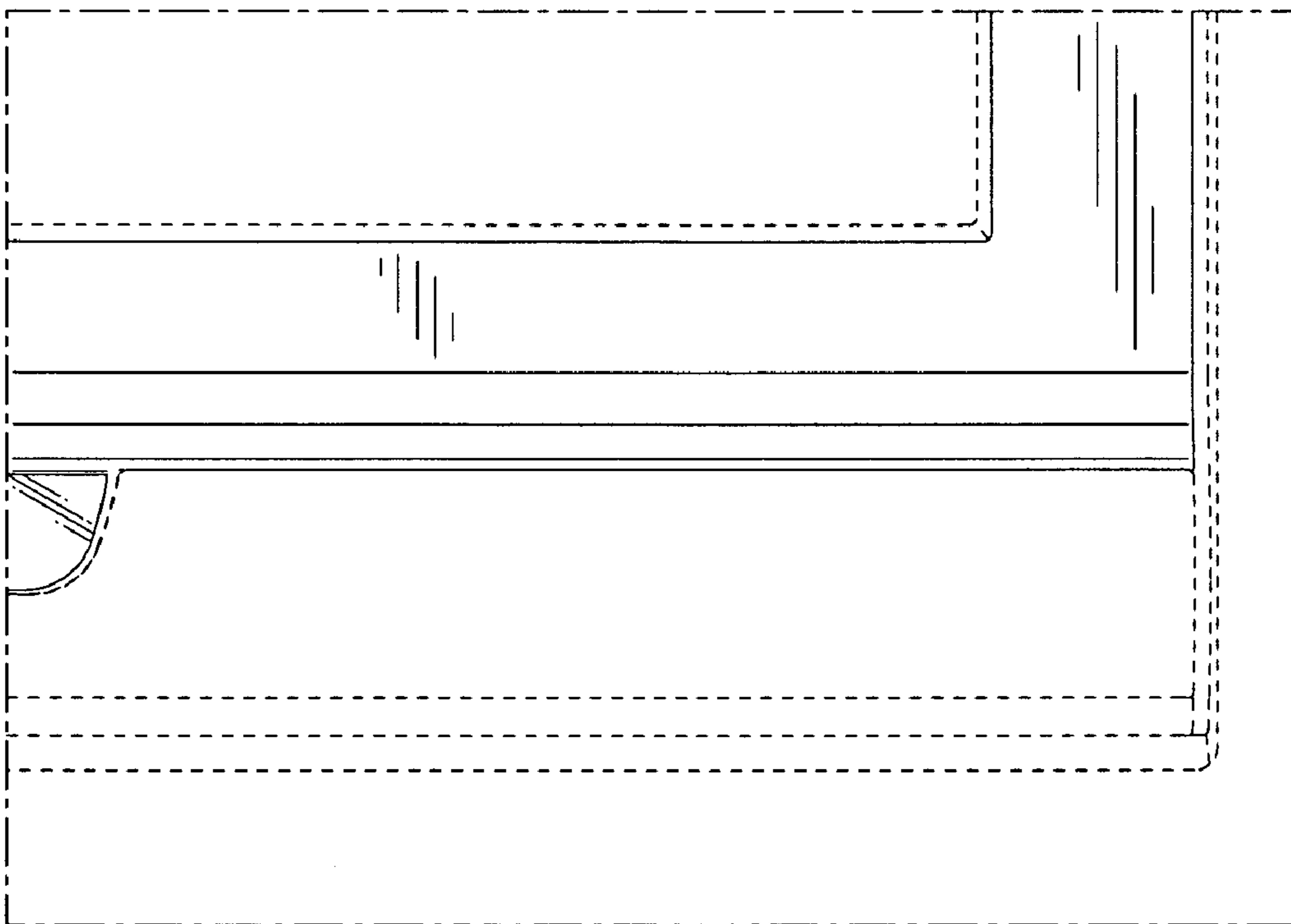

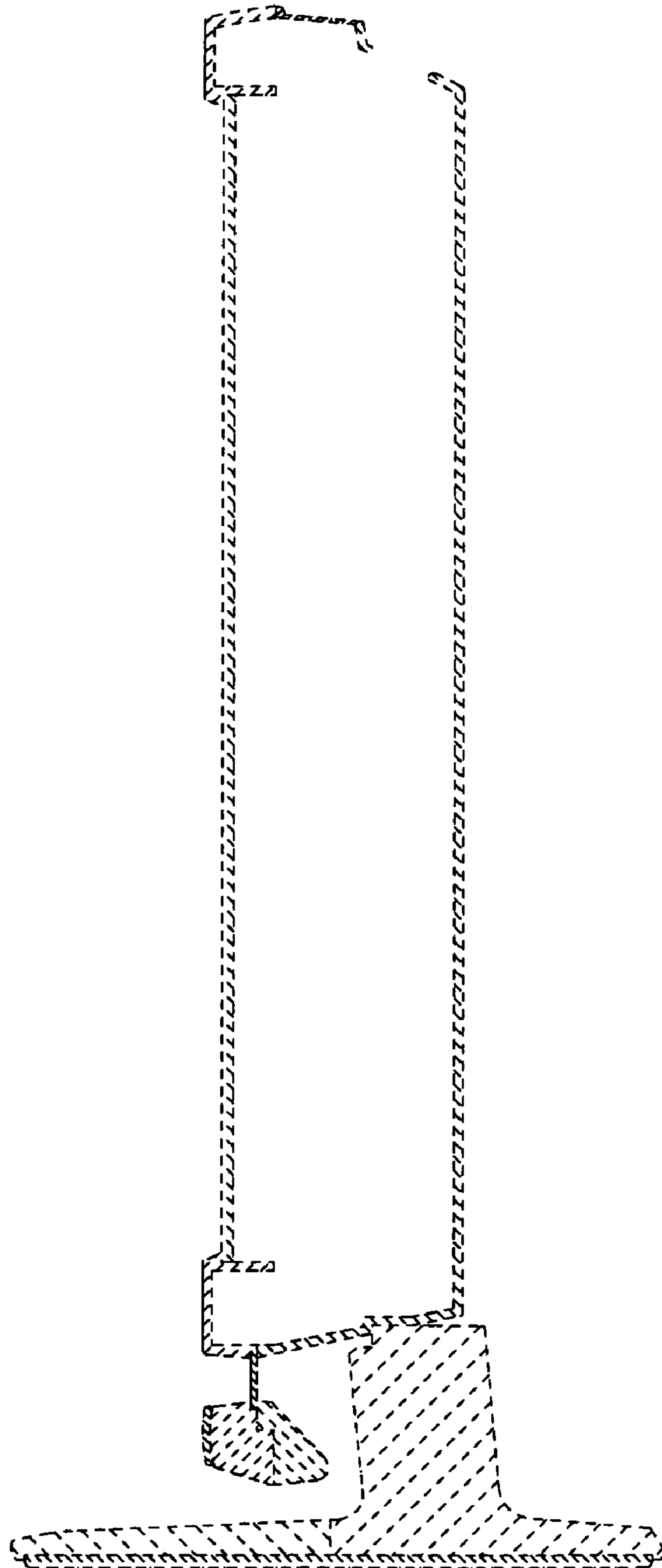

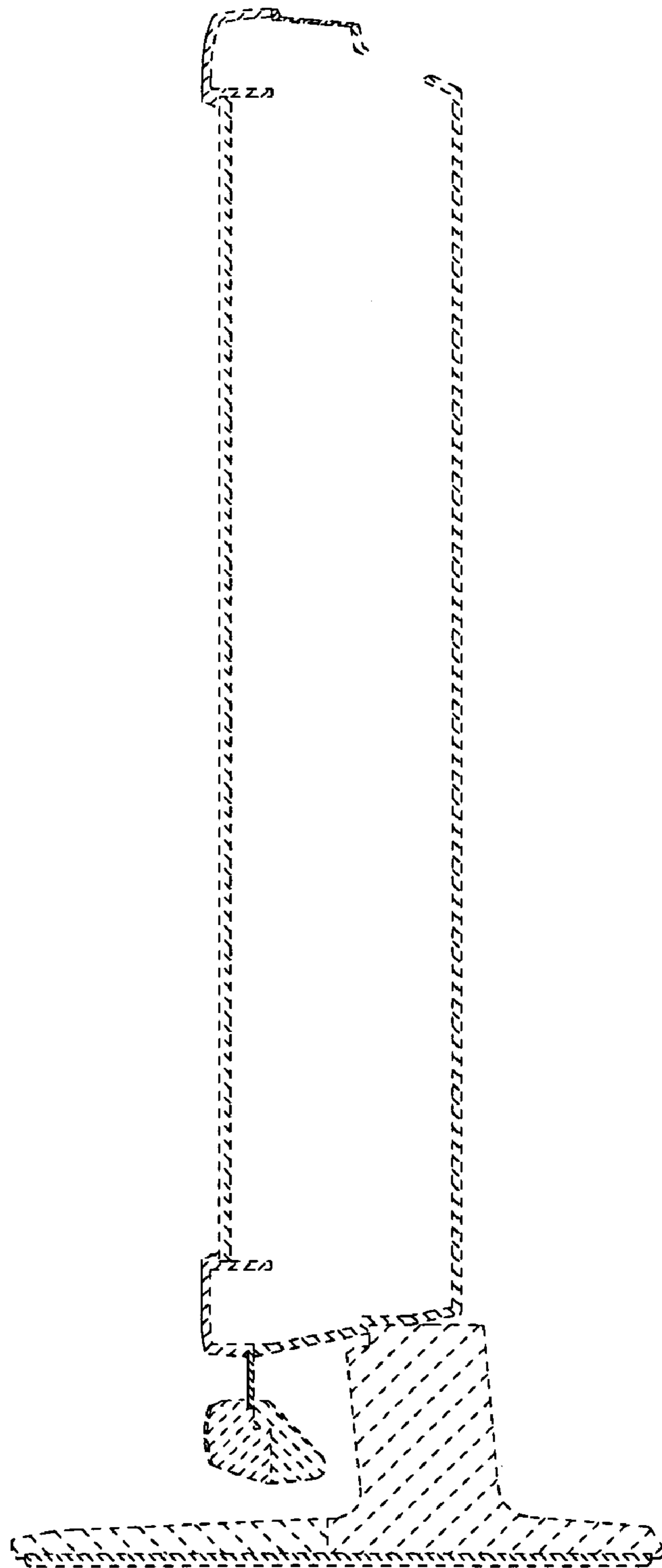

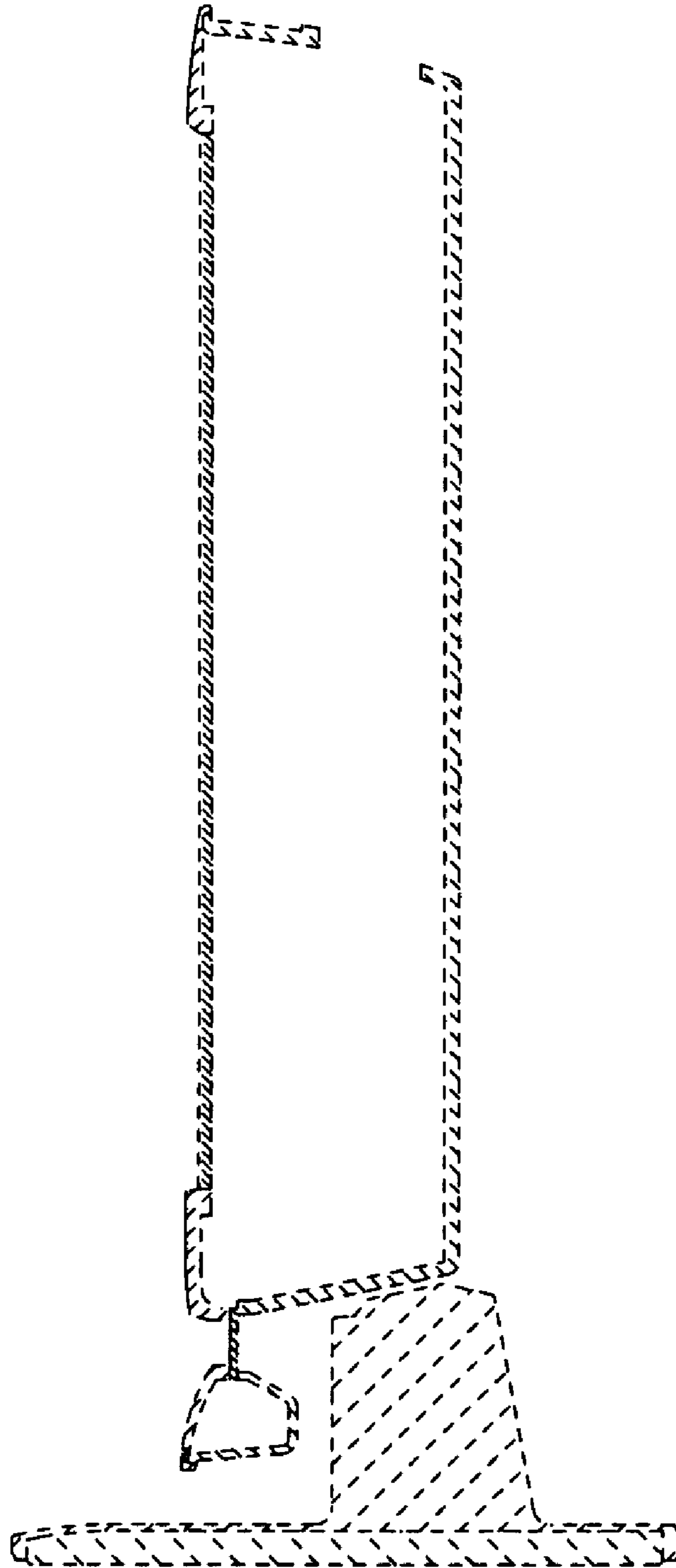

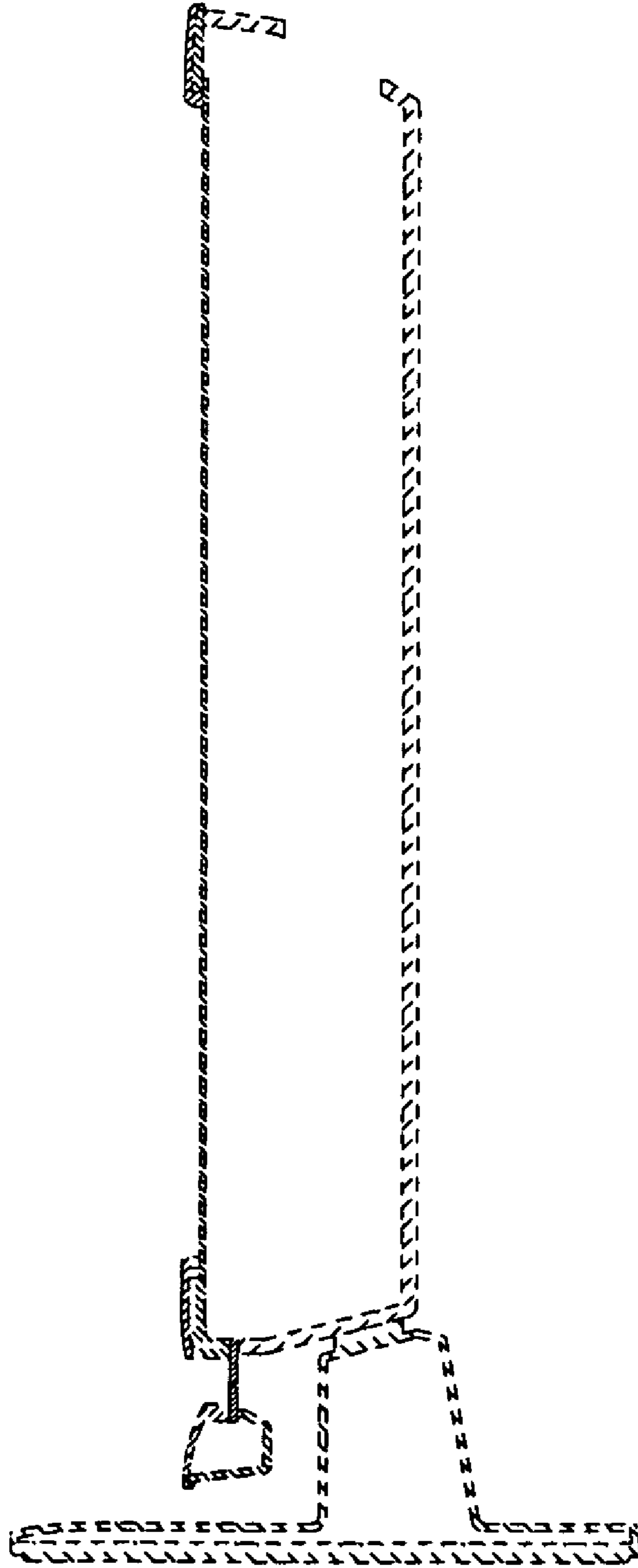
