DESCRIPTION

FIG. 1 is an isometric view of a faucet incorporating our new design, viewed from in front of, above, and from the right side of the faucet;

FIG. 2 is a right-side elevation view thereof;

FIG. 3 is a left-side elevation view thereof;

FIG. 4 is a front elevation view thereof;

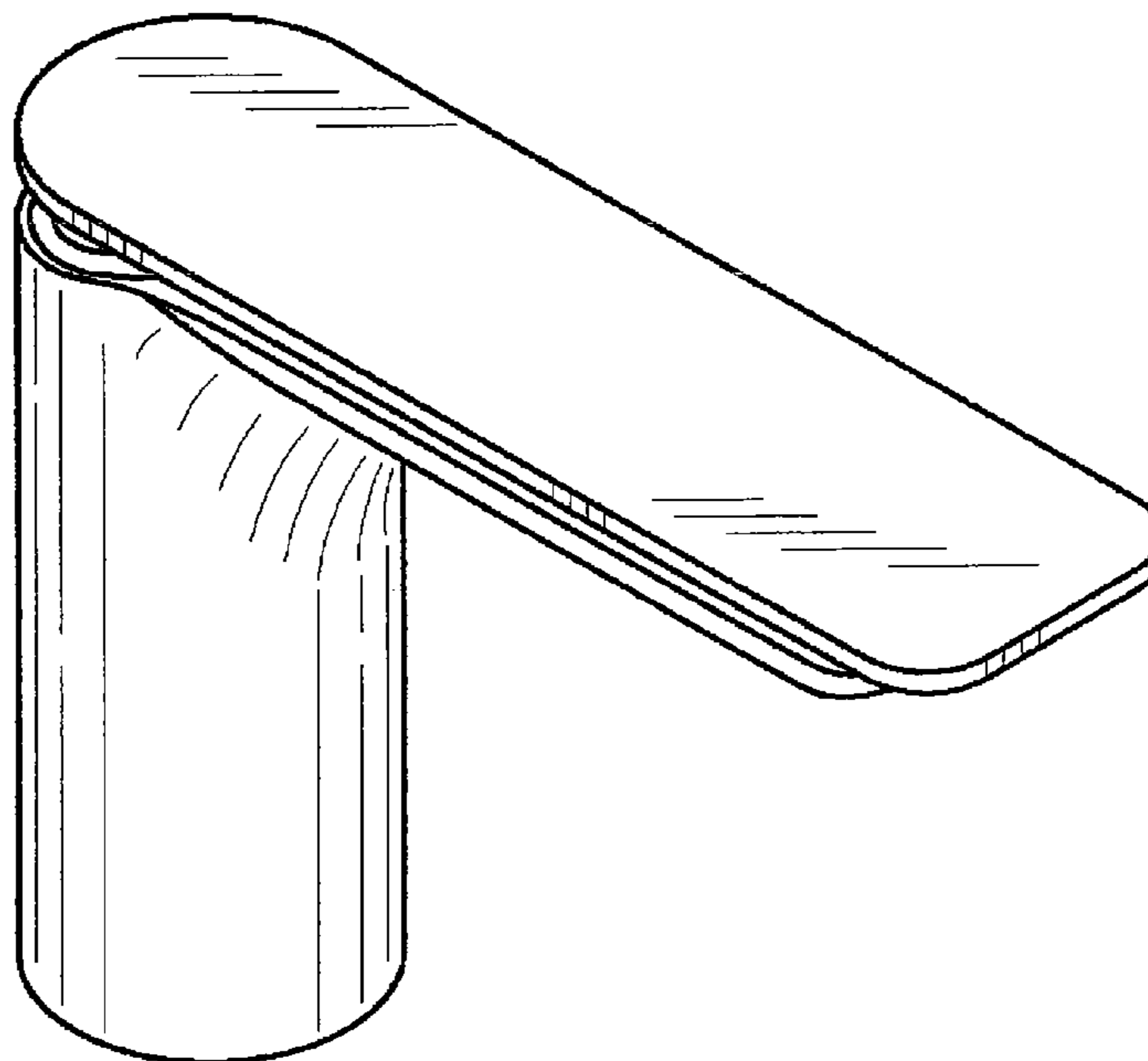
FIG. 5 is a rear elevation view thereof;

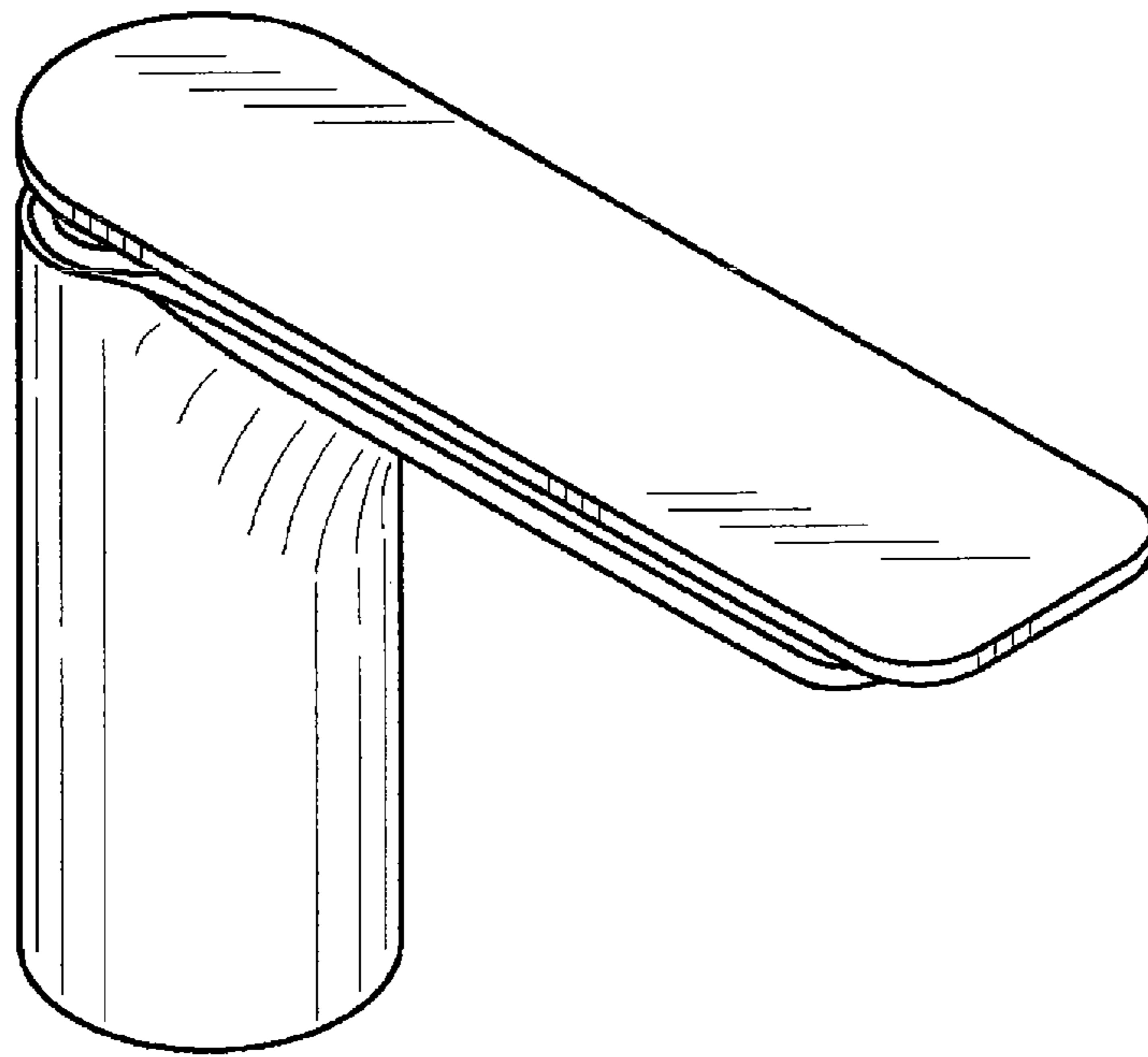

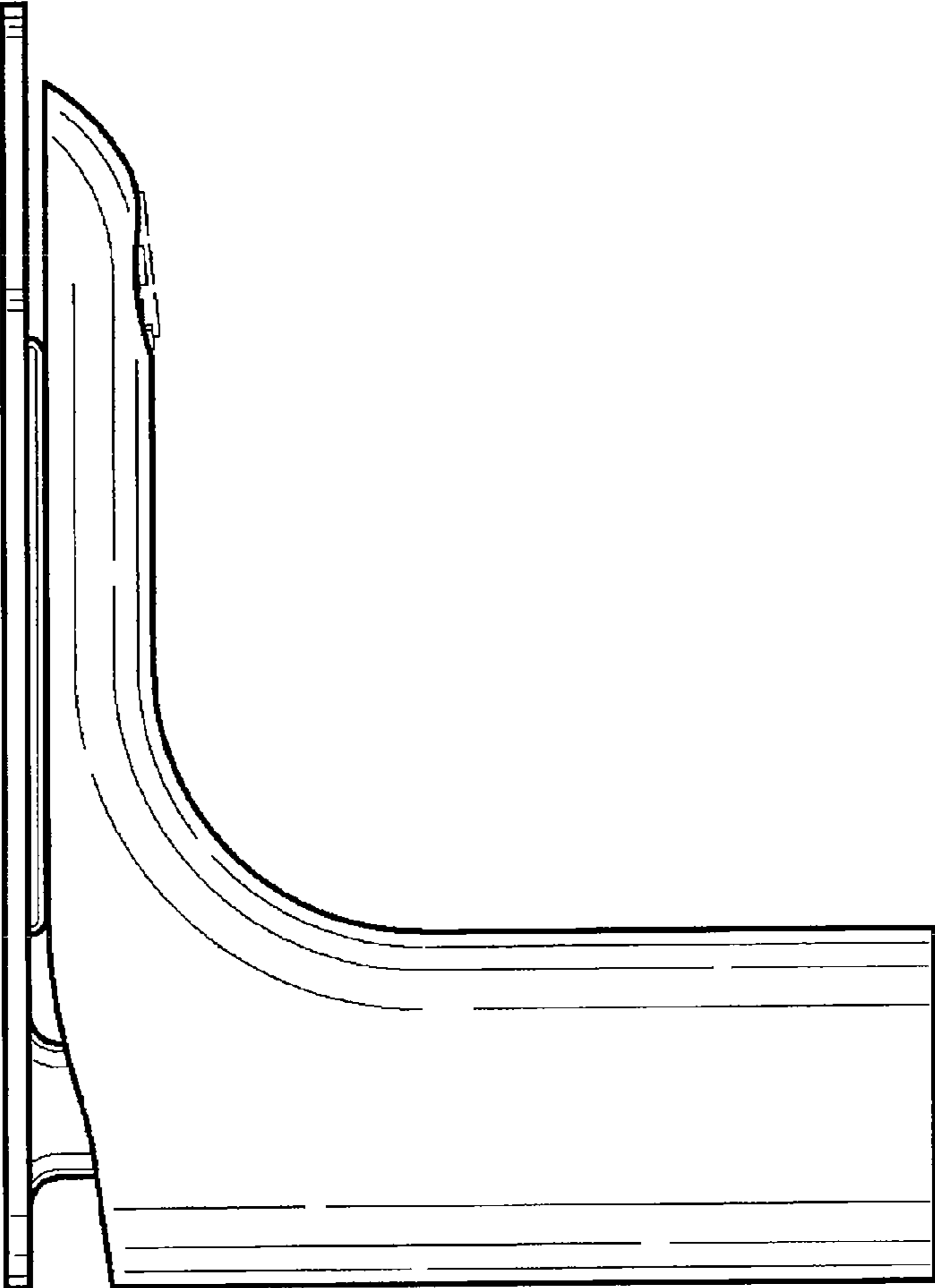

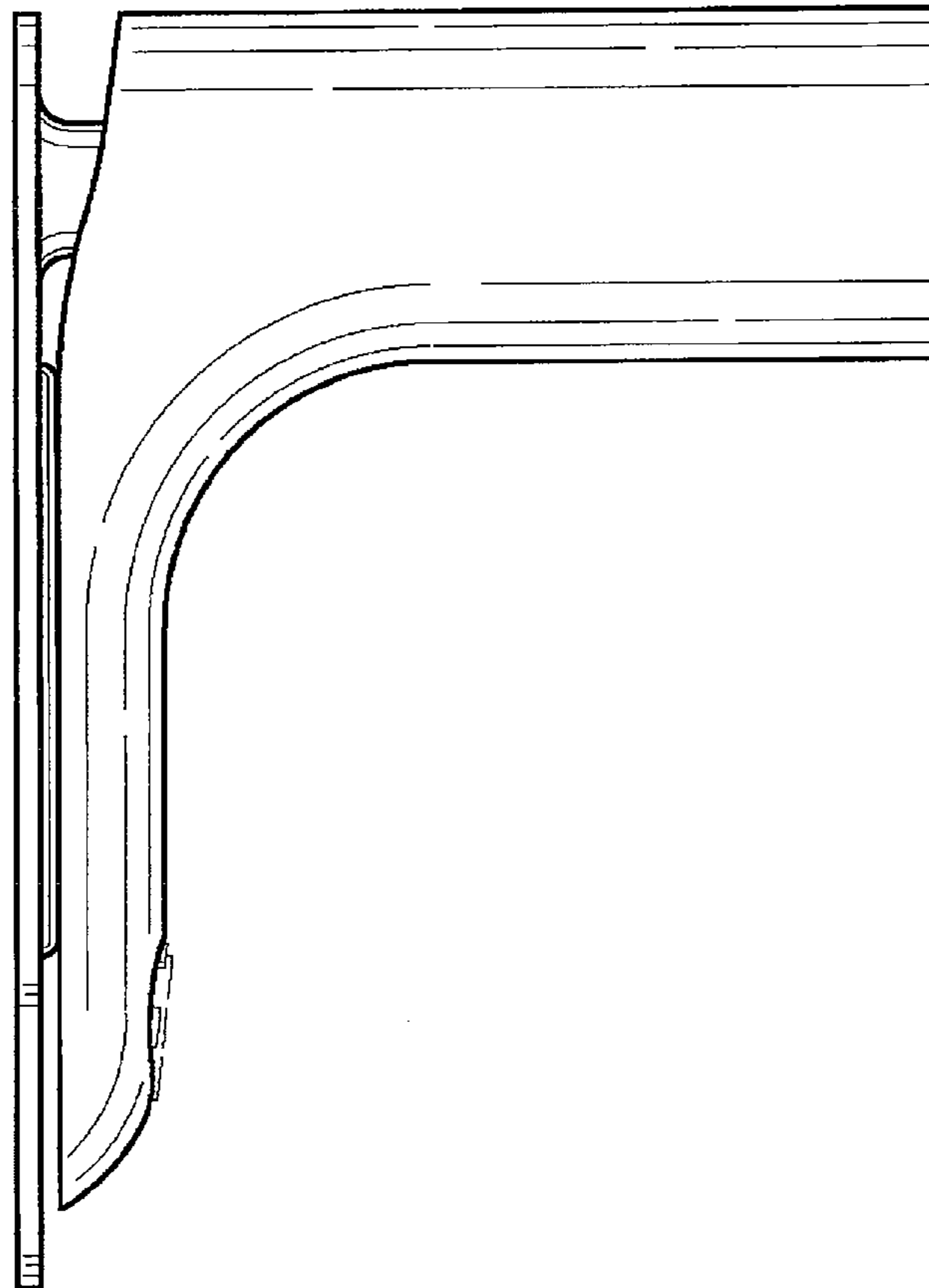

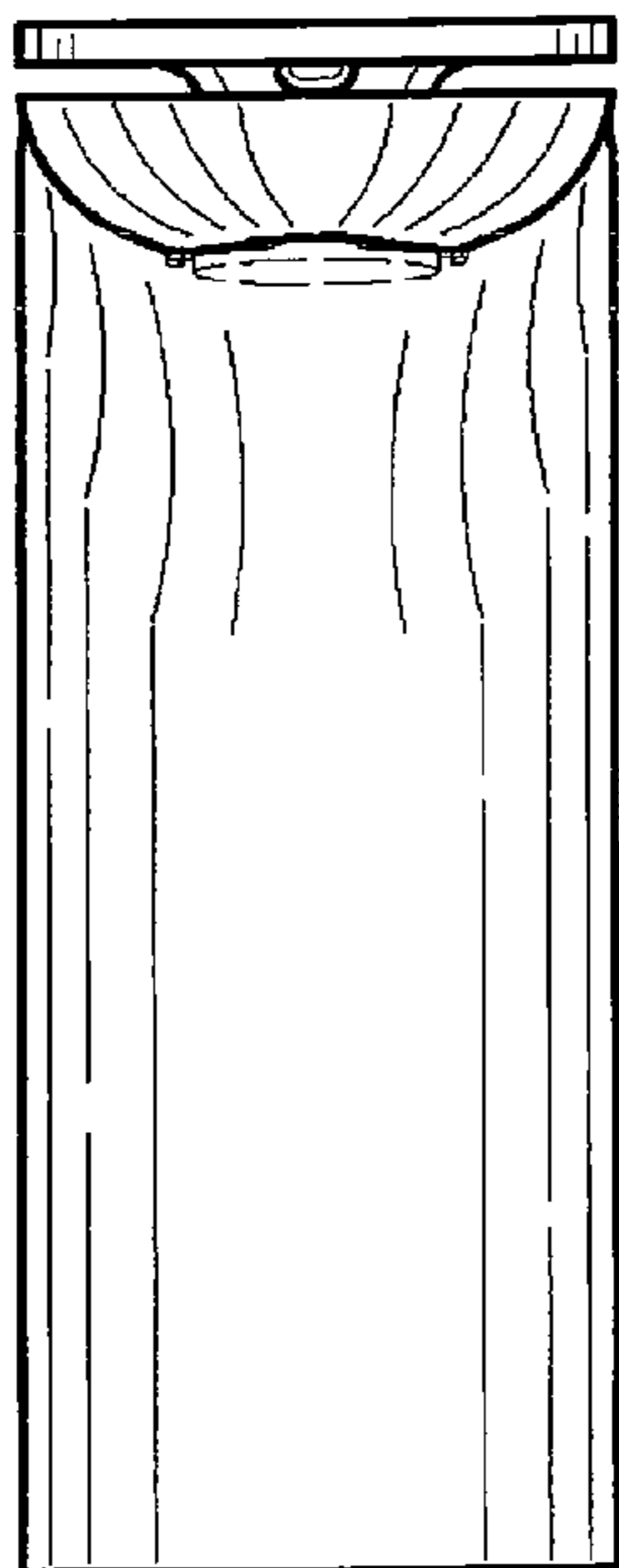

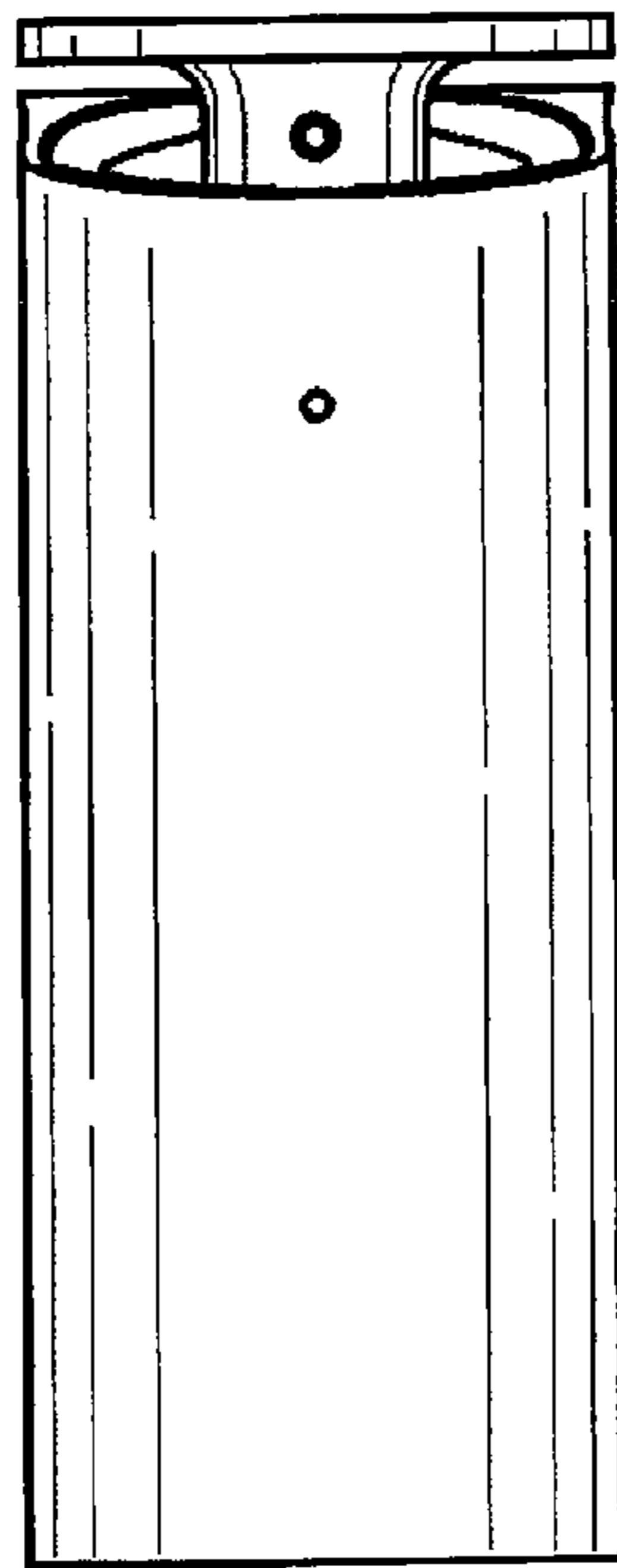

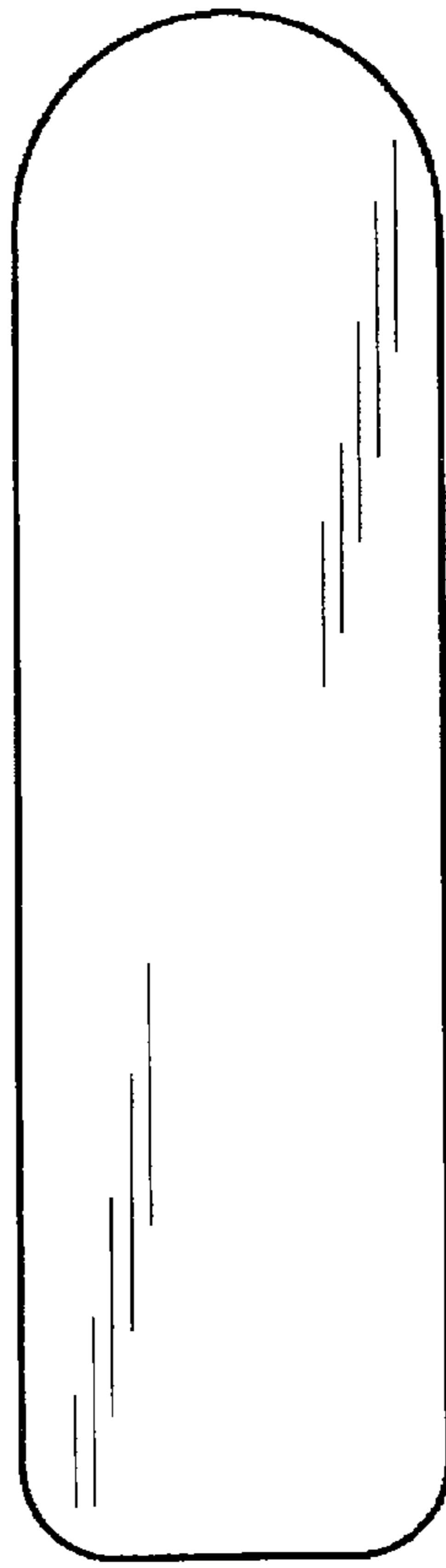

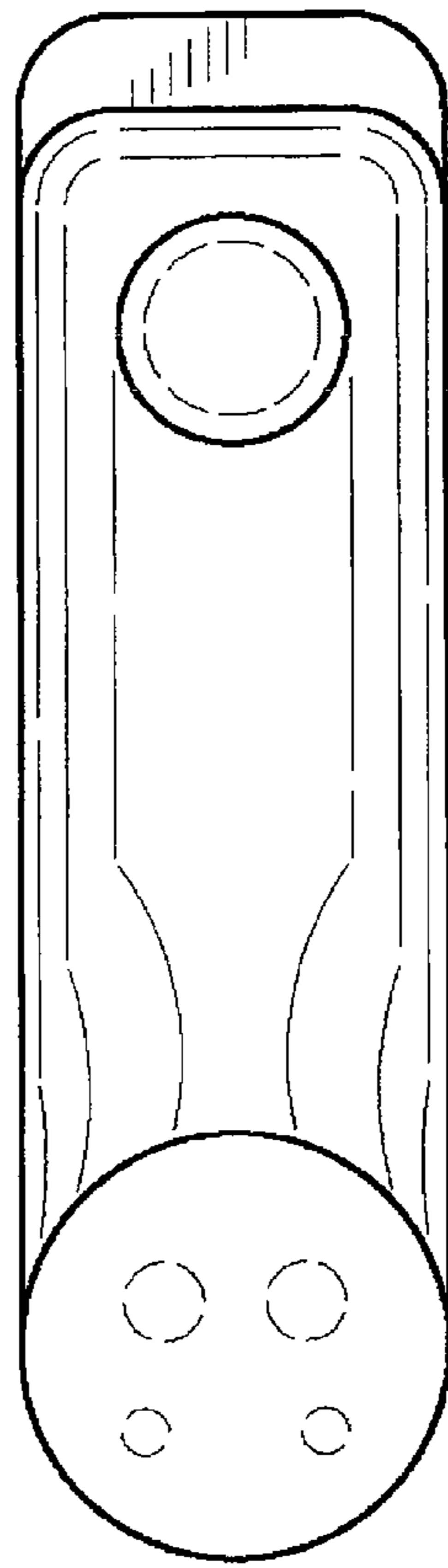
