(57) **CLAIM**

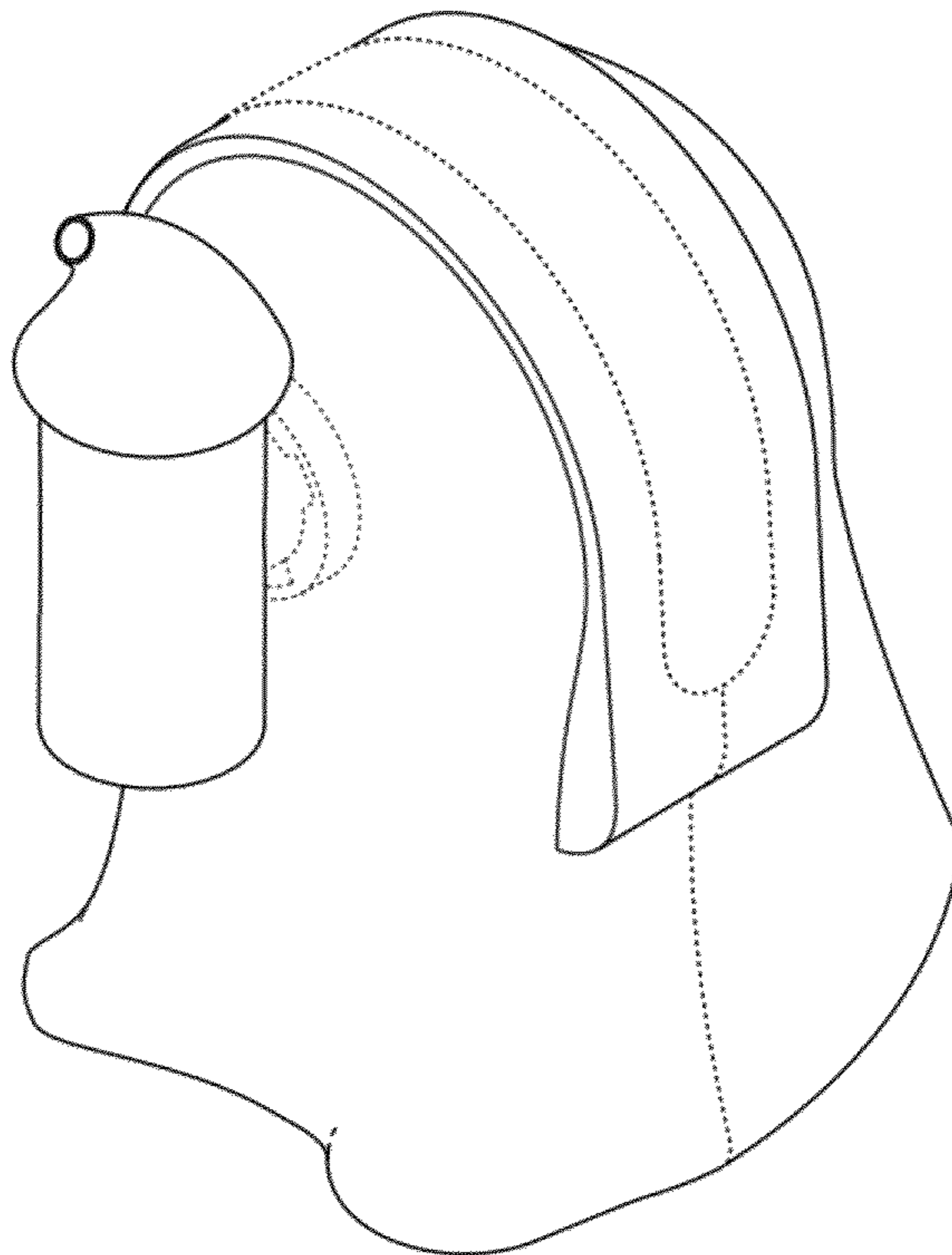
The ornamental design for a aroma nebulizing diffuser, as shown and described.

DESCRIPTION

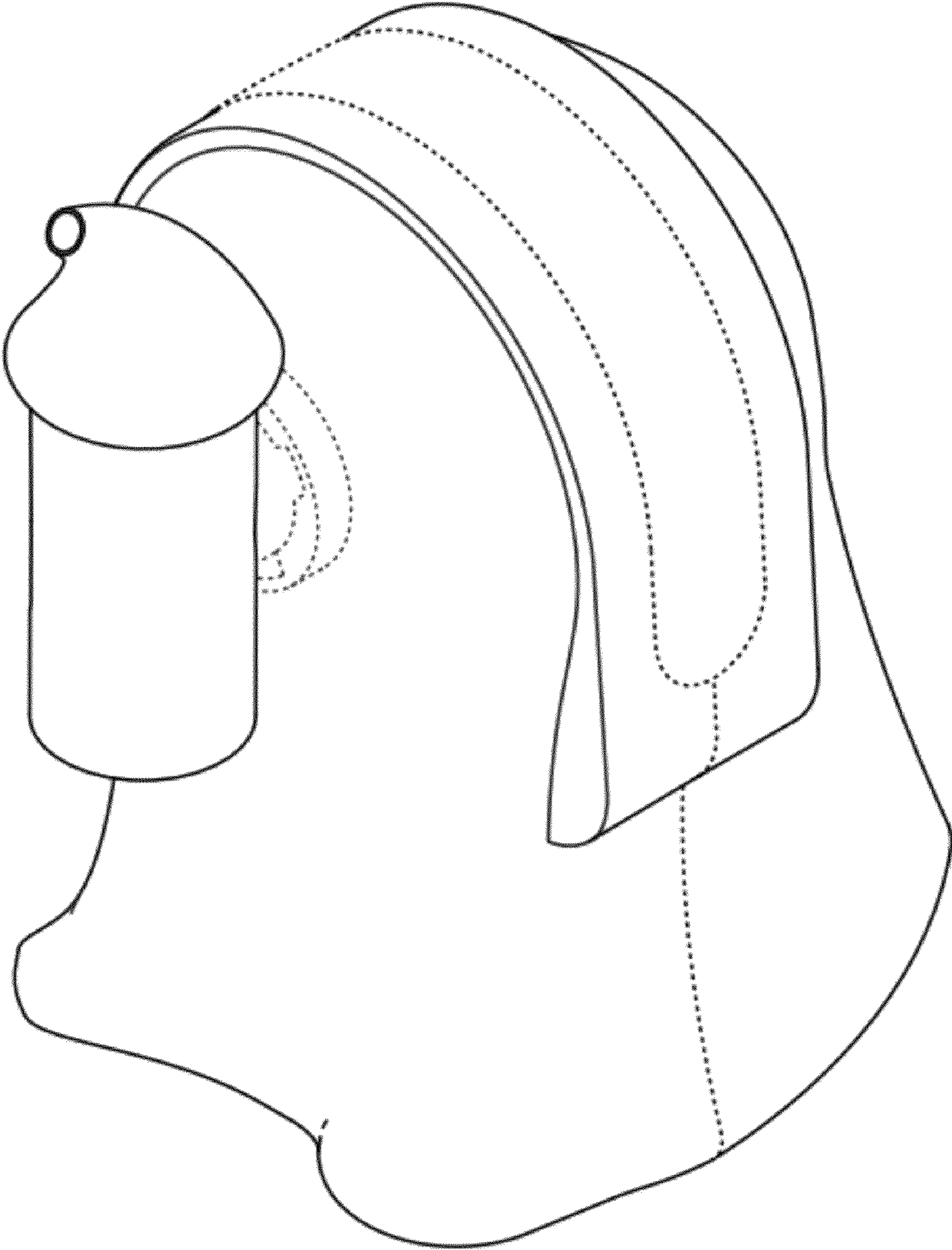

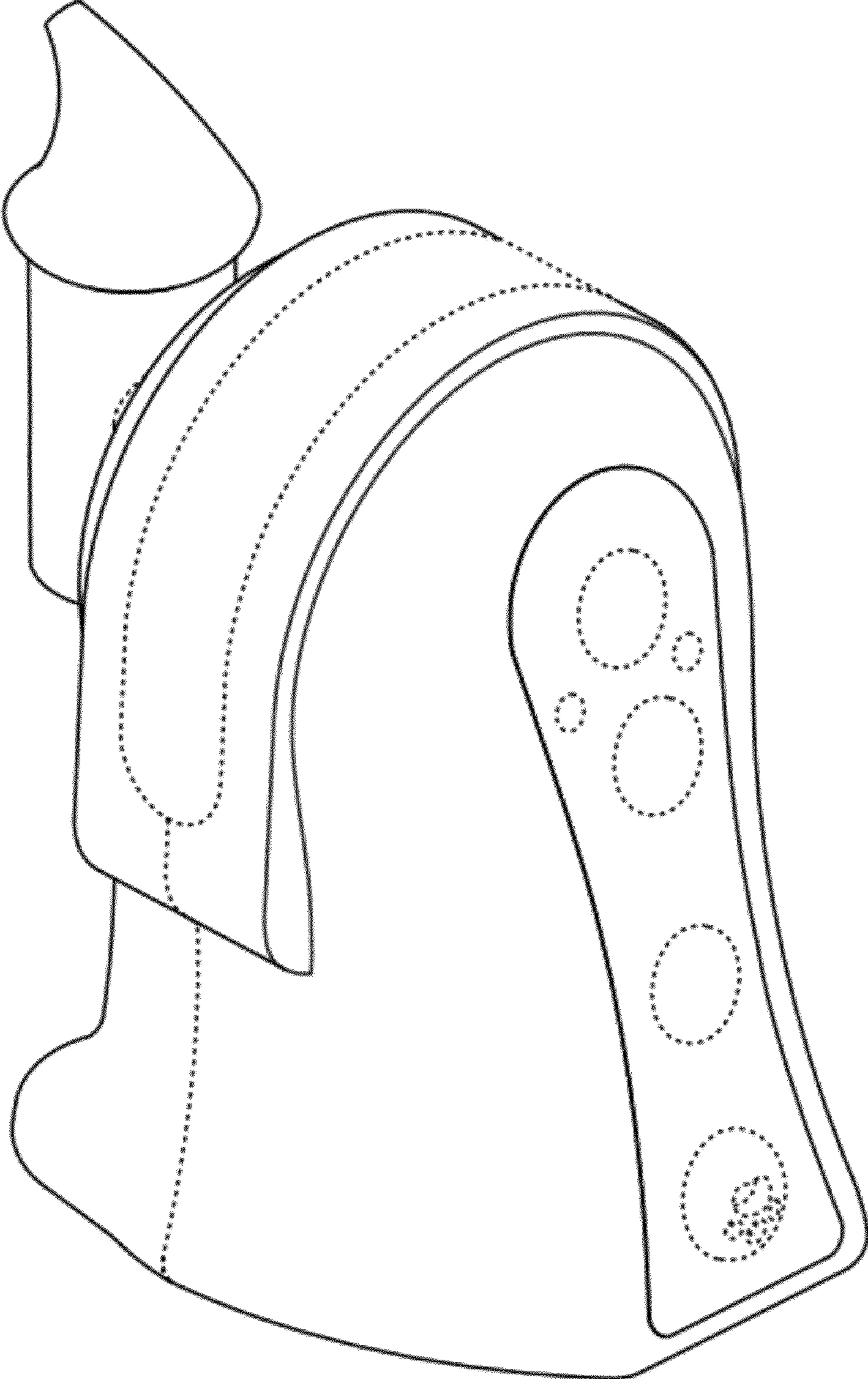

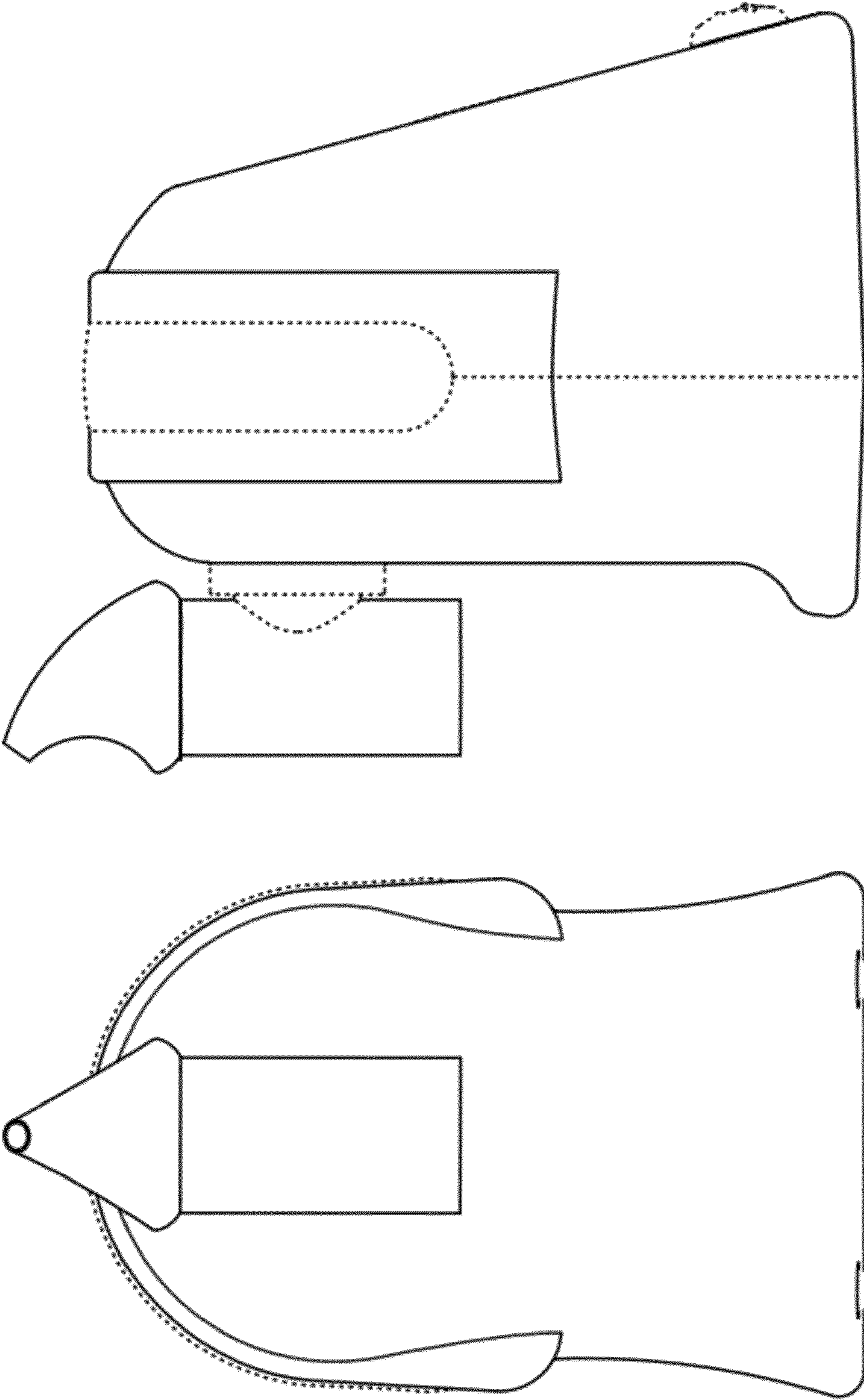

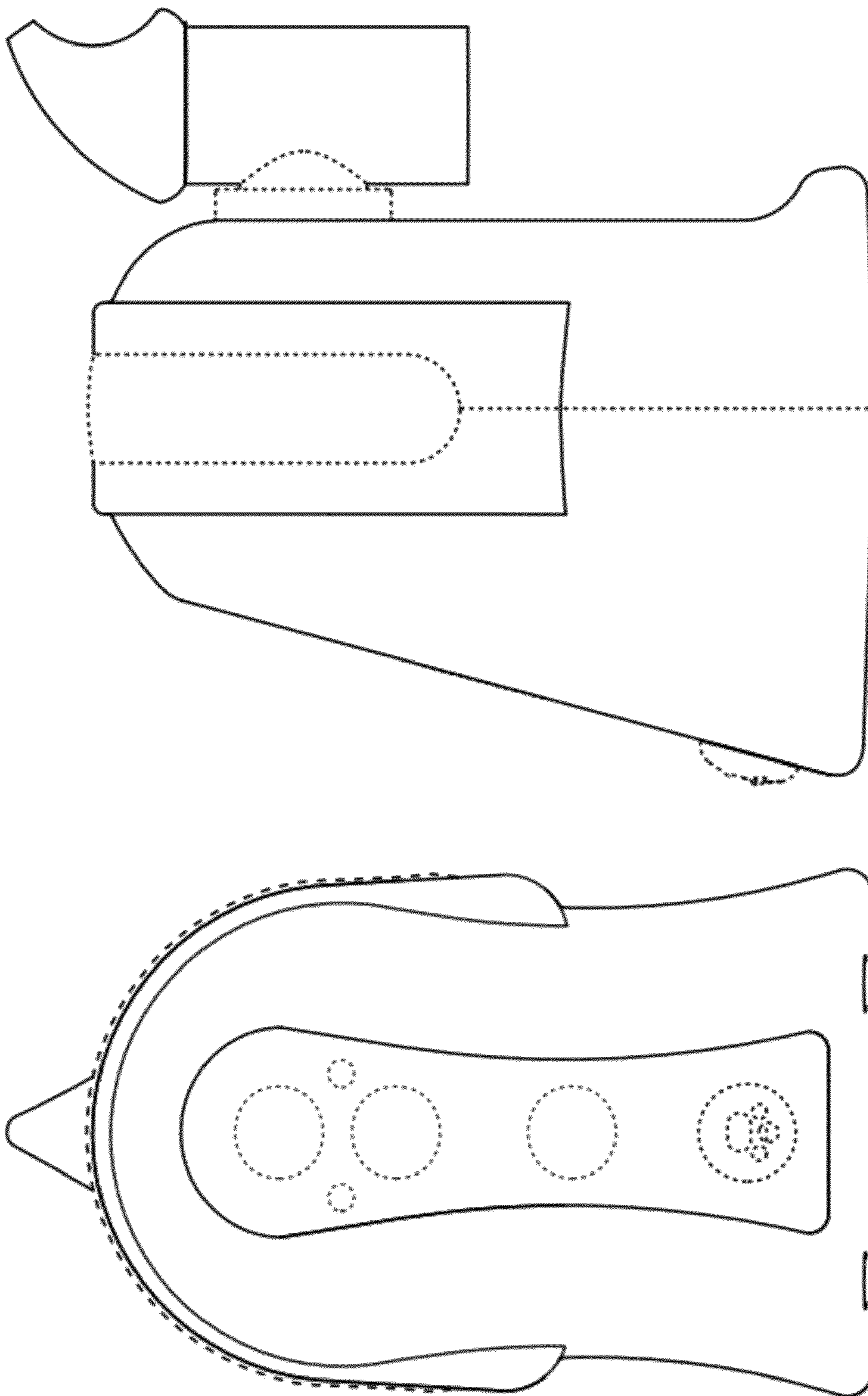

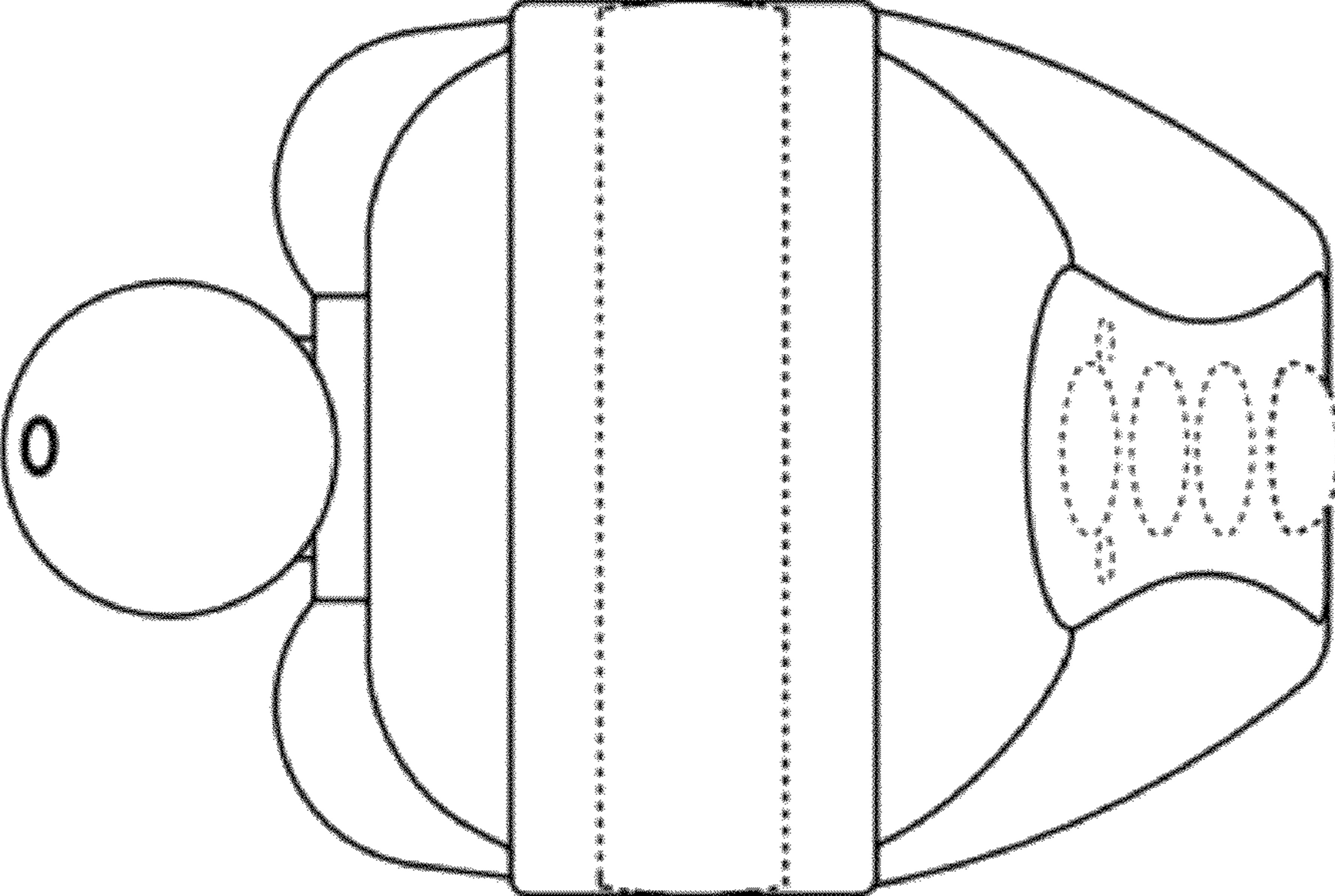

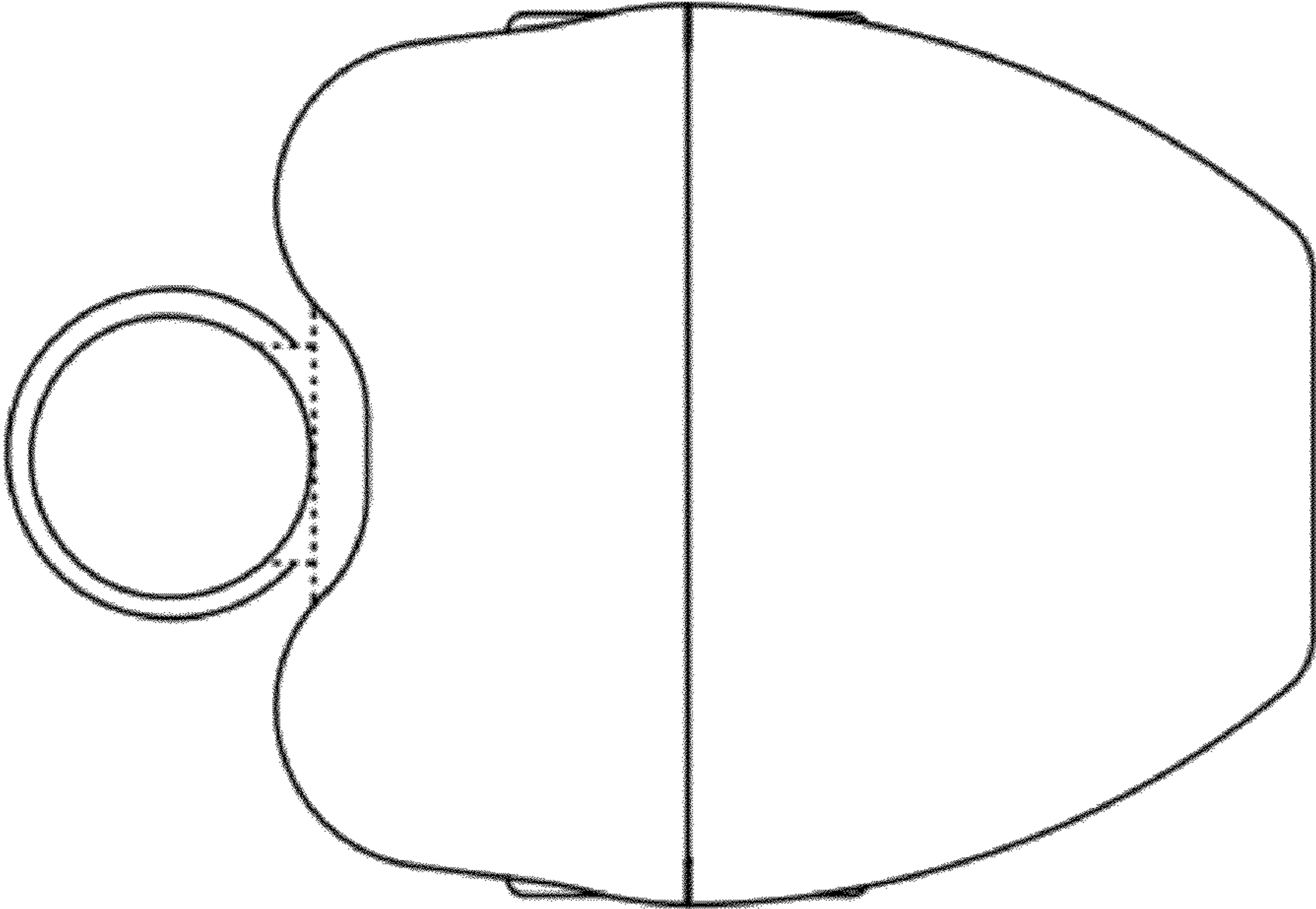

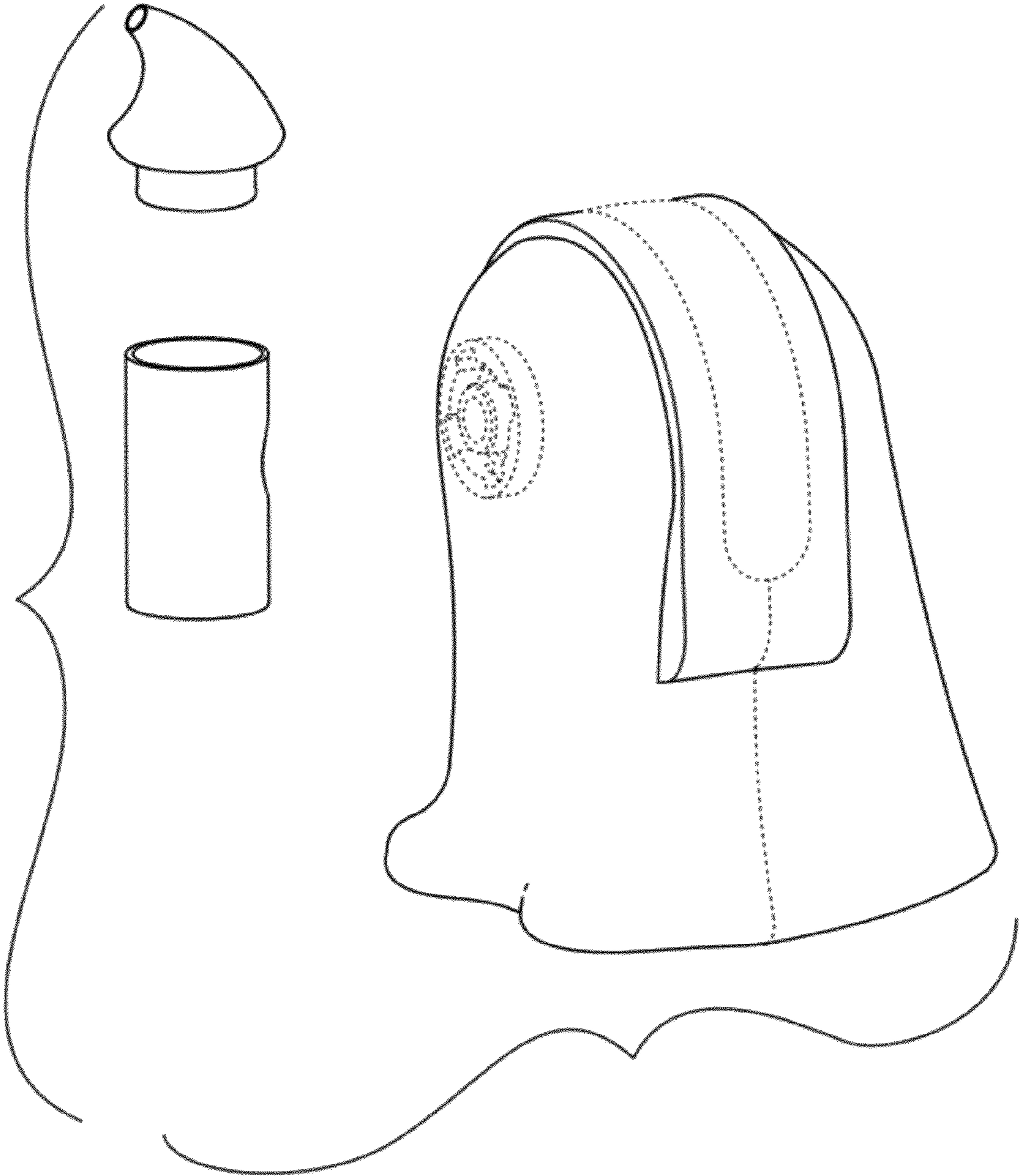
