The ornamental design for a corral panel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the corral panel of the present invention;

FIG. 2 is a top view of the corral panel of FIG. 1;

FIG. 4 is a front view of the corral panel of FIG. 1;

FIG. 5 is a right side view of the corral panel of FIG. 1;

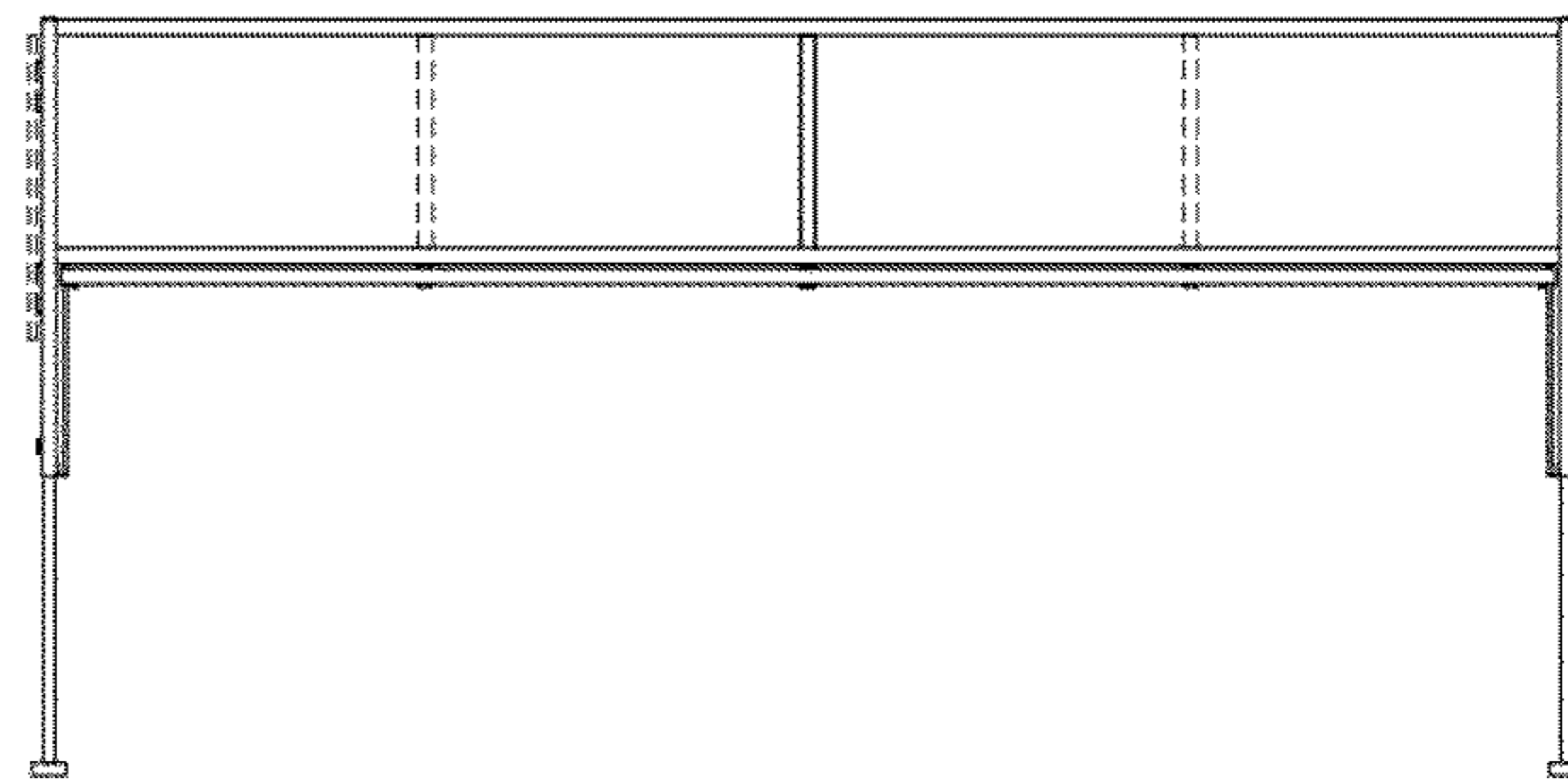
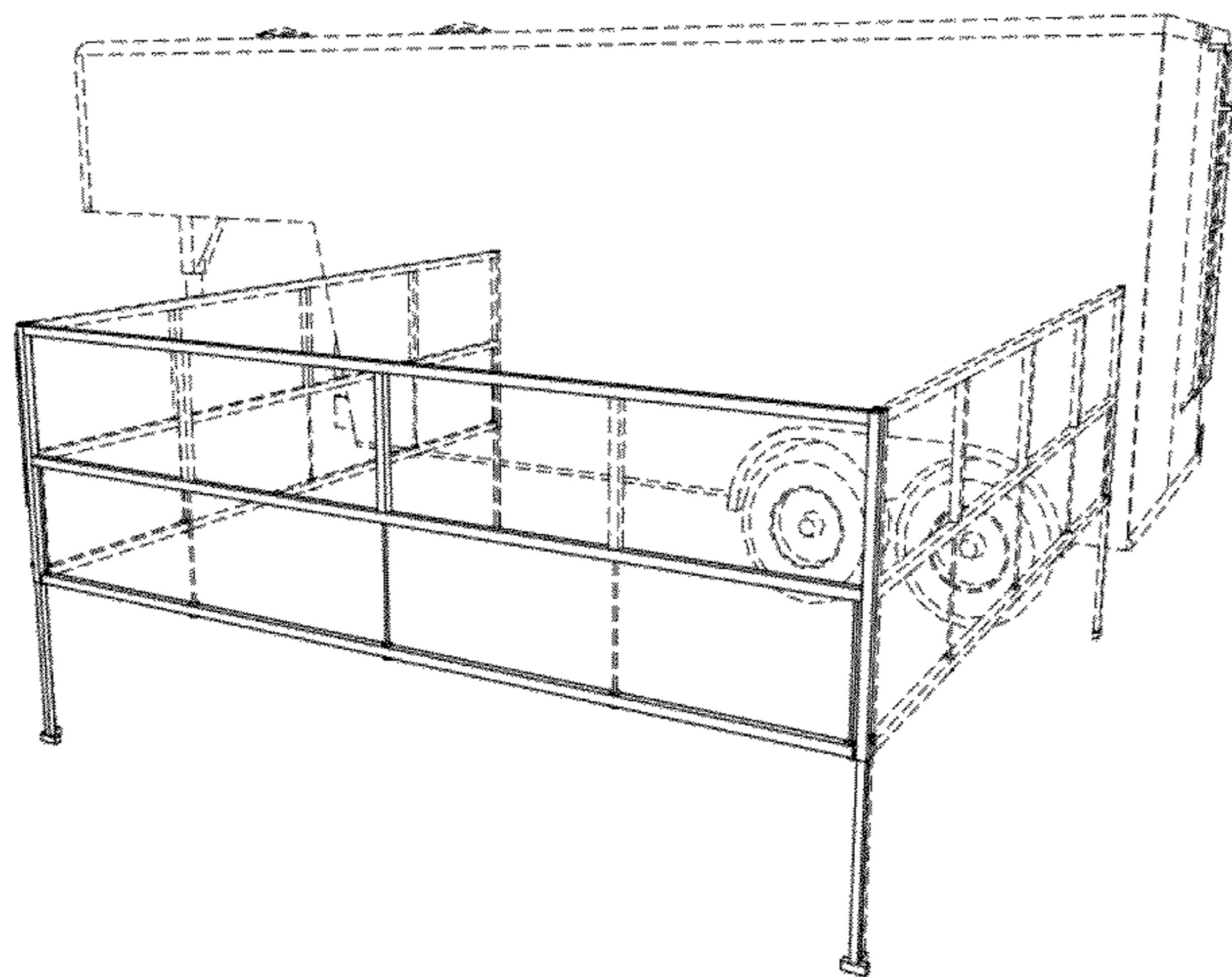
FIG. 6 is a bottom view of the corral panel of FIG. 1;

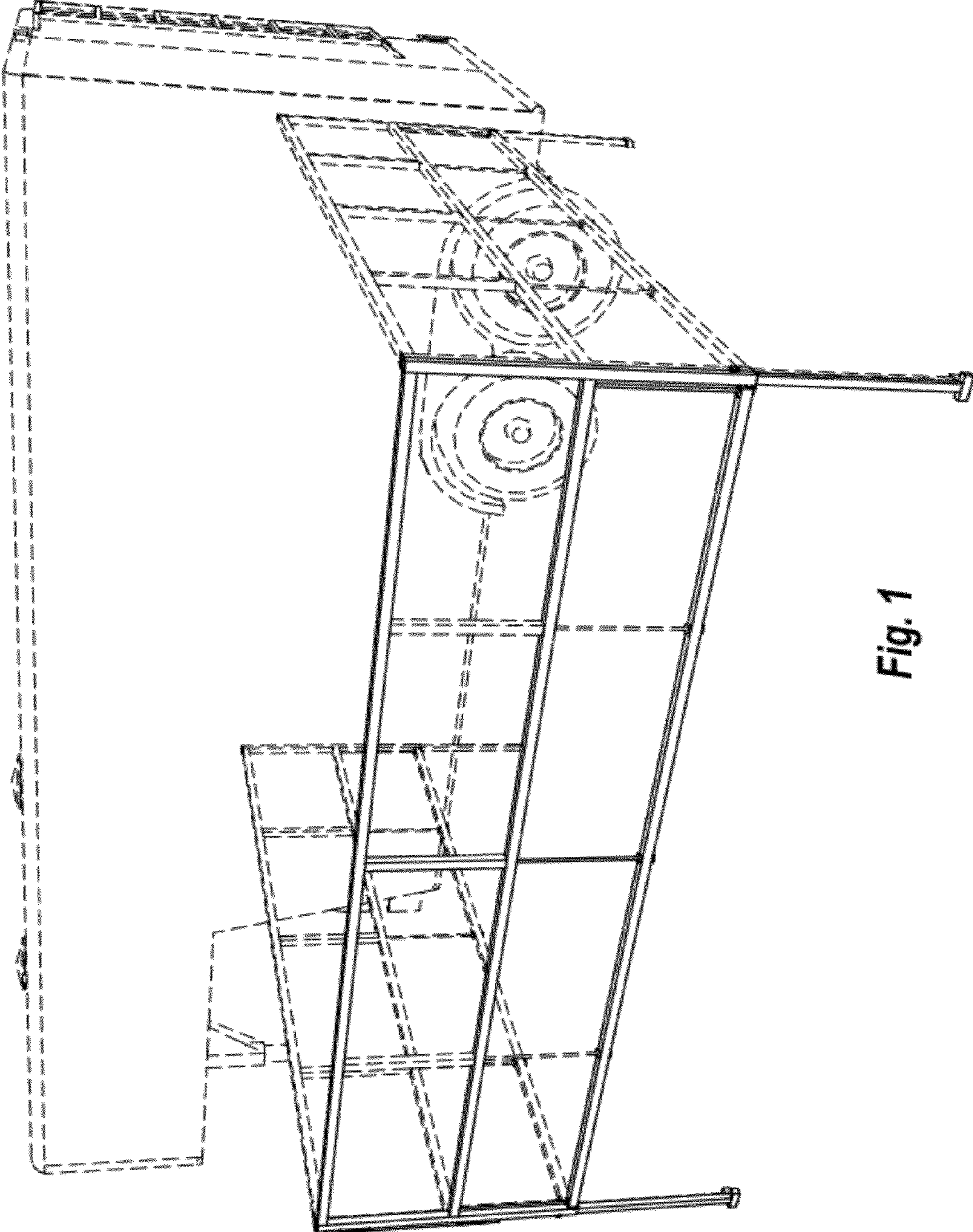

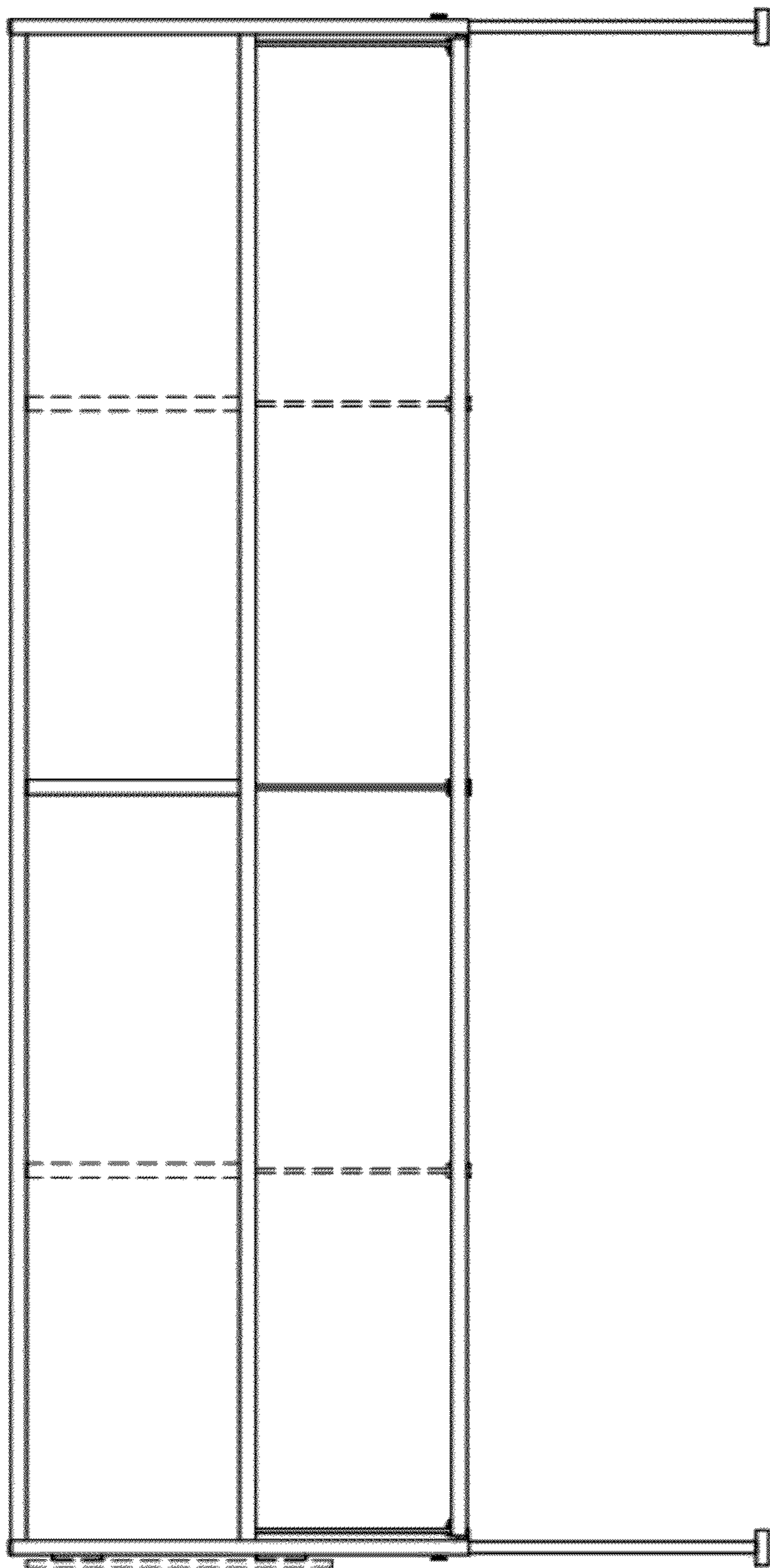

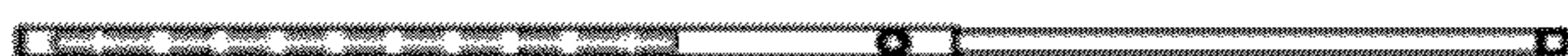

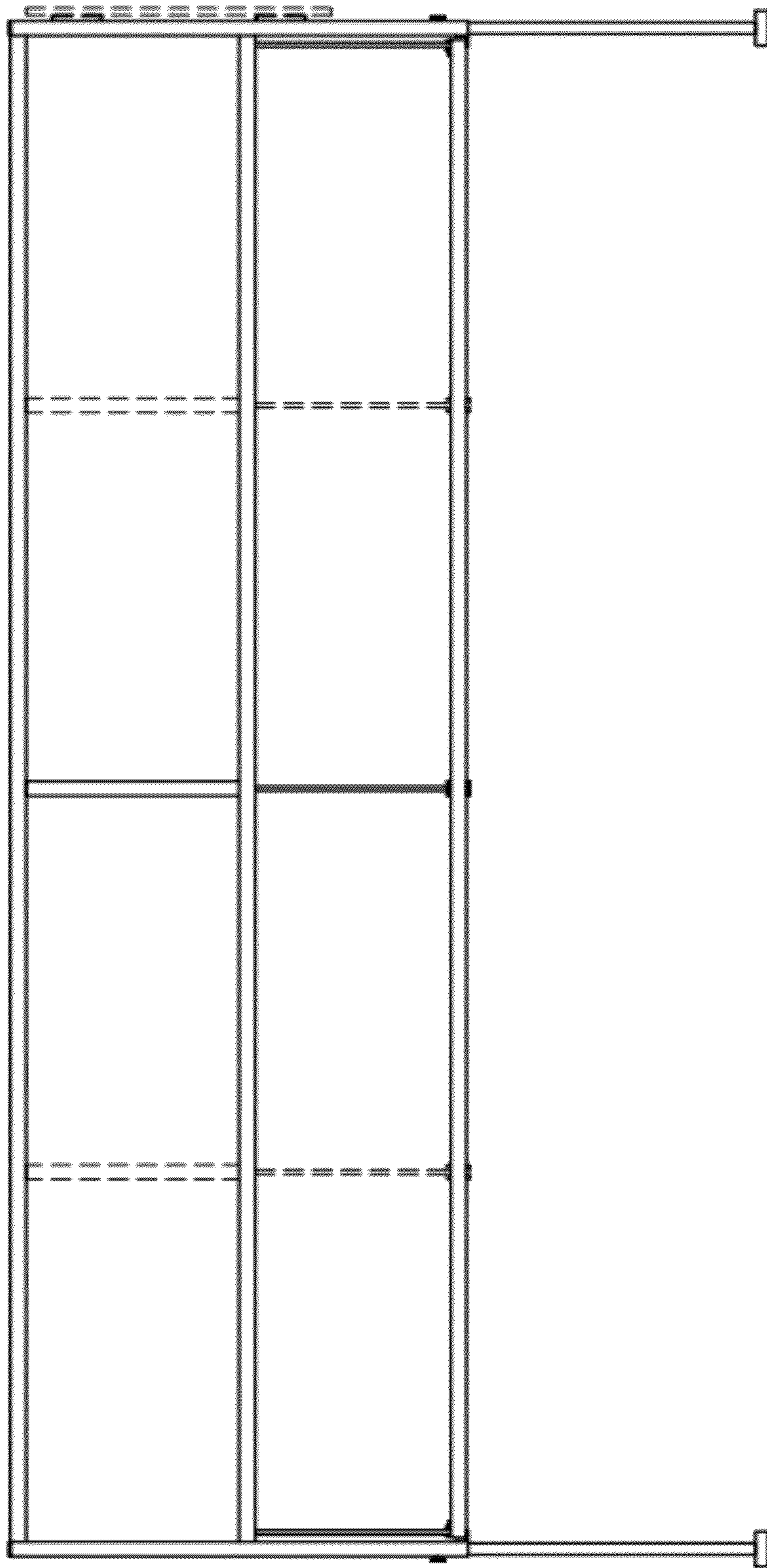

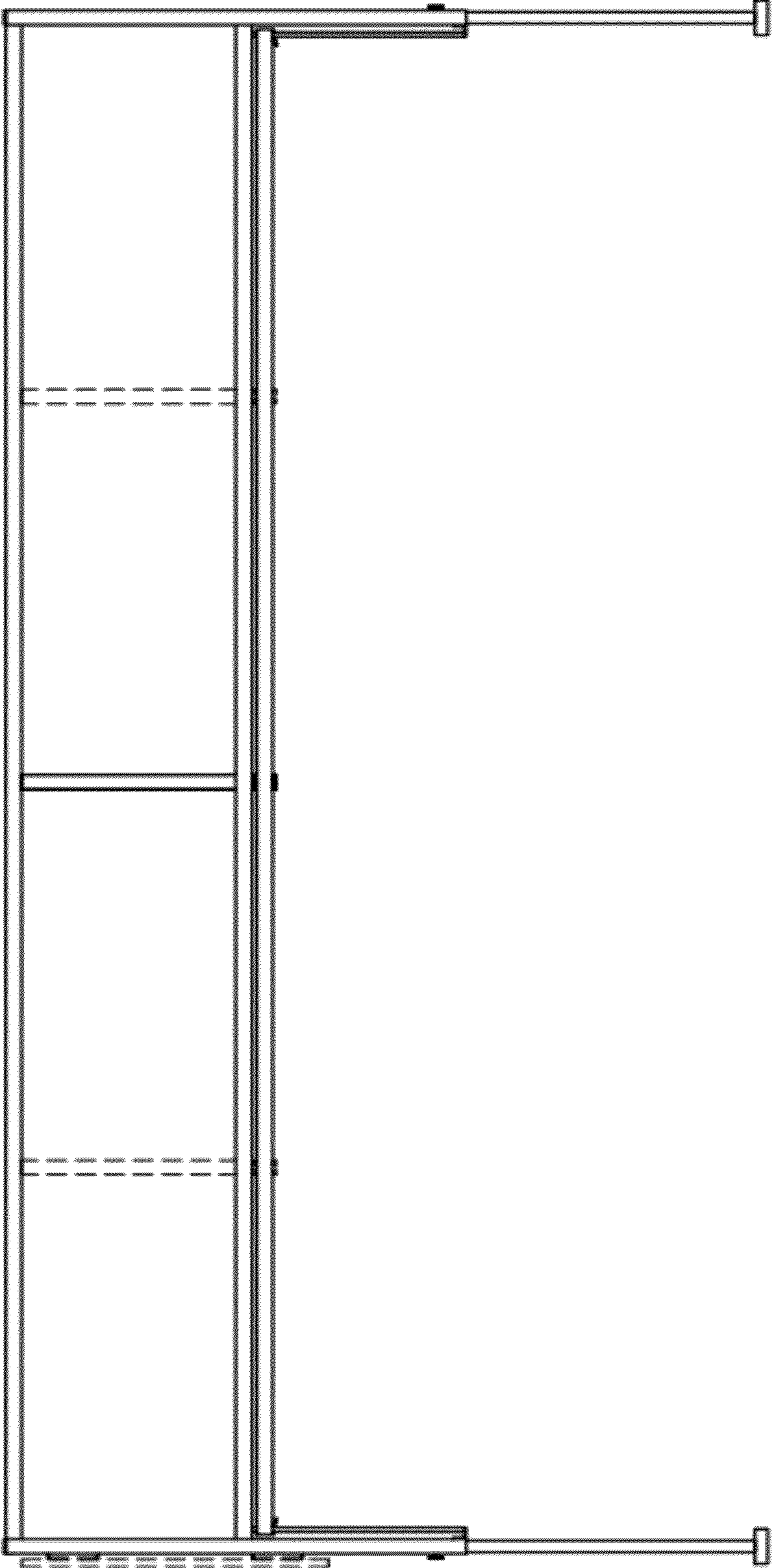
