(57) **CLAIM**

The ornamental design for a individually packaged communion host, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment for an individually packaged communion host enclosing a communion wafer.

FIG. 2 is a front view of the embodiment of FIG. 1.

FIG. 3 is a back view of the embodiment of FIG. 1.

FIG. 4 is a side view of the embodiment of FIG. 1.

FIG. 5 is a top view of the embodiment of FIG. 1. The bottom view is identical.

FIG. 6 is a perspective view of a second embodiment for an individually packaged communion host enclosing a communion wafer.

FIG. 7 is a front view of the embodiment of FIG. 6.

FIG. 8 is a back view of the embodiment of FIG. 6.

FIG. 9 is a side view of the embodiment of FIG. 6.

FIG. 10 is a top view of the embodiment of FIG. 6. The bottom view is identical.

FIG. 11 is a perspective view of a third embodiment for an individually packaged communion host enclosing a communion host pillow.

FIG. 12 is a front view of a fourth embodiment for an individually packaged communion host and including a tear strip.

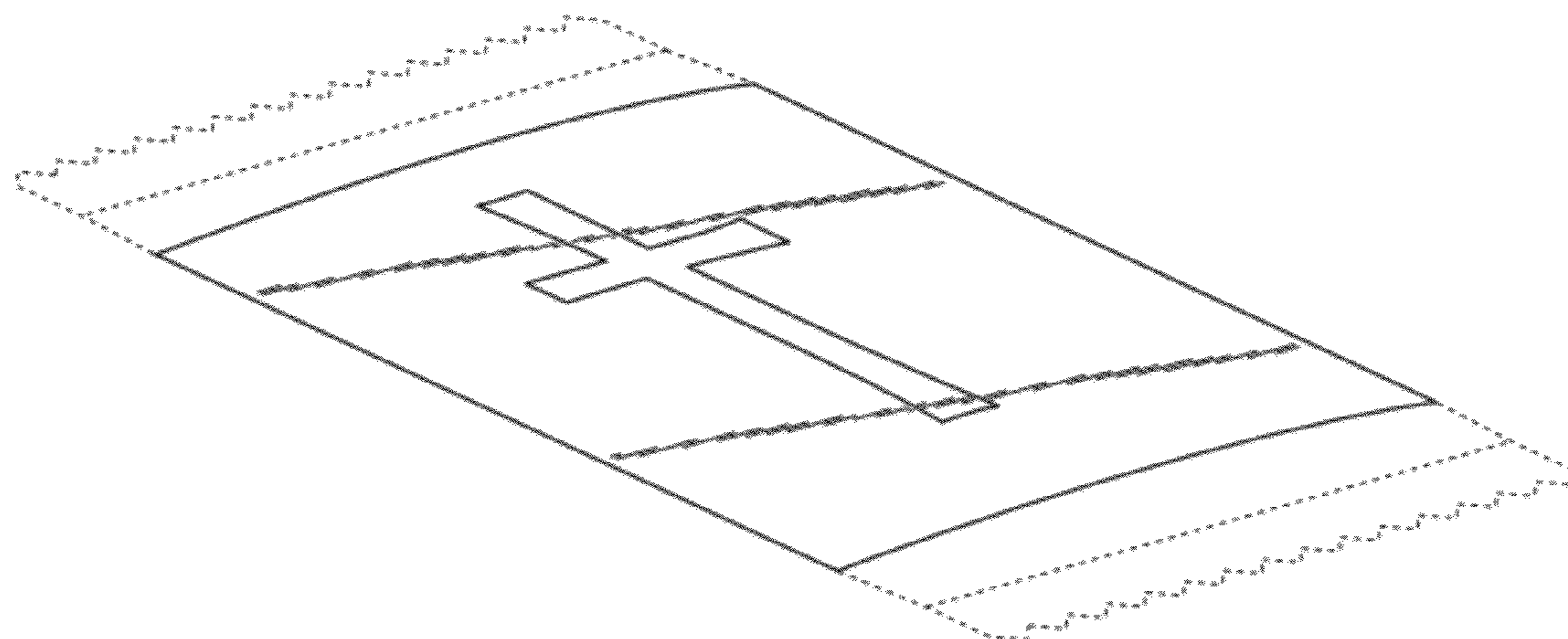
FIG. 13 is a back view of the embodiment of FIG. 12.

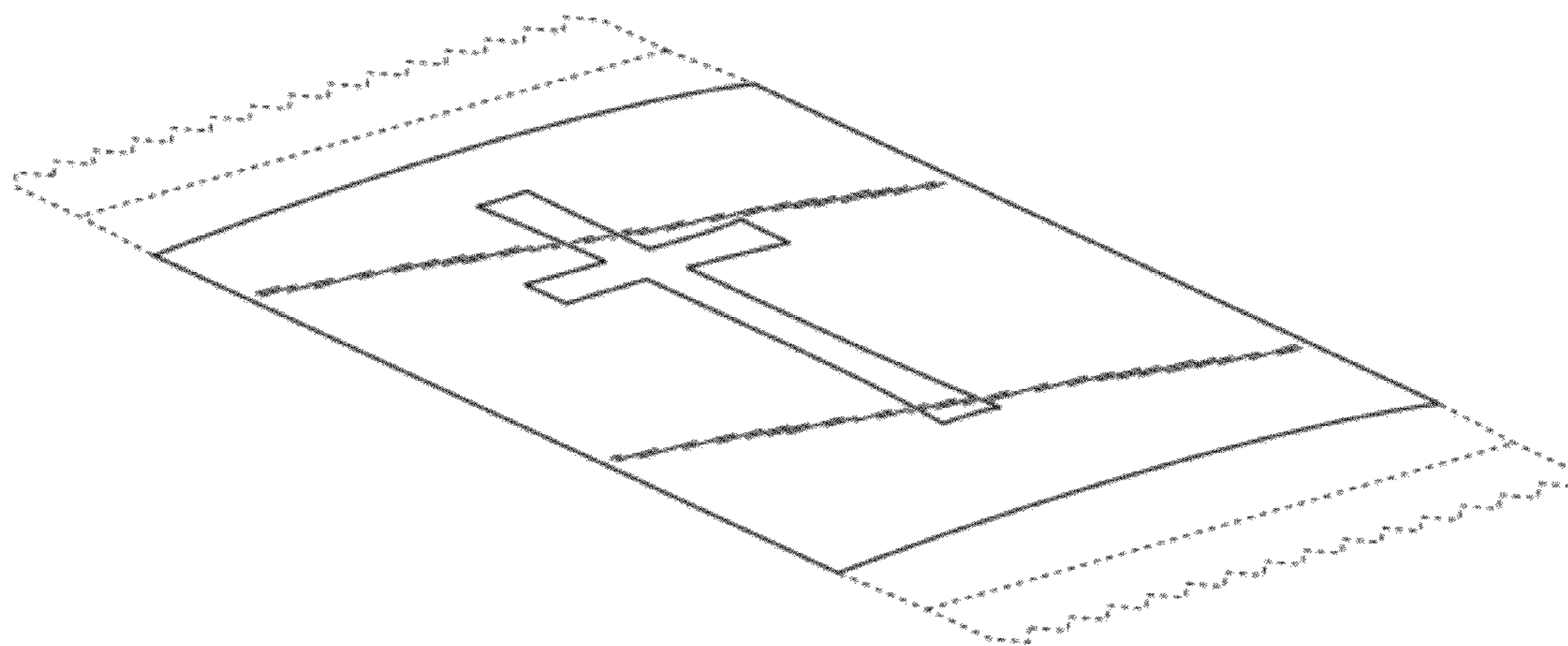
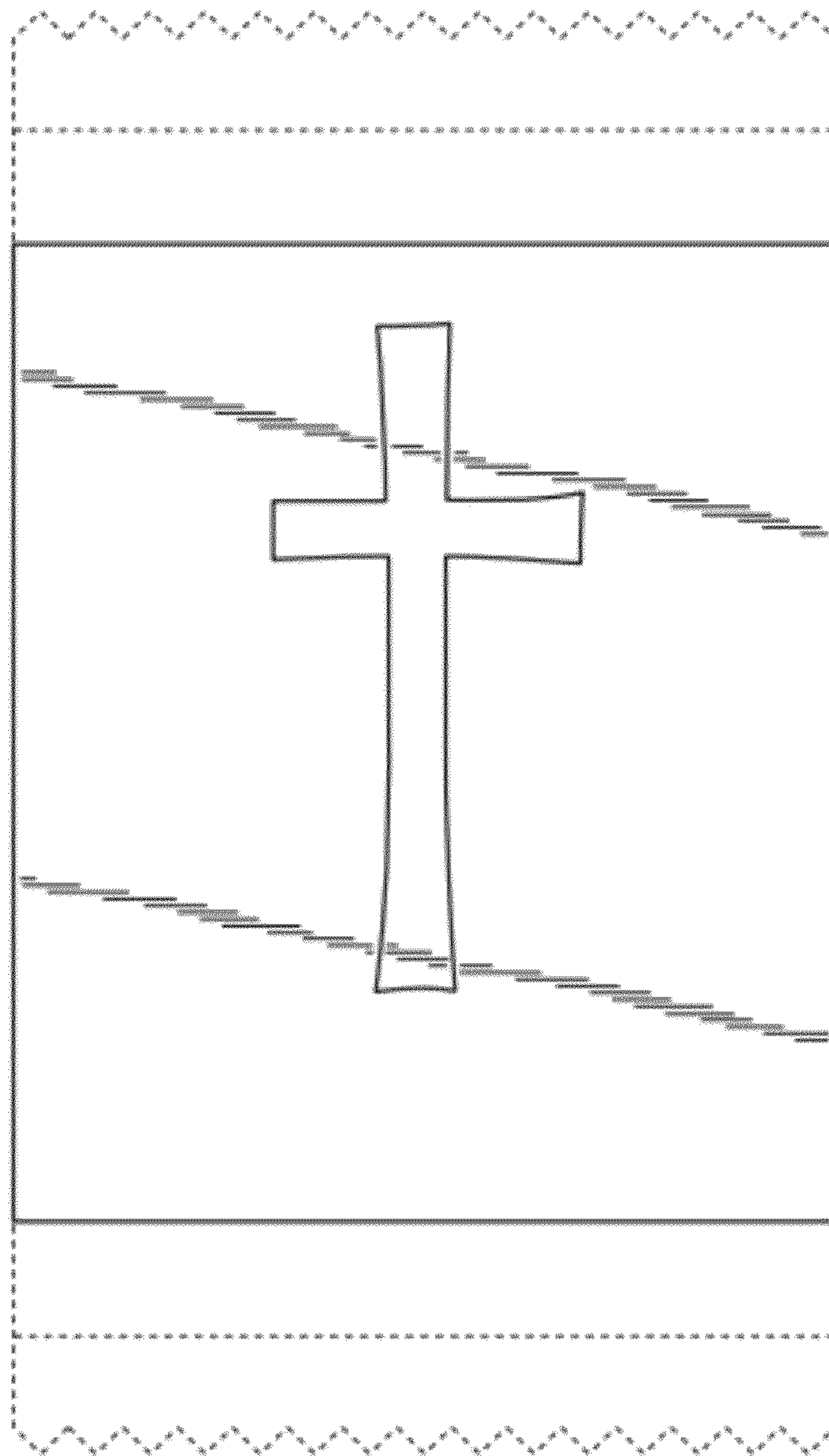
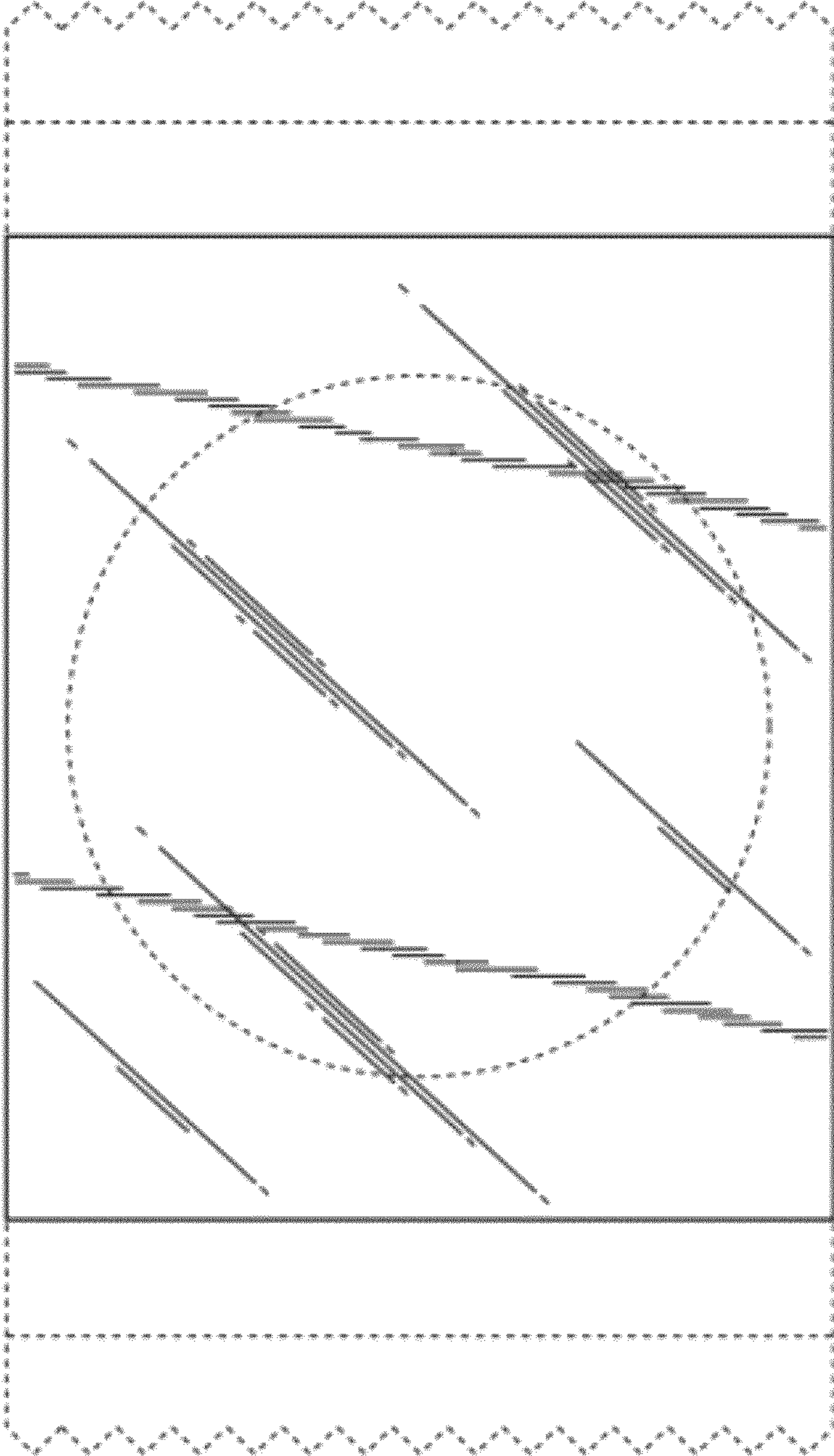

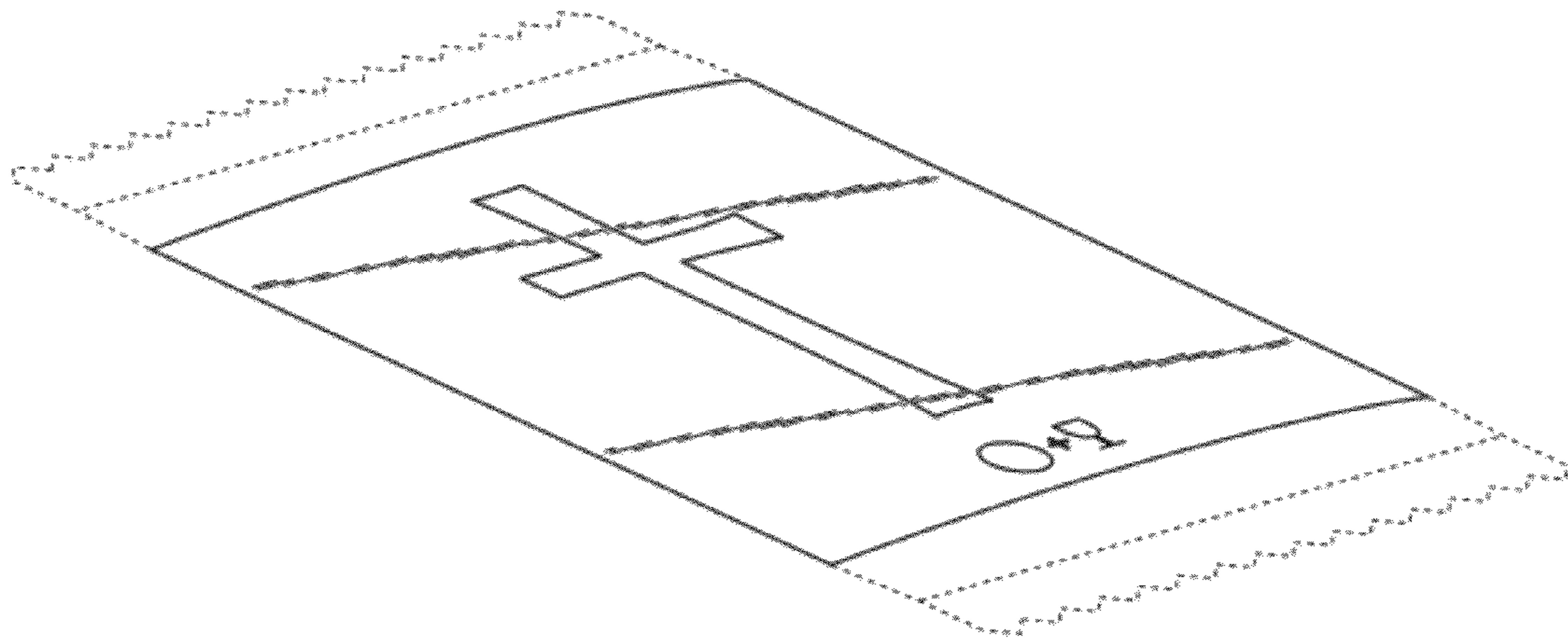
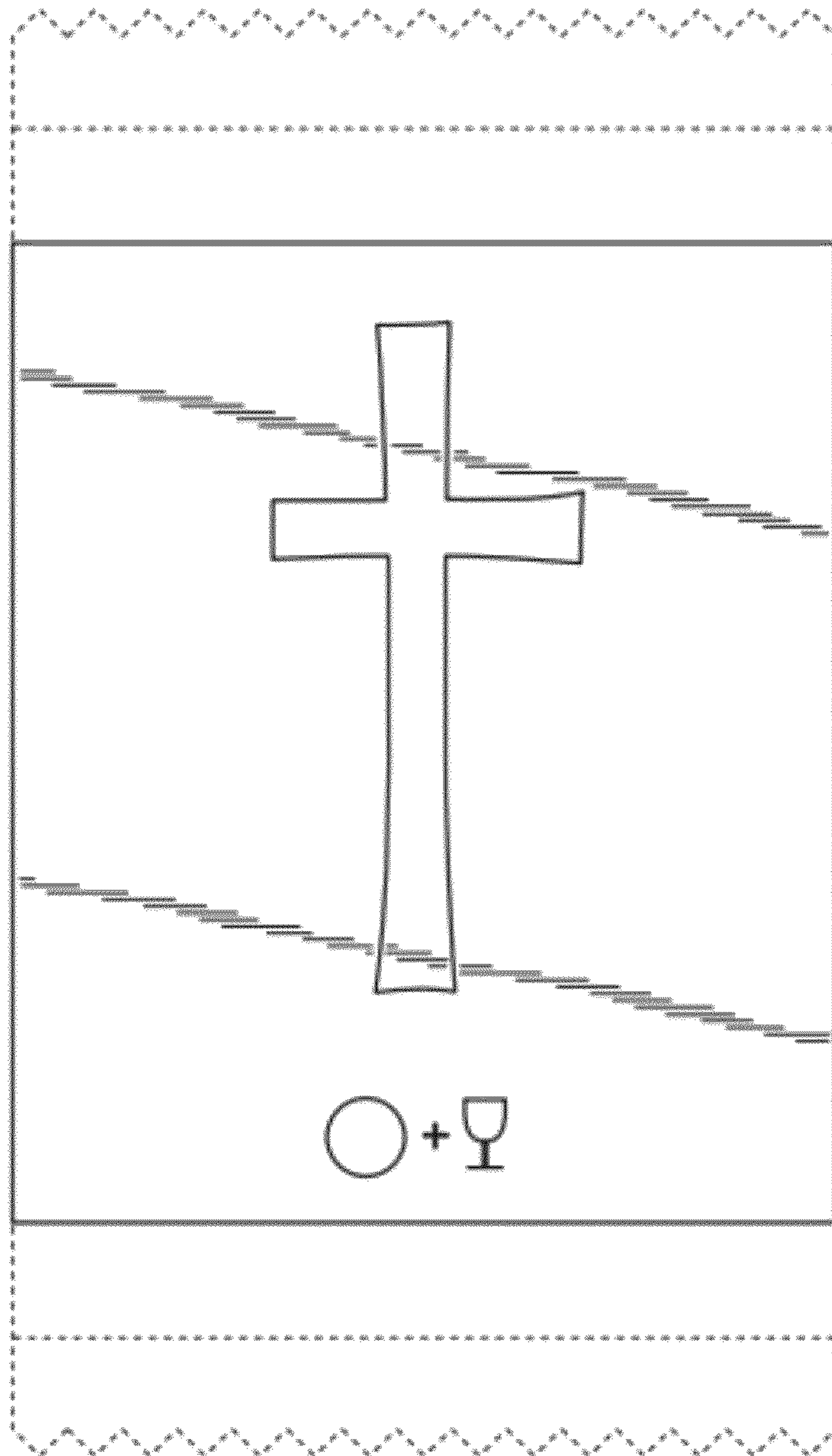
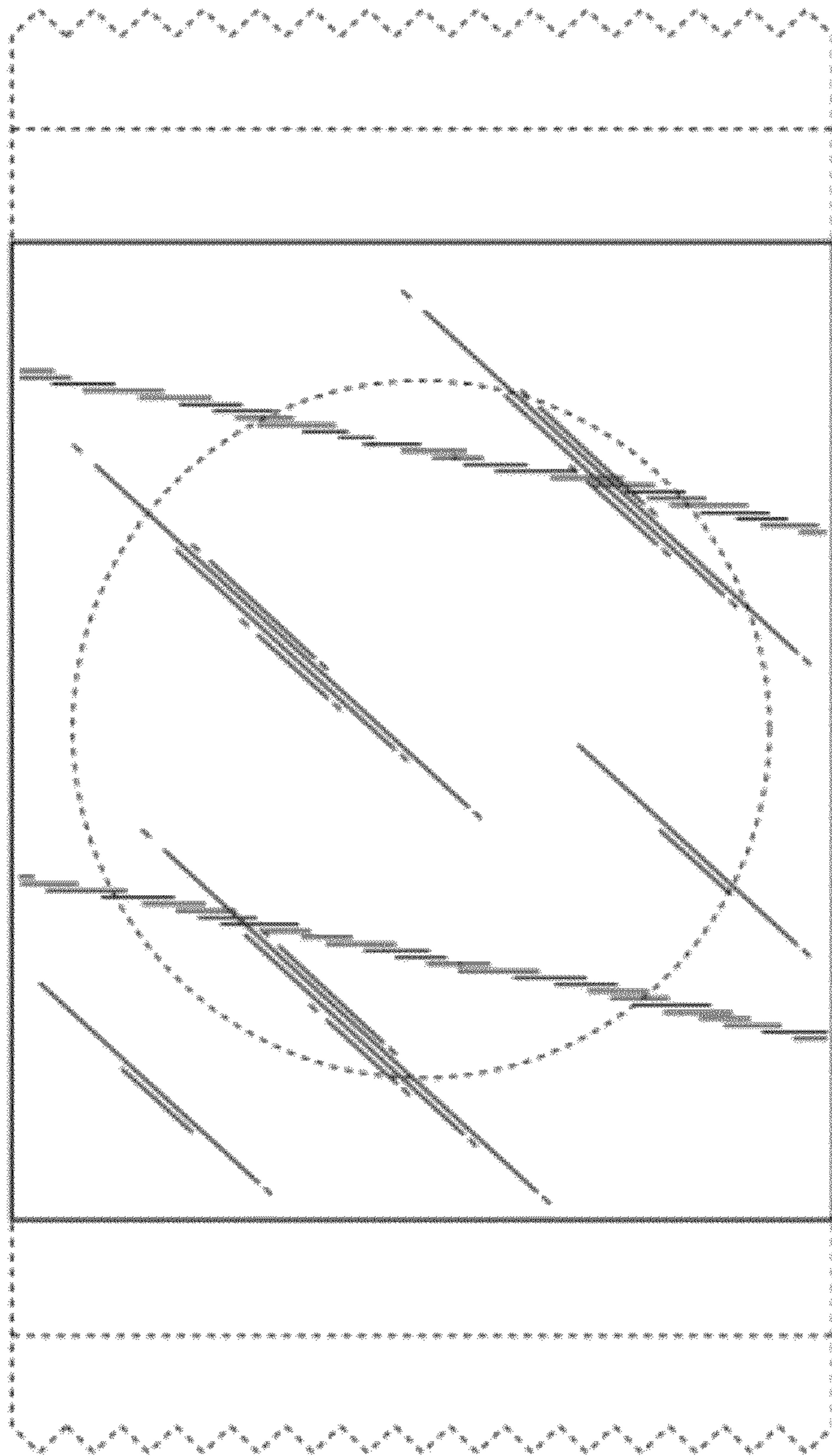

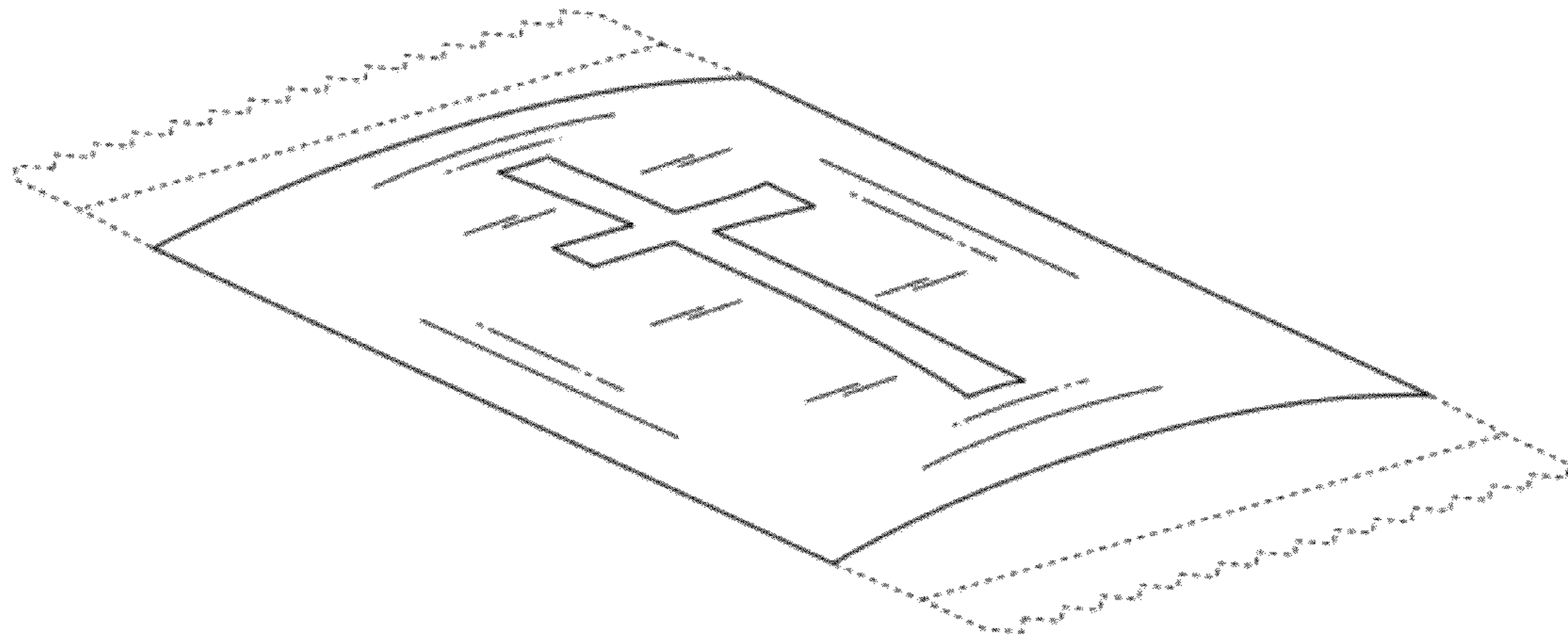




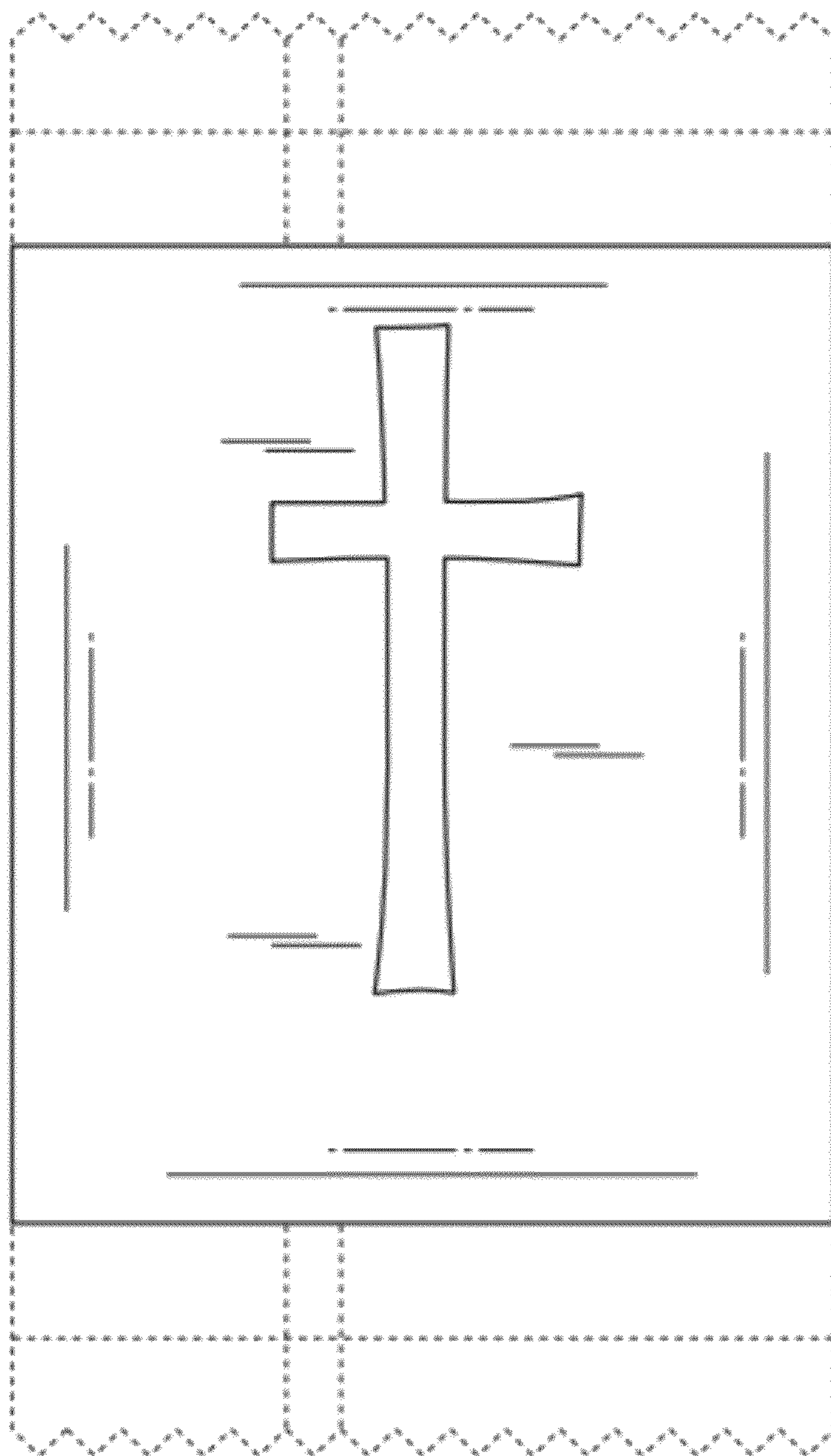

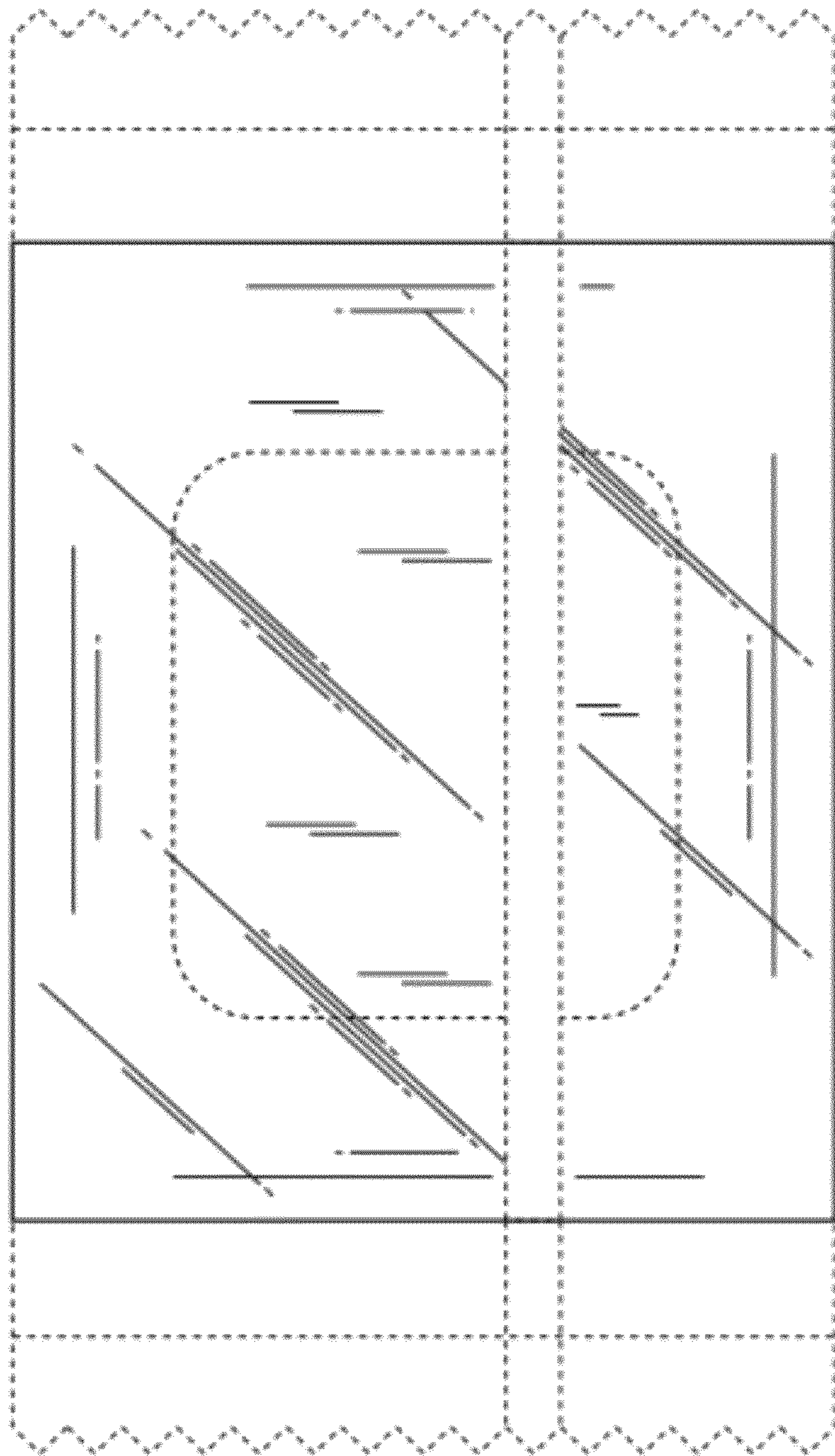

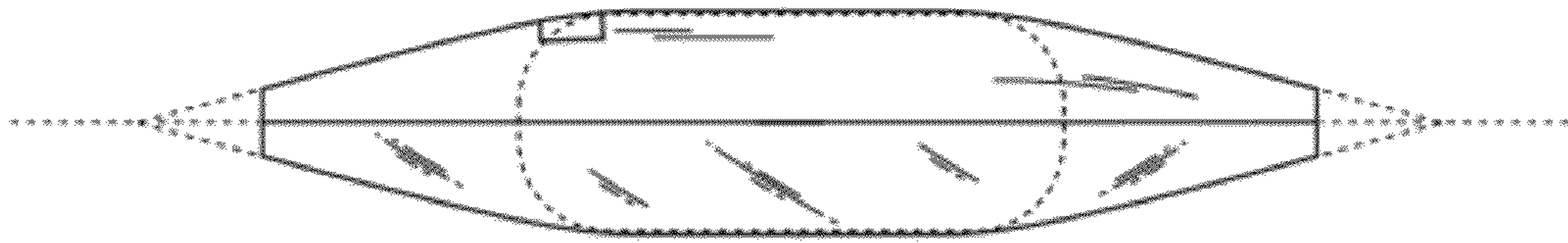

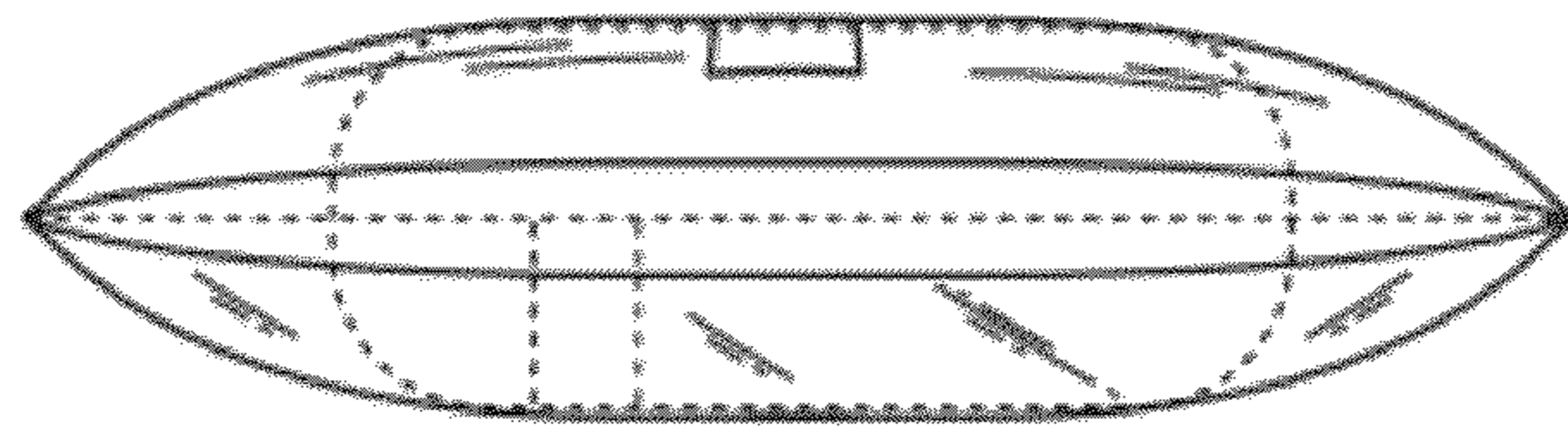
