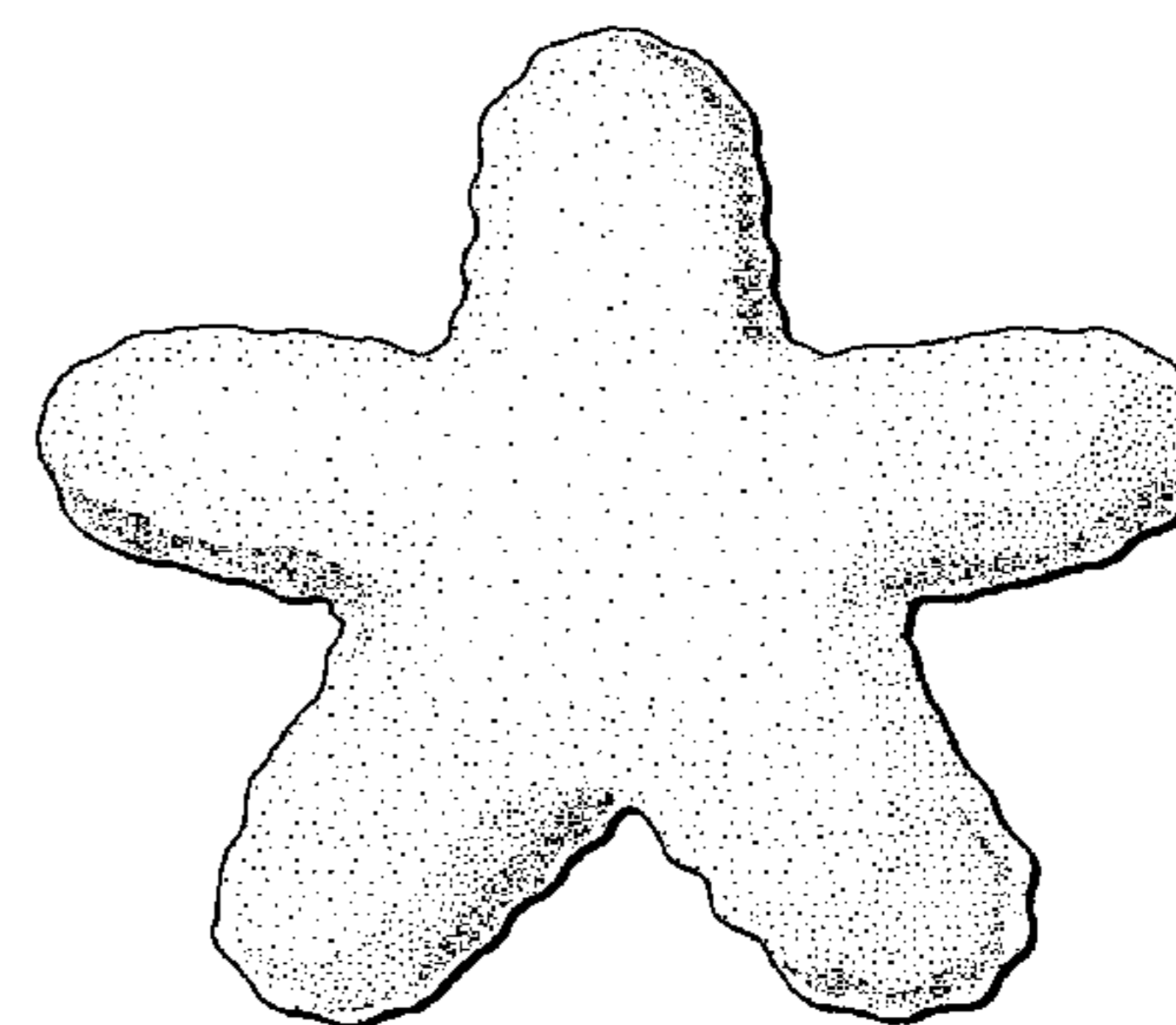
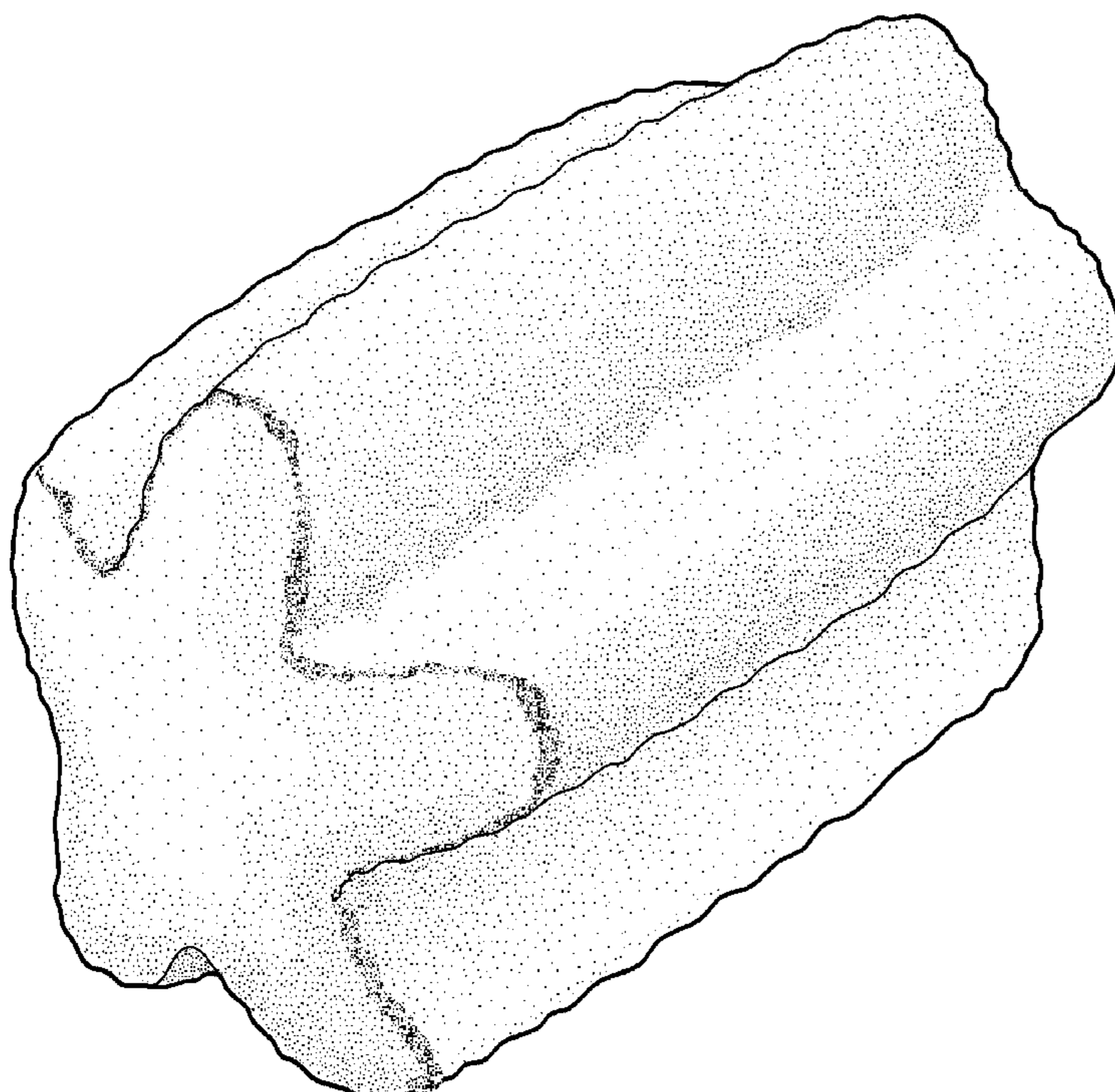
(57) **CLAIM**

I claim the ornamental design for a dog food product, as shown and described herein.

DESCRIPTION

FIG. 1 is a front perspective view of a dog food product; FIG. 2 is a right side view of the dog food product of FIG. 1; FIG. 3 is a left side view of the dog food product of FIG. 1; FIG. 4 is a front view of the dog food product of FIG. 1; FIG. 5 is a rear view of the dog food product of FIG. 1; FIG. 6 is a top view of the dog food product of FIG. 1; and, FIG. 7 is a bottom view of the dog food product of FIG. 1.

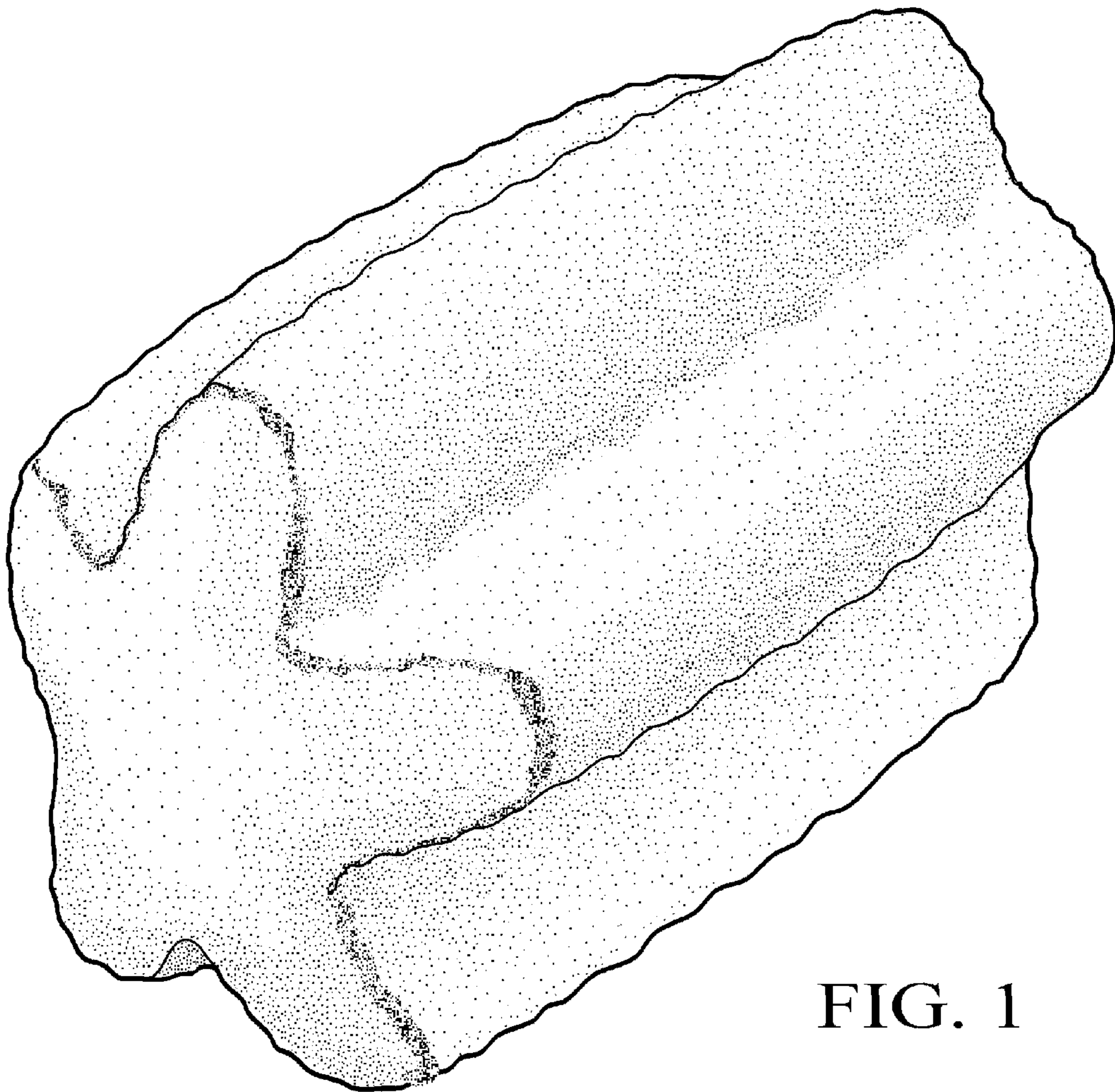

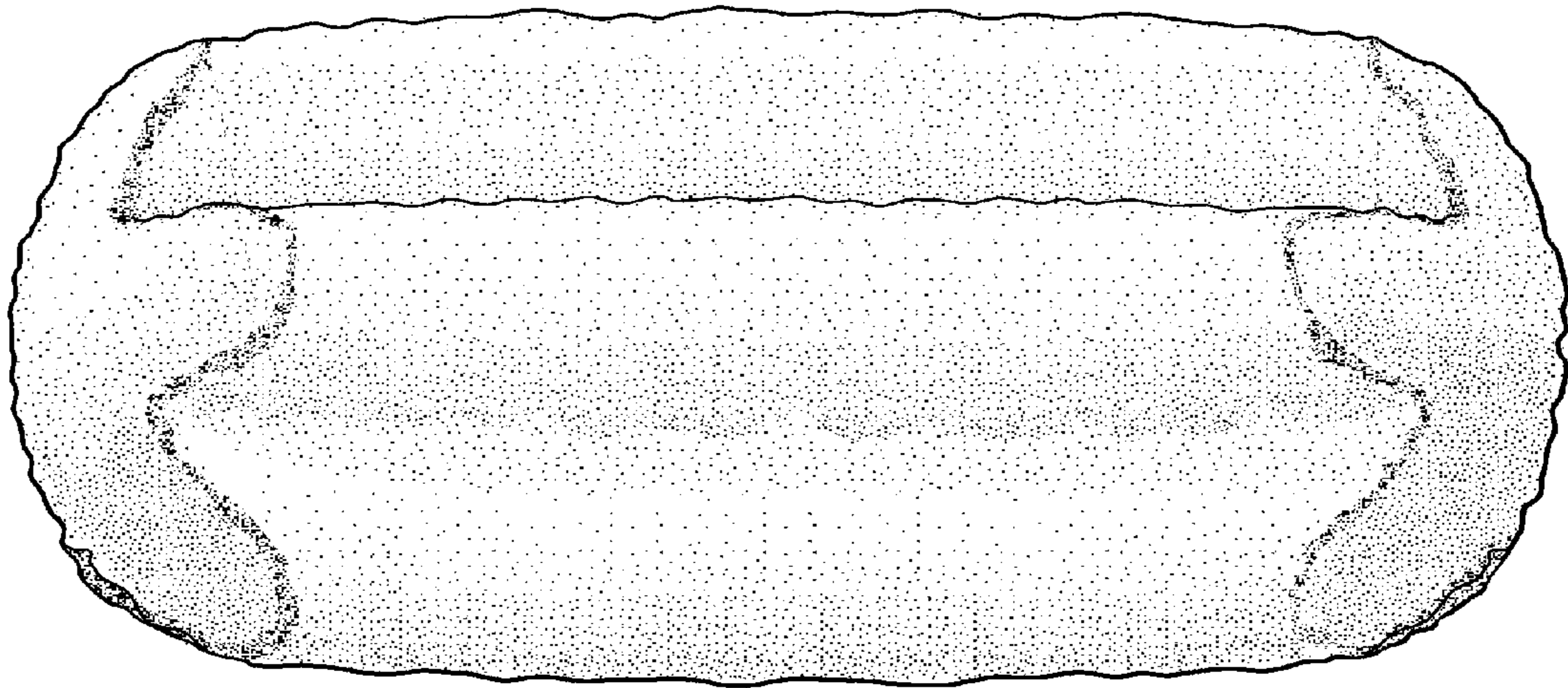

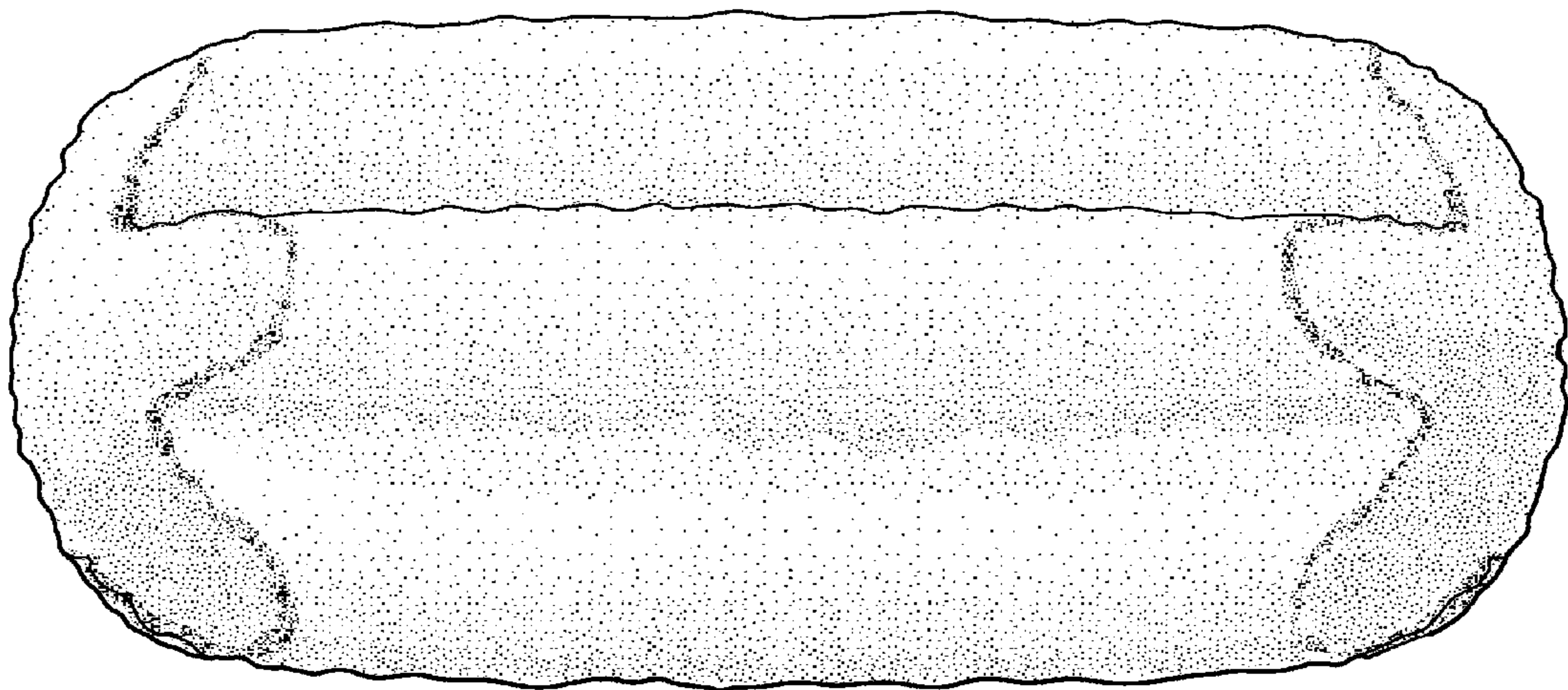

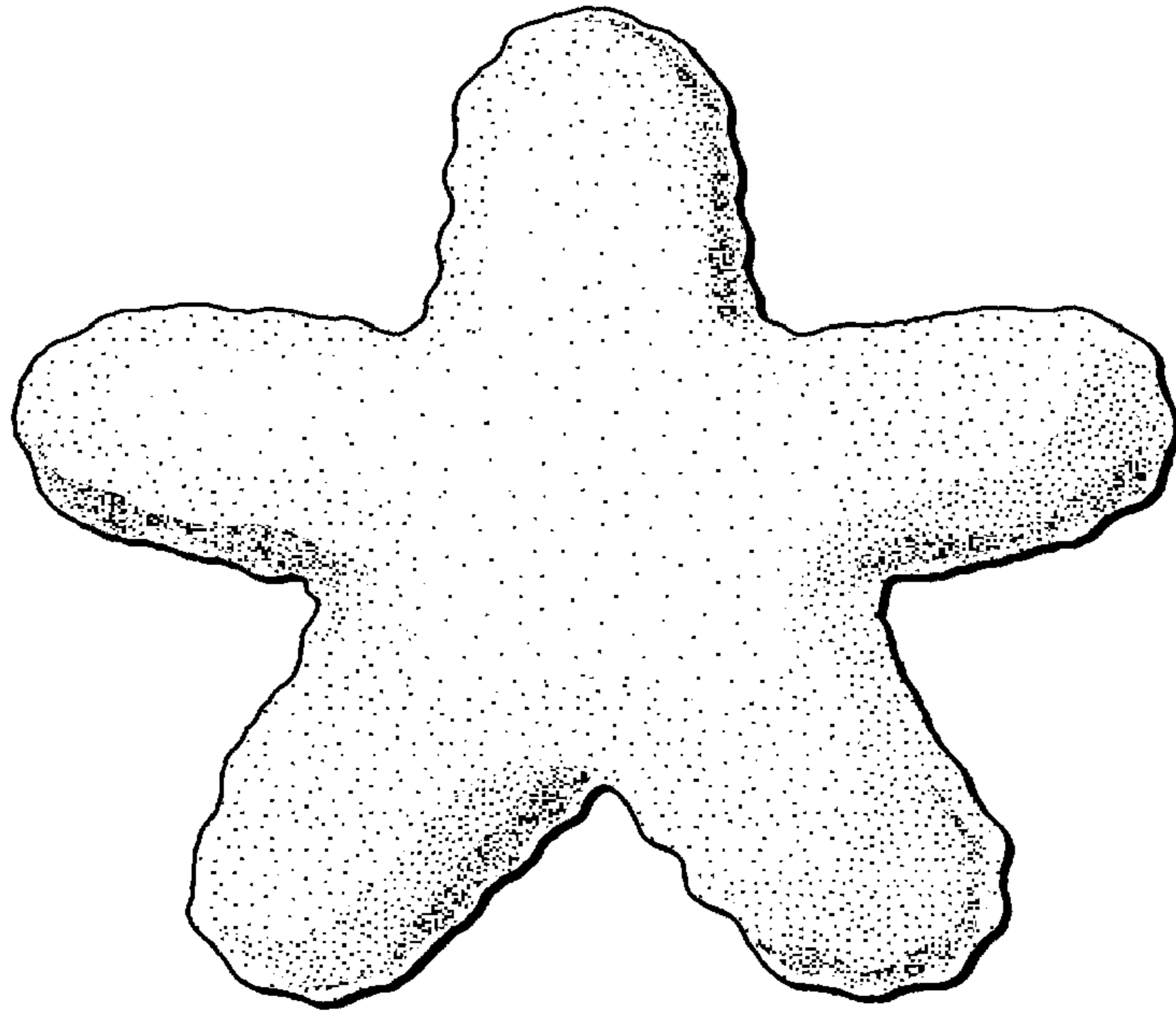

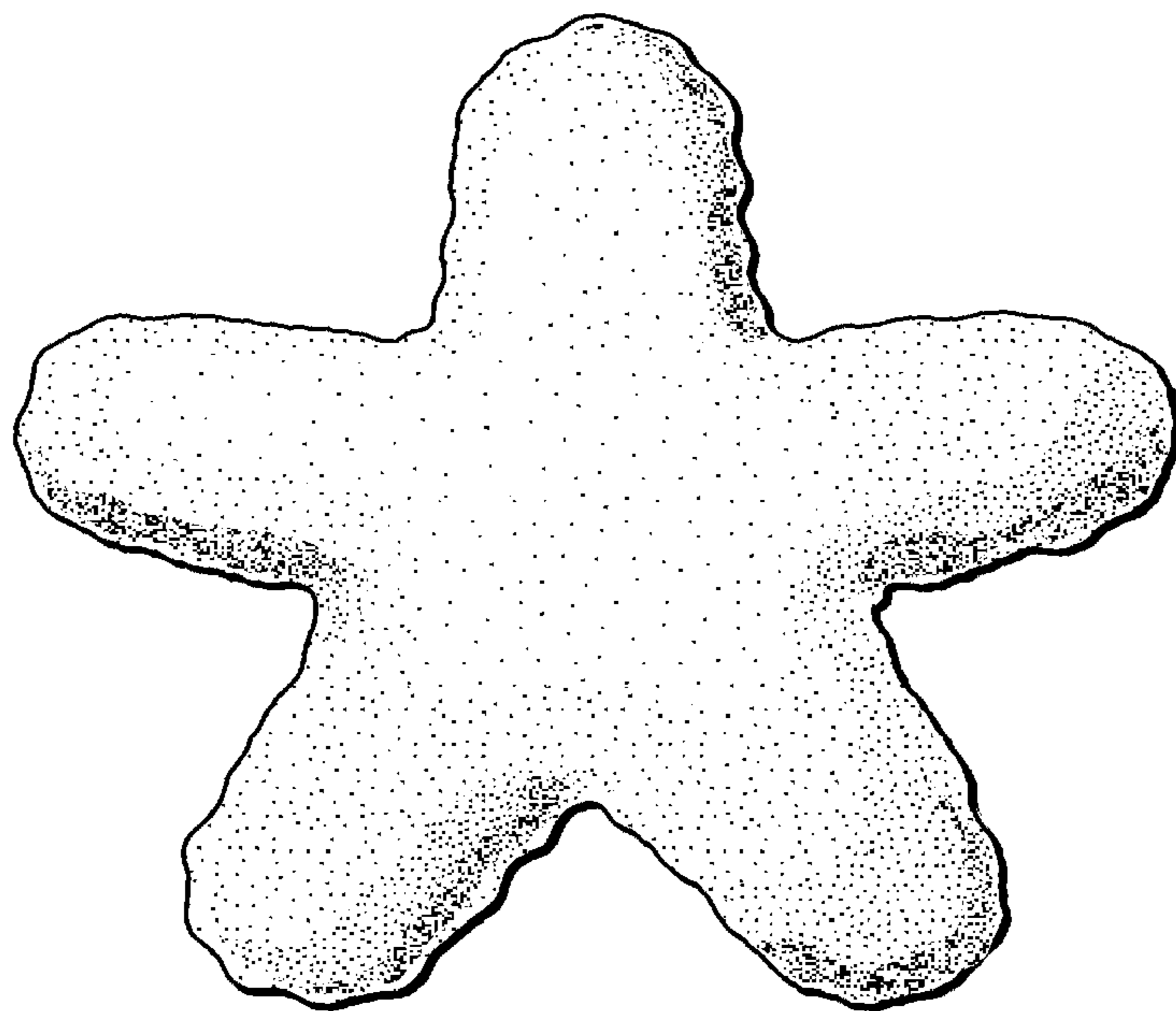

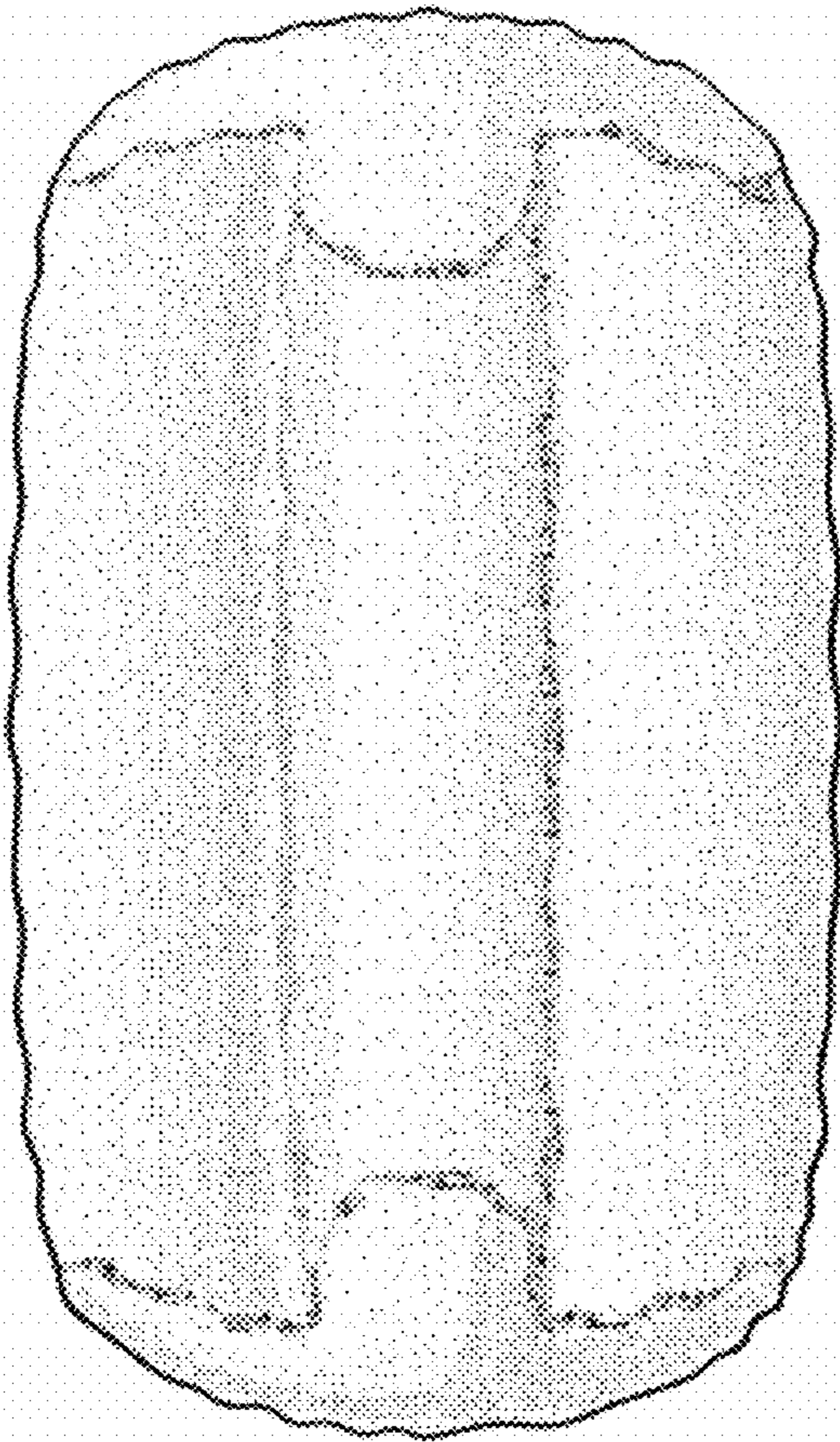

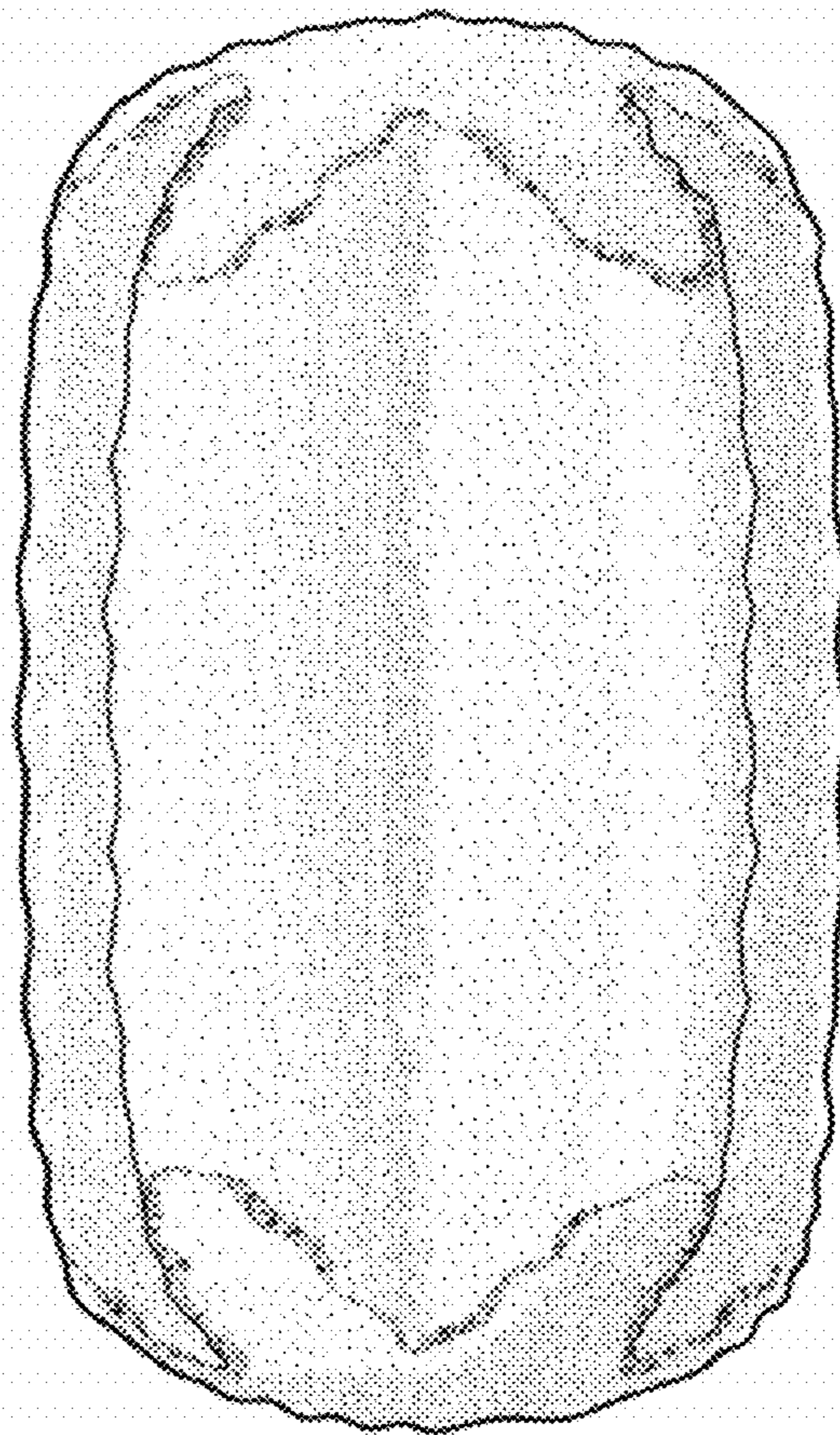
