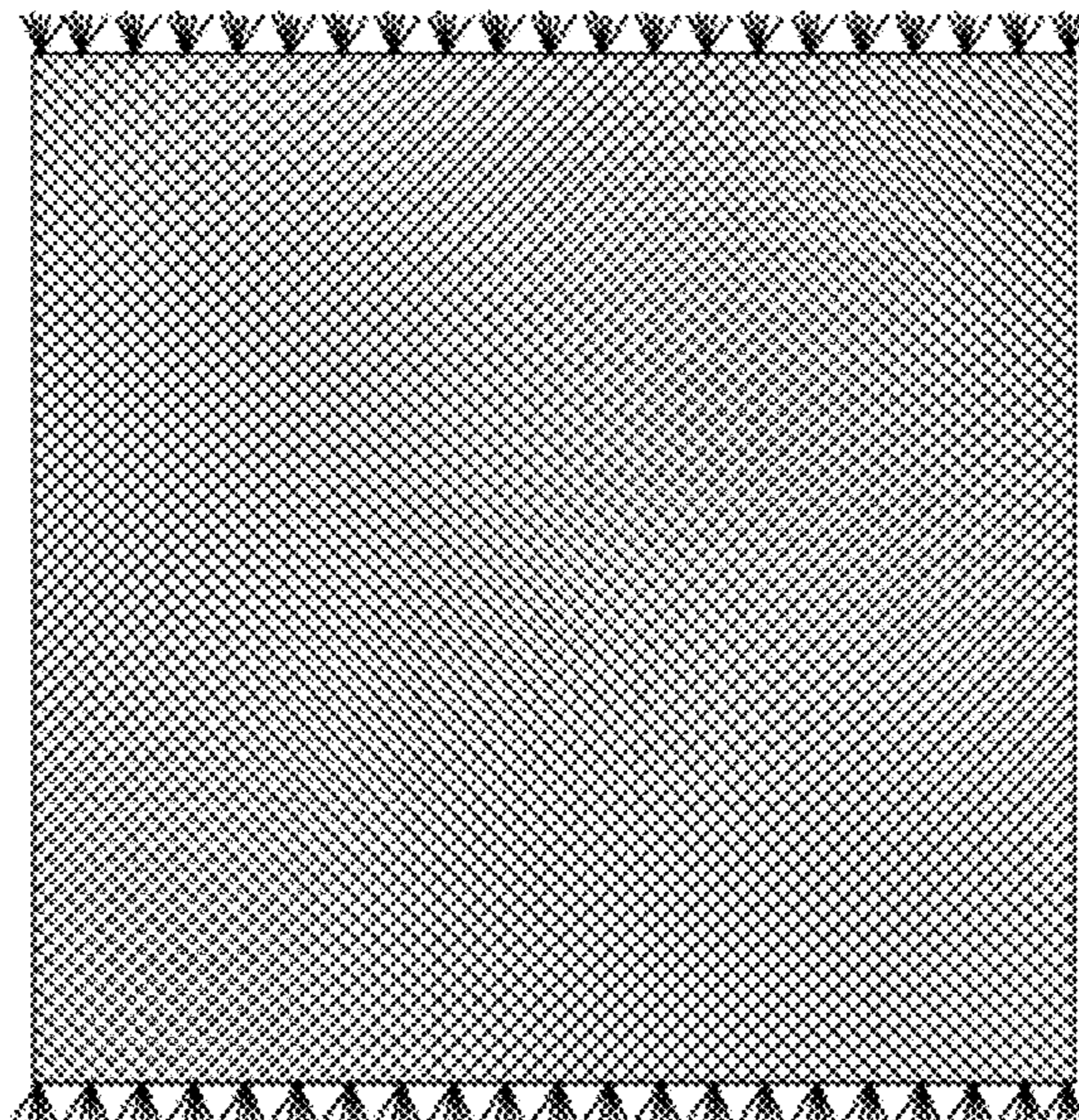

(57) **CLAIM**
I claim the ornamental design for an orange safety headscarf, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an orange safety headscarf, showing the new design;
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
FIG. 3 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof; and,
FIG. 4 is a top plan view thereof.
The rectangular portion of the orange safety headscarf is lined for the color orange.

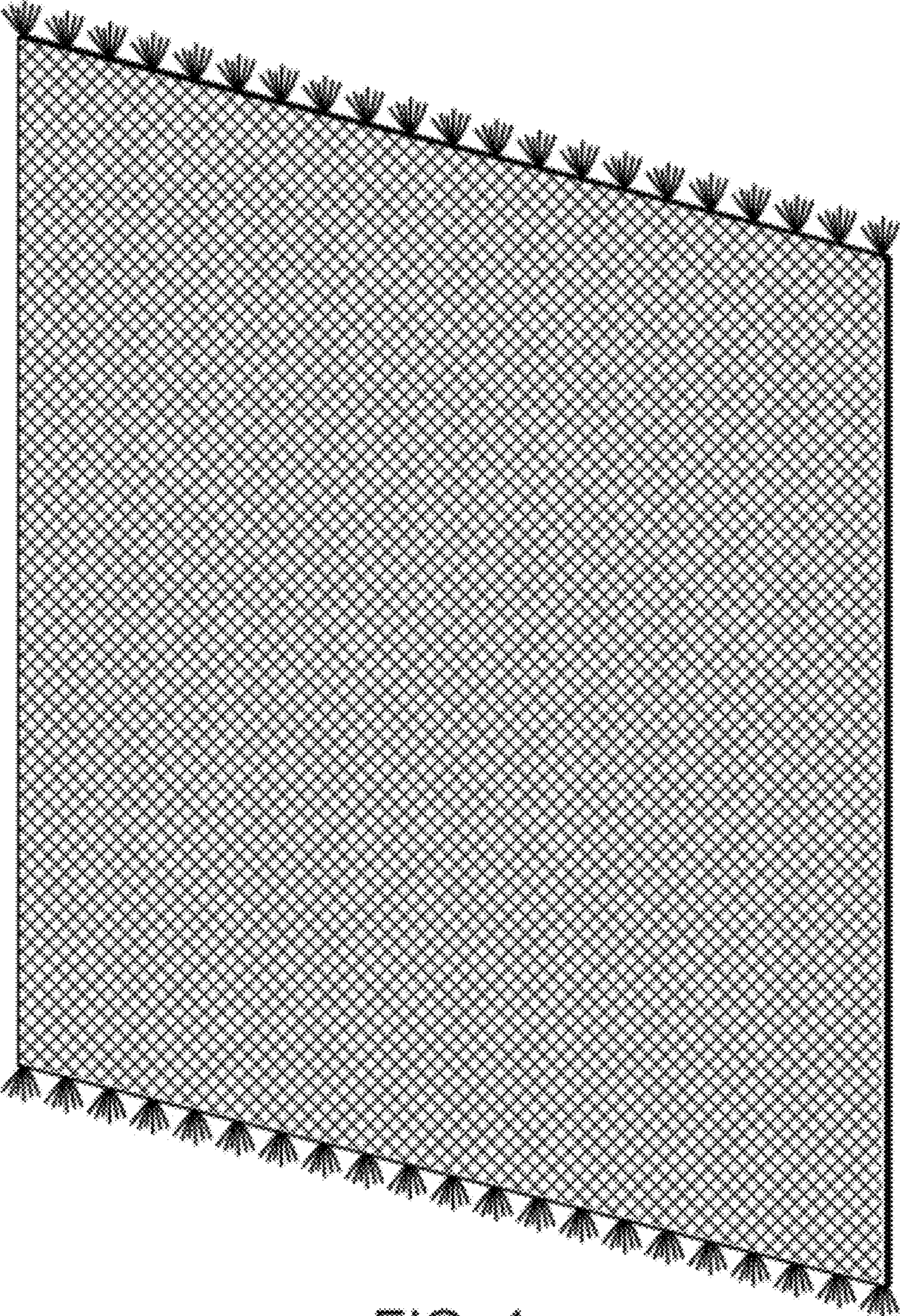

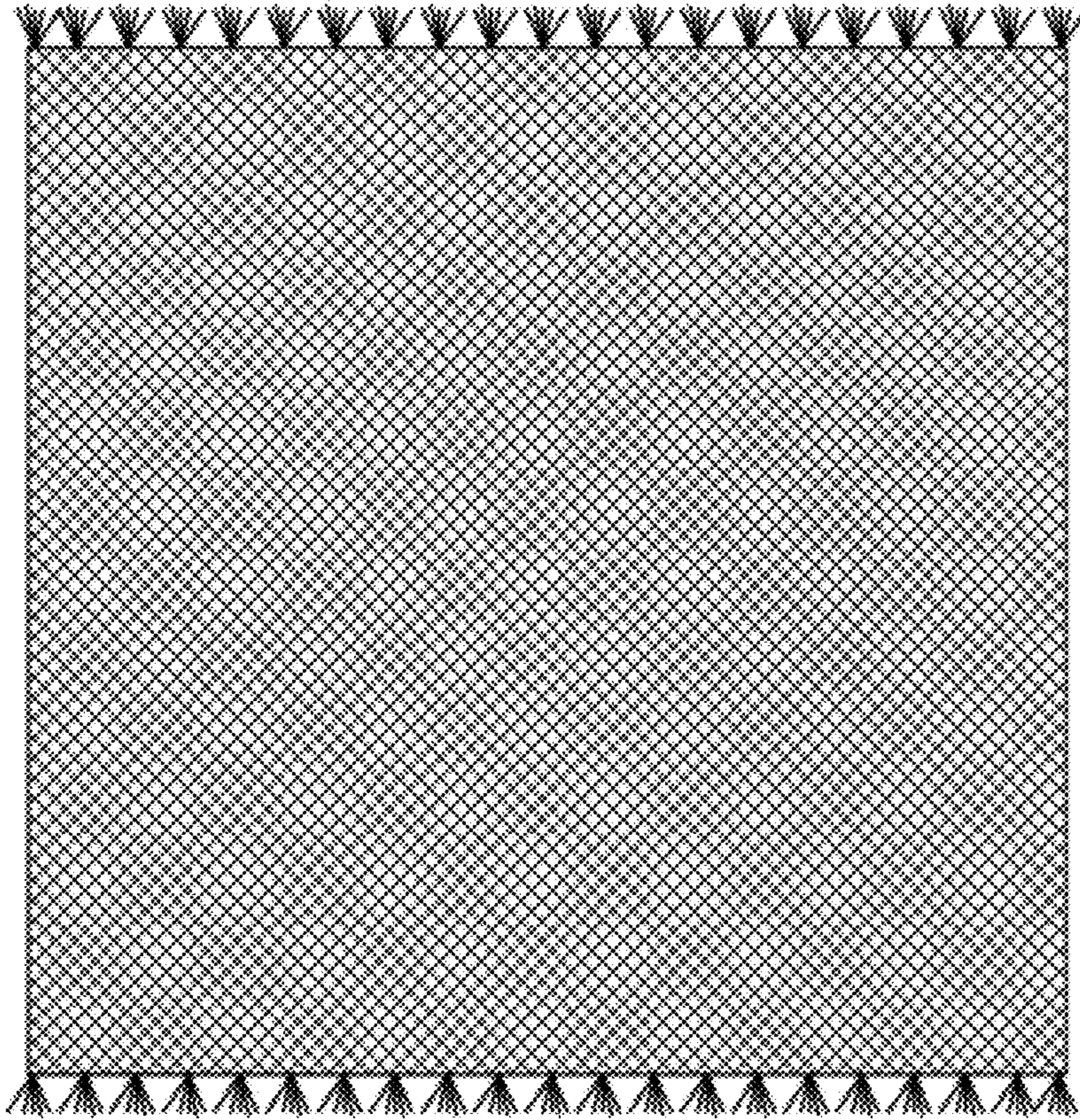
