(57) **CLAIM**

The ornamental design for a toolbox, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a toolbox of the present
invention;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view thereof, the left side being
a mirror image thereof; and,

FIG. 4 is a top plan view thereof.

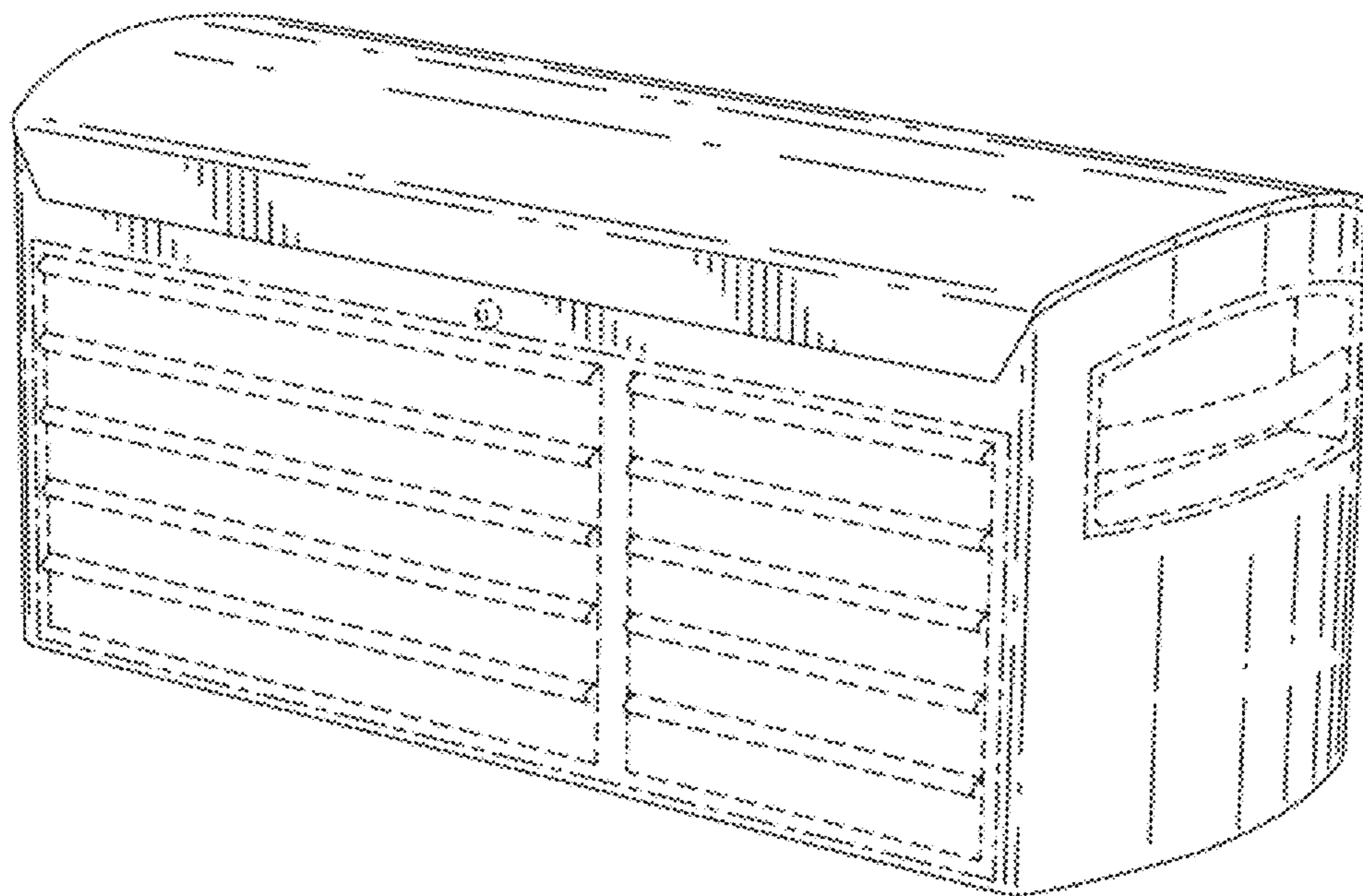
Rear elevation and bottom plan views, have been omitted as

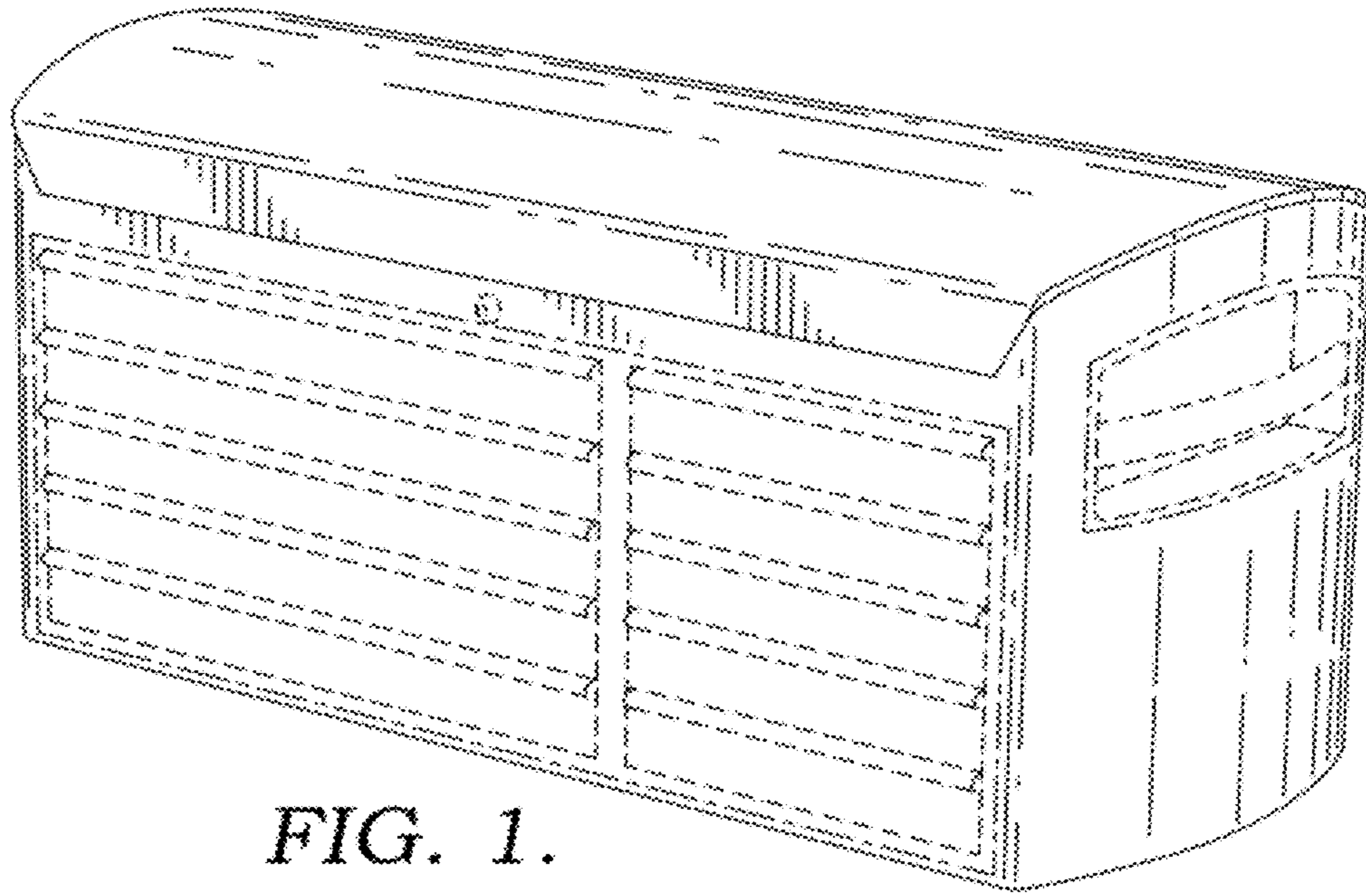

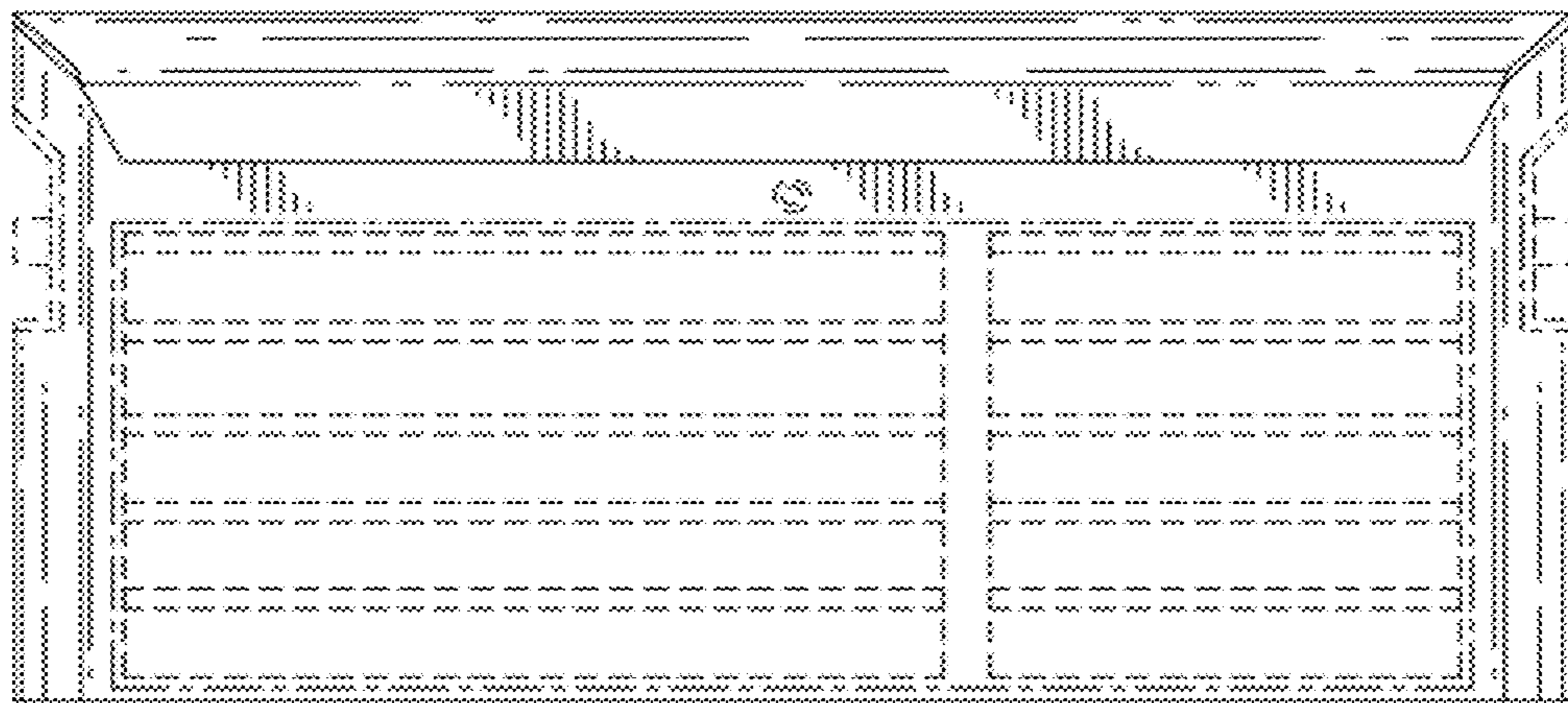

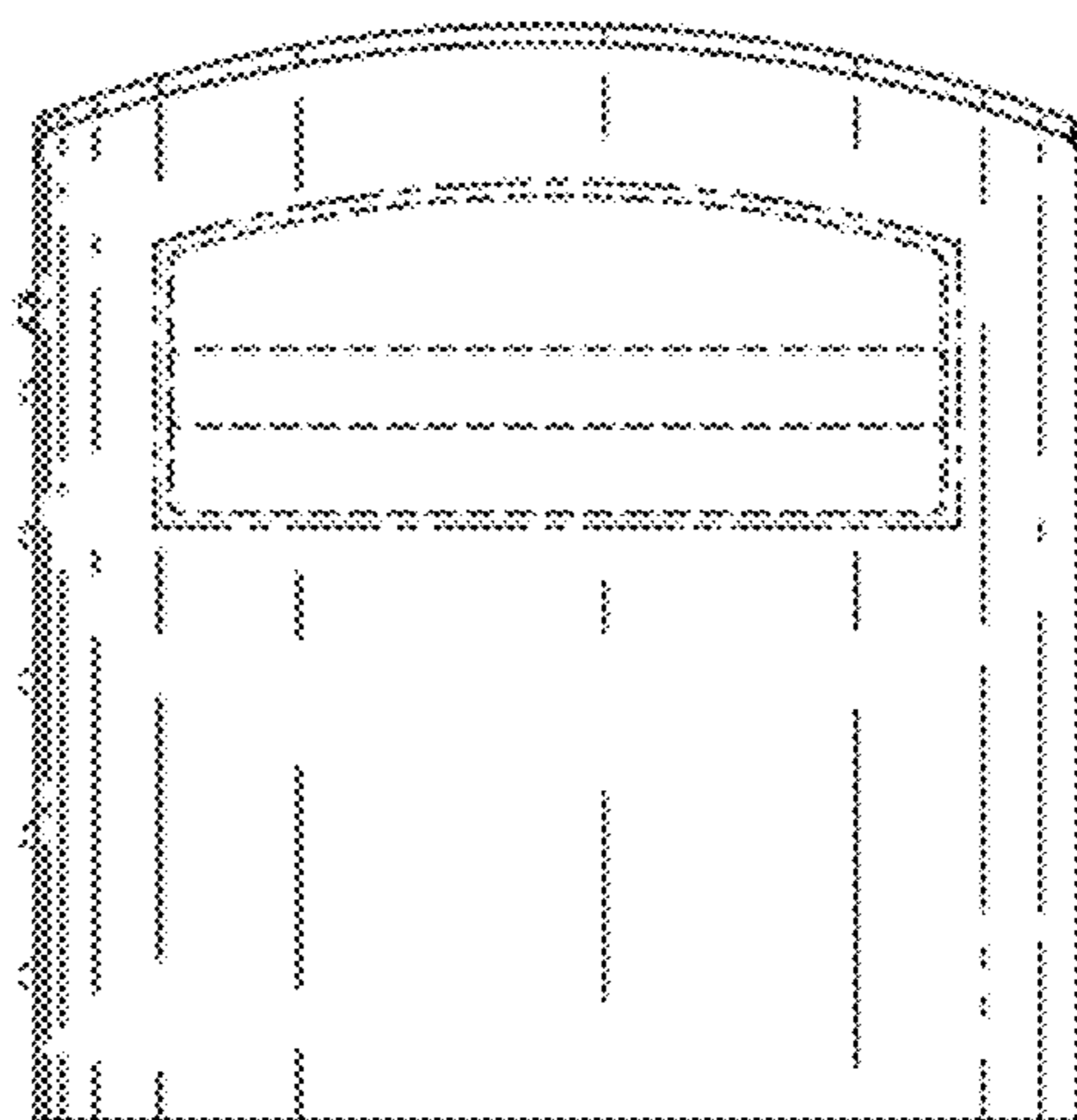

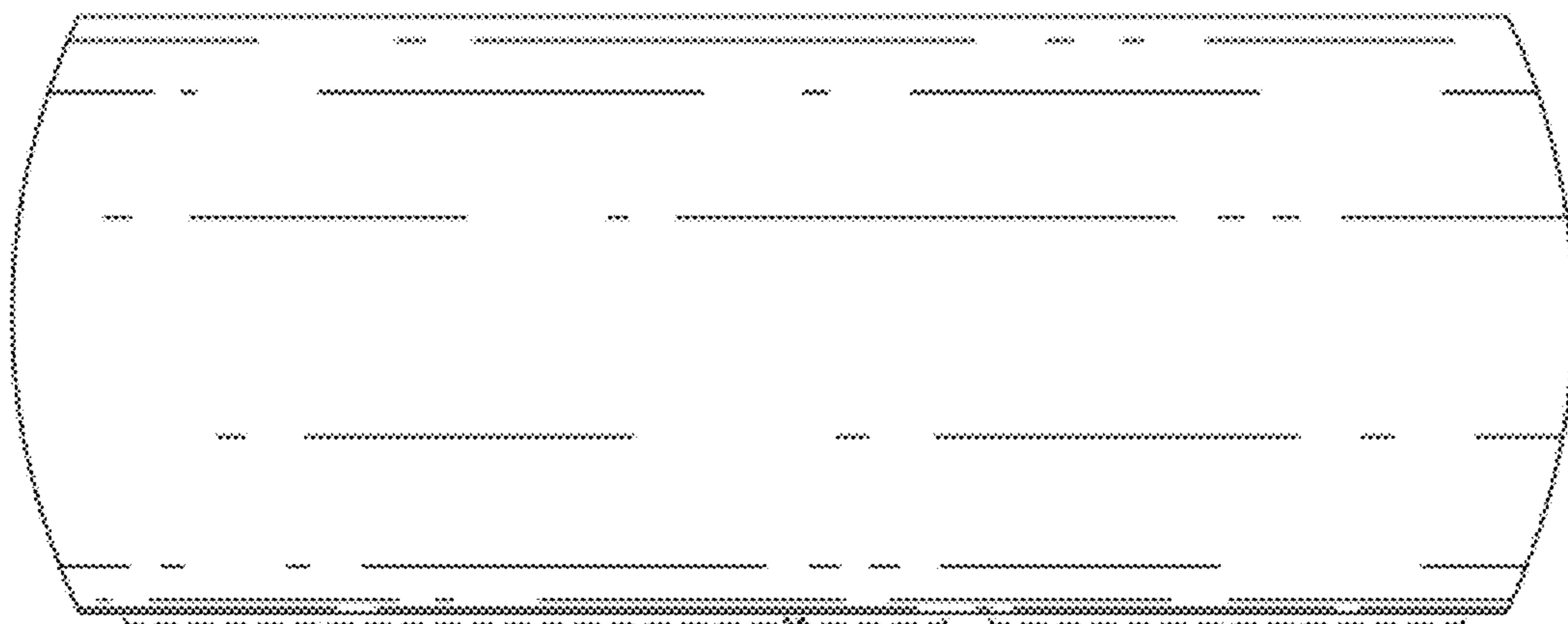
